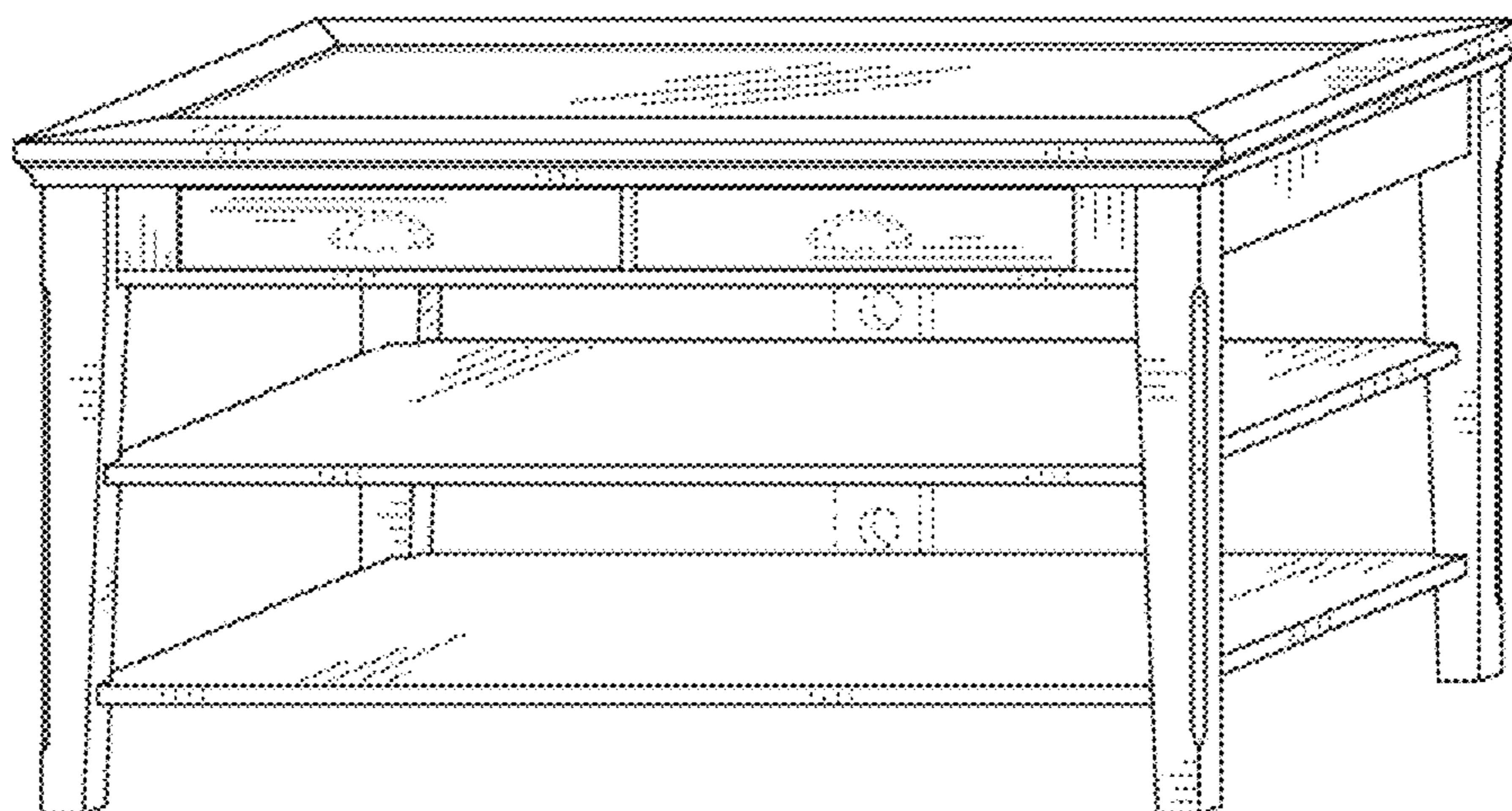
The ornamental design for audio video shelving unit, as shown and described.

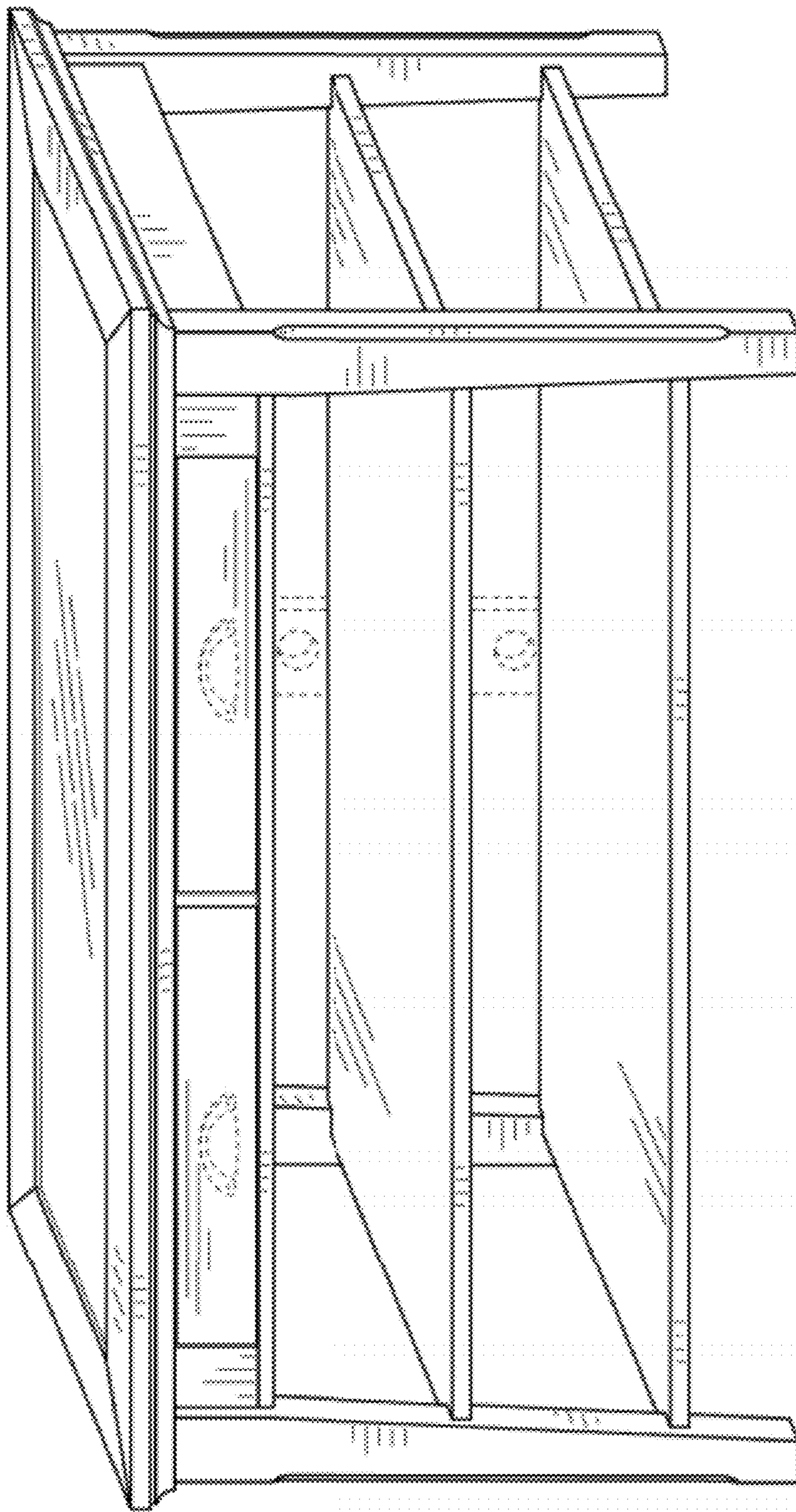

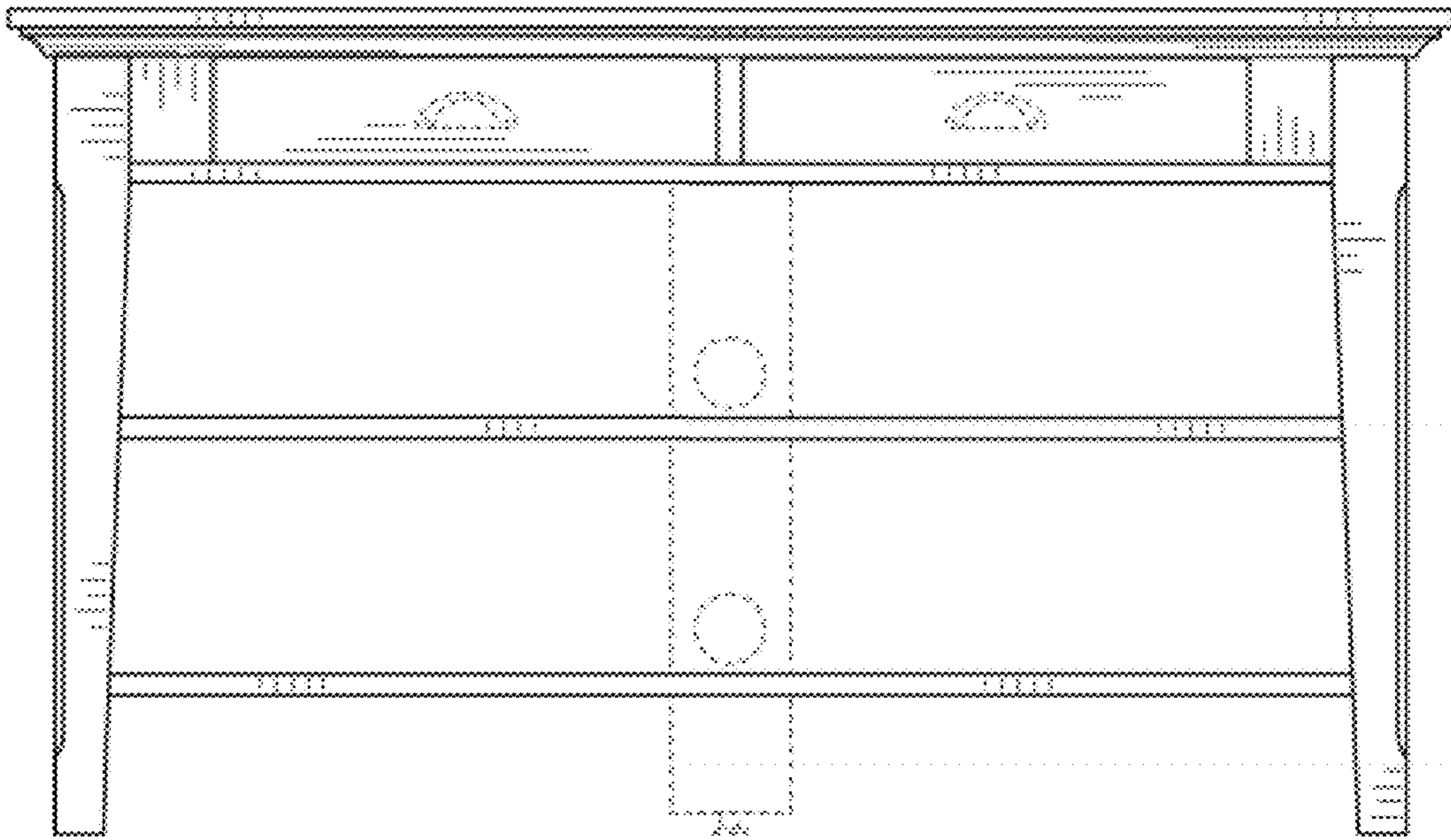

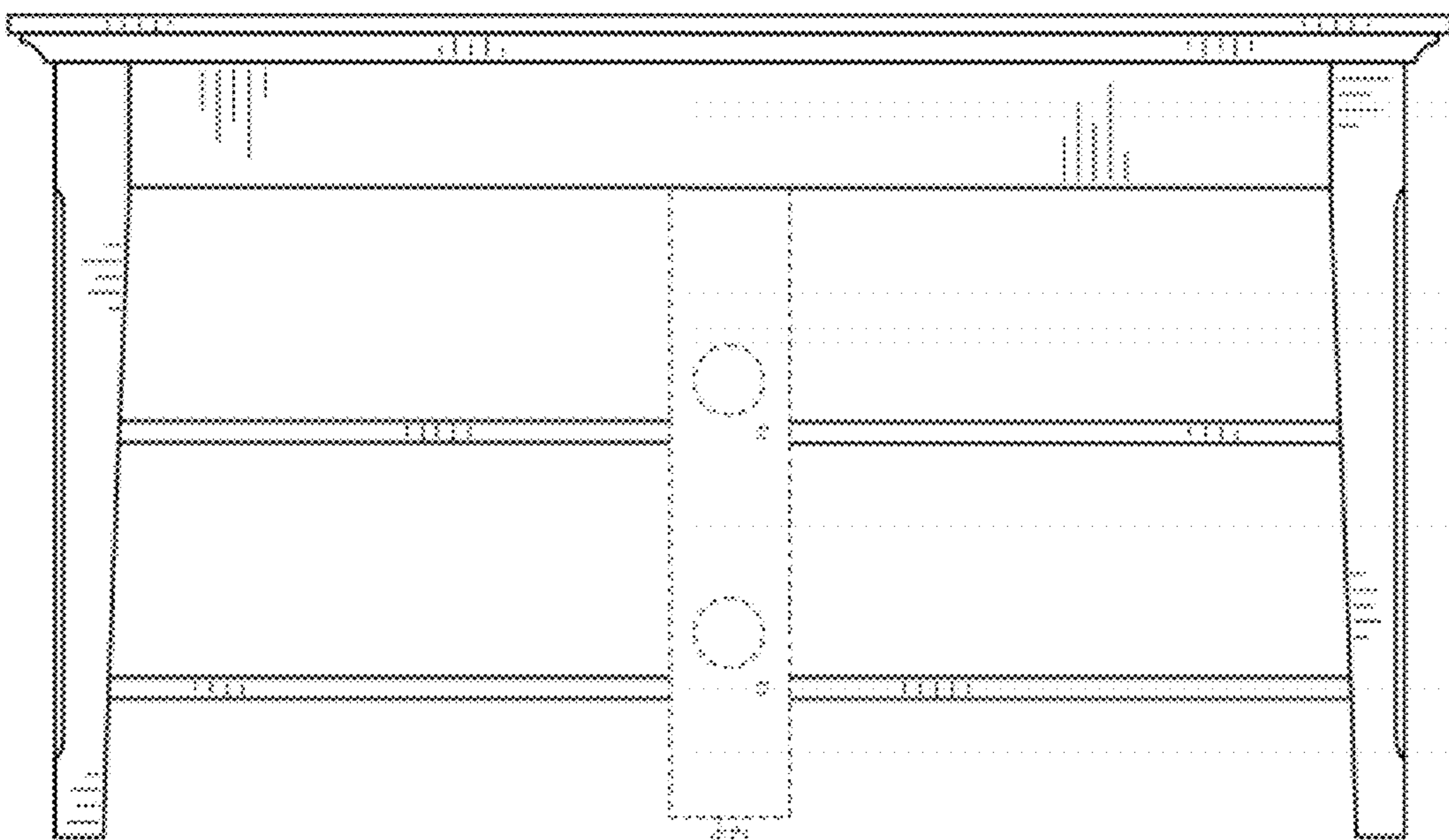

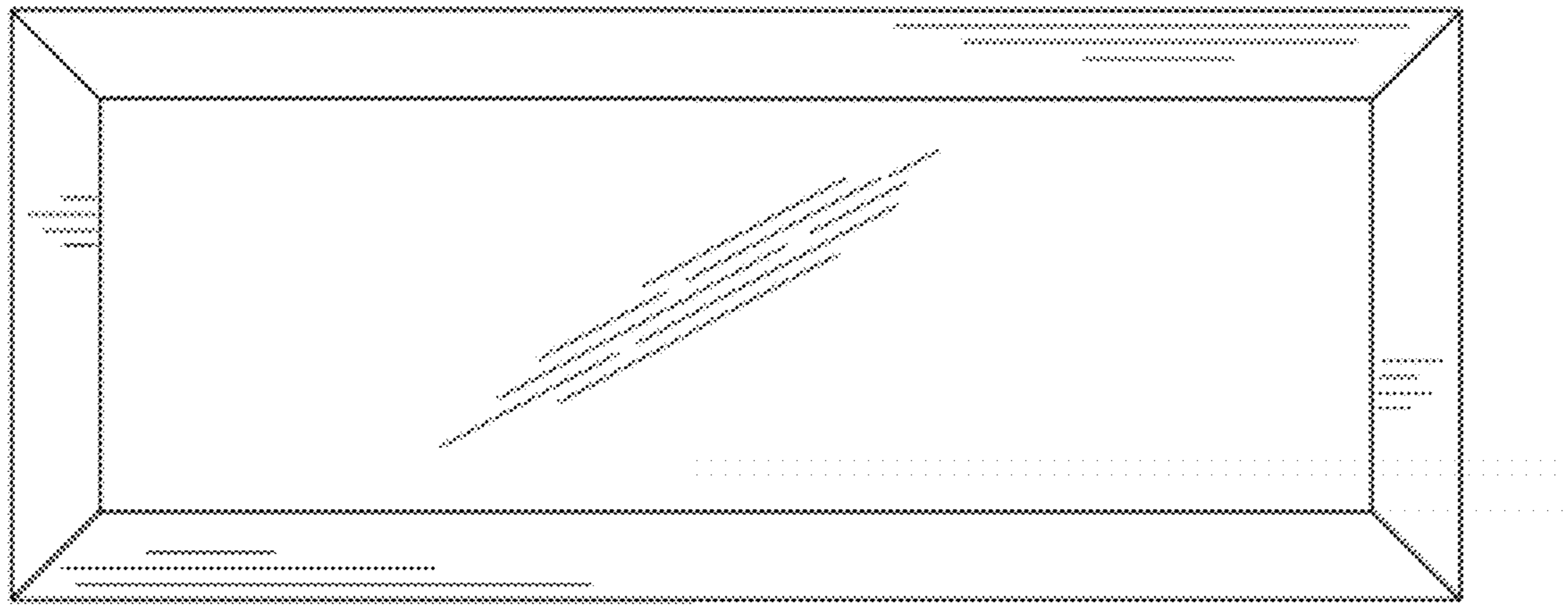

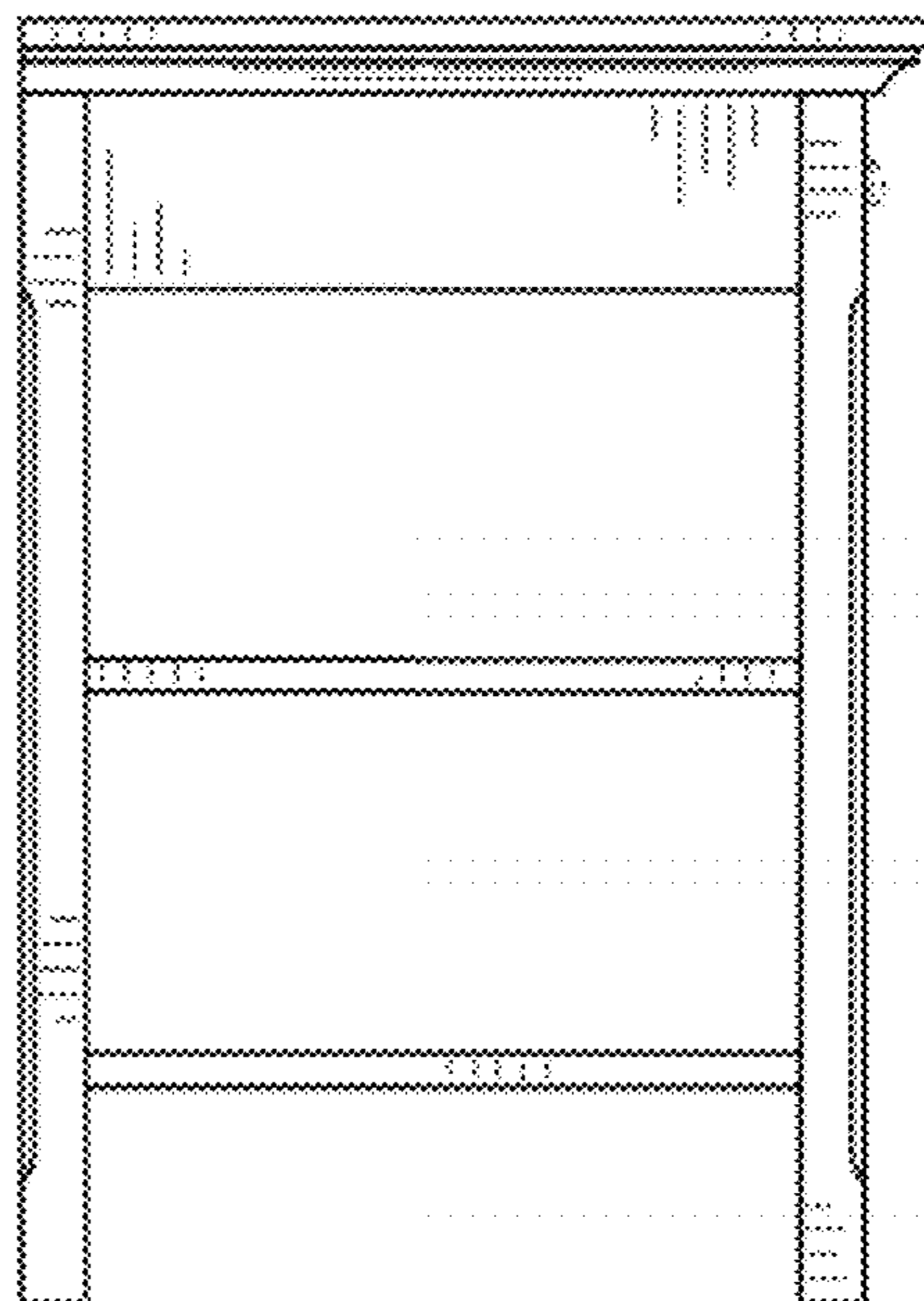
