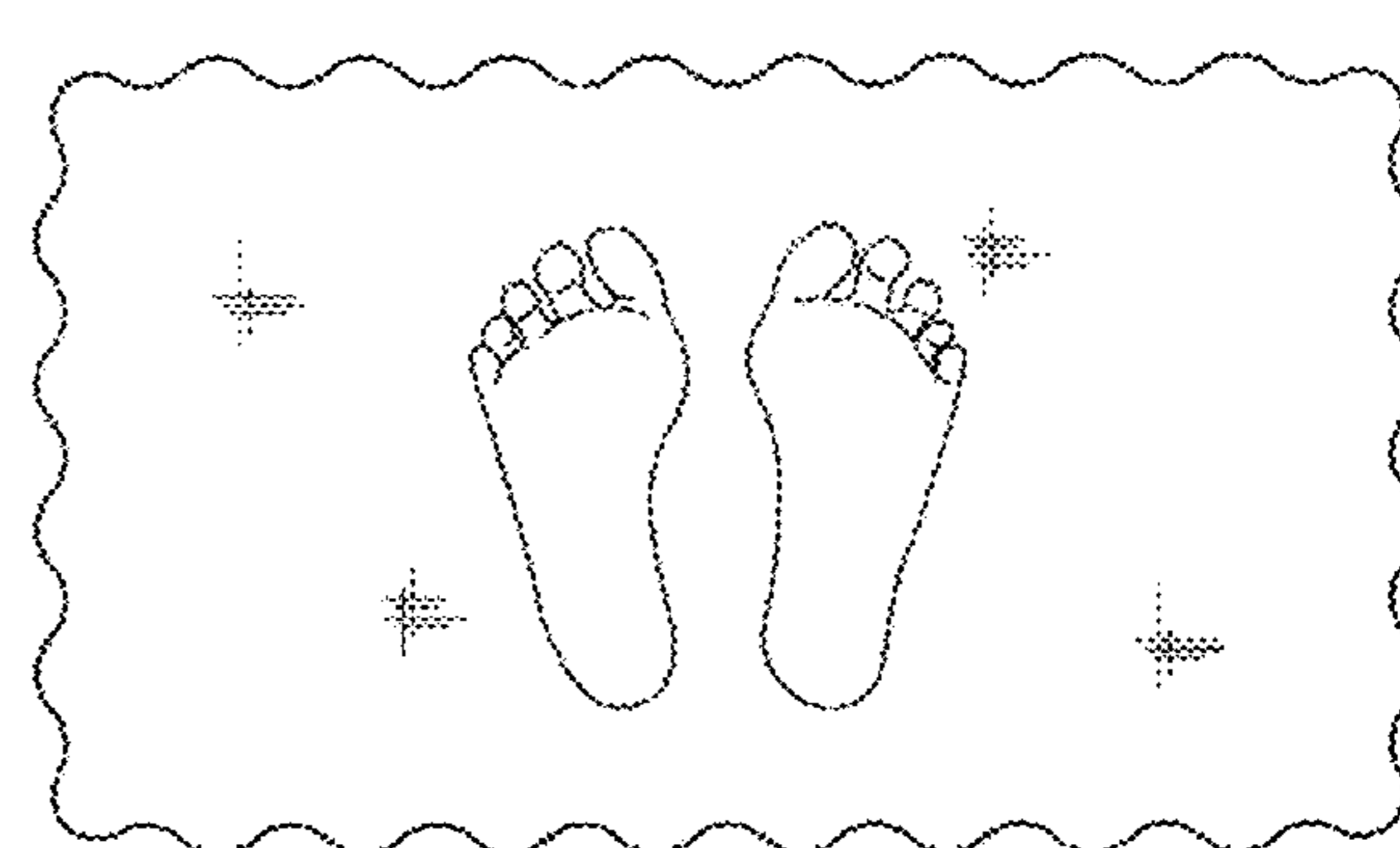
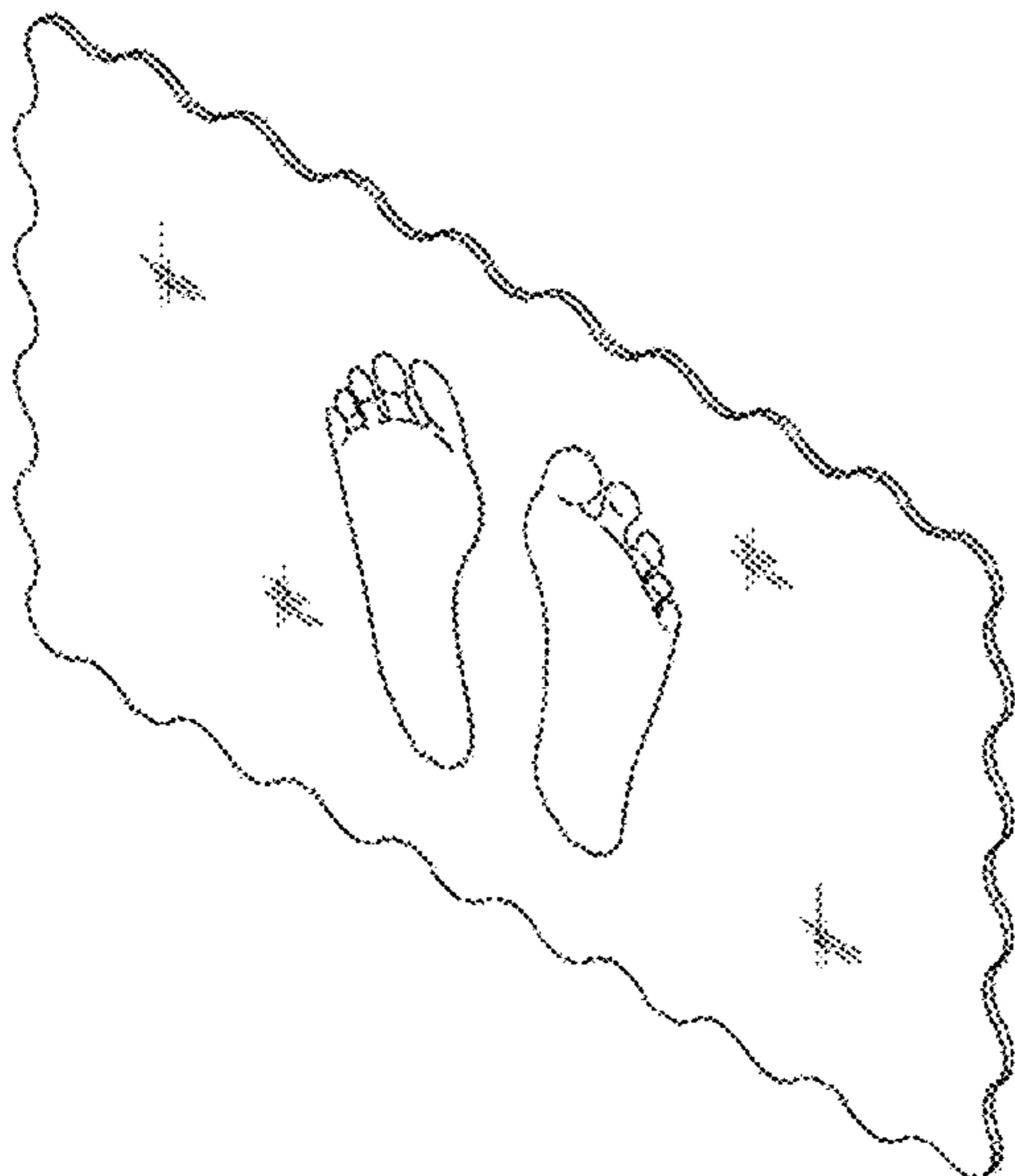
(57) **CLAIM**

The ornamental design for a disposable absorbent bathmat, as shown and described.

DESCRIPTION

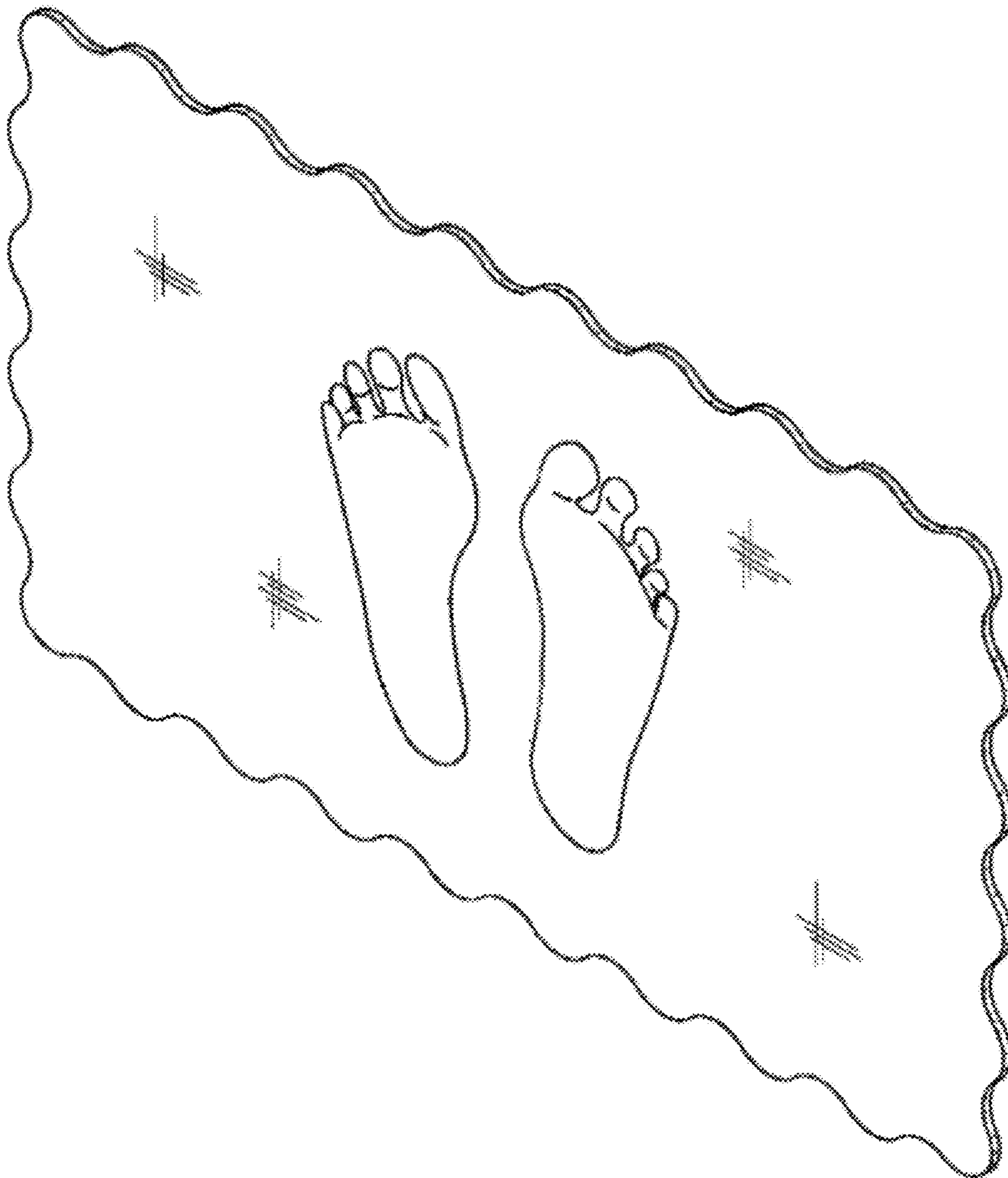

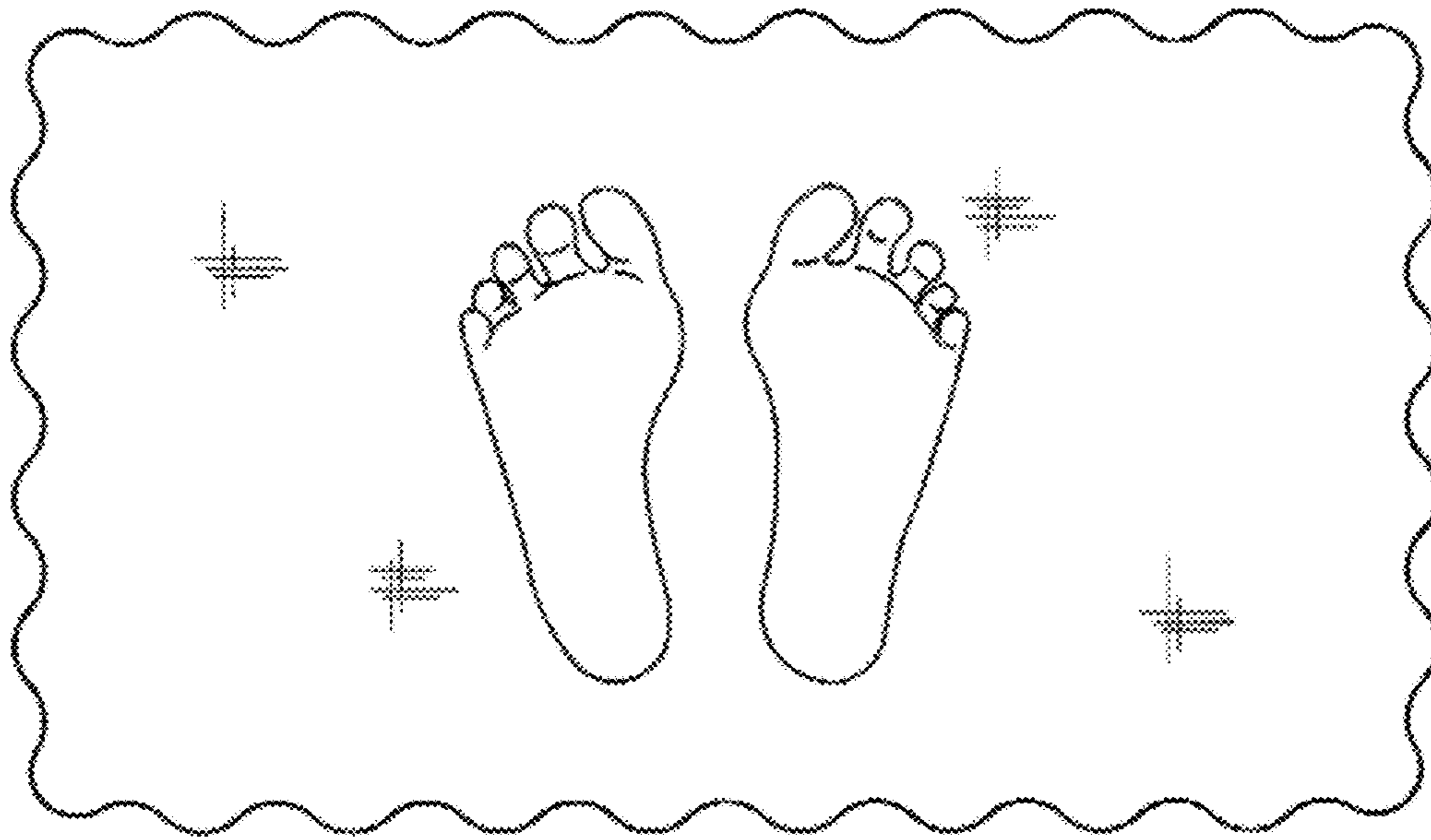
