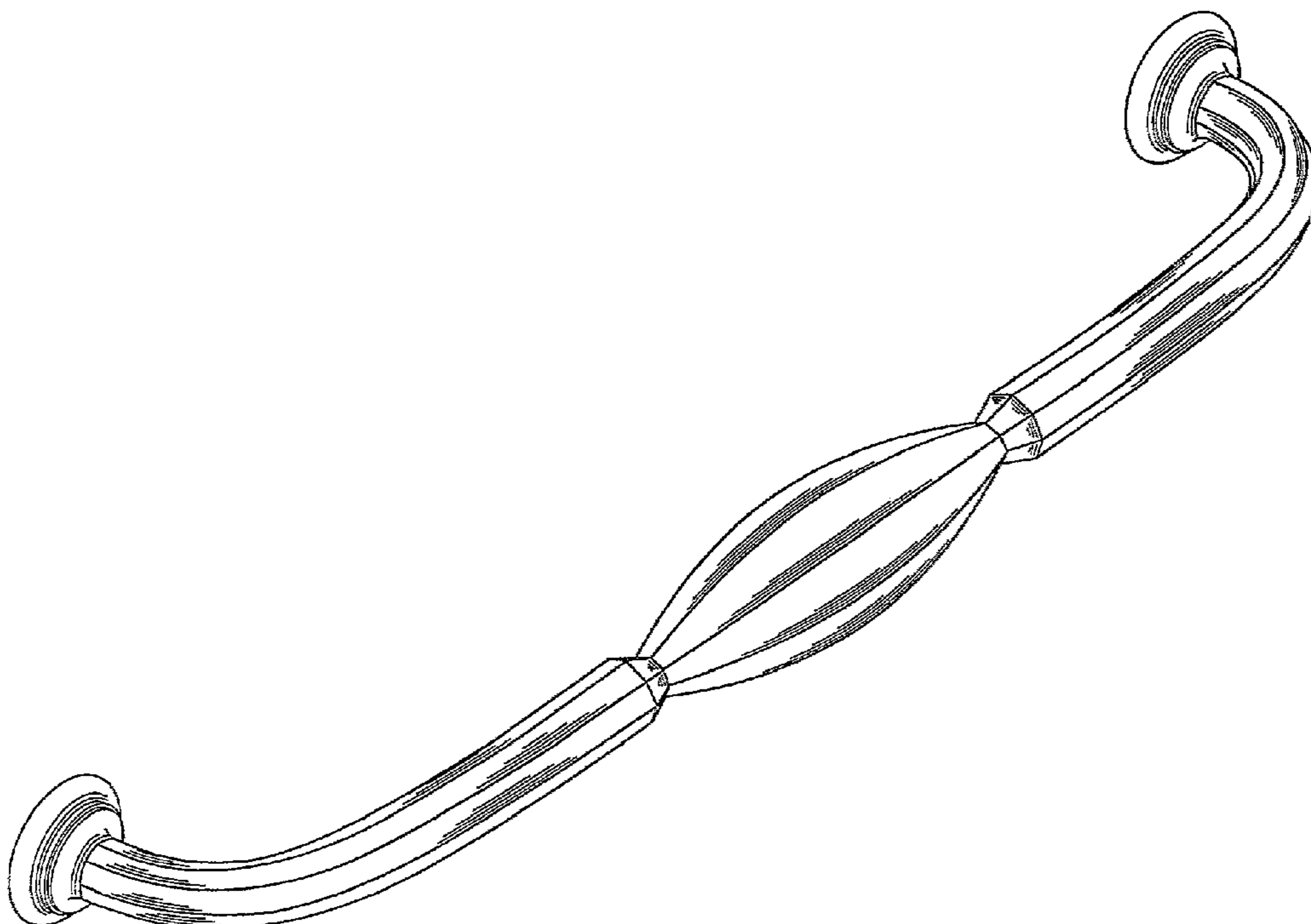
(57) **CLAIM**

The ornamental design for a pull handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view, of a pull handle showing my new design;  
FIG. 2 is a first end elevational view thereof, the opposite end elevational view being identical thereto;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a first side elevational view thereof, the opposite side elevational view being identical thereto; and,  
FIG. 5 is a top plan view thereof.

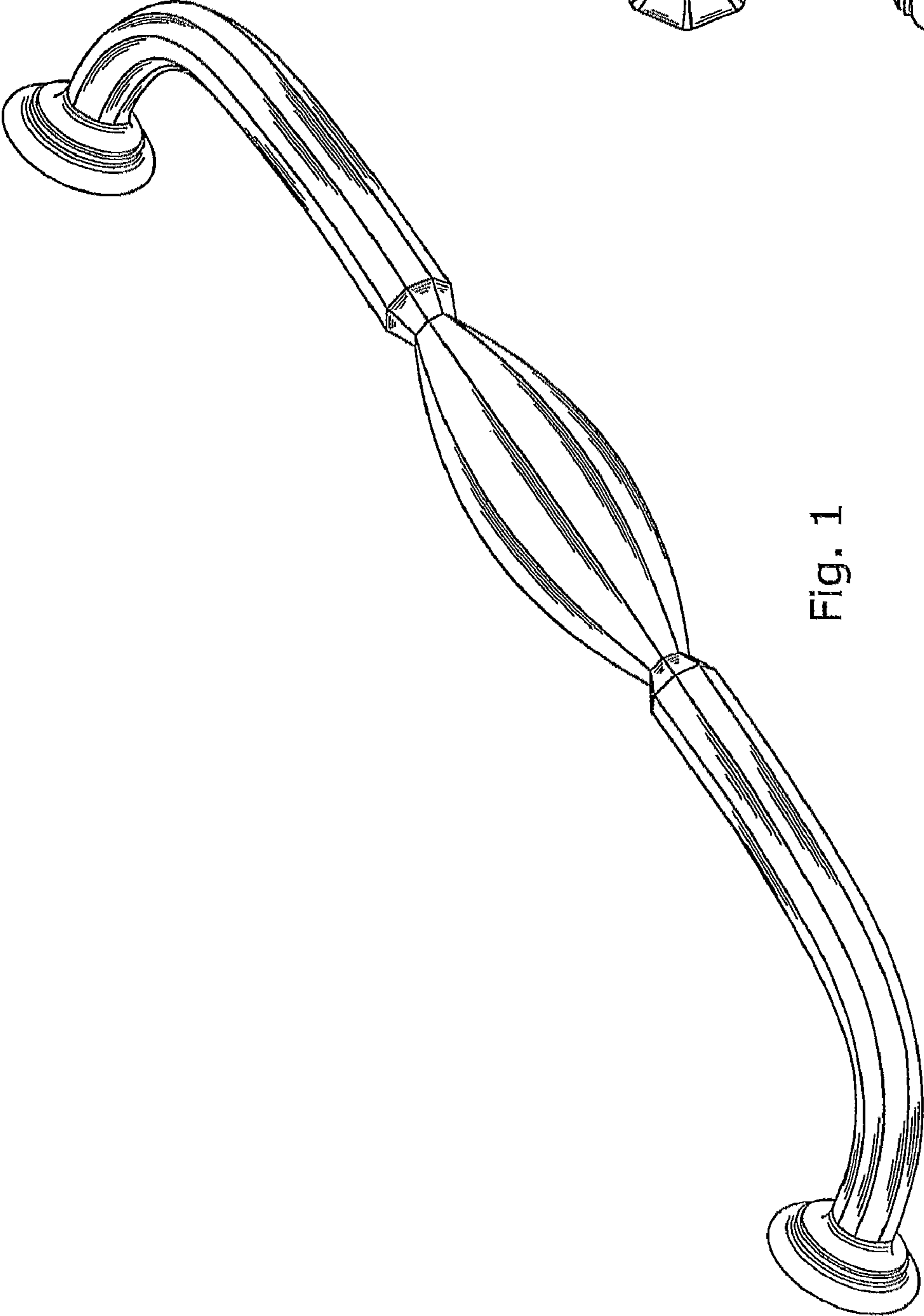

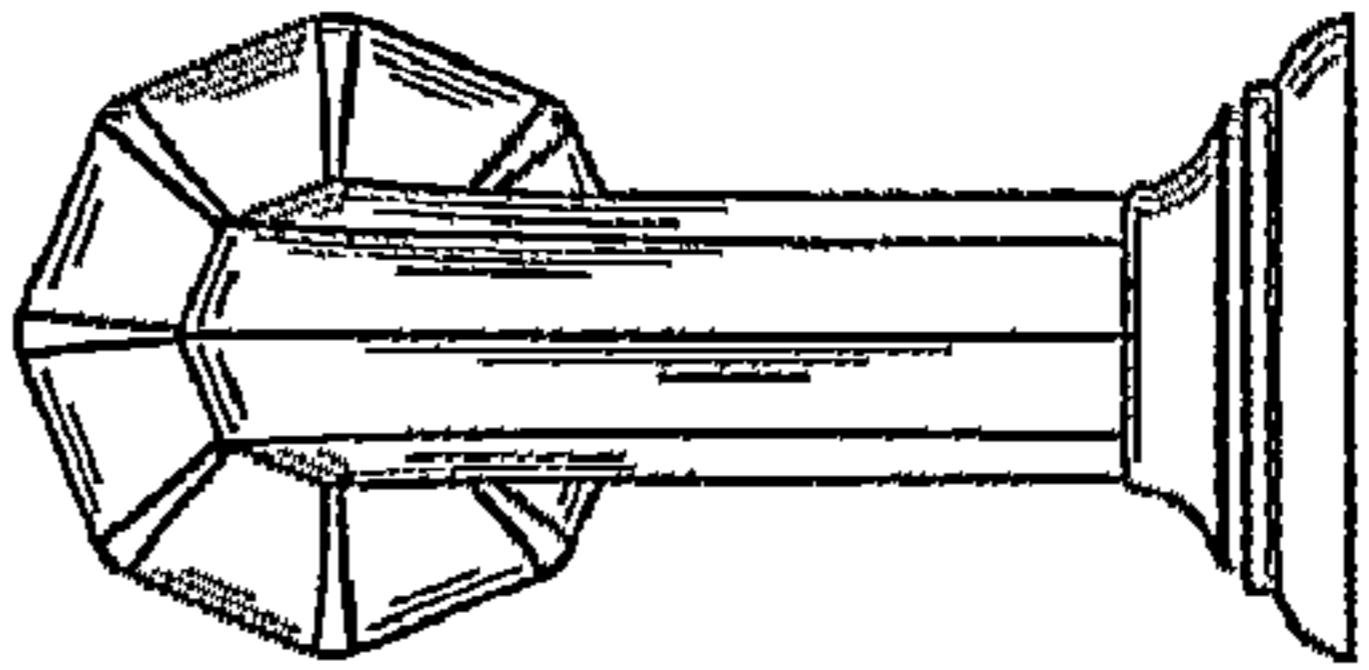

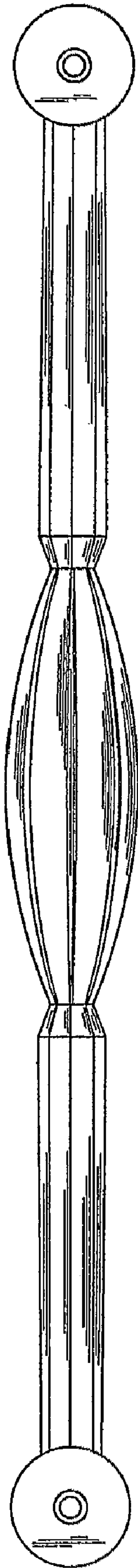

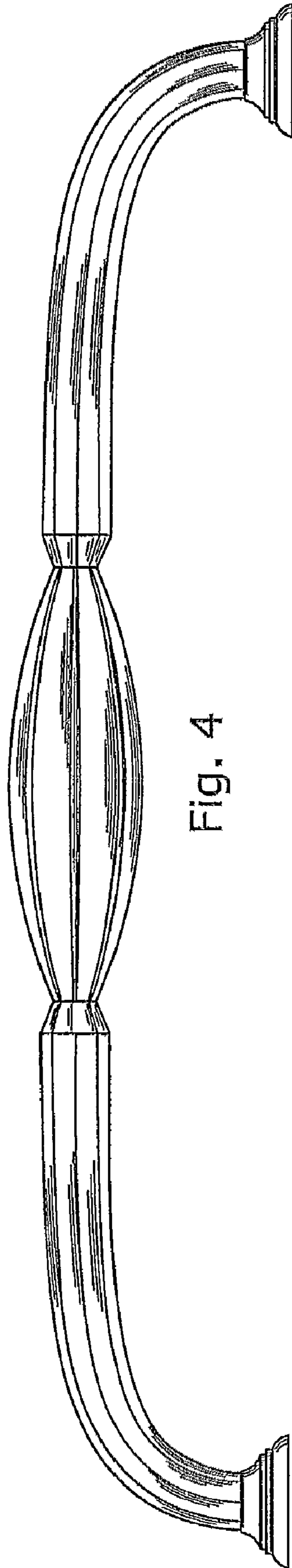

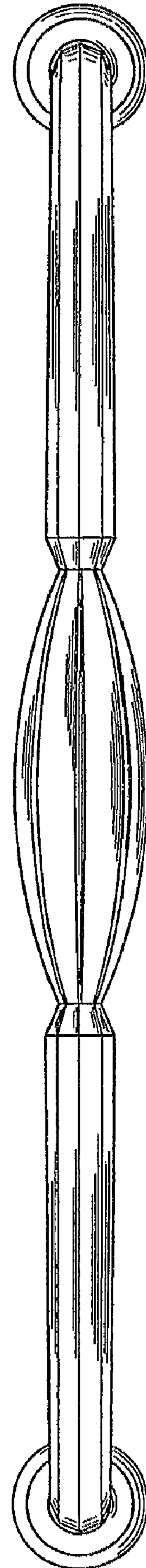
