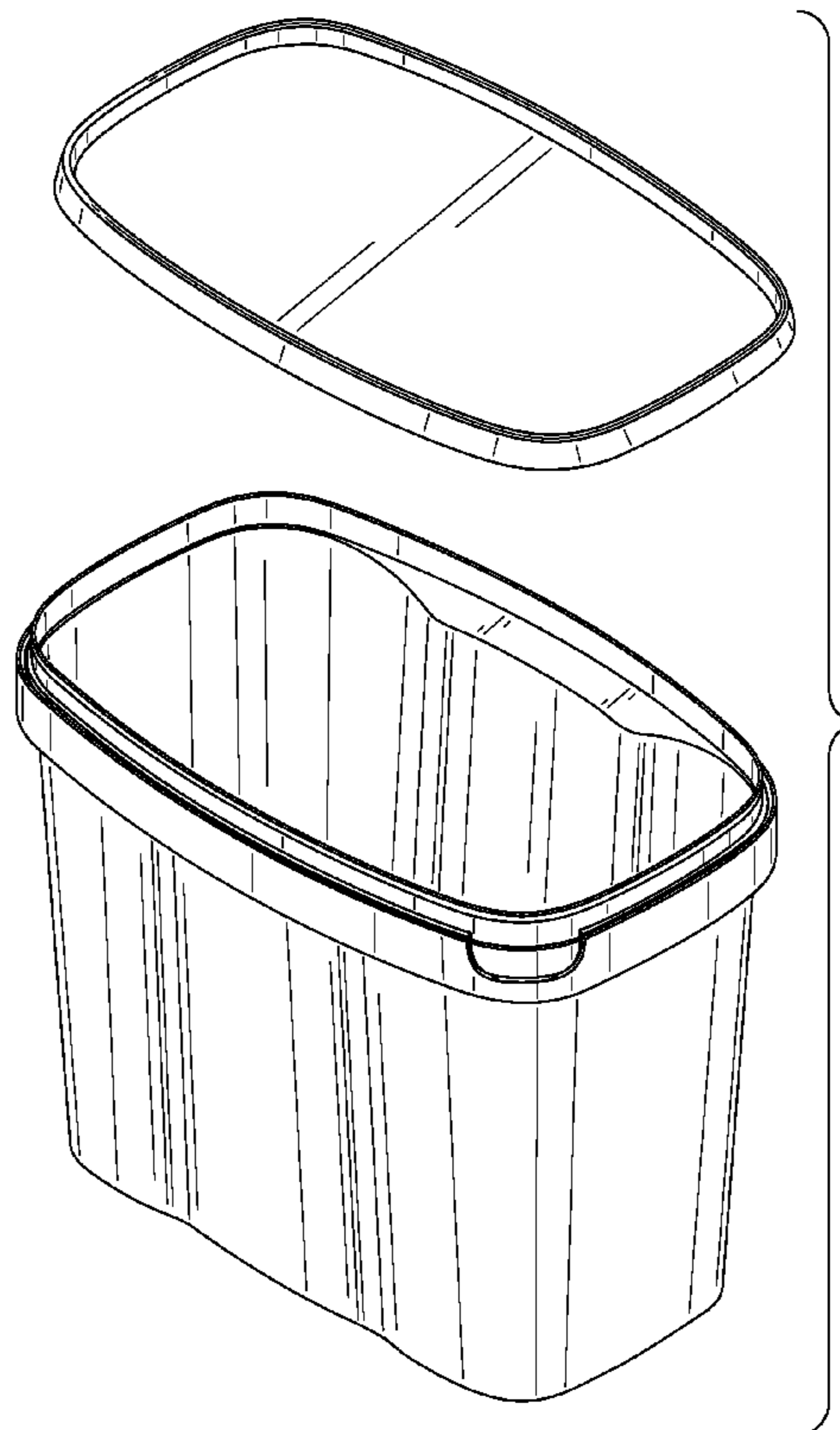
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a container showing our design without the lid for clarity of detail; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a back elevation view thereof; FIG. 5 is a right elevation view thereof; FIG. 6 is a left elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a top perspective exploded view thereof including the lid for use with the container.

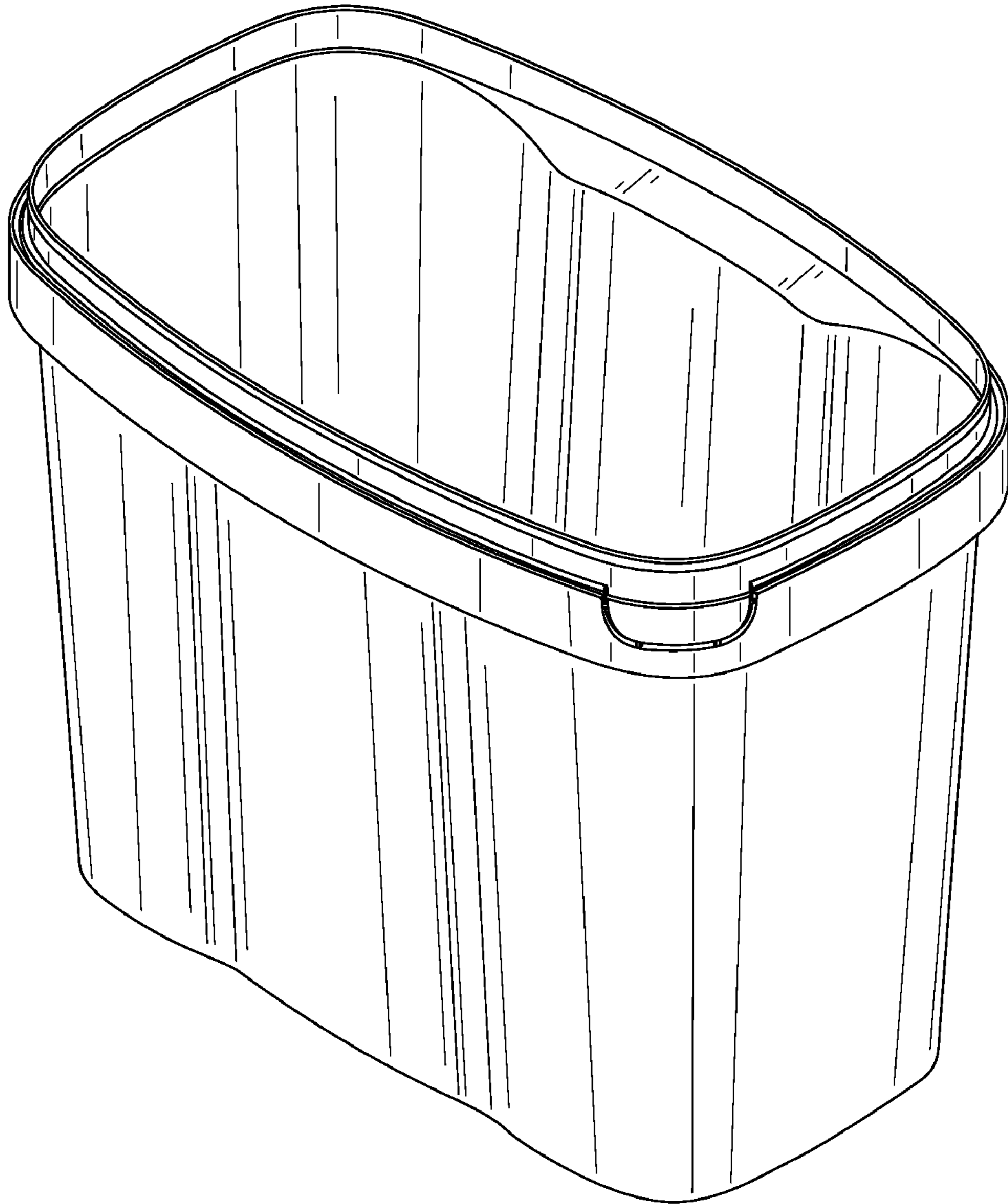

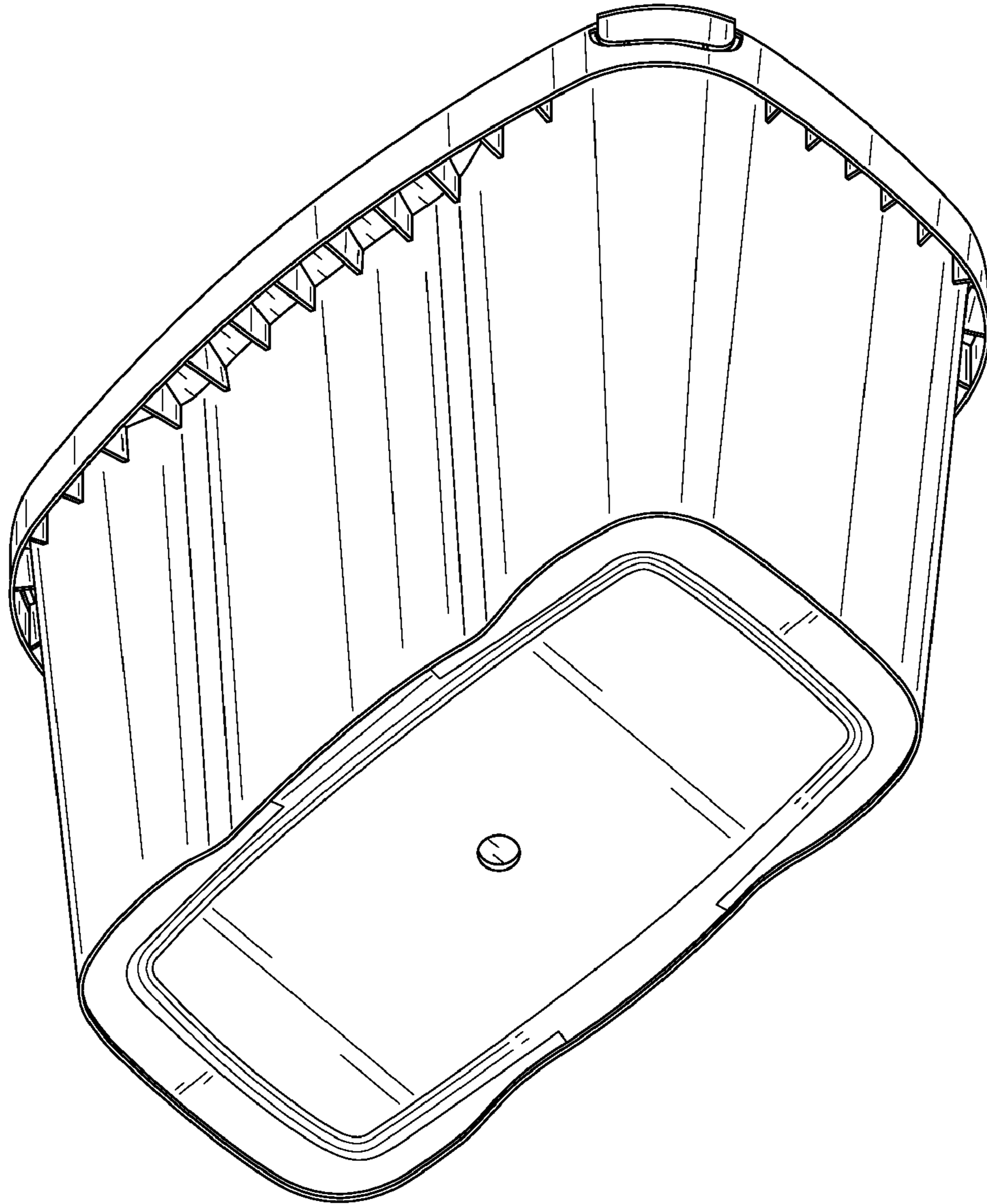

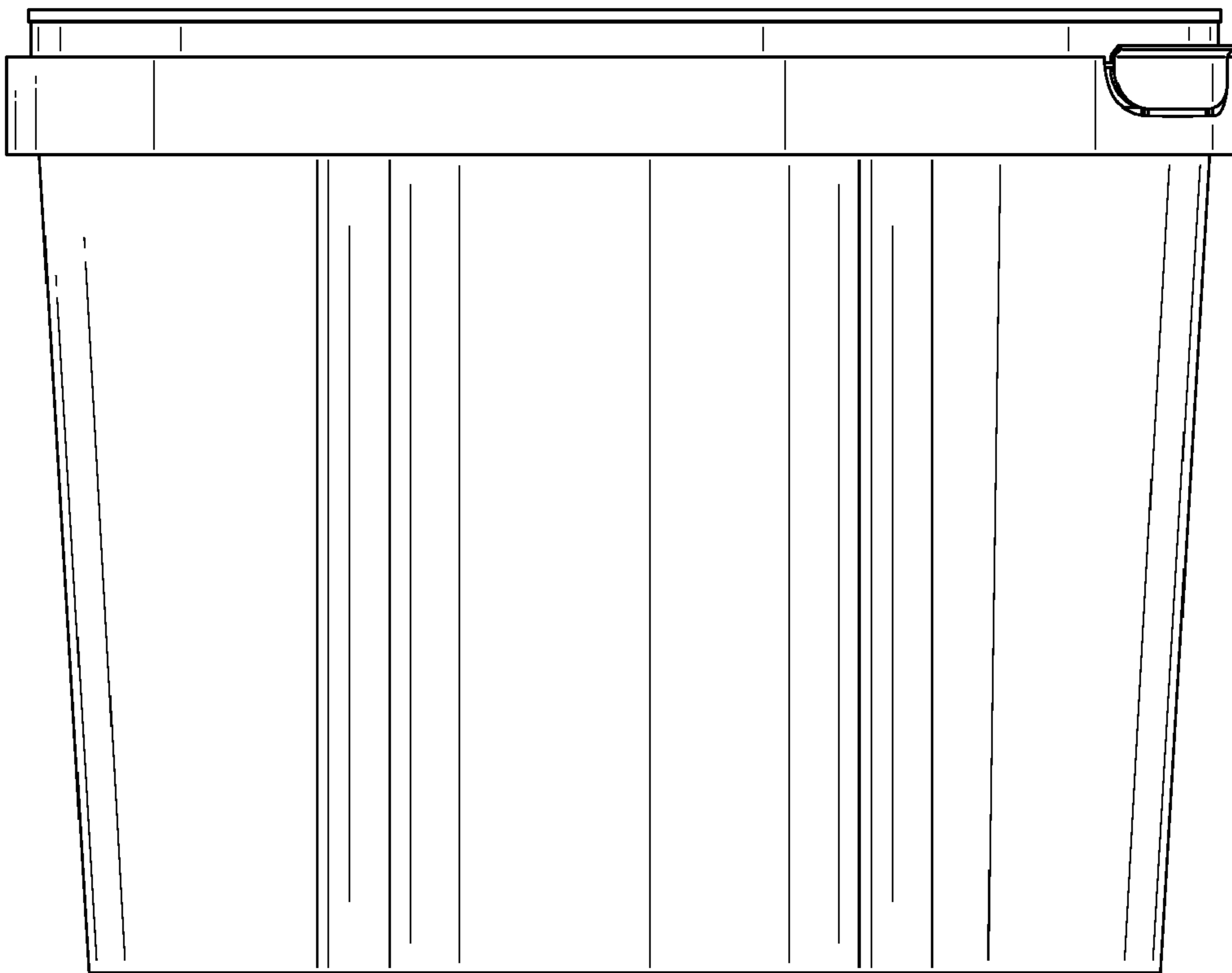

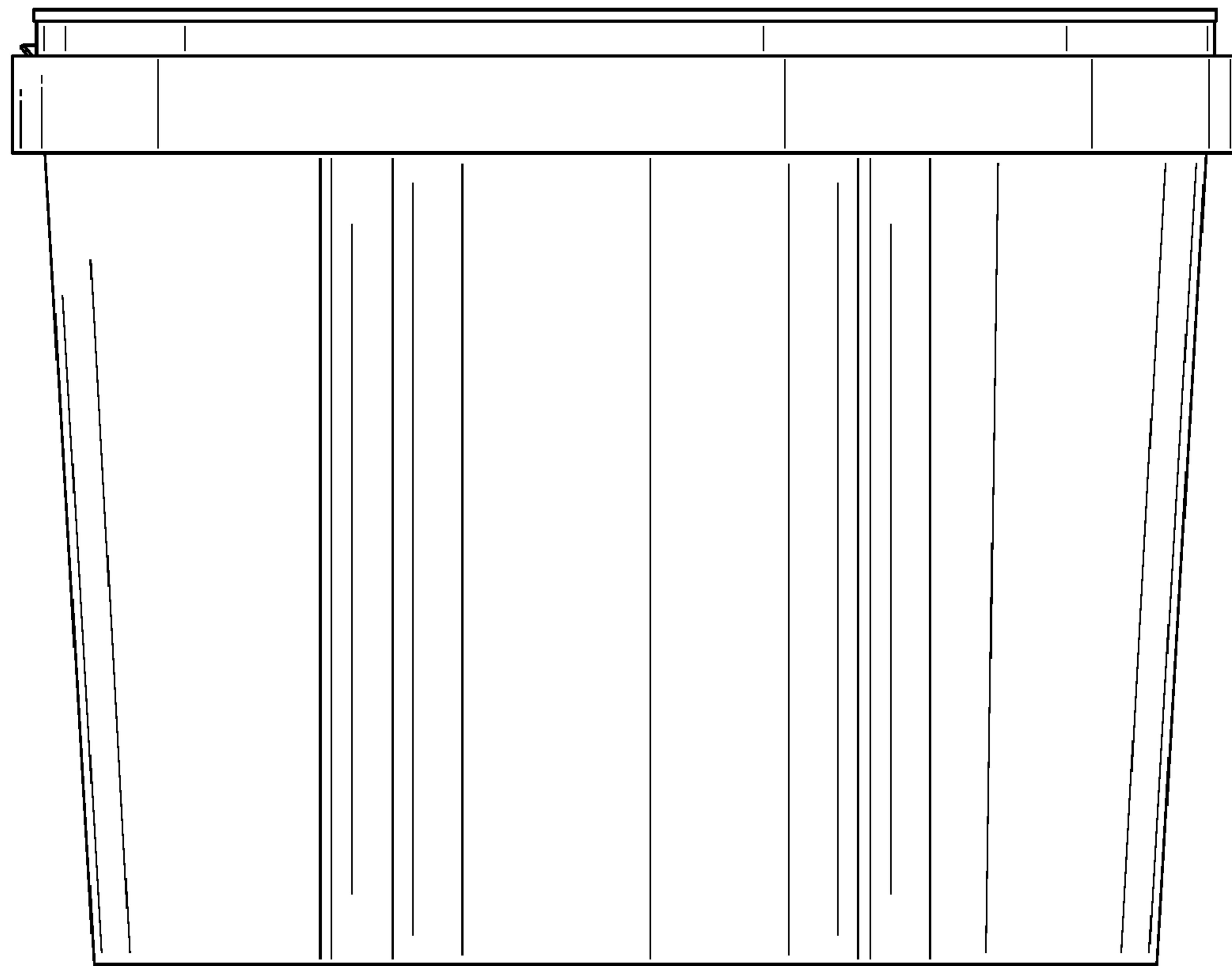

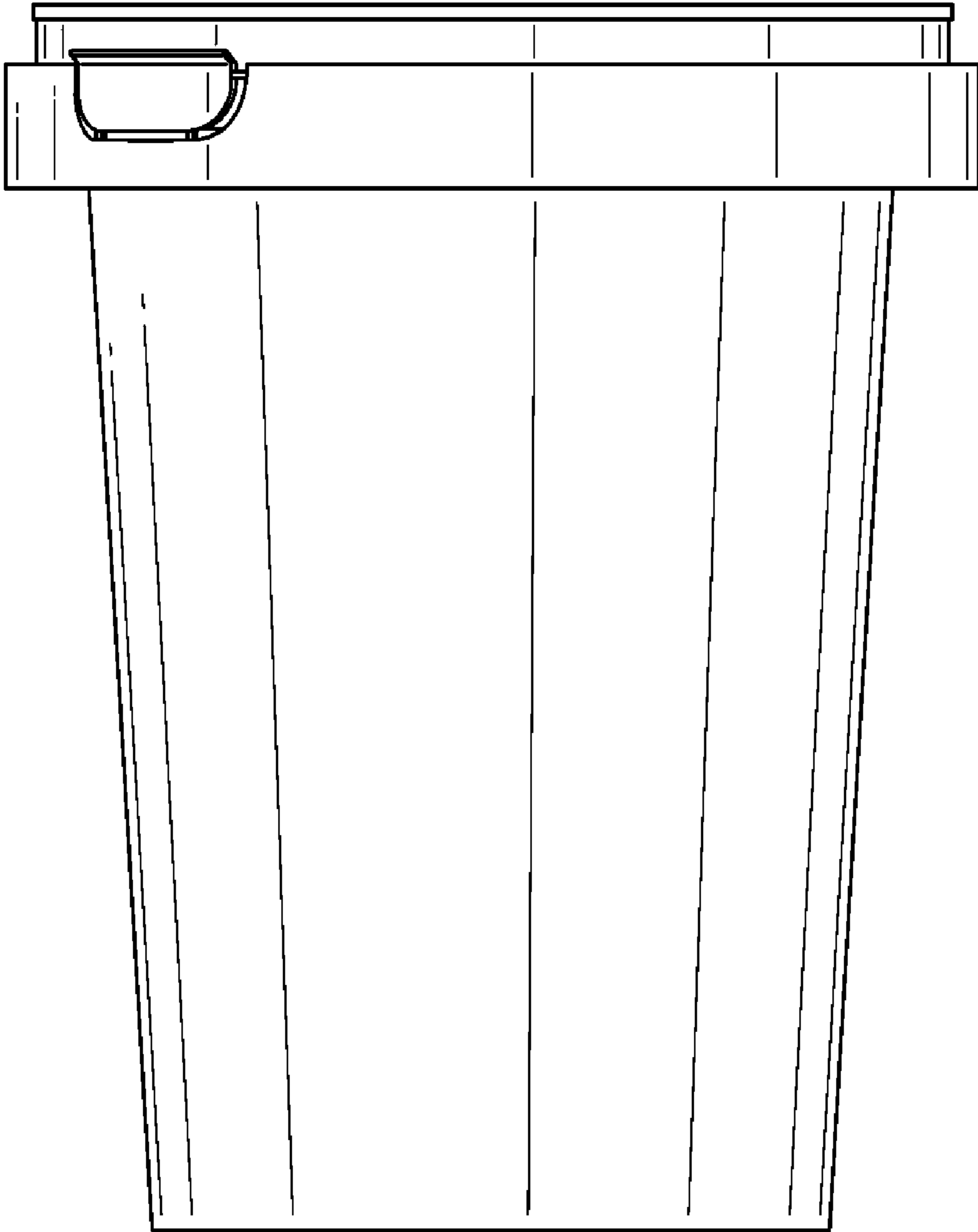

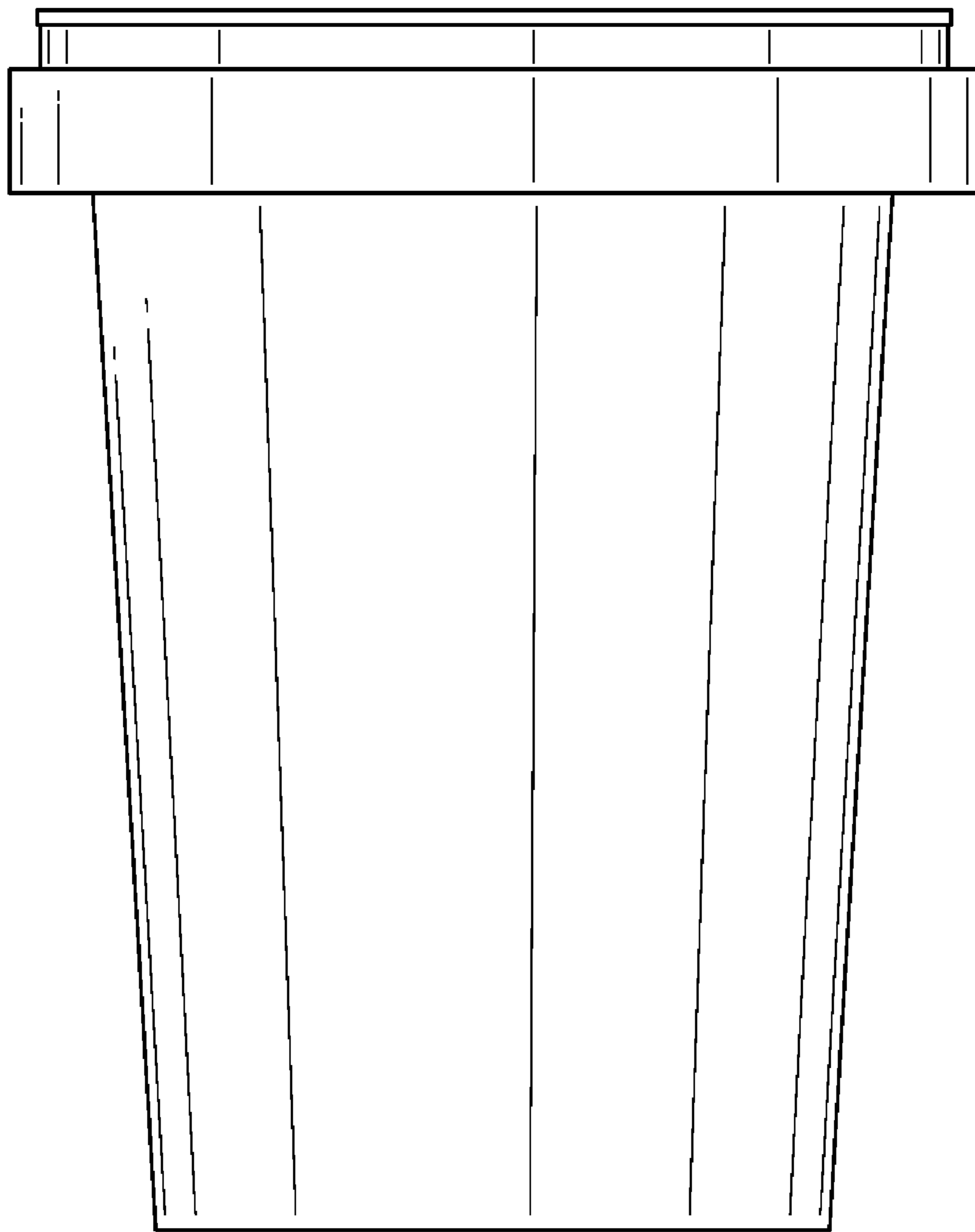

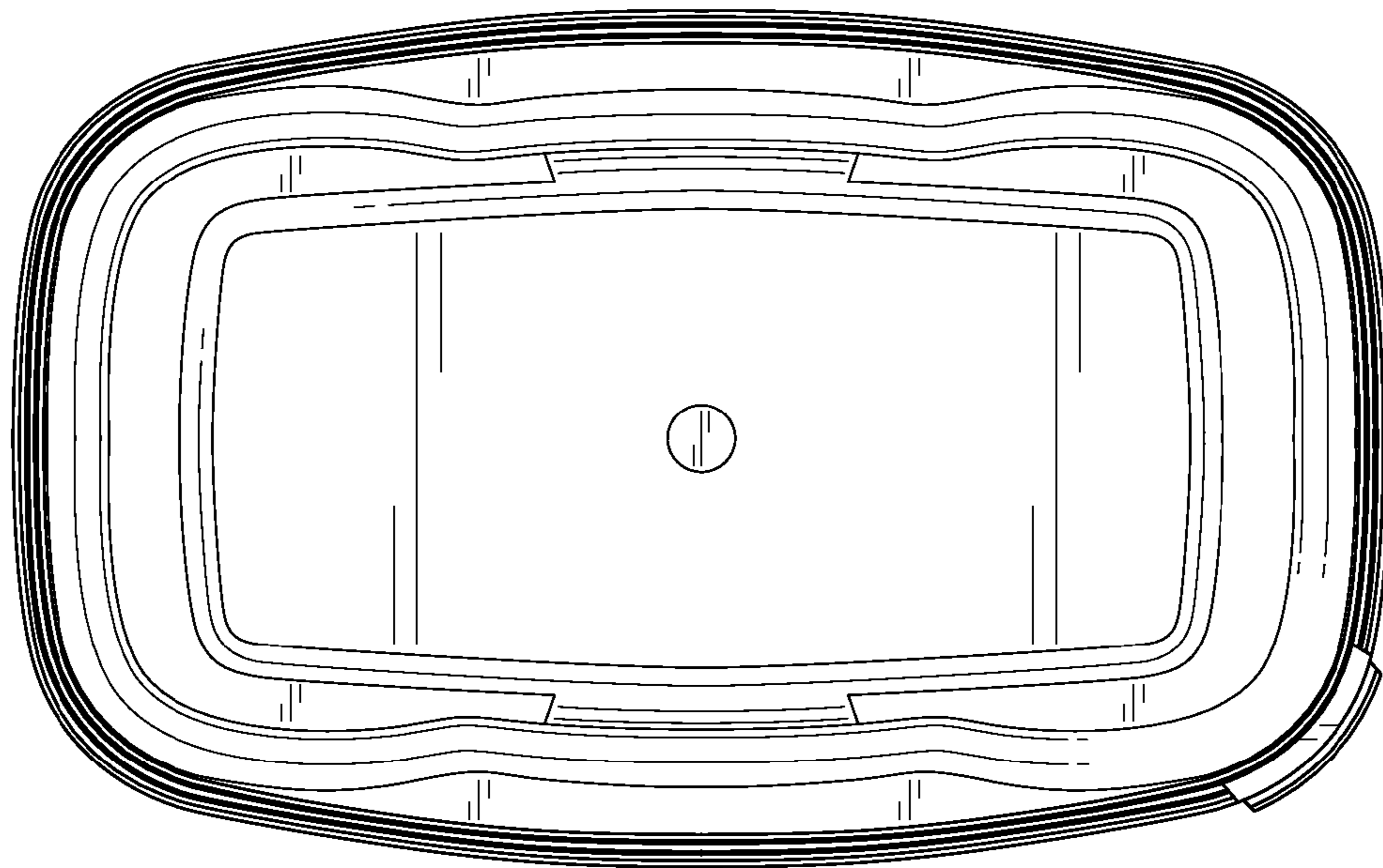

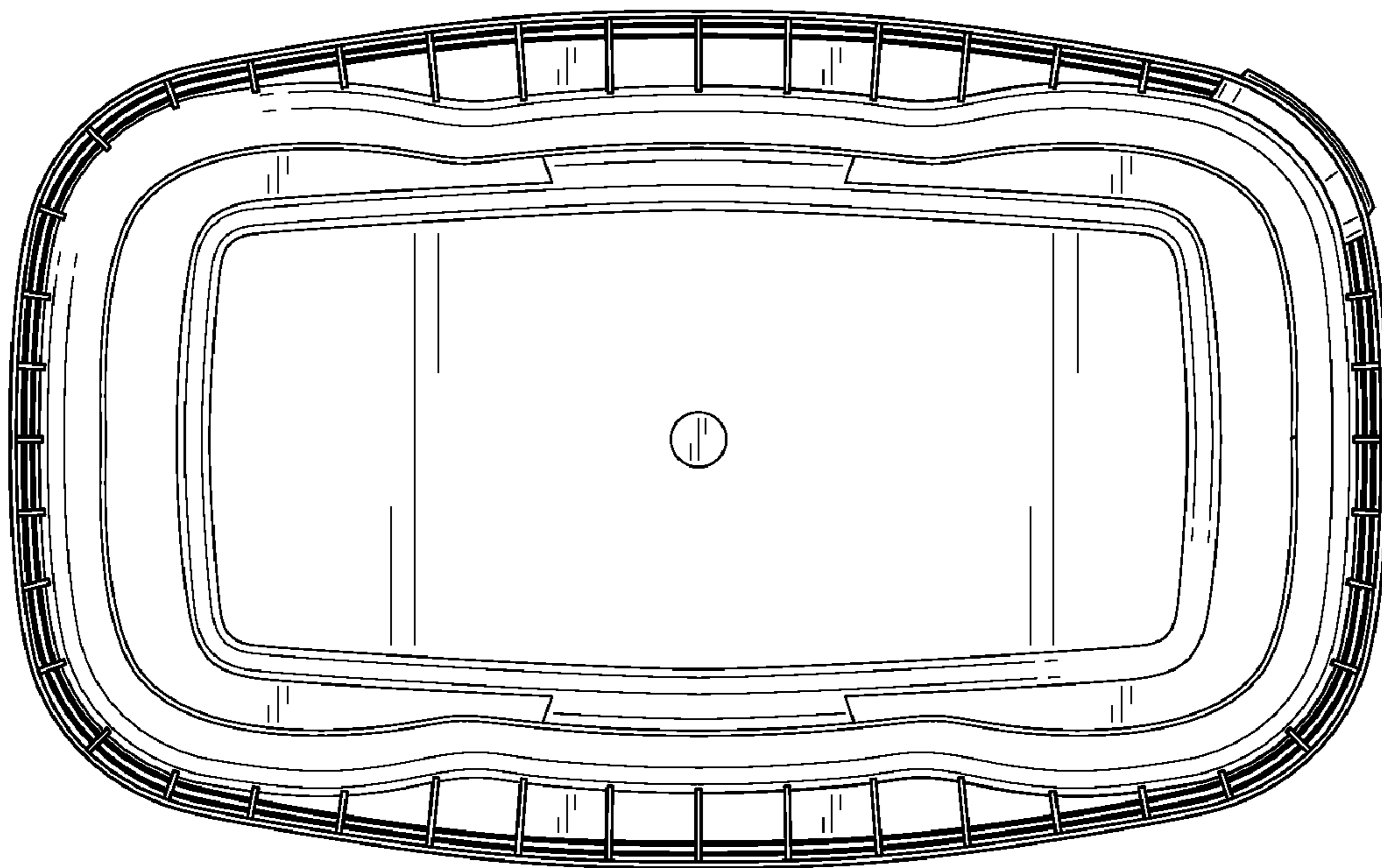

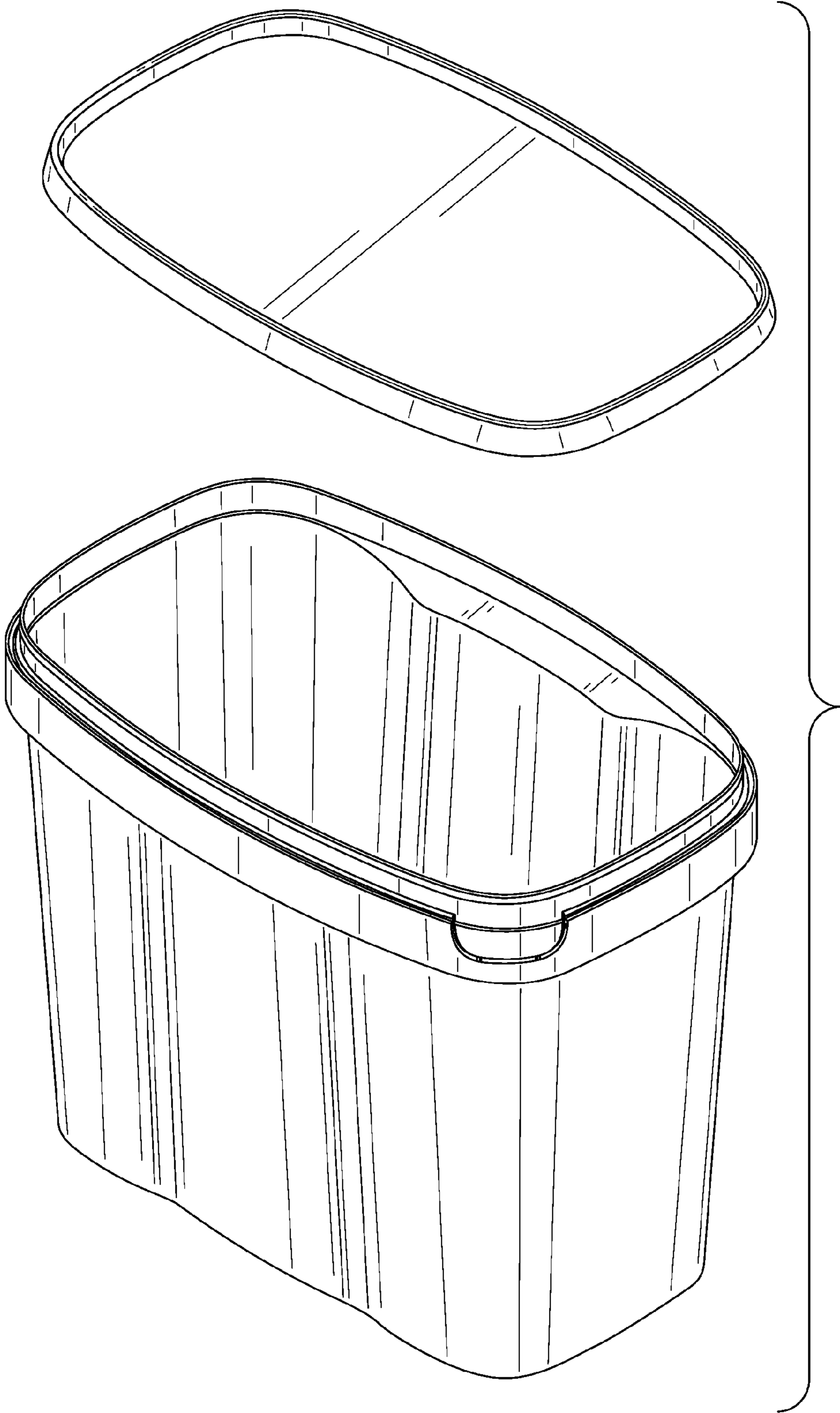
