The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top front, left side perspective view of a bottle
showing our new design;

FIG. 2 is a front elevational view thereof,

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view thereof, the left side
elevational view being a mirror image;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

purpose of illustrating environmental structure and form no
part of the claimed design.

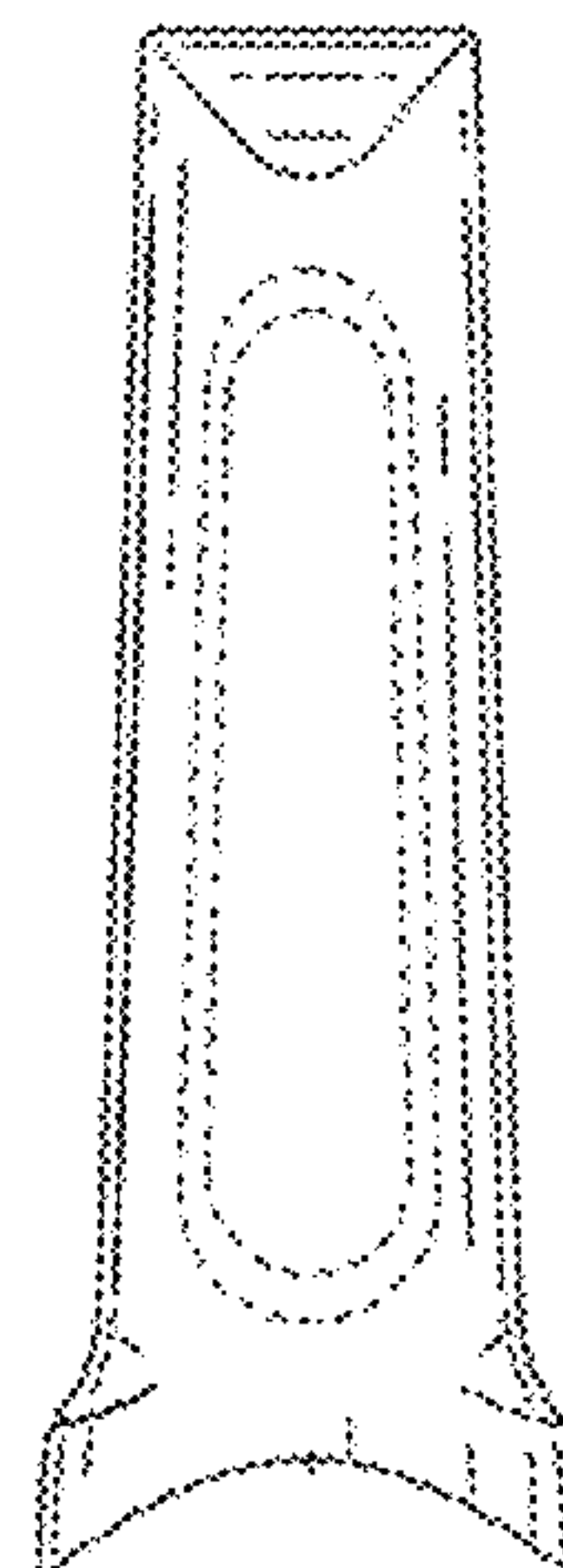
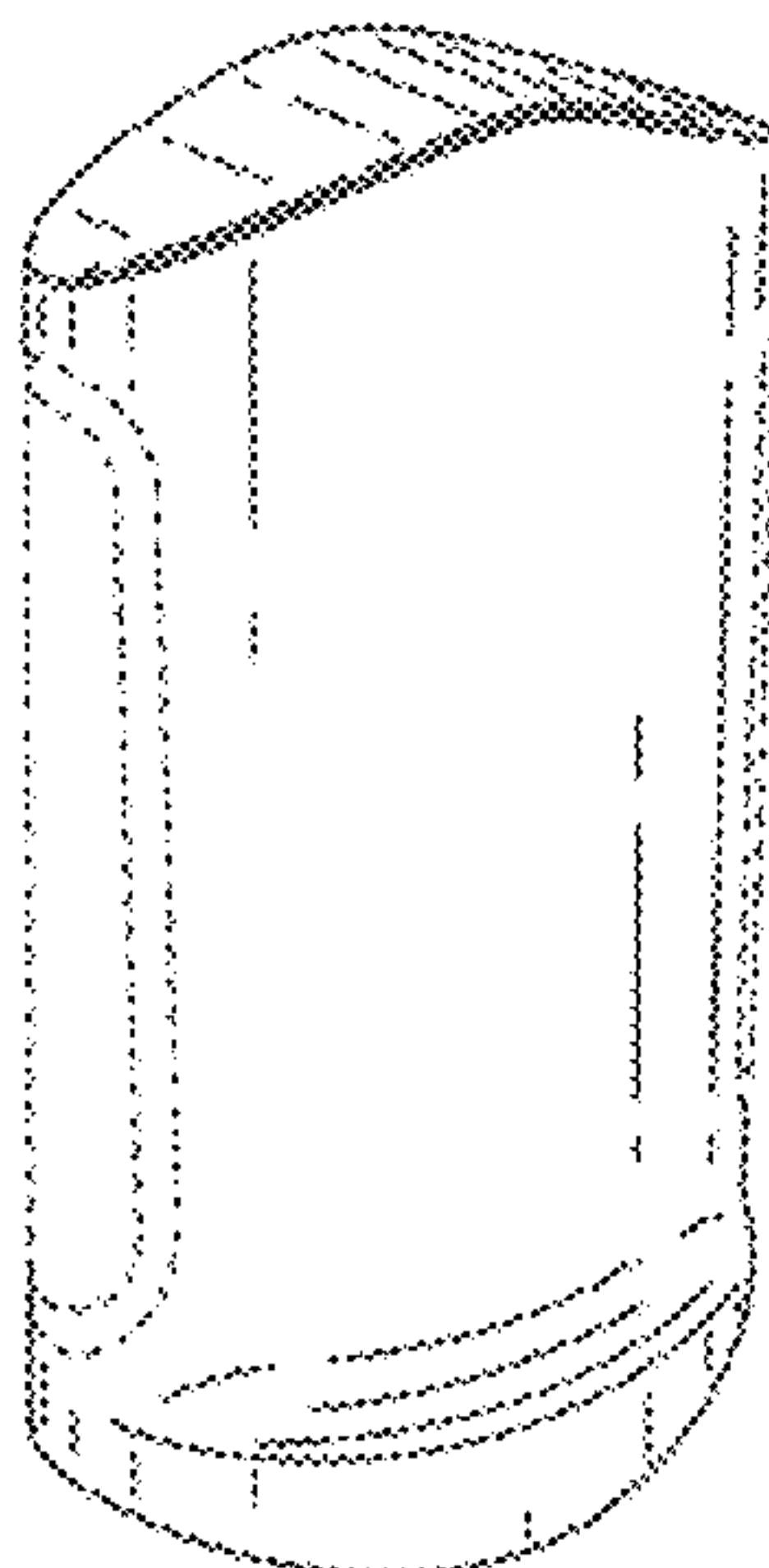

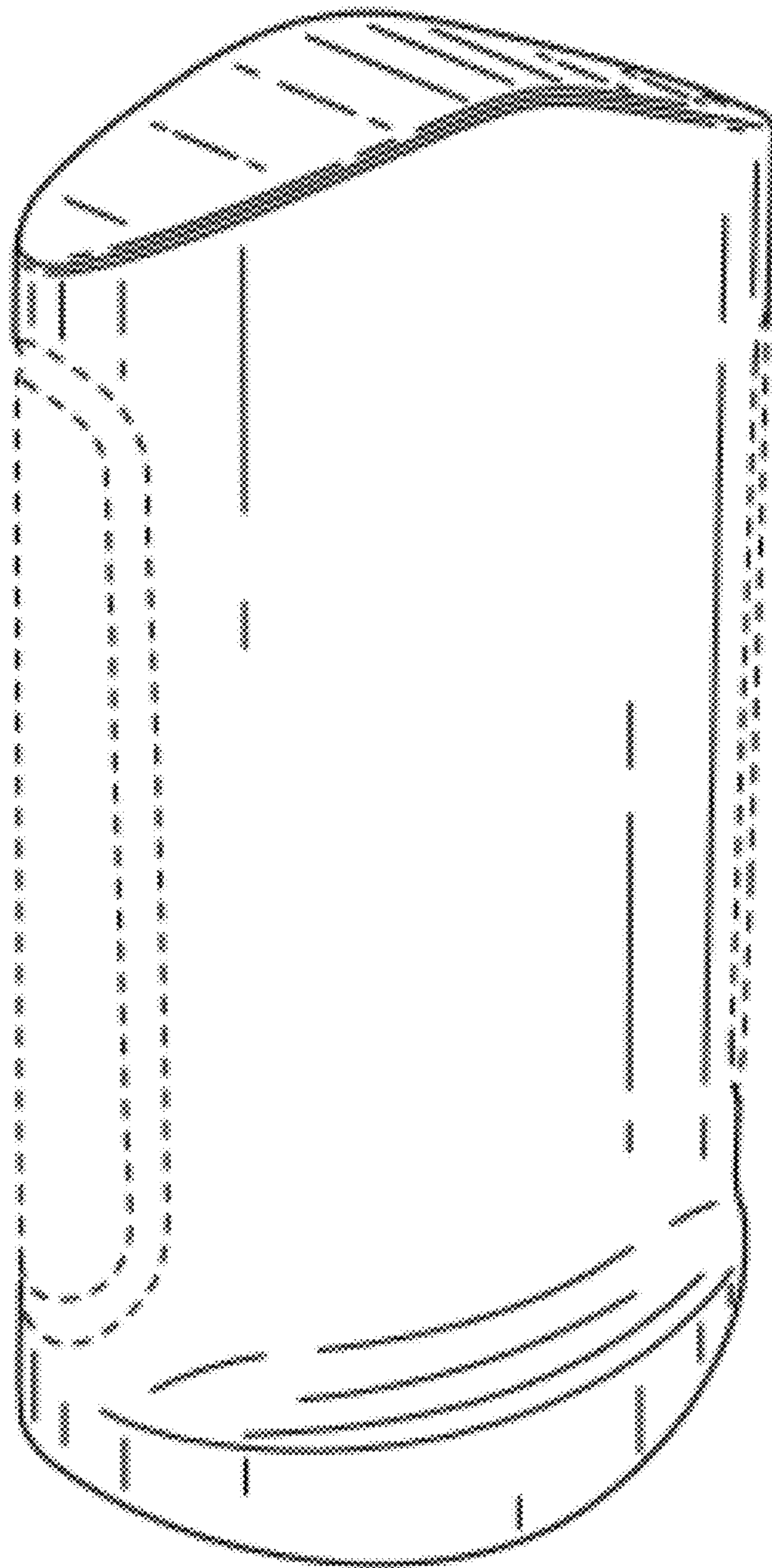

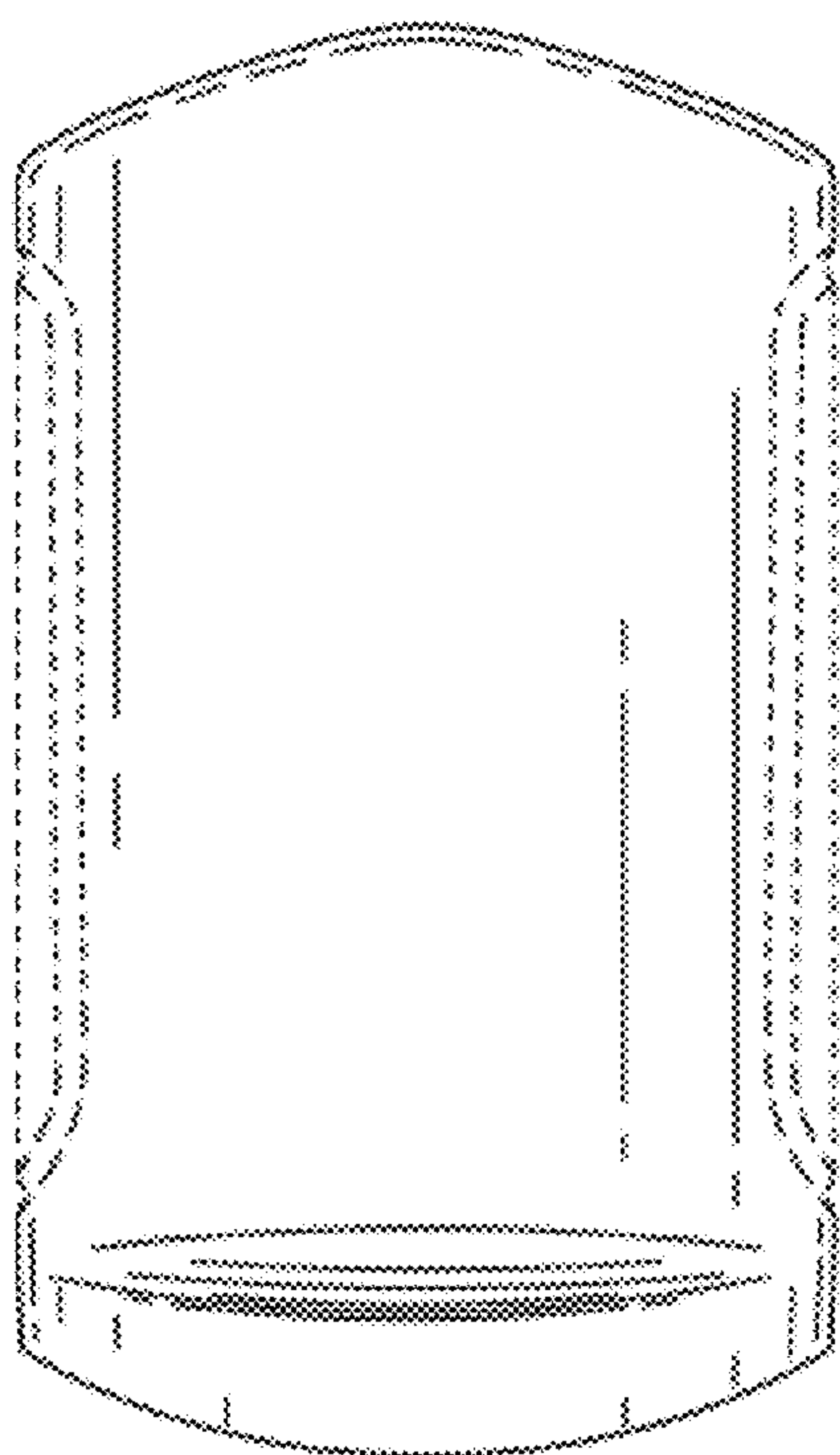

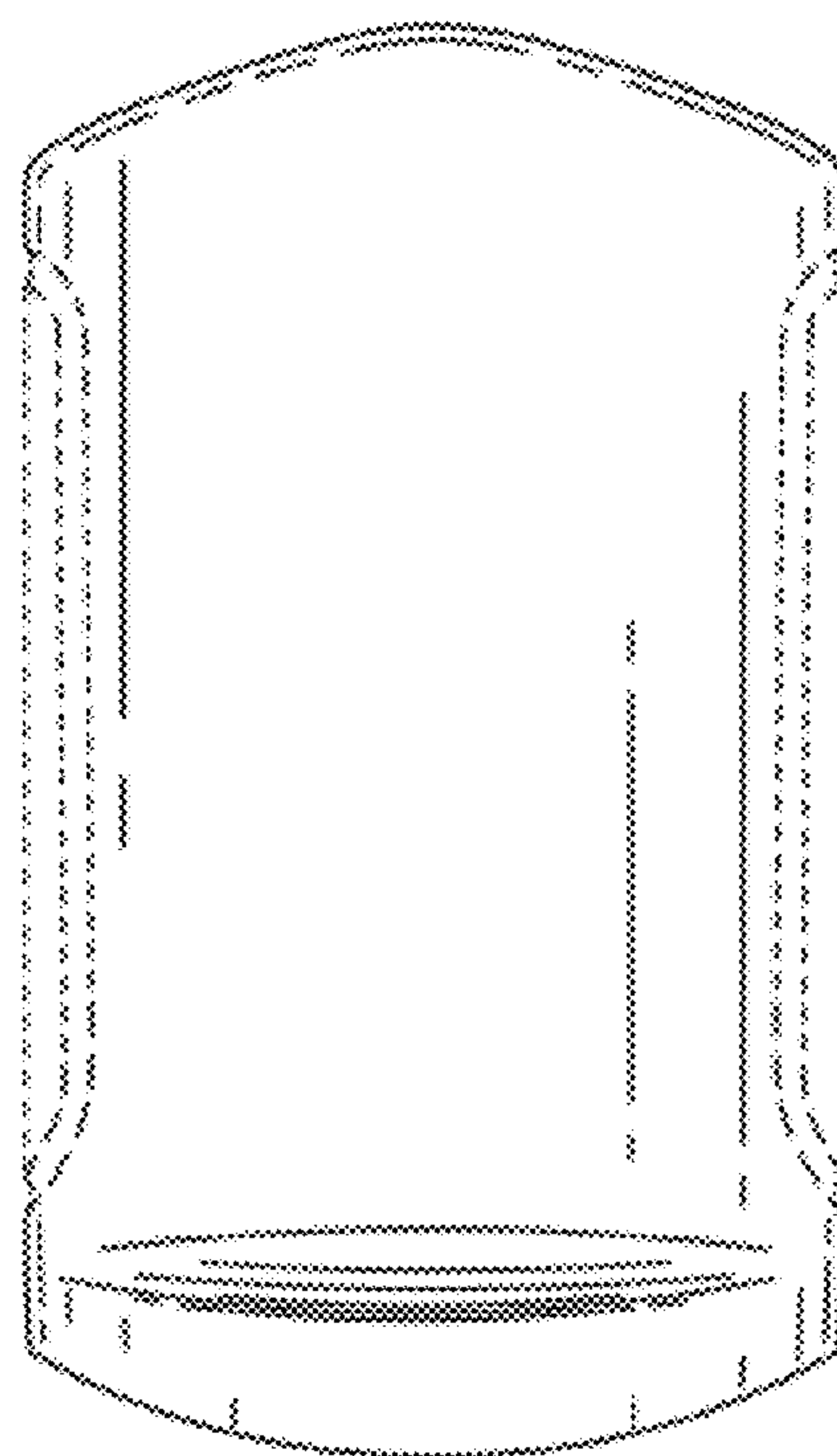

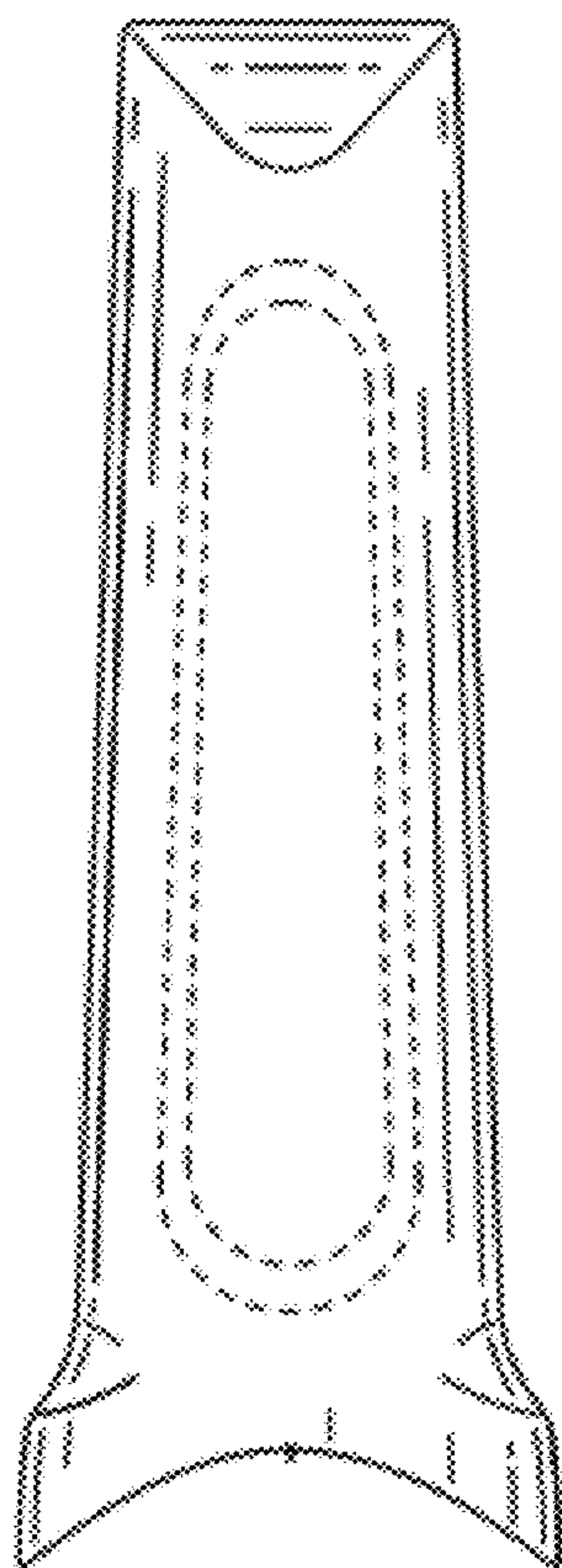

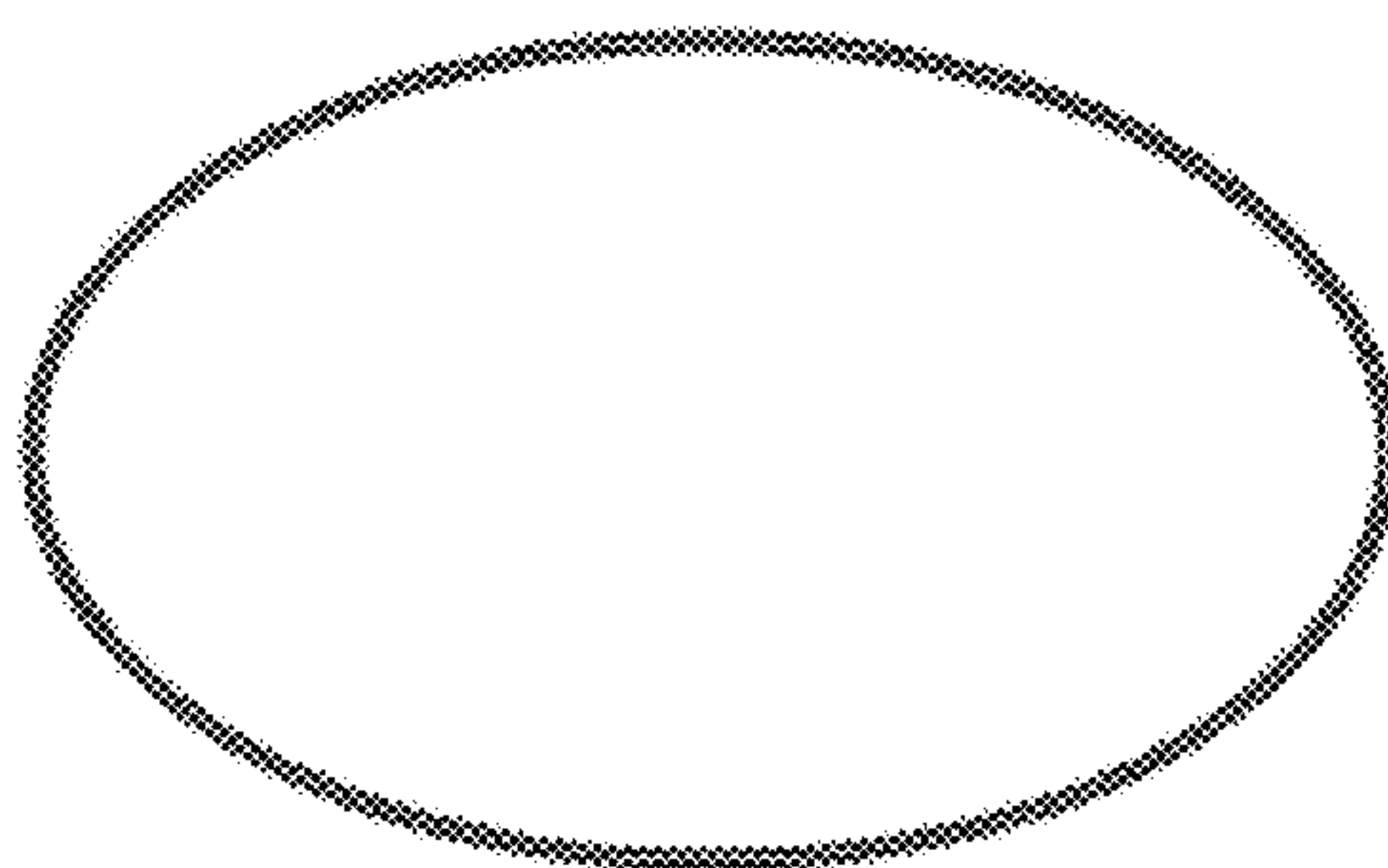
