The ornamental design for a food container, as shown and described.

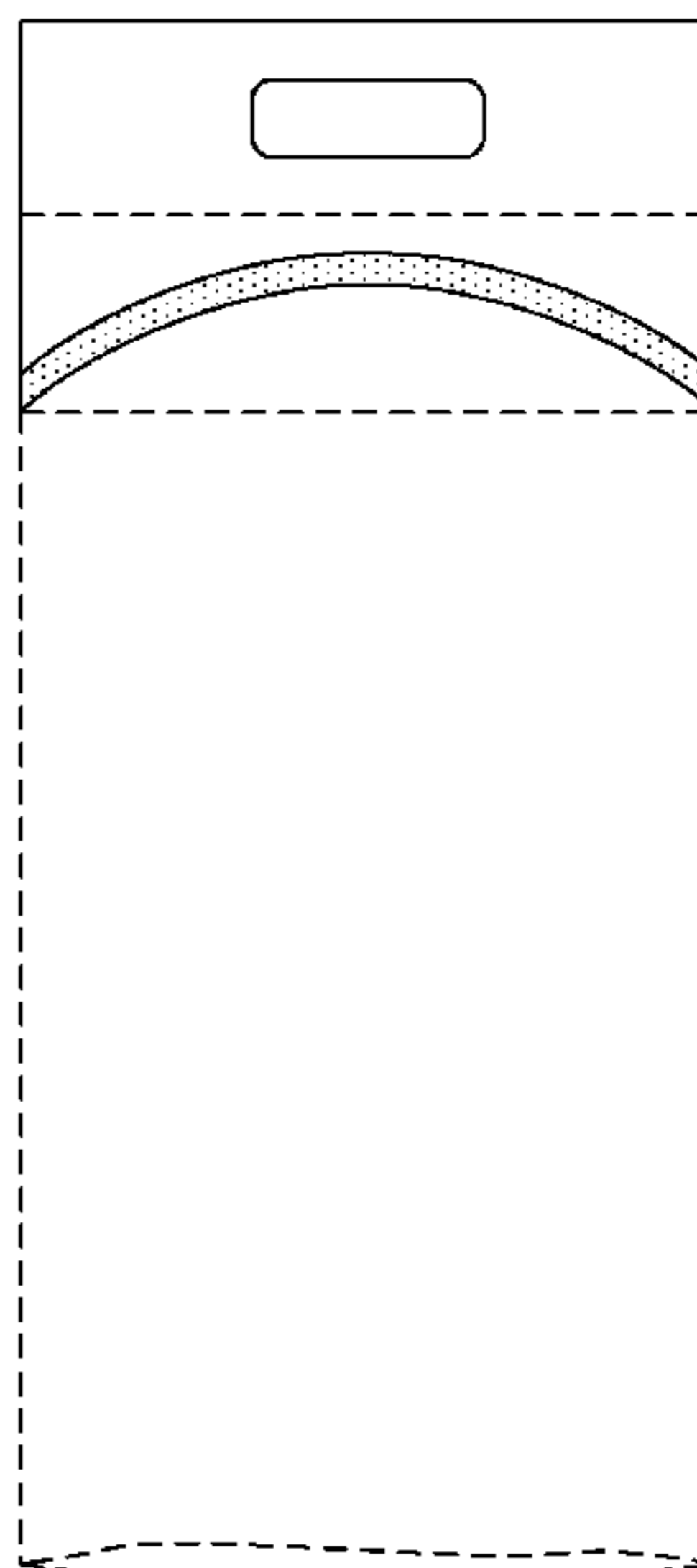
DESCRIPTION
