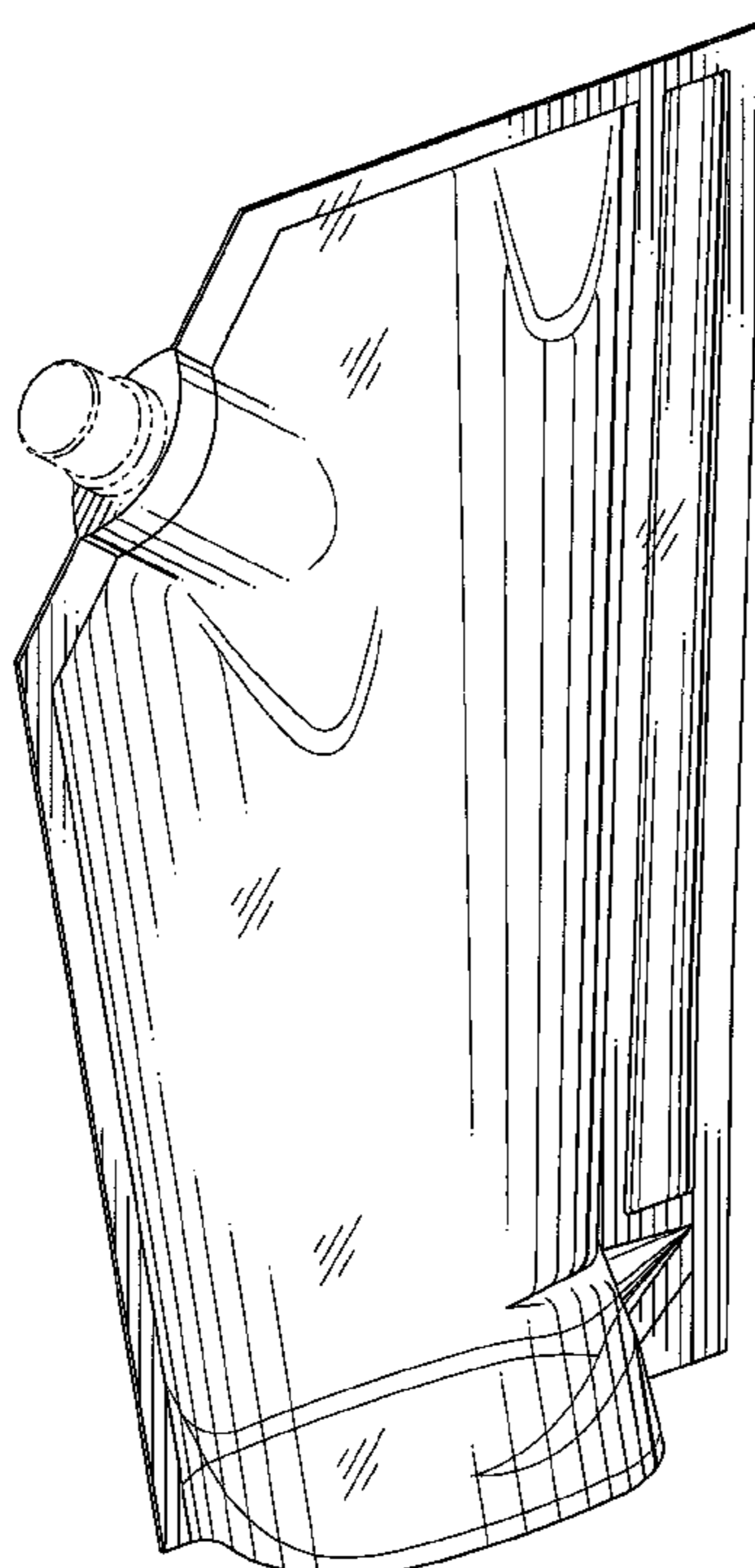
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of a container, showing our new design;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a left elevation view thereof, the opposite side being a mirror image of the side shown;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is a back elevation view thereof;

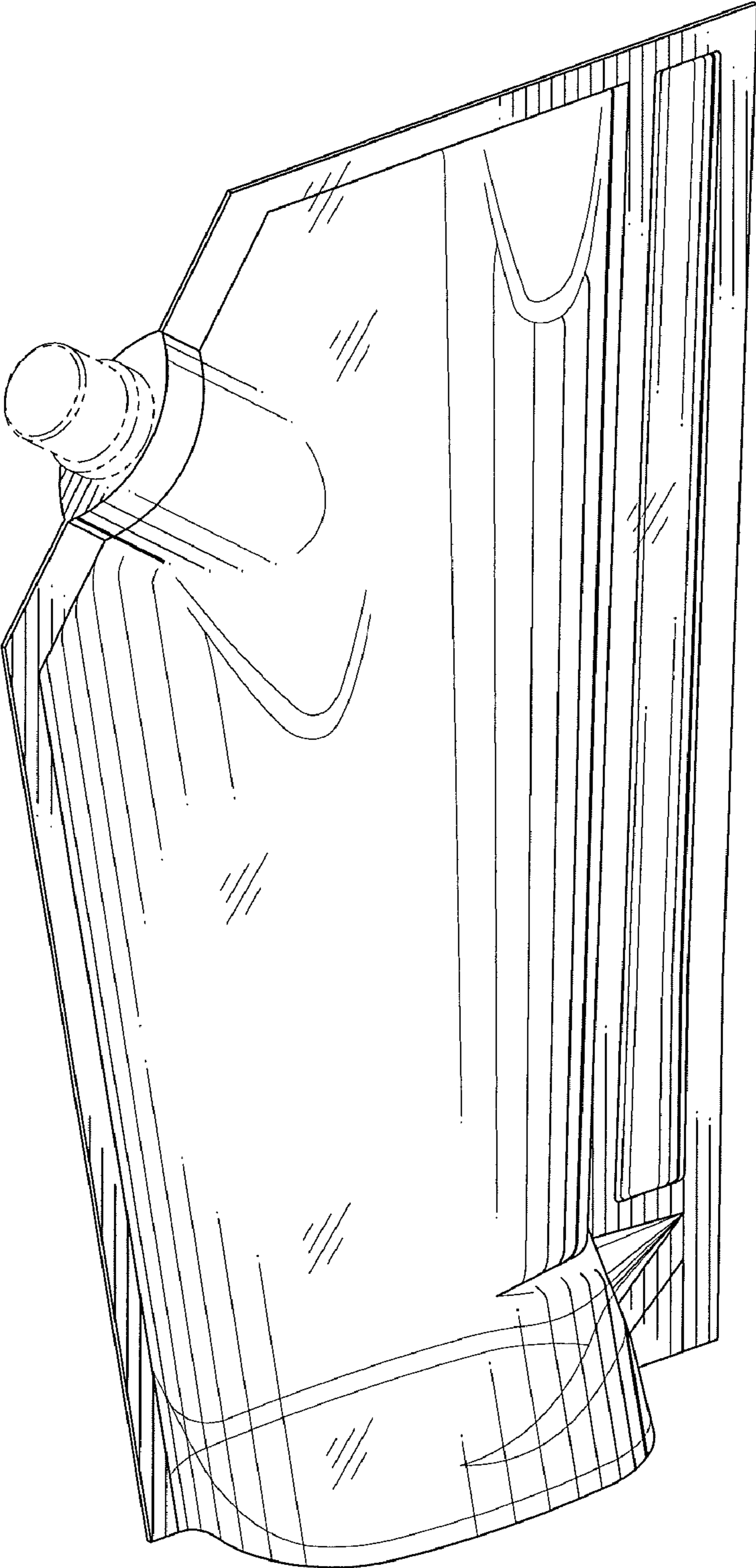

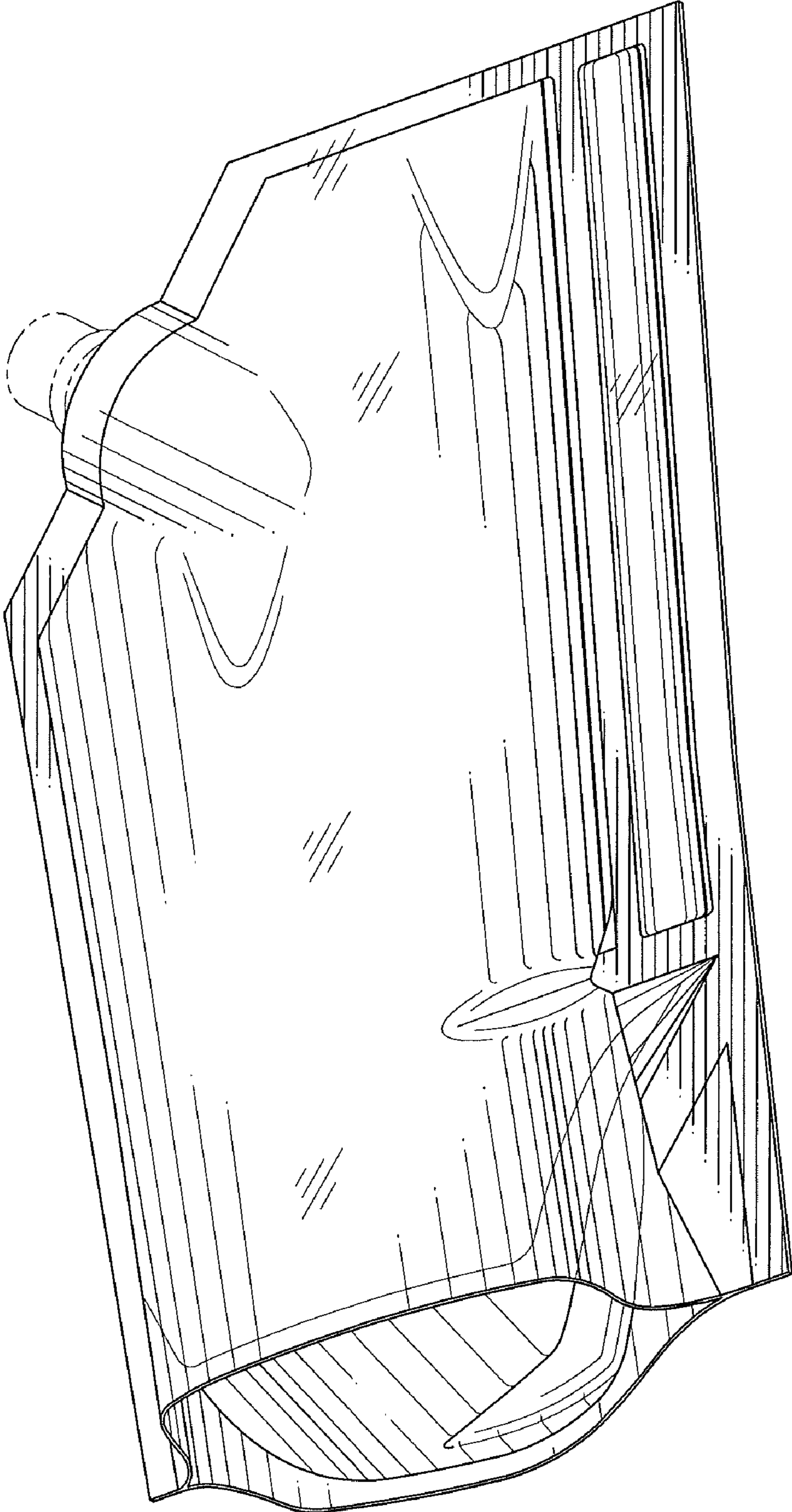

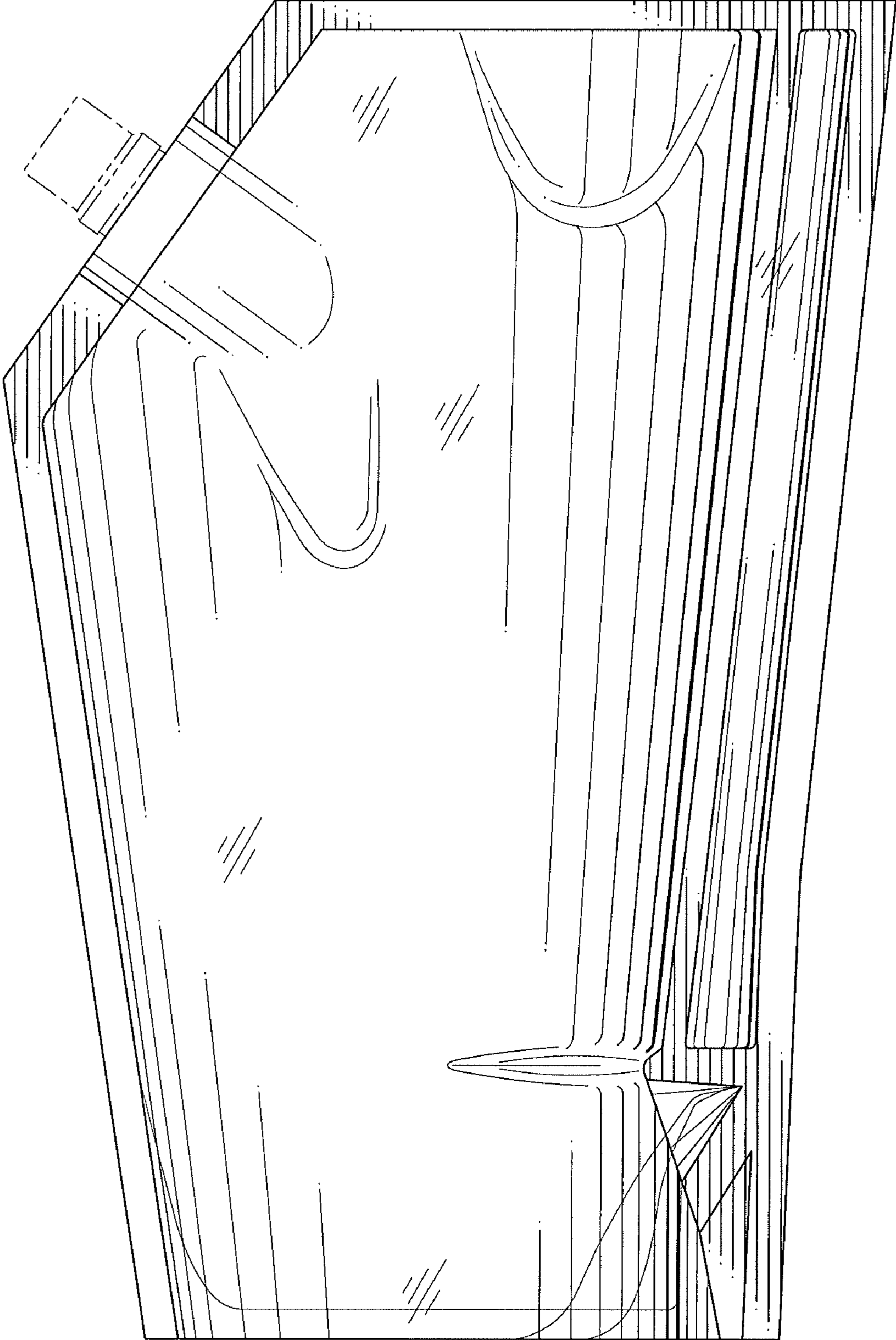

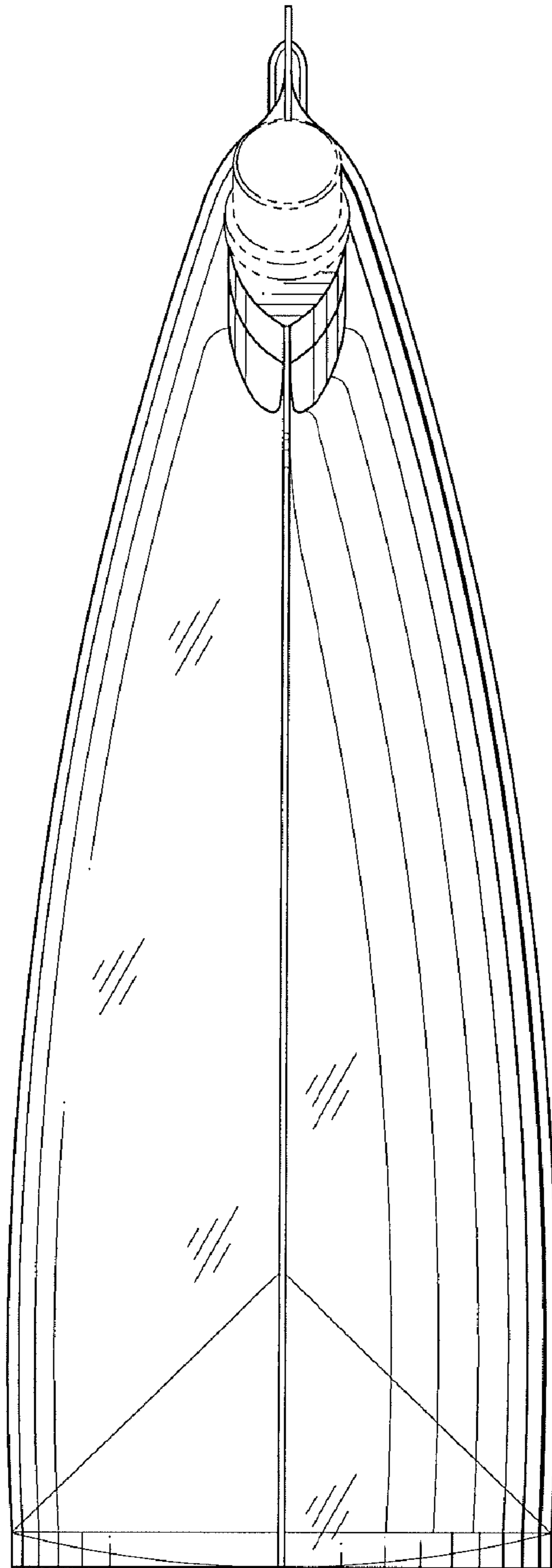

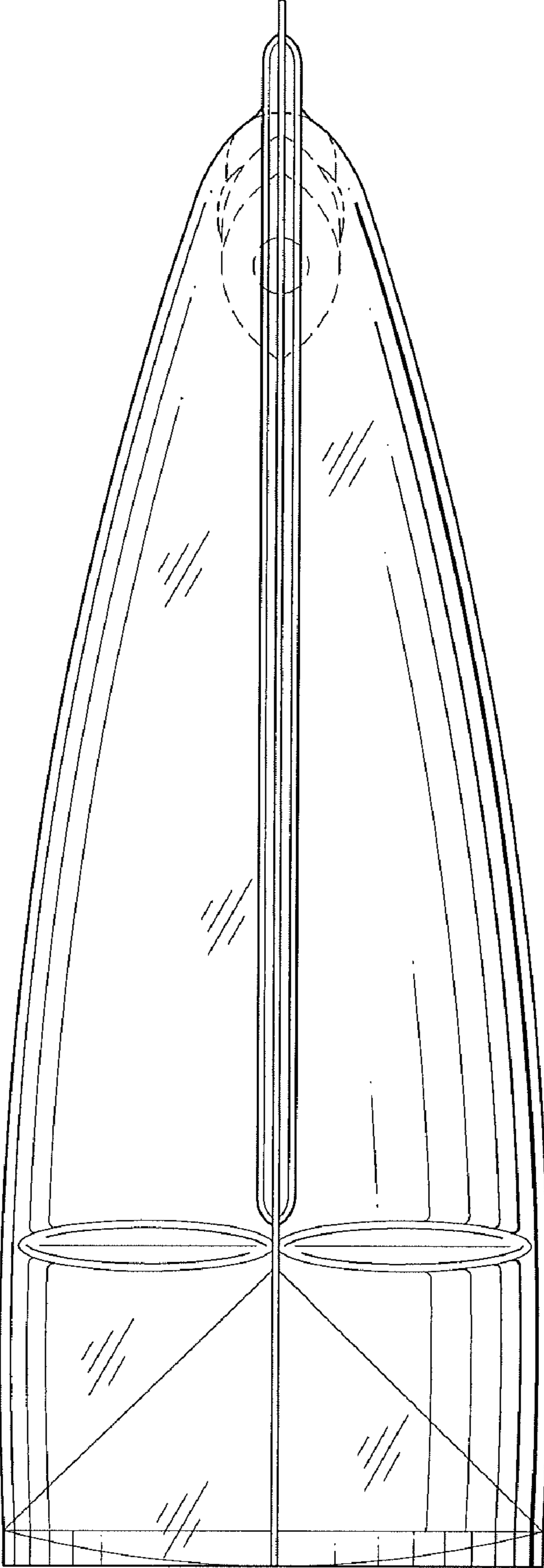

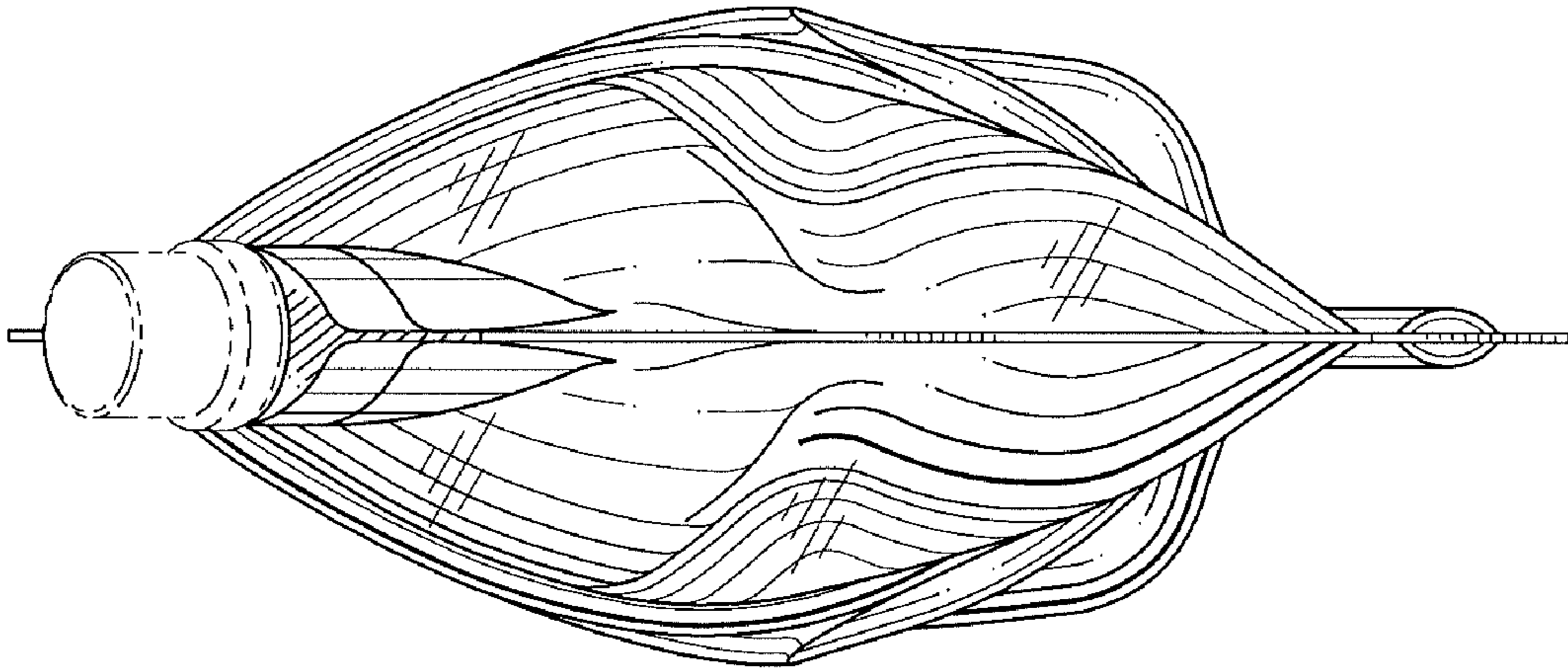

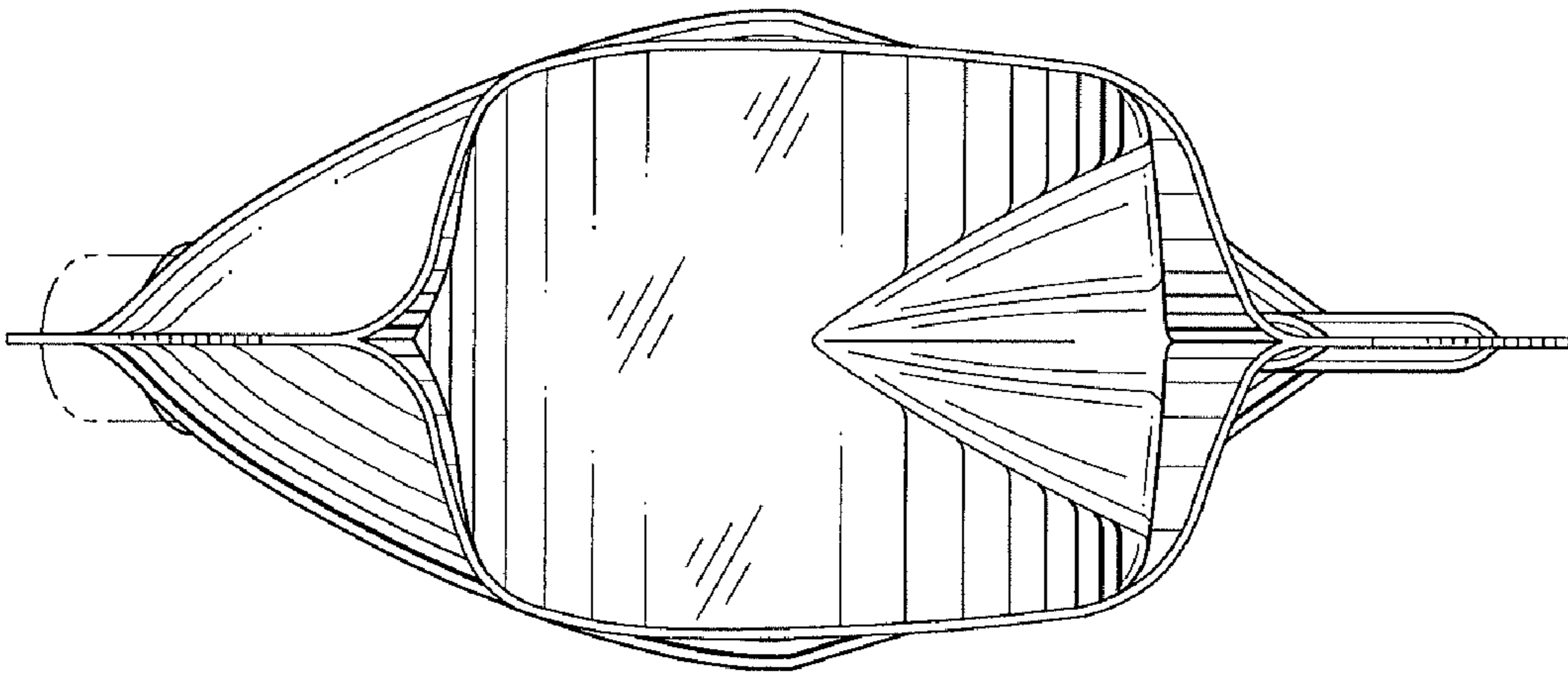
