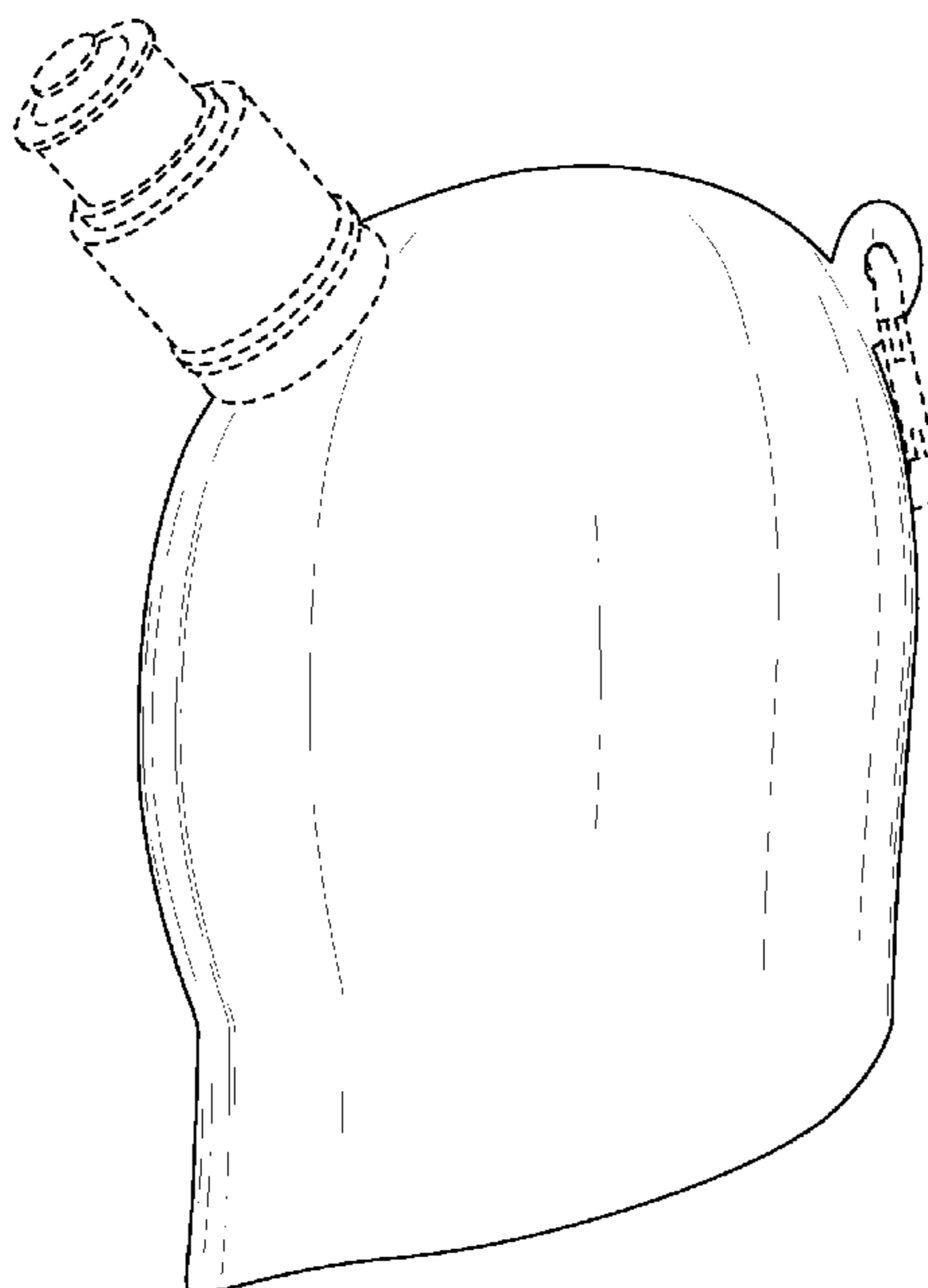

FIG. 7 is a bottom view of the collapsible bottle of FIG. 1.

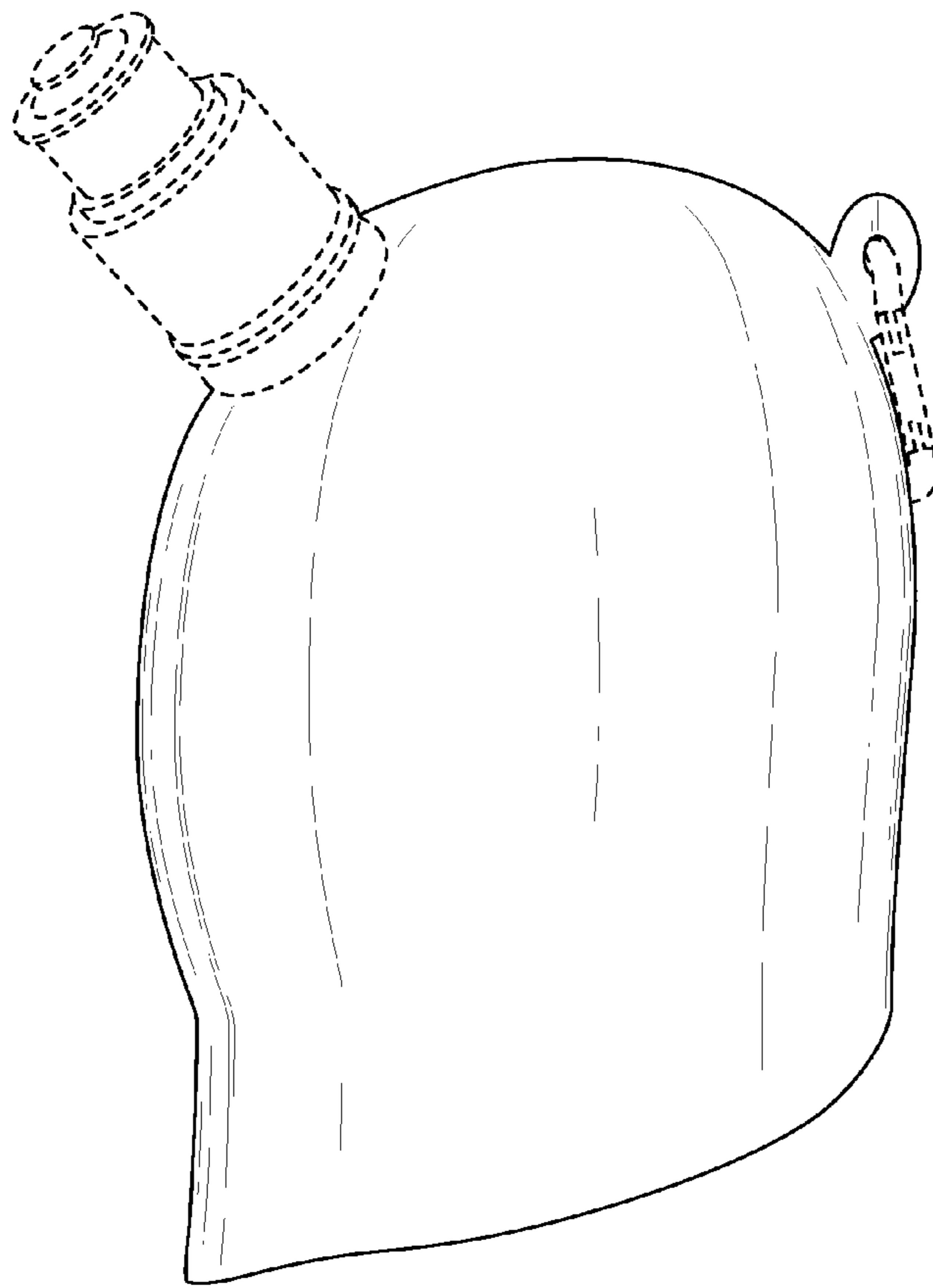

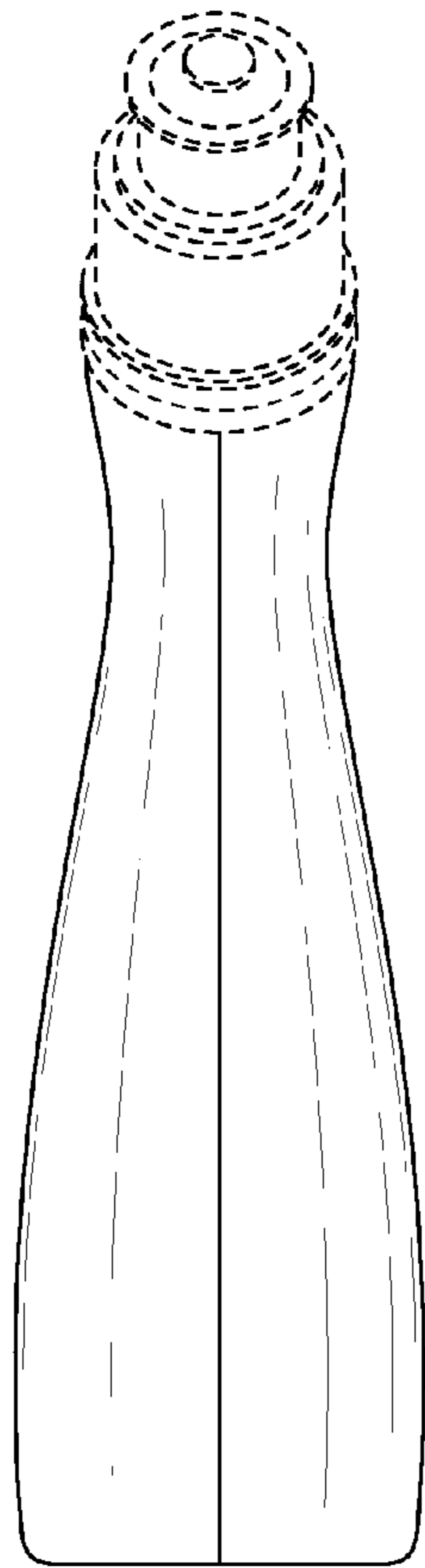

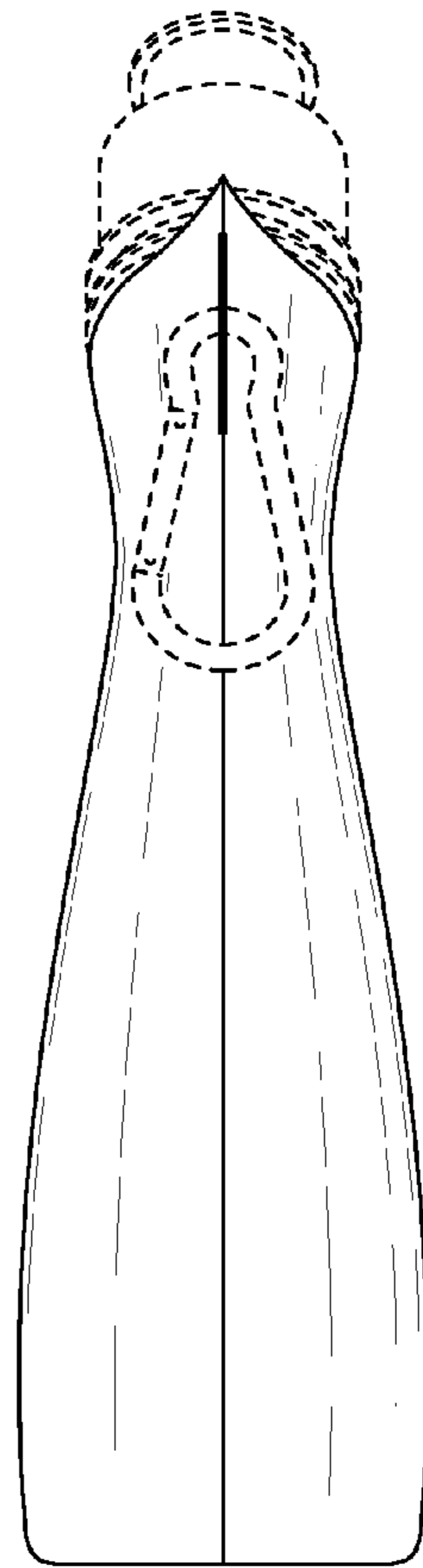

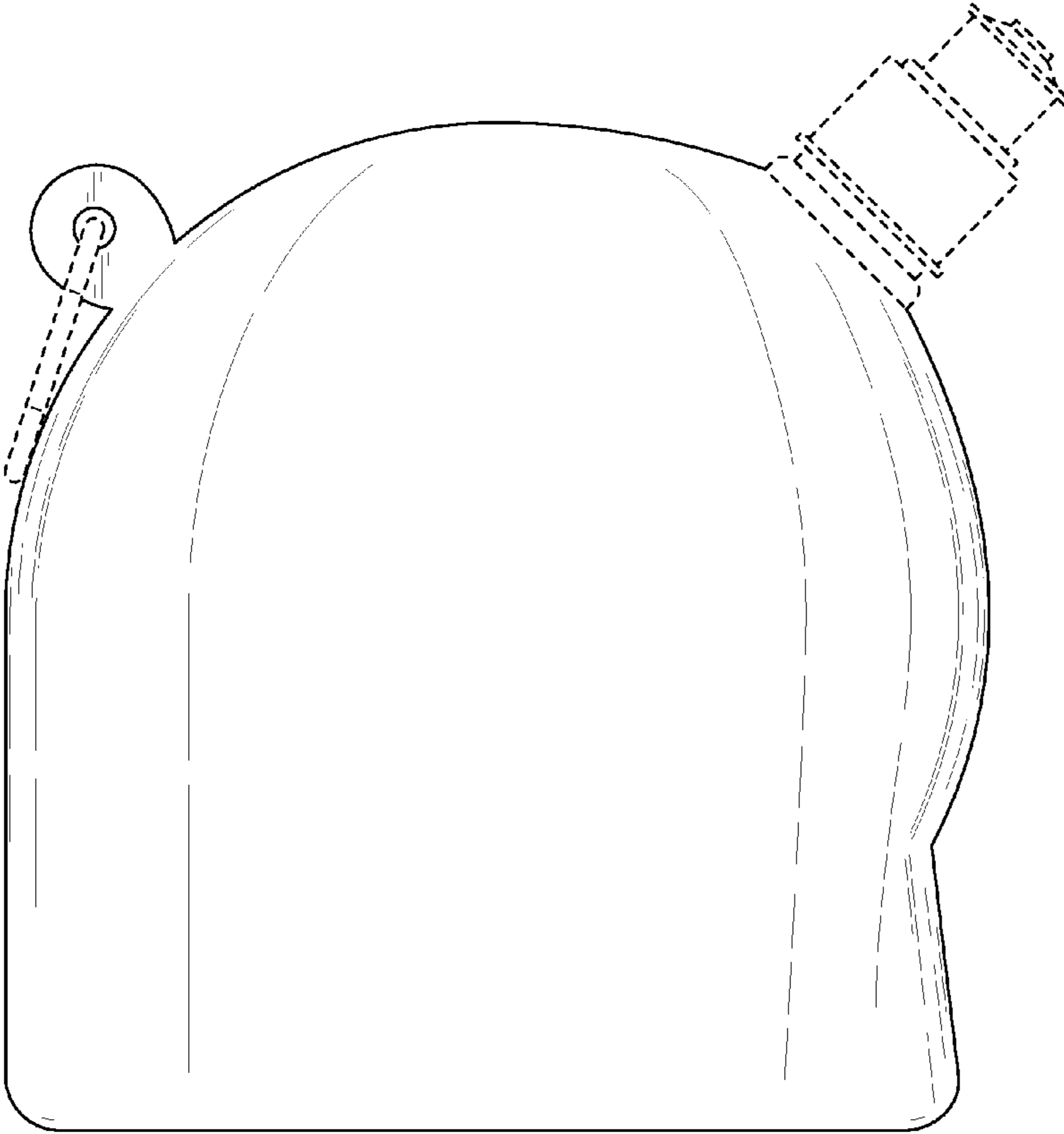

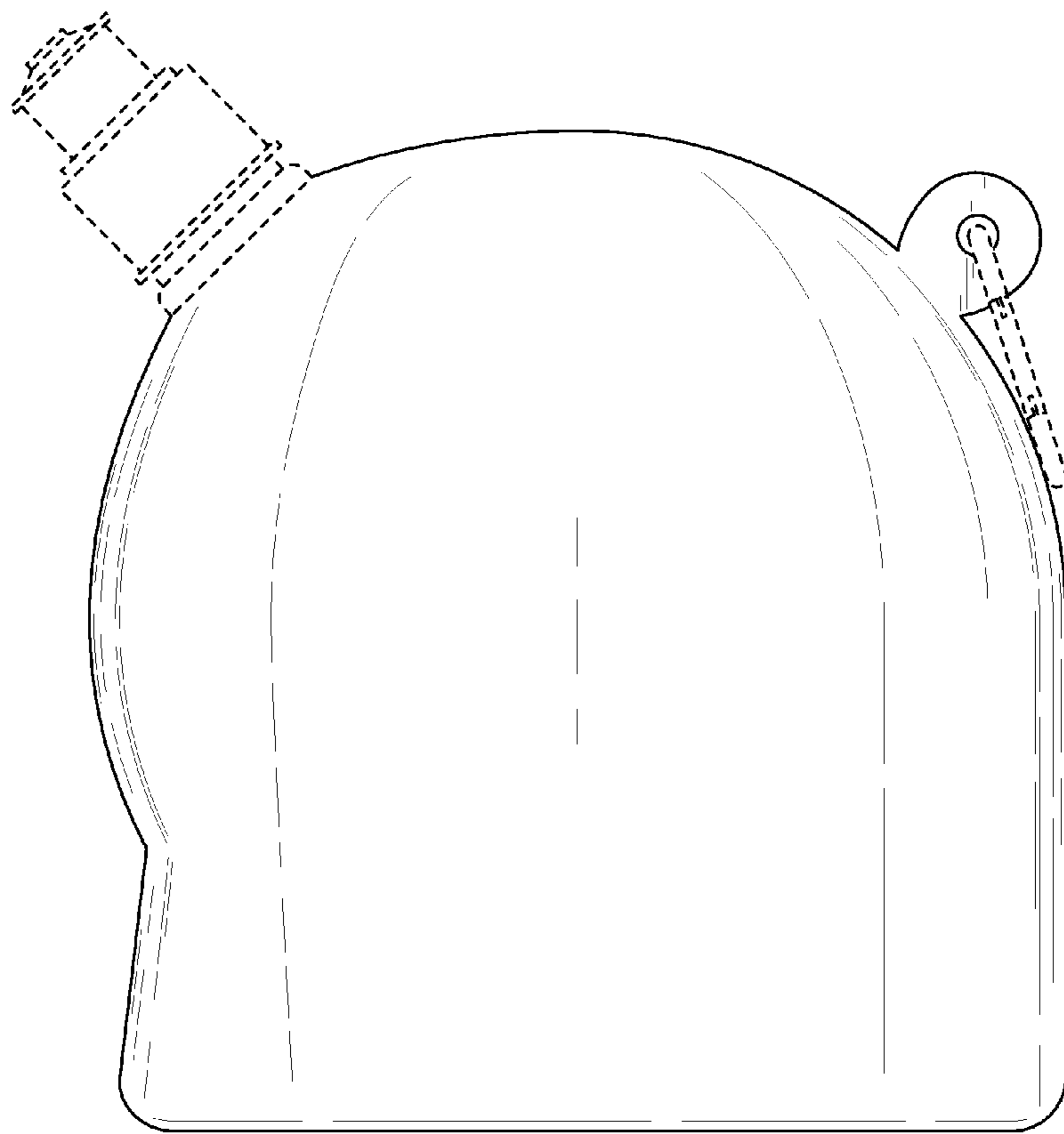

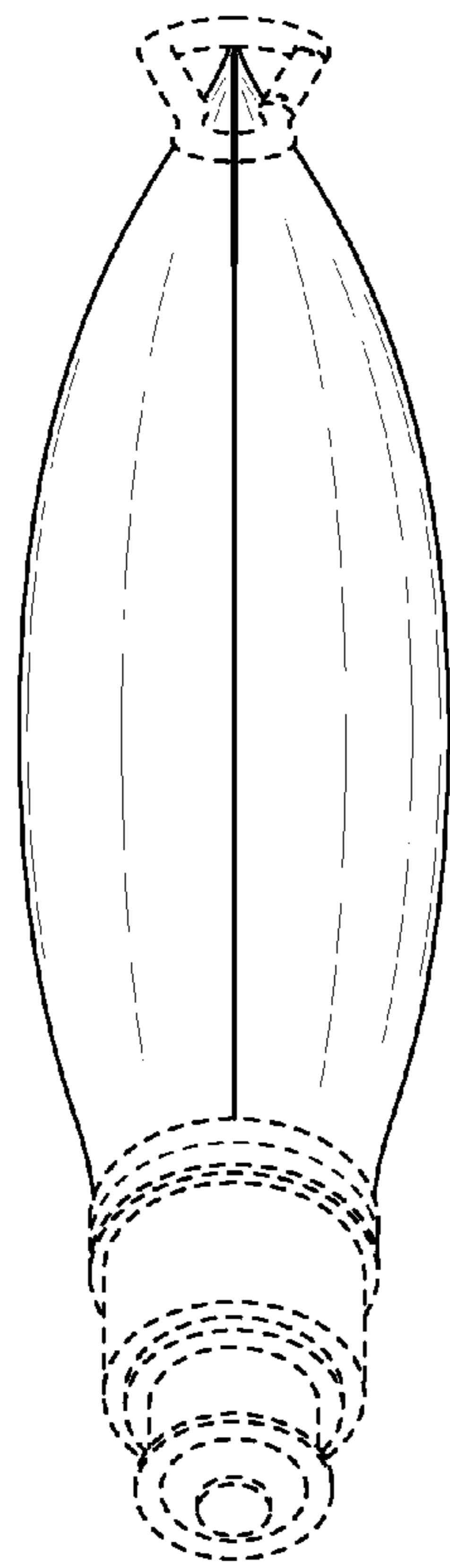

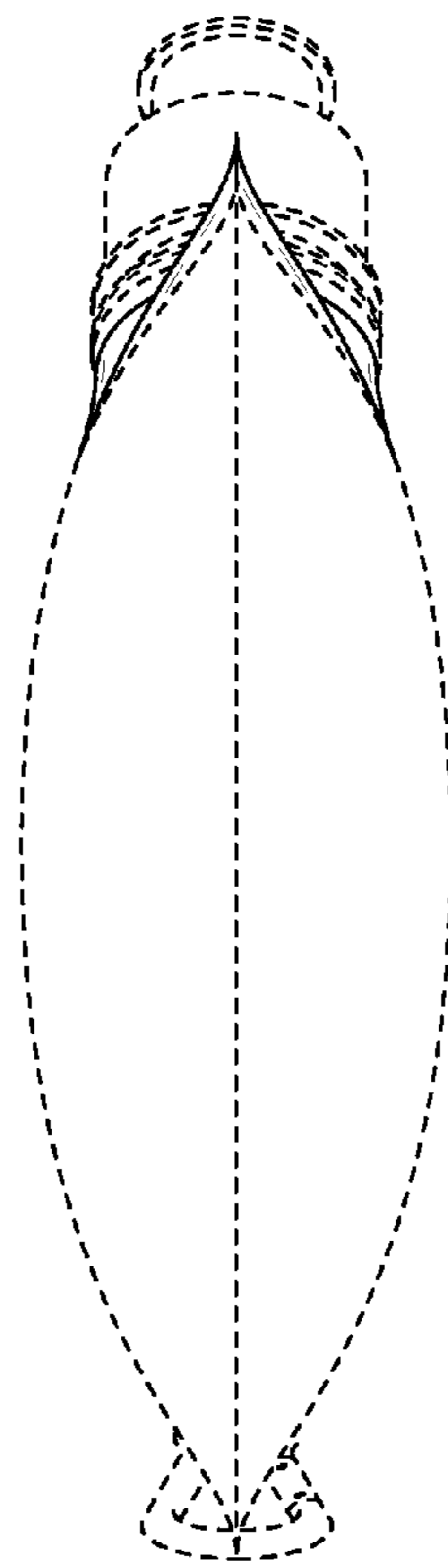
