 FIG. 8 is an oblique view thereof.

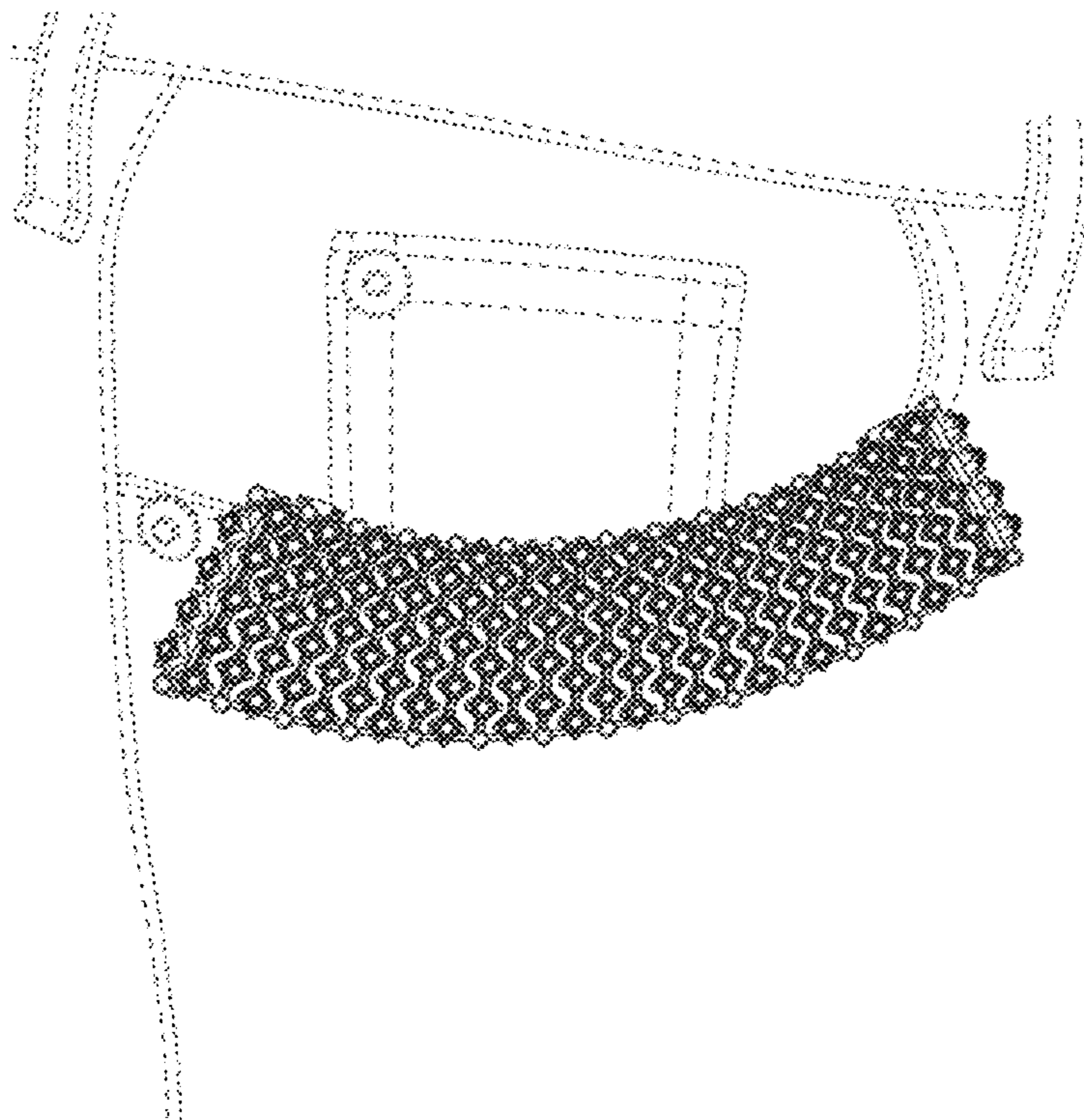
The broken line showing of FIG. 1 is for the purpose of illustrating the environment in which the article embodying the design is used and forms no part of the claimed design.

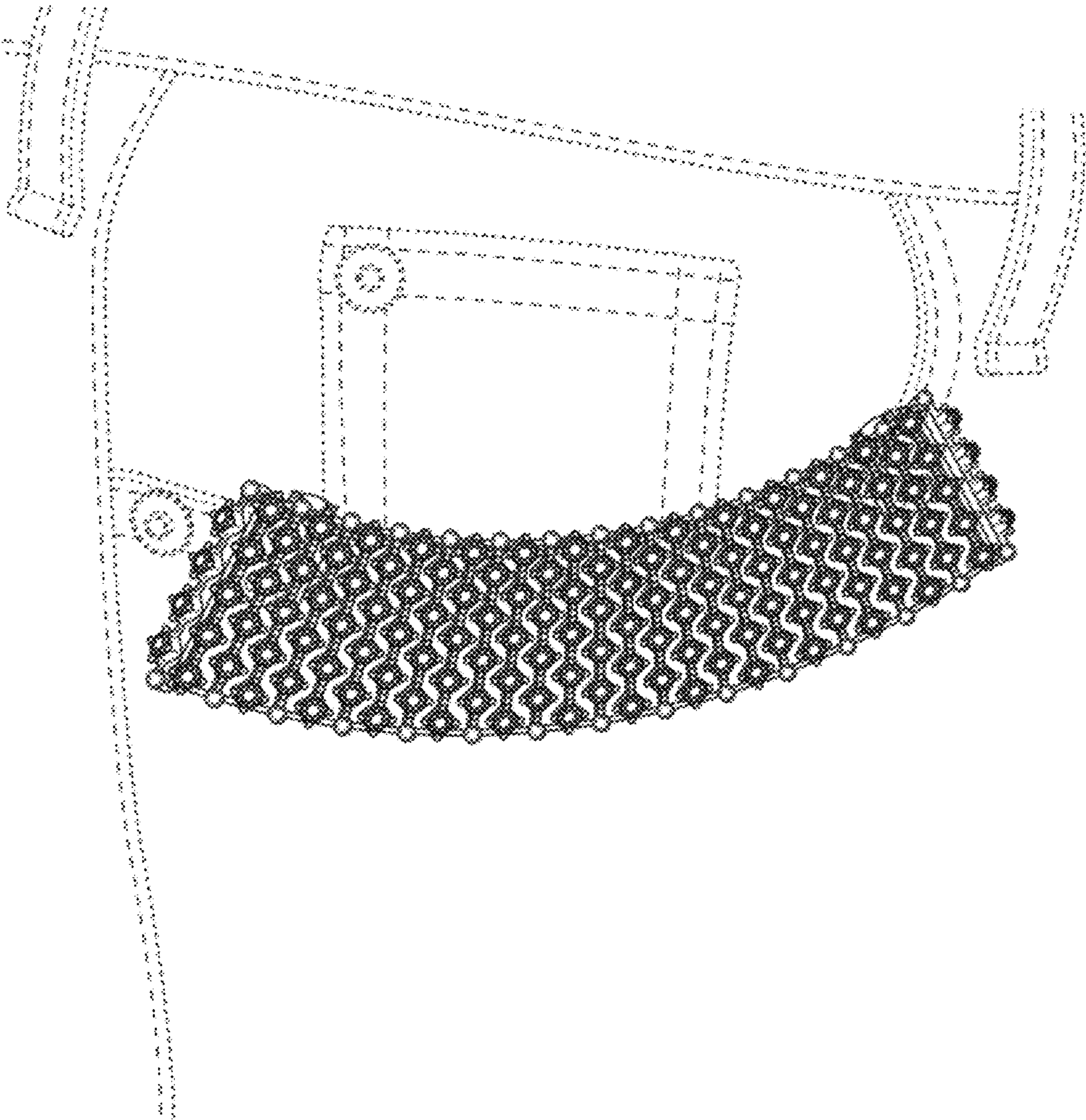

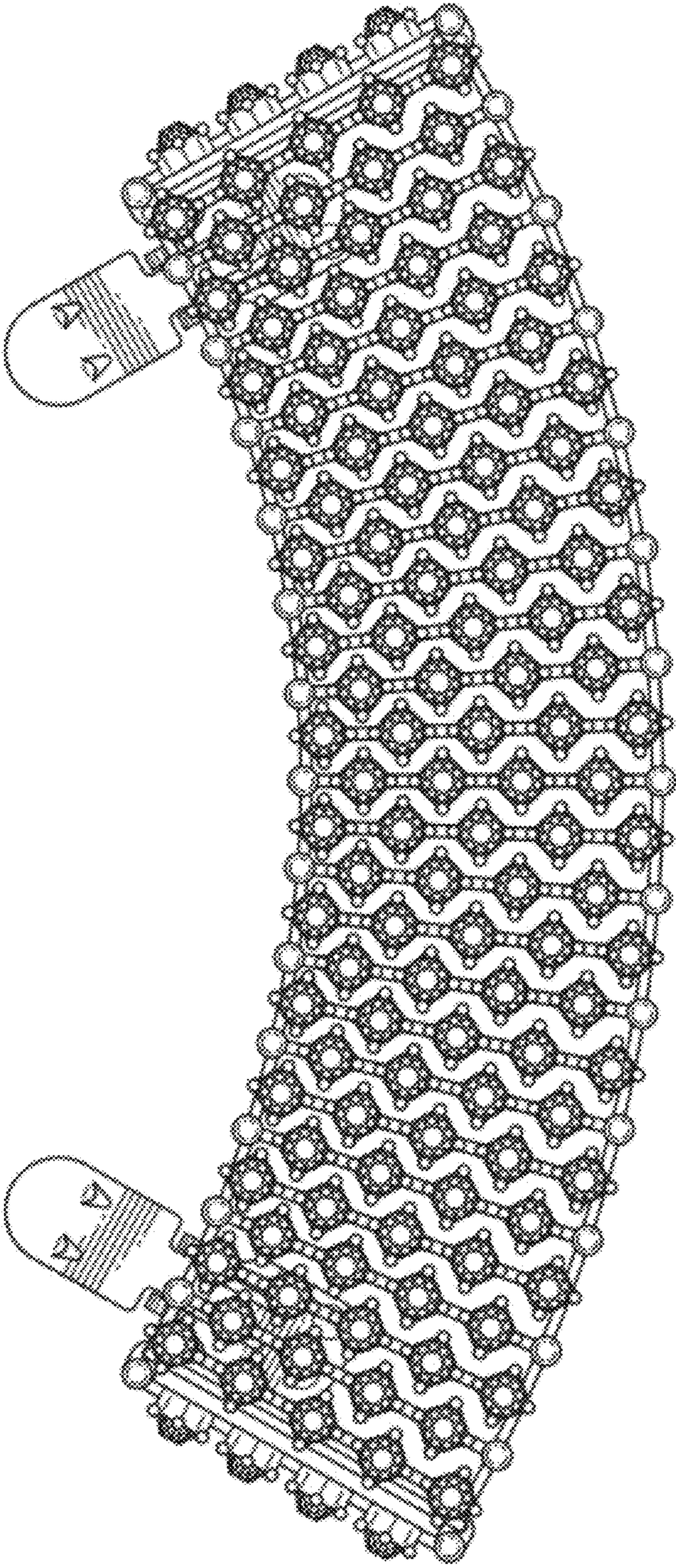

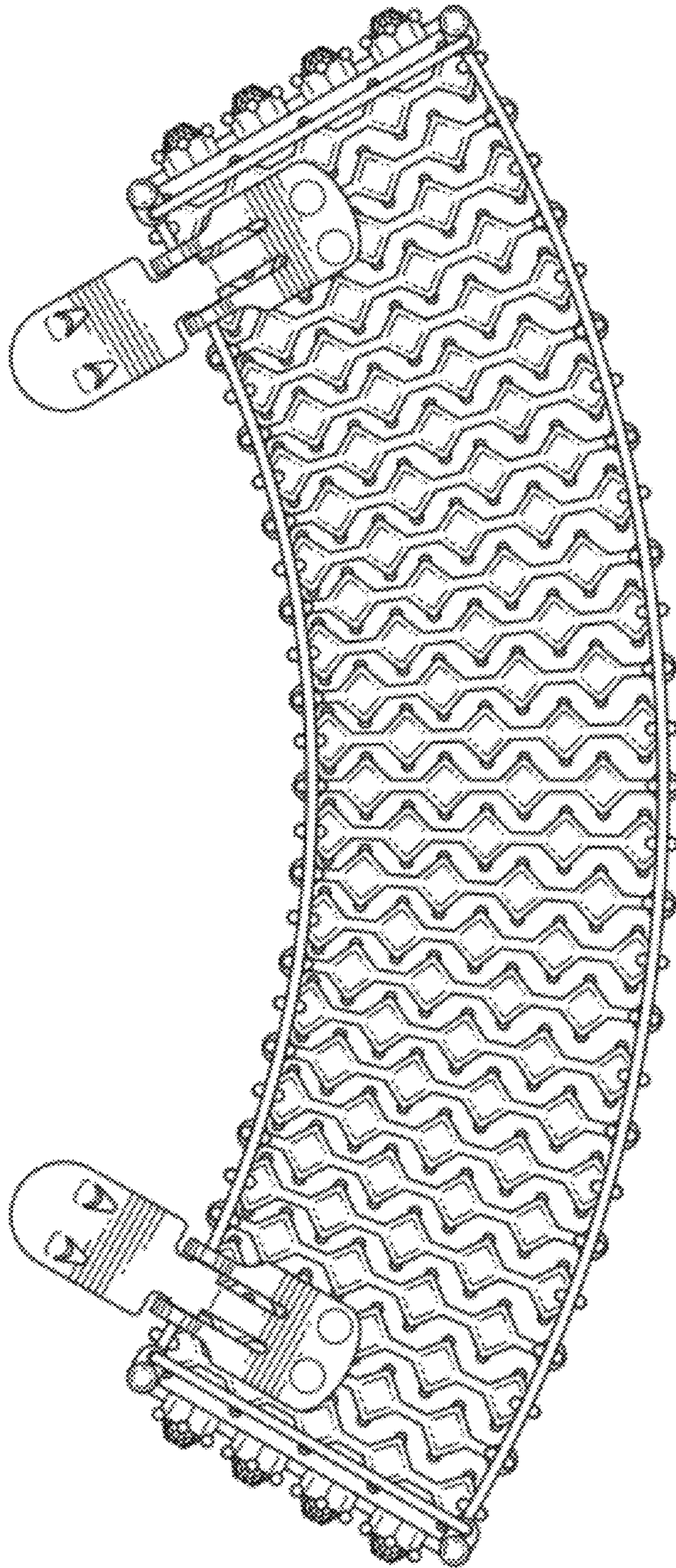

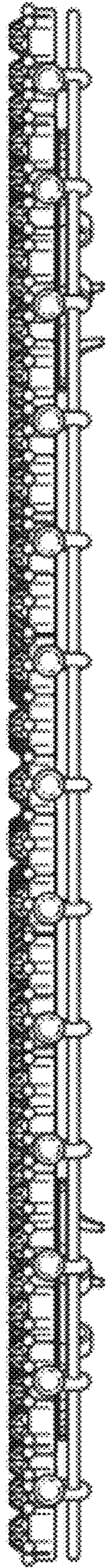

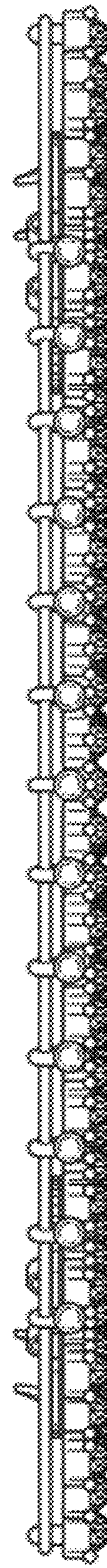

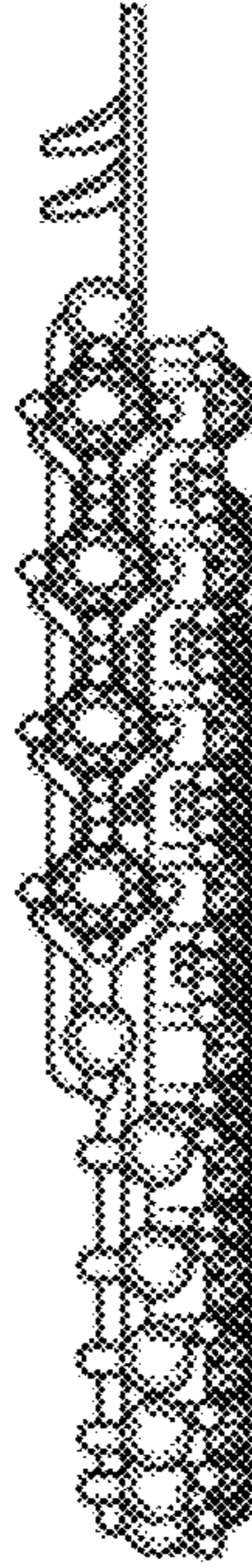

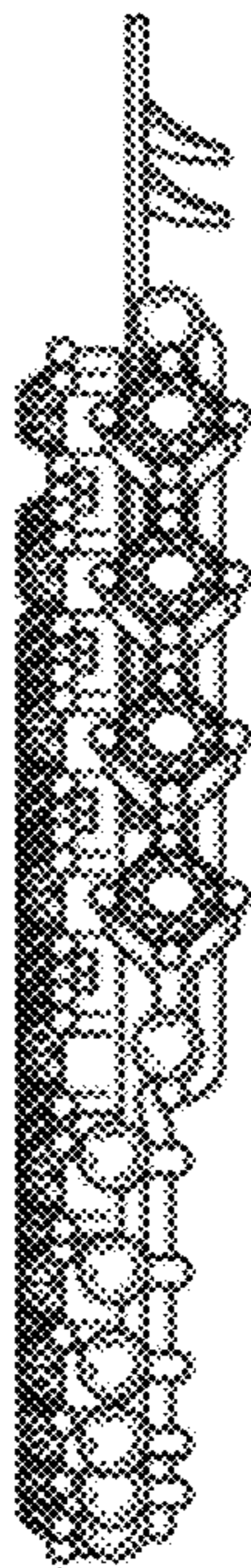
