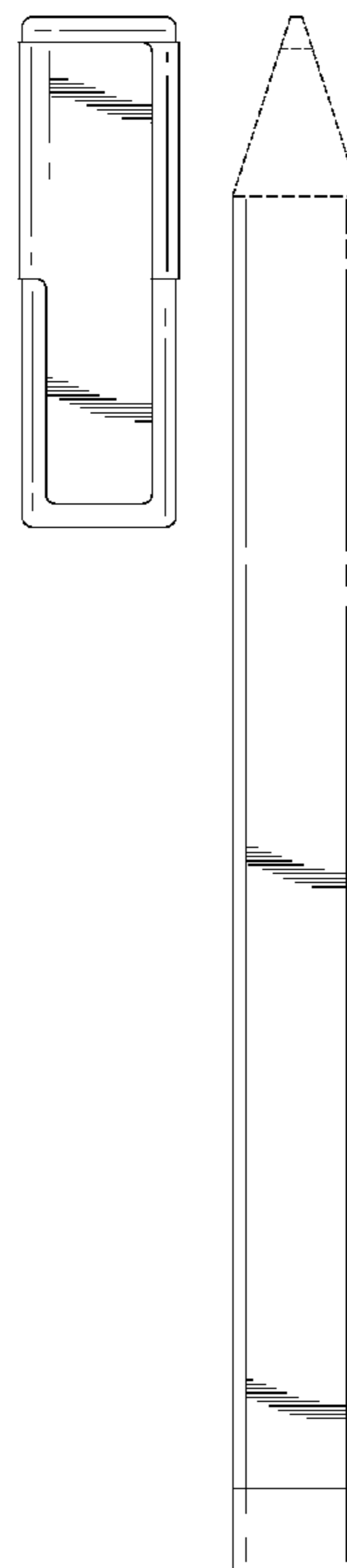
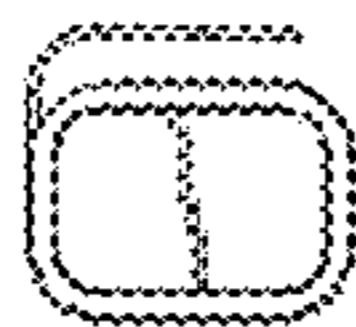
(57) **CLAIM**

The ornamental design for a writing instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the writing instrument;  
FIG. 2 is a first side view of the writing instrument of FIG. 1, the opposite side view being a mirror image of FIG. 2;  
FIG. 3 is a bottom side view of the writing instrument of FIG. 1;  
FIG. 4 is a front view of the writing instrument of FIG. 1 with the cap in an open position; and,  
FIG. 5 is a side view of the writing instrument of FIG. 4, the opposite side view being a mirror image of FIG. 5.  
The broken lines shown in FIGS. 4 and 5 are included for the purpose of showing portions that form no part of the claimed design.

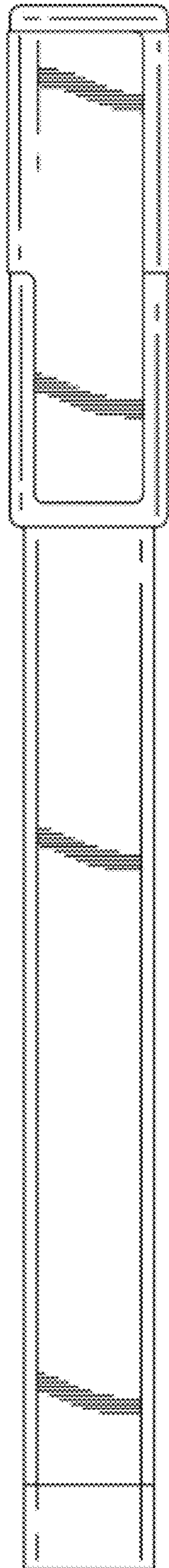

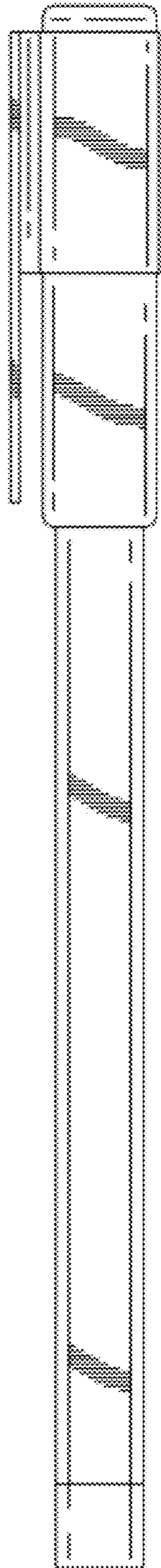

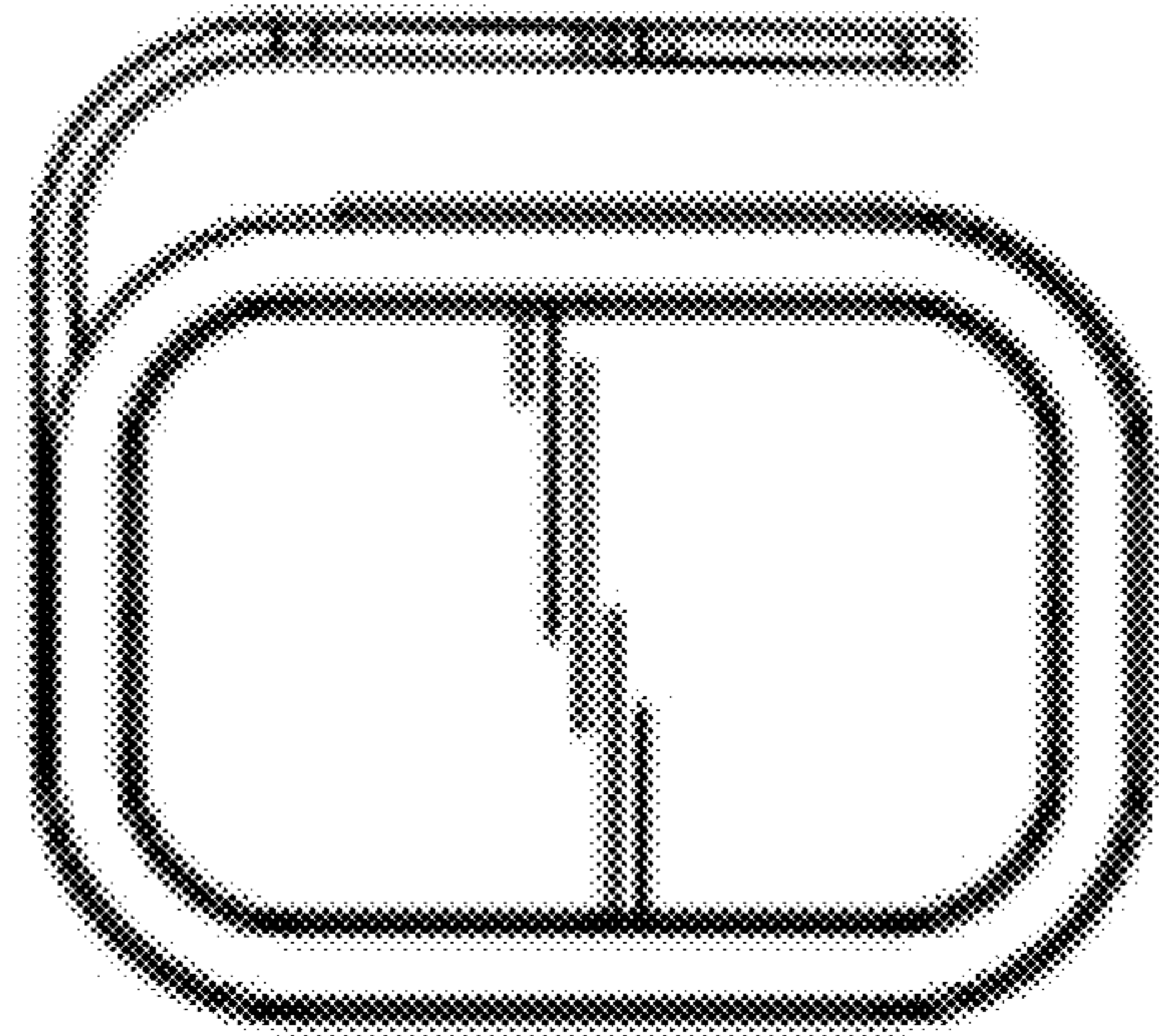

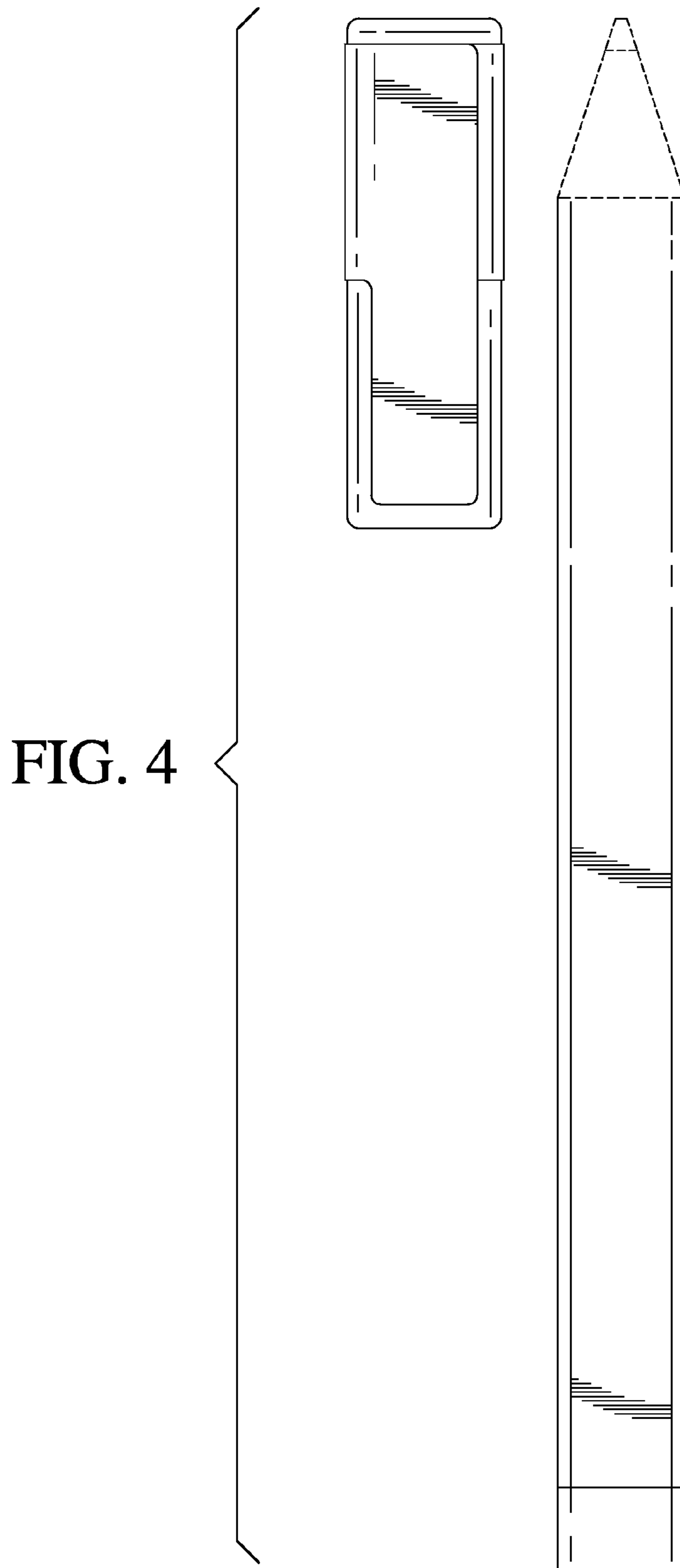
