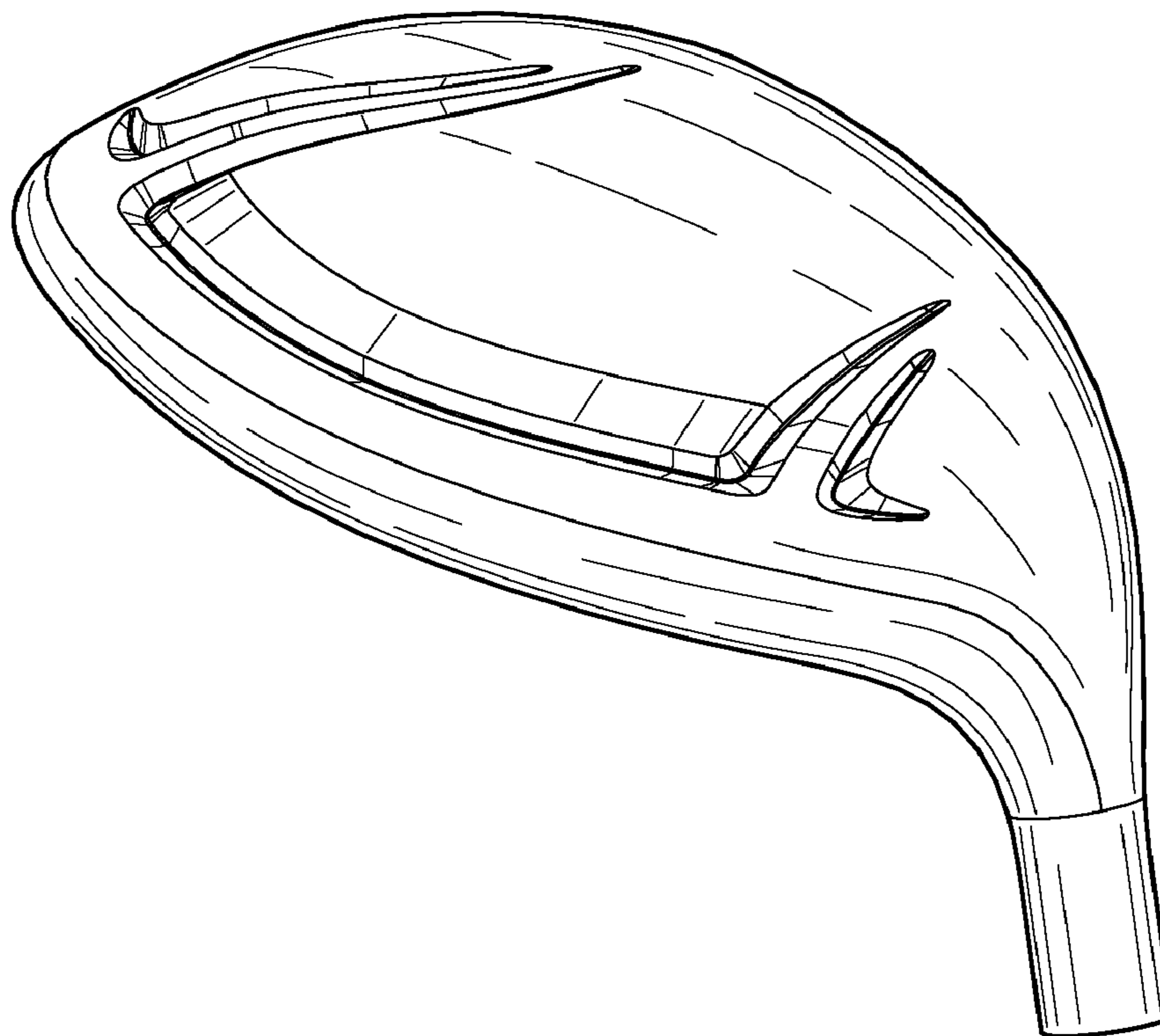
(57) **CLAIM**

The ornamental design for a wood-type golf club, as shown and described.

DESCRIPTION

FIG. 1 illustrates a bottom, rear perspective view of a wood-type golf club with multiple channels;
FIG. 2 illustrates a right, rear perspective view of a wood-type golf club with multiple channels;
FIG. 3 illustrates a right side elevational view of a wood-type golf club;
FIG. 4 illustrates a bottom plan view of a wood-type golf club;
FIG. 5 illustrates a rear elevational view of a wood-type golf club; and,
FIG. 6 illustrates a top plan view of a wood-type golf club.

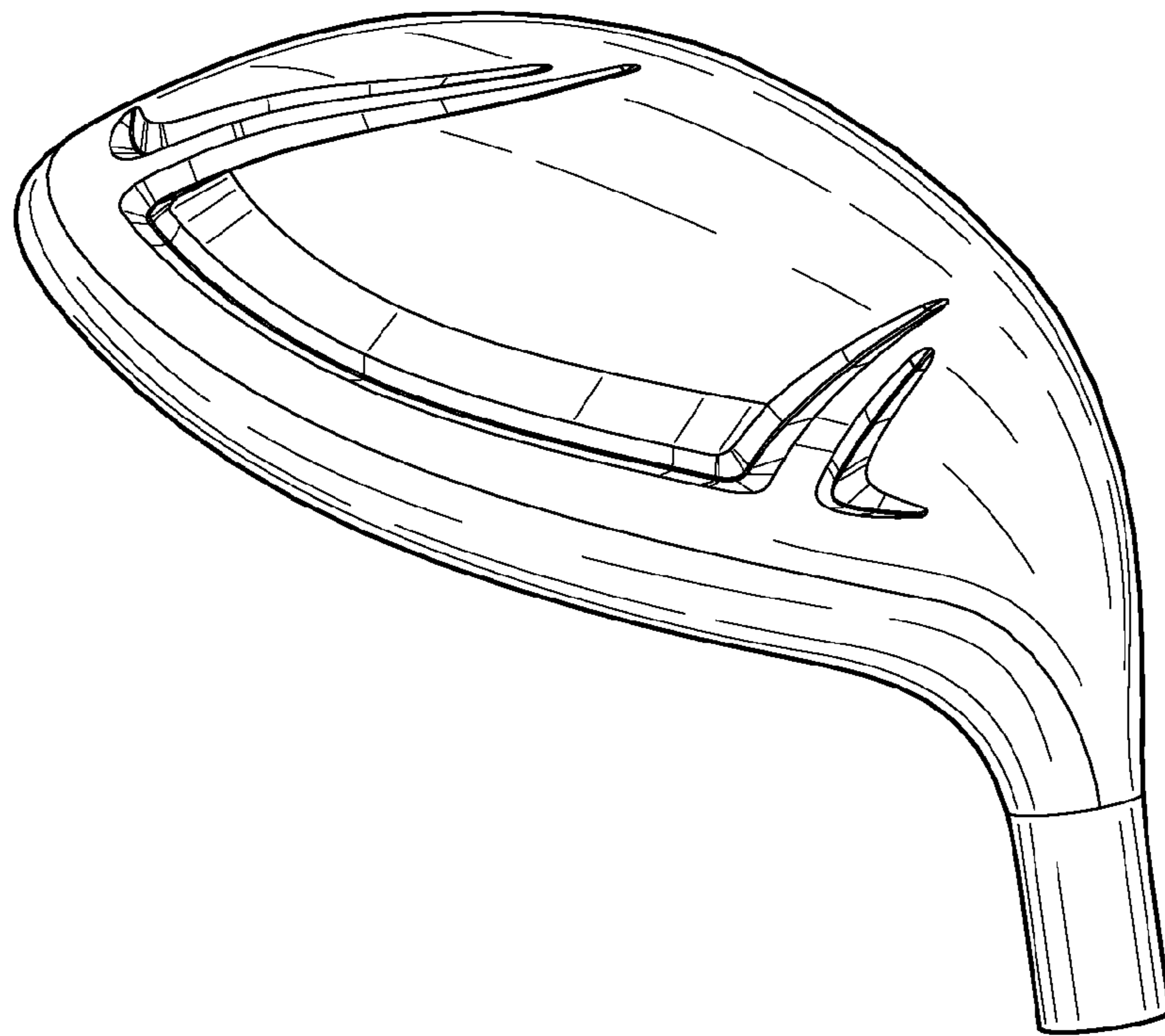

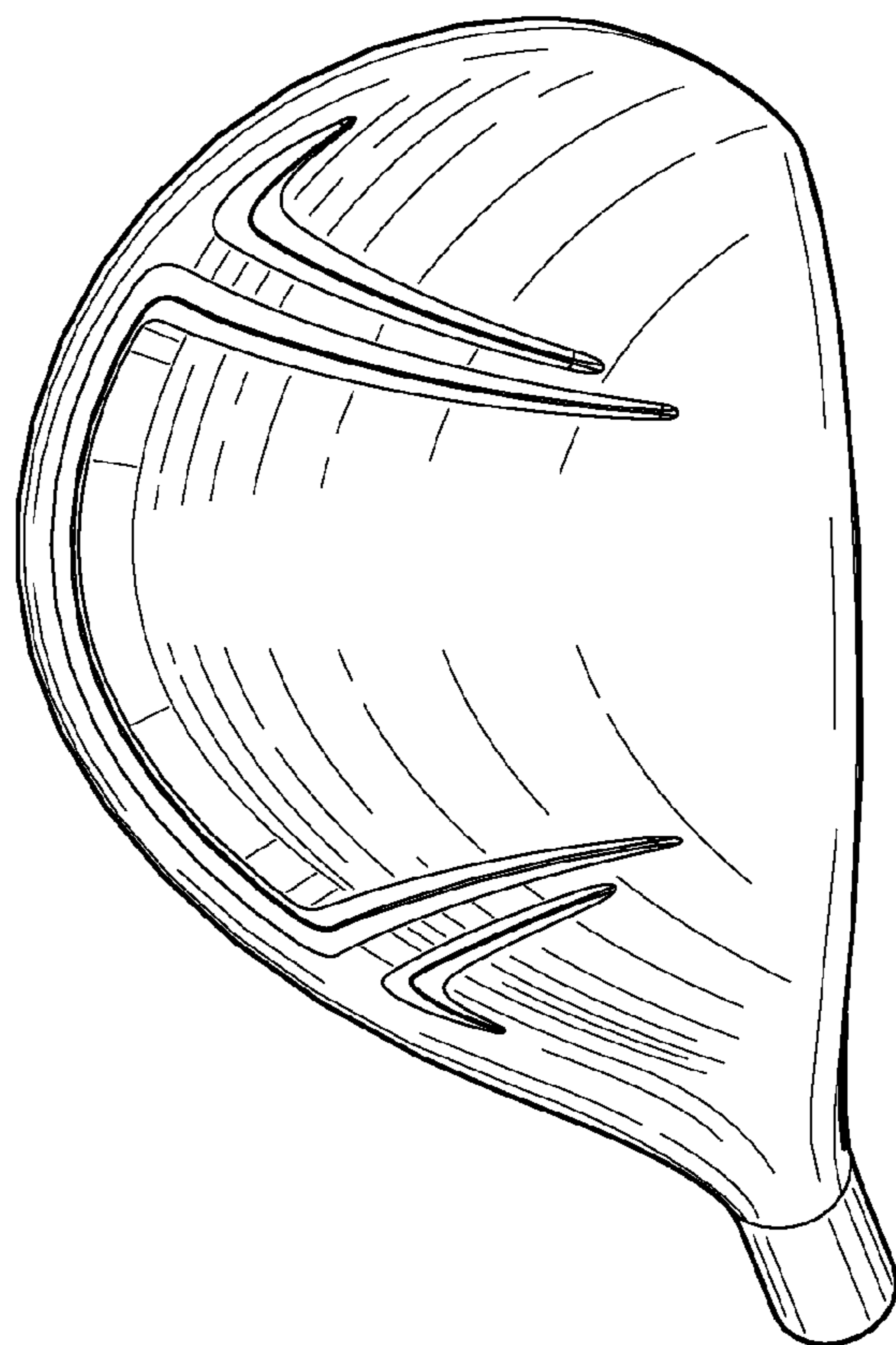

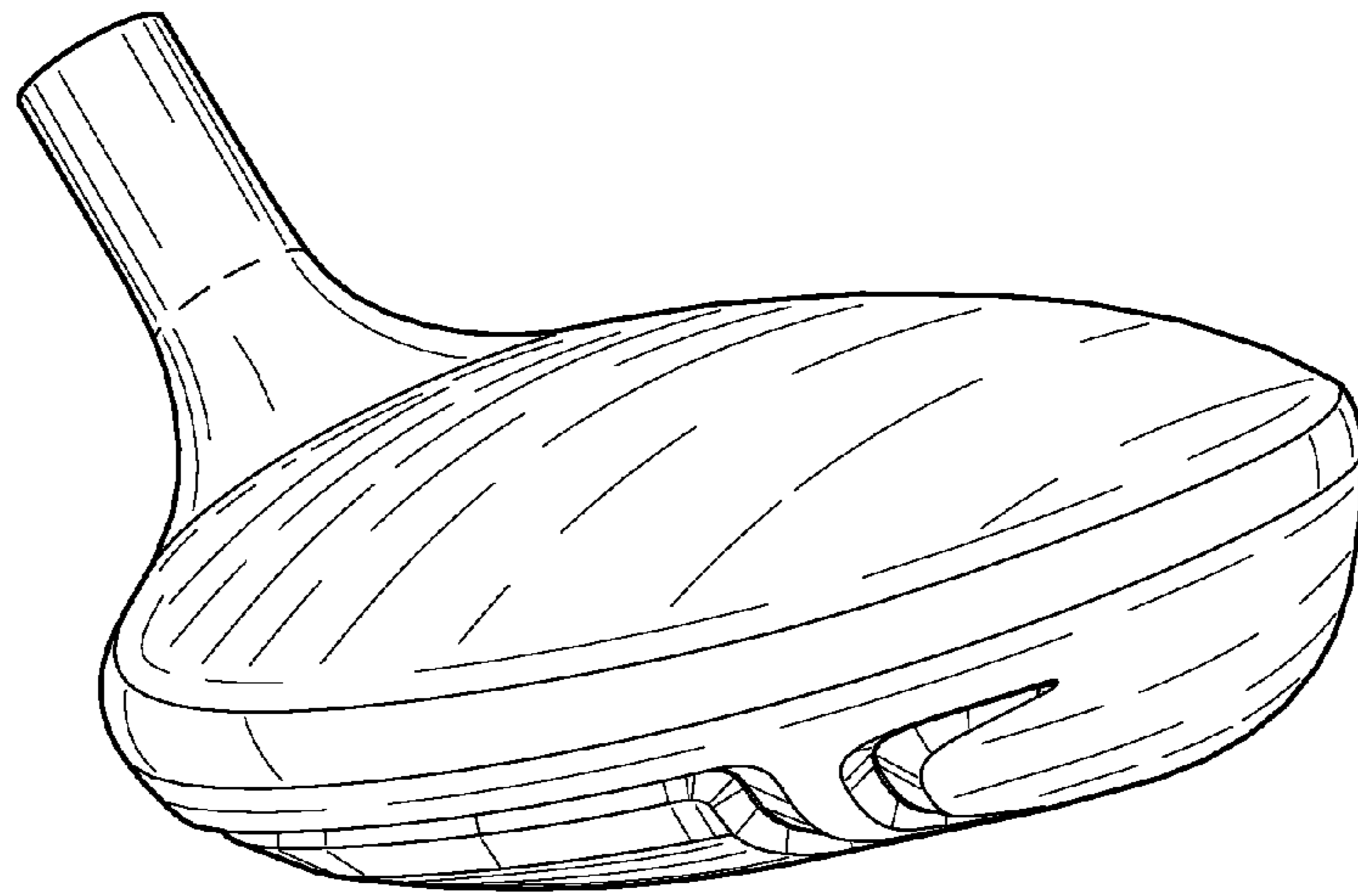

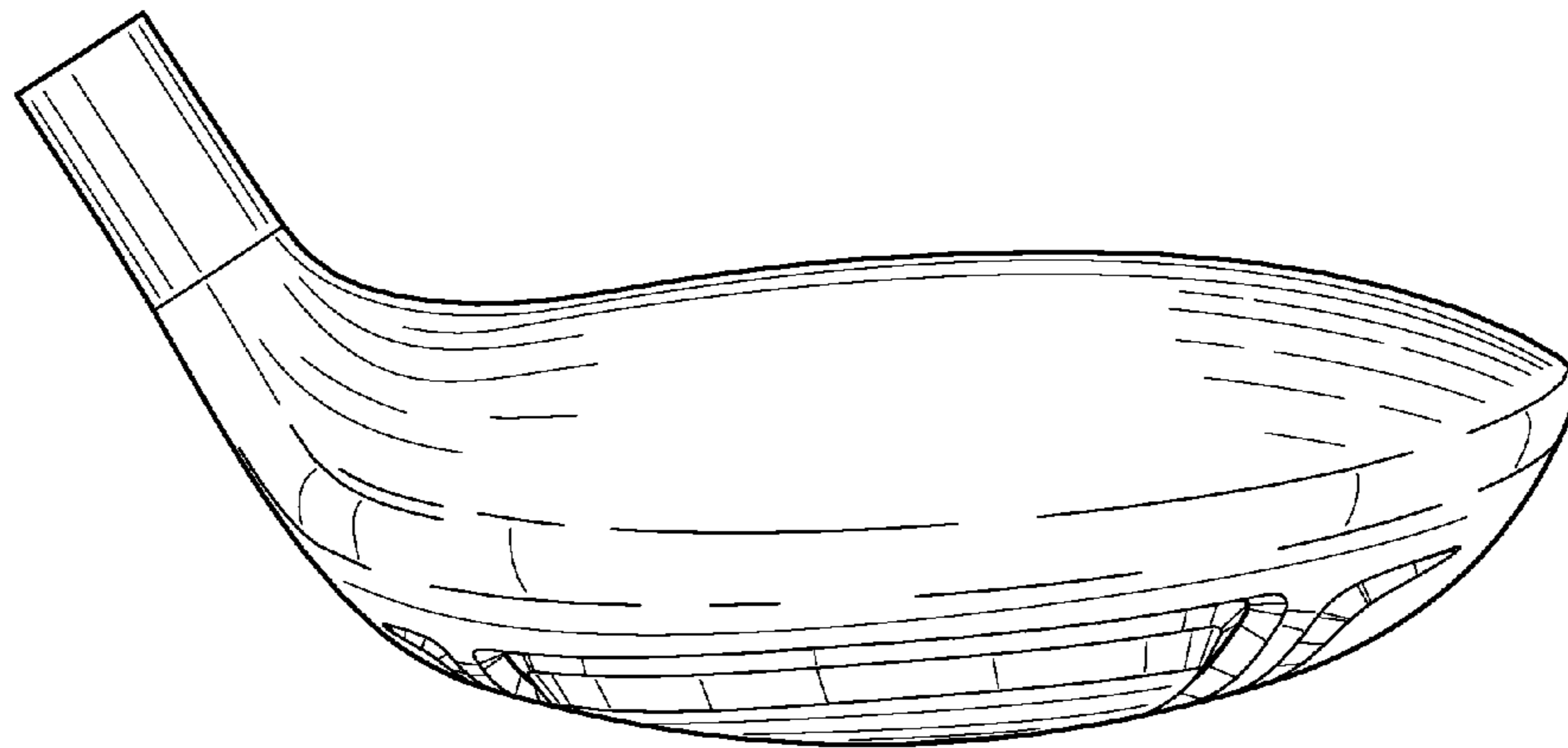

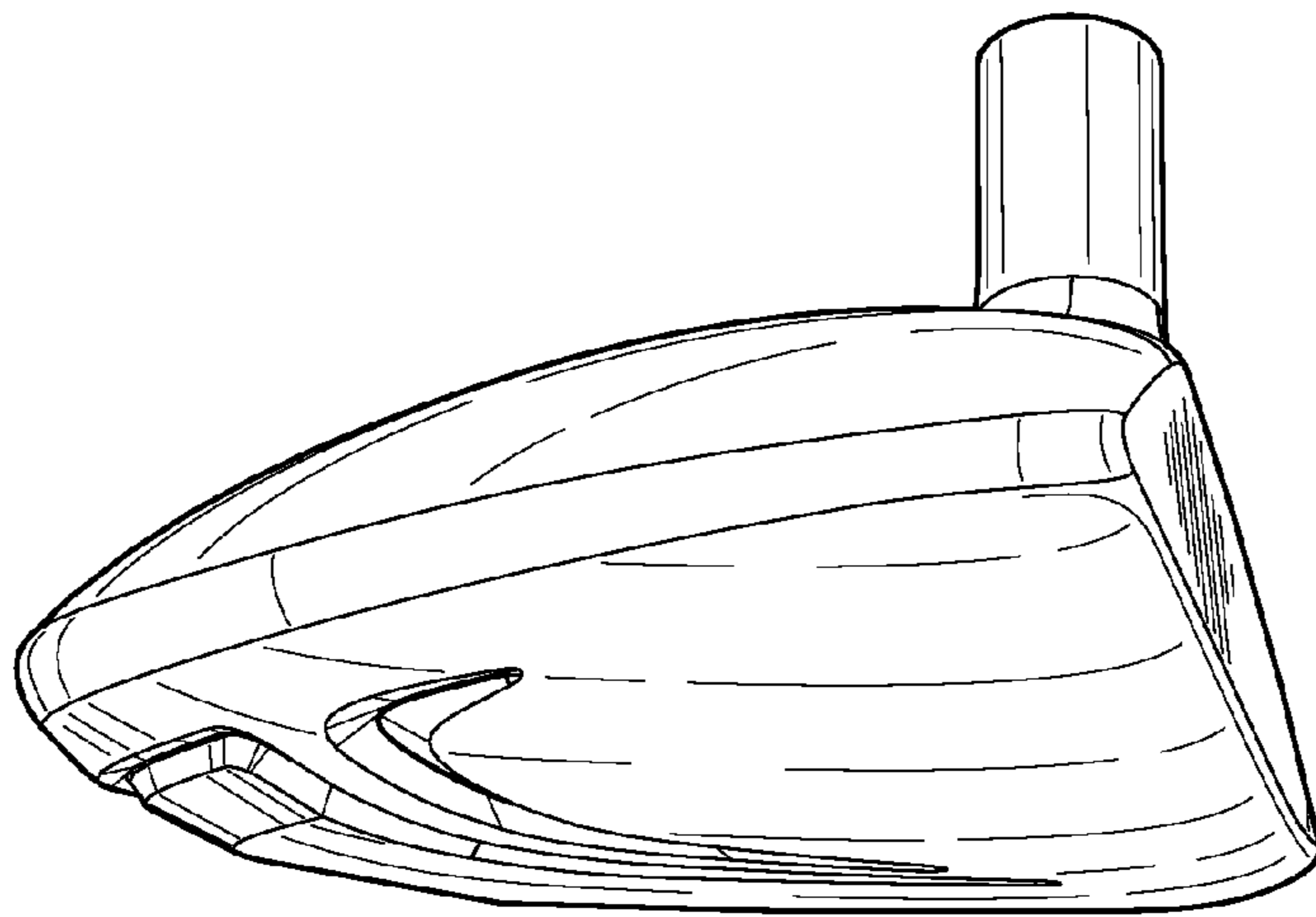

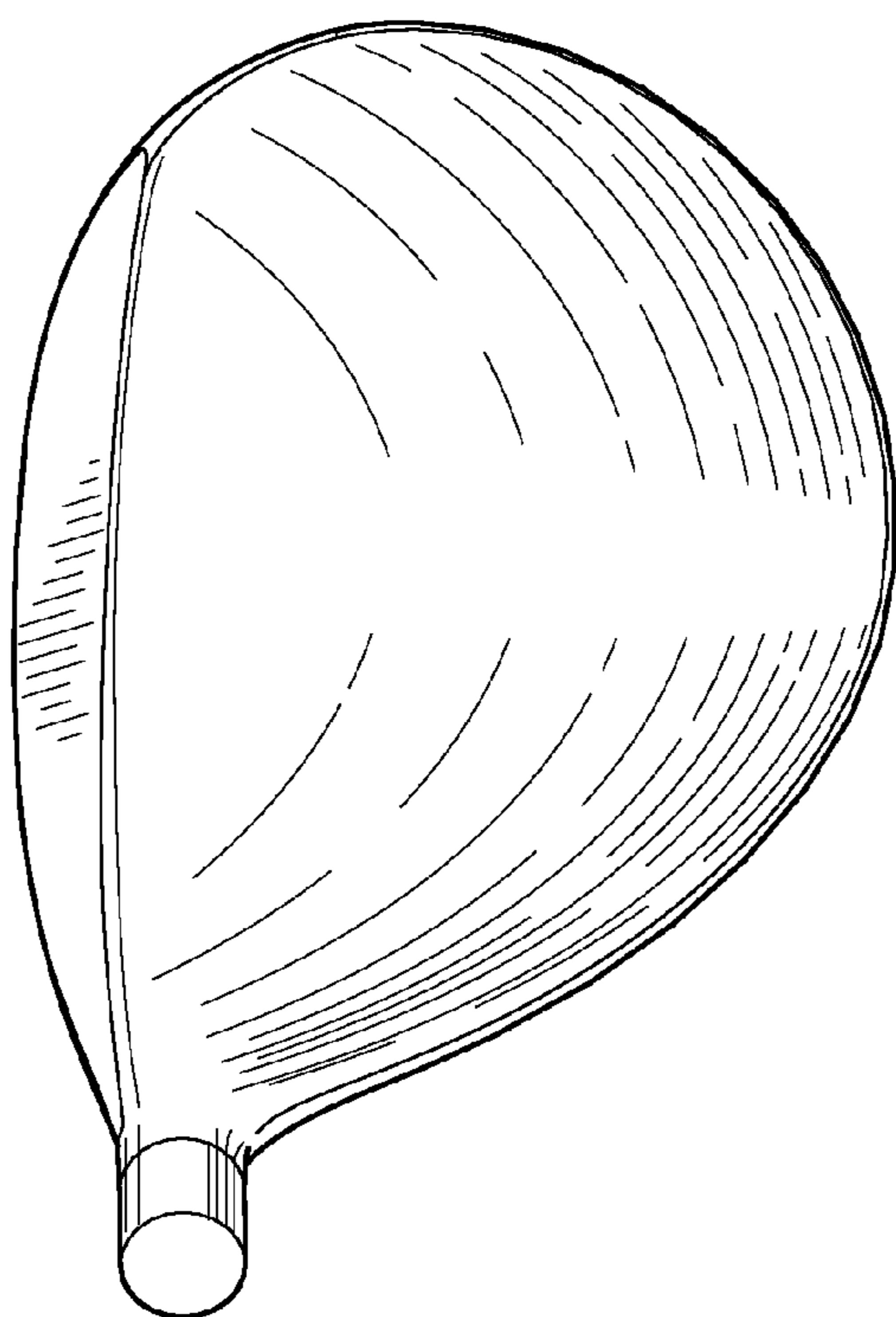
