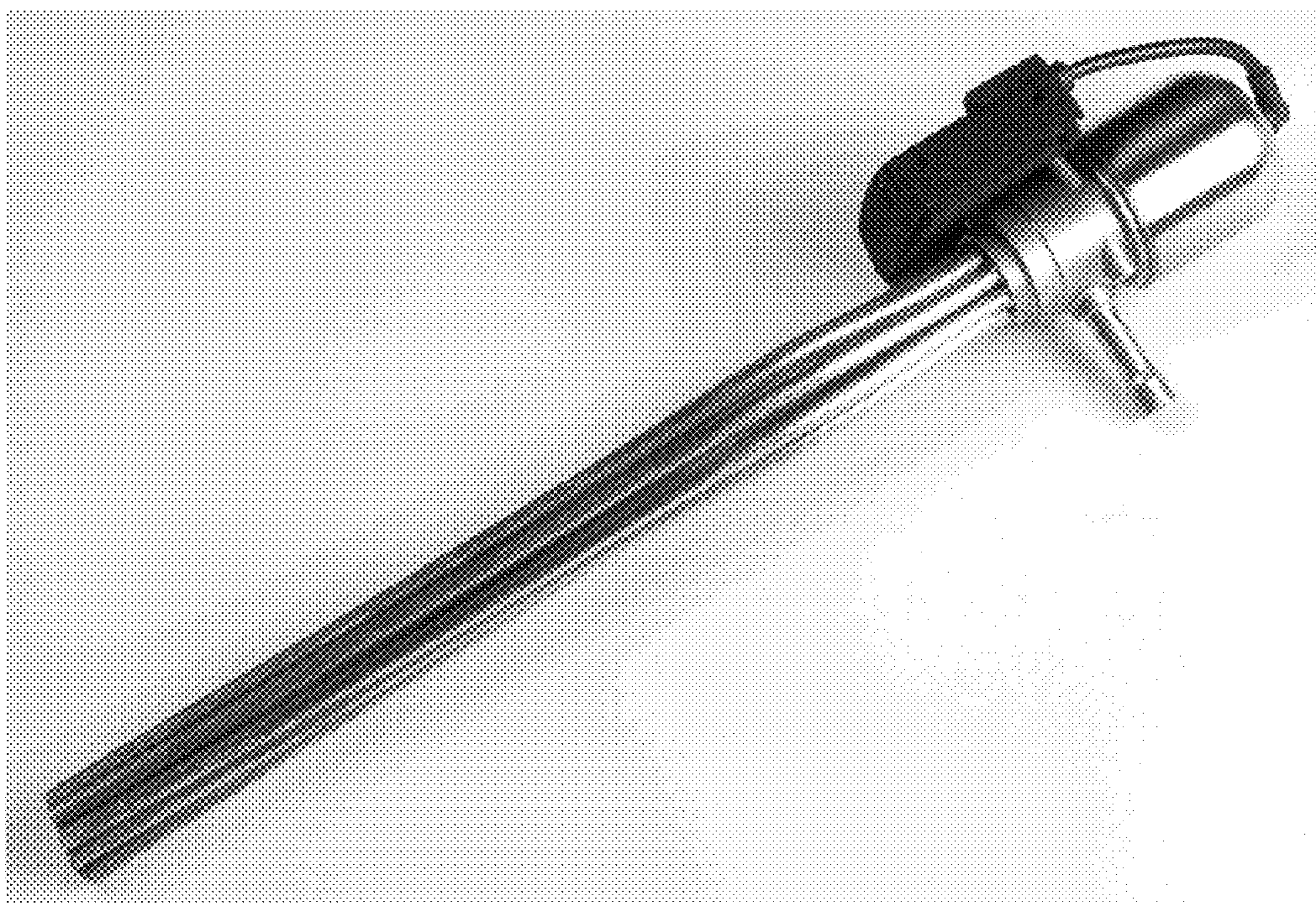
(57) **CLAIM**

The ornamental design for an ecoflow valve, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an ecoflow valve comprising a new, original and ornamental design;  
FIG. 2 is a left-hand side perspective view of an ecoflow valve comprising the new, original and ornamental design;  
FIG. 3 is a rear view of an ecoflow valve comprising the new, original and ornamental design;

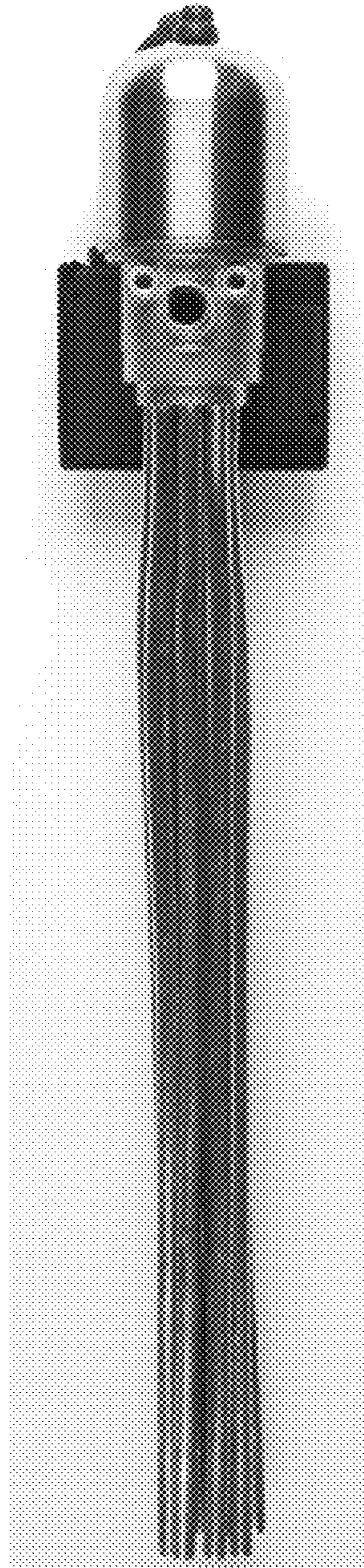

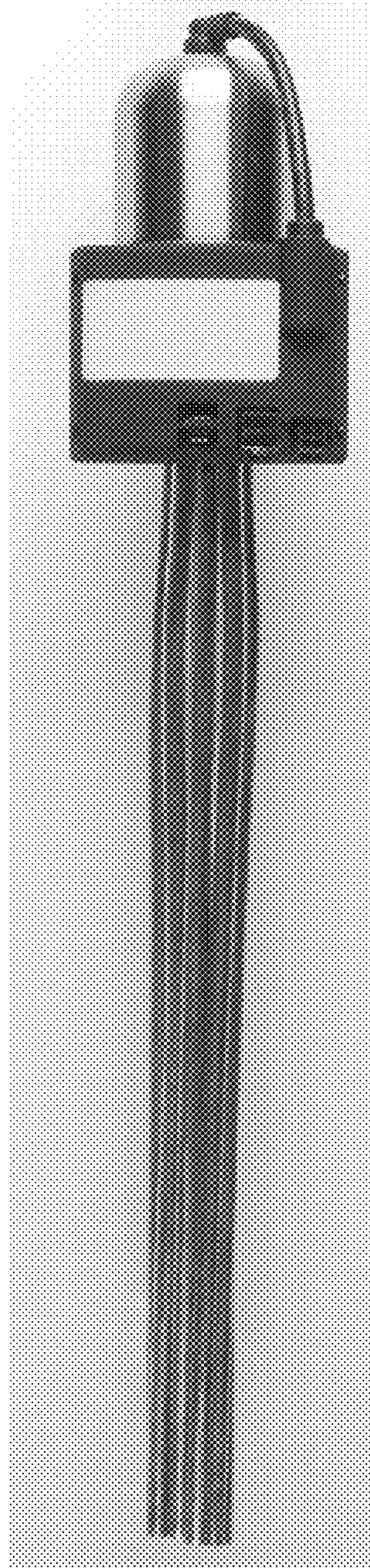

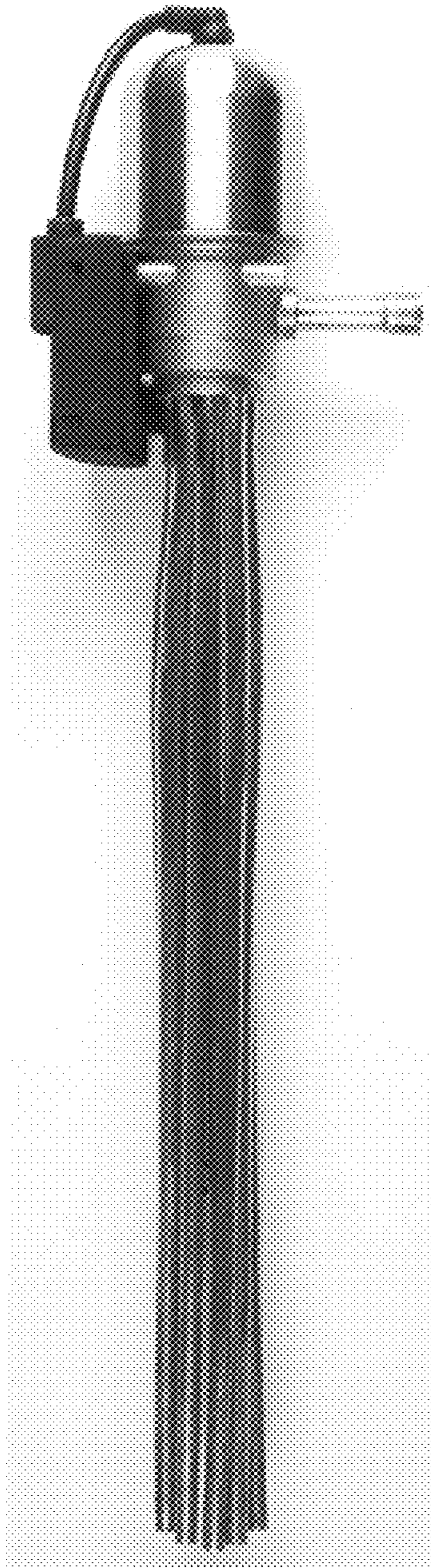

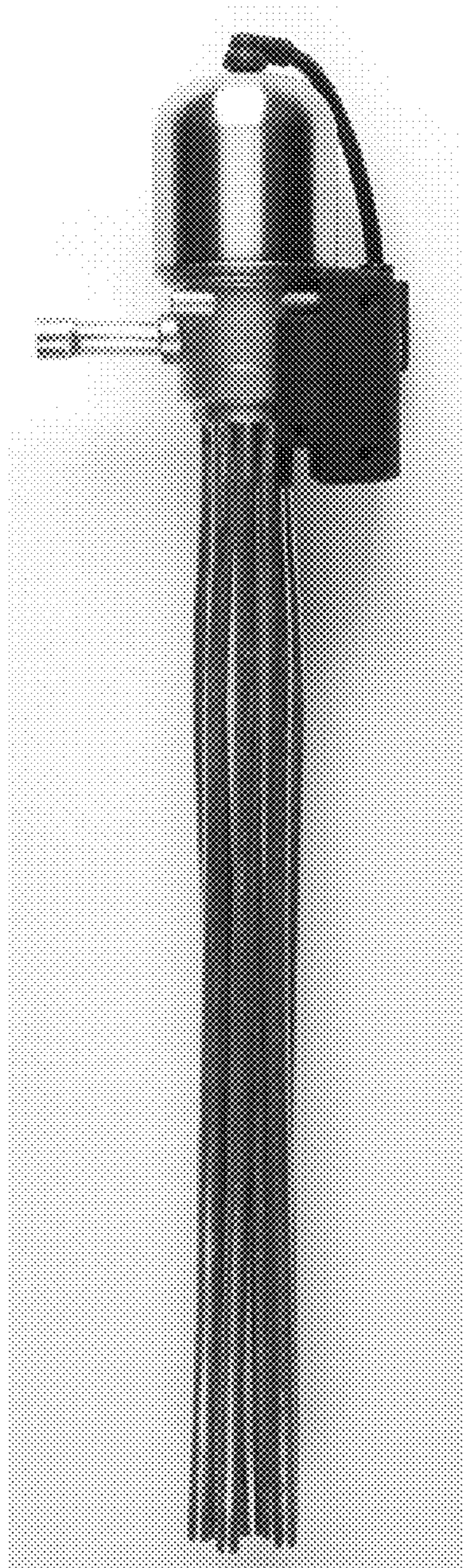

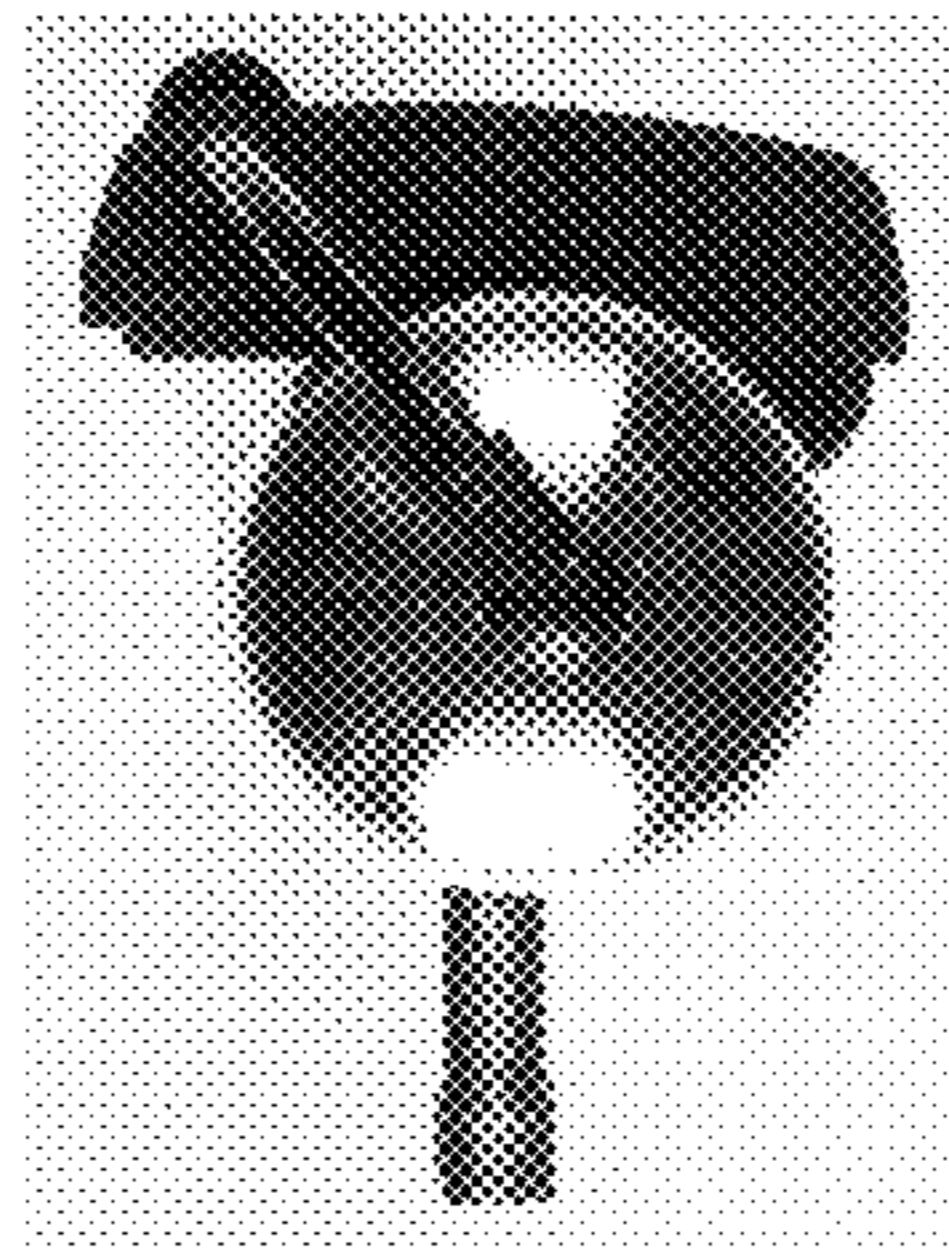

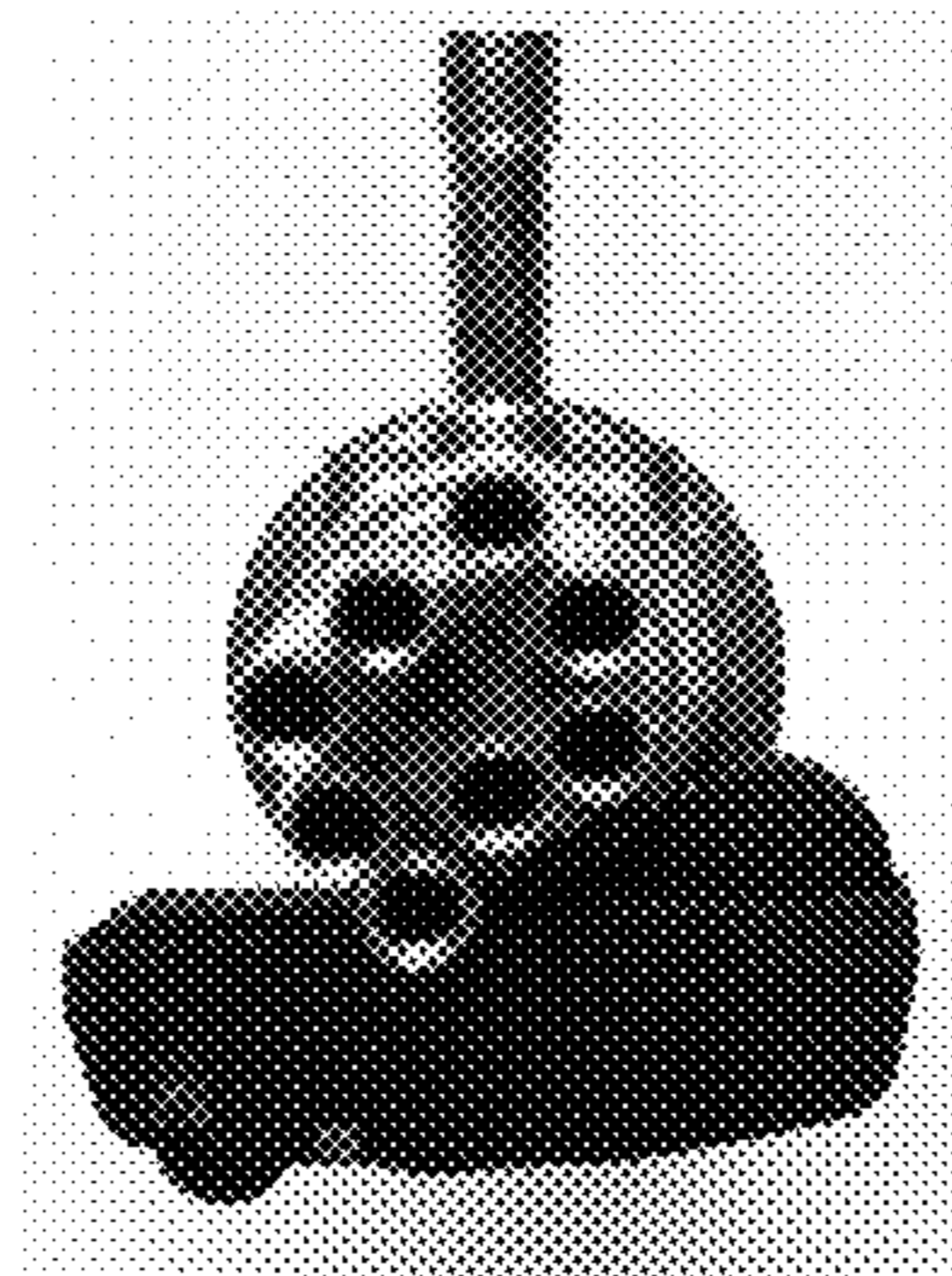
