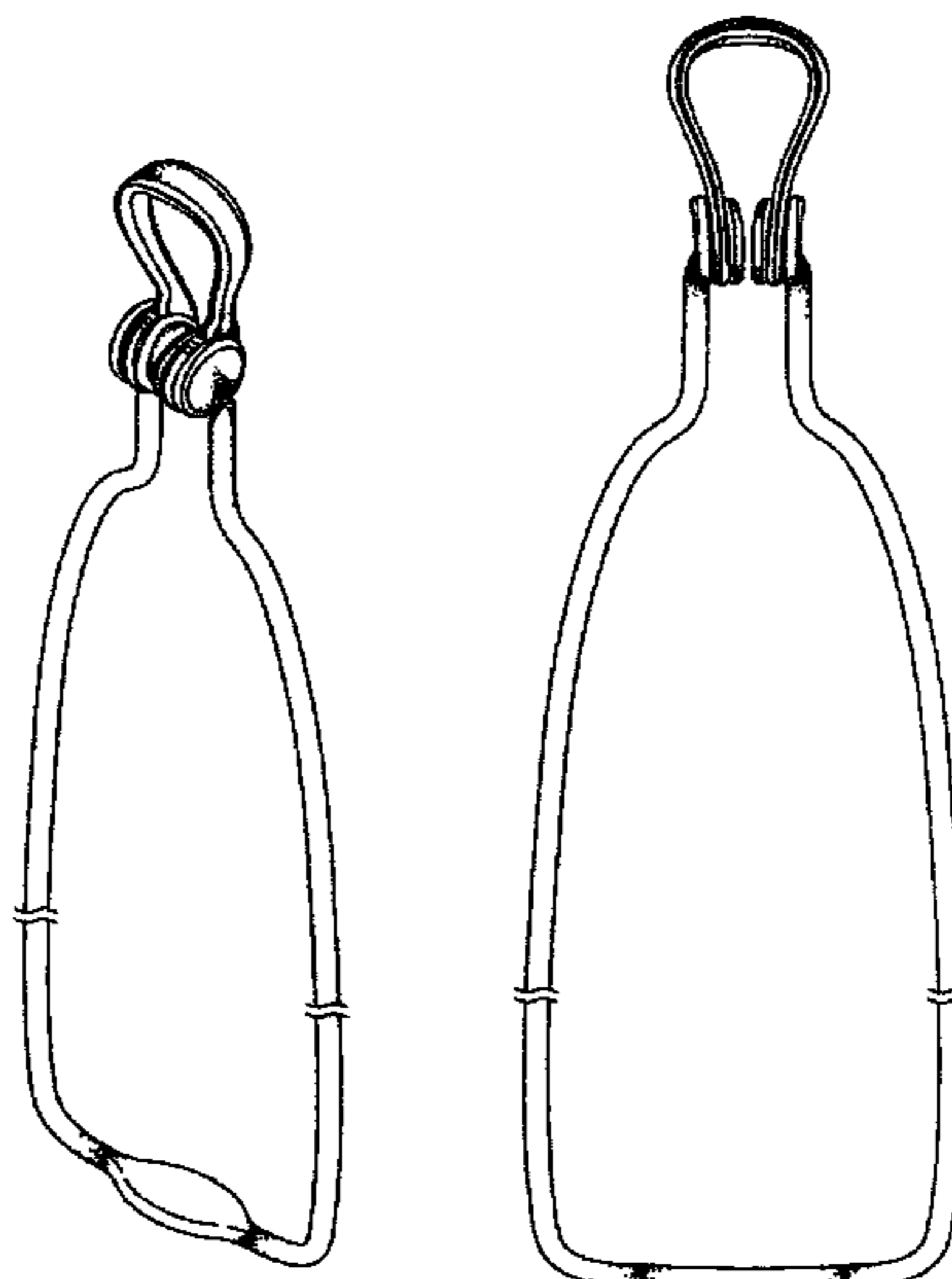
(57) **CLAIM**

The ornamental design for a nose clip with a head strap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a nose clip with a head strap showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left elevational view thereof;
FIG. 5 is a right elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The strap is shown broken away at each side to indicate that no particular length is claimed.

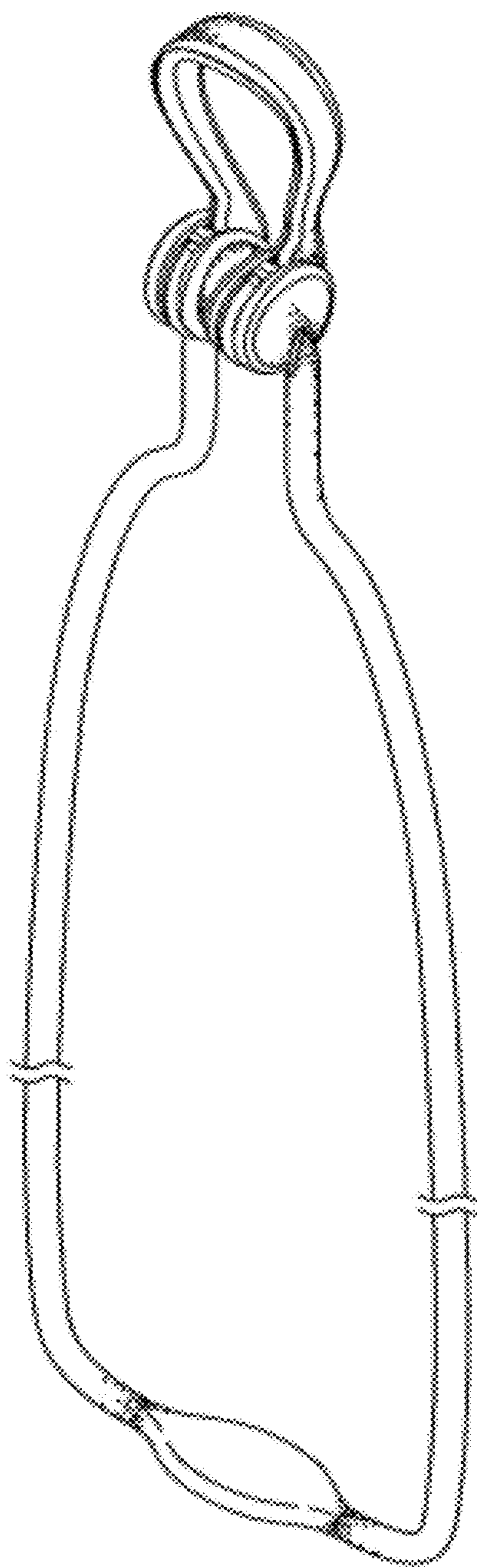

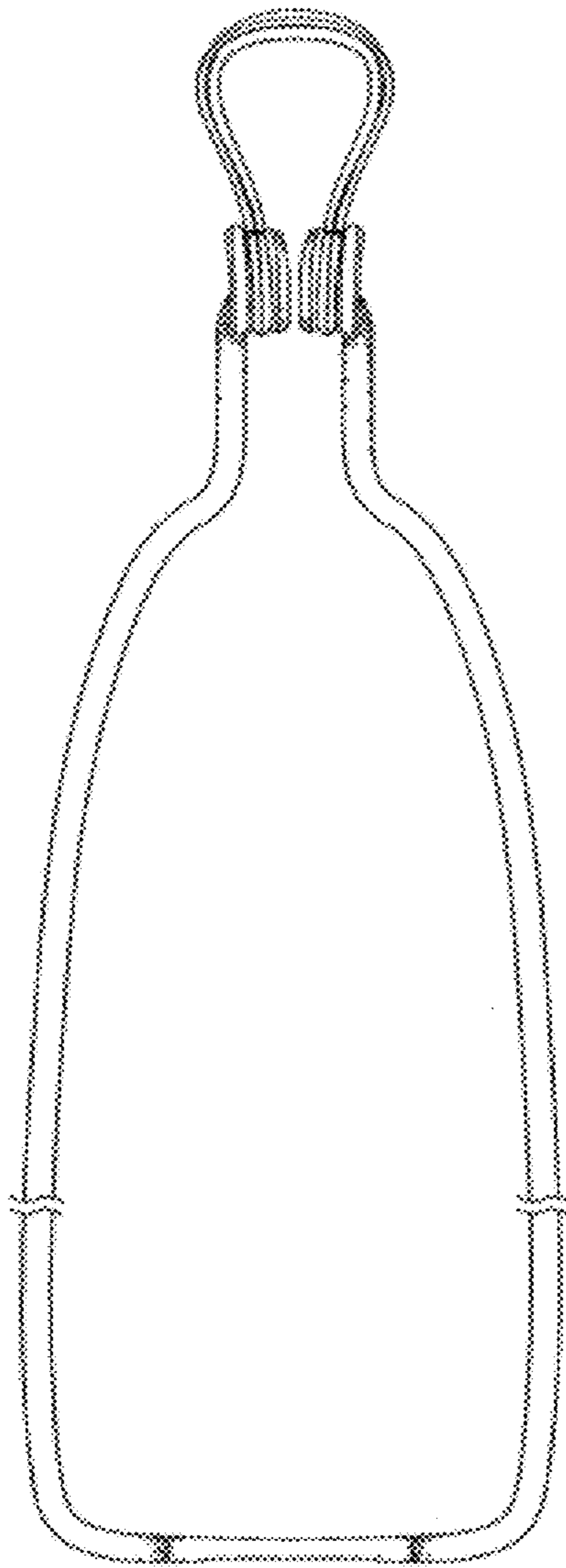

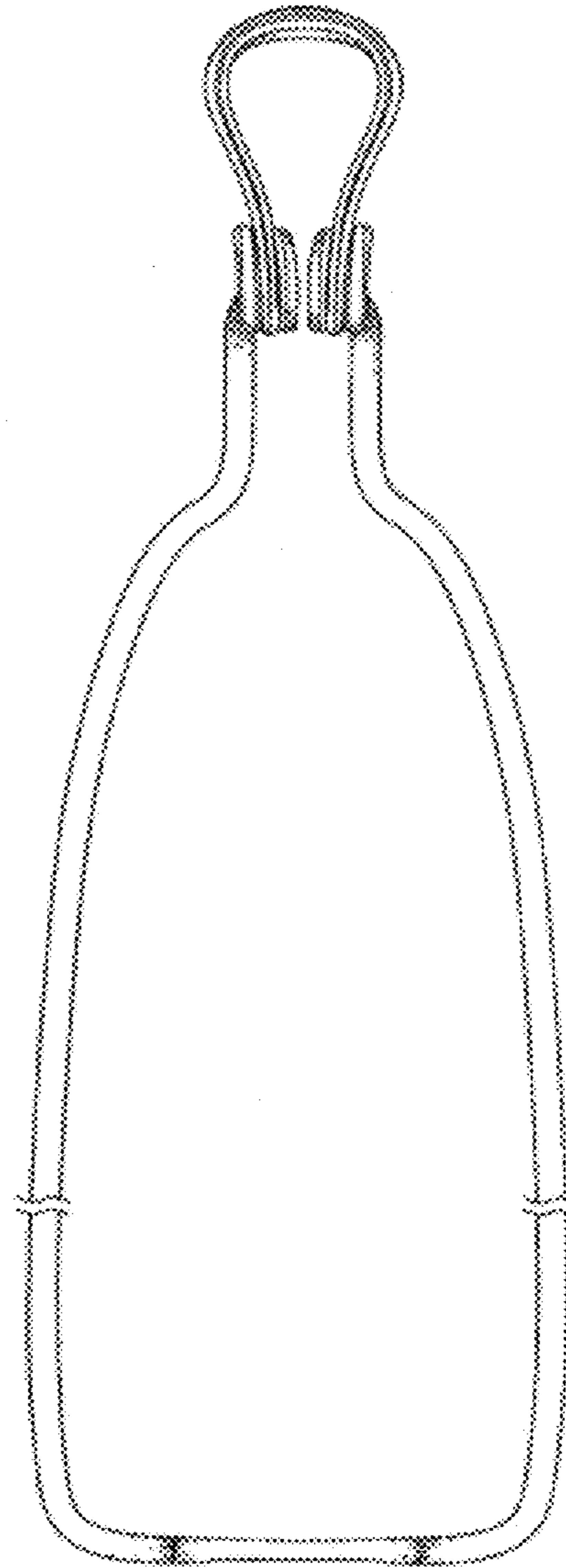

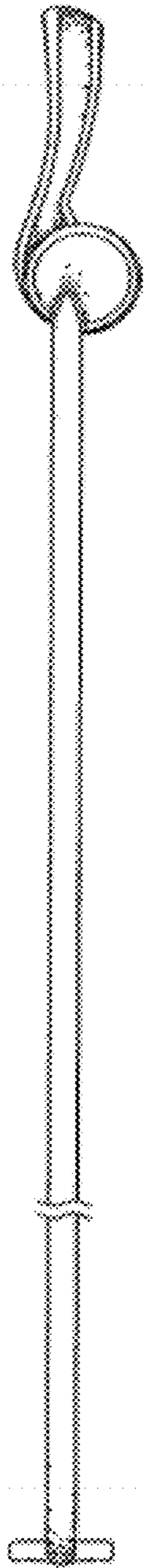

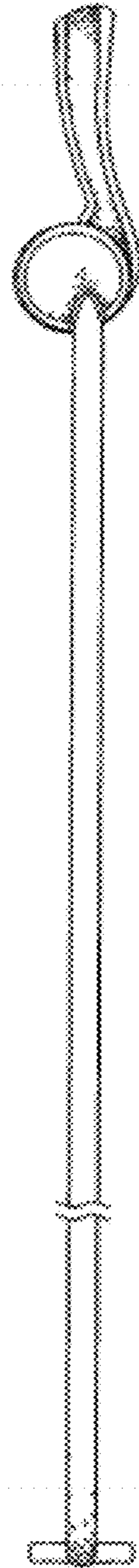

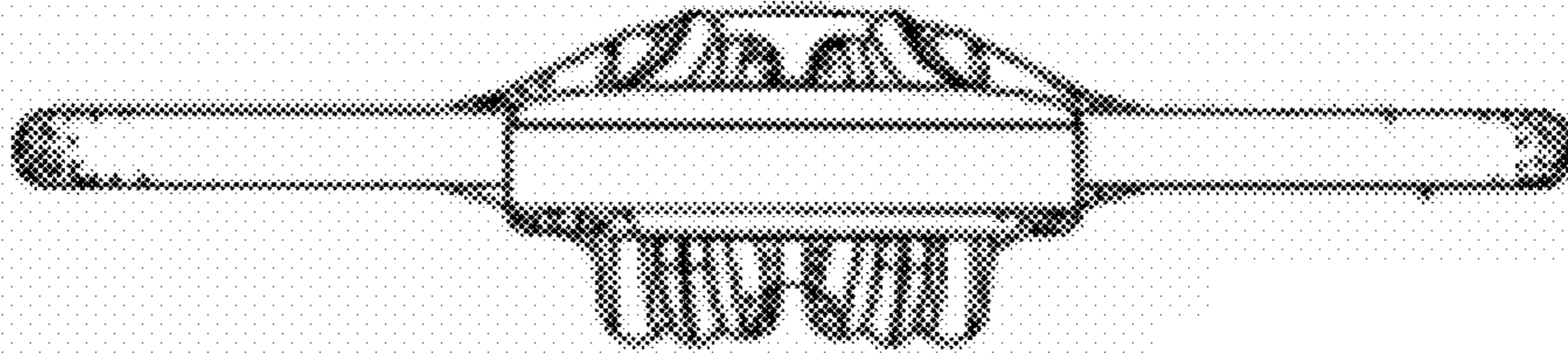

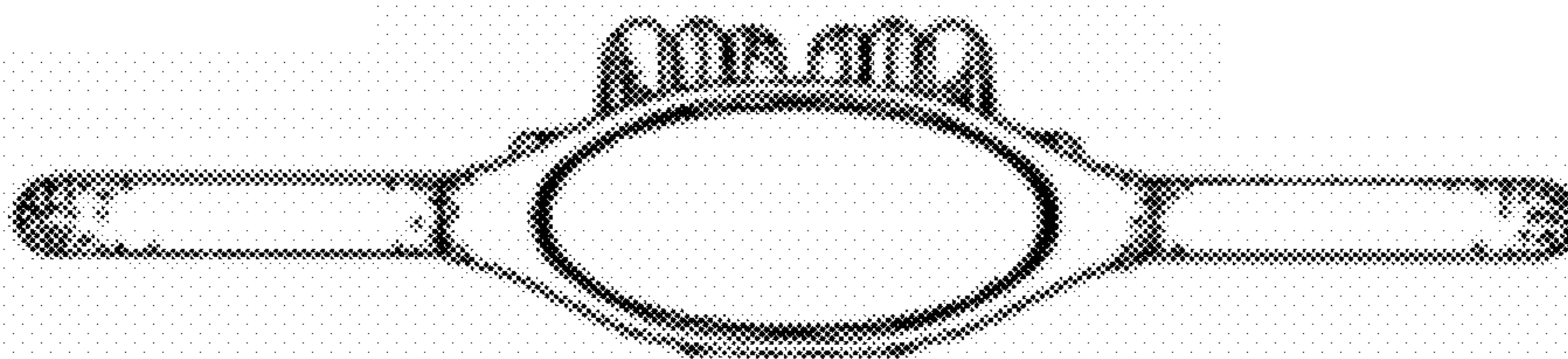
