(57) **CLAIM**

The ornamental design for a surgical needle holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a surgical needle holder showing my new design;

FIG. 2 is a top plan view of the surgical needle holder shown in FIG. 1;

FIG. 3 is a bottom plan view of the surgical needle holder shown in FIG. 1;

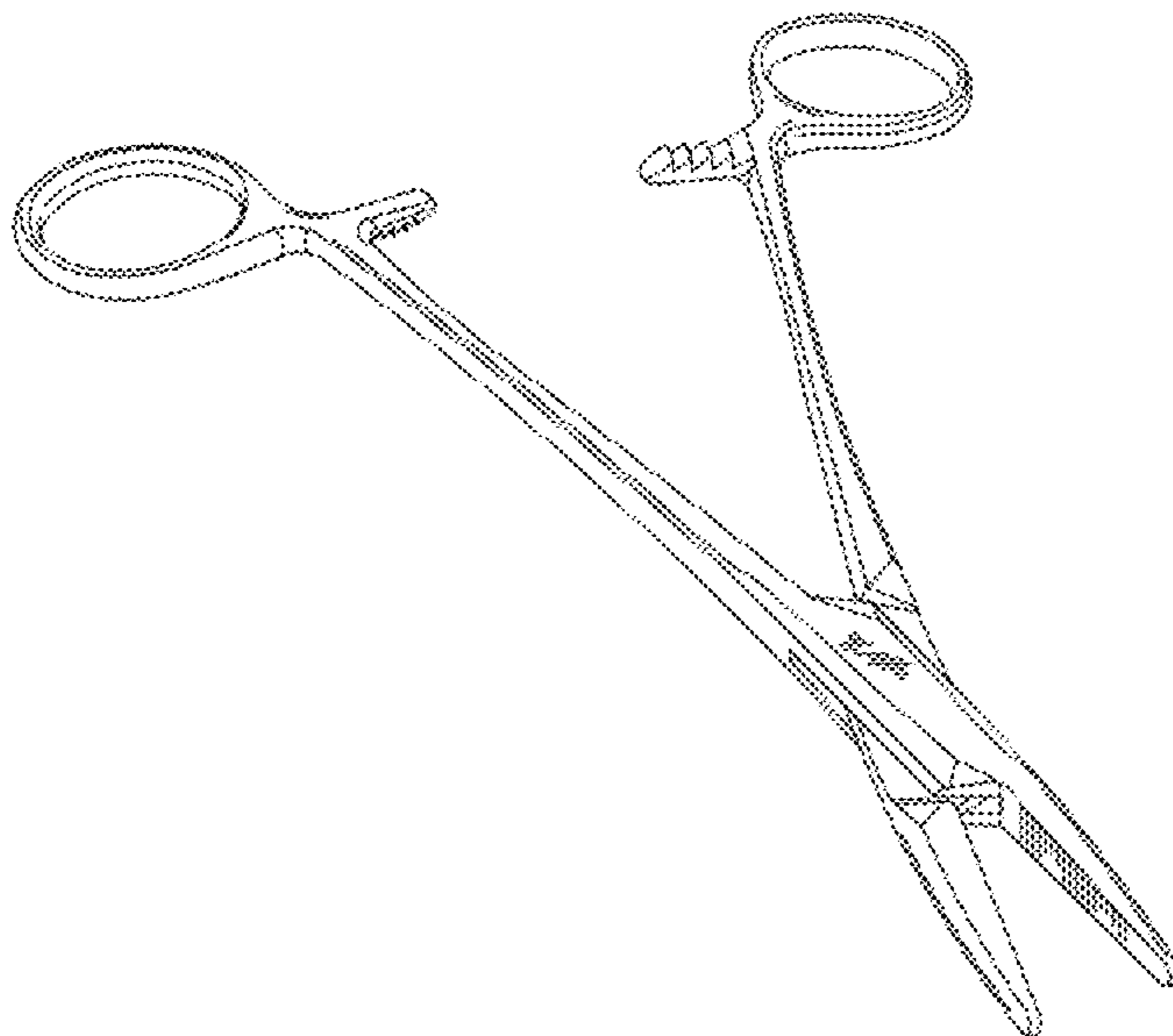
FIG. 4 is a side view of the surgical needle holder shown in FIG. 1;

FIG. 5 is a side view of the side opposite that of the side shown in FIG. 4;

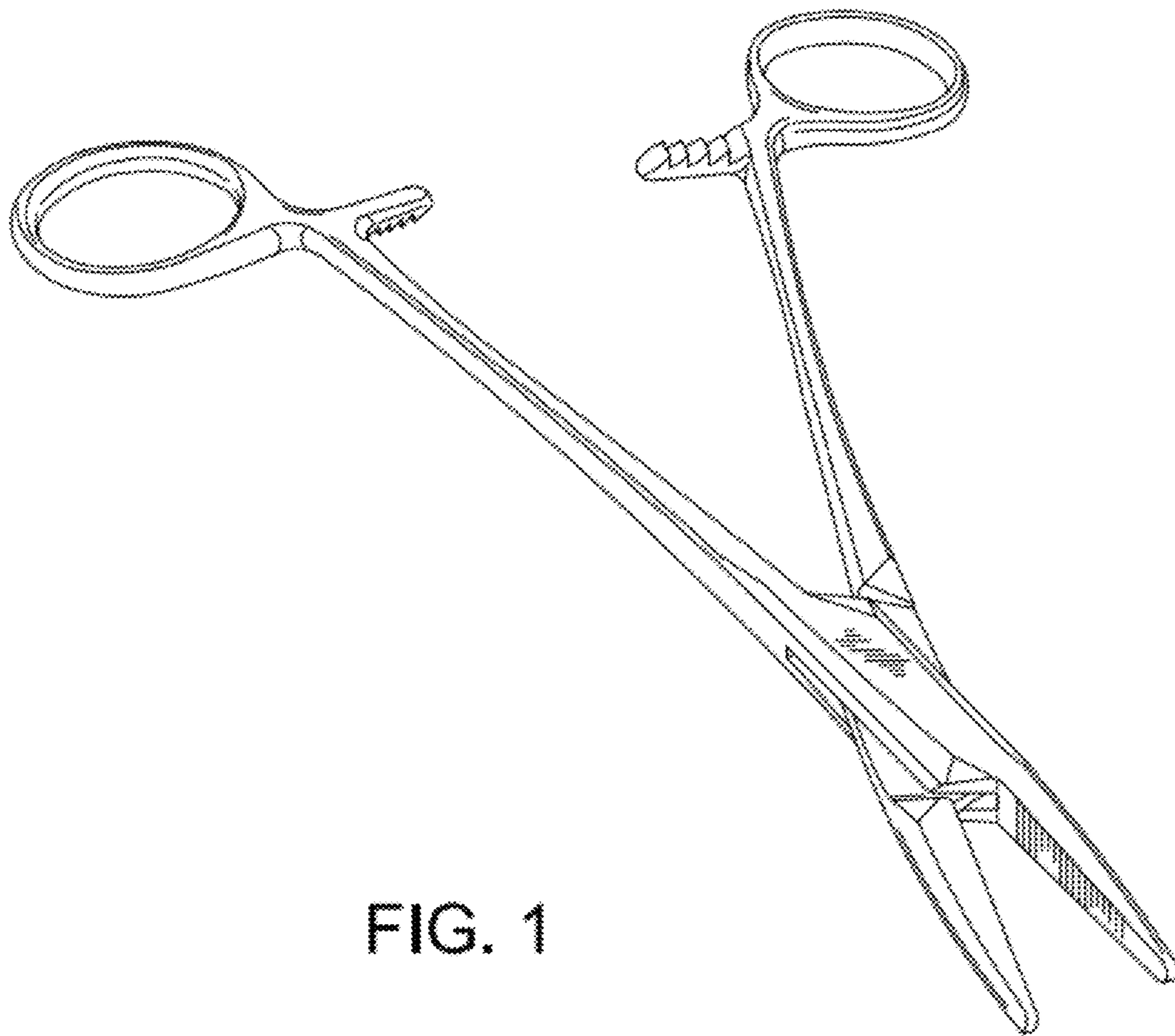

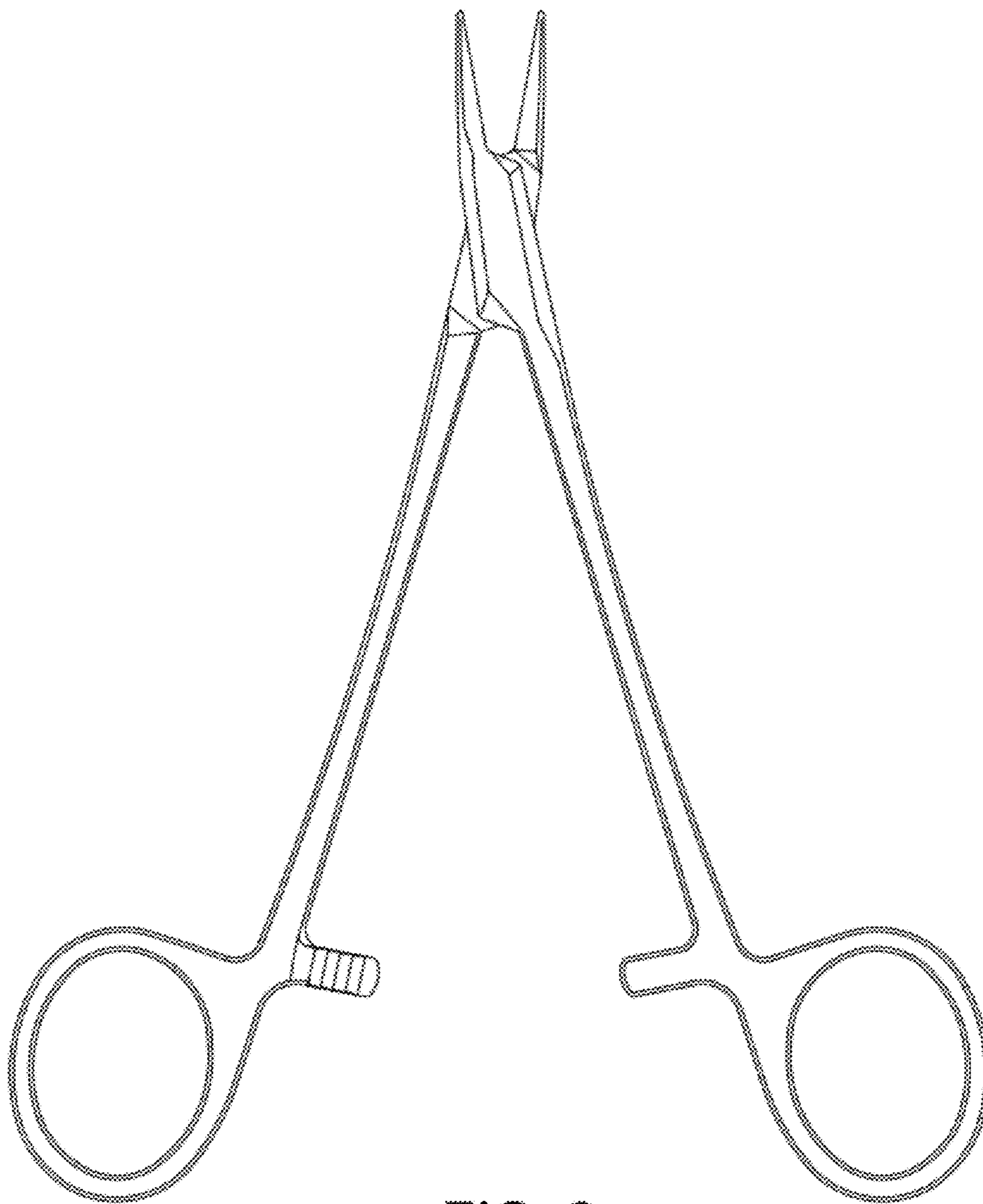

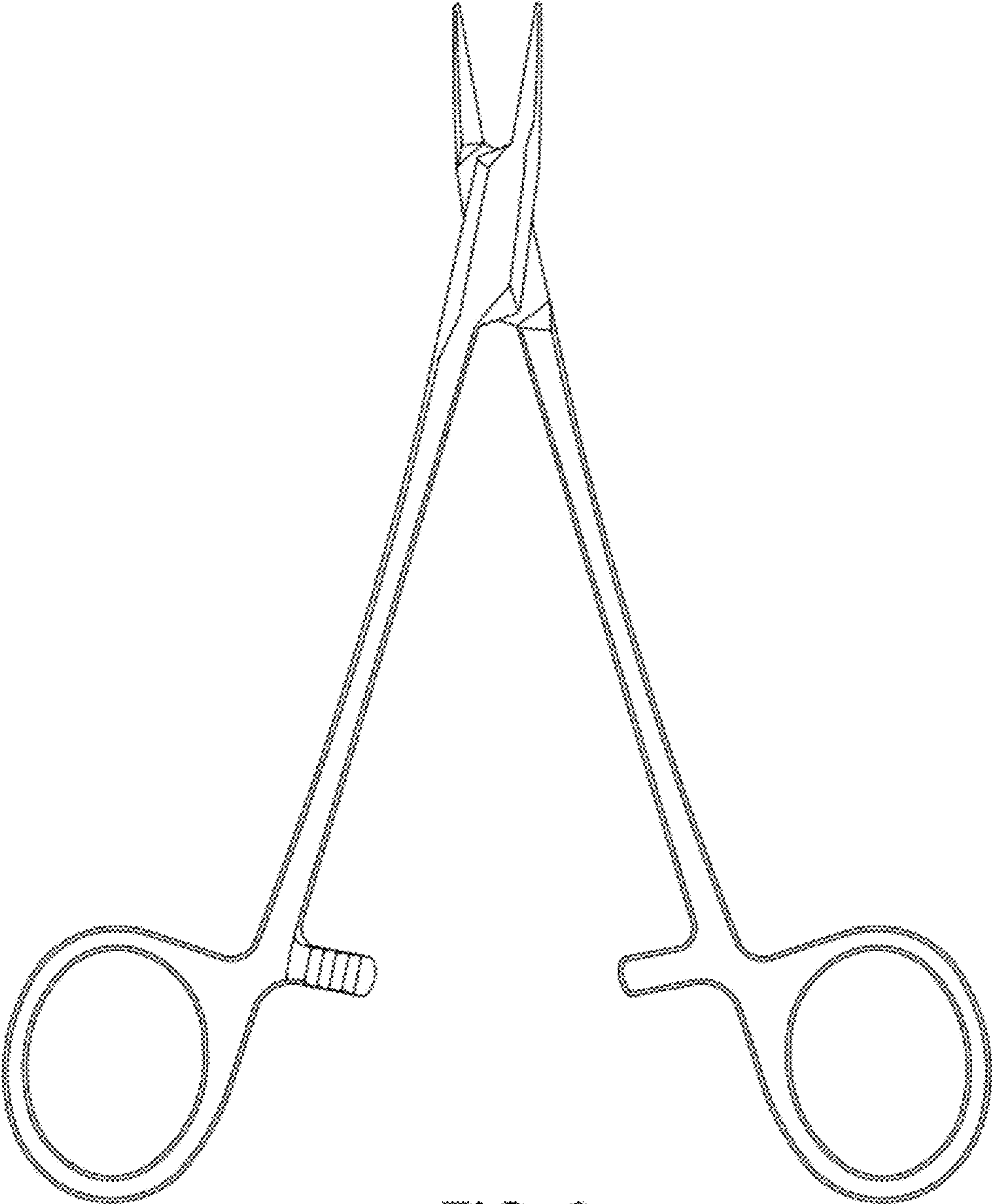

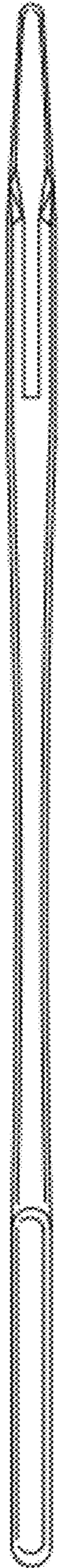

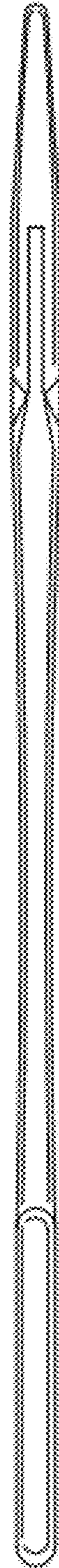
