DESCRIPTION

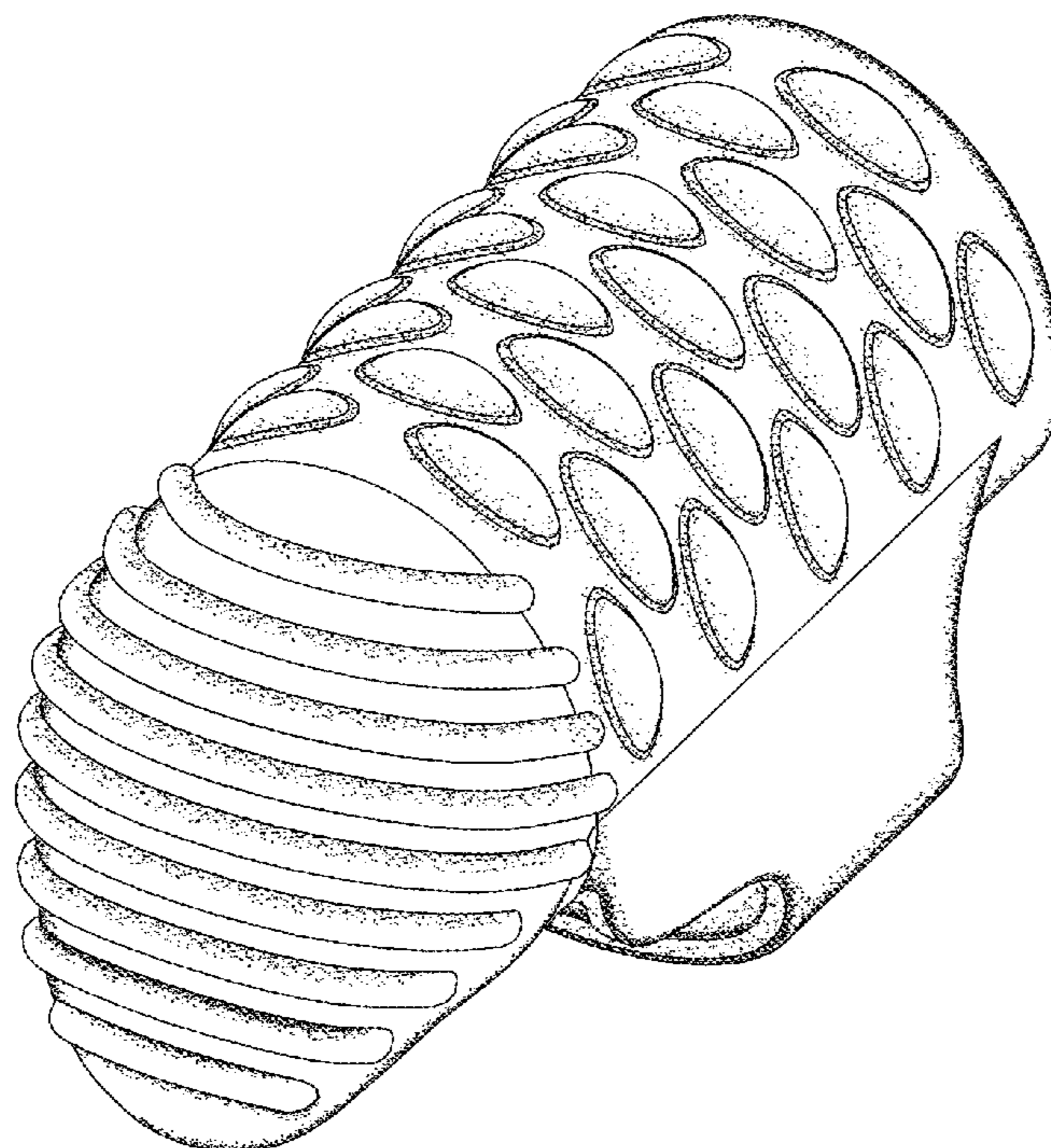
FIG. 1 is a perspective view of a massage fingerstall showing my new design;

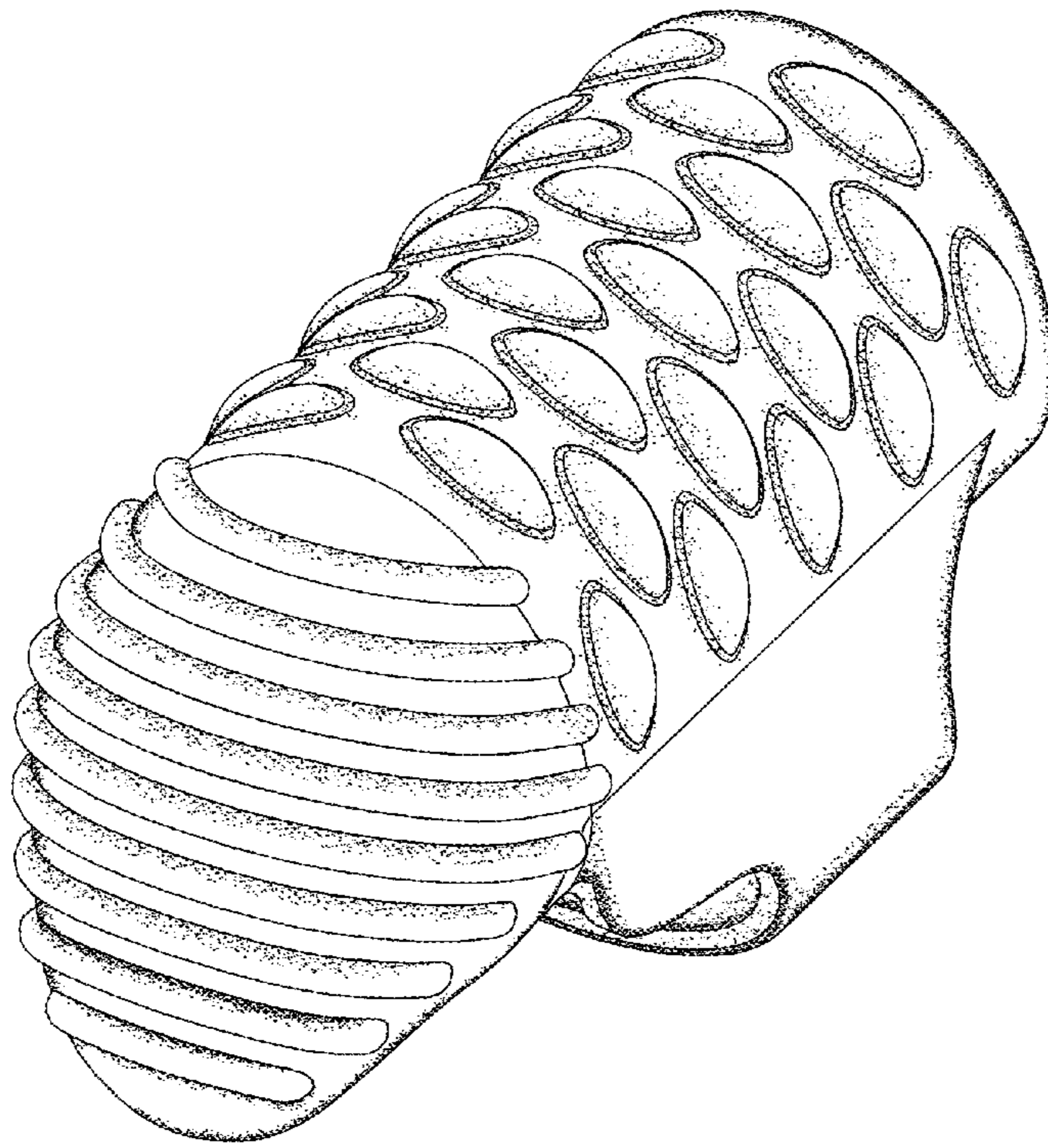

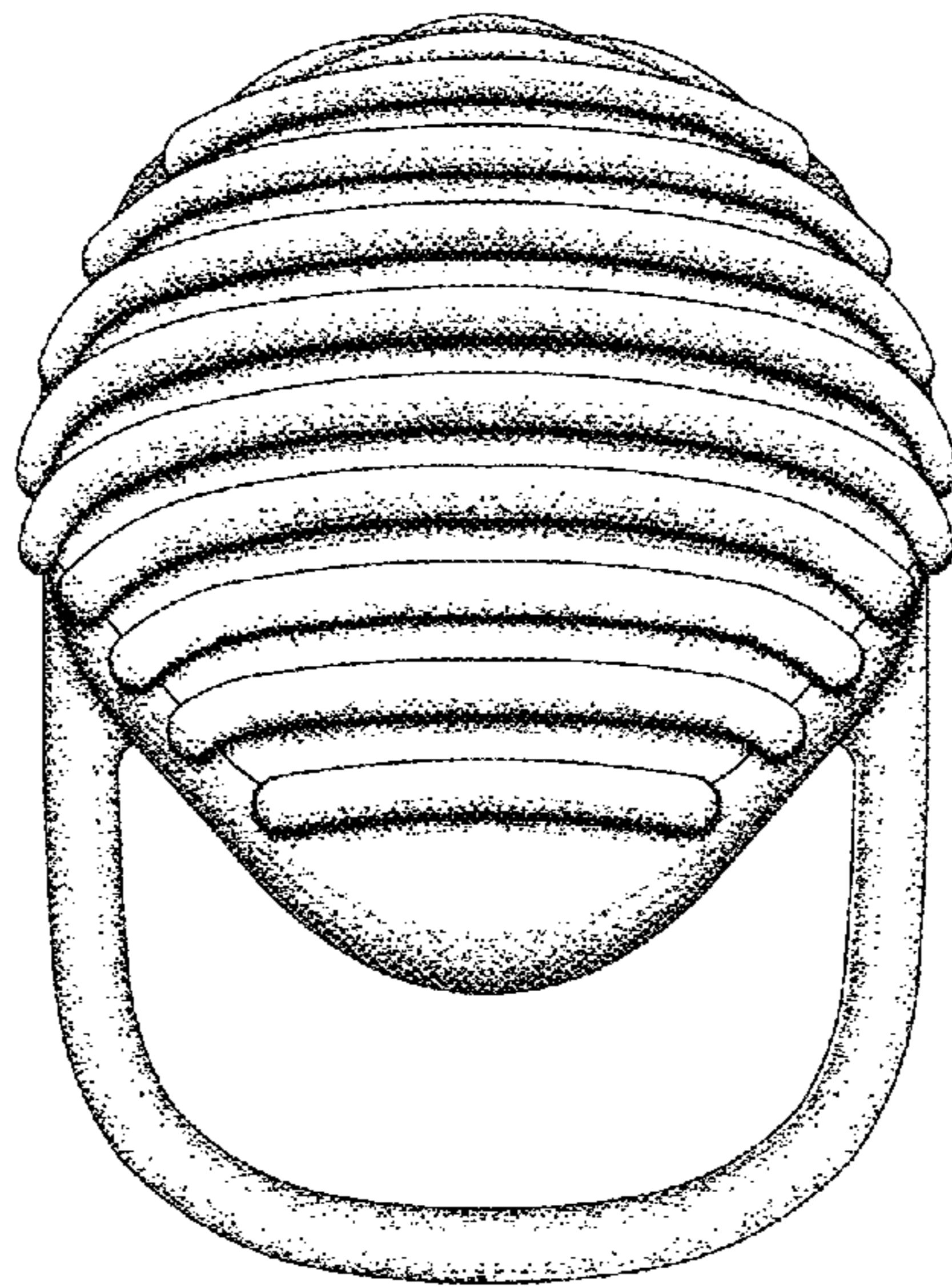

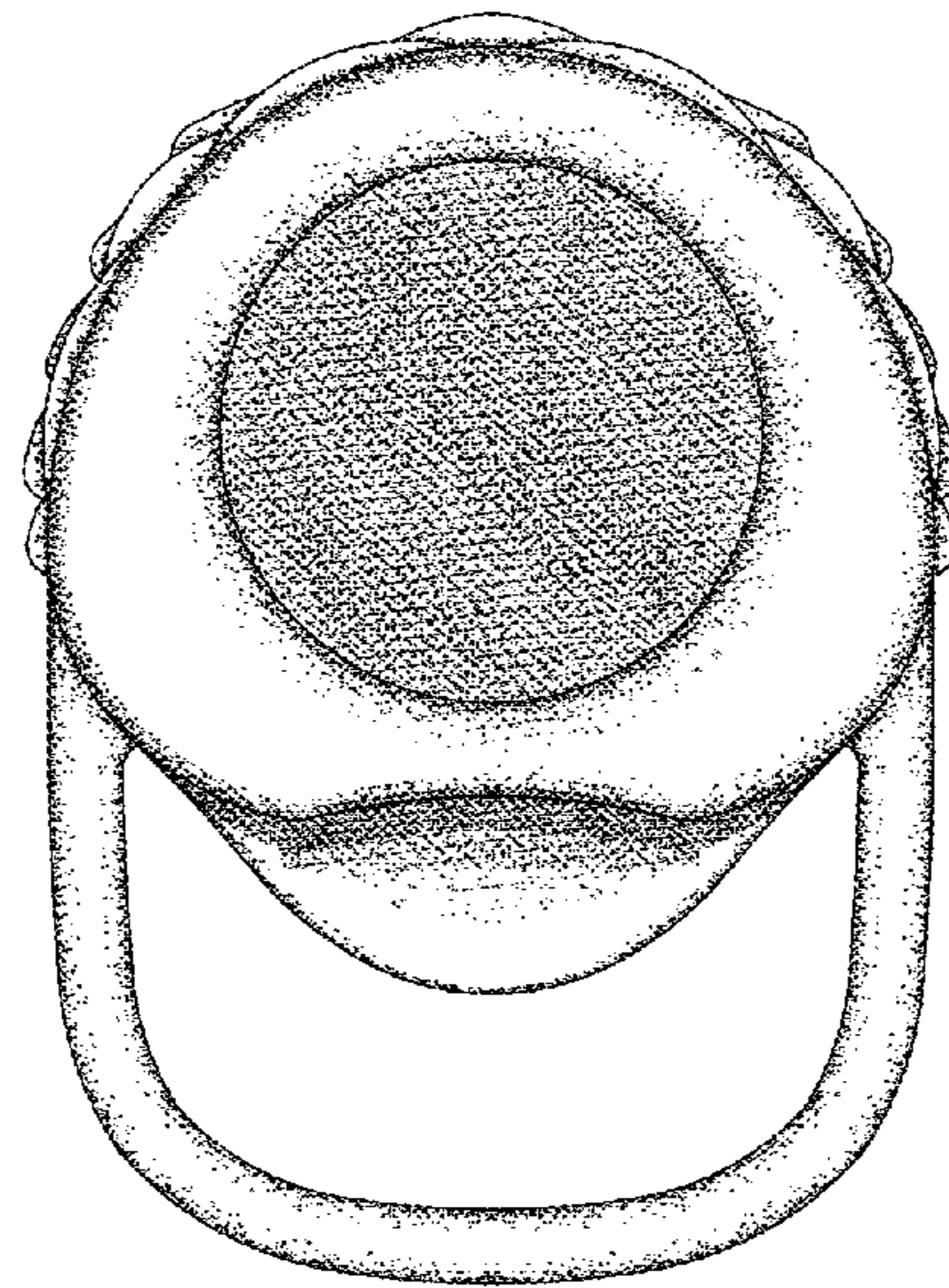

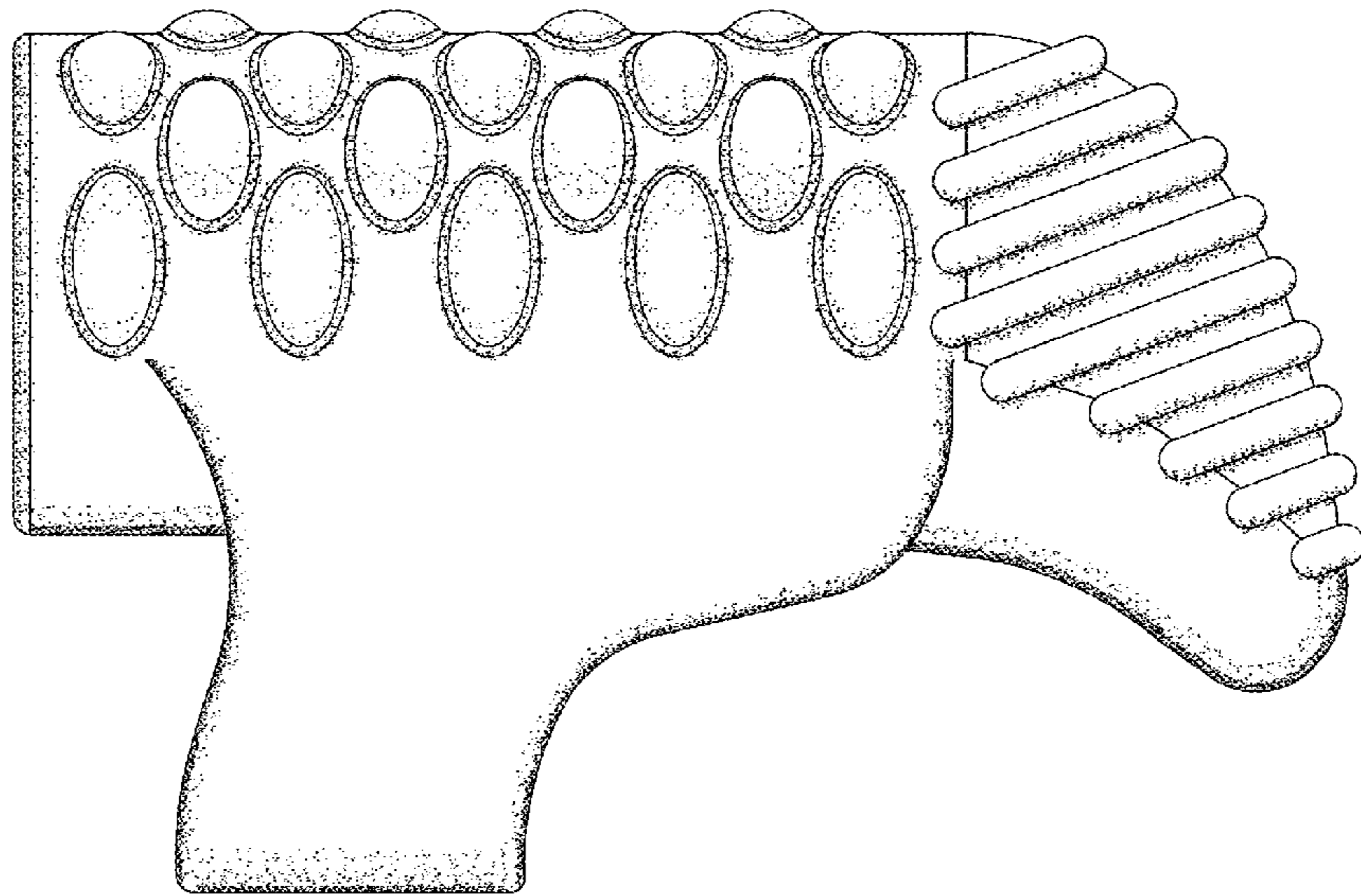

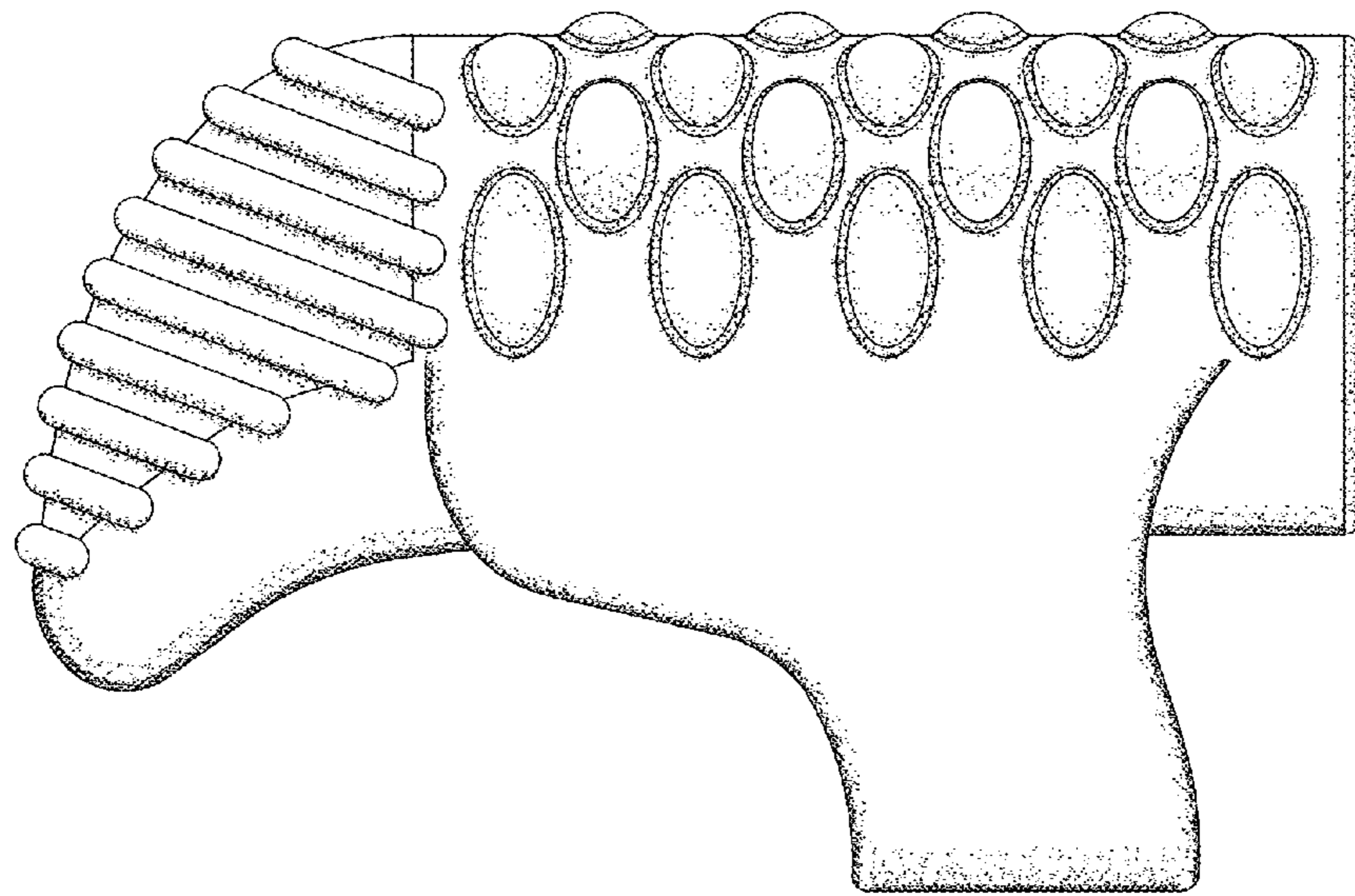

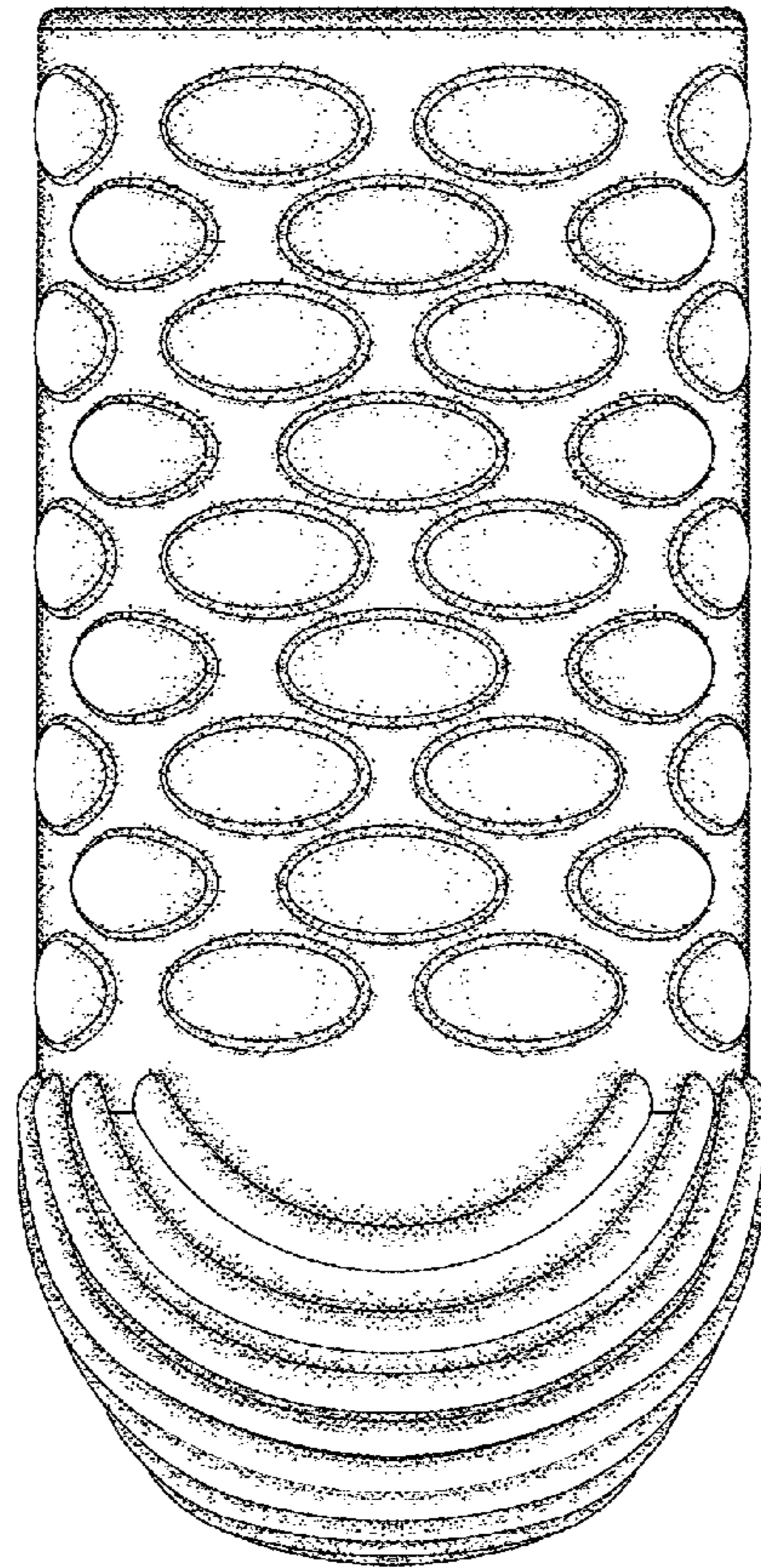

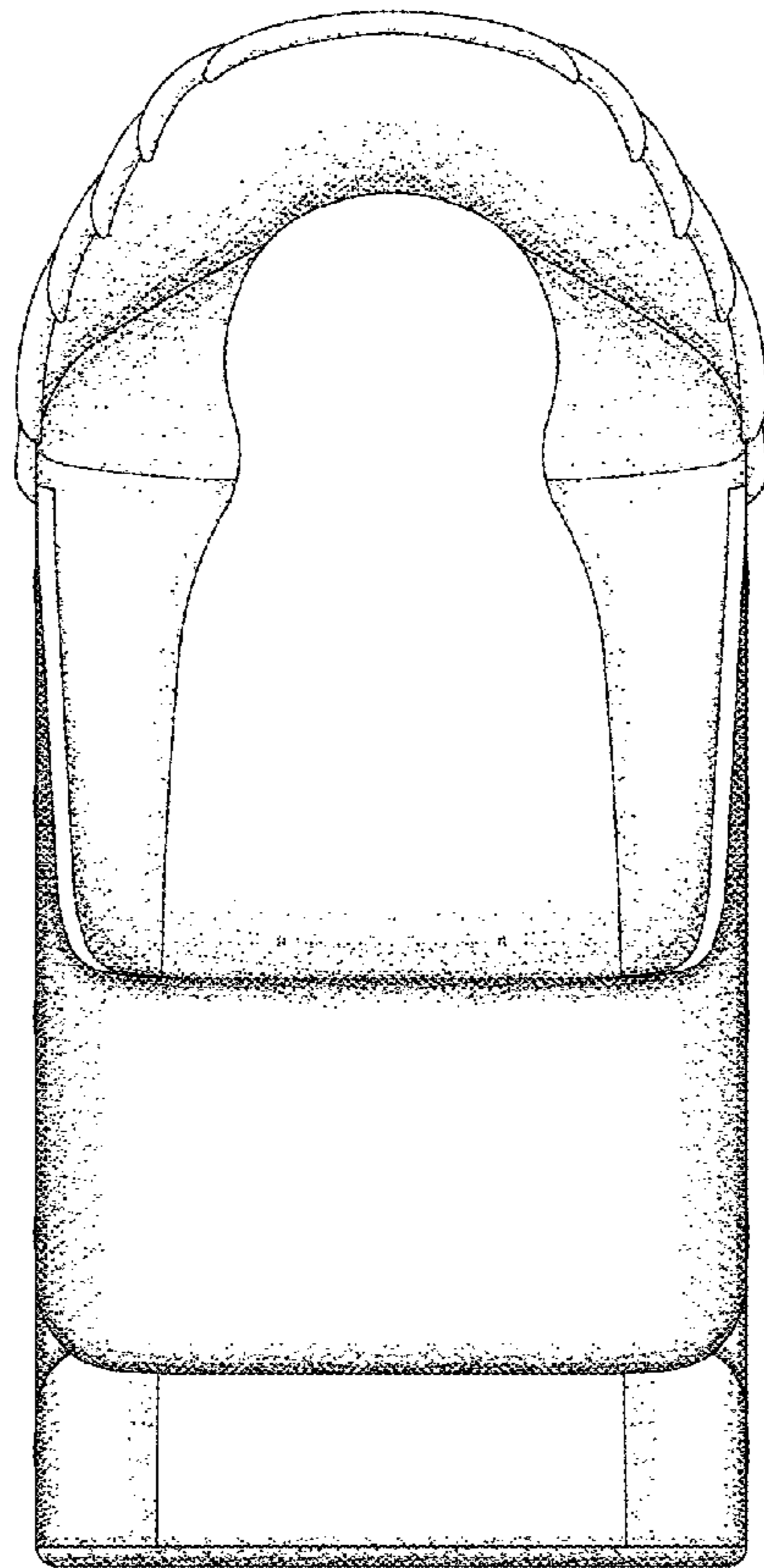
