(57) **CLAIM**

We claim the ornamental design for a wardrobe door, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wardrobe door, according to a first embodiment;

FIG. 2 is a left side elevation view of the wardrobe door of FIG. 1, of which a right side elevation view (not shown) is a mirror image;

FIG. 3 is a front elevation view of the wardrobe door of FIG. 1;

FIG. 4 is a top plan view of the wardrobe door of FIG. 1, of which a bottom plan view (not shown) is a mirror image;

FIG. 5 is a rear elevation view of the wardrobe door of FIG. 1; FIG. 6 is a perspective view of a wardrobe door, according to a second embodiment;

FIG. 7 is a left side elevation view of the wardrobe door of FIG. 6, of which a right side elevation view (not shown) is a mirror image;

FIG. 8 is a front elevation view of the wardrobe door of FIG. 6;

FIG. 9 is a top plan view of the wardrobe door of FIG. 6, of which a bottom plan view (not shown) is a mirror image;

FIG. 10 is a rear elevation view of the wardrobe door of FIG. 6;

FIG. 11 is a perspective view of a wardrobe door, according to a third embodiment;

FIG. 12 is a left side elevation view of the wardrobe door of FIG. 11, of which a right side elevation view (not shown) is a mirror image;

FIG. 13 is a front elevation view of the wardrobe door of FIG. 11;

FIG. 14 is a top plan view of the wardrobe door of FIG. 11, of which a bottom plan view (not shown) is a mirror image;

FIG. 15 is a rear elevation view of the wardrobe door of FIG. 11;

FIG. 16 is a perspective view of a wardrobe door, according to a fourth embodiment;

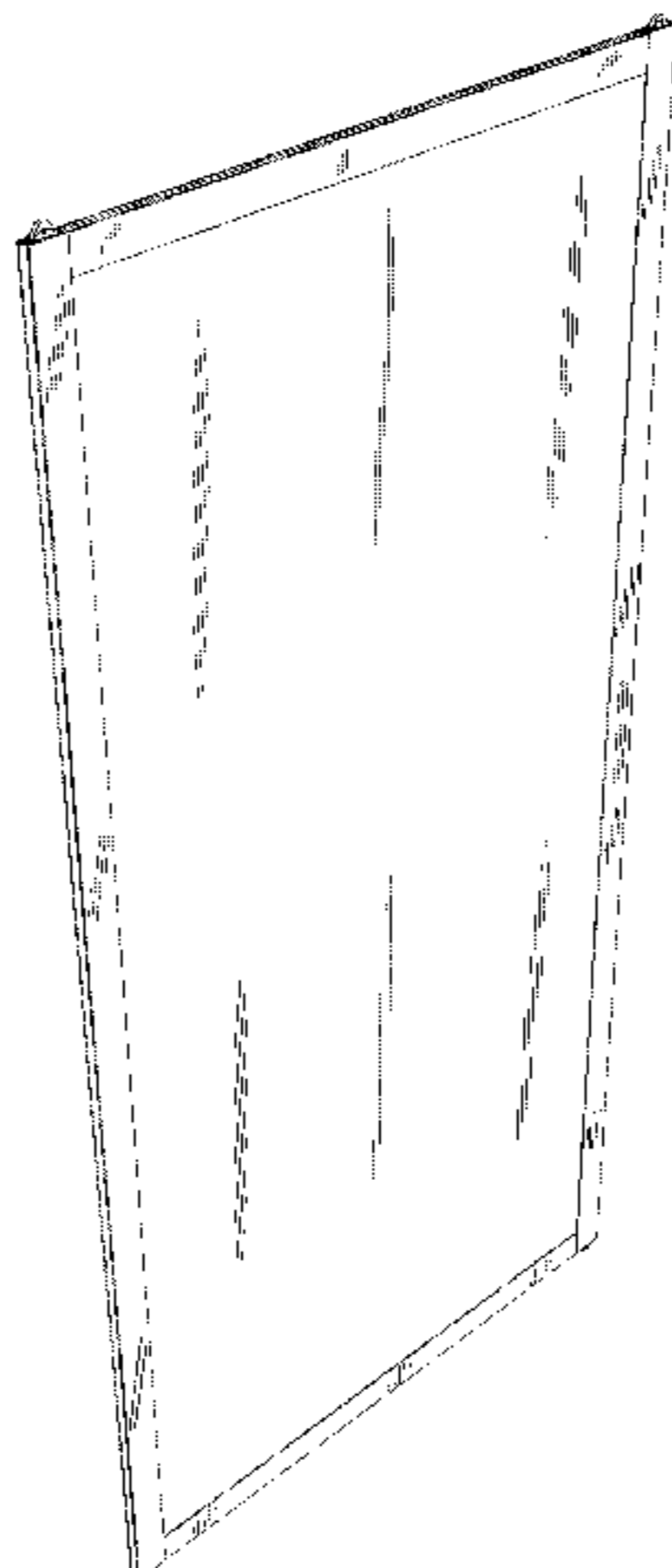
FIG. 17 is a left side elevation view of the wardrobe door of FIG. 16, of which a right side elevation view (not shown) is a mirror image;

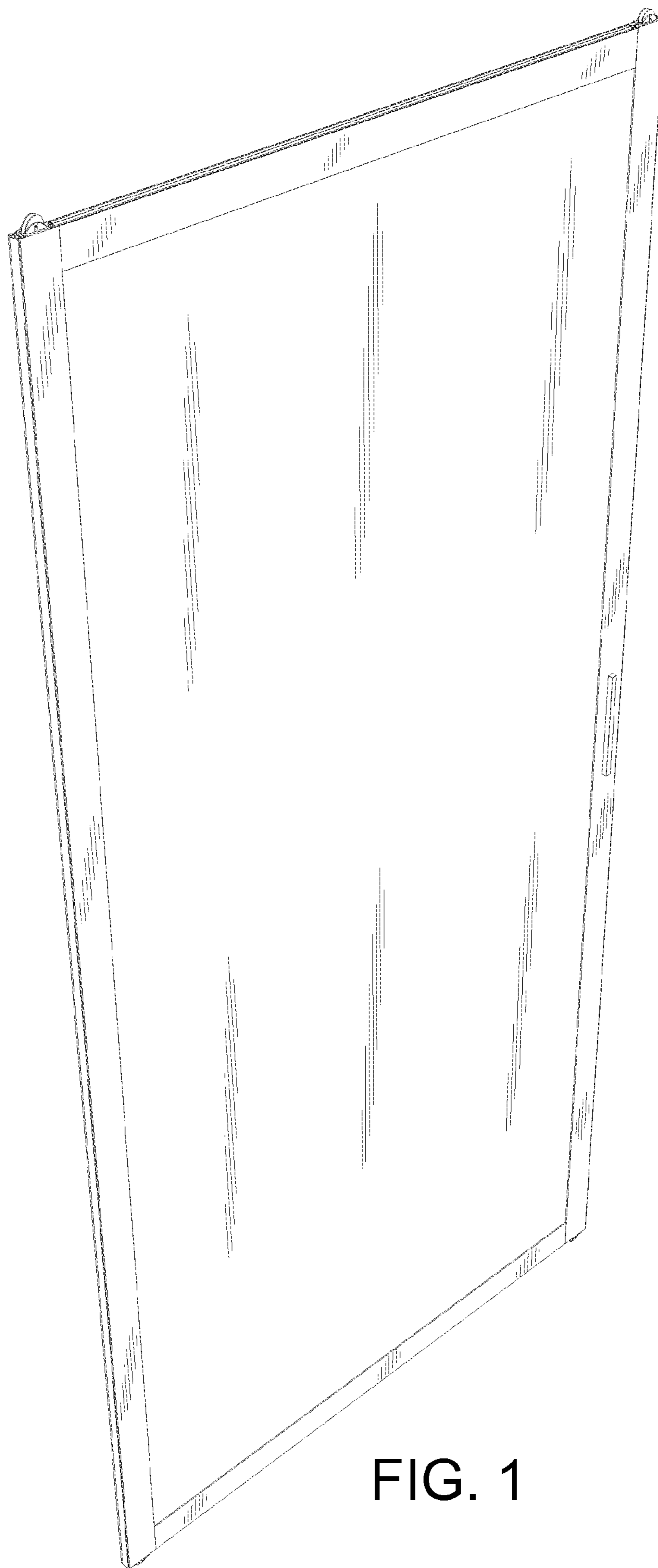

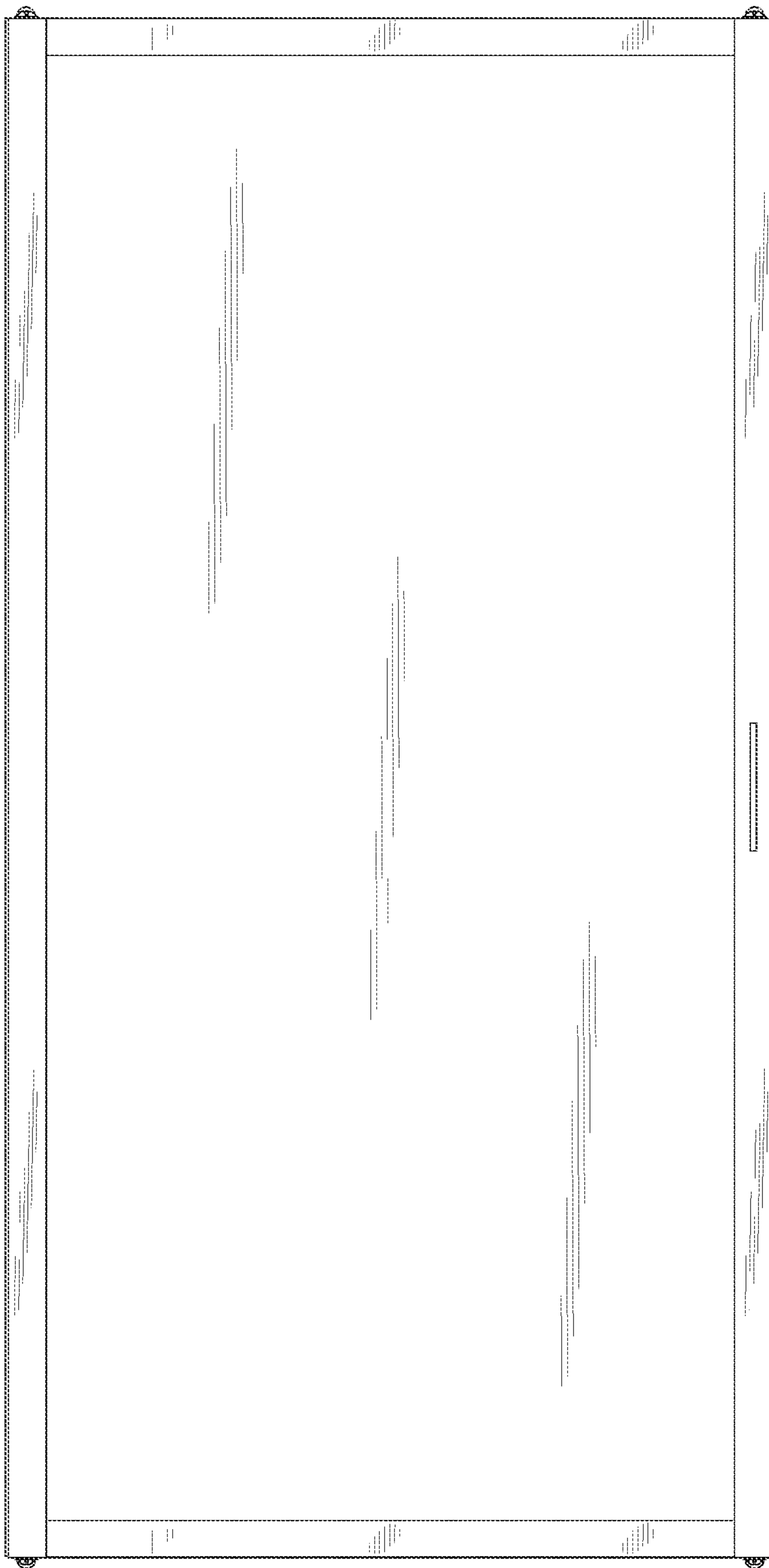

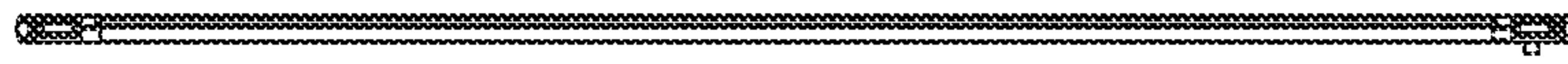

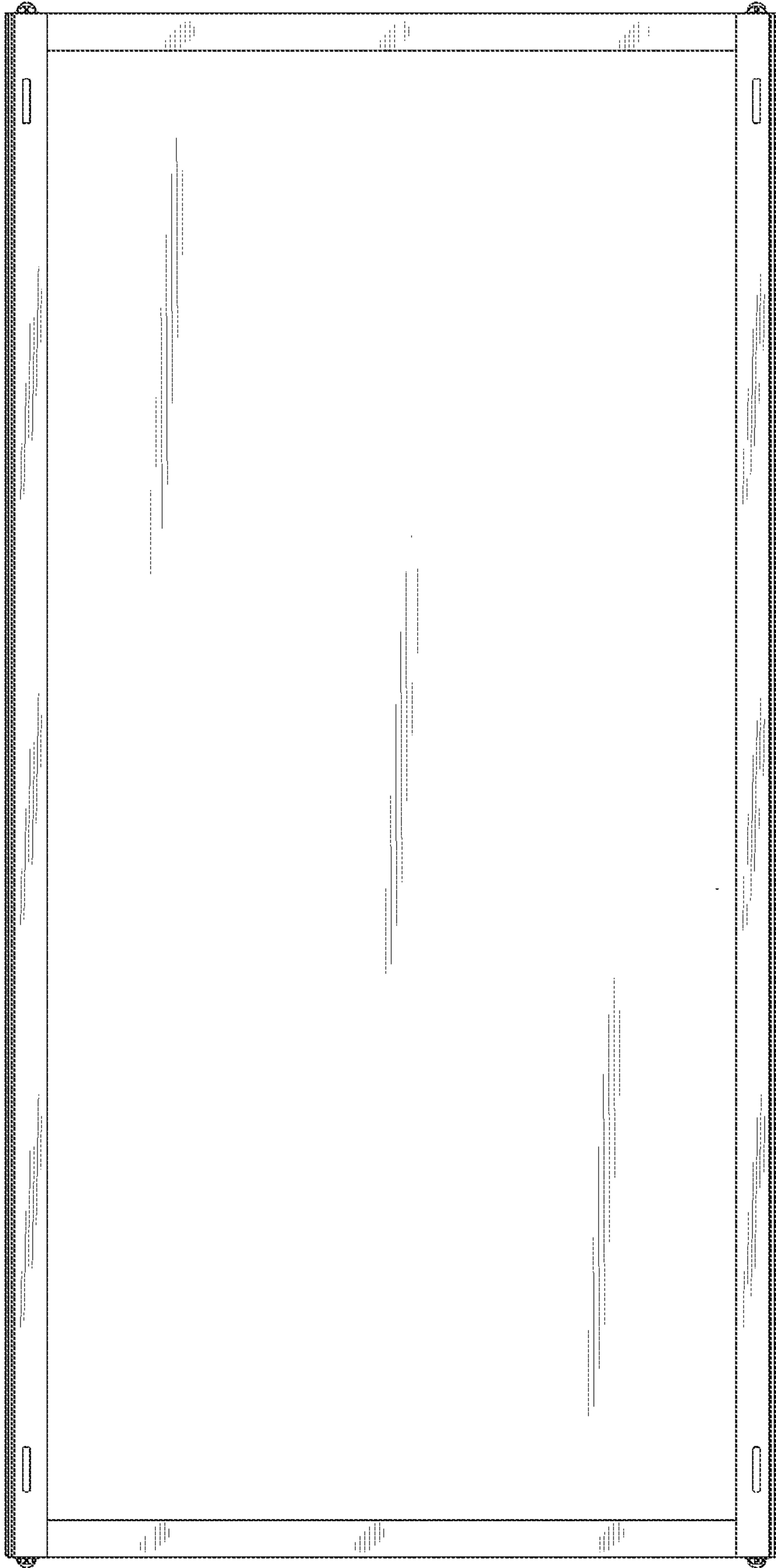

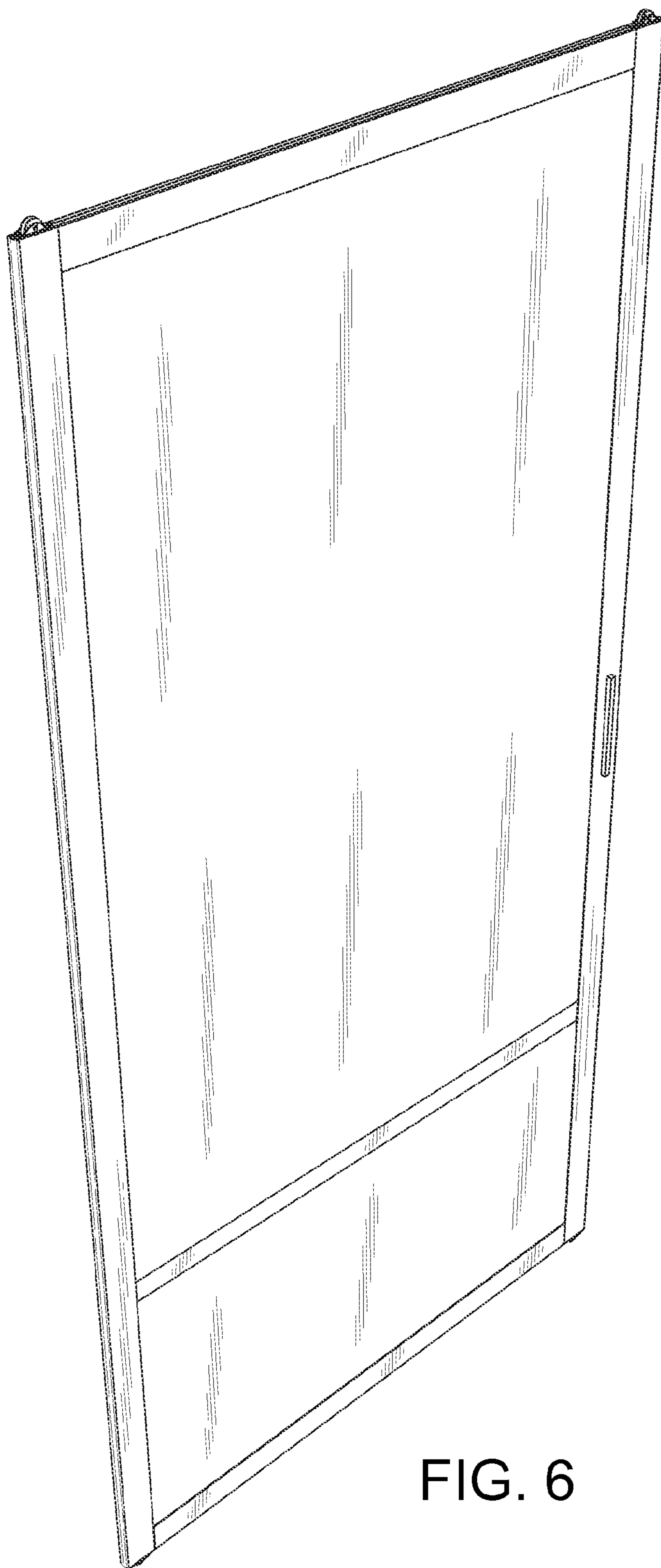

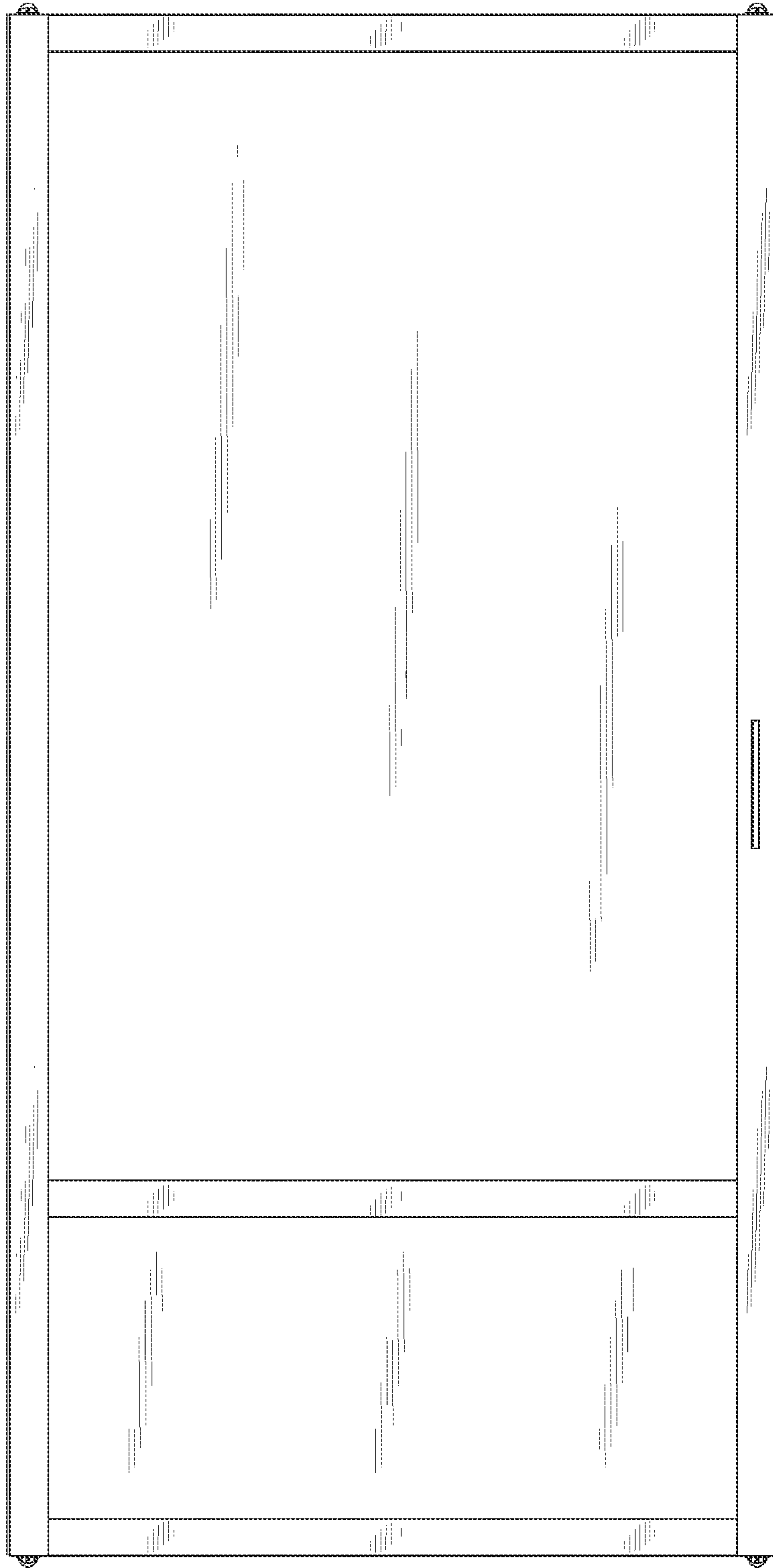

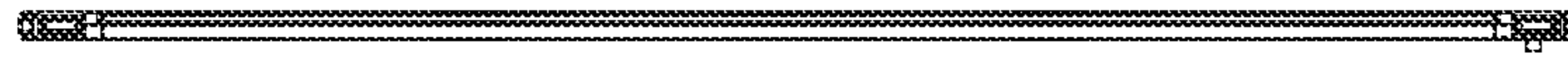

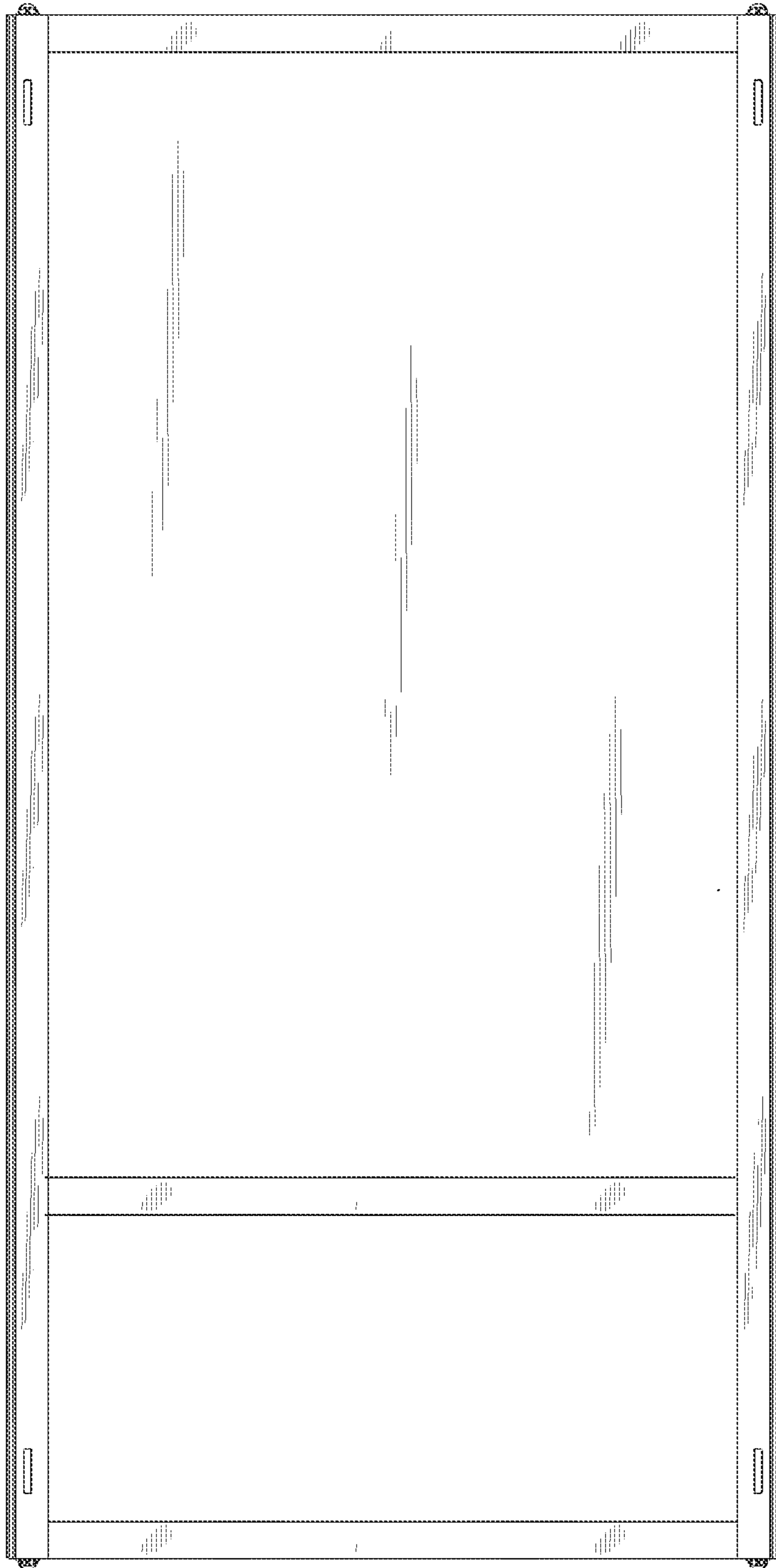

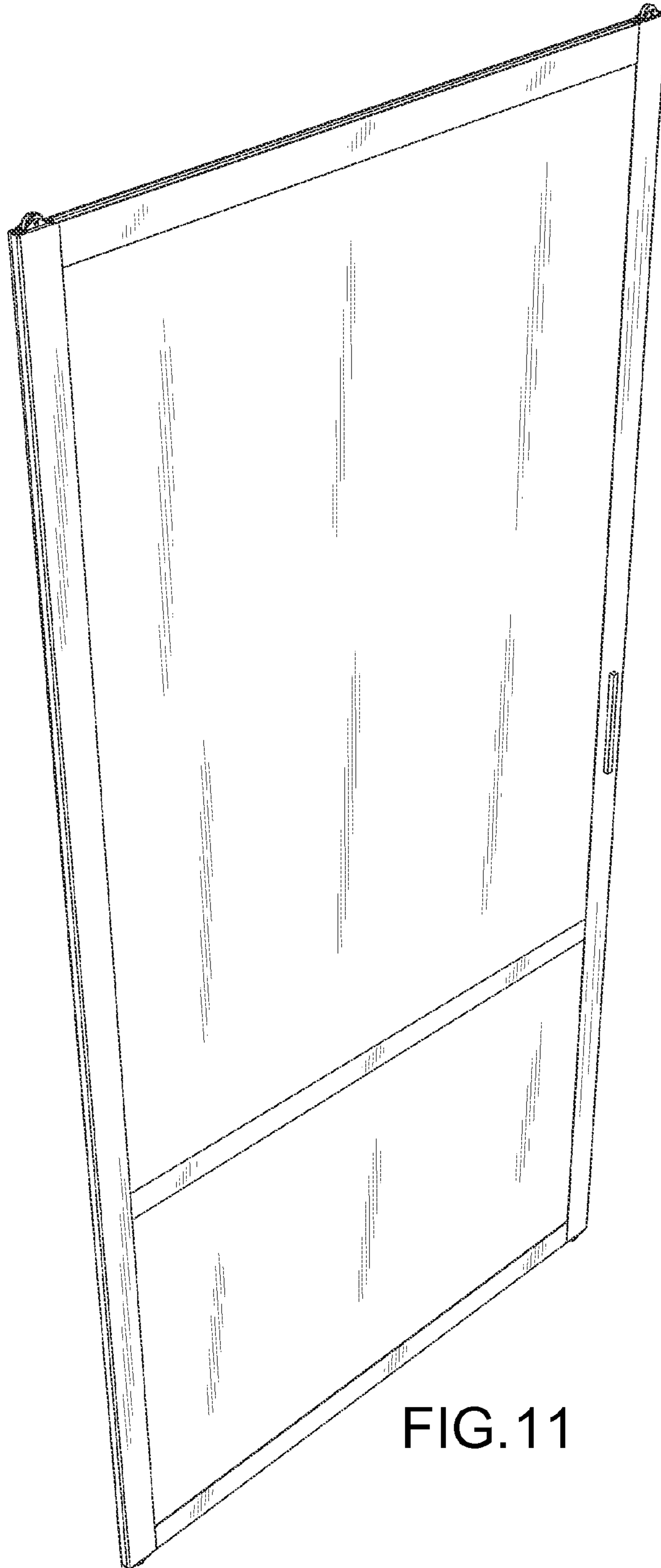

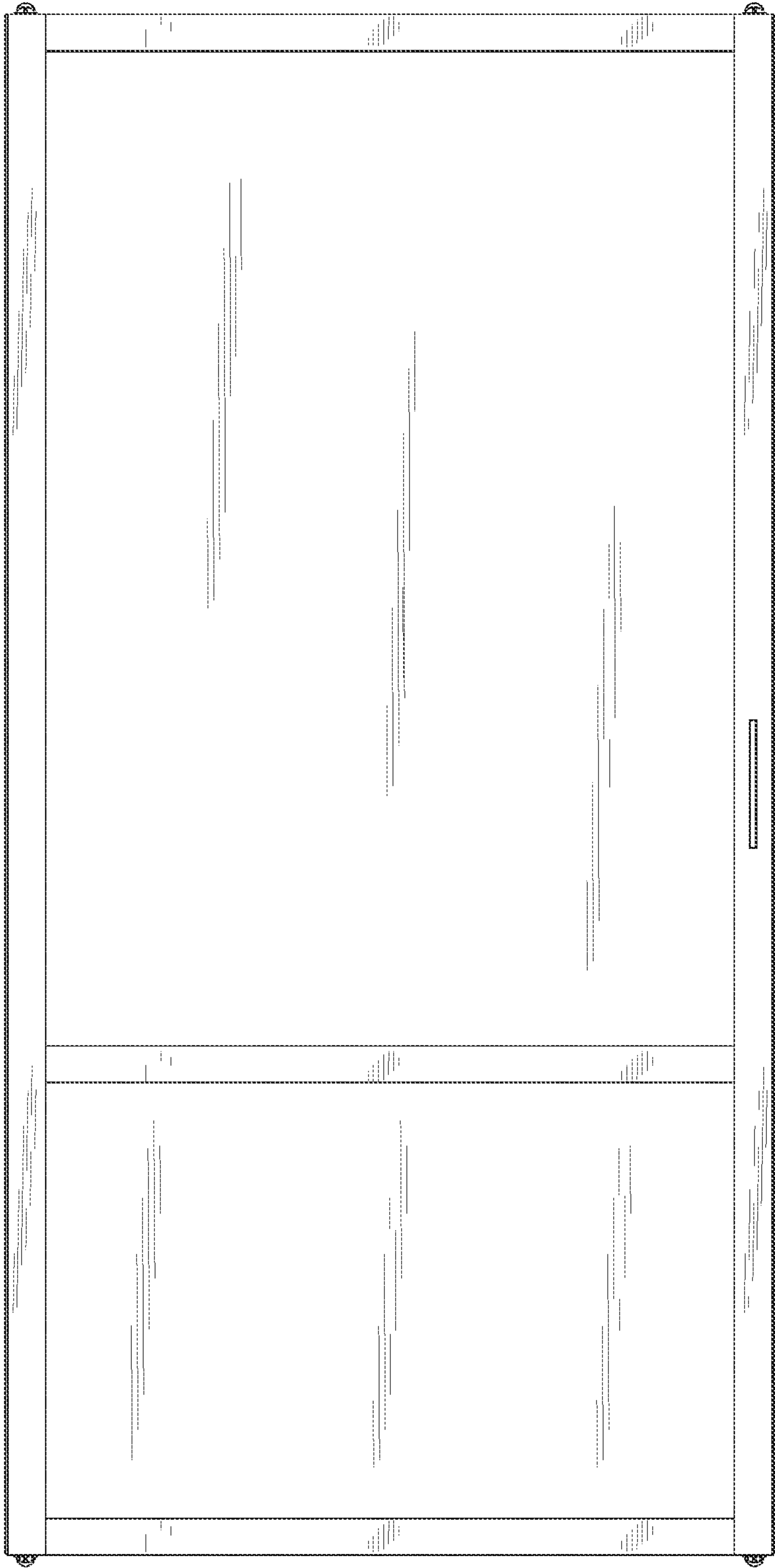

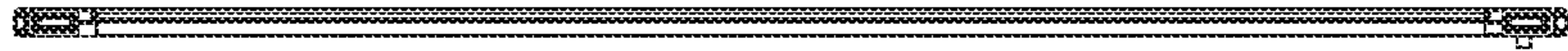

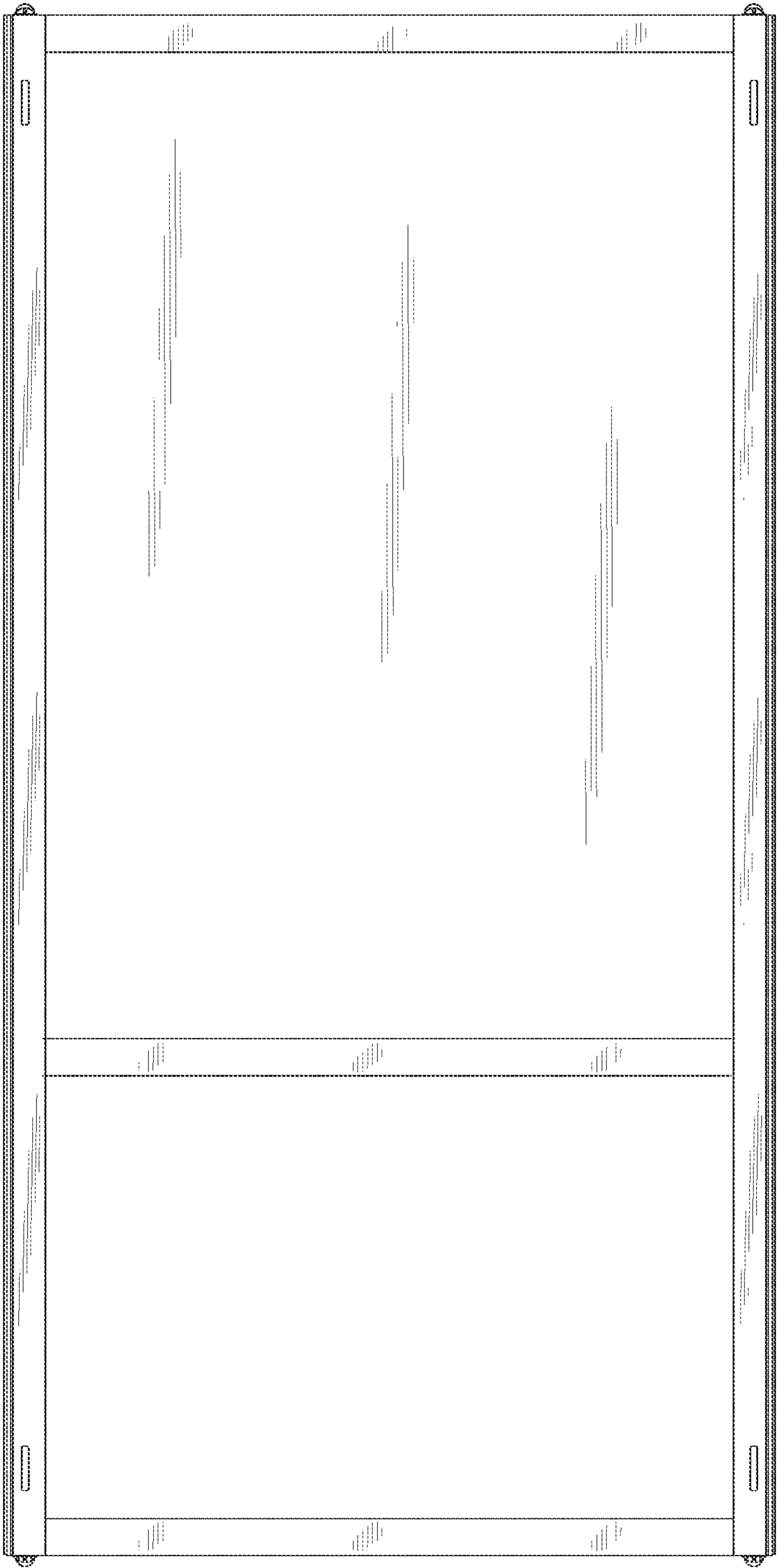

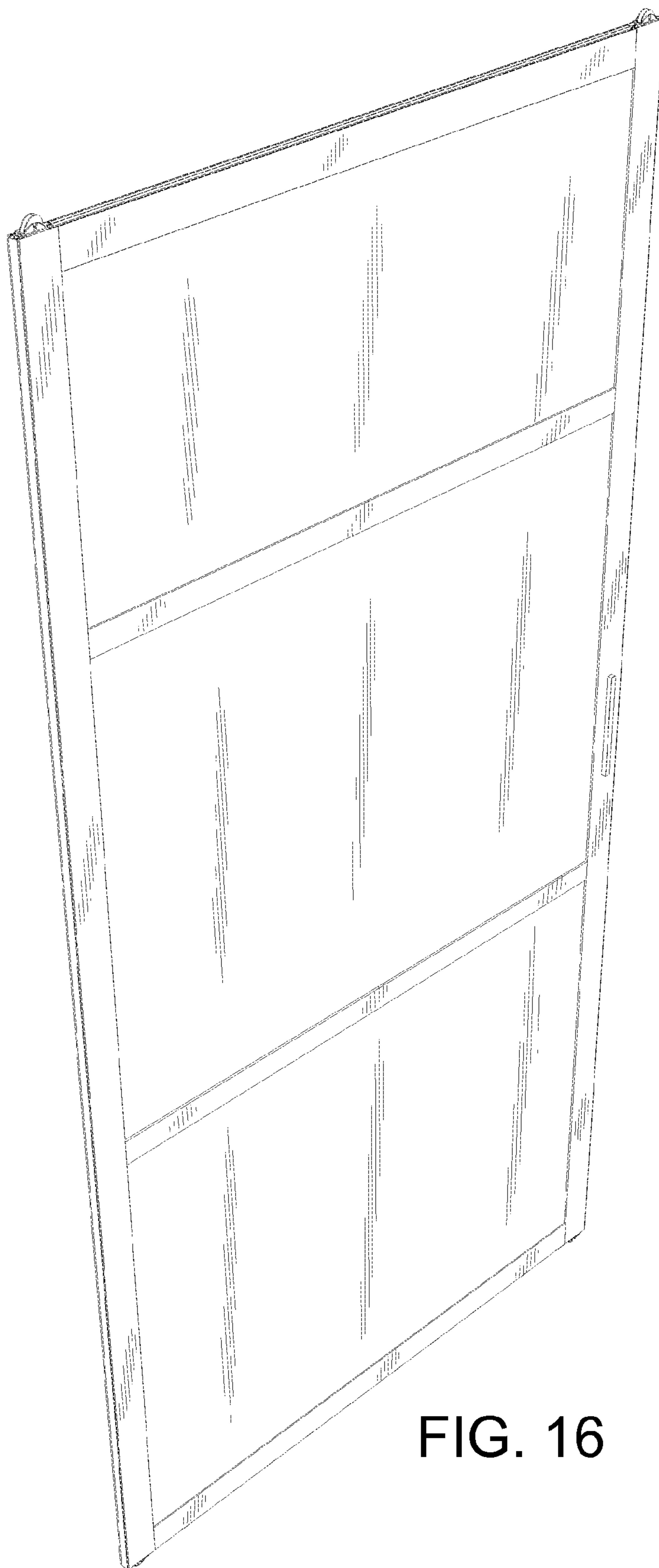

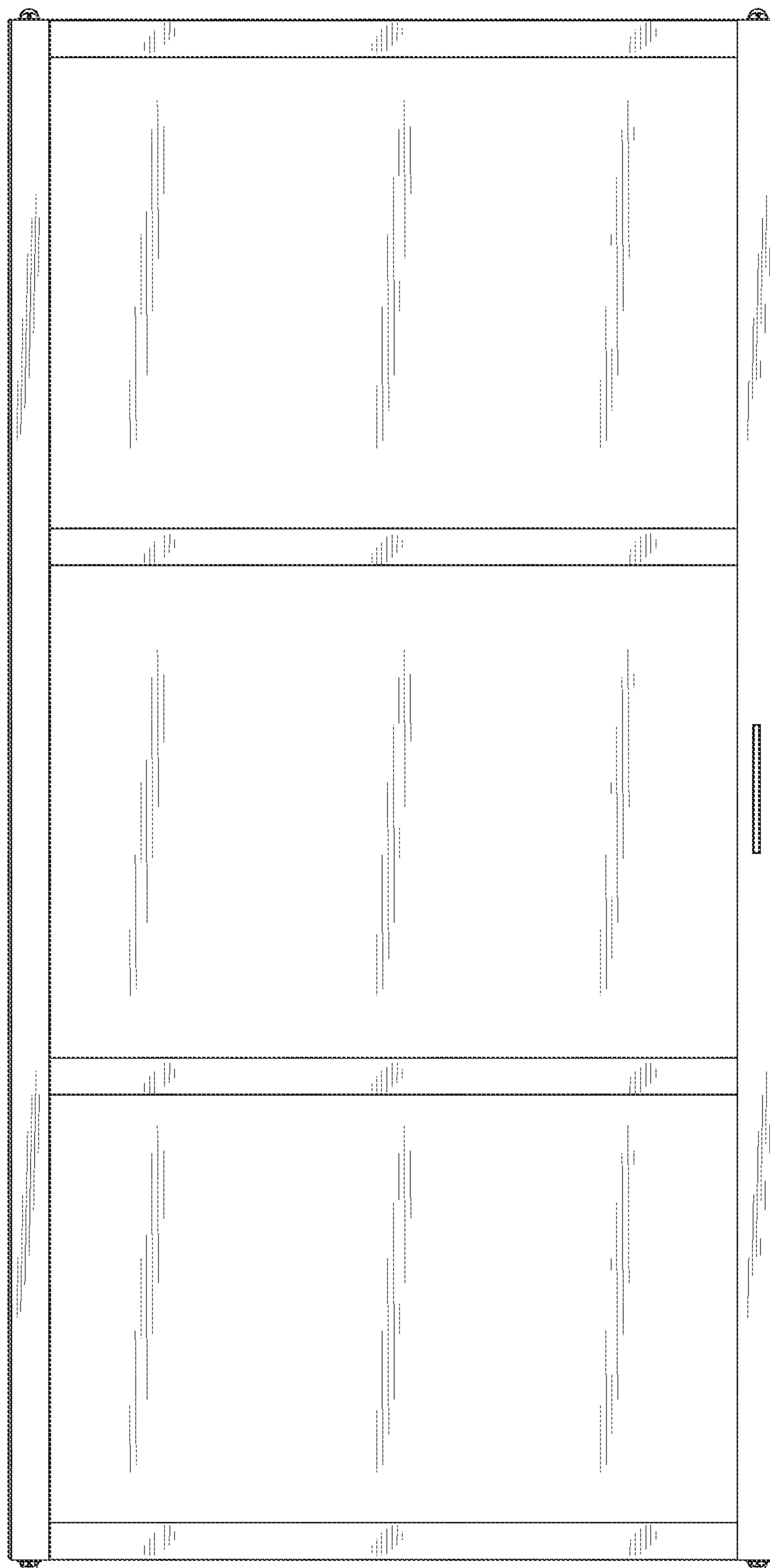

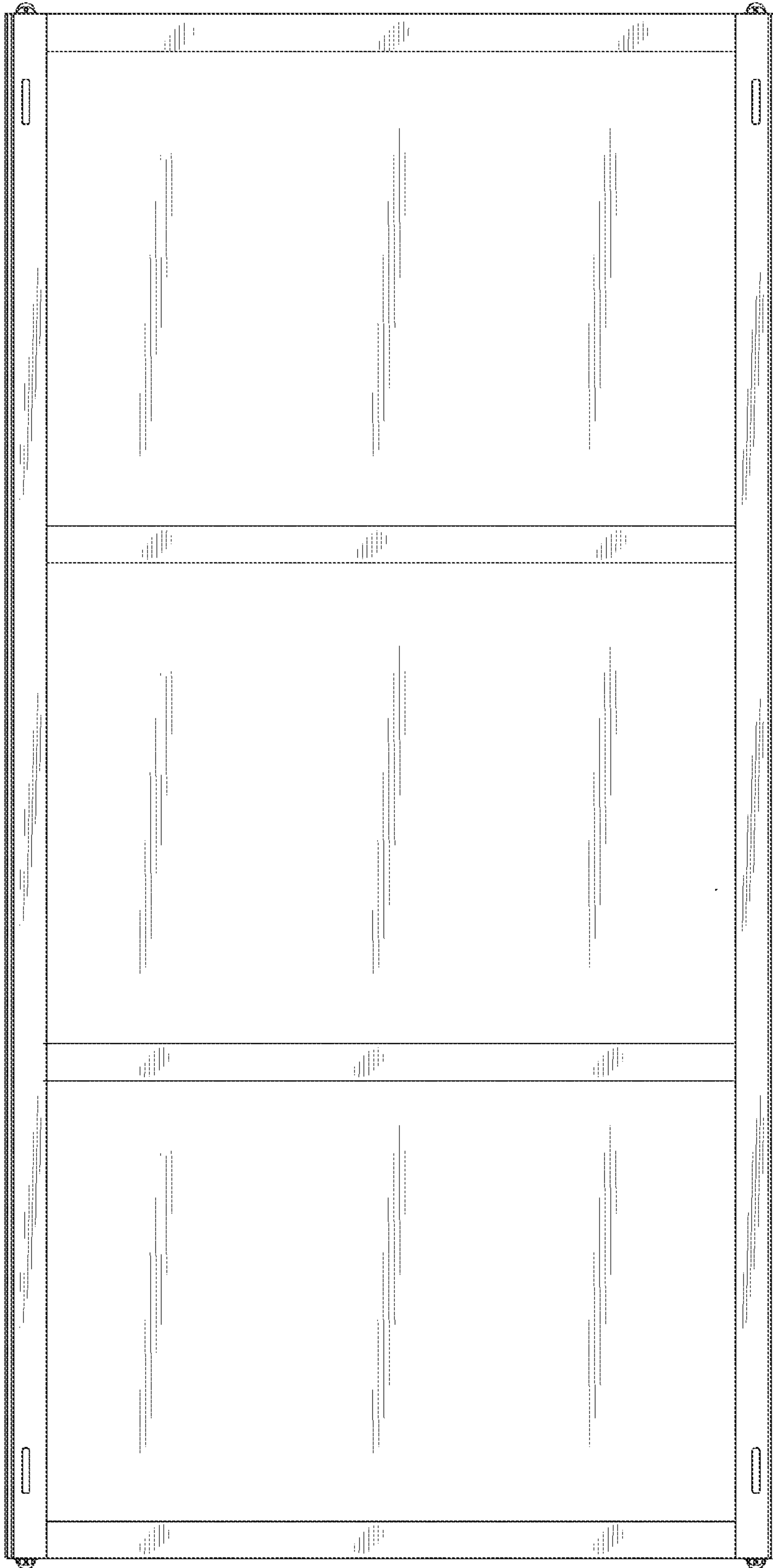
