(57) **CLAIM**

We claim the ornamental design for a ski mask with attachment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ski mask with attachment, showing our new design;

FIG. 2 is an exploded perspective view of FIG. 1;

FIG. 3 is a front elevational view of FIG. 1;

FIG. 4 is a rear elevational view of FIG. 1;

FIG. 5 is a right side elevational view of FIG. 1;

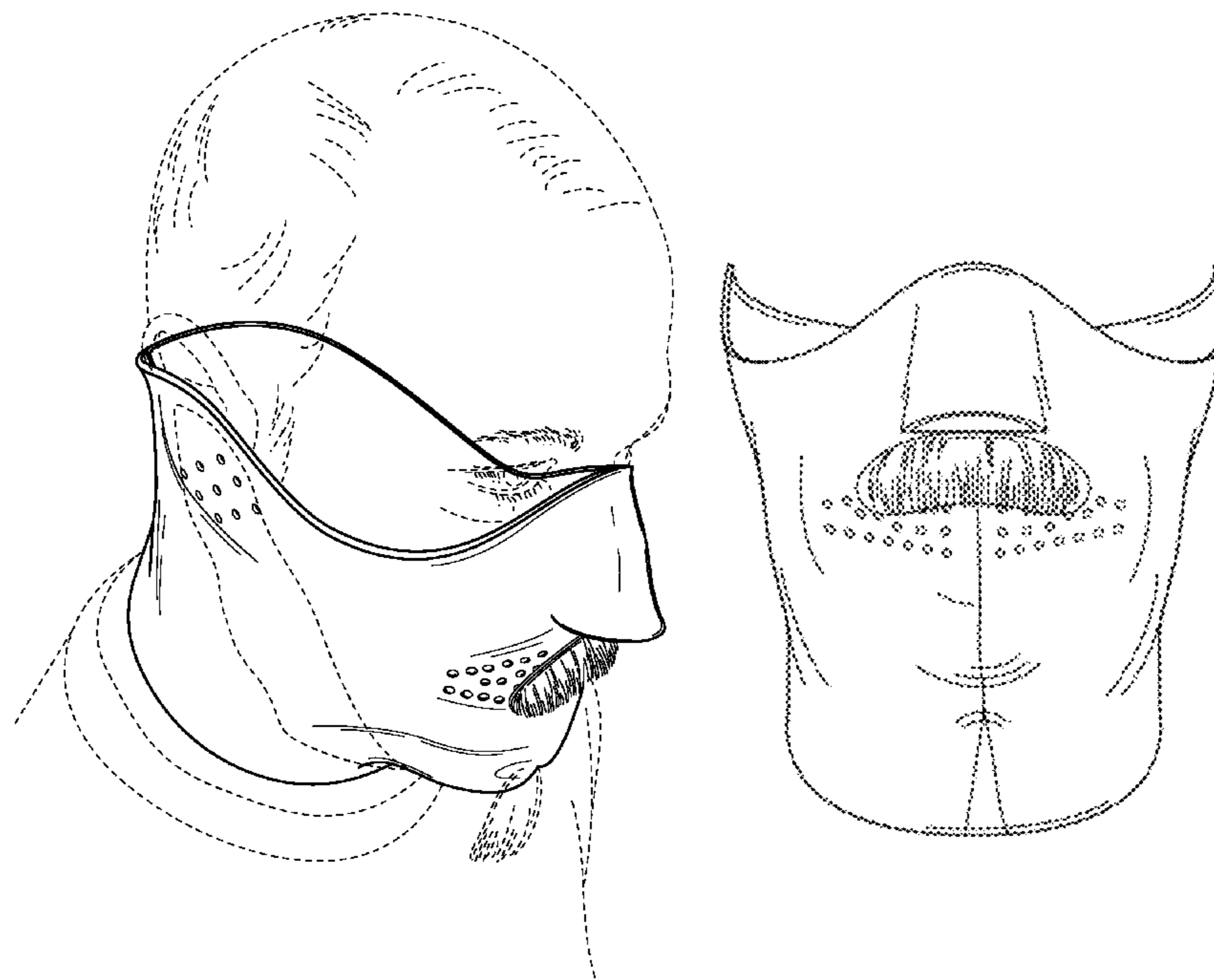
FIG. 6 is a left side elevational view of FIG. 1;

FIG. 7 is a top plan view of FIG. 1; and,

FIG. 8 is a bottom plan view of FIG. 1.

The broken lines shown on the ski mask with attachment represent thread stitching. The broken lines illustrating a person and additional attachments in FIG. 1 form no part of the claimed design.

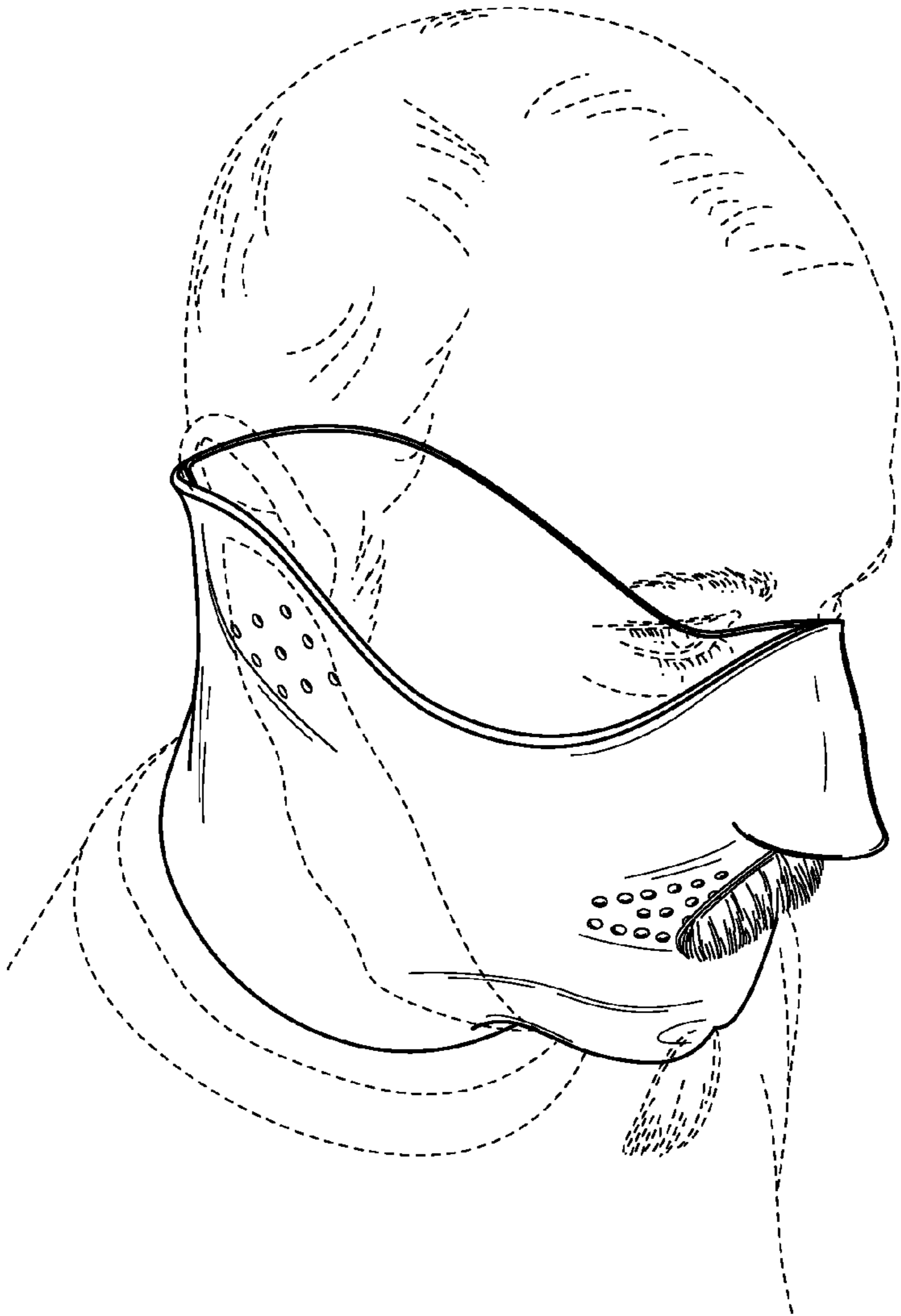

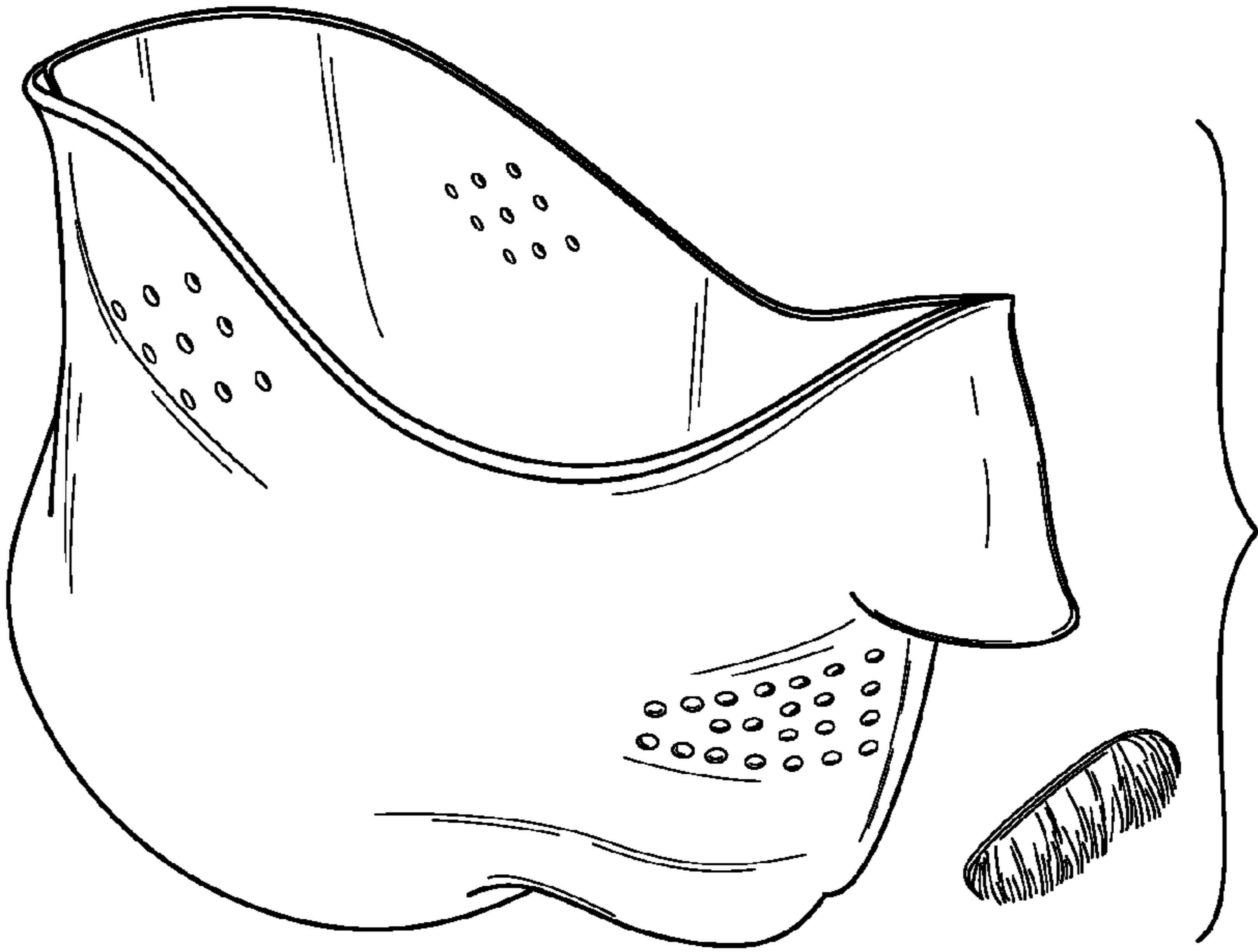

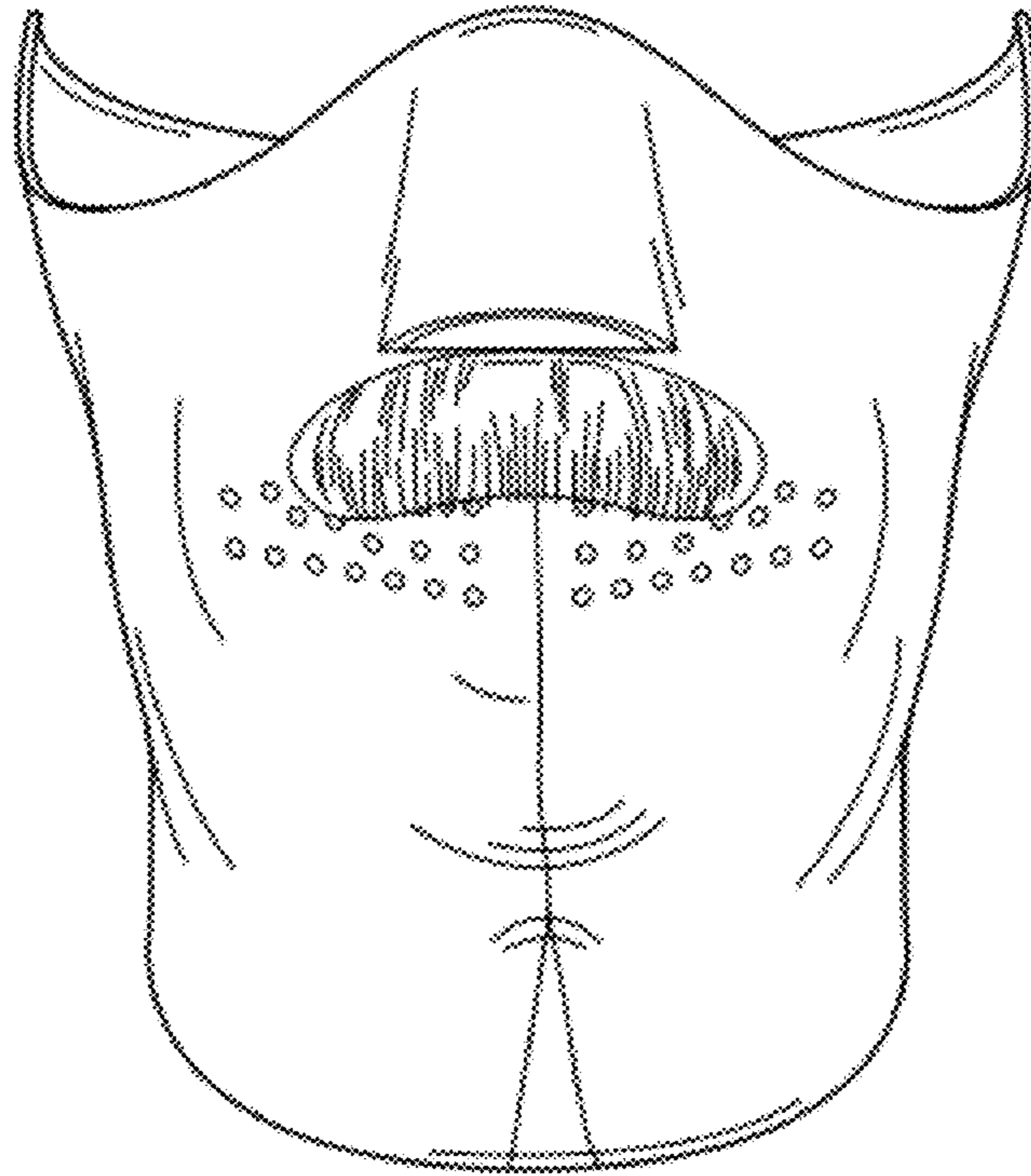

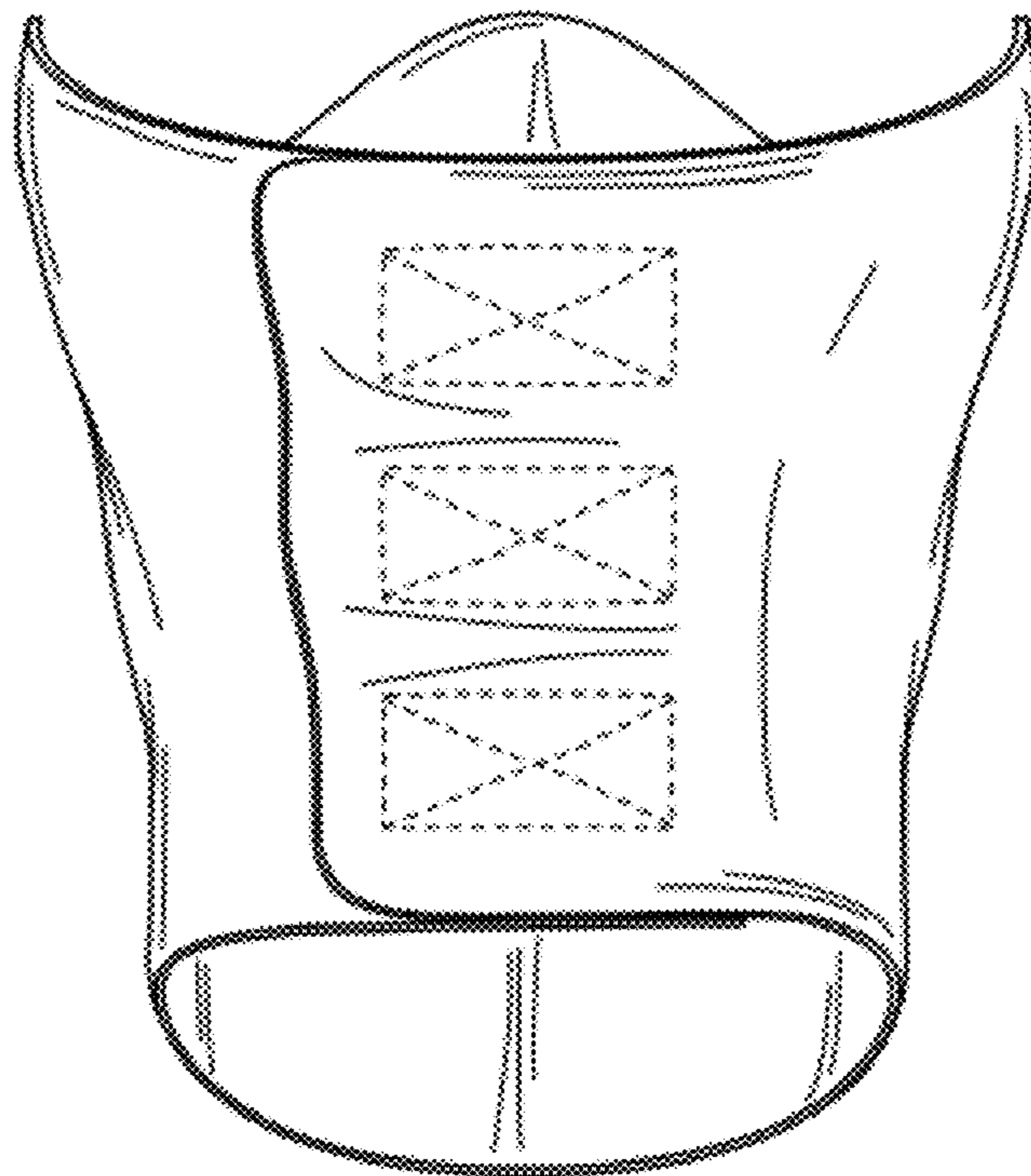

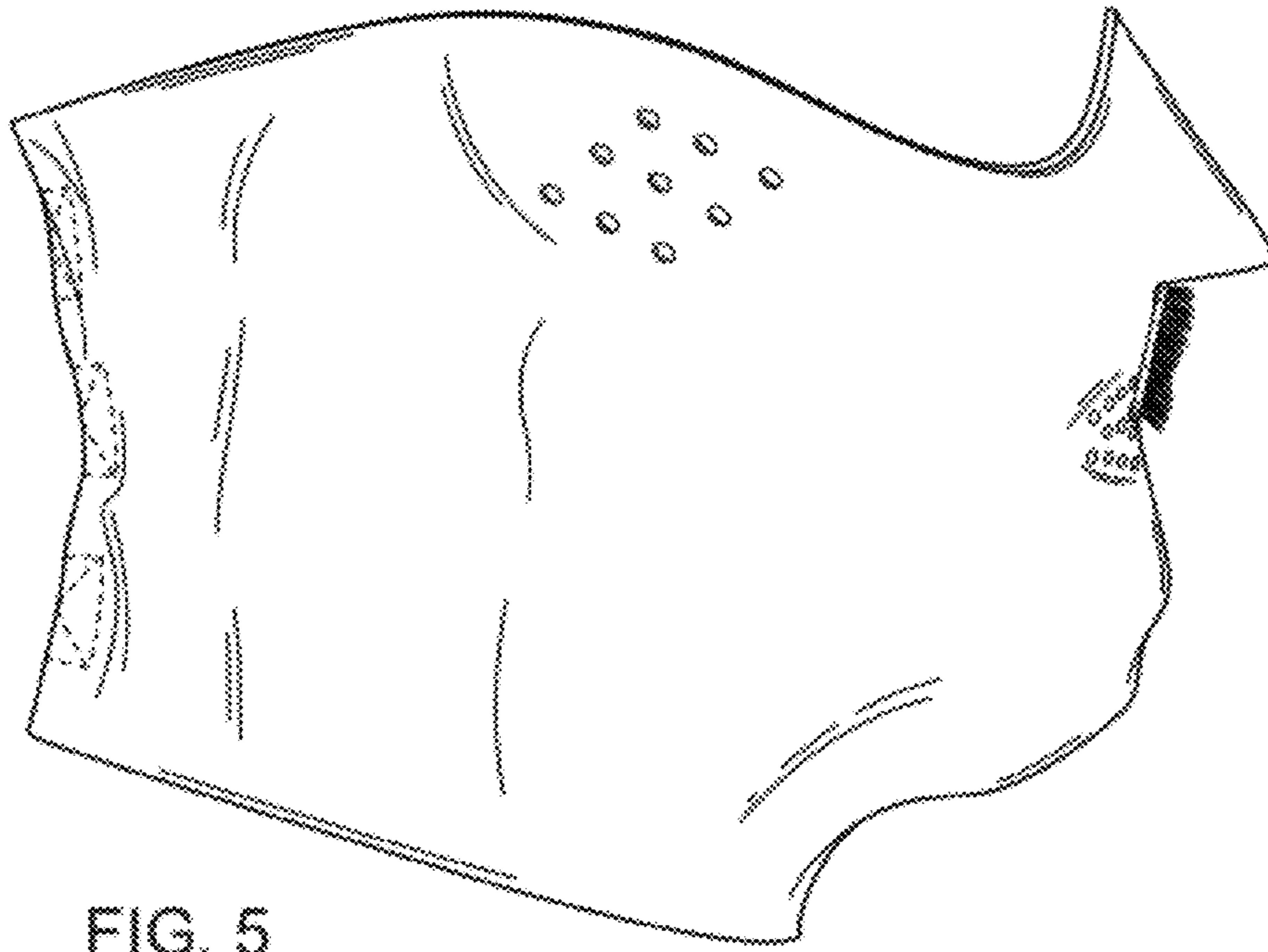

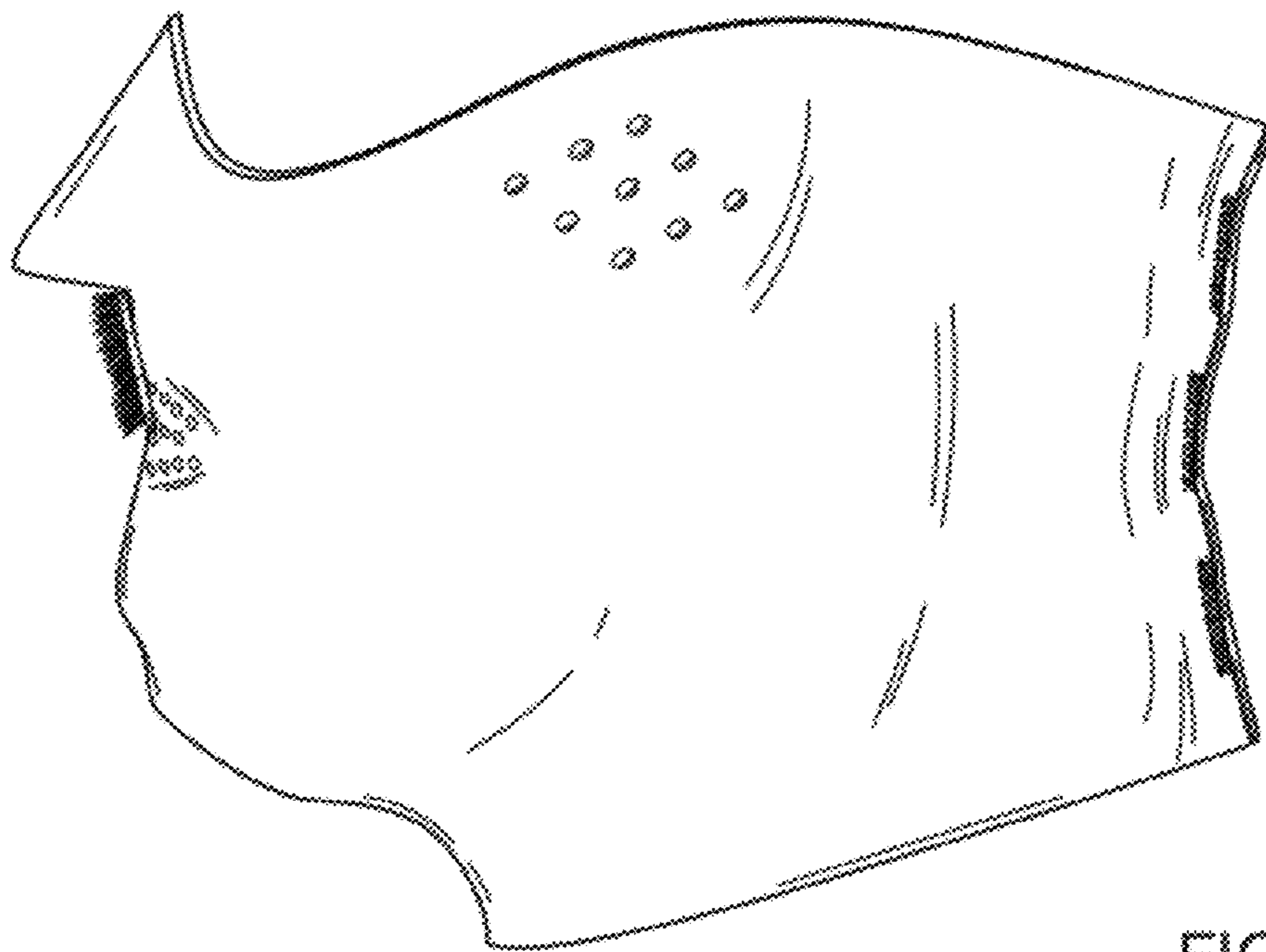

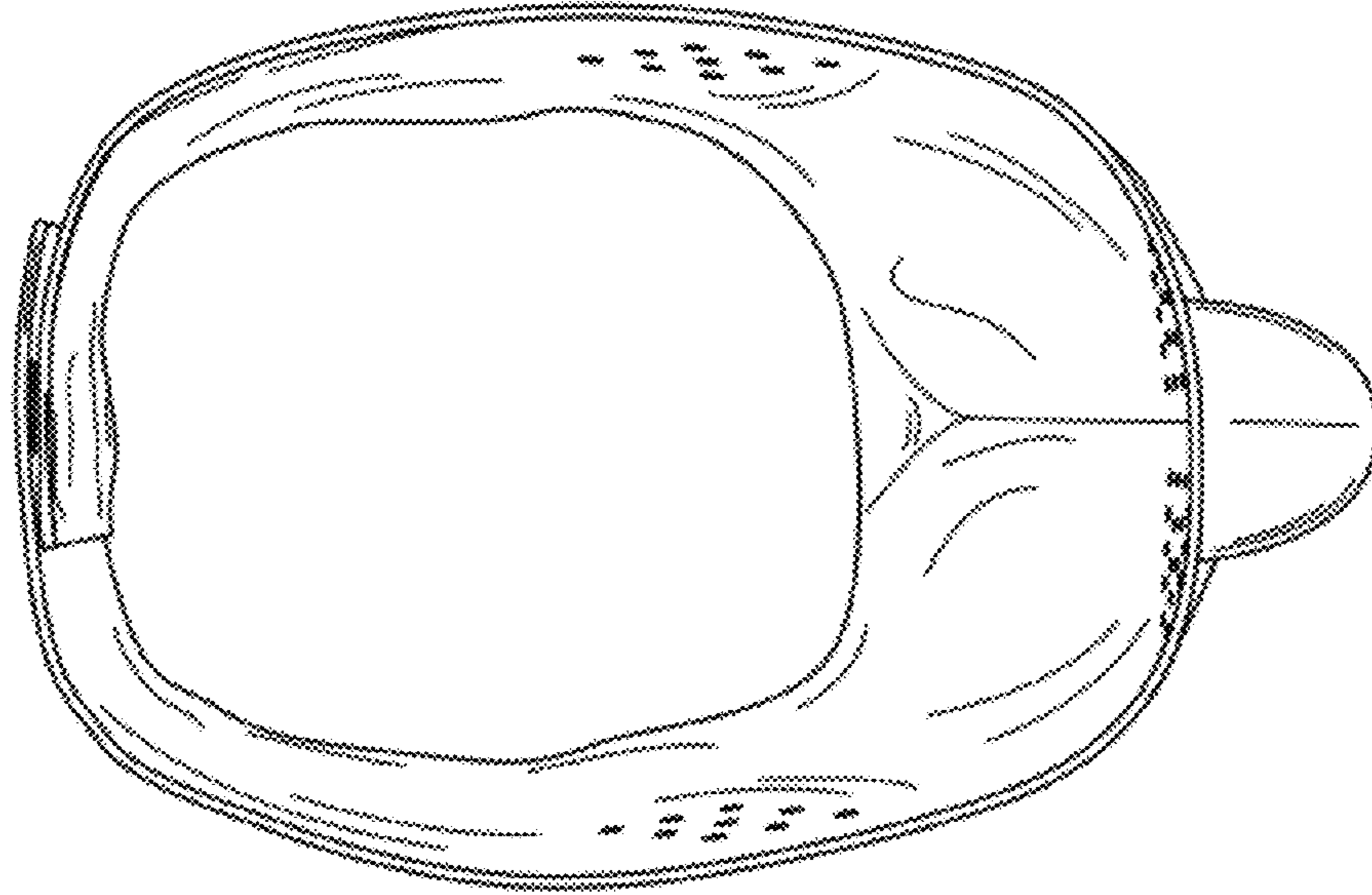

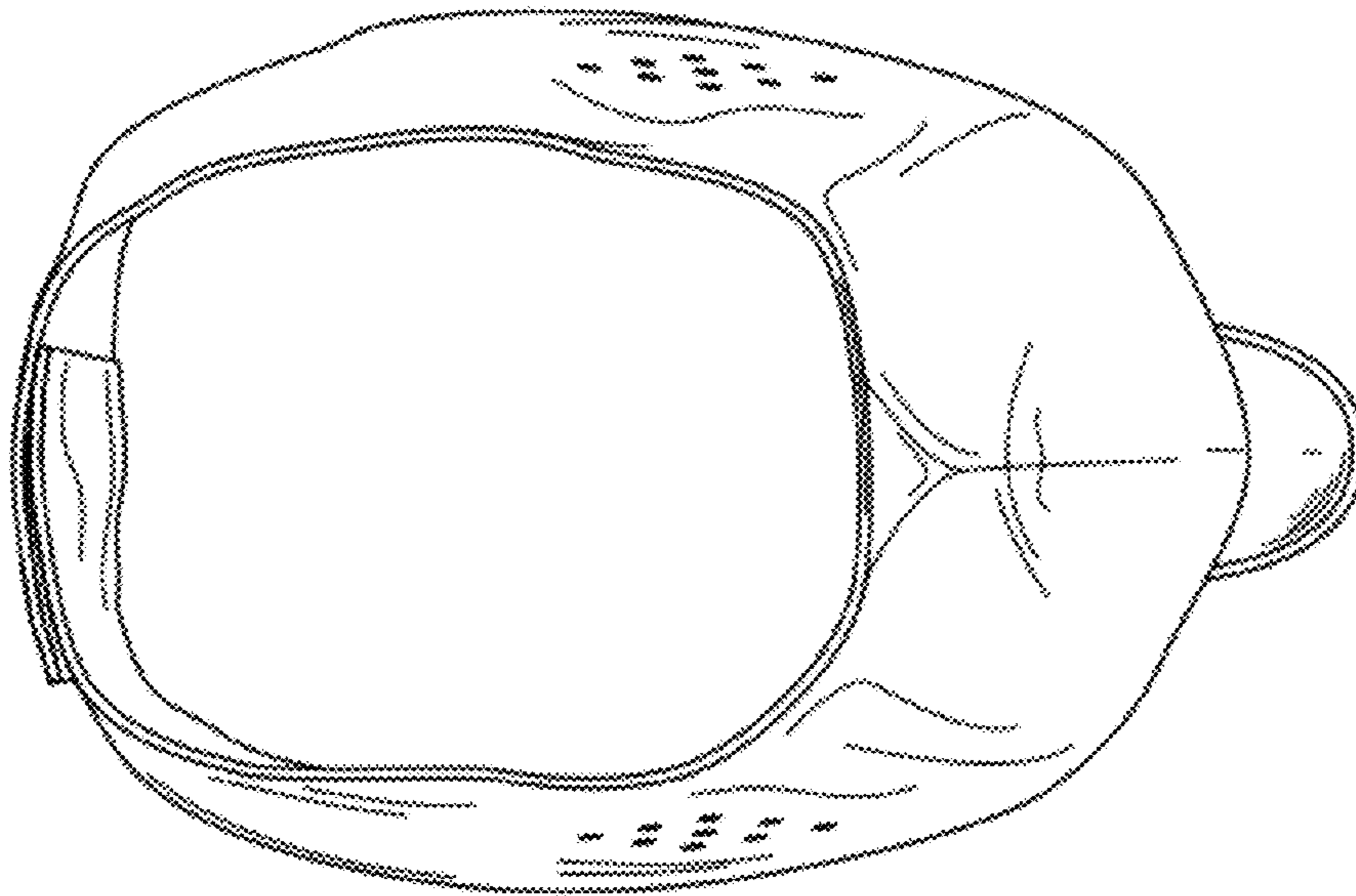
