We claim the ornamental design for a pet bowl, as shown and described.

DESCRIPTION

FIG. 7 is a bottom plan view of the pet bowl of FIG. 1; and,

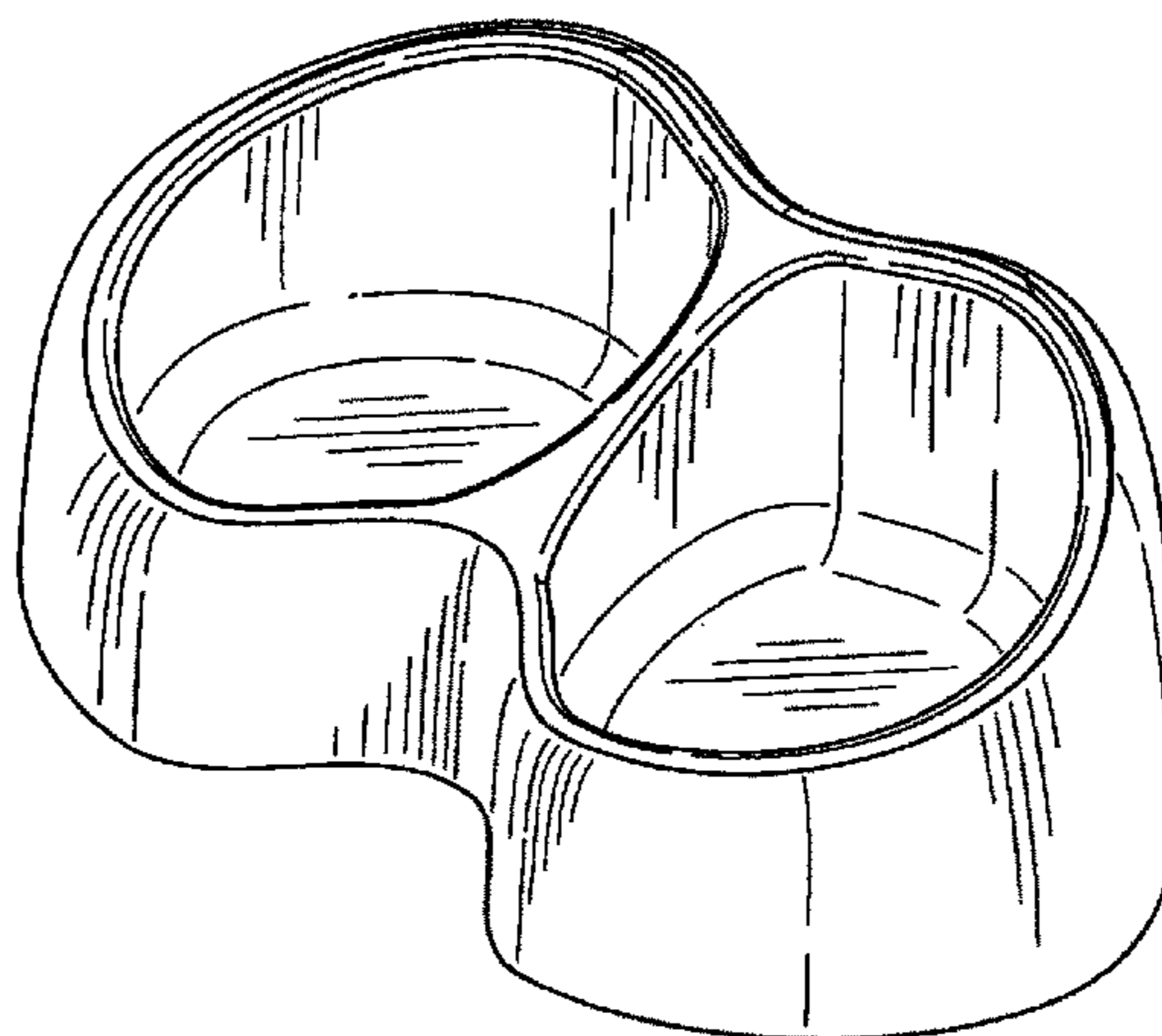
FIG. 8 is a bottom perspective view of the pet bowl of FIG. 1.

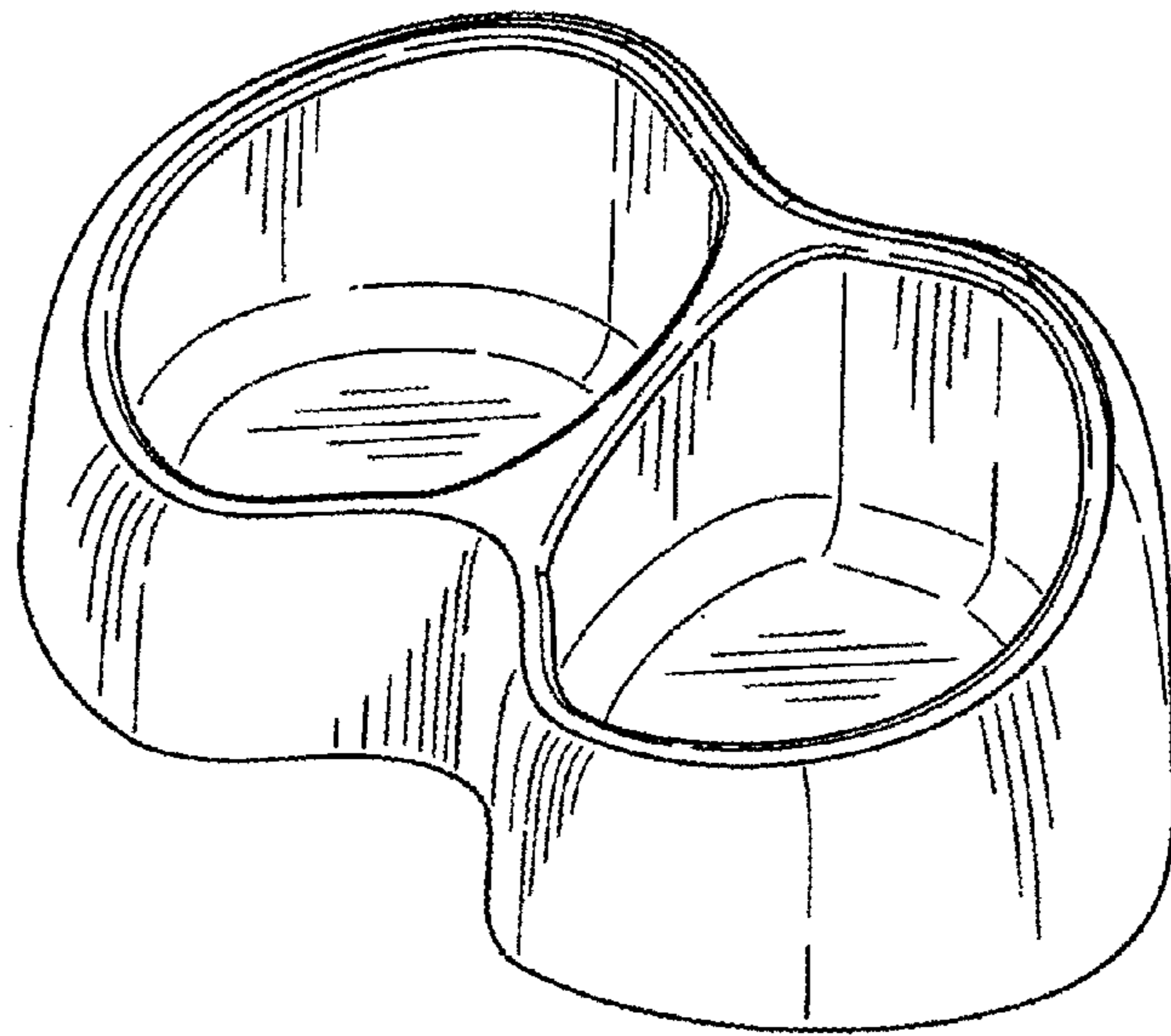

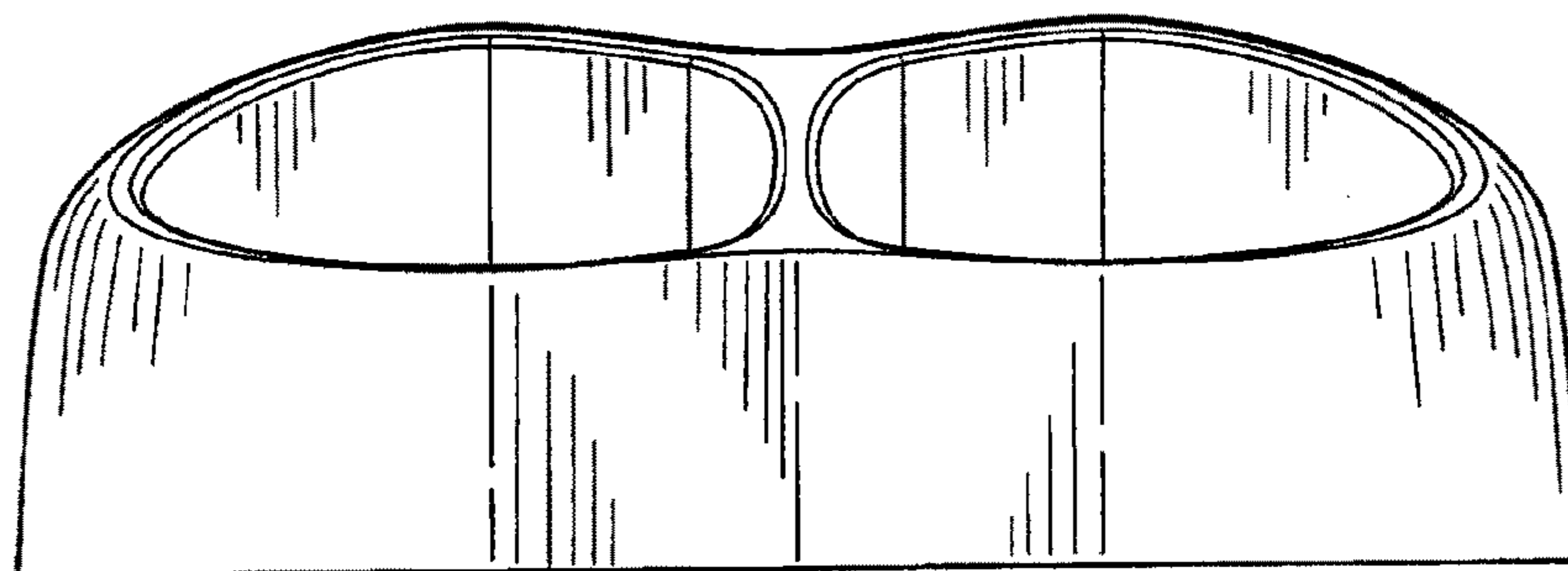

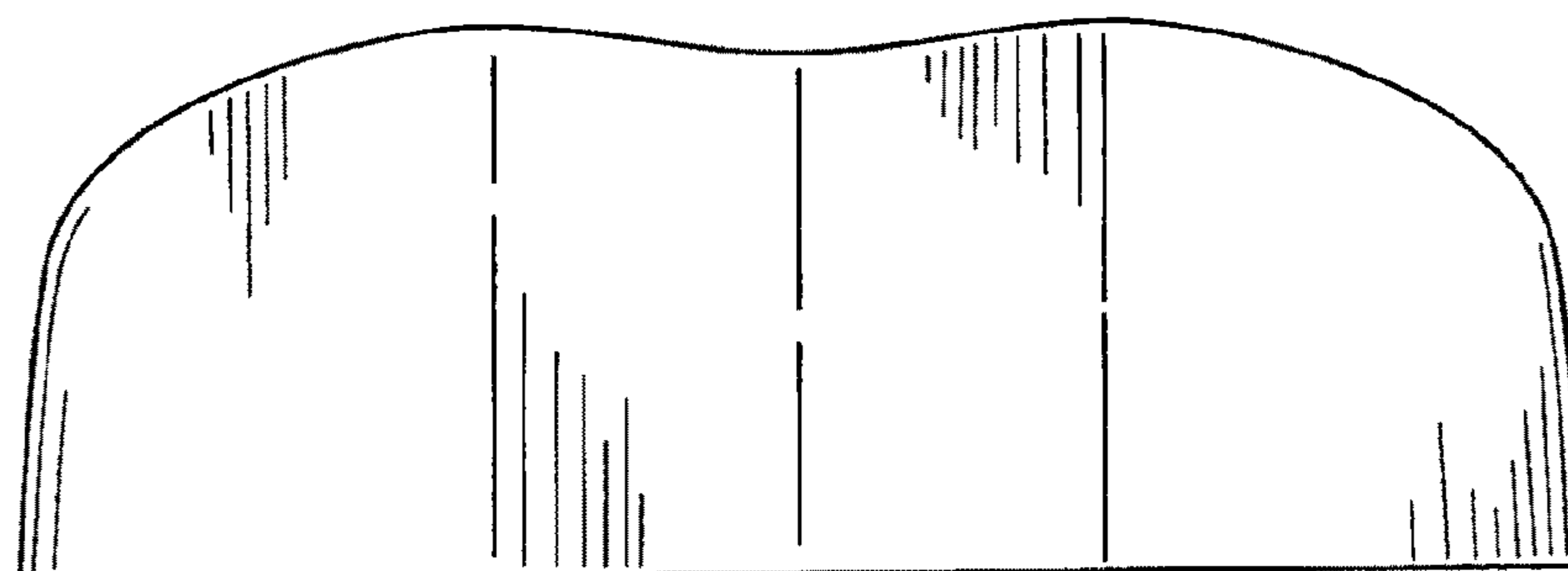

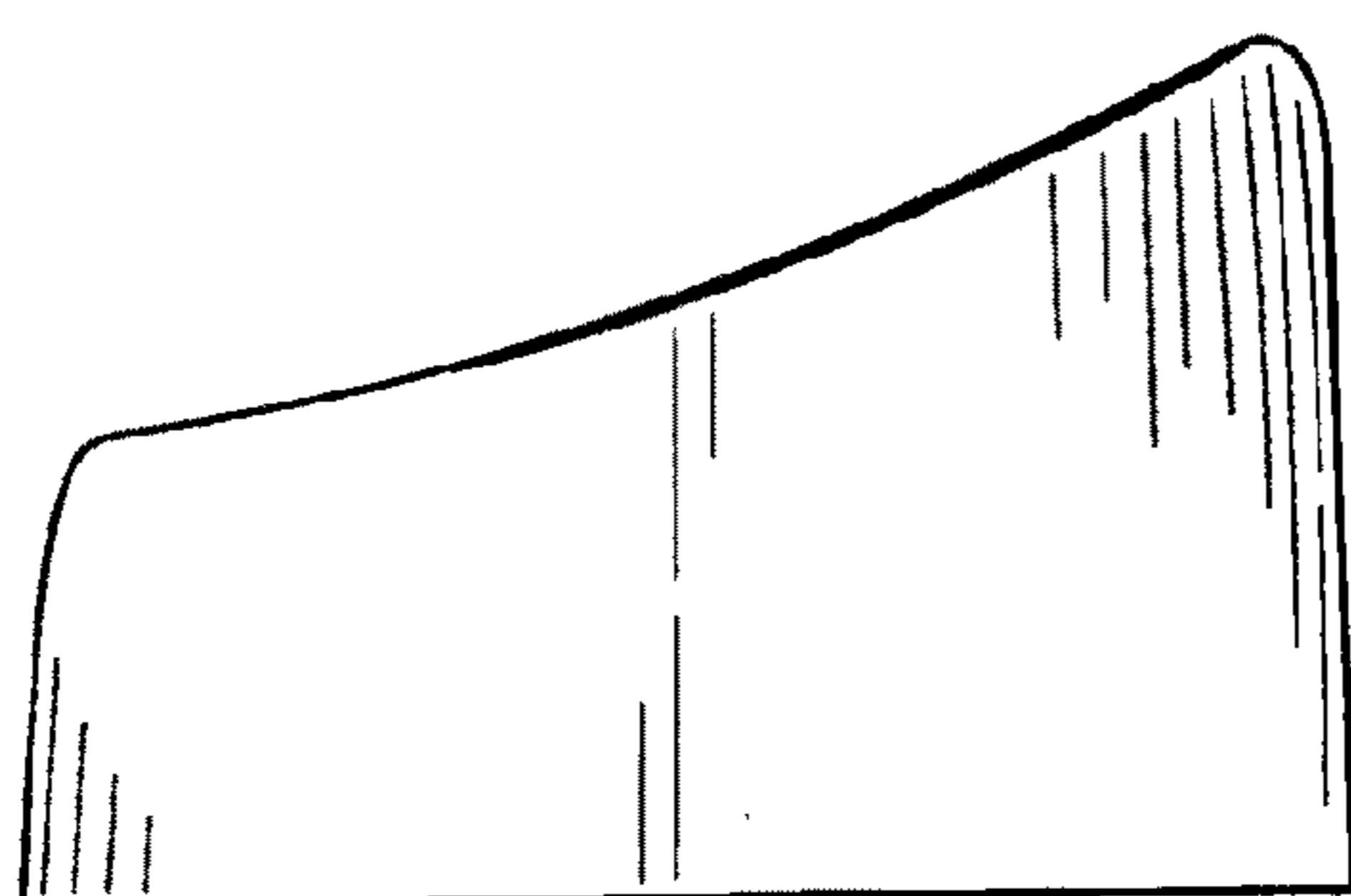

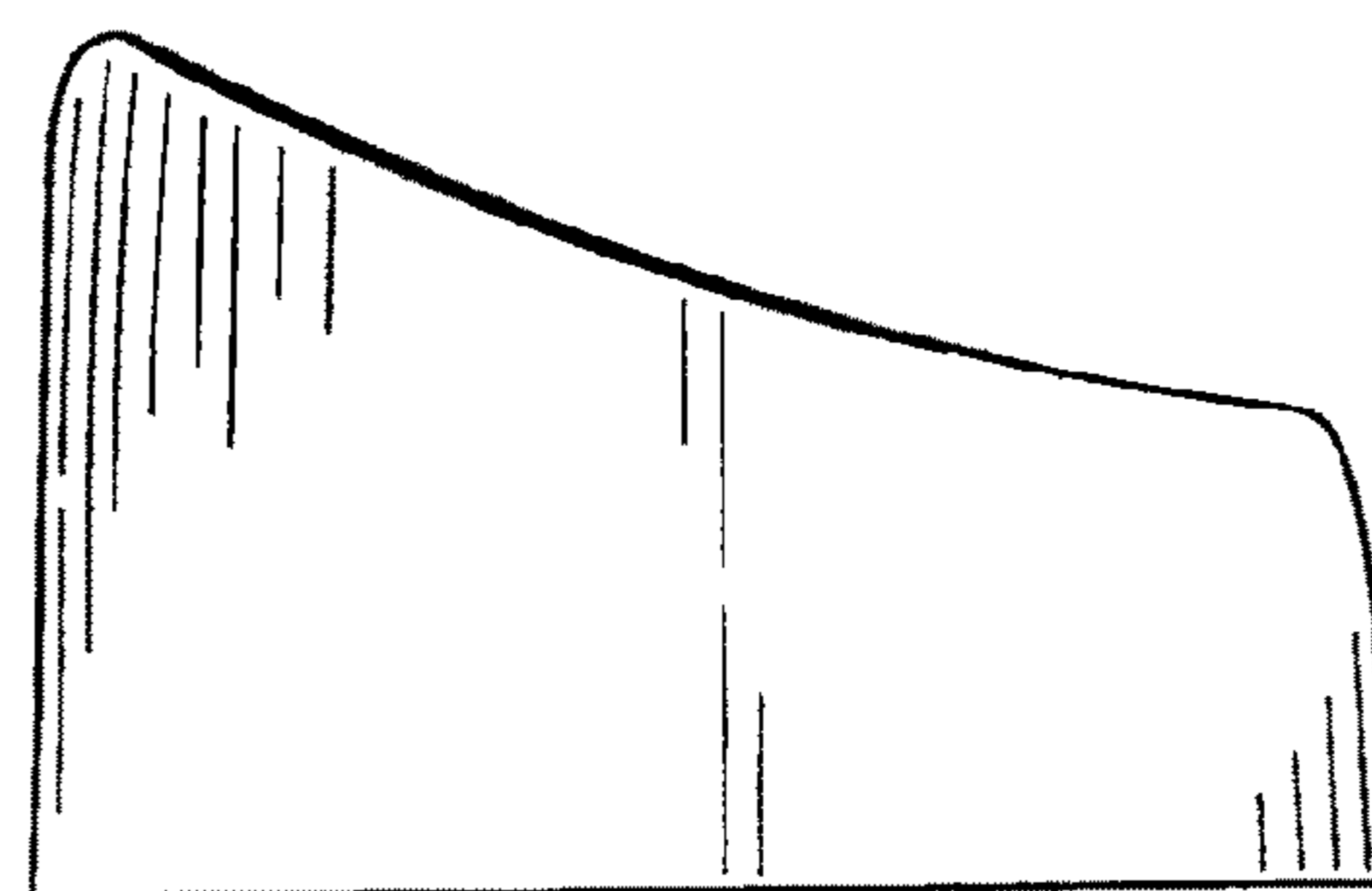

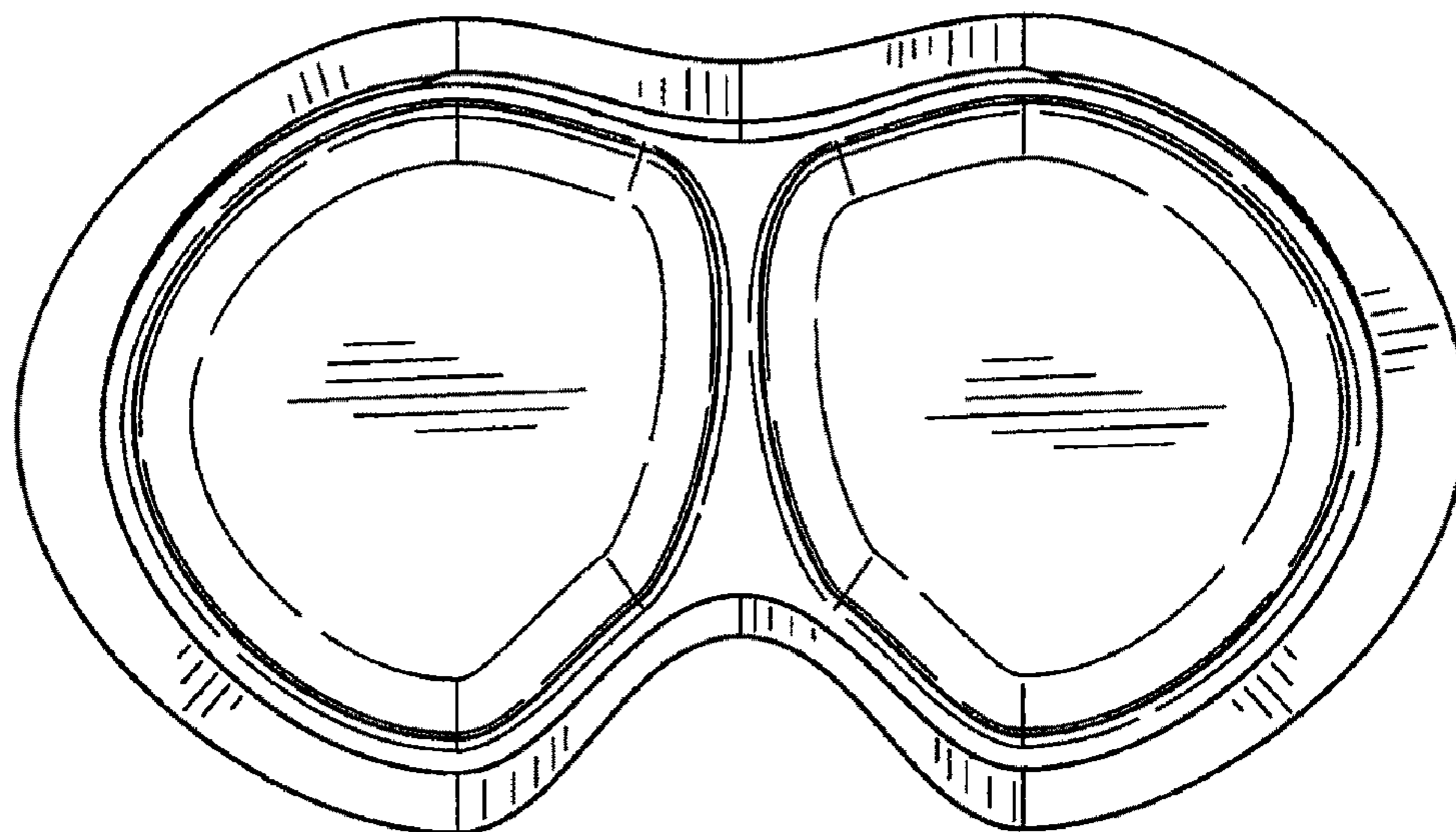

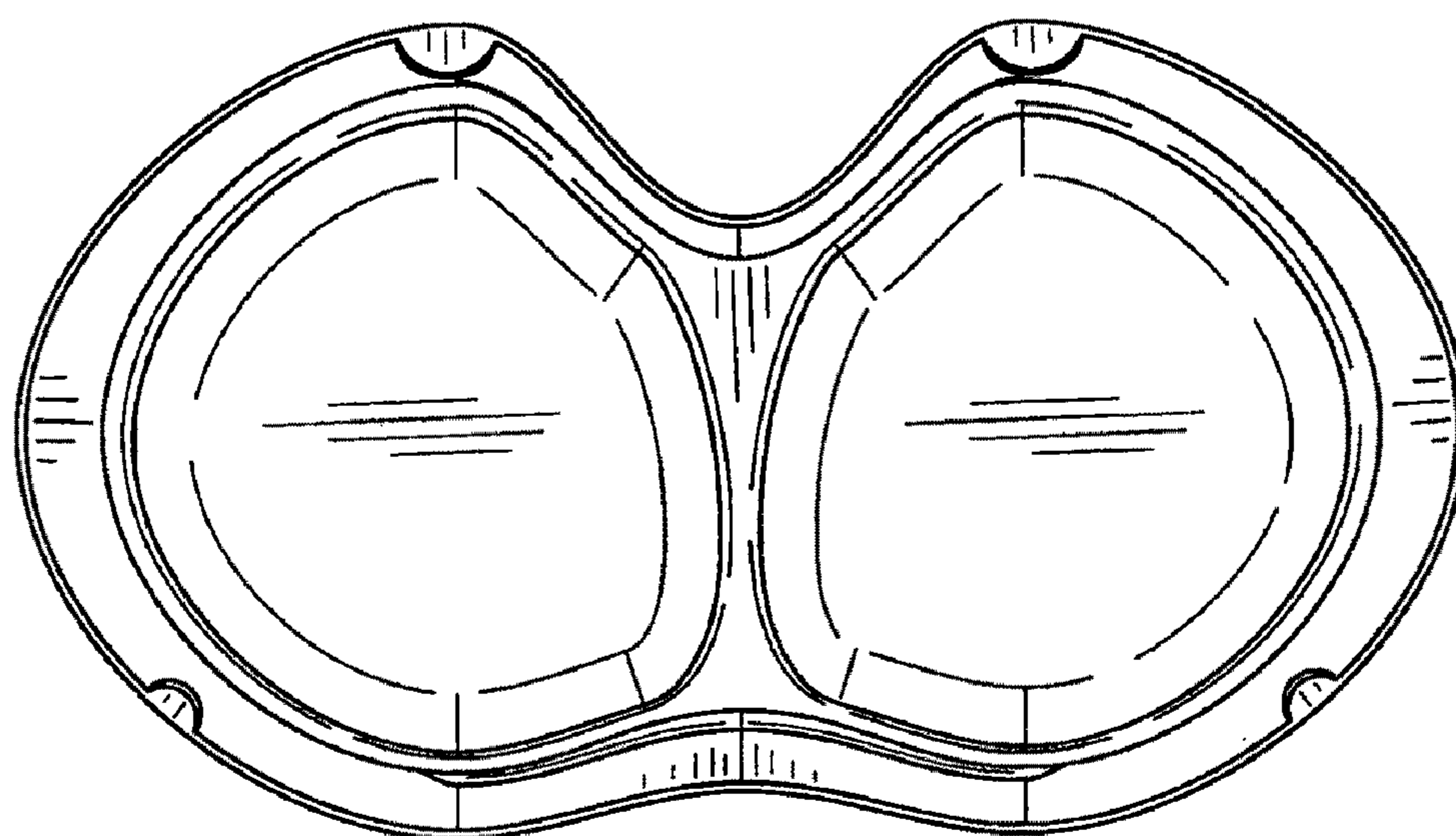

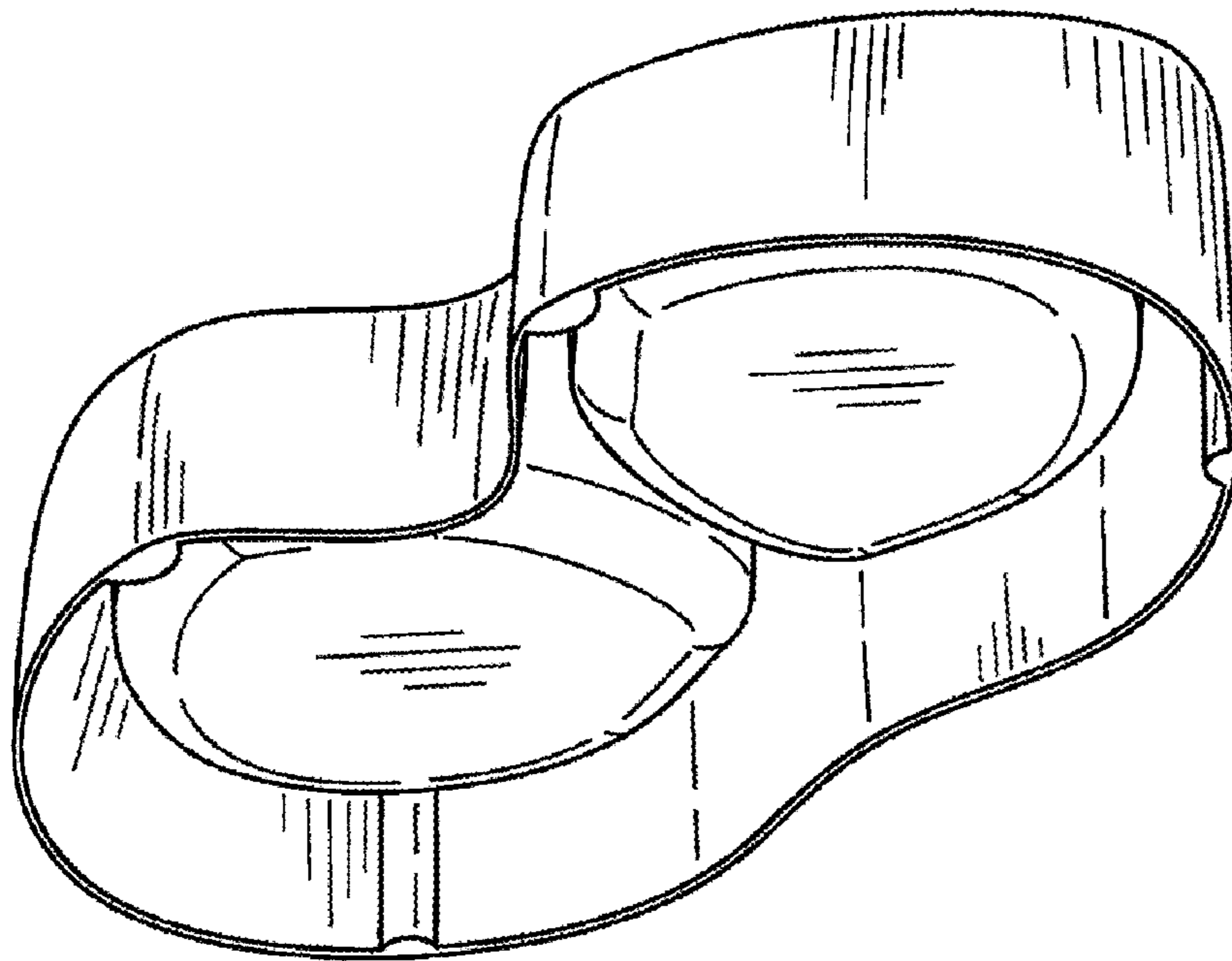
