(57) **CLAIM**

The ornamental design for a shopping cart handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a plan view of the shopping cart handle, showing our new design;  
FIG. 2 is a right side elevation view thereof, the left side being a mirror image thereof; and,  
FIG. 3 is a right, front, top perspective view thereof.  
The bottom and rear of the handle are not part of the claimed design.

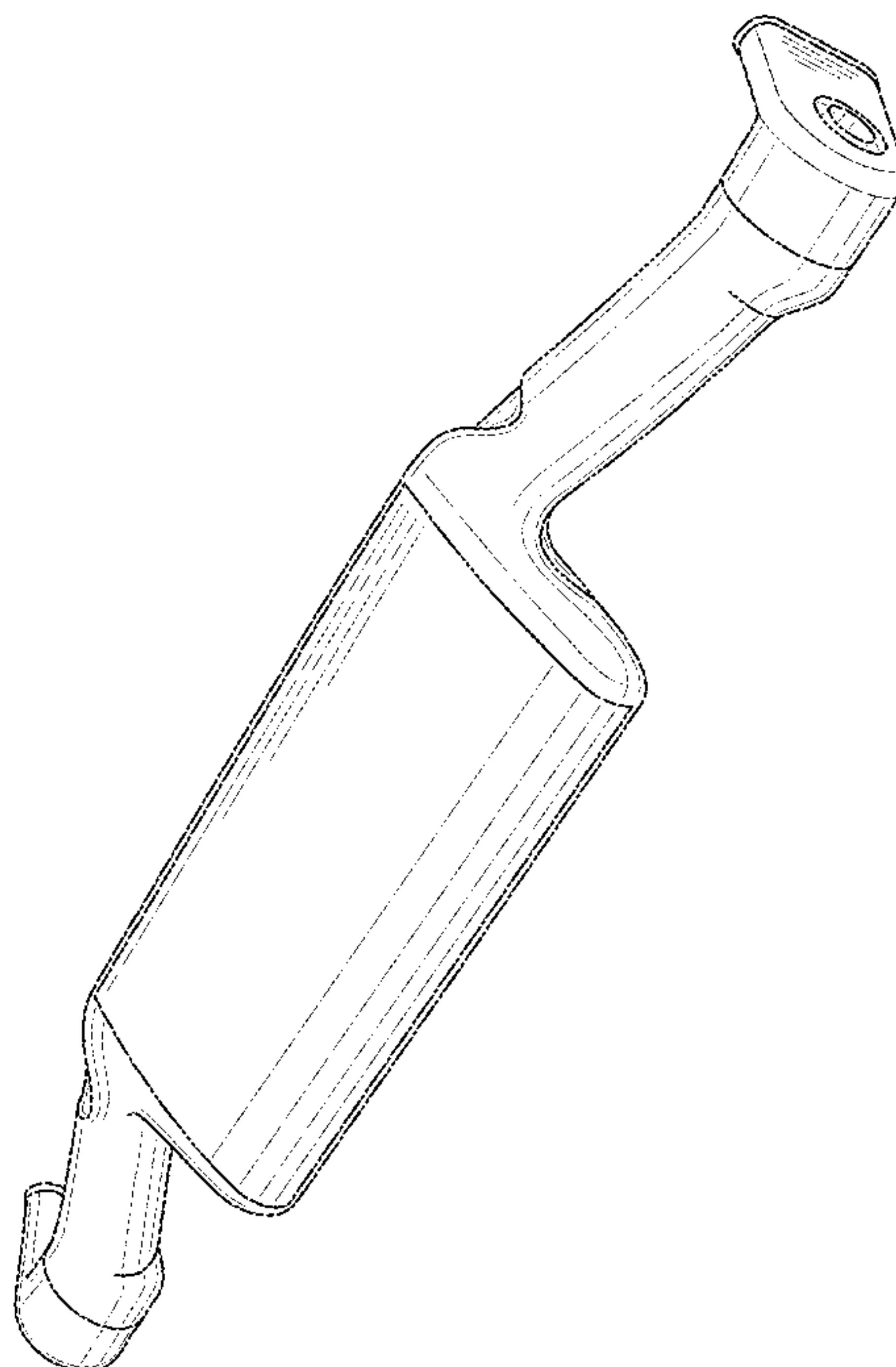

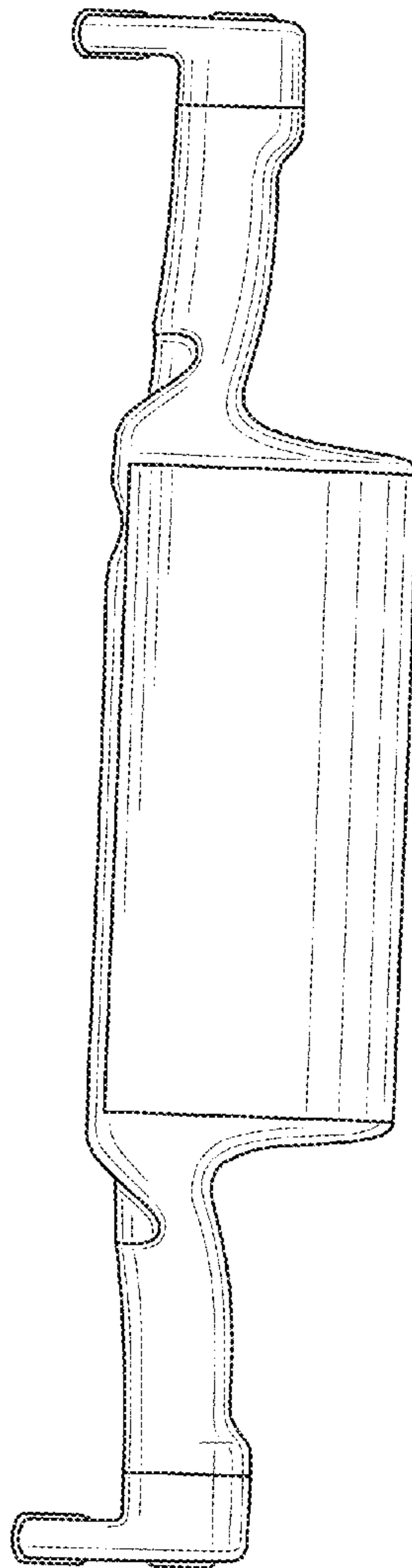

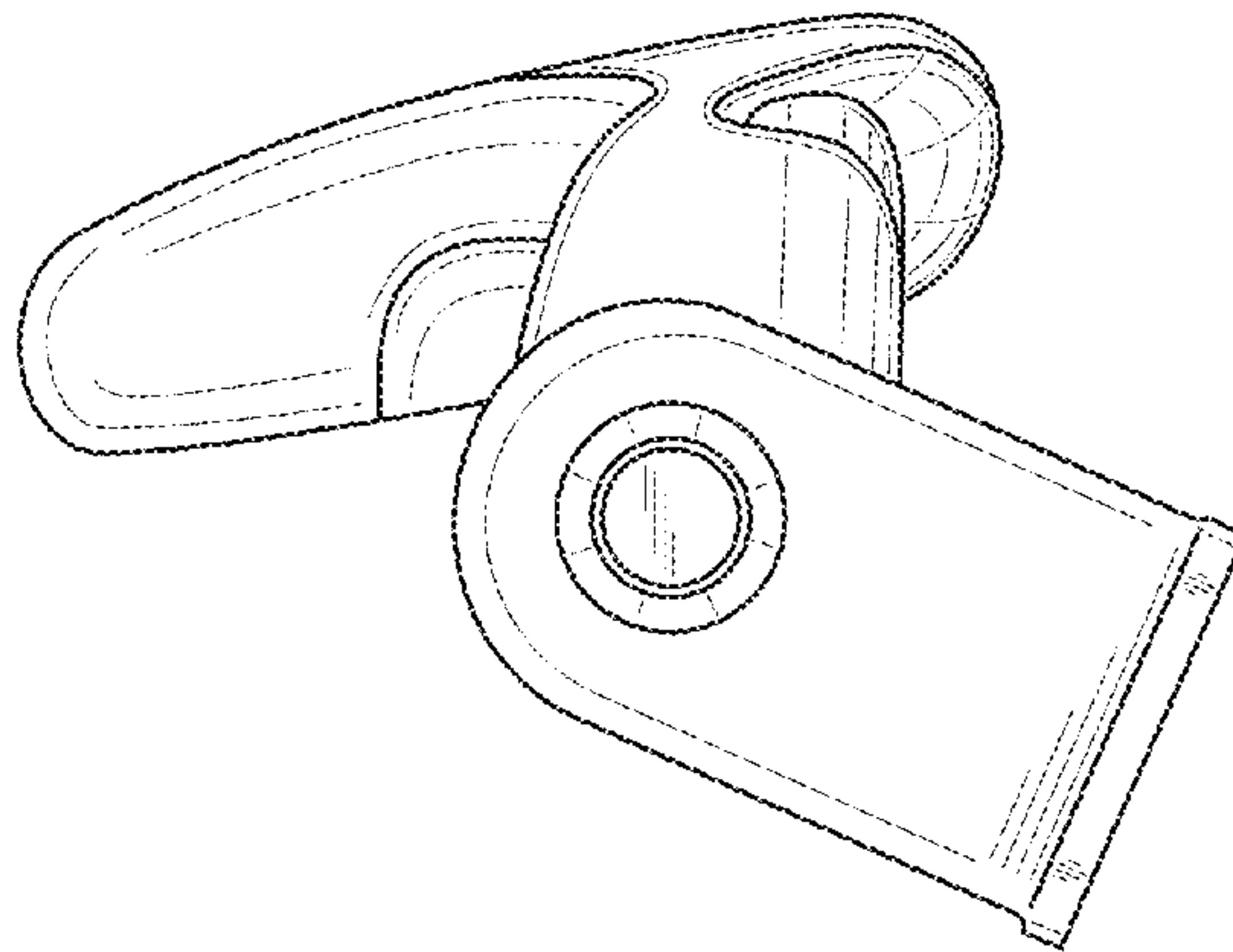
