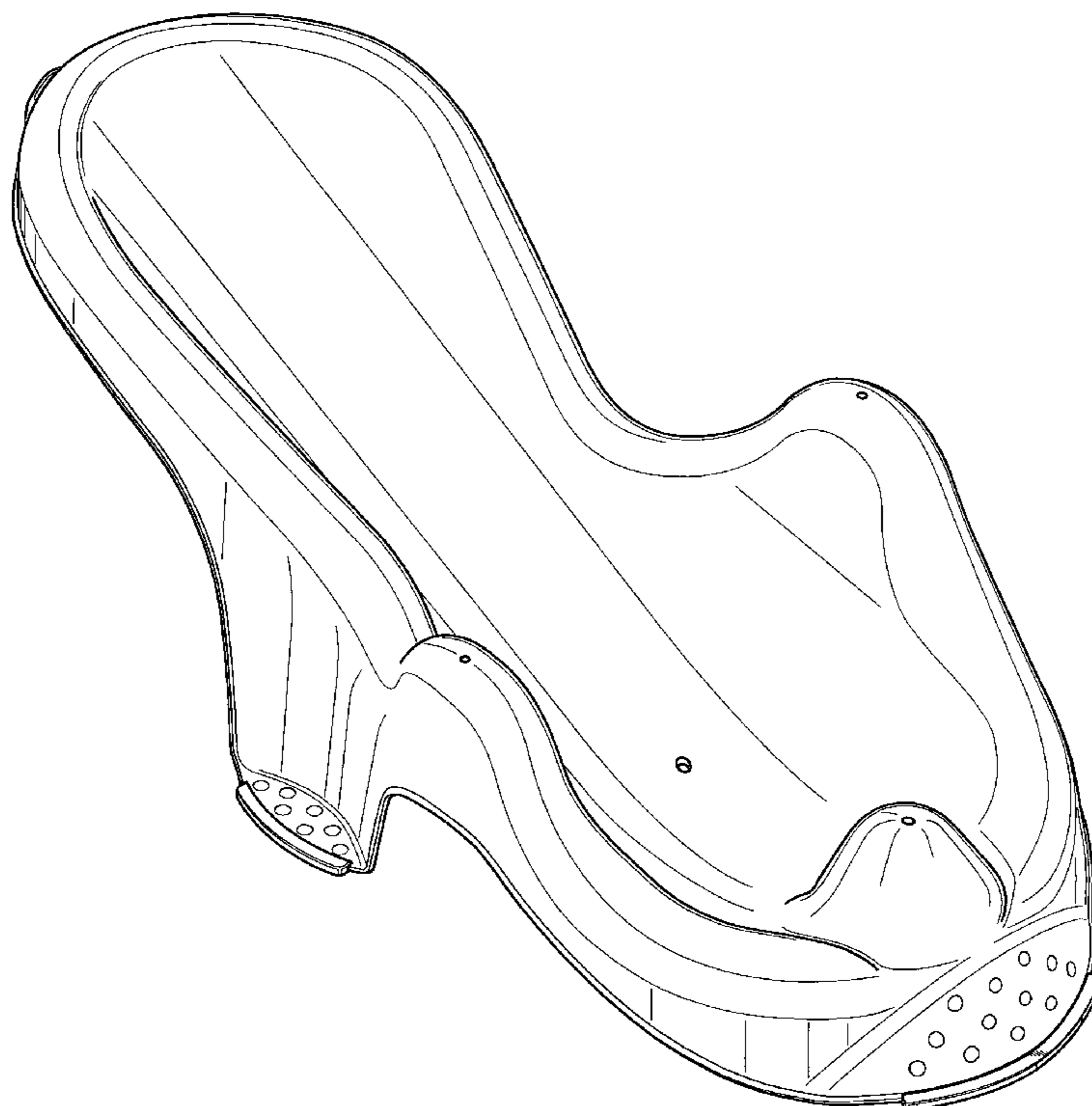
(57) **CLAIM**

I claim the ornamental design for a bath seat for infants, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bath seat for infants;

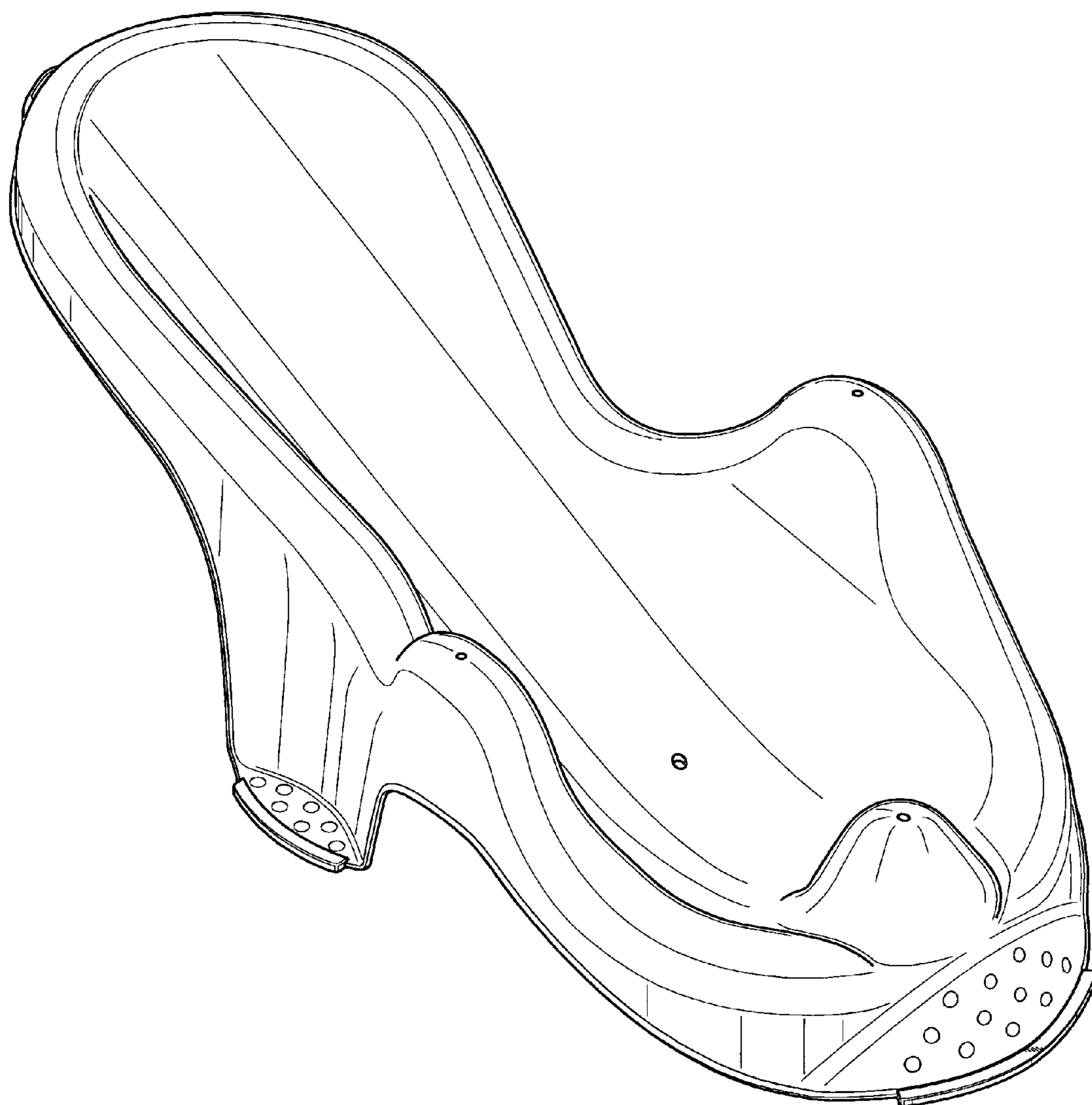

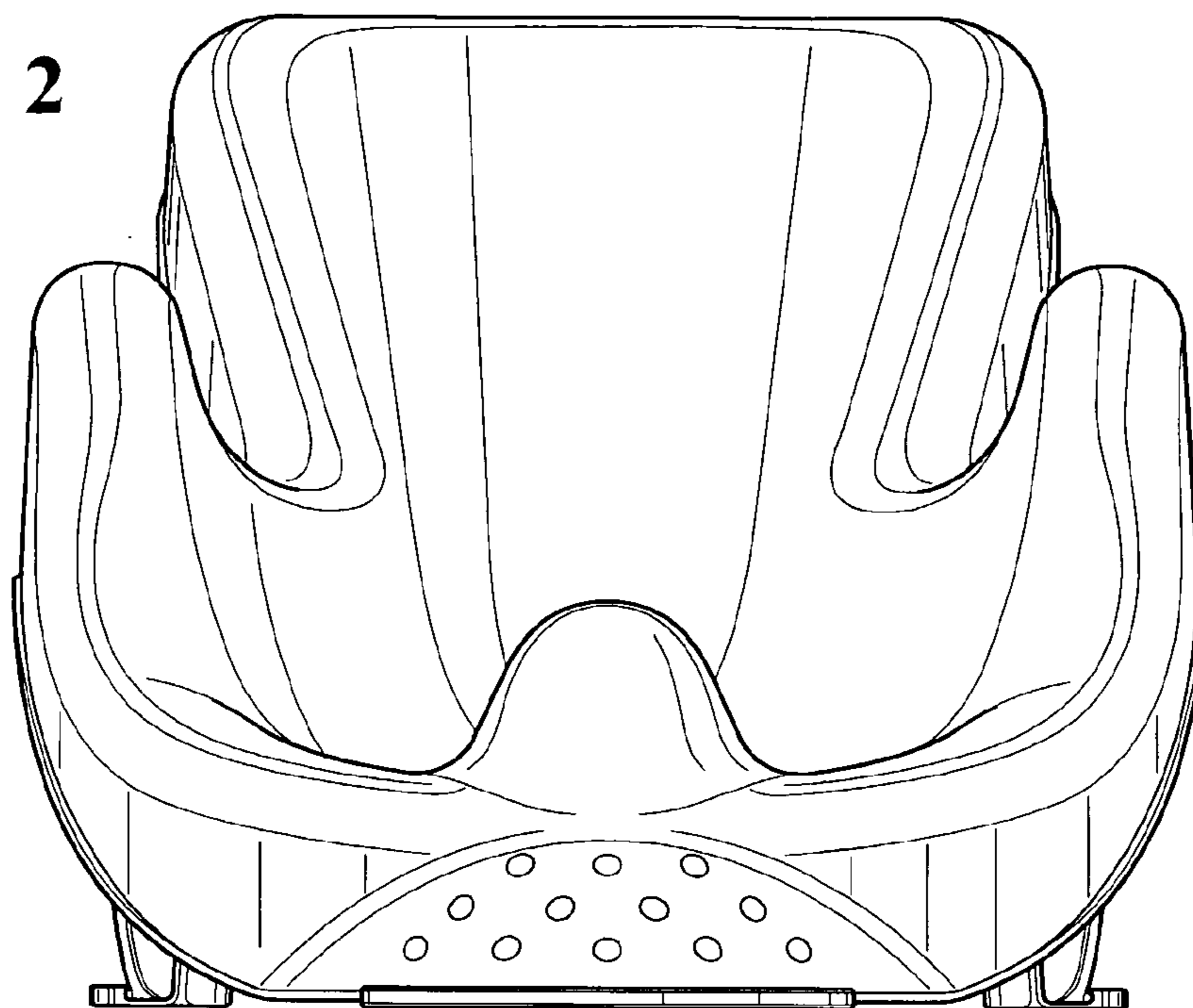
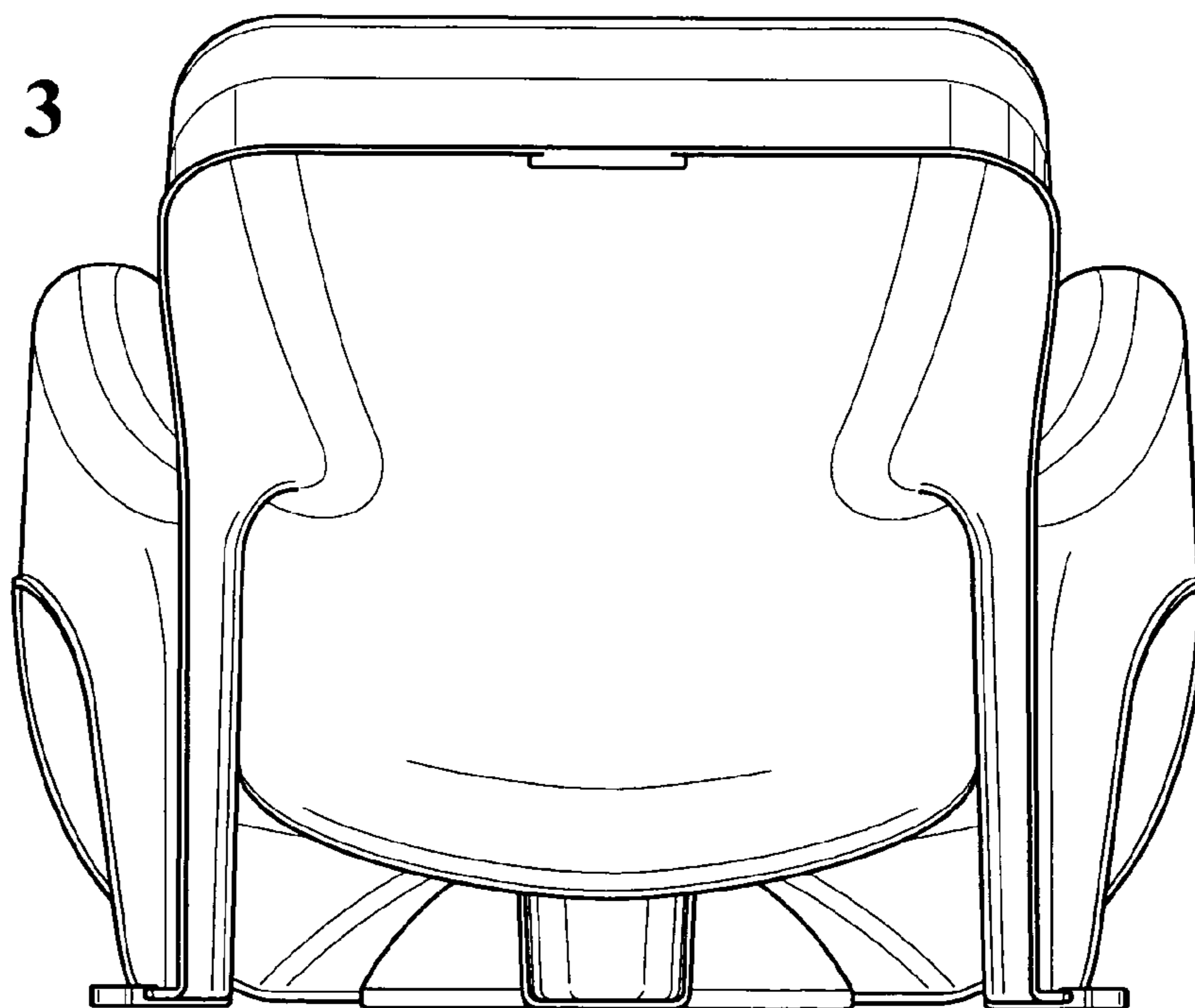

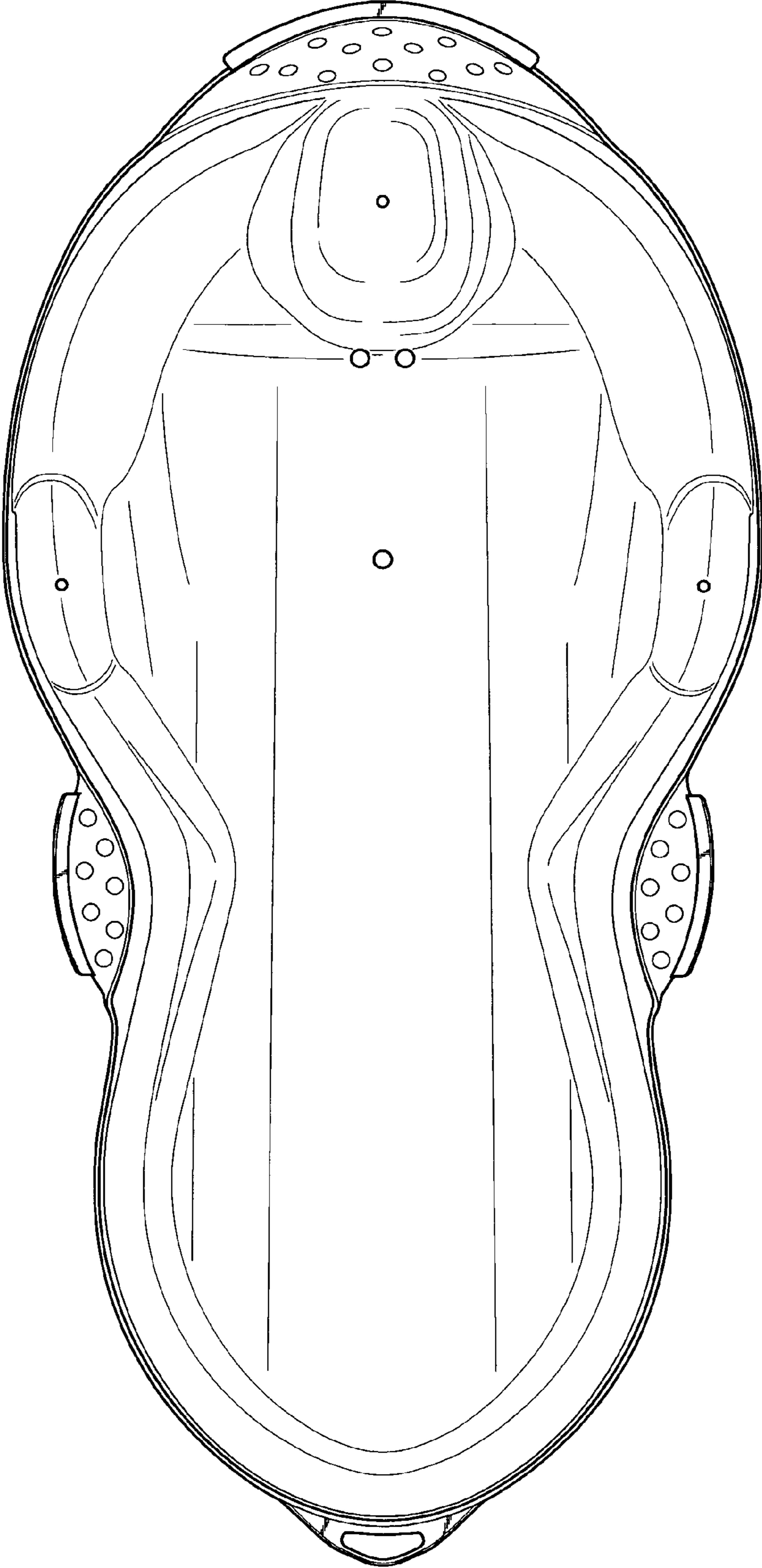

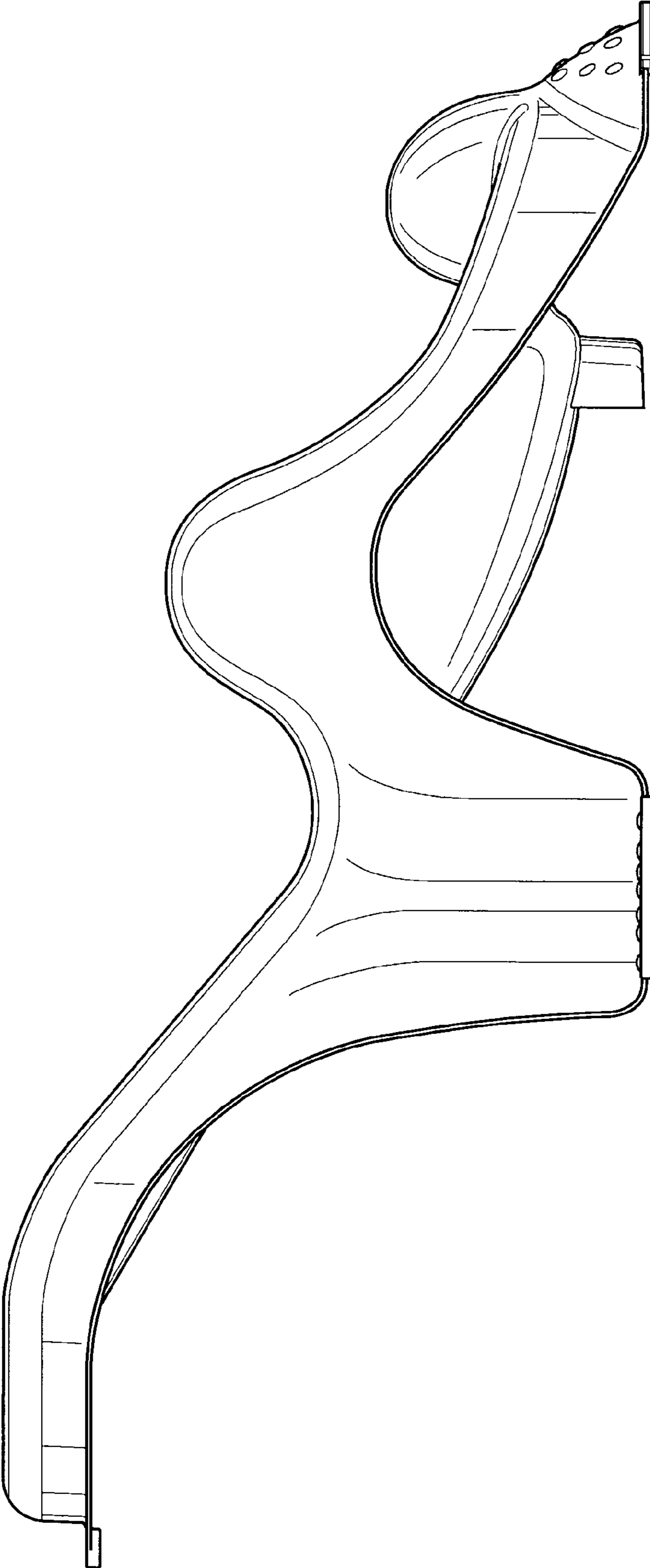

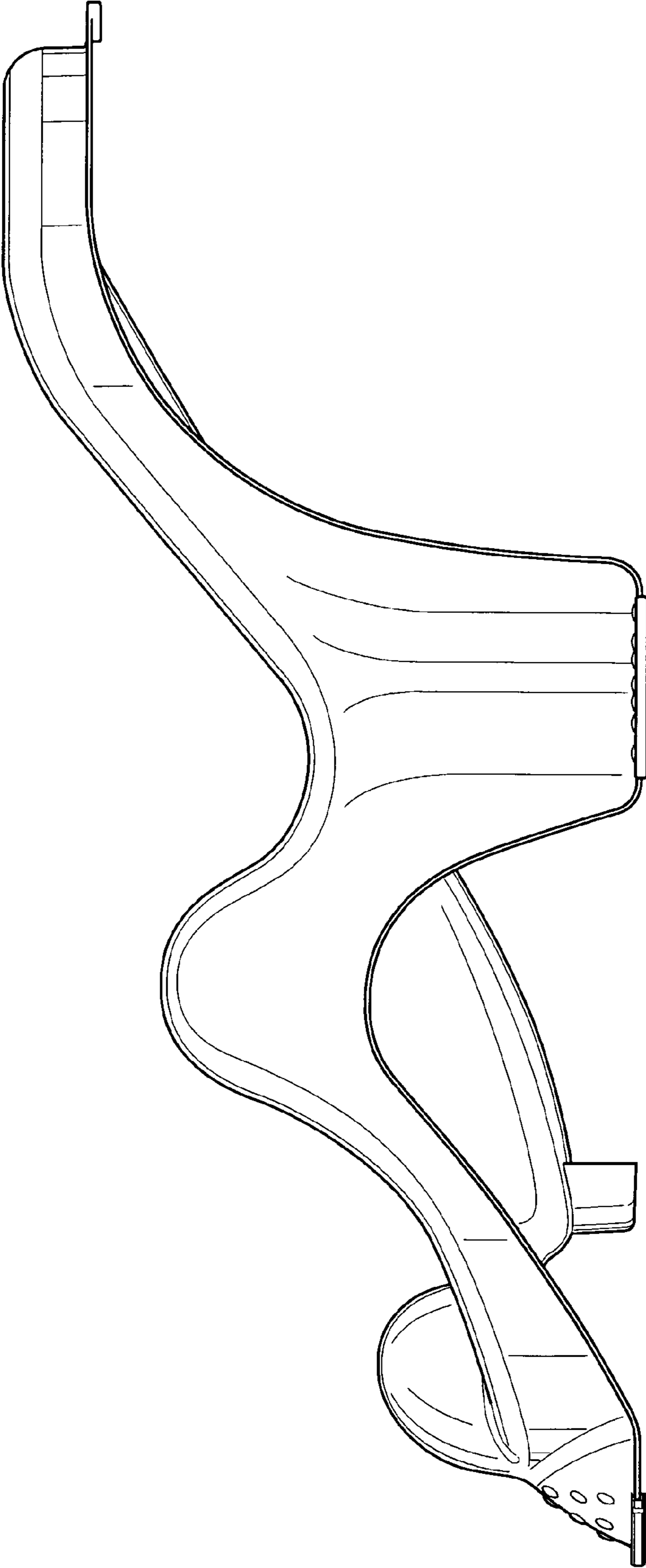

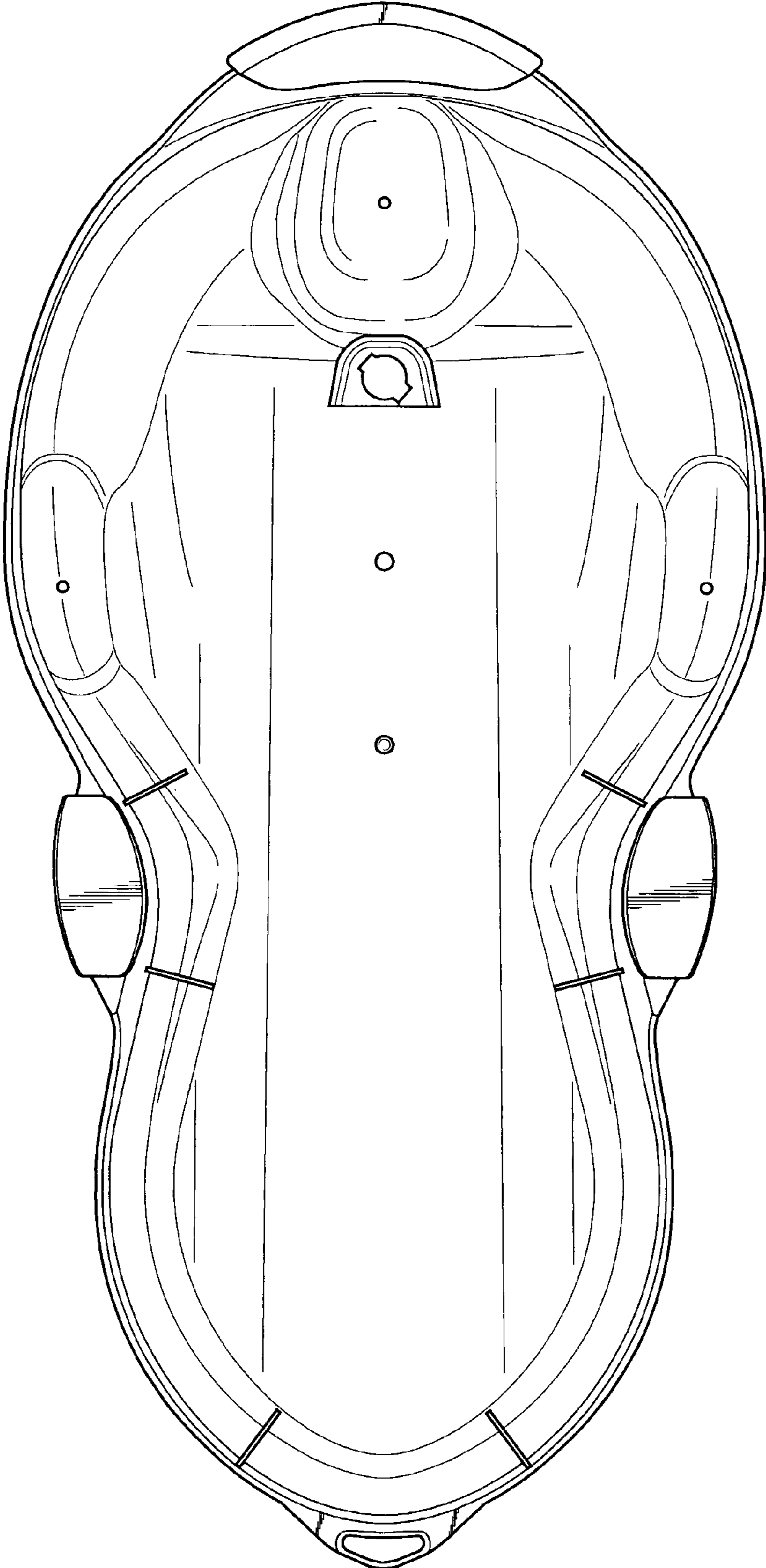
