(57) **CLAIM**

I claim the ornamental design for a container with a cap opener, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a container with cap opener showing my new design;

FIG. 2 is a front elevational view of the container with a cap opener of FIG. 1;

FIG. 3 is a rear elevational view of the container with a cap opener of FIG. 1;

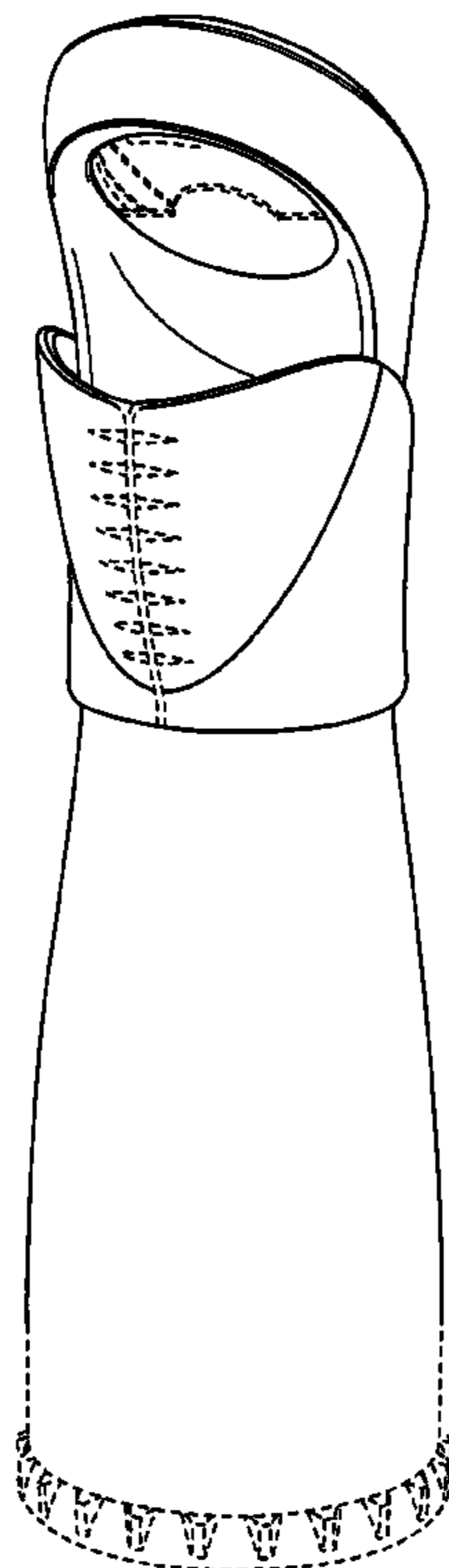
FIG. 4 is a left side elevational view of the container with a cap opener of FIG. 1;

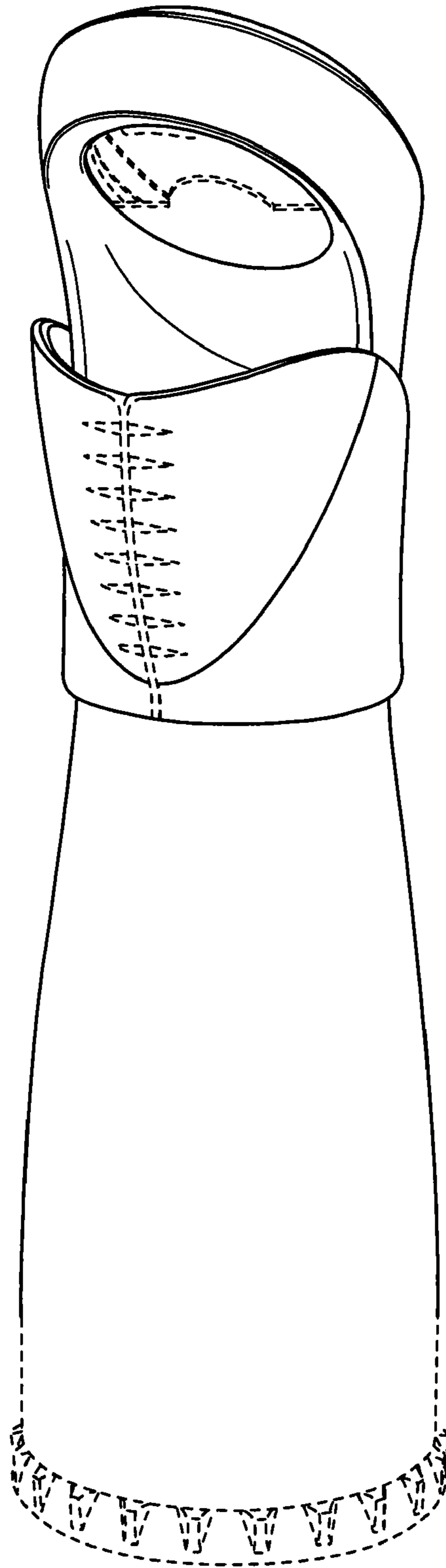

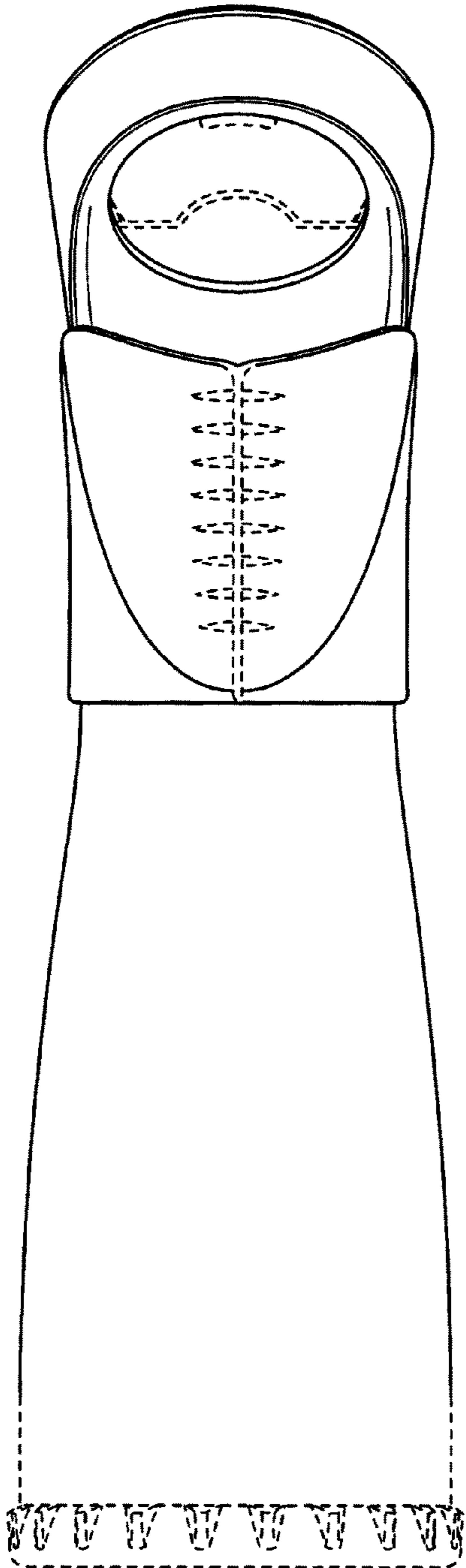

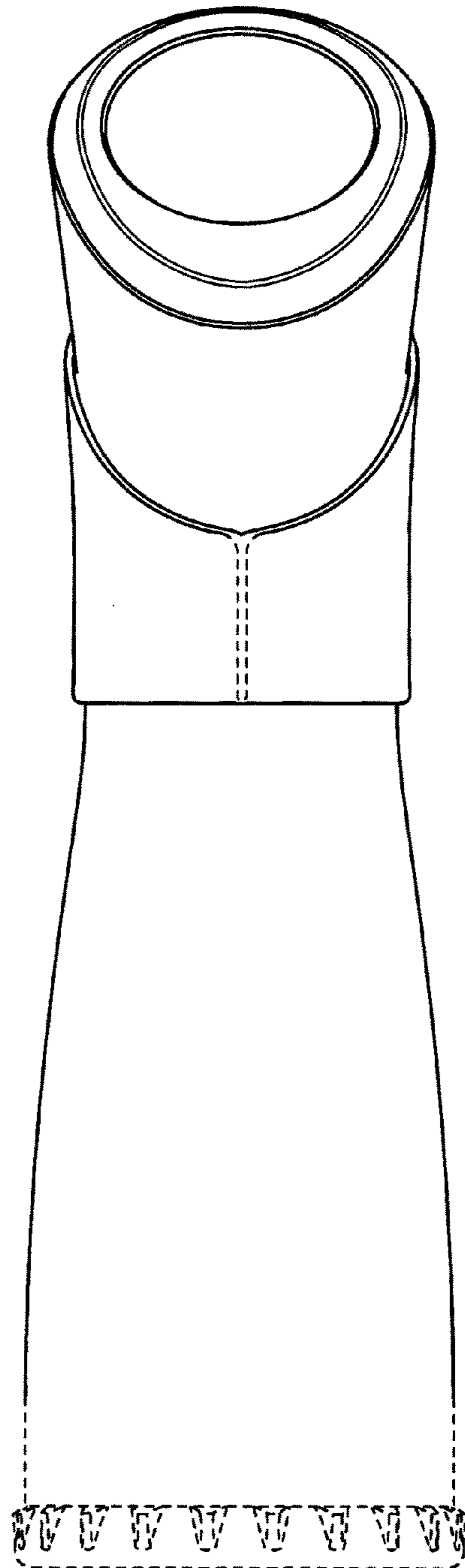

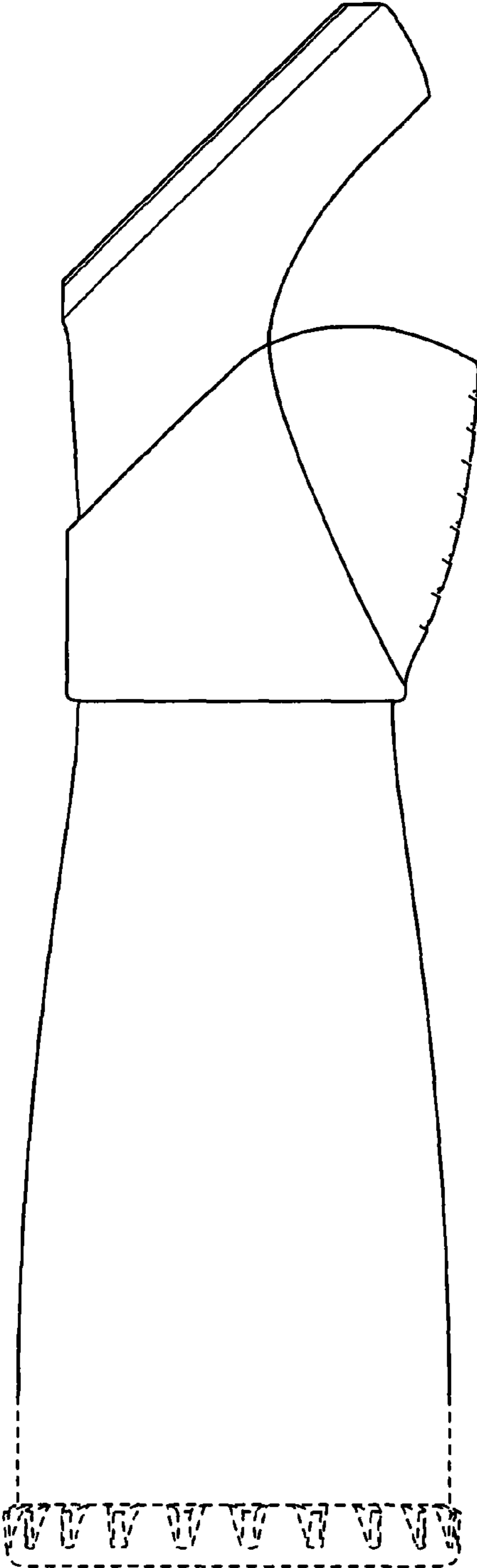

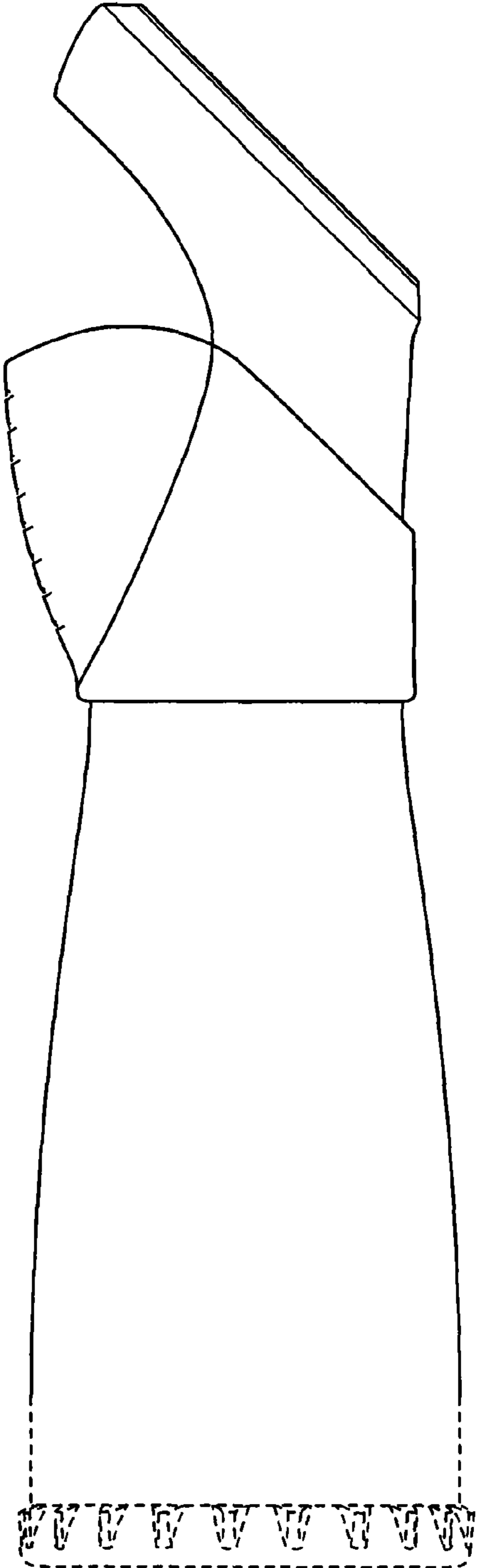

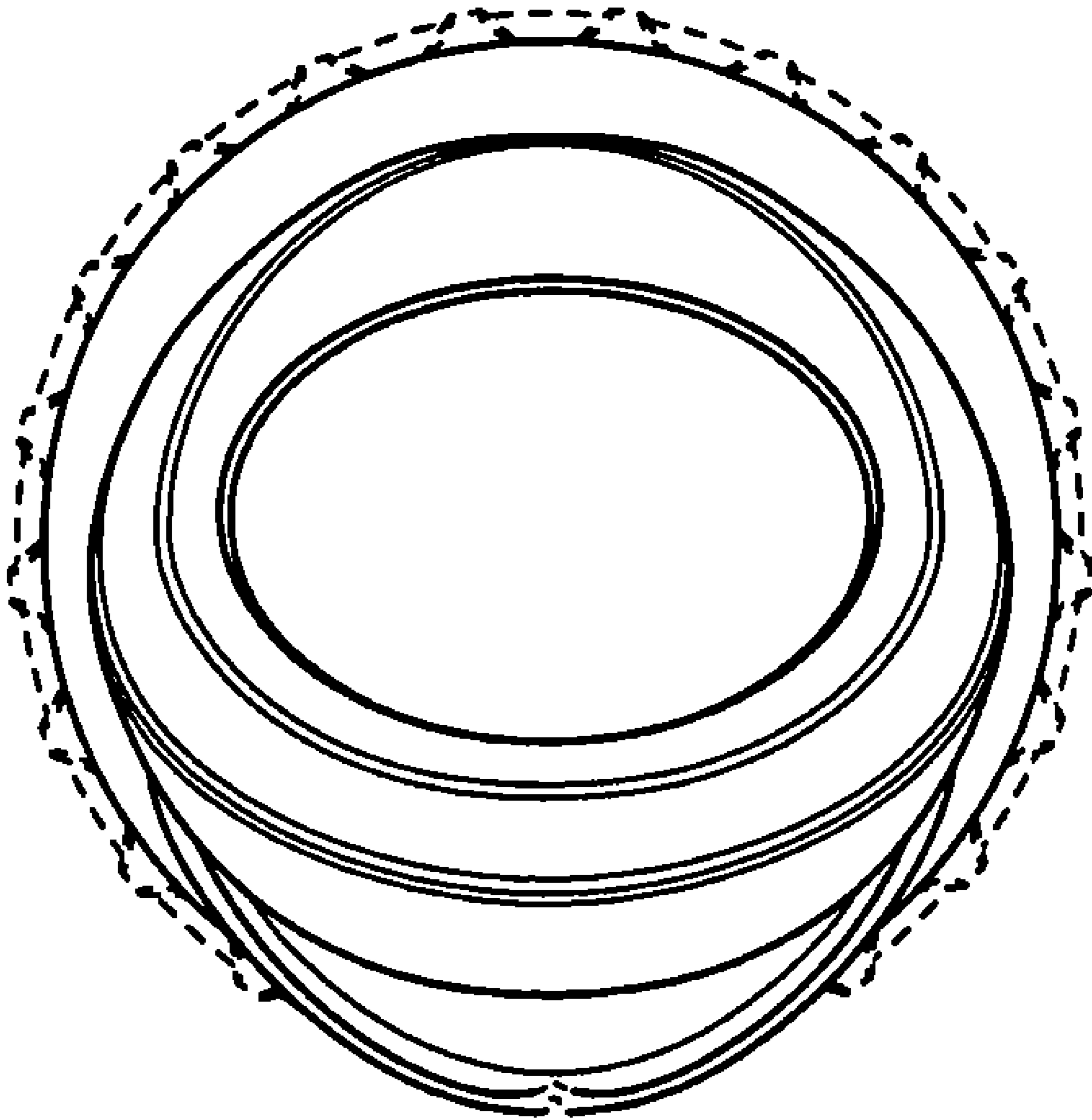
