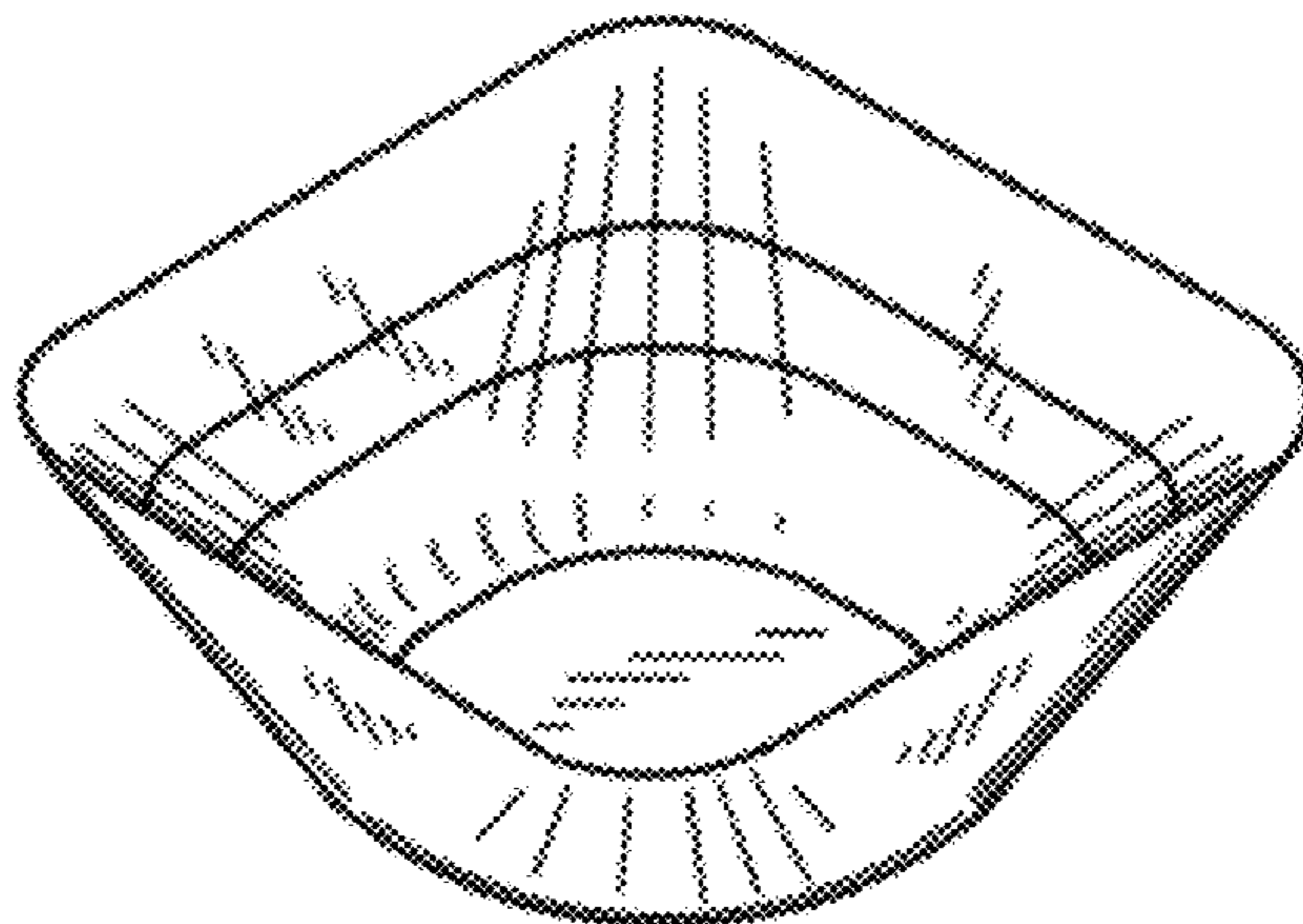
(57) **CLAIM**

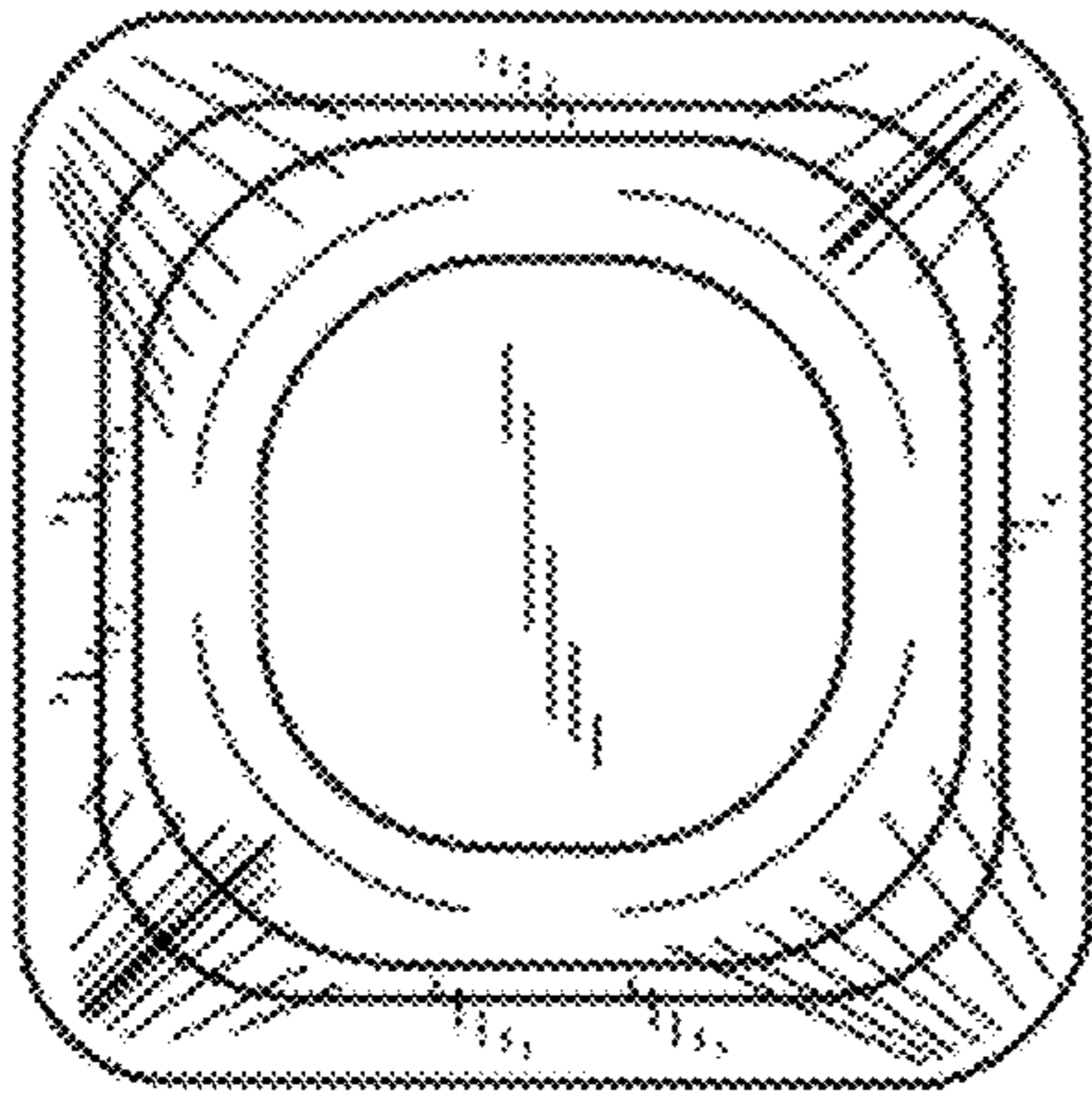
We claim the ornamental design for a bowl, as shown and described.

**DESCRIPTION**

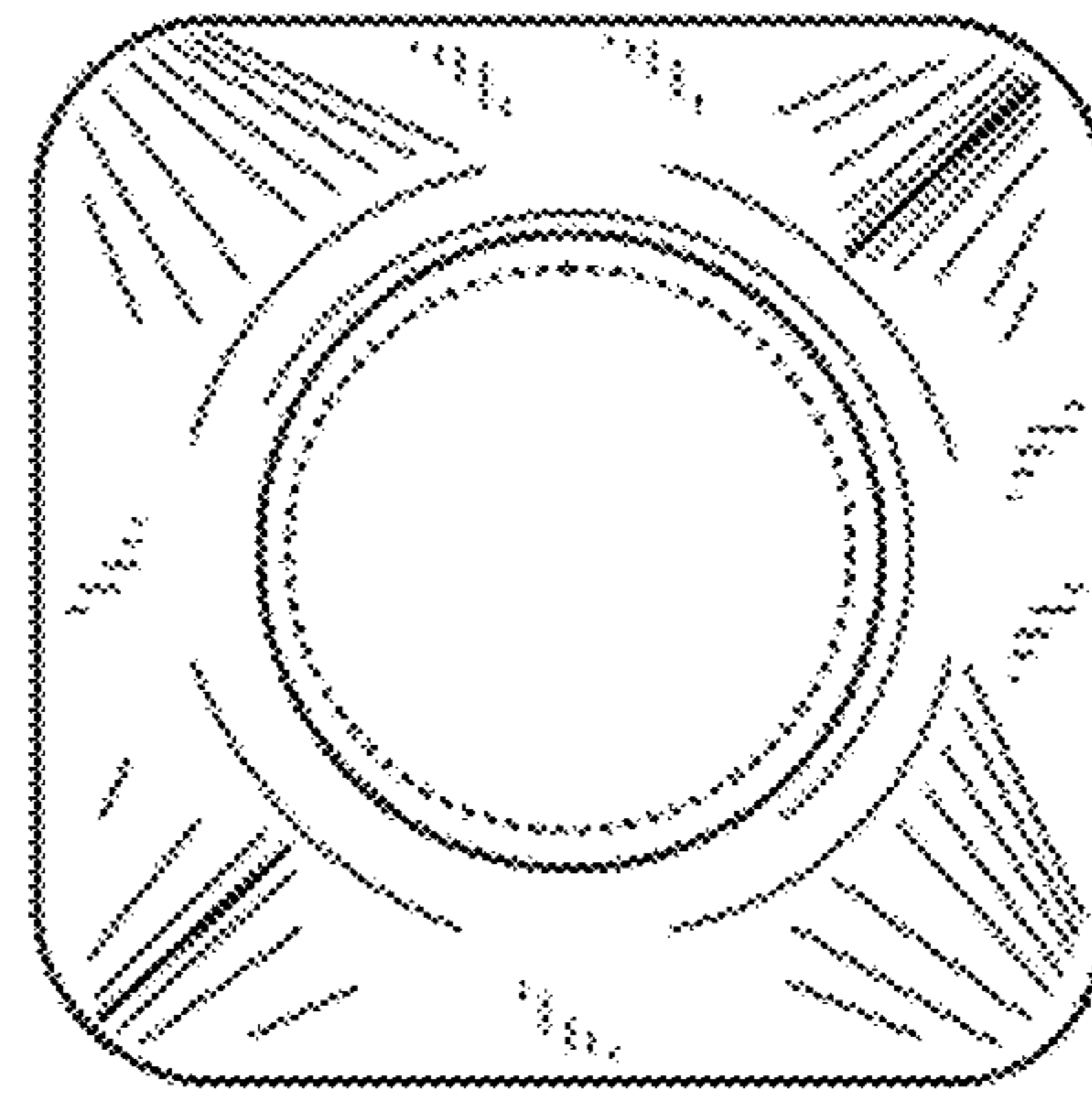
FIG. 1 is a perspective view of the bowl;

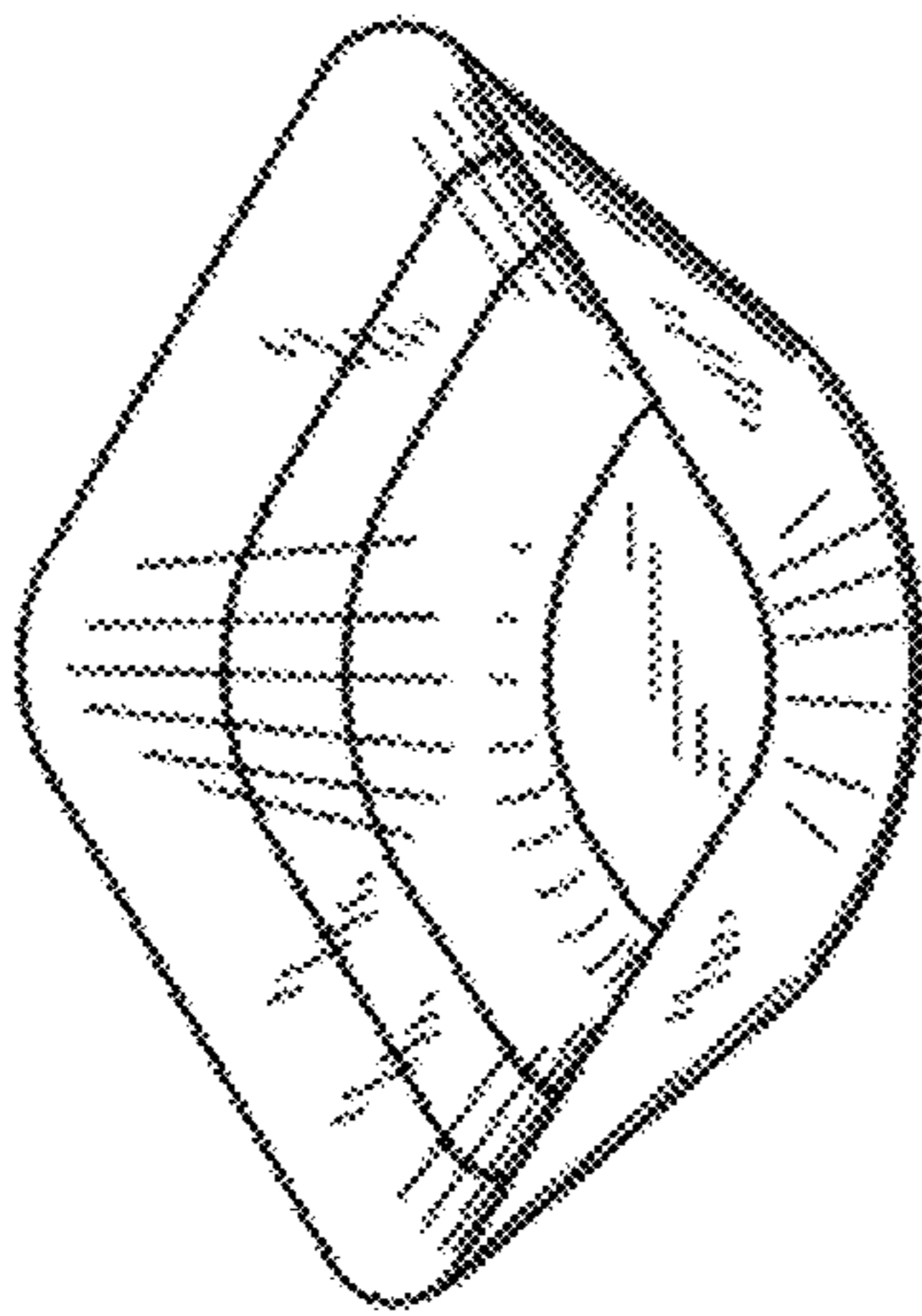




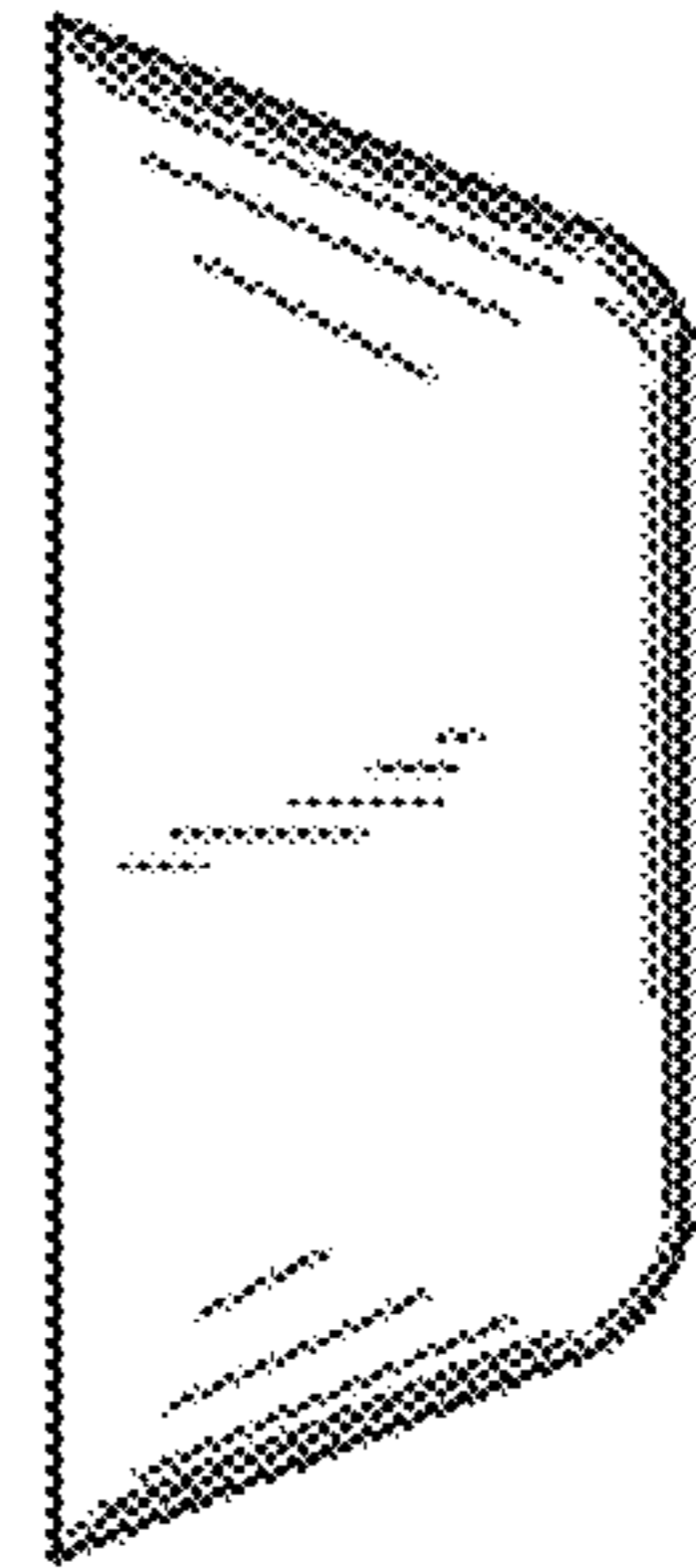
