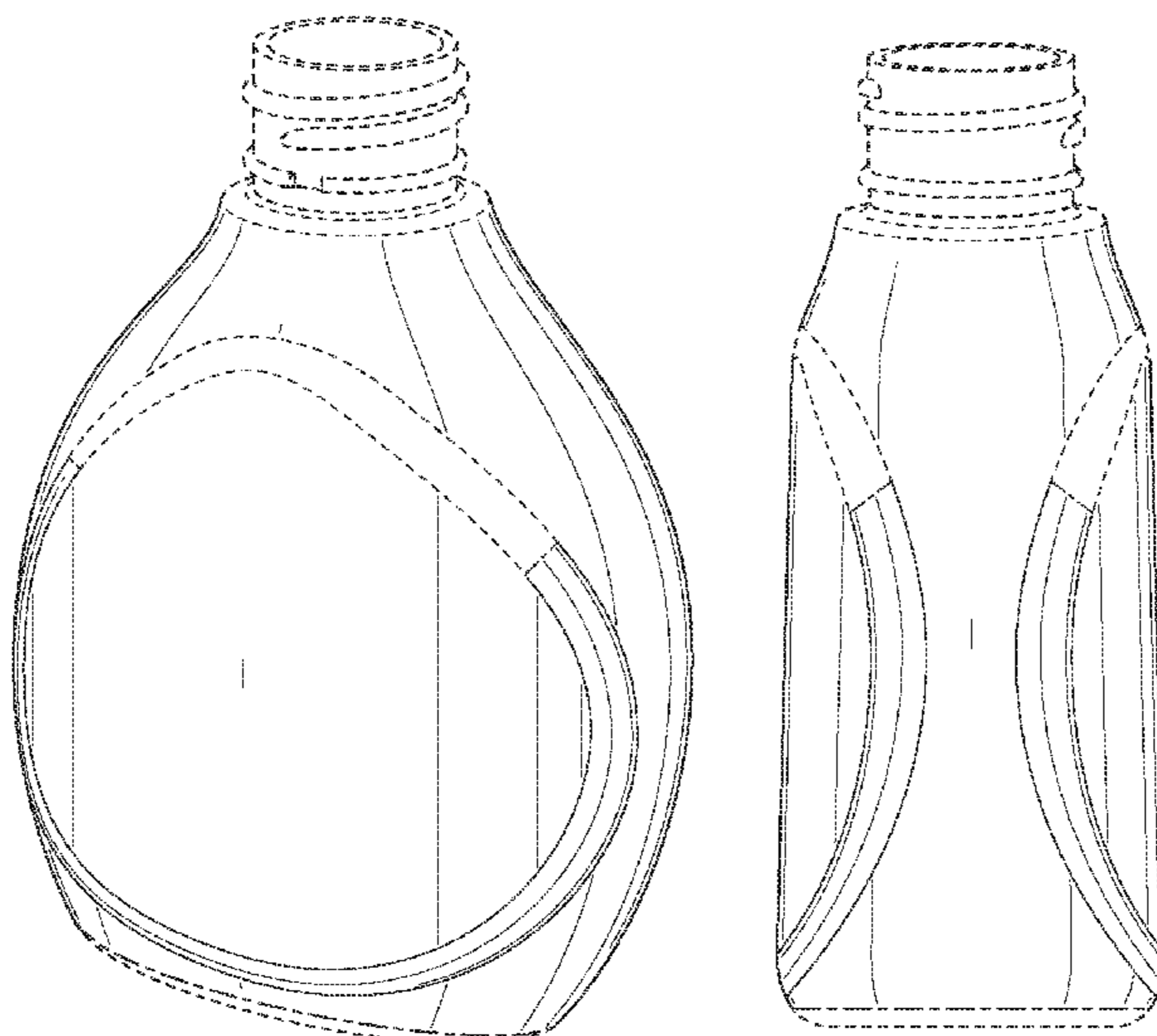
(57) **CLAIM**

We claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a bottle showing our new design;
FIG. 2 is a front elevational view thereof, the back elevational view being a mirror image;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines shown in the drawings are included for the purpose of illustrating environmental structure and form no part of the claimed design.

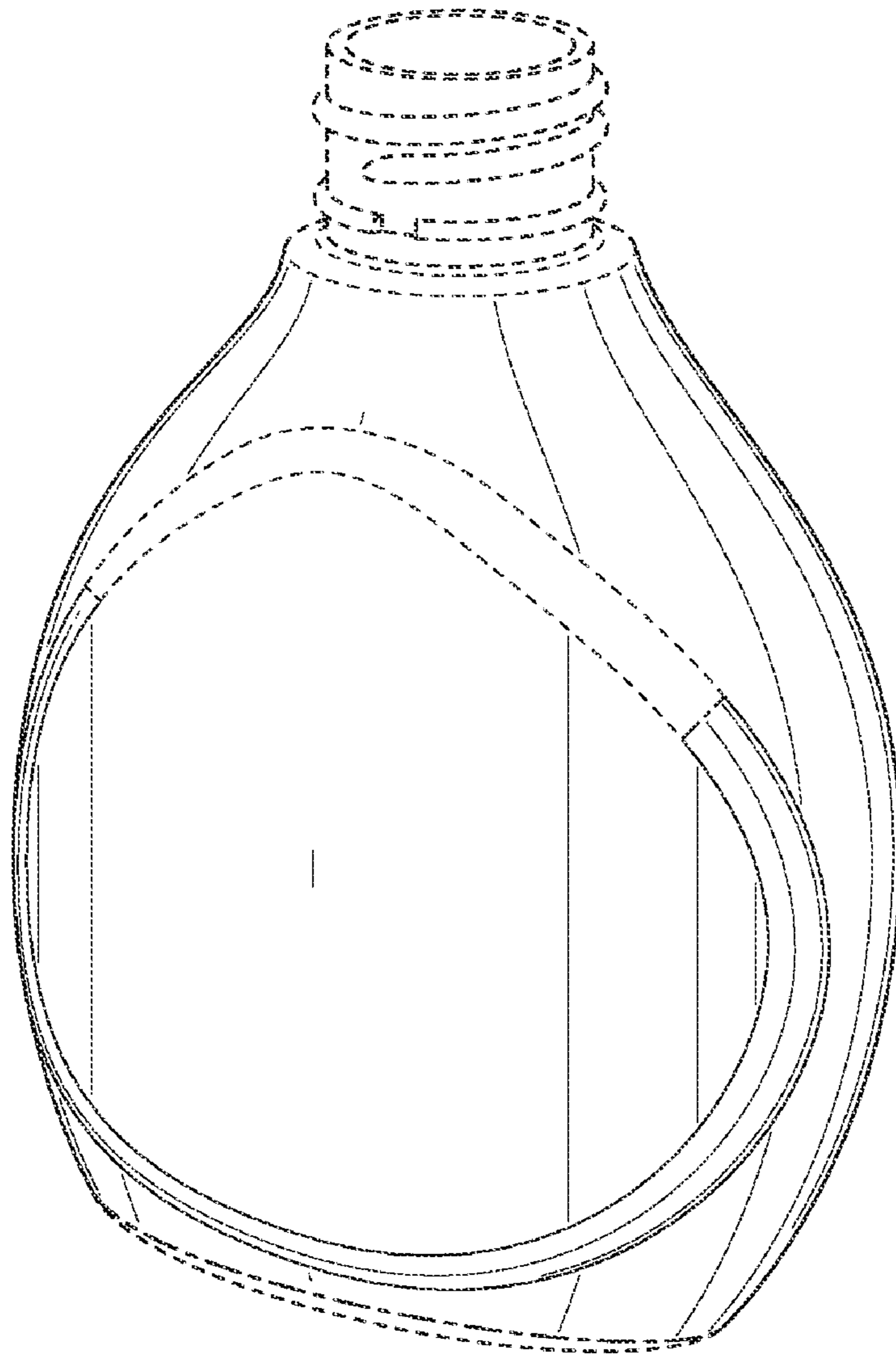

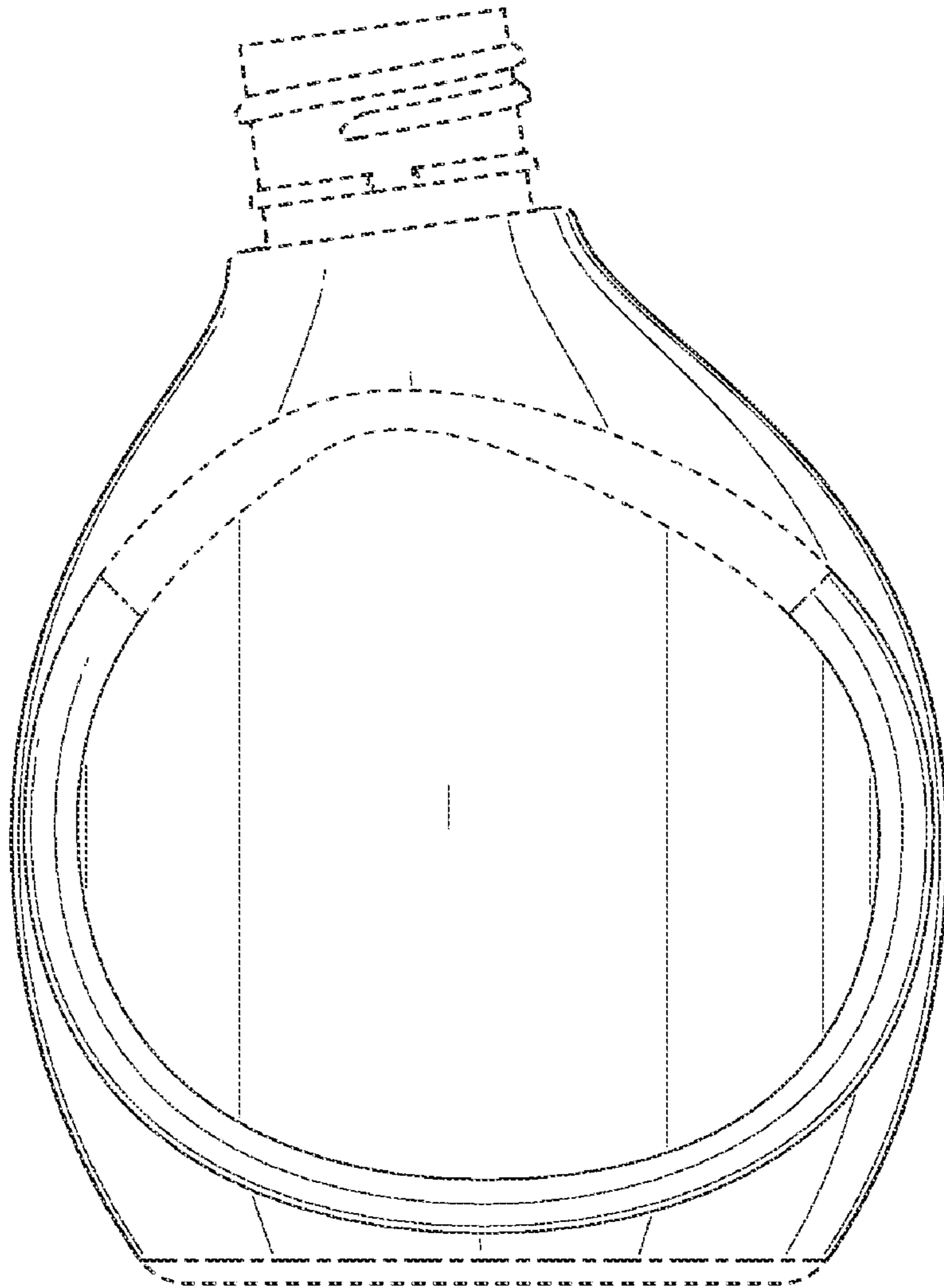

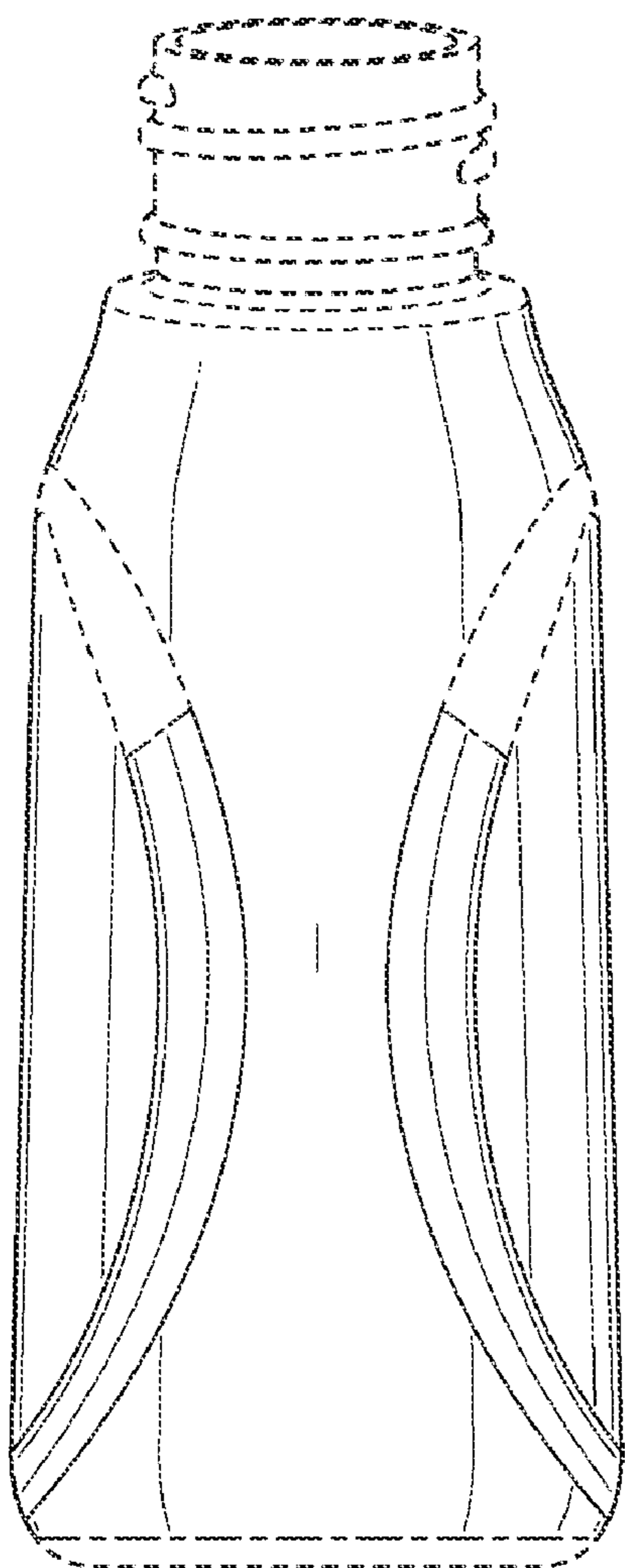

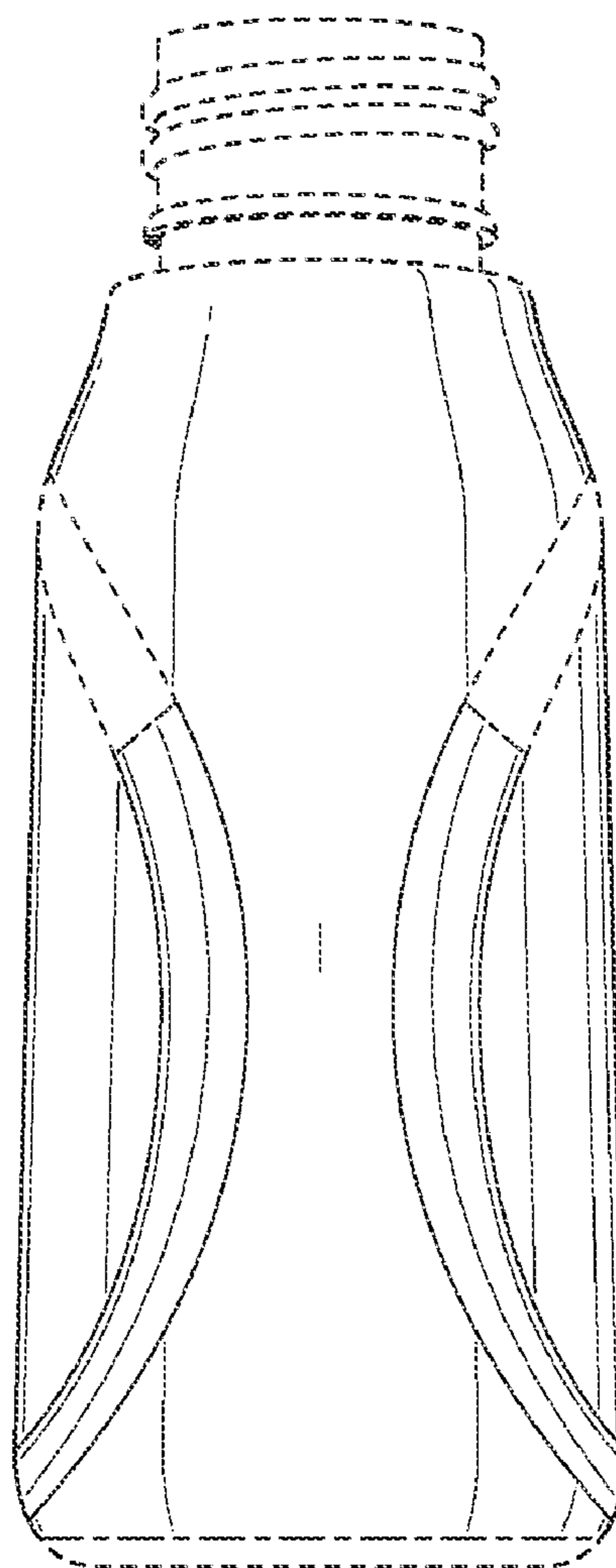

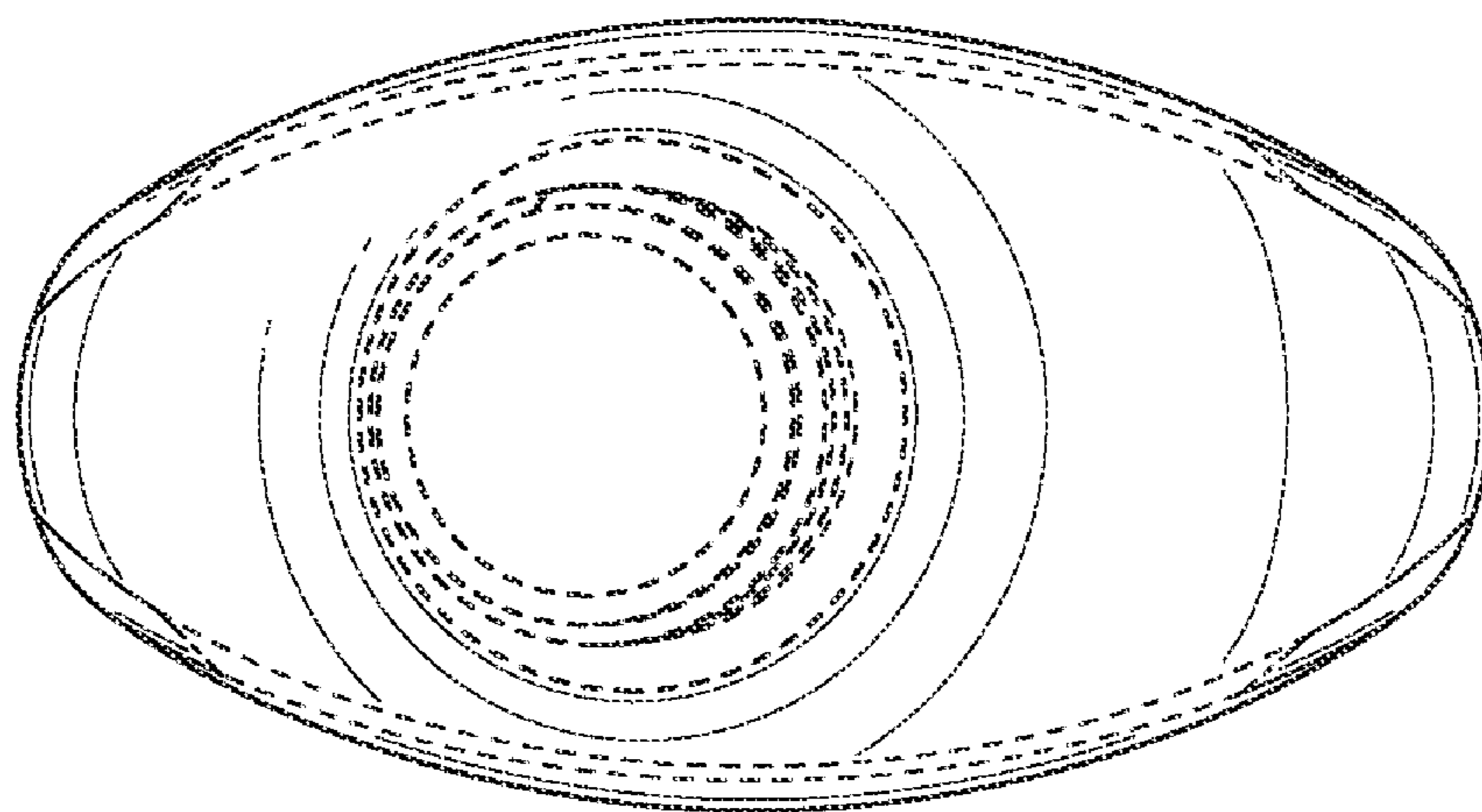

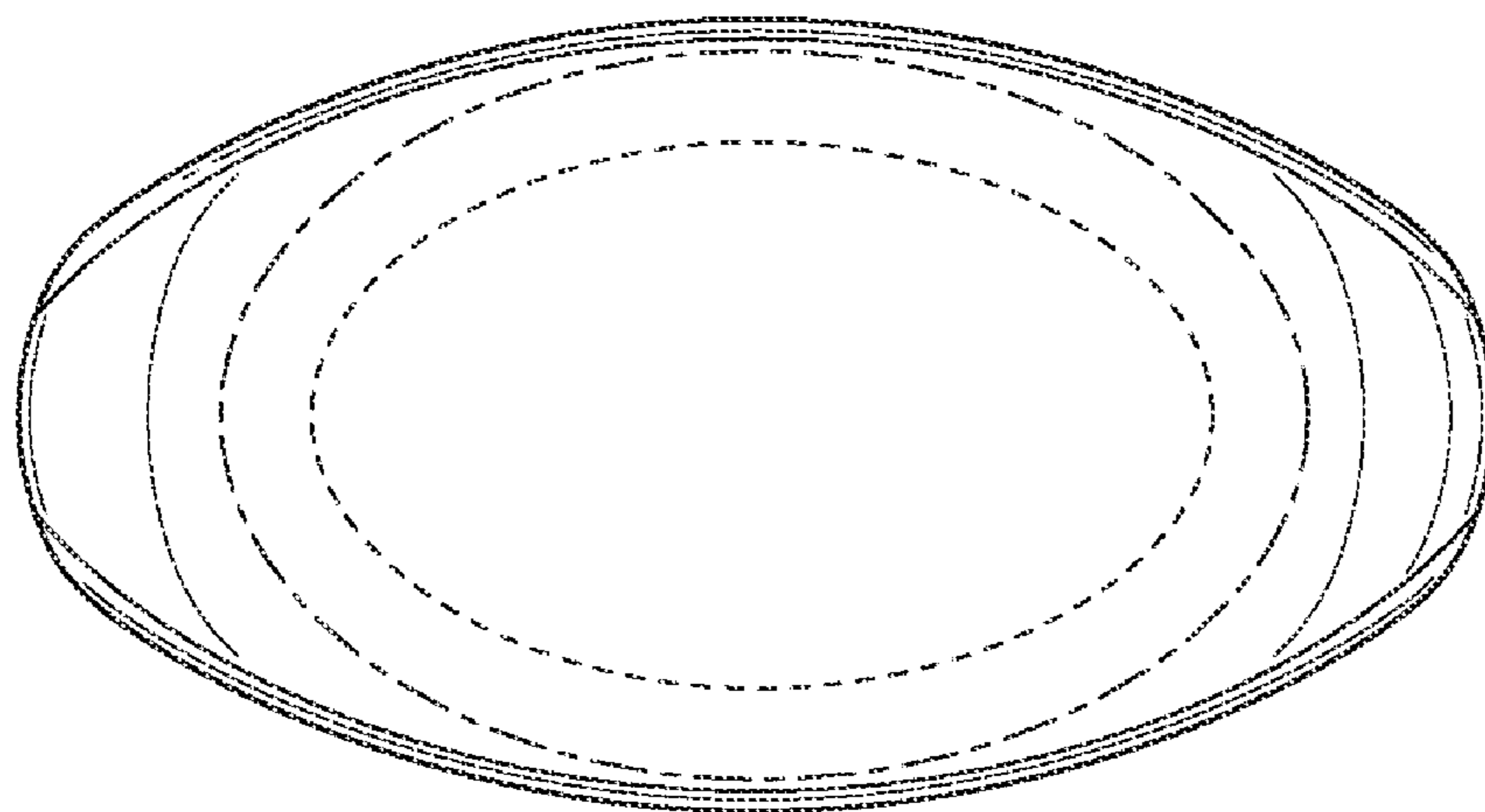
