(57) **CLAIM**

The ornamental design for a weighing scale body, as shown and described above.

**DESCRIPTION**

FIG. 1 is a front-left perspective view of a first embodiment of a weighing scale body showing our new design;

FIG. 2 is a top plan view of the embodiment of FIG. 1;

FIG. 3 is a front elevation view of the embodiment of FIG. 1; FIG. 4 is a rear elevation view of the embodiment of FIG. 1; FIG. 5 is a left side elevation view of the embodiment of FIG. 1, the right-side elevation view being a mirror image thereof; FIG. 6 is a top plan view of the weighing scale body of FIG. 1 shown in conjunction with an unclaimed weigh pan of round shape;

FIG. 7 is a top plan view of the weighing scale body of FIG. 1 shown in conjunction with an unclaimed weigh pan of square shape;

FIG. 8 is a front-left perspective view of a second embodiment of a weighing scale body showing our new design;

FIG. 9 is a top plan view of the embodiment of FIG. 8;

FIG. 10 is a front elevation view of the embodiment of FIG. 8;

FIG. 11 is a rear elevation view of the embodiment of FIG. 8;

FIG. 12 is a left side elevation view of the embodiment of FIG. 8, the right-side elevation view being a mirror image thereof;

FIG. 13 is a top plan view of the weighing scale body of FIG. 8 shown in conjunction with an unclaimed weigh pan of round shape;

FIG. 14 is a top plan view of the weighing scale body of FIG. 8 shown in conjunction with an unclaimed weigh pan of square shape;

FIG. 15 is a front-left perspective view of a third embodiment of a weighing scale body showing our new design;

FIG. 16 is a top plan view of the embodiment of FIG. 15;

FIG. 17 is a front elevation view of the embodiment of FIG. 15;

FIG. 18 is a rear elevation view of the embodiment of FIG. 15;

FIG. 19 is a left side elevation view of the embodiment of FIG. 15, the right-side elevation view being a mirror image thereof;

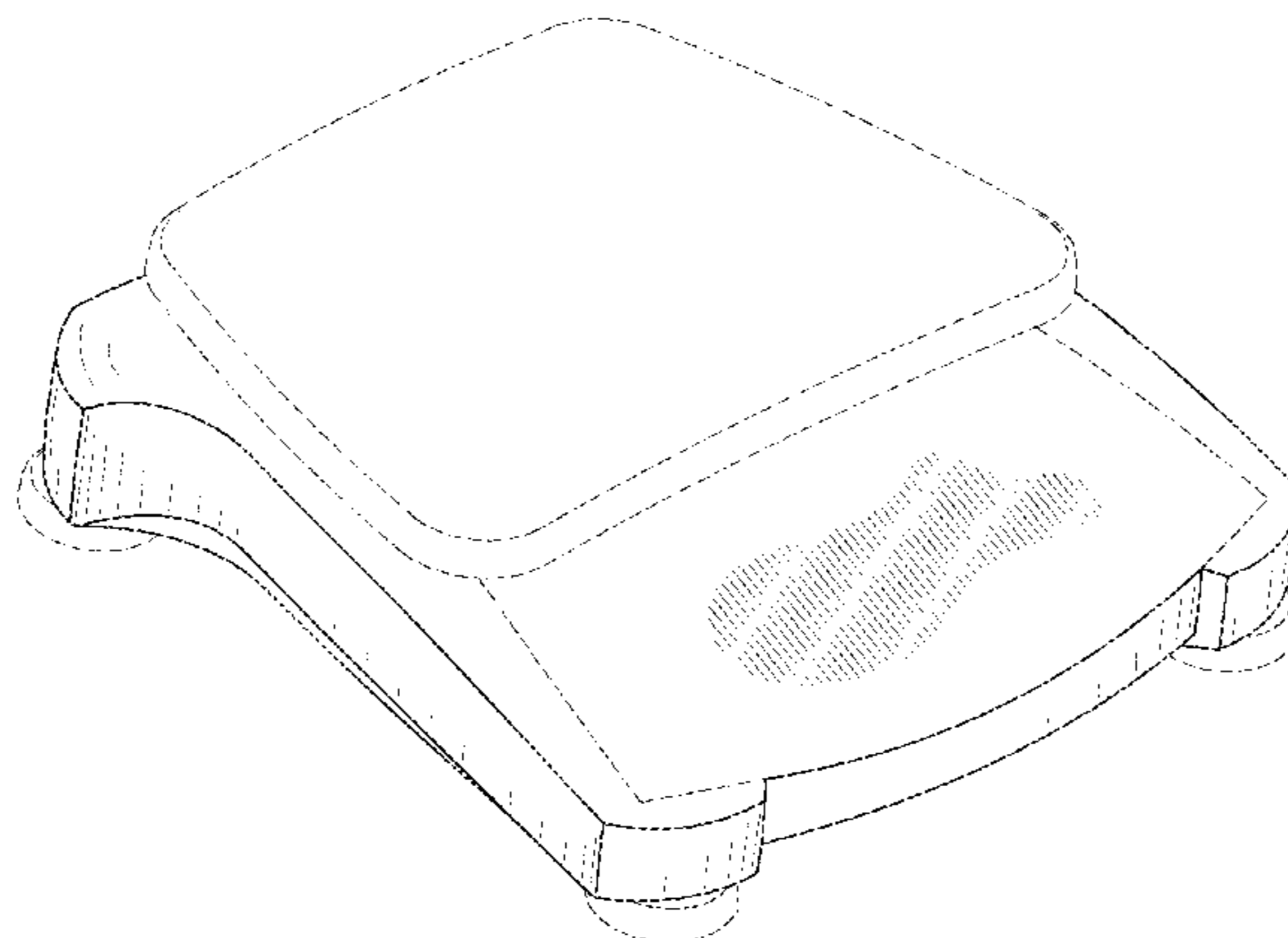
FIG. 20 is a top plan view of the weighing scale body of FIG. 15 shown in conjunction with an unclaimed weigh pan of round shape; and,

FIG. 21 is a top plan view of the weighing scale body of FIG. 15 shown in conjunction with an unclaimed weigh pan of square shape.

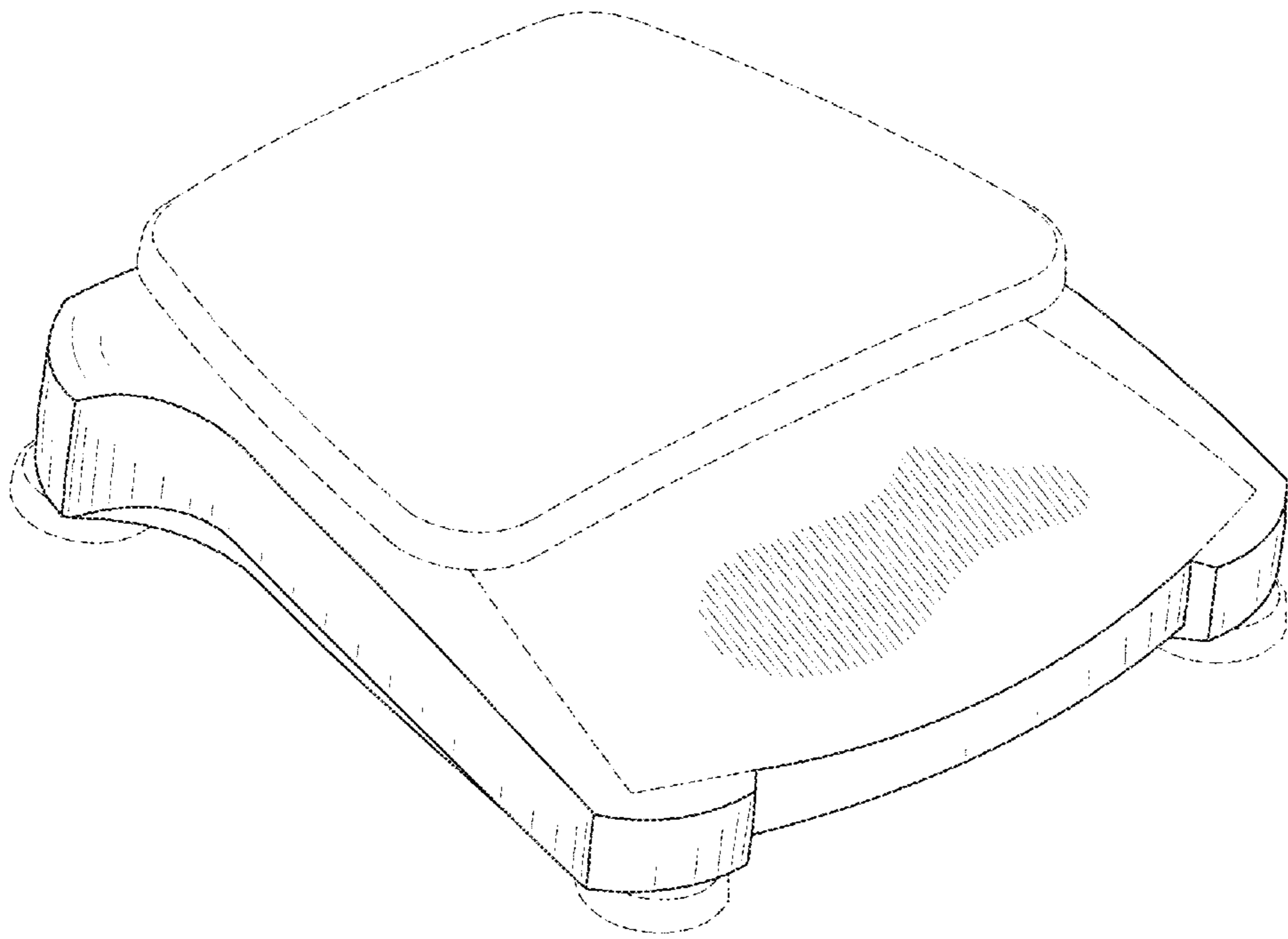

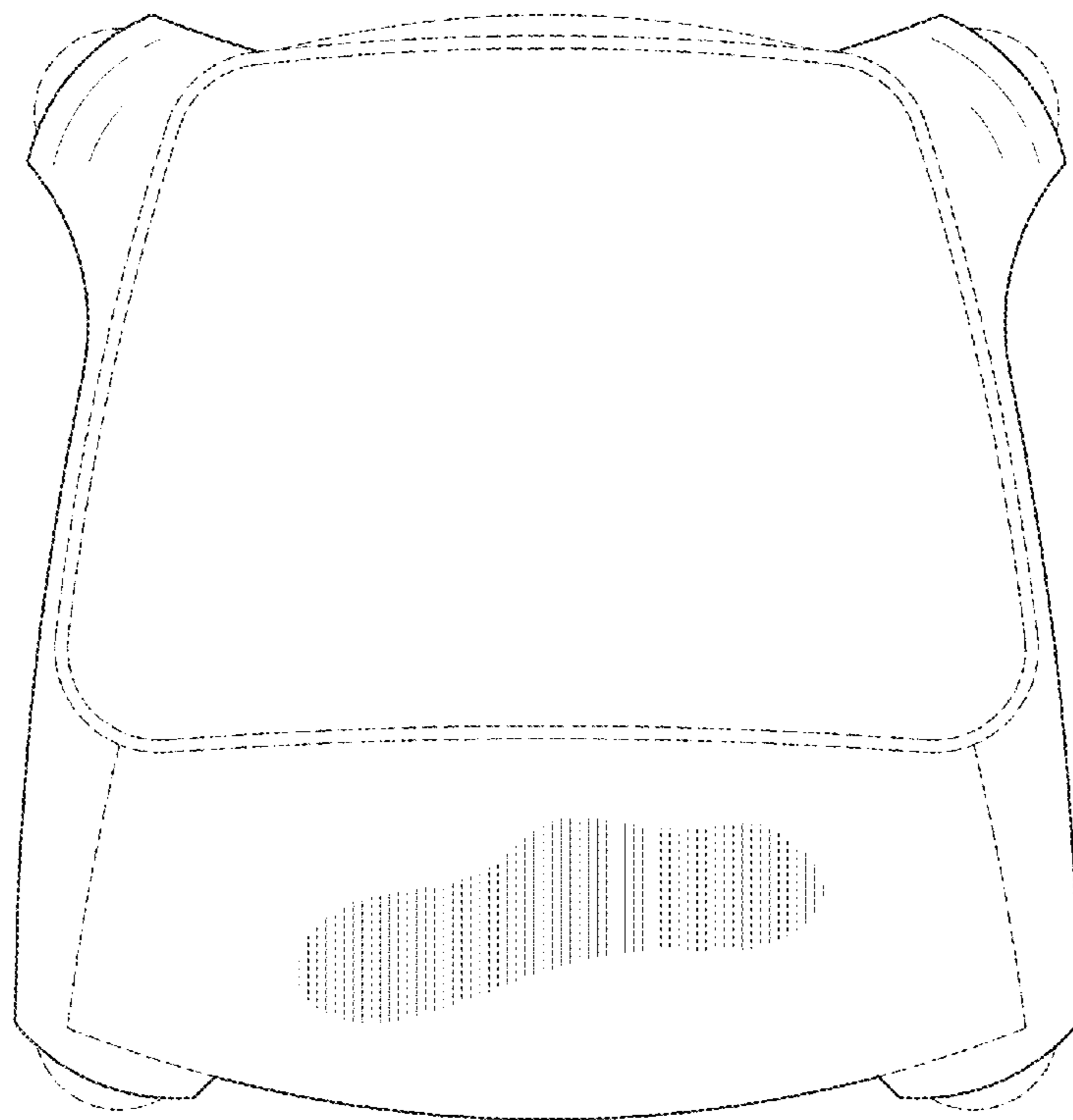

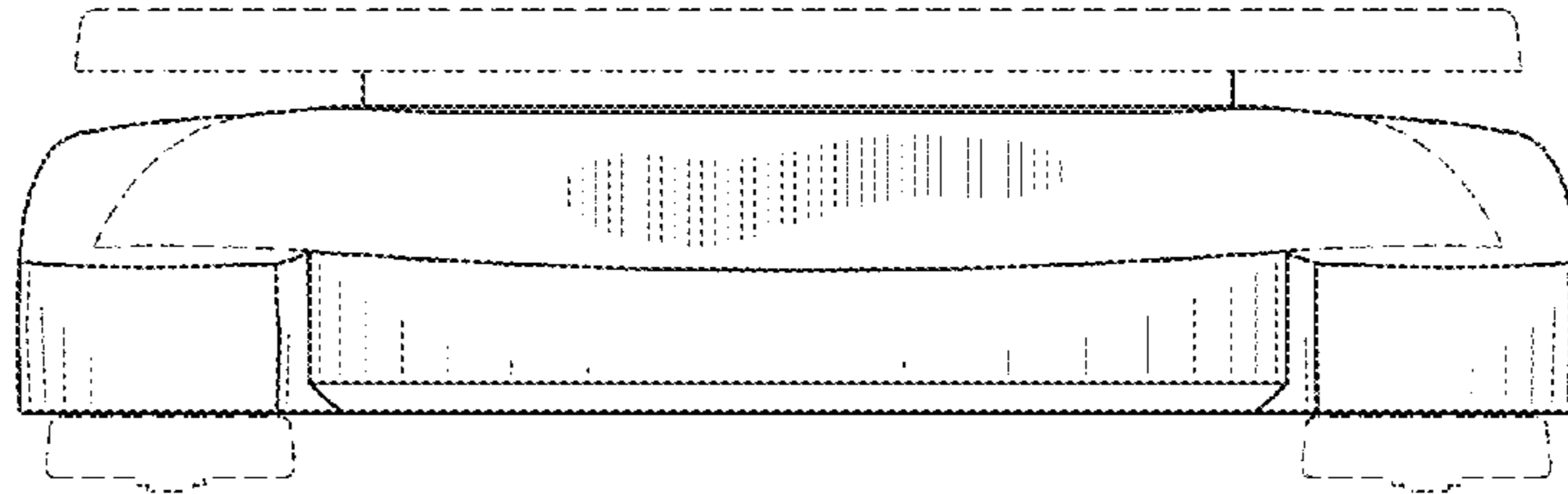

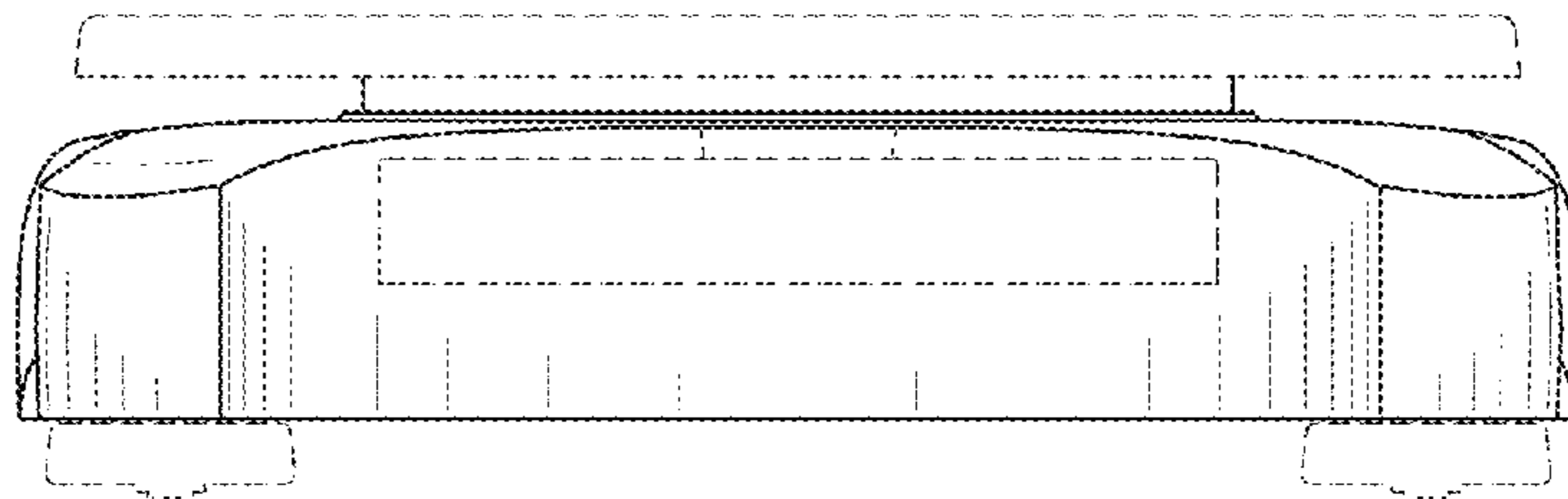

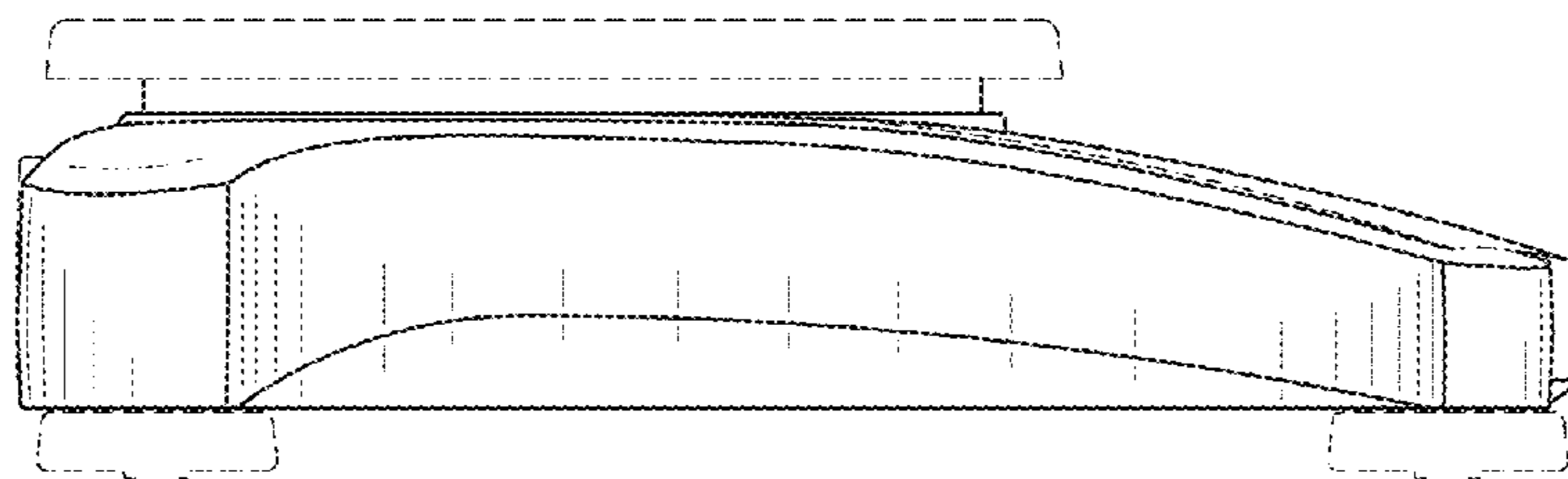

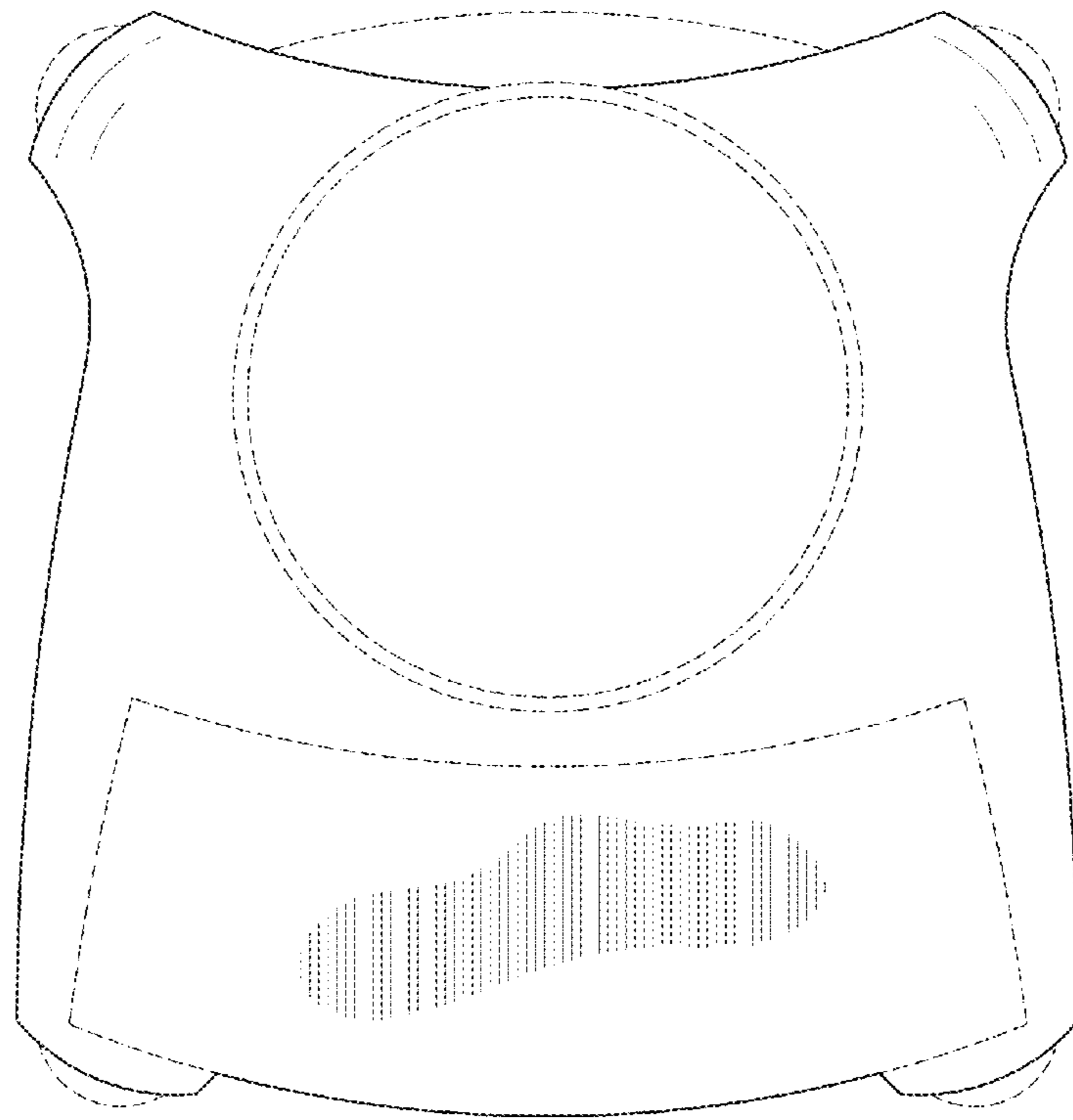

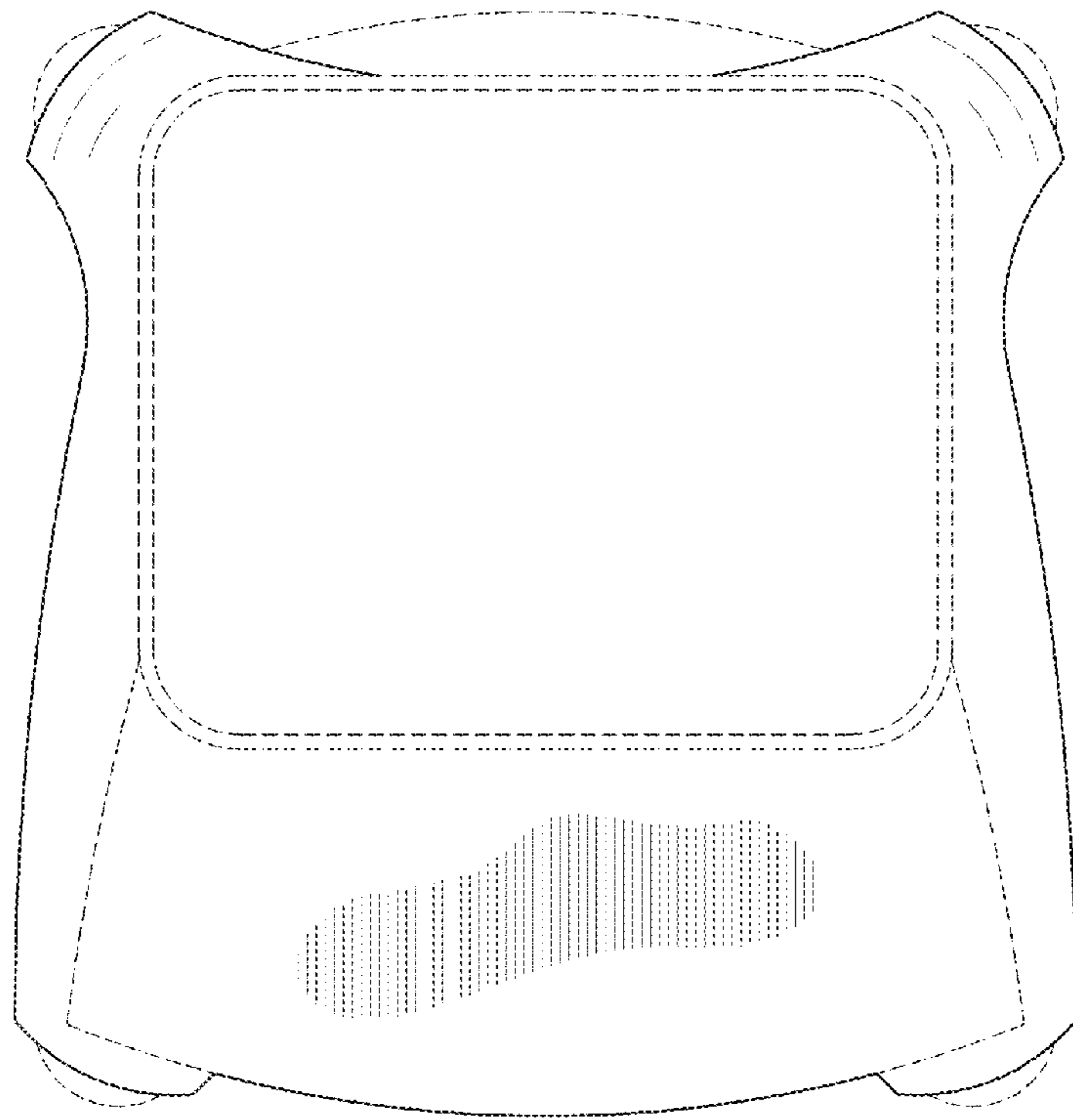

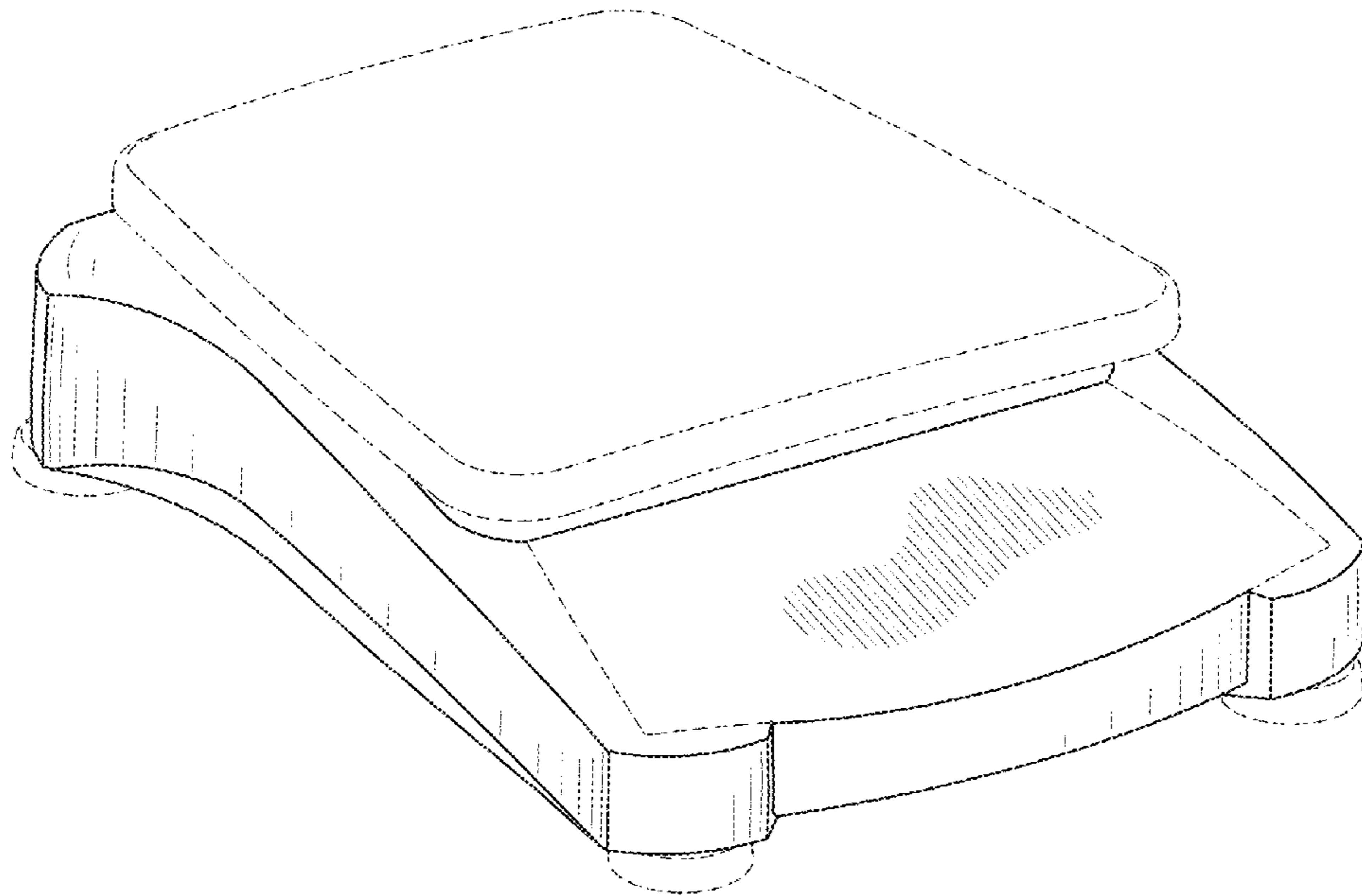

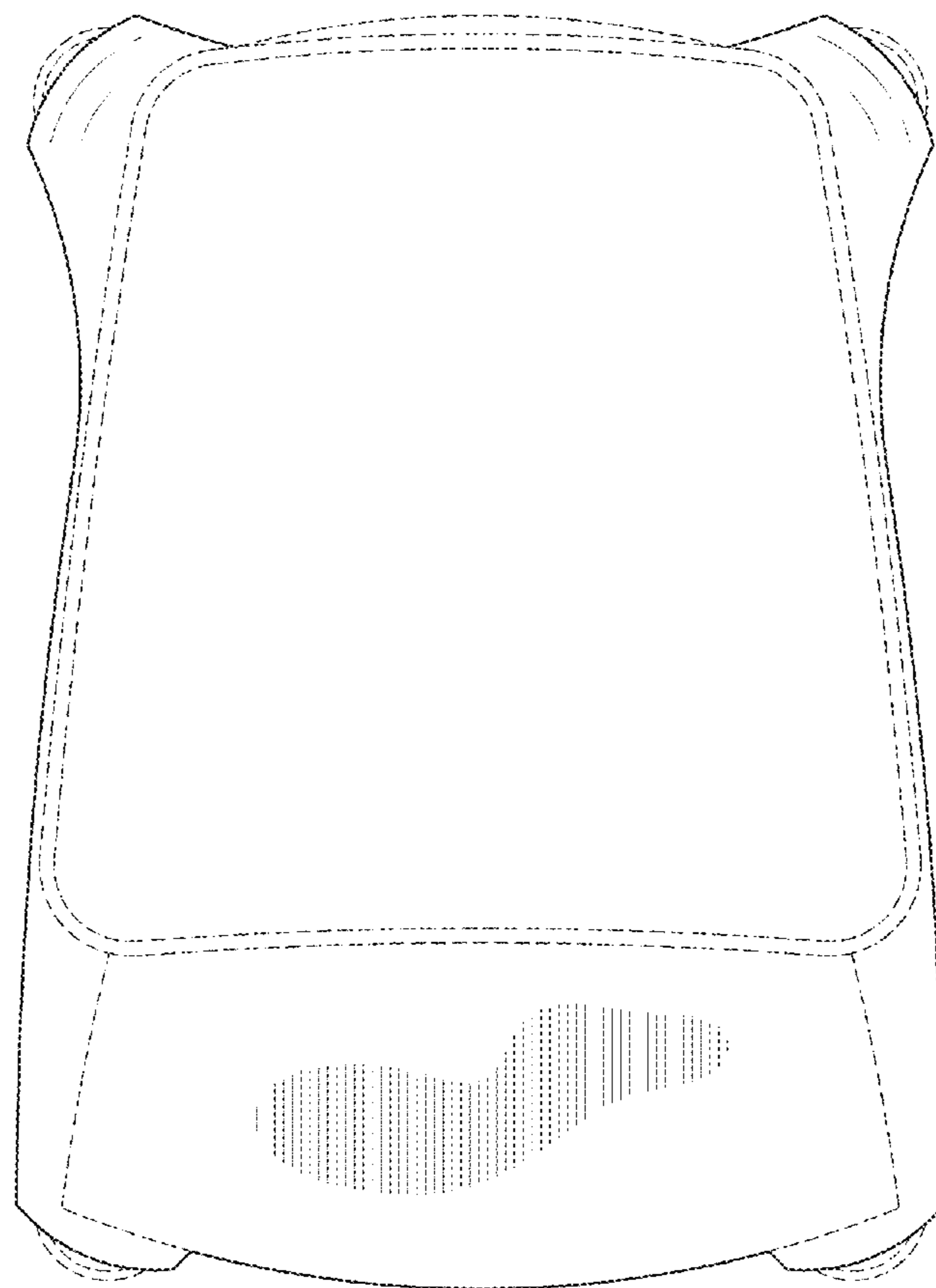

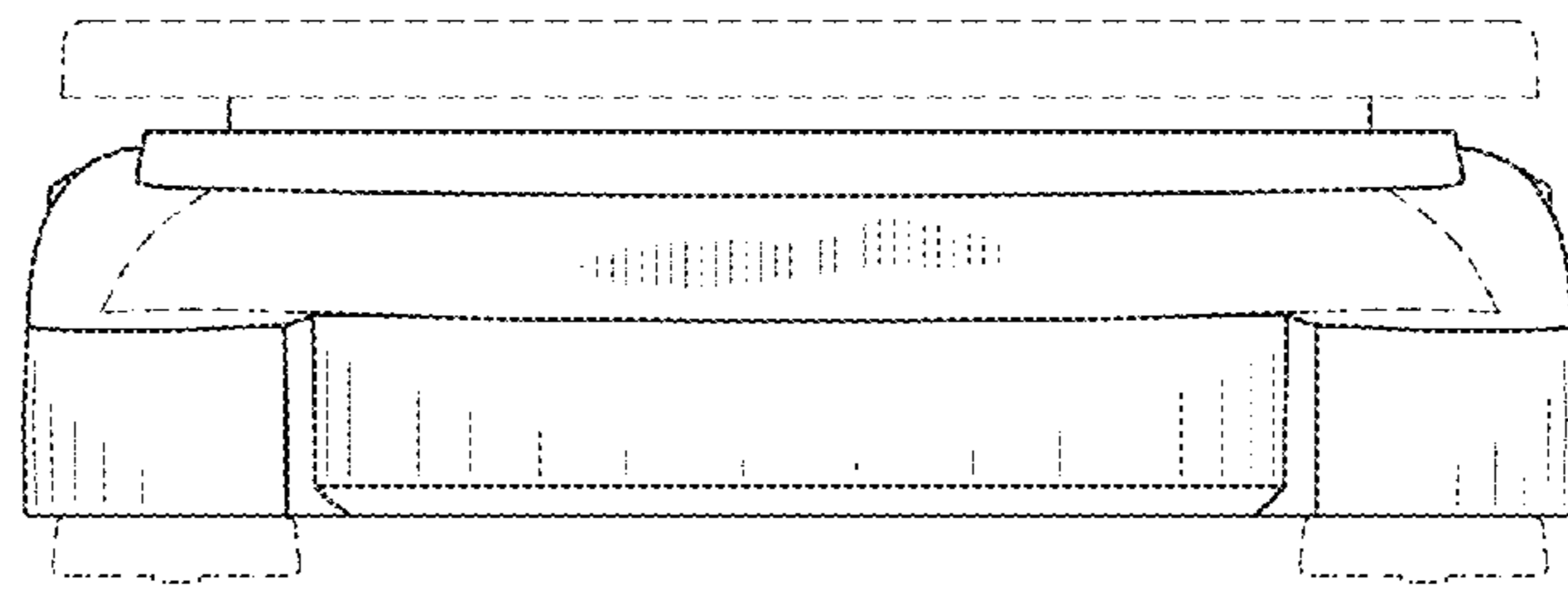

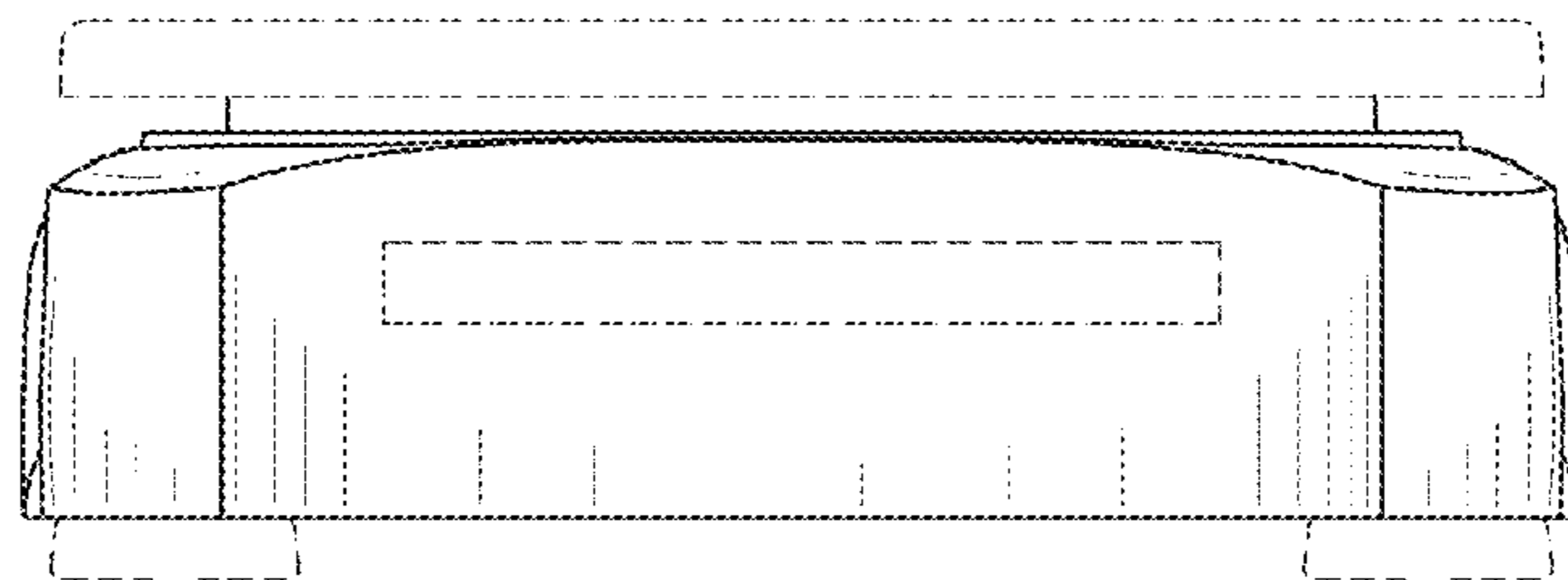

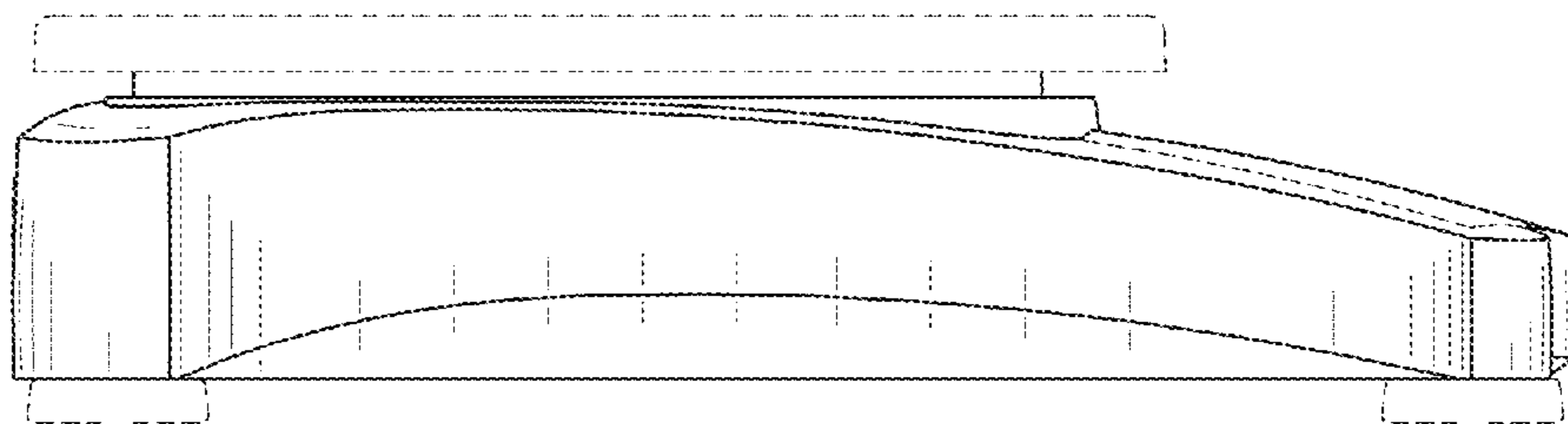

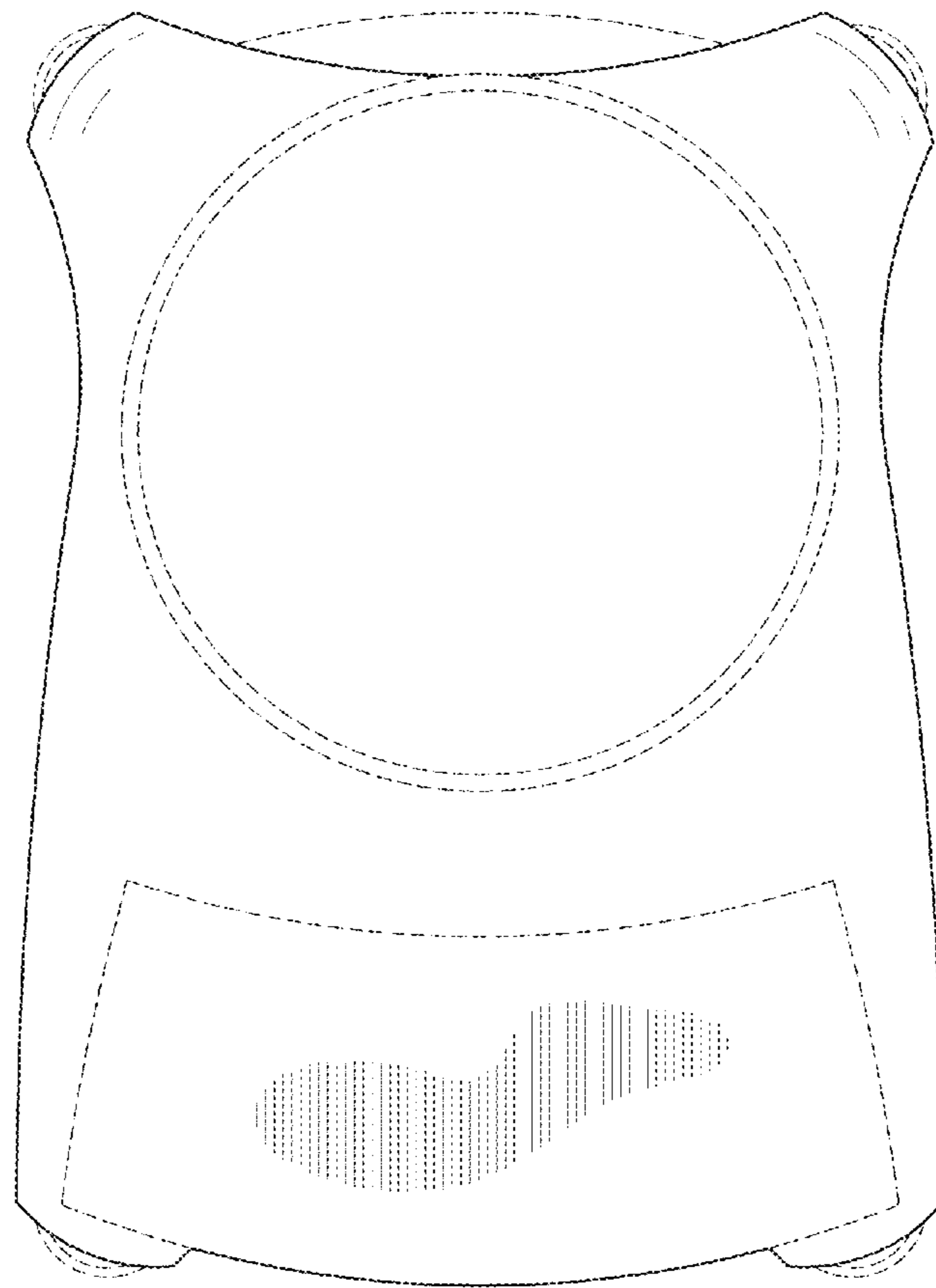

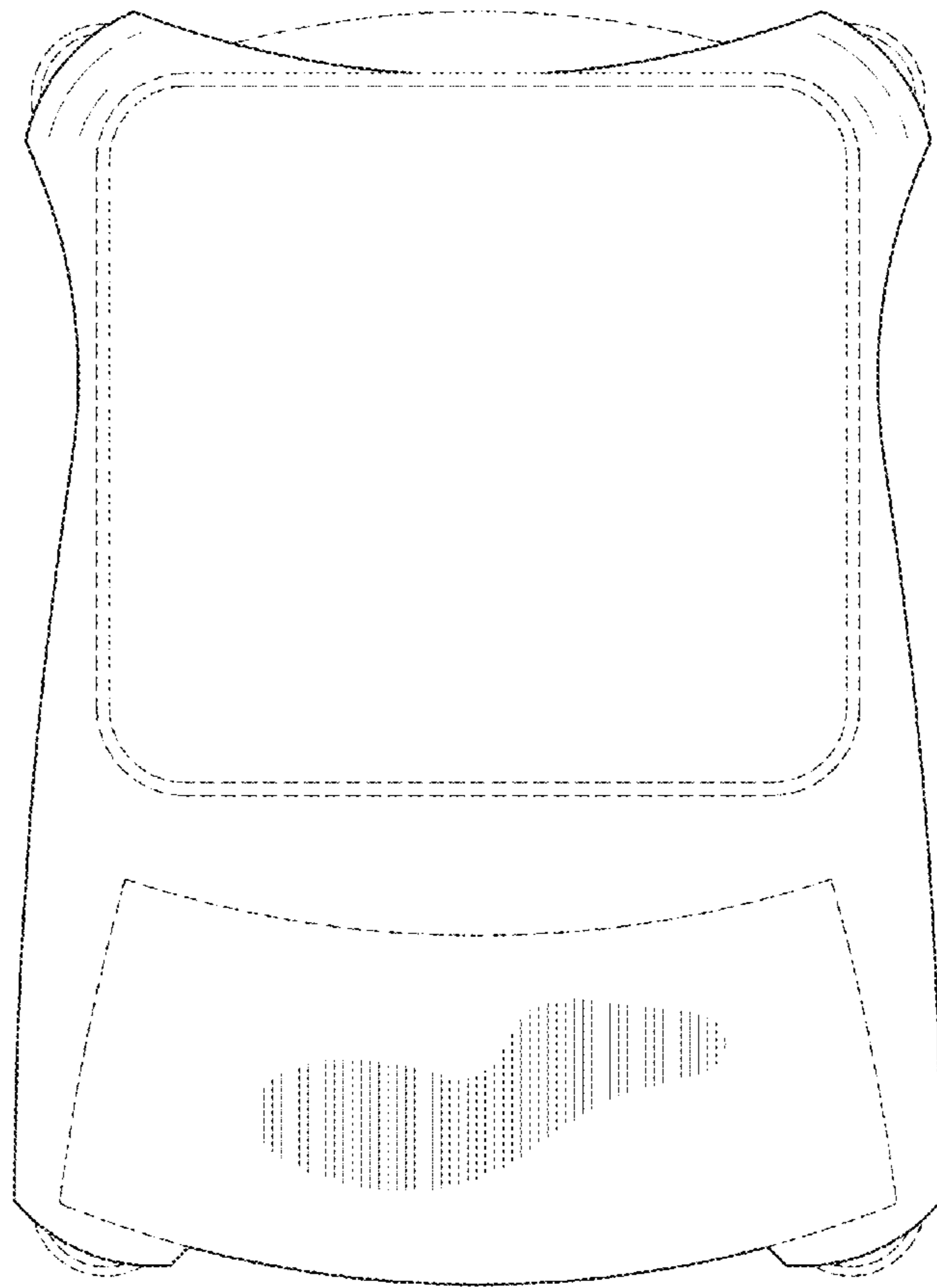

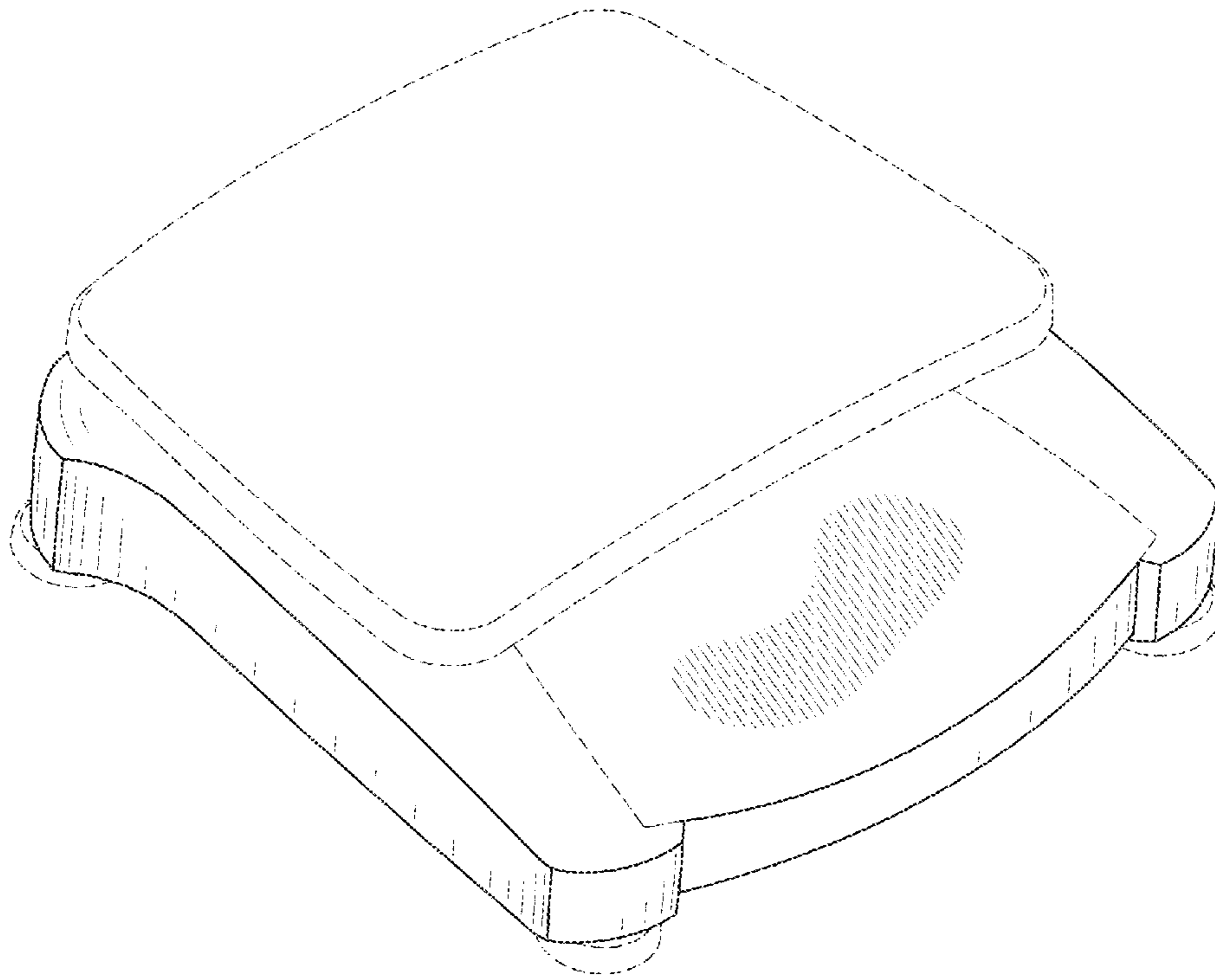

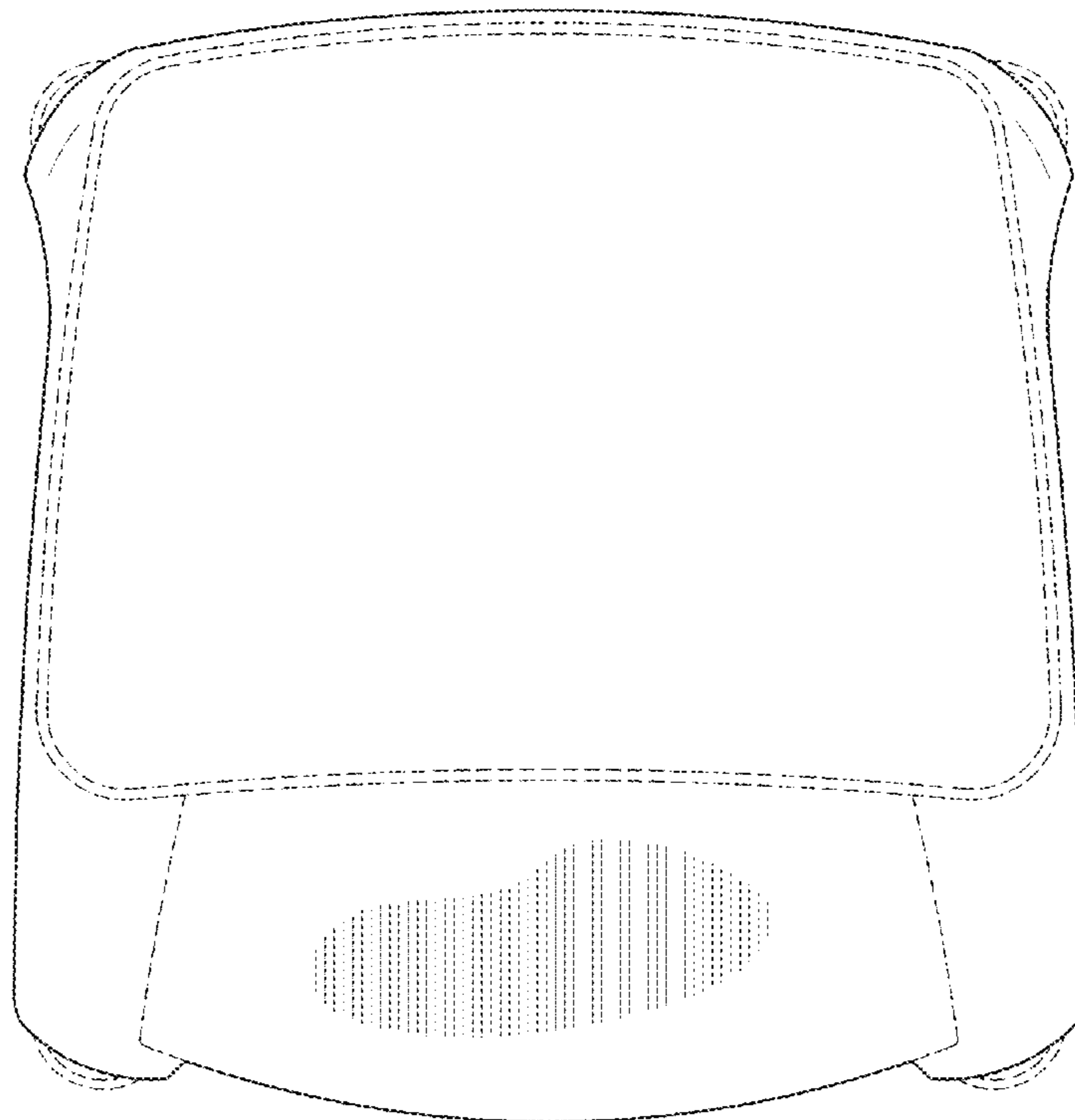

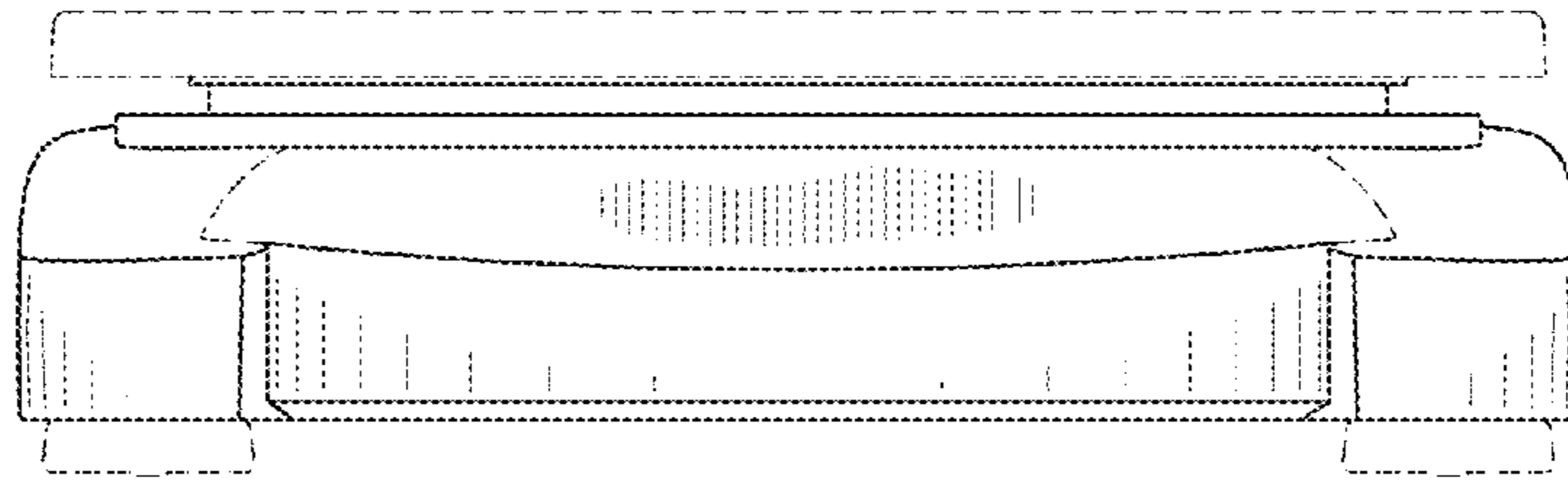

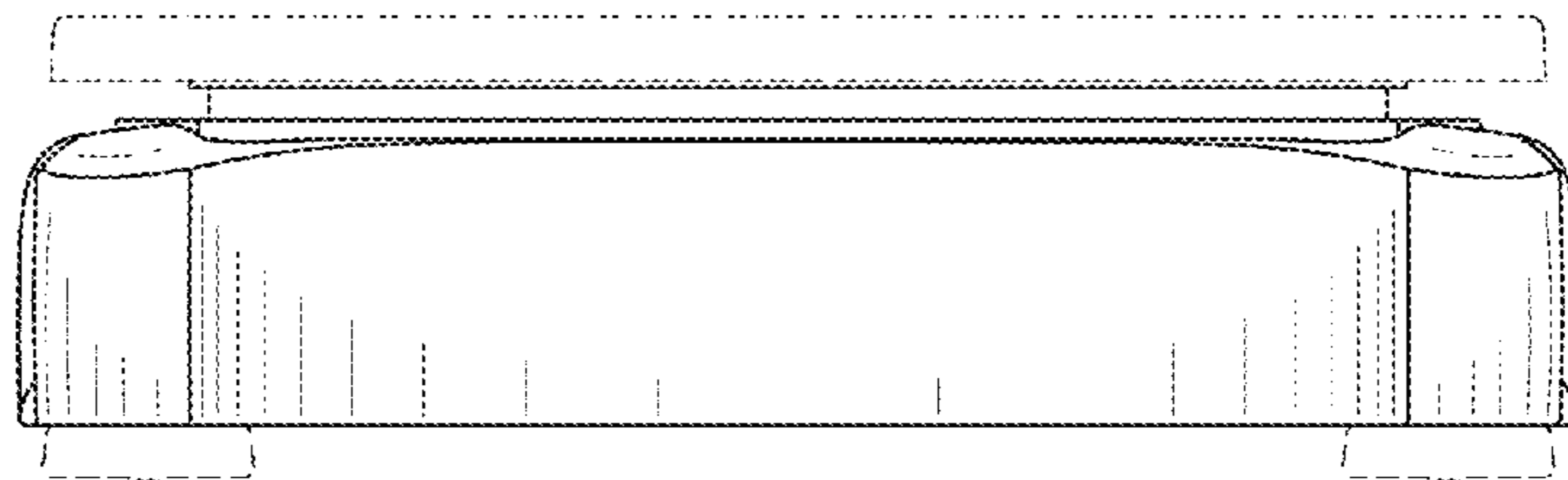

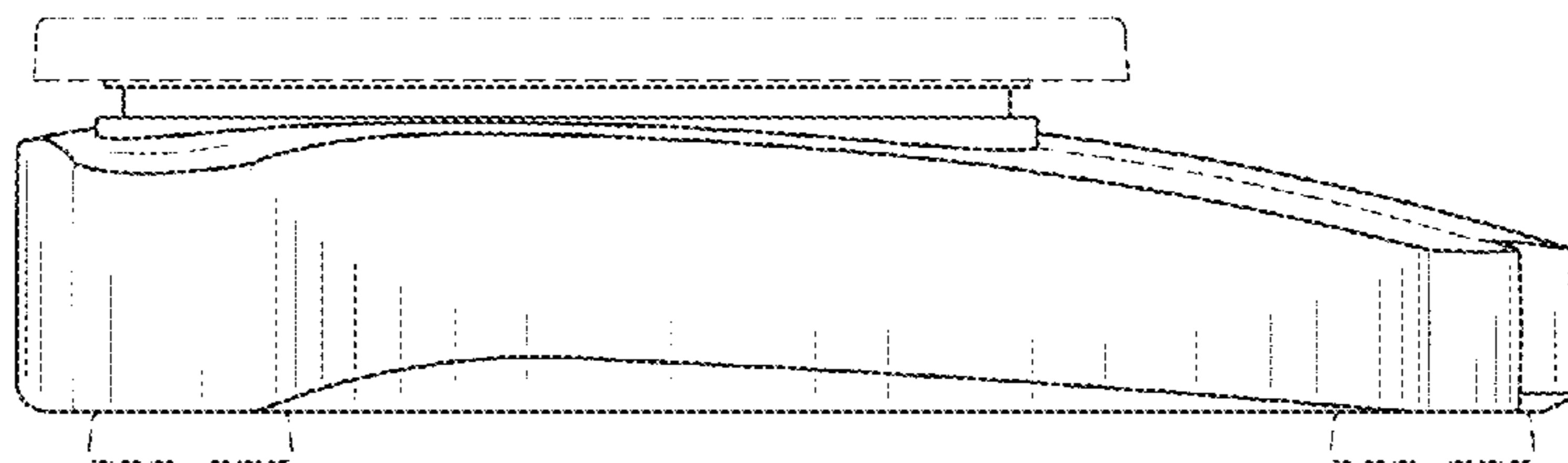

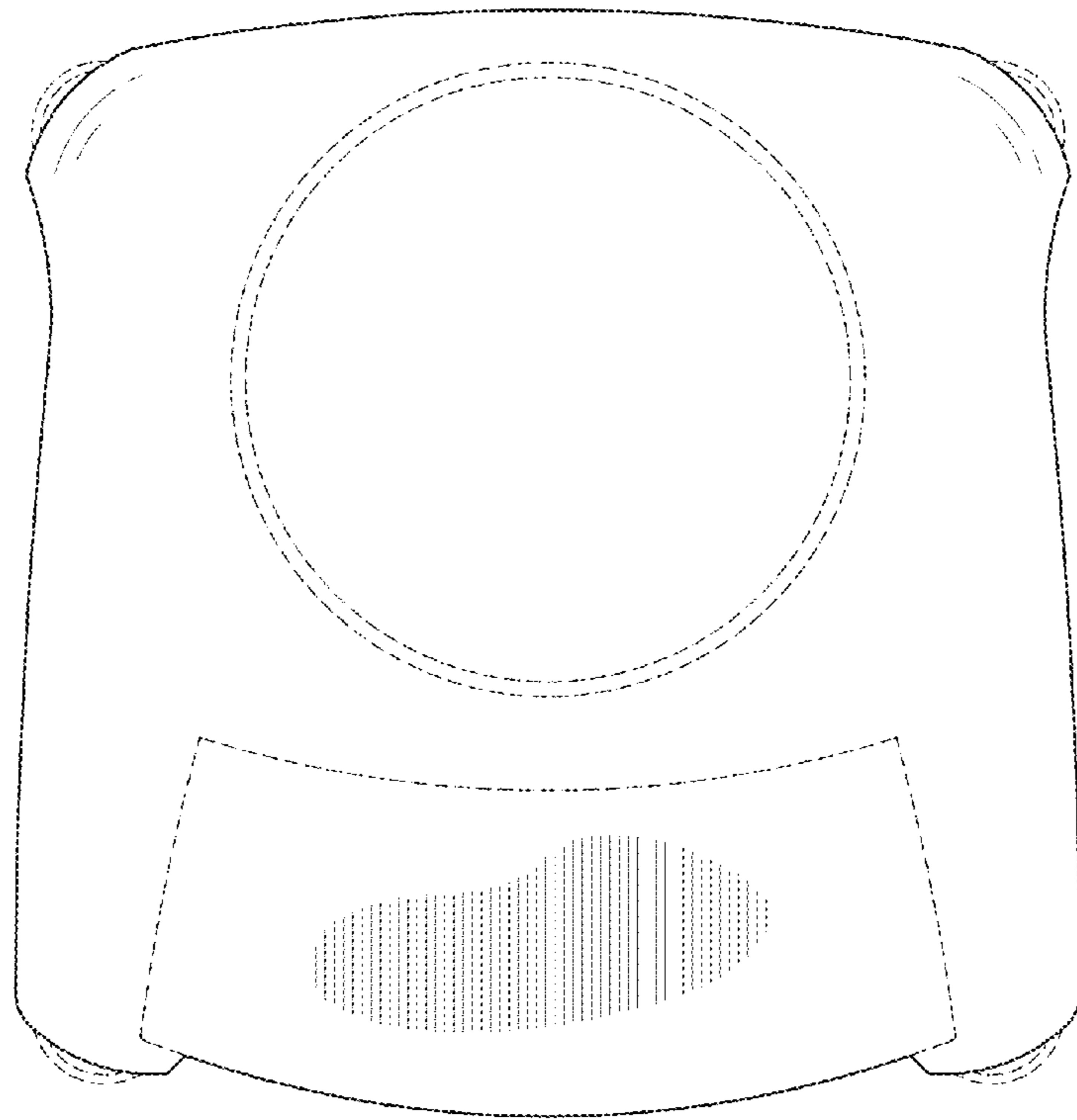

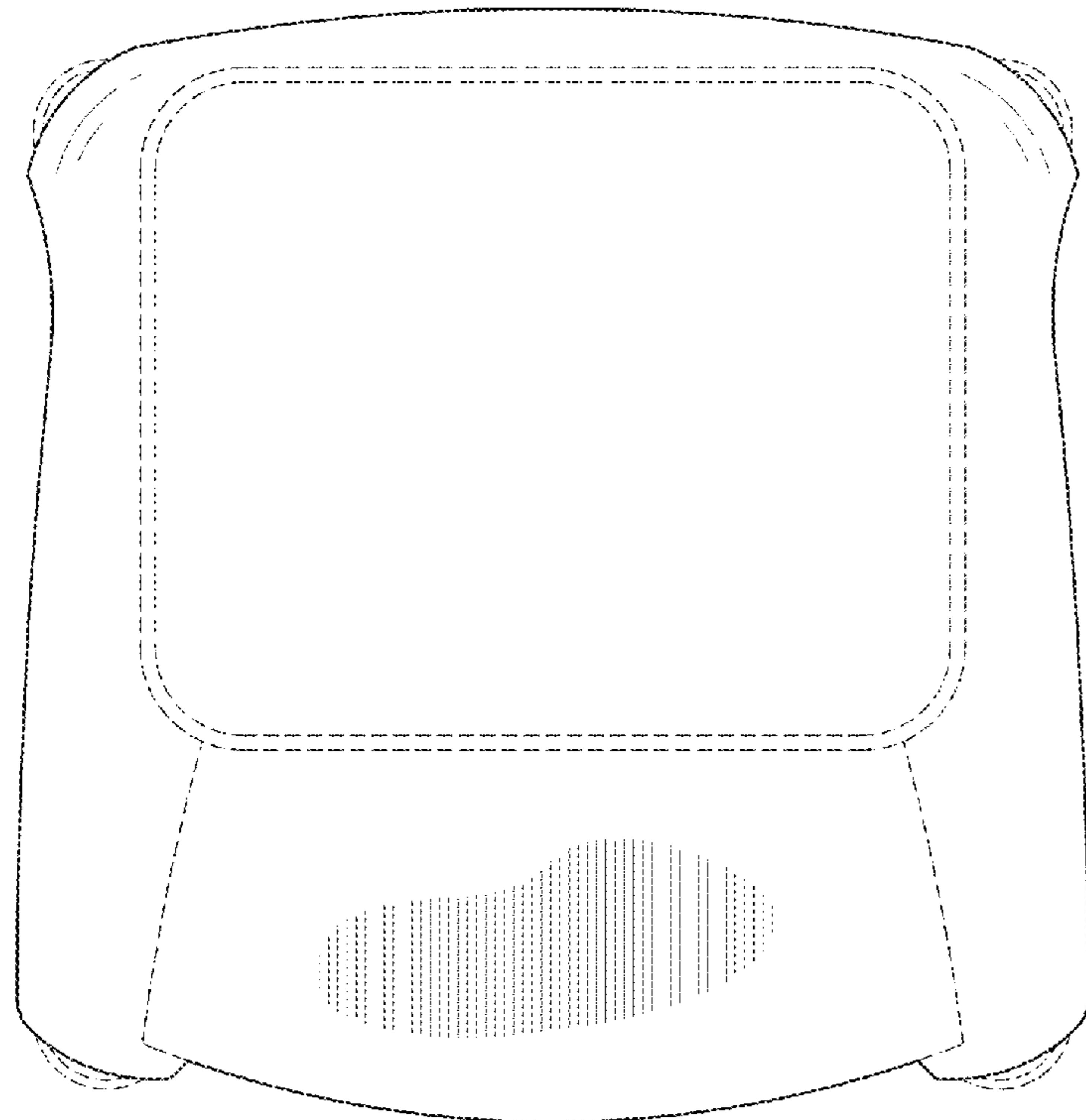
