FIG. 3 is a back elevation view thereof;

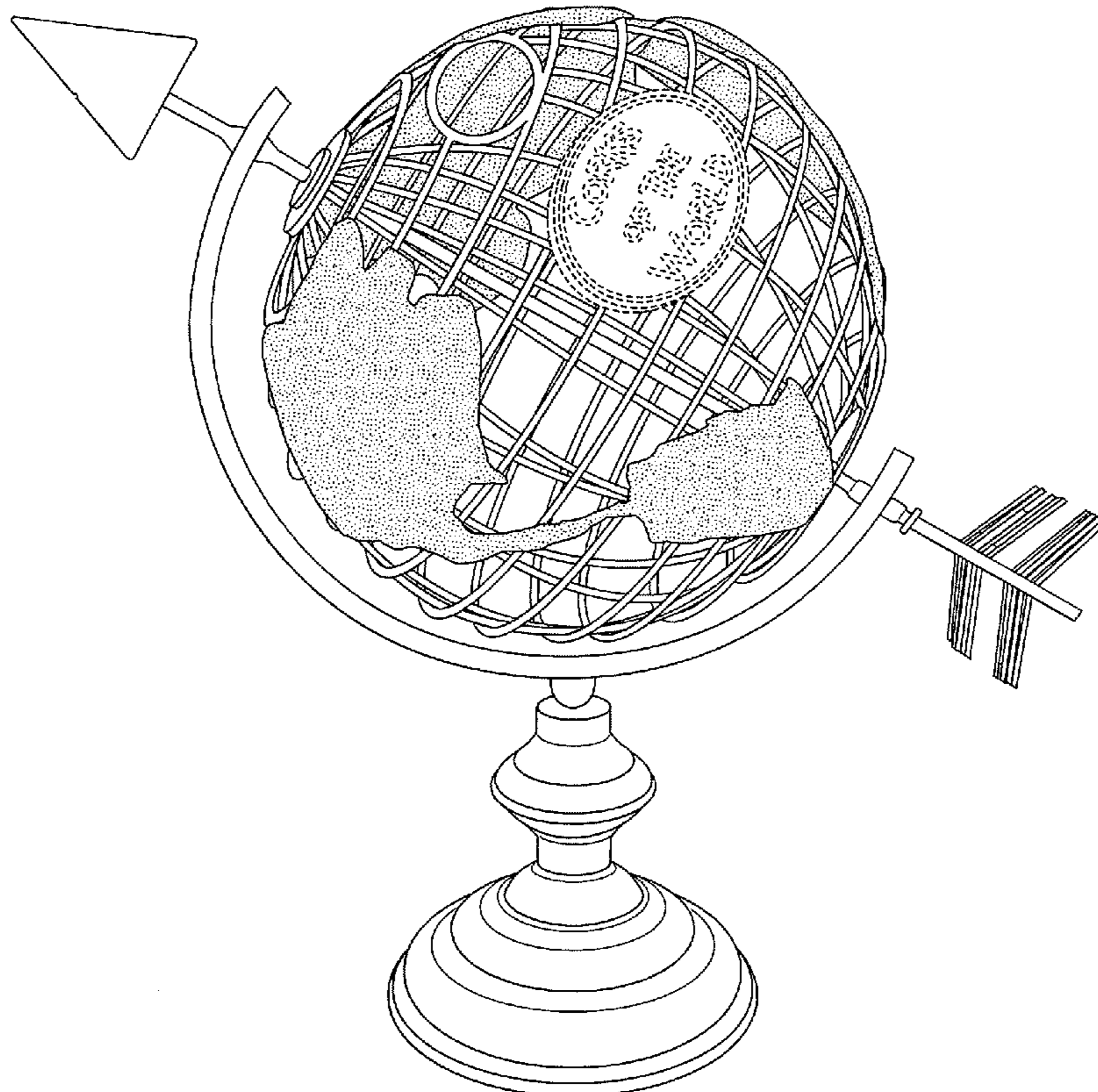
FIG. 4 is a right side elevation view thereof;

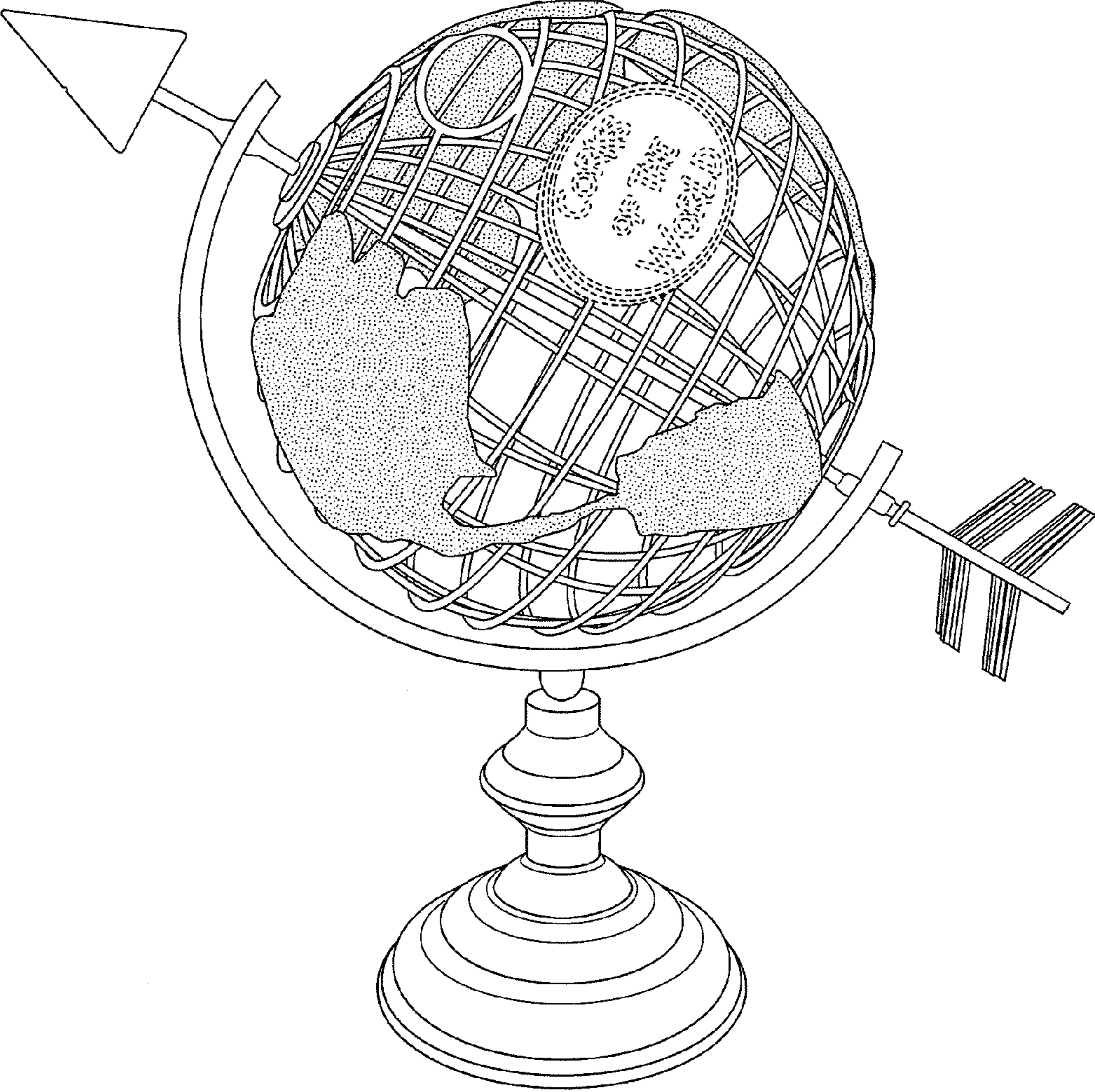
FIG. 5 is a left side elevation view thereof; and,

FIG. 6 is a top view thereof.

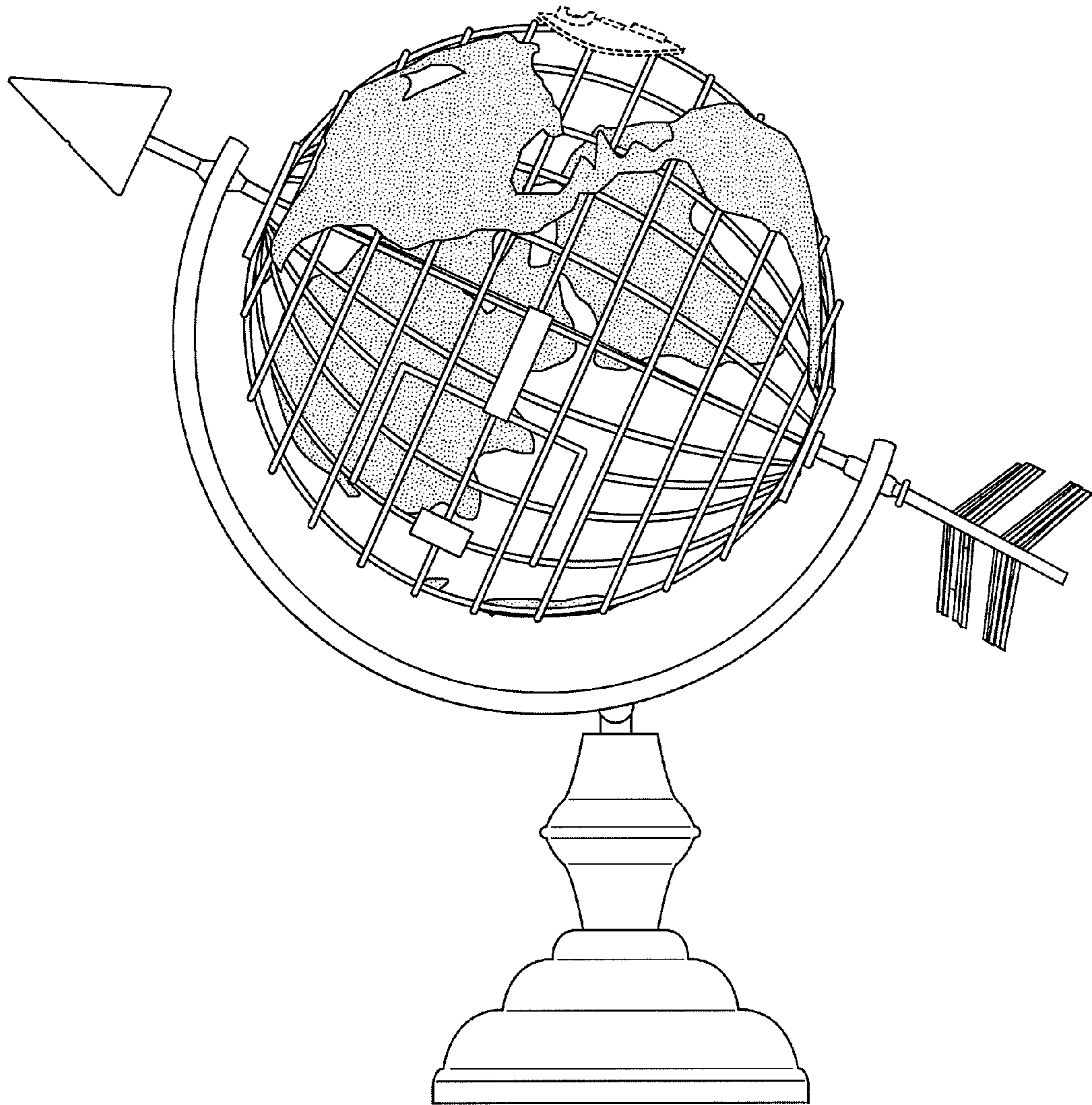
The broken line showing of the label and text on the globe cork cage forms no part of the claimed design.

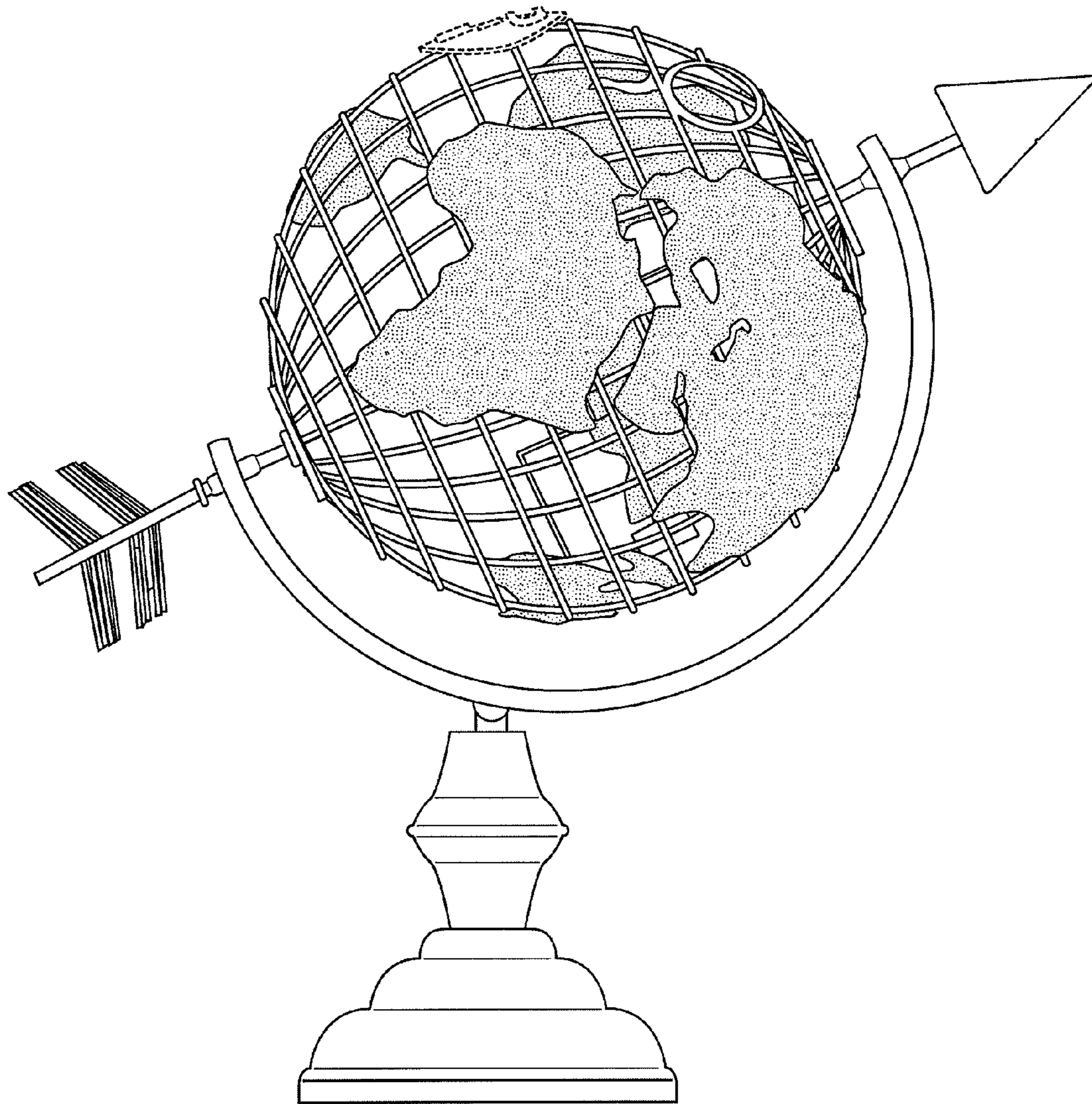




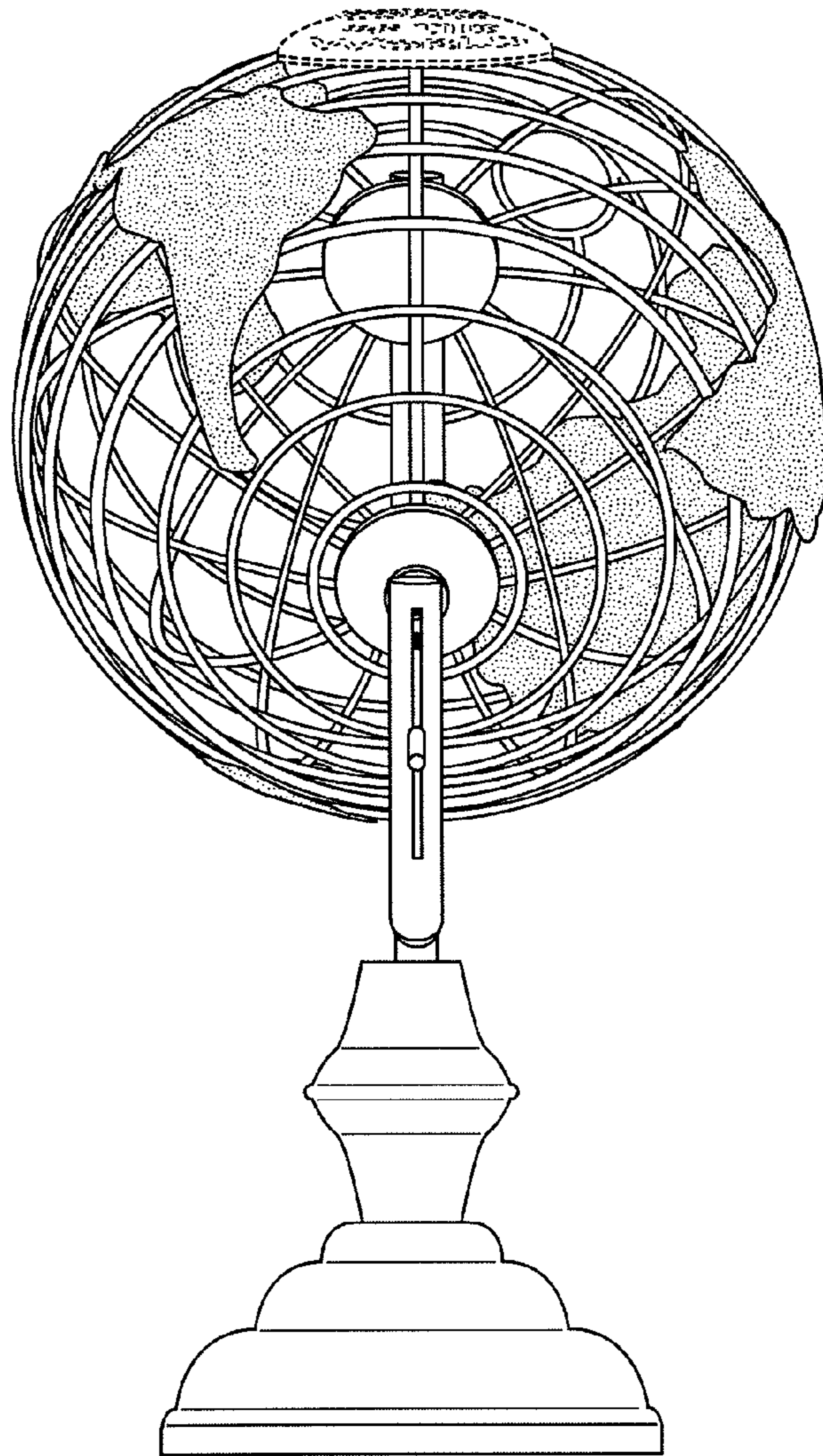

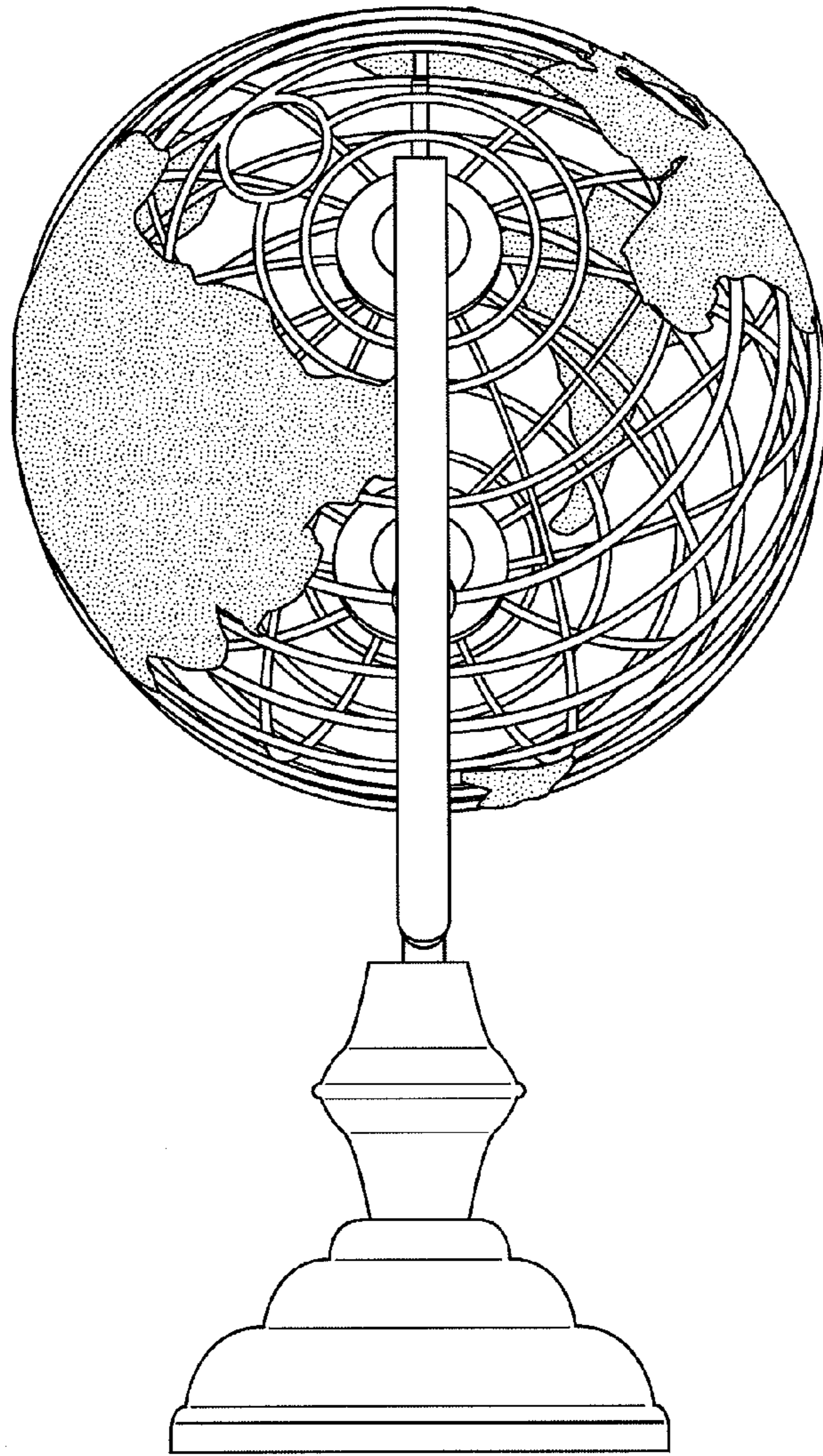

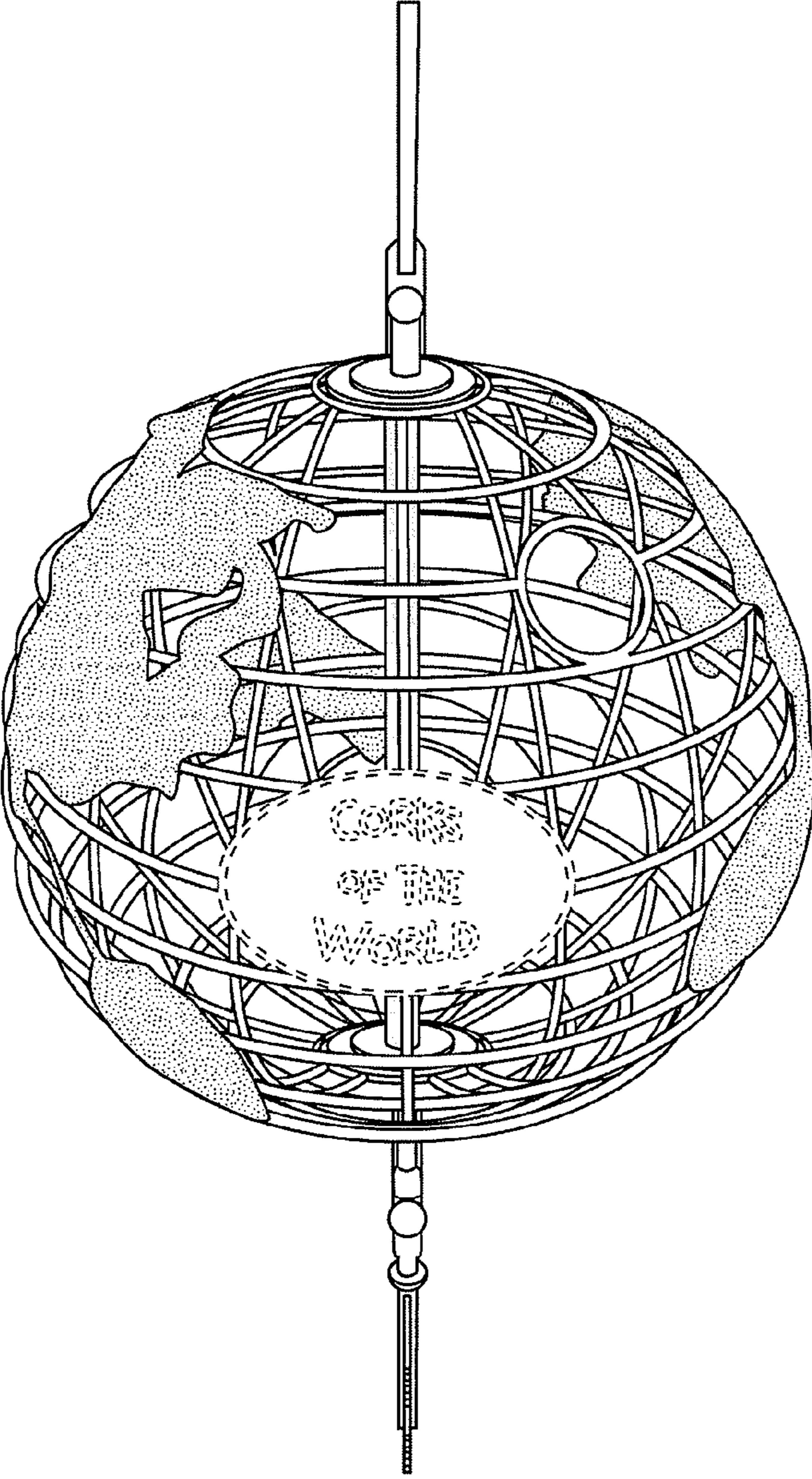
