The ornamental design for a rotational damper, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a rotational damper showing my new design;

FIG. 2 is rear view thereof;

FIG. 3 is left side view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view;

FIG. 7 is a cross-sectional view thereof taken along the line 7-7 in FIG. 5;

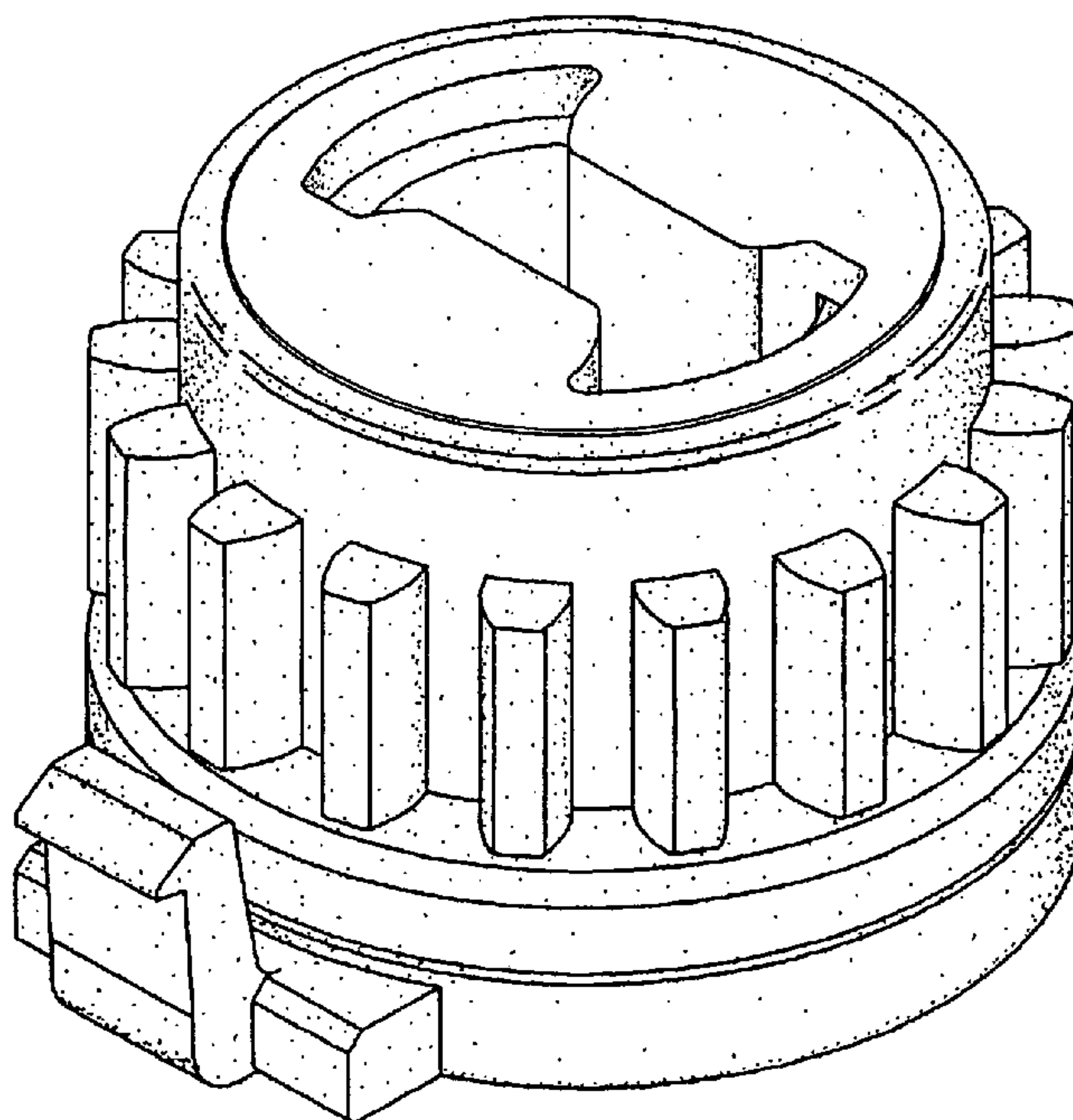

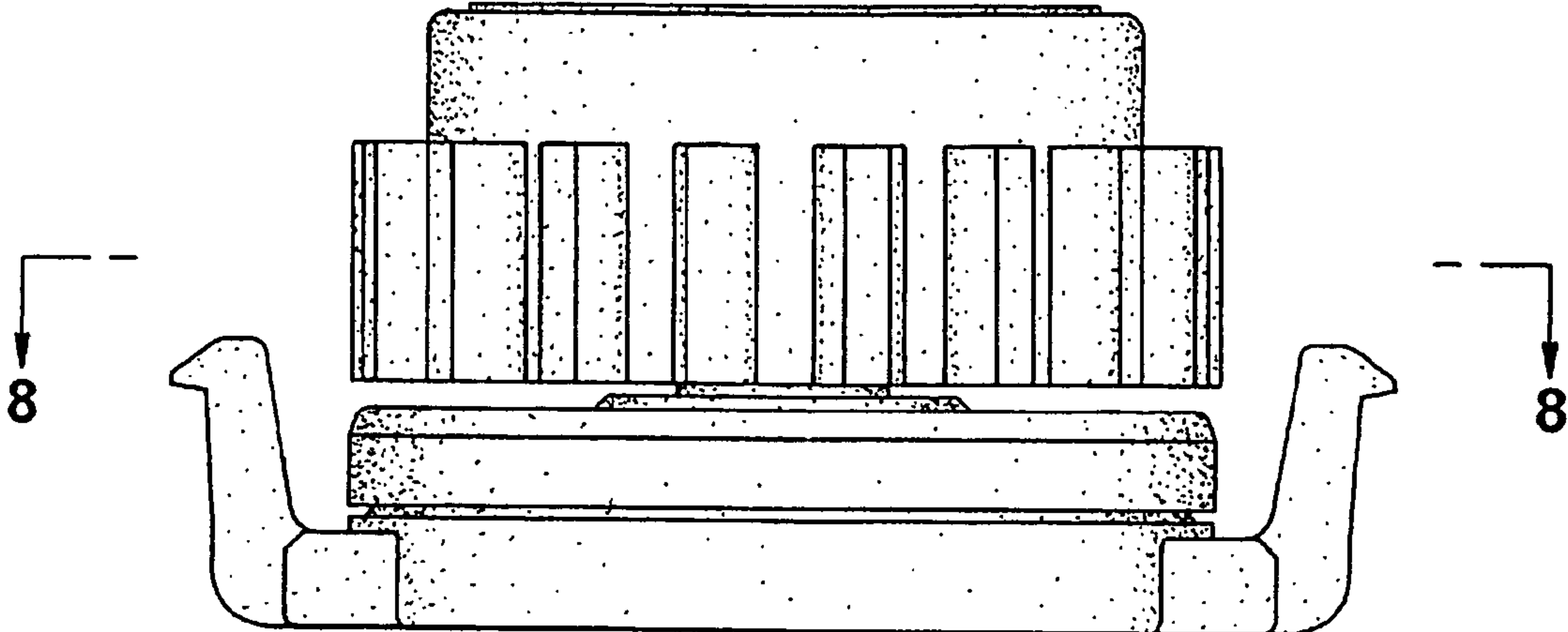

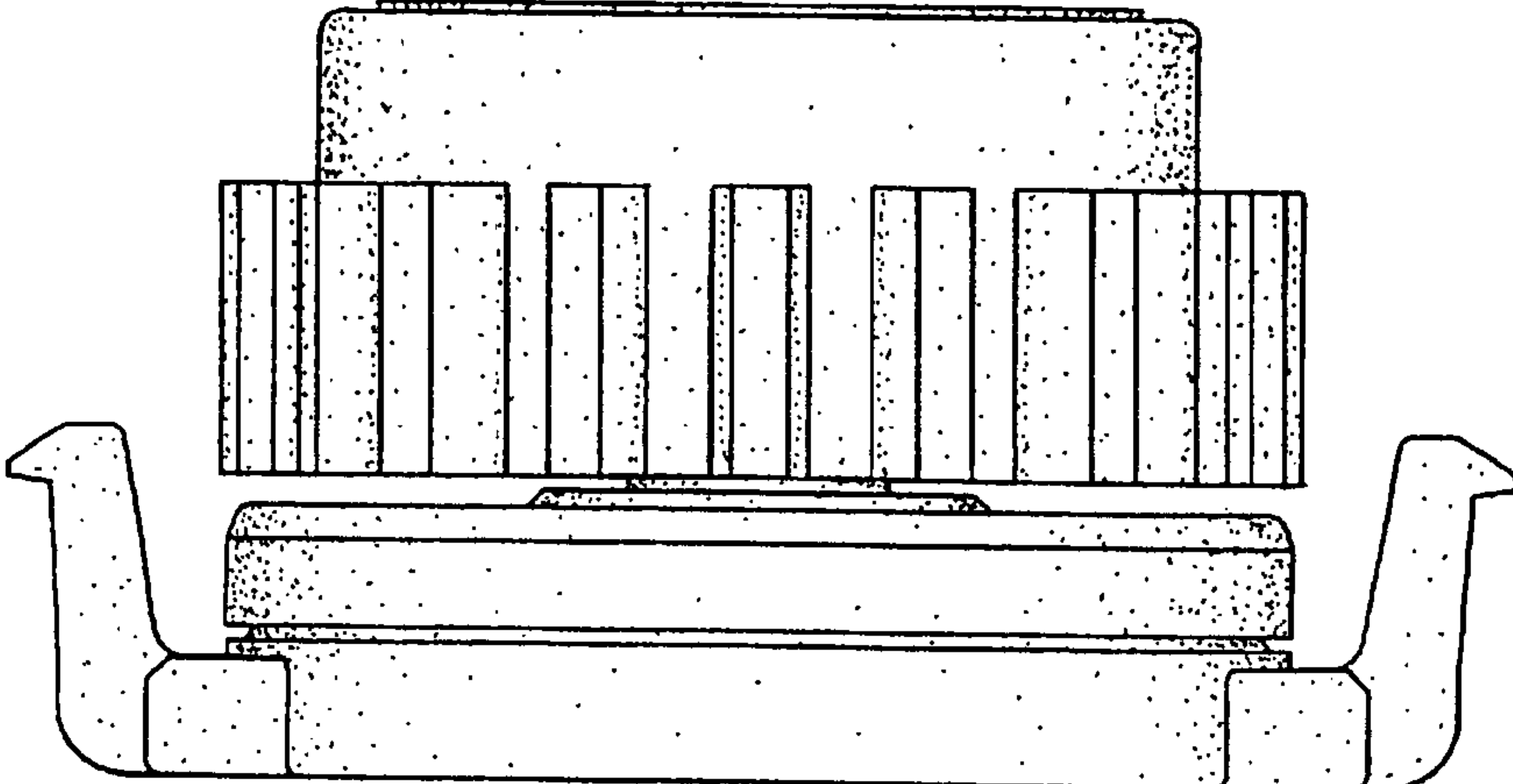

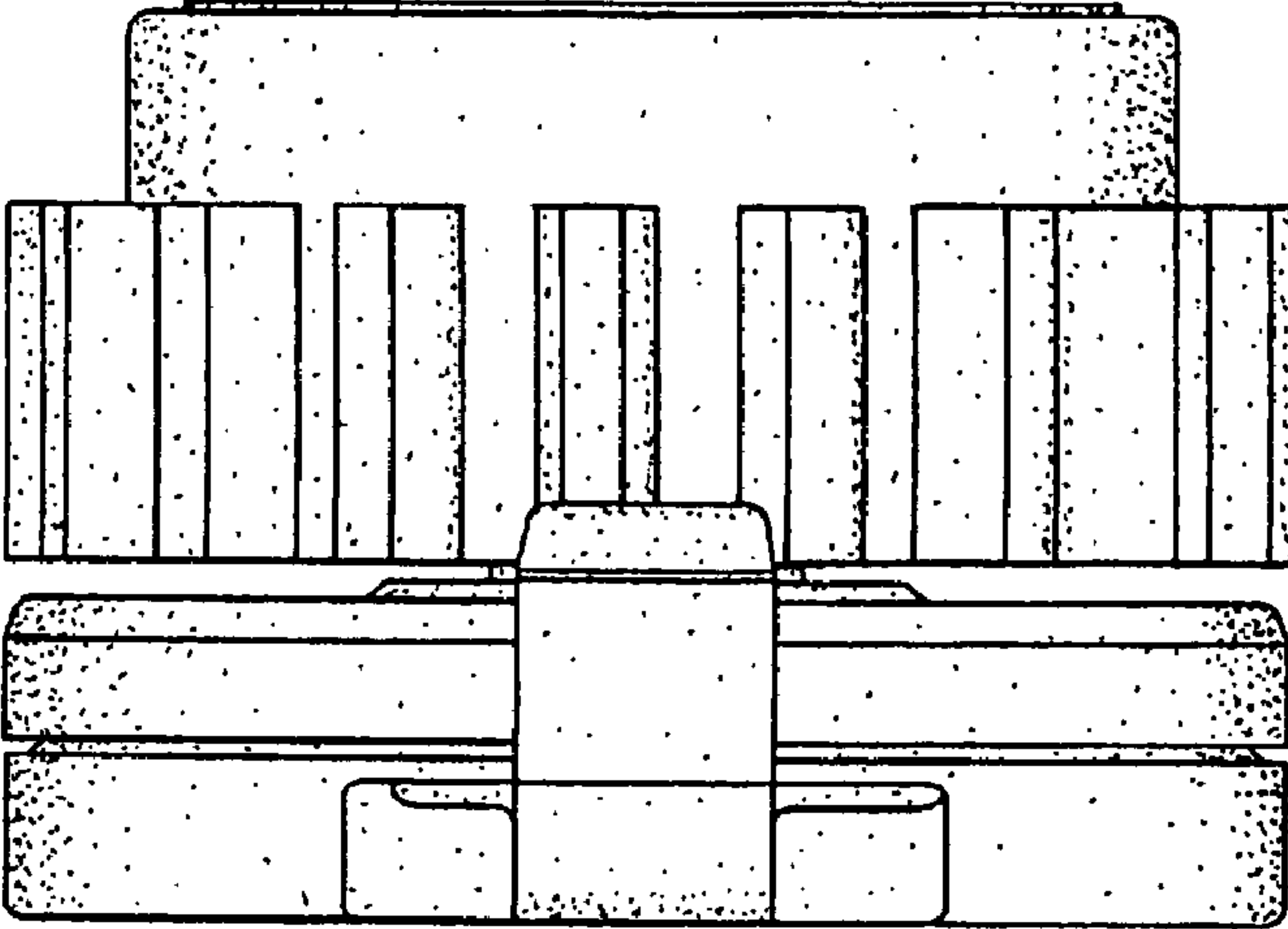

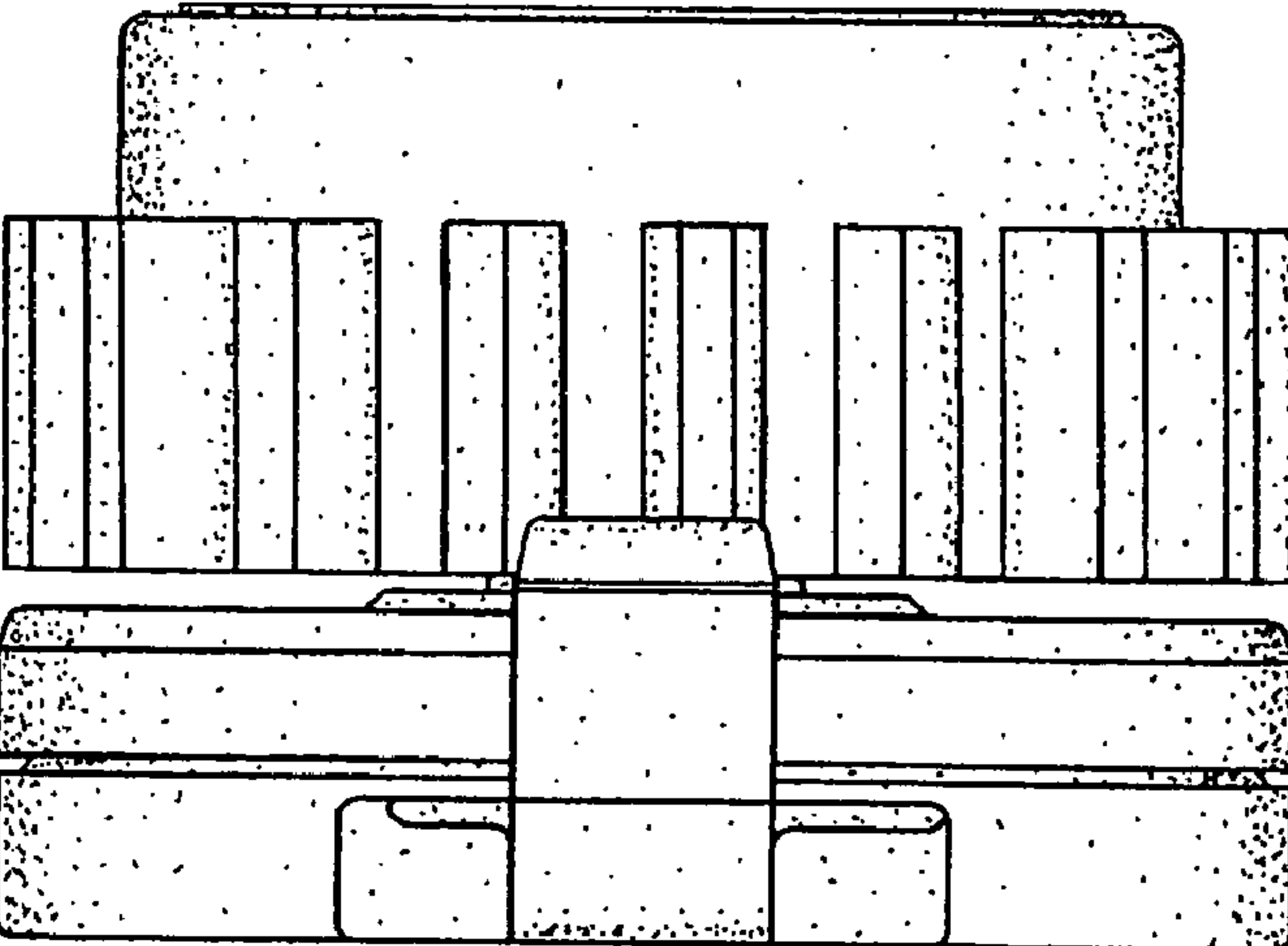

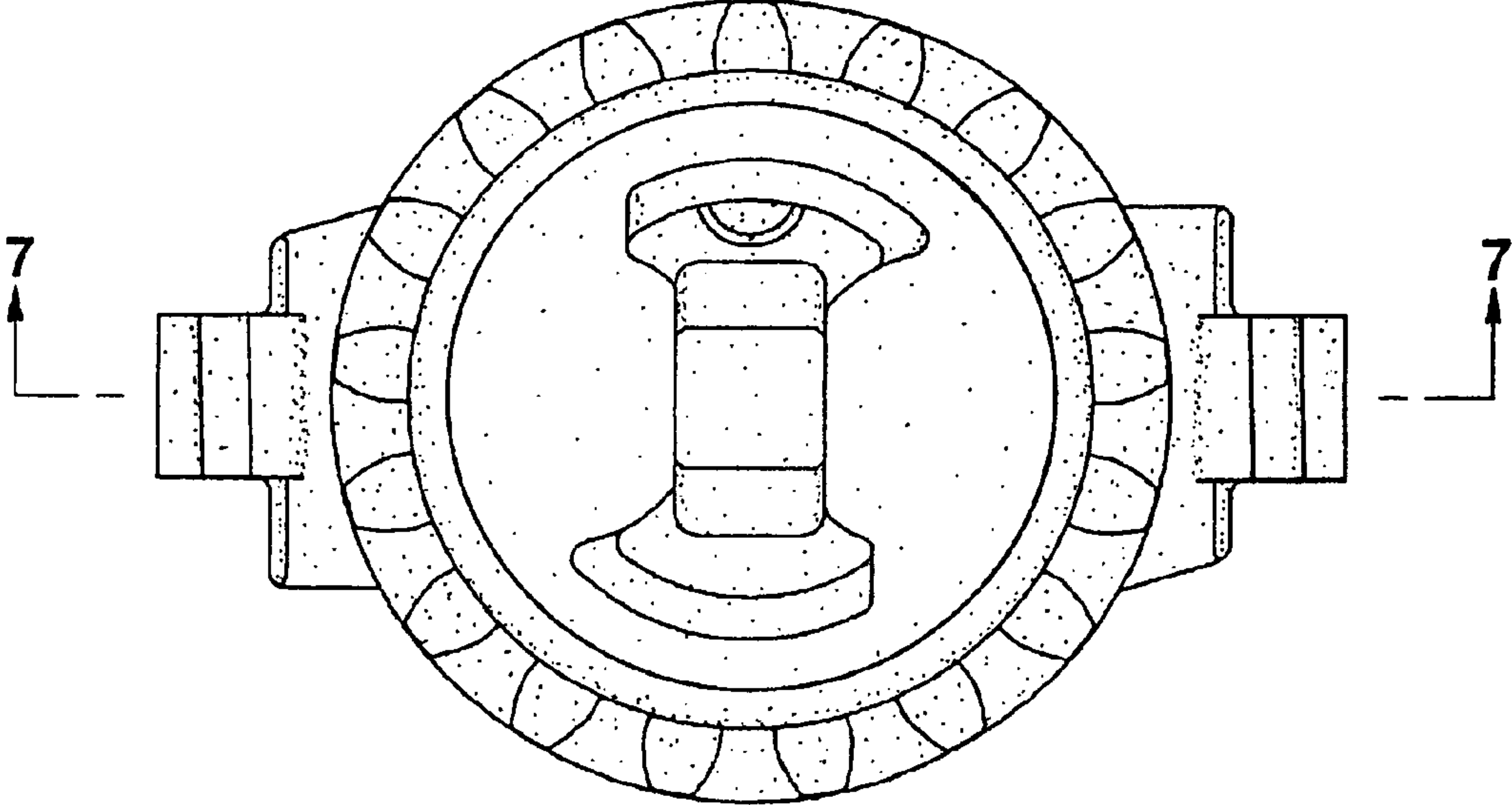

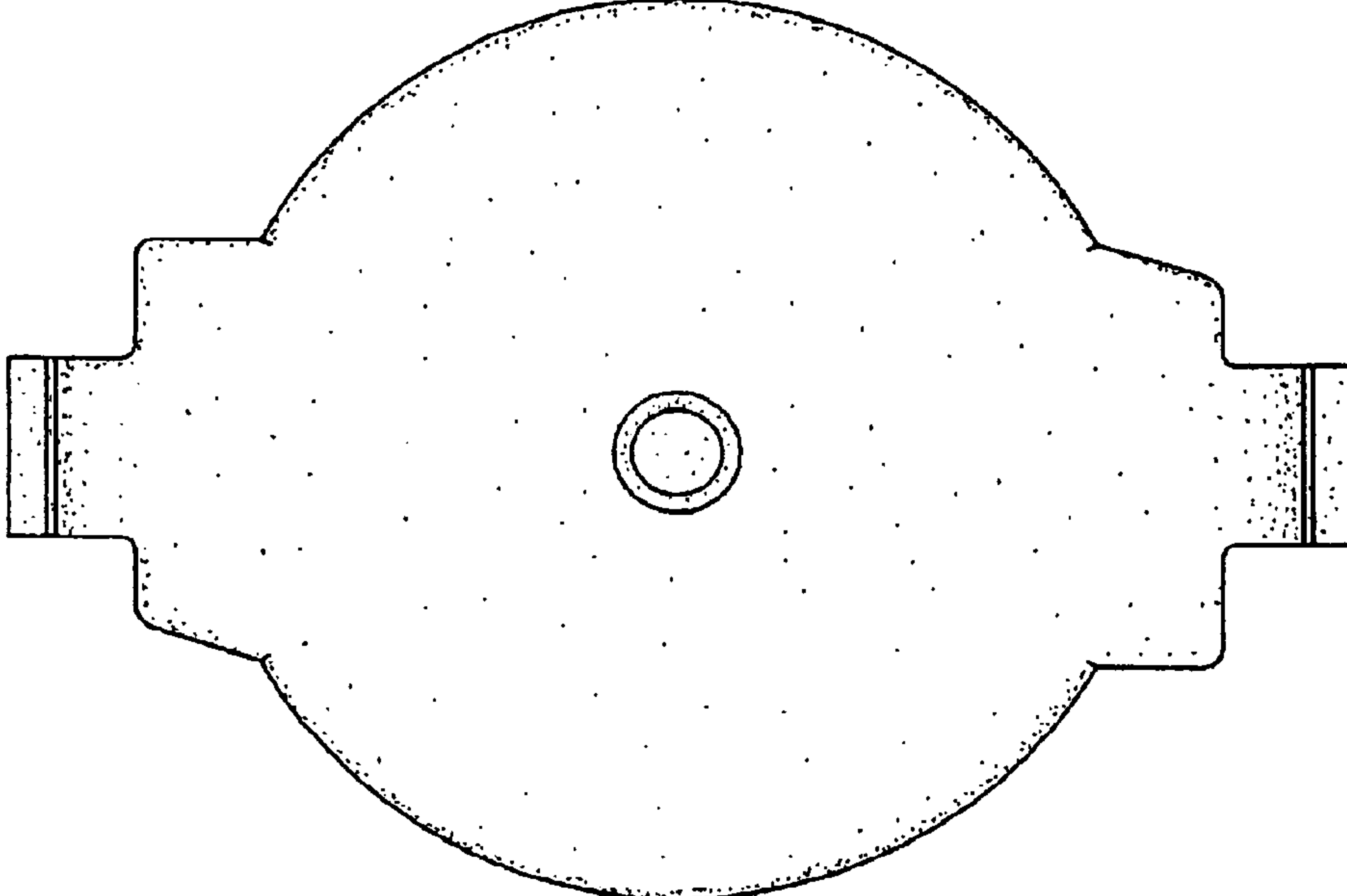

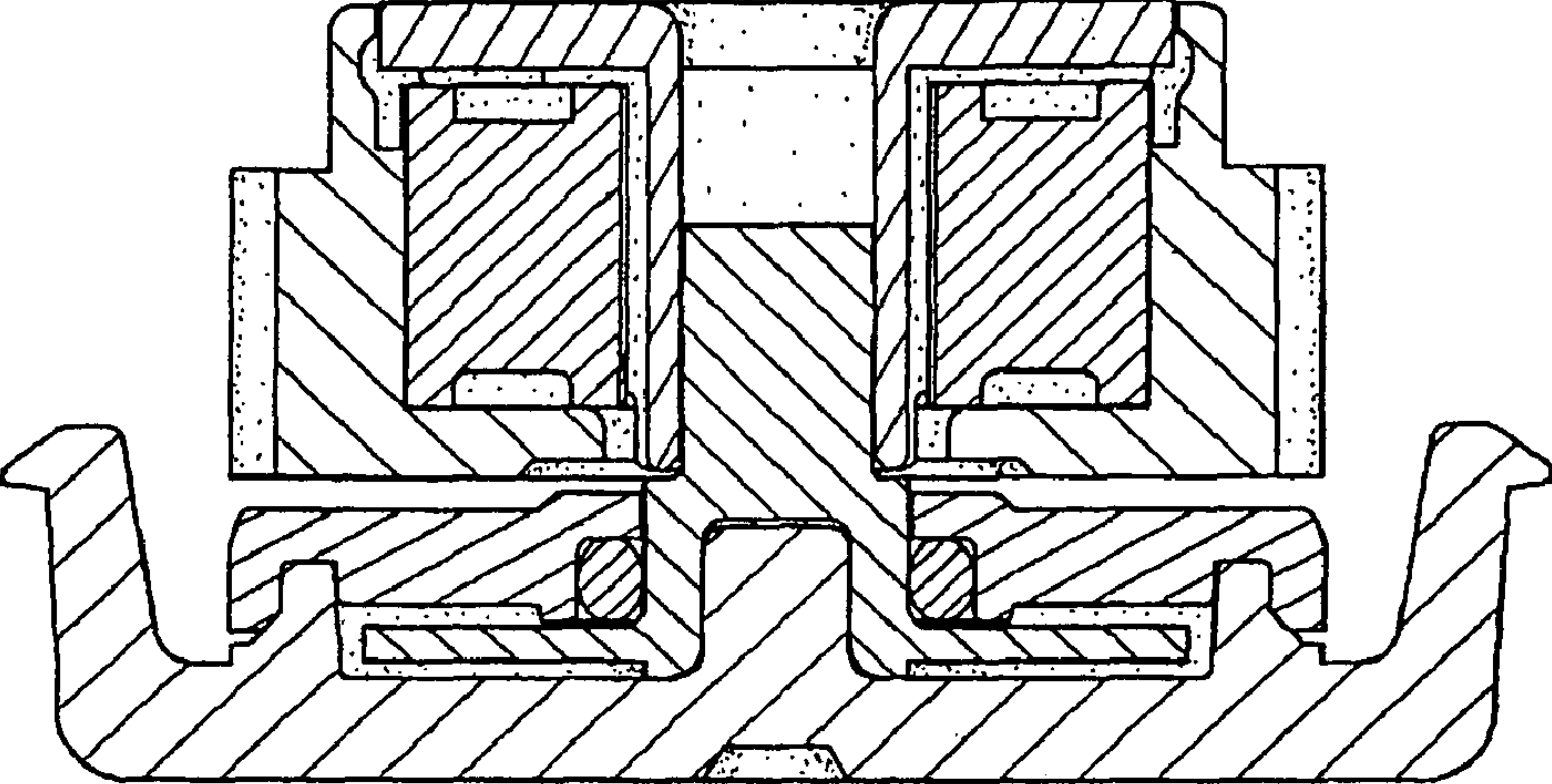

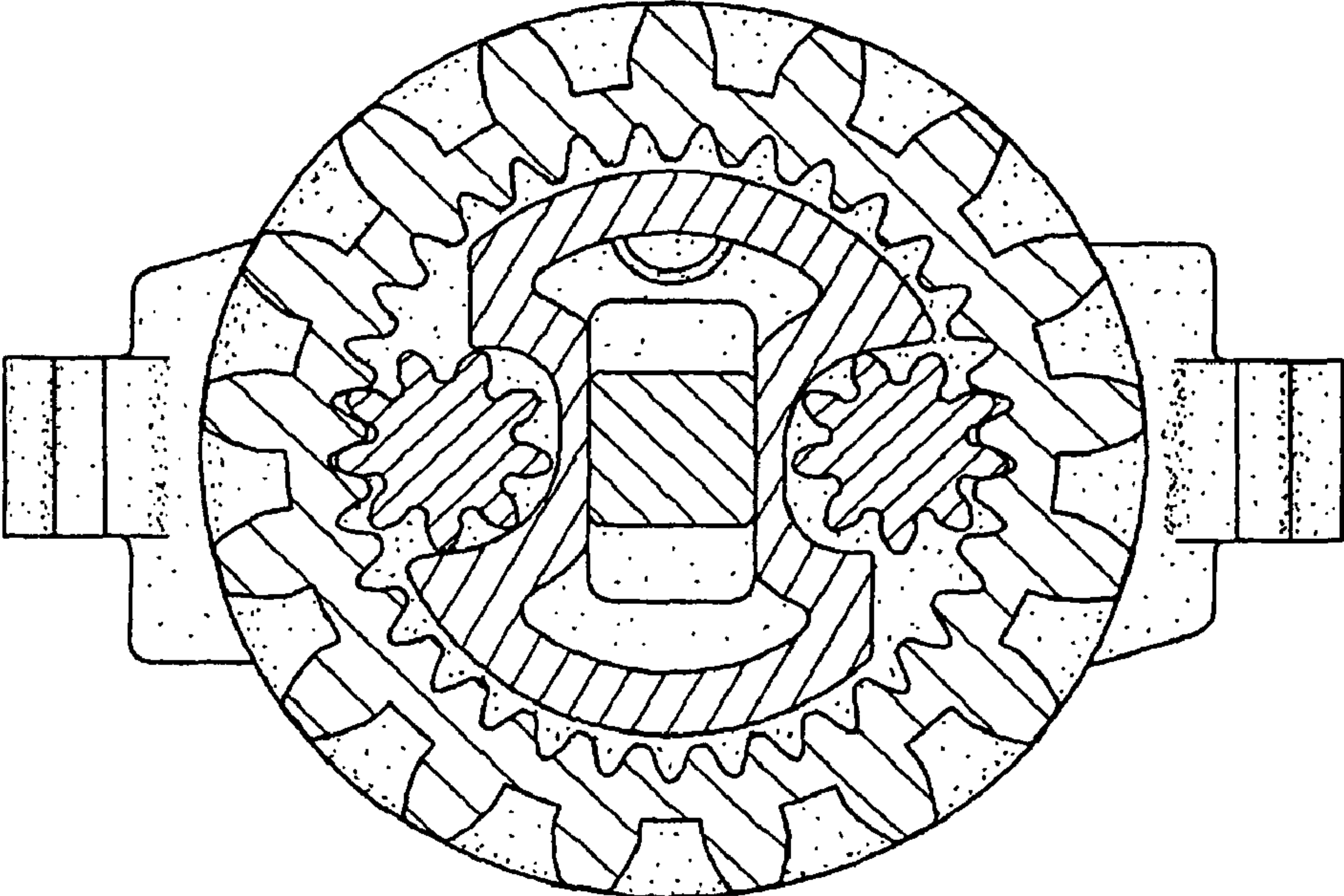
