(57) **CLAIM**

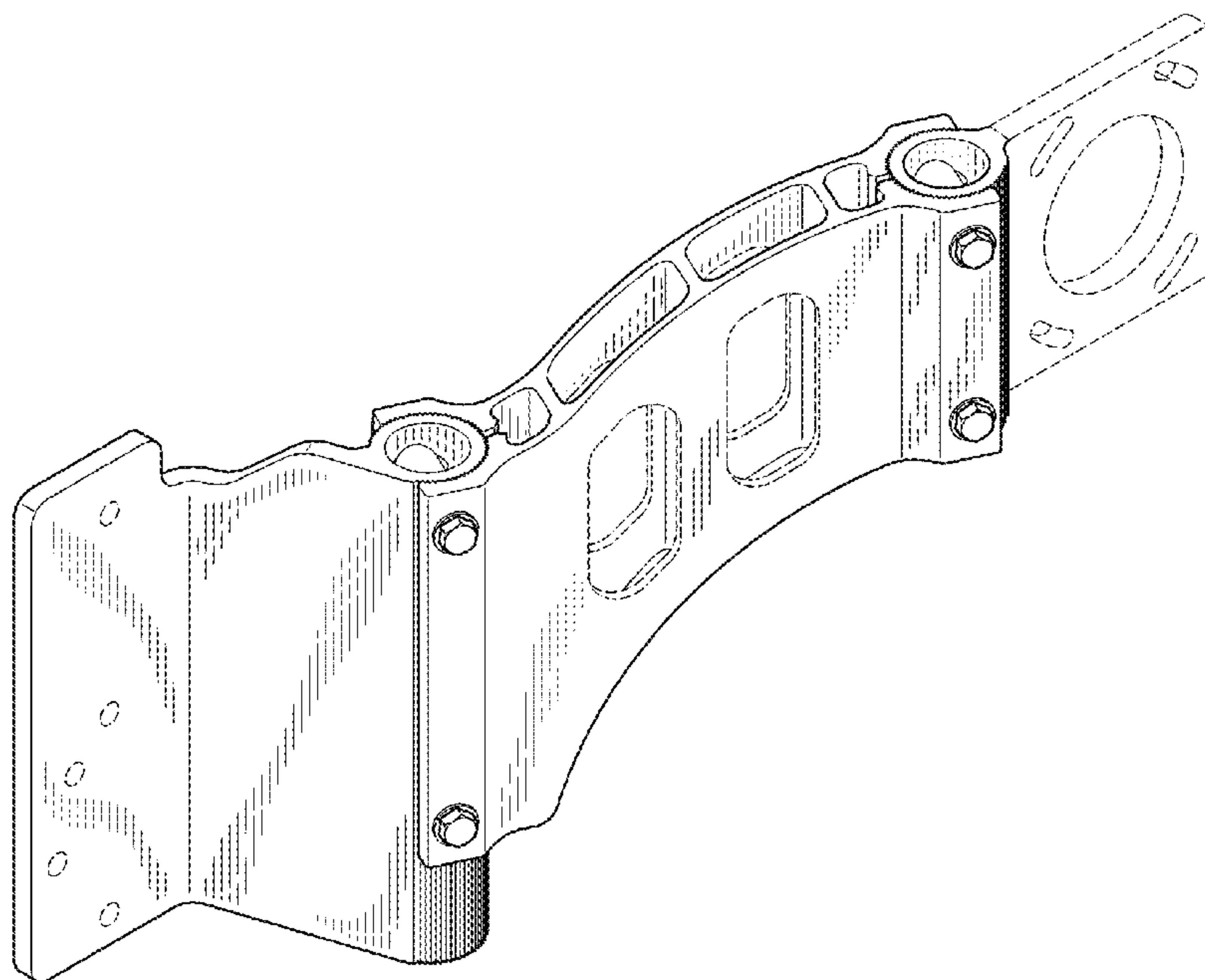
I claim the ornamental design for the mounting bracket for marine equipment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the mounting bracket for marine equipment;

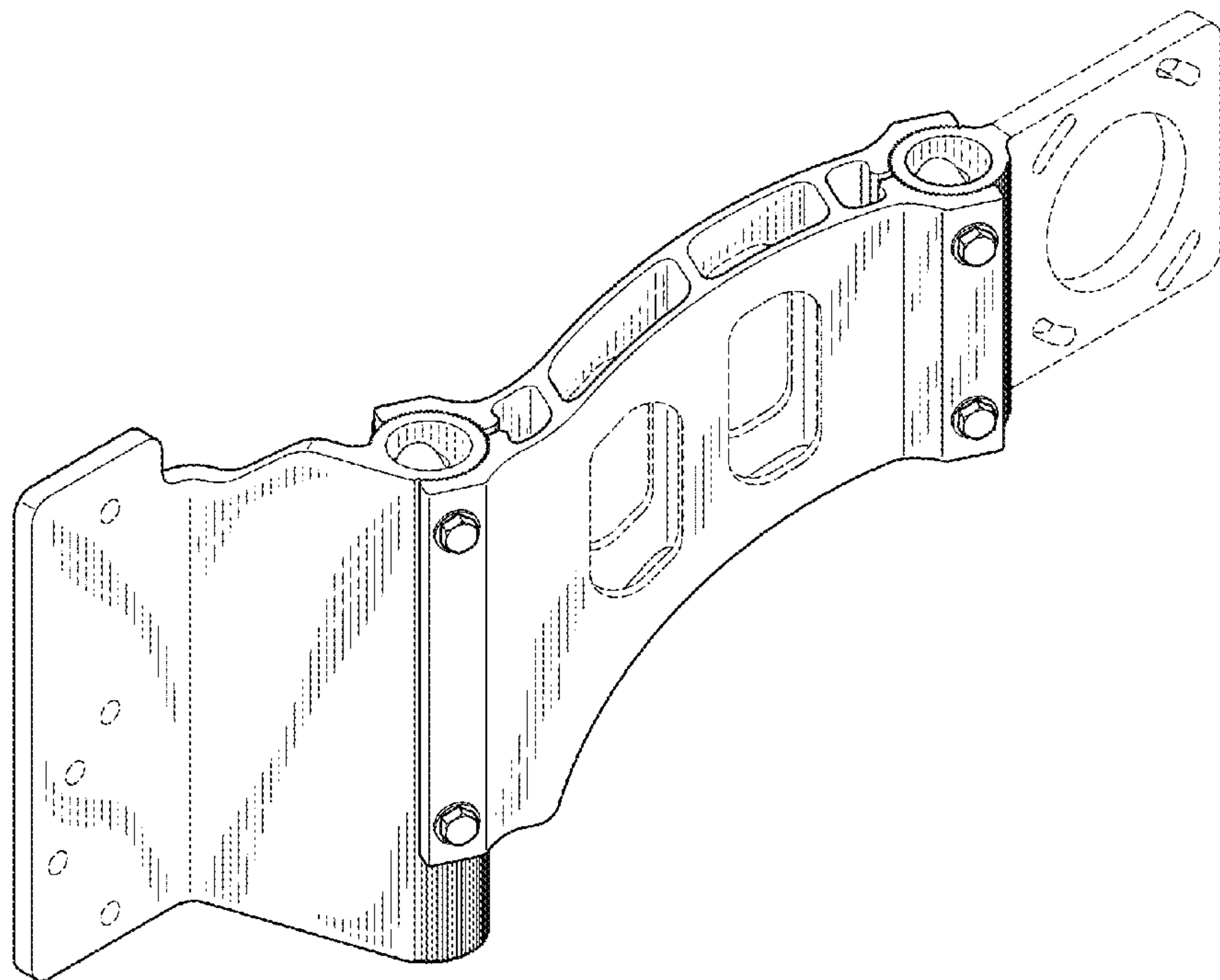

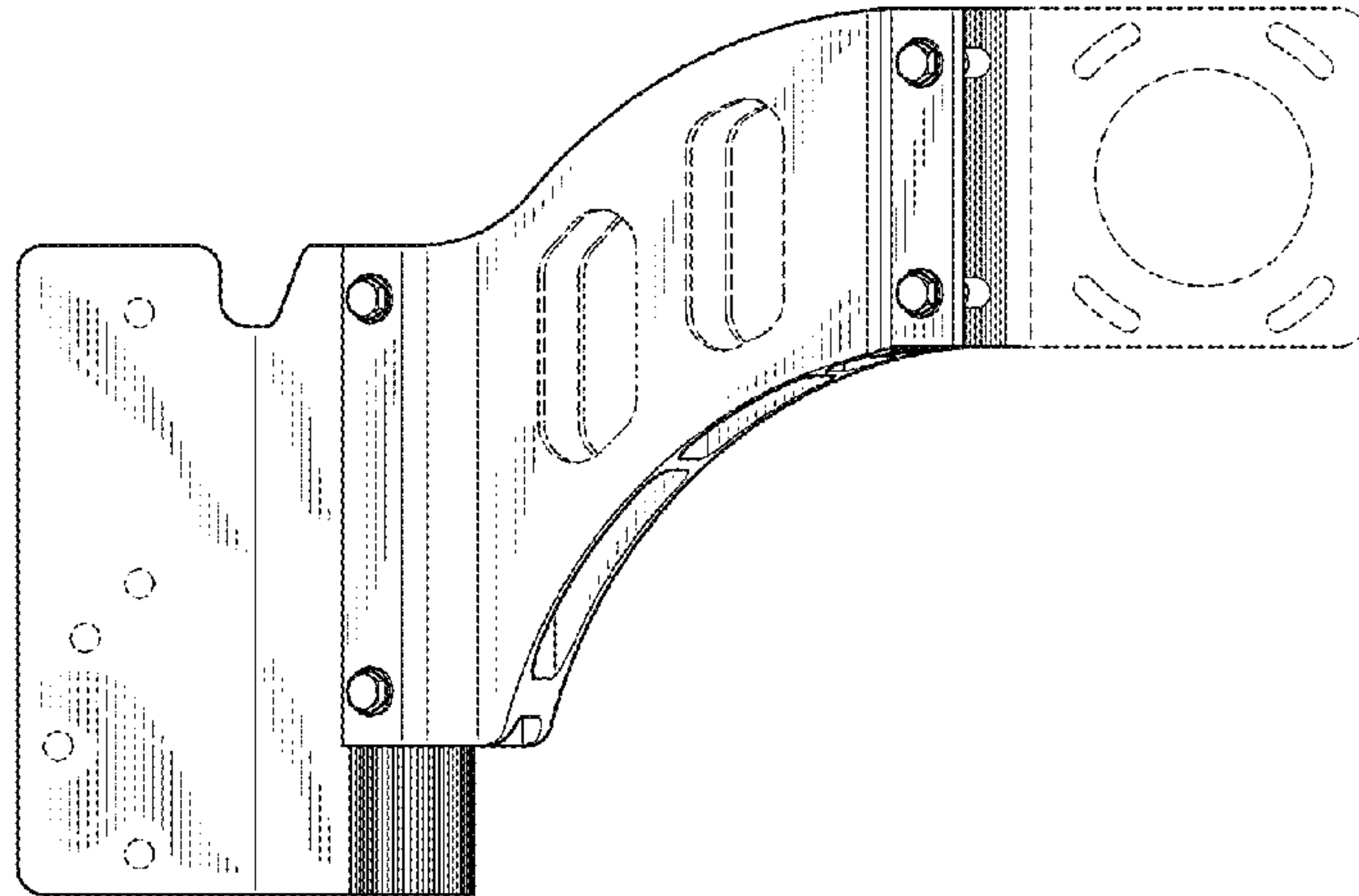

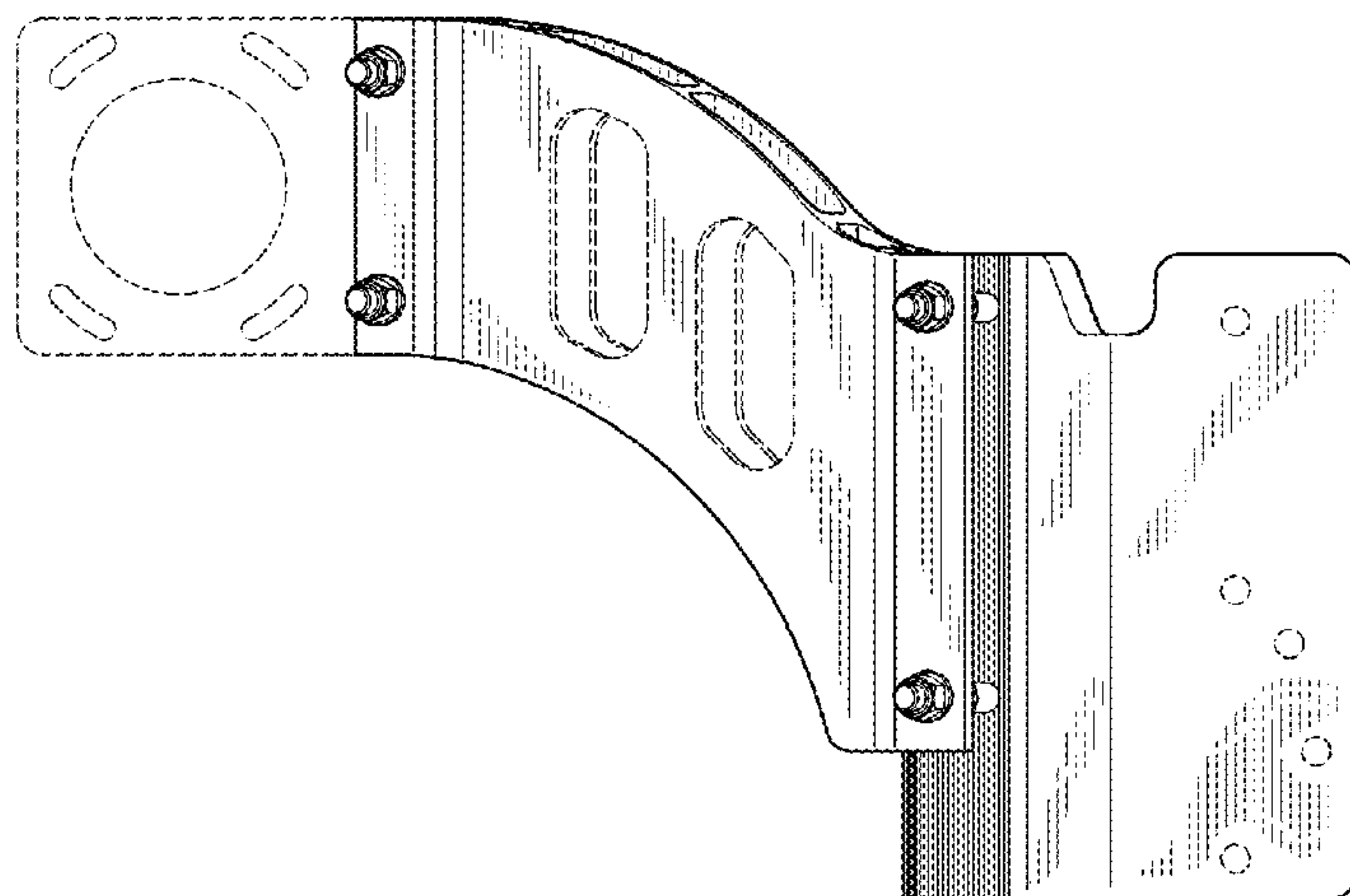

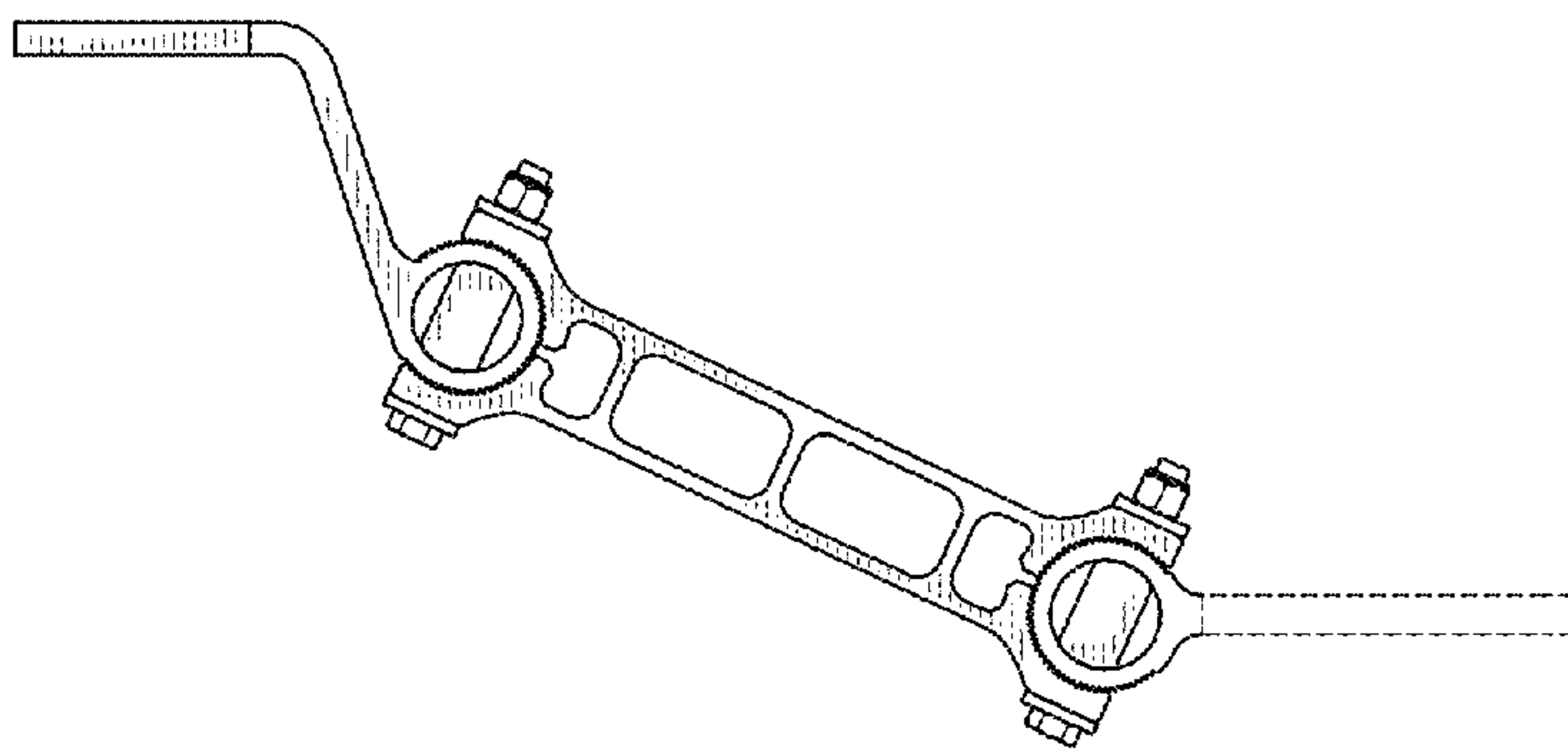

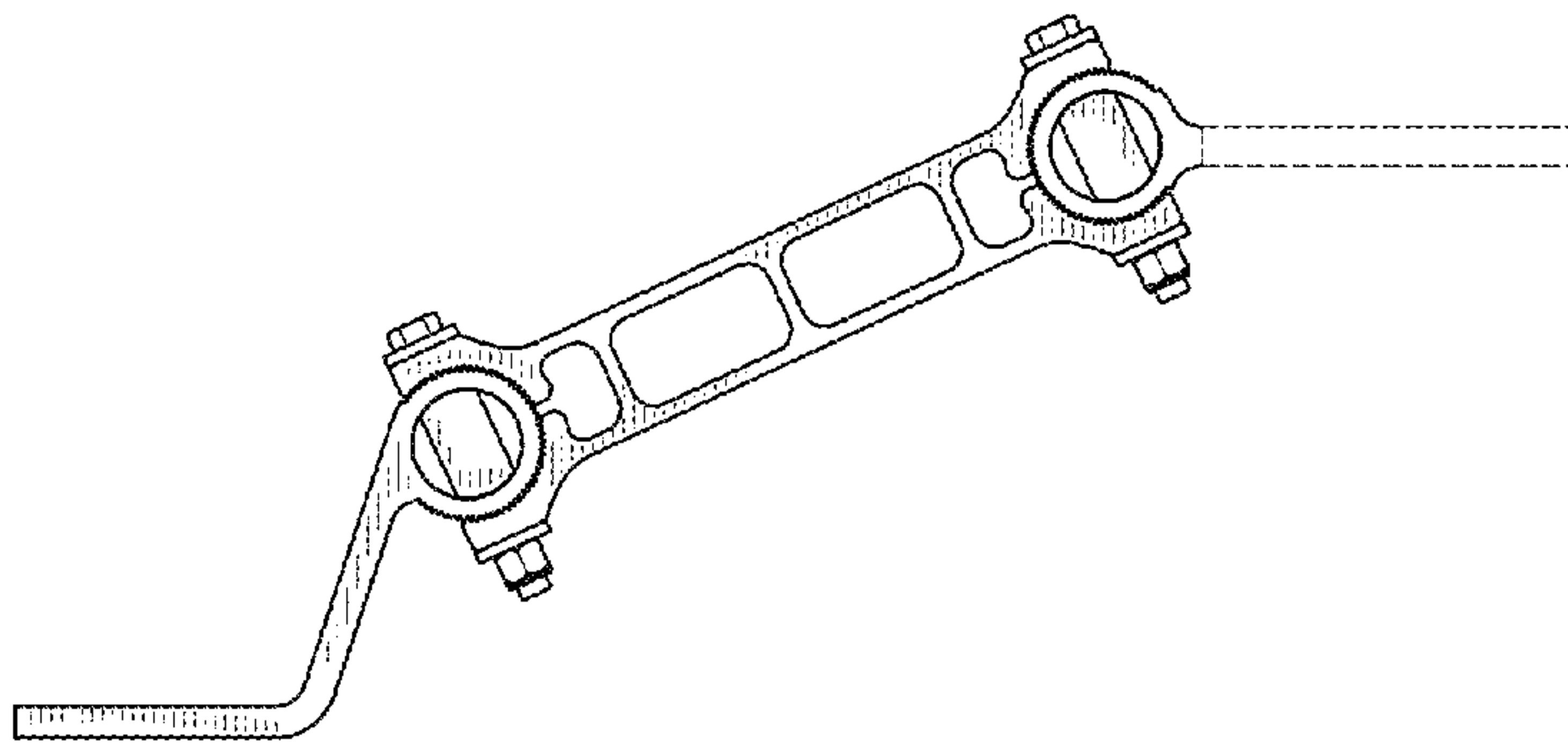

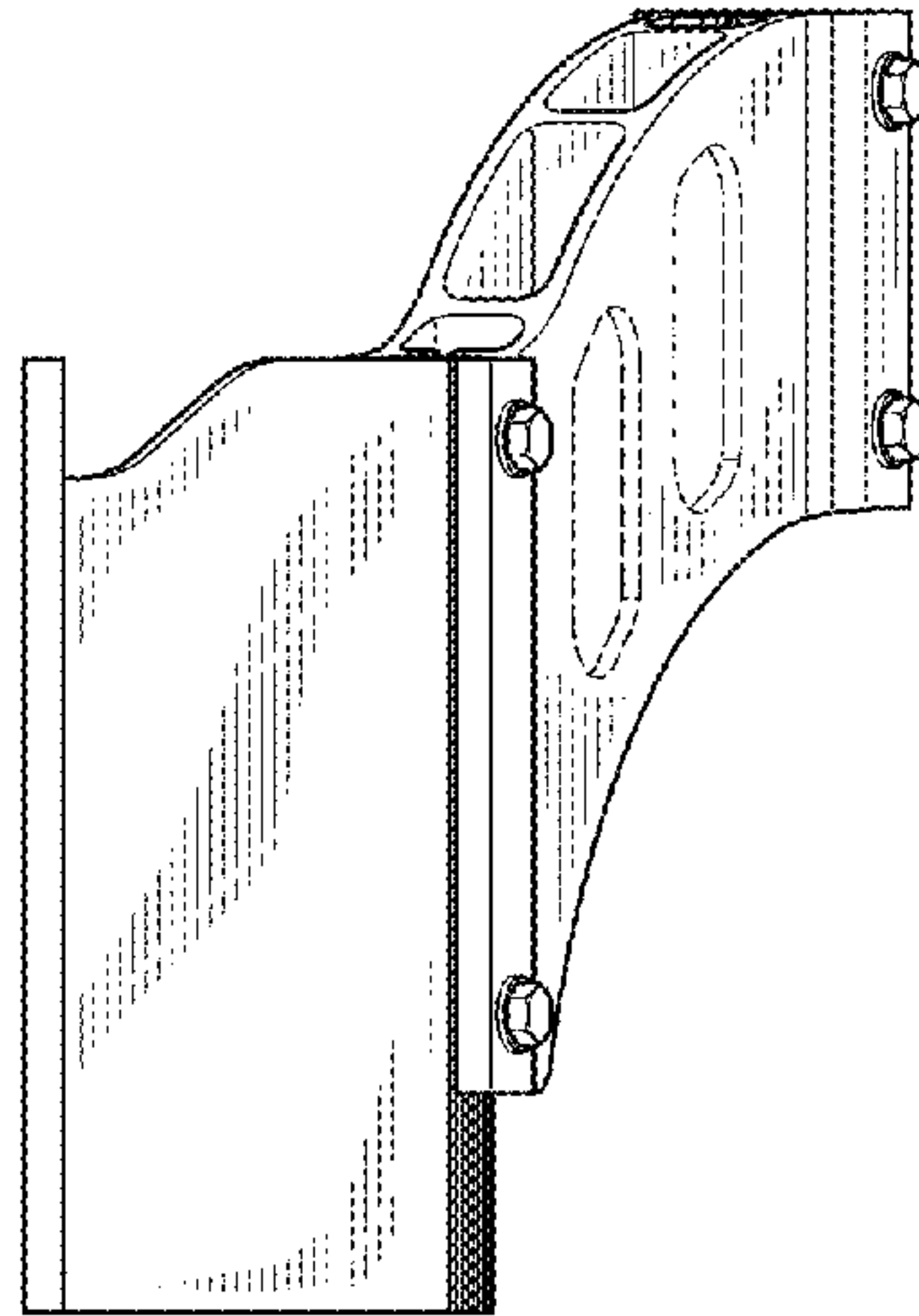

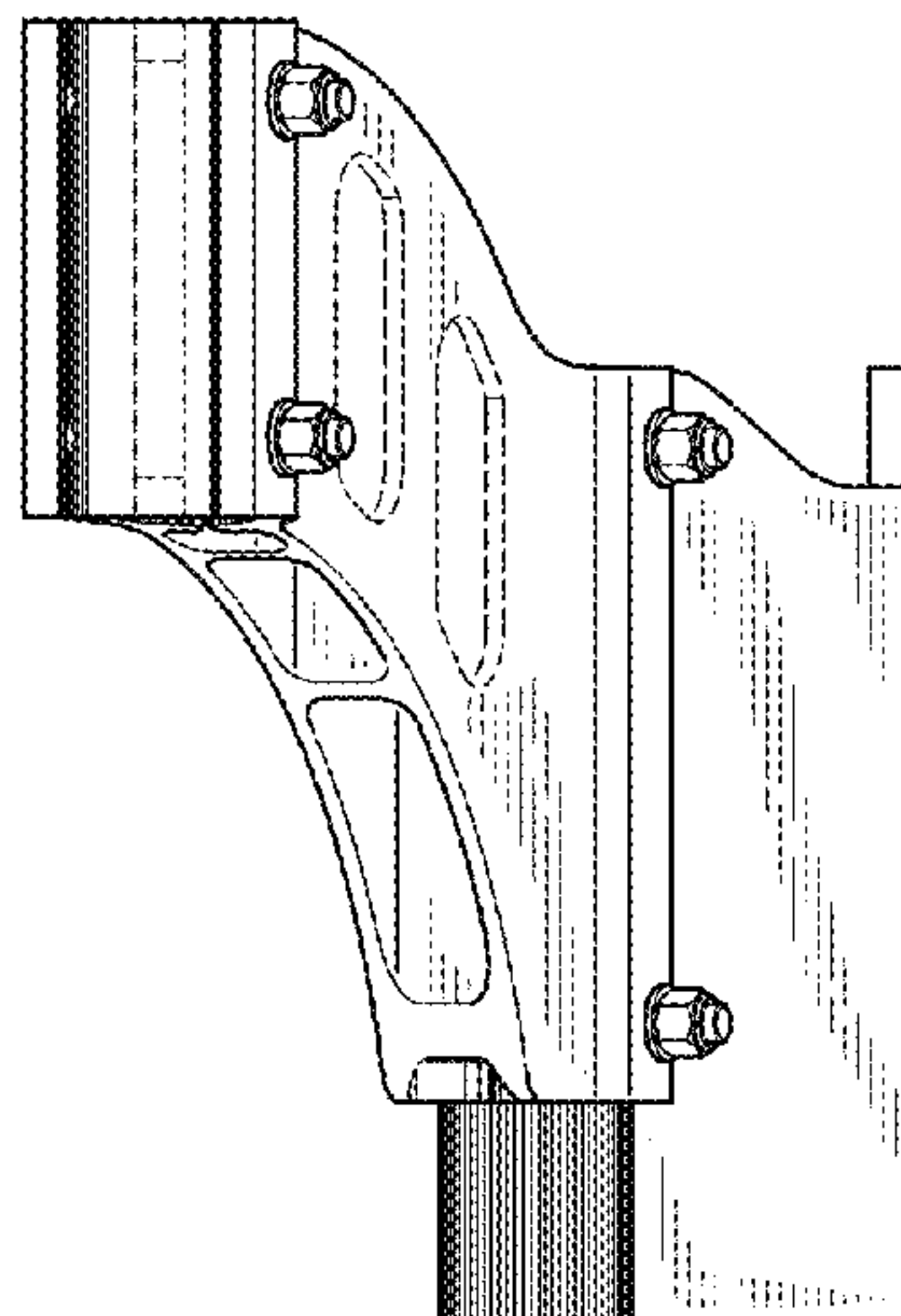
