DESCRIPTION

FIG. 1 is a perspective view of a typing tool showing my new design;

FIG. 2 is a front view (back view is mirror image) thereof;

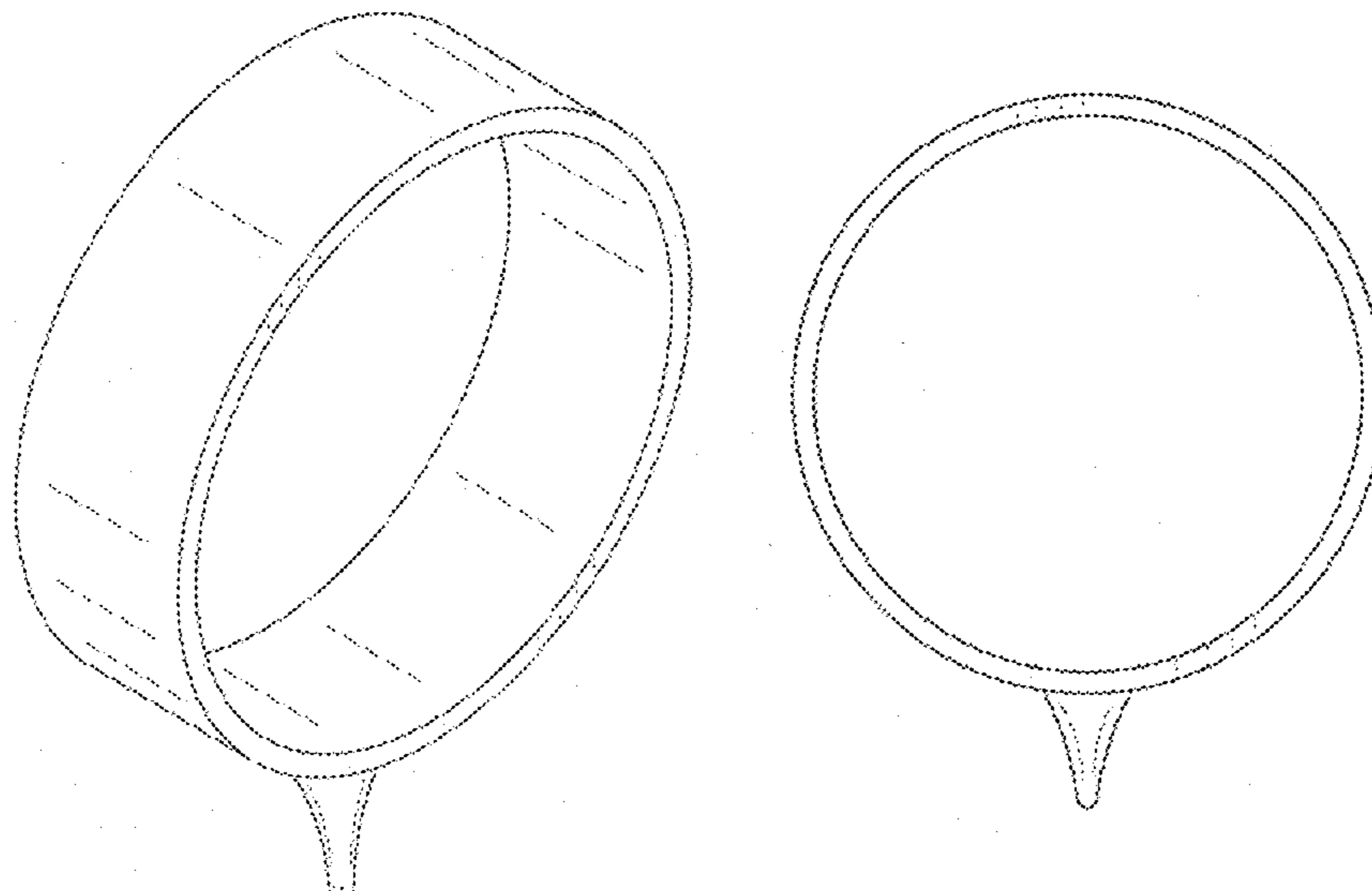
FIG. 3 is a side view (opposite side view is mirror image) thereof;

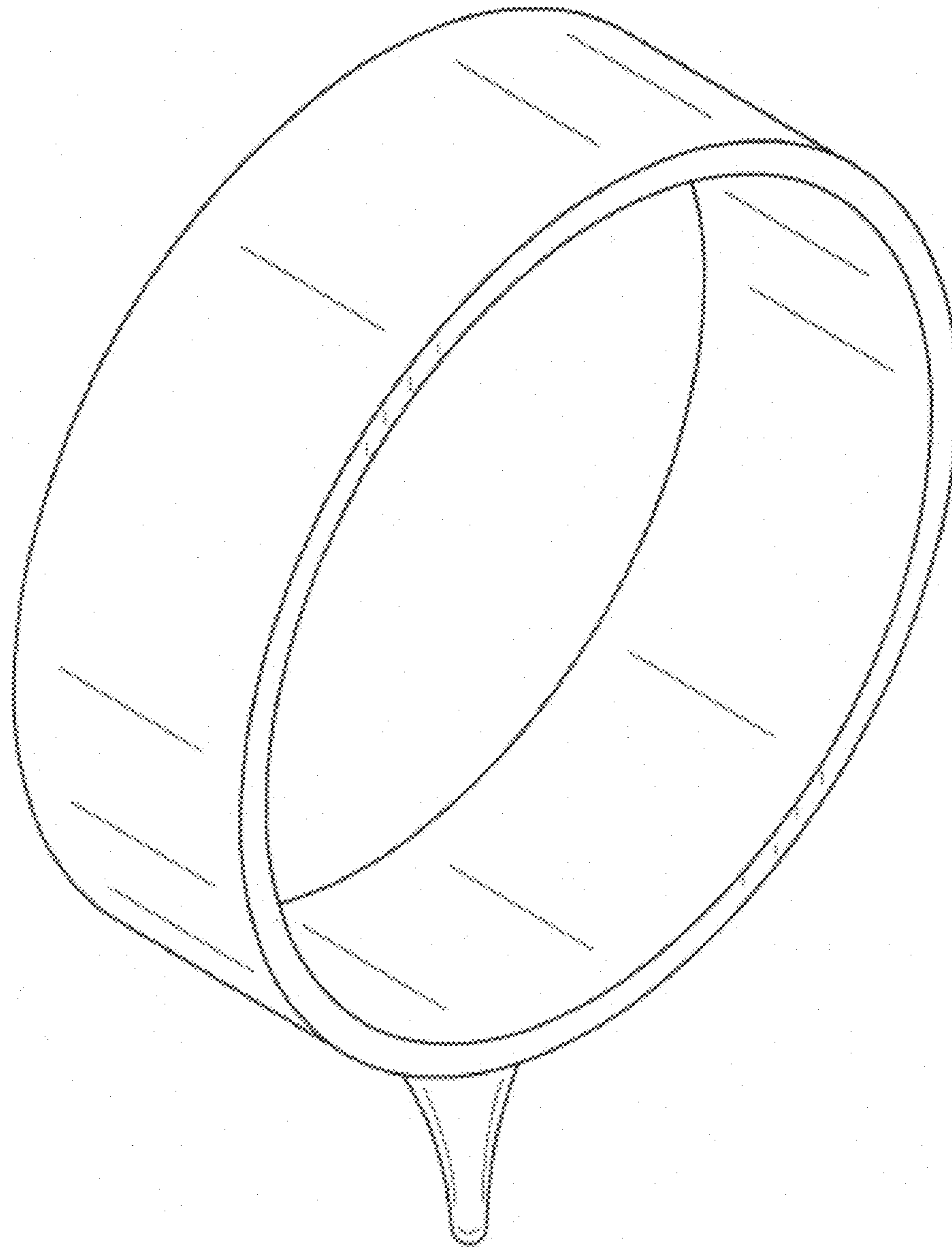

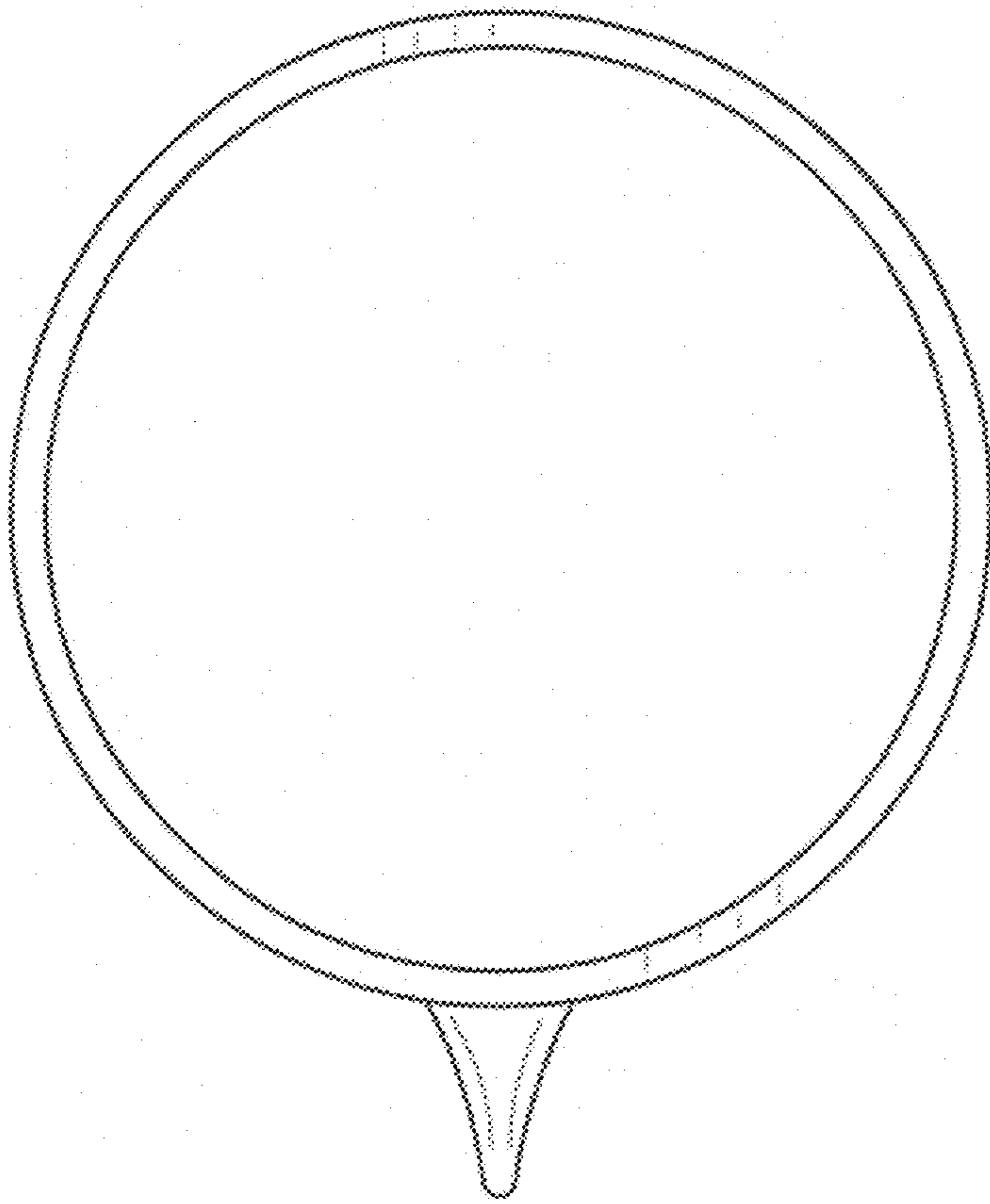

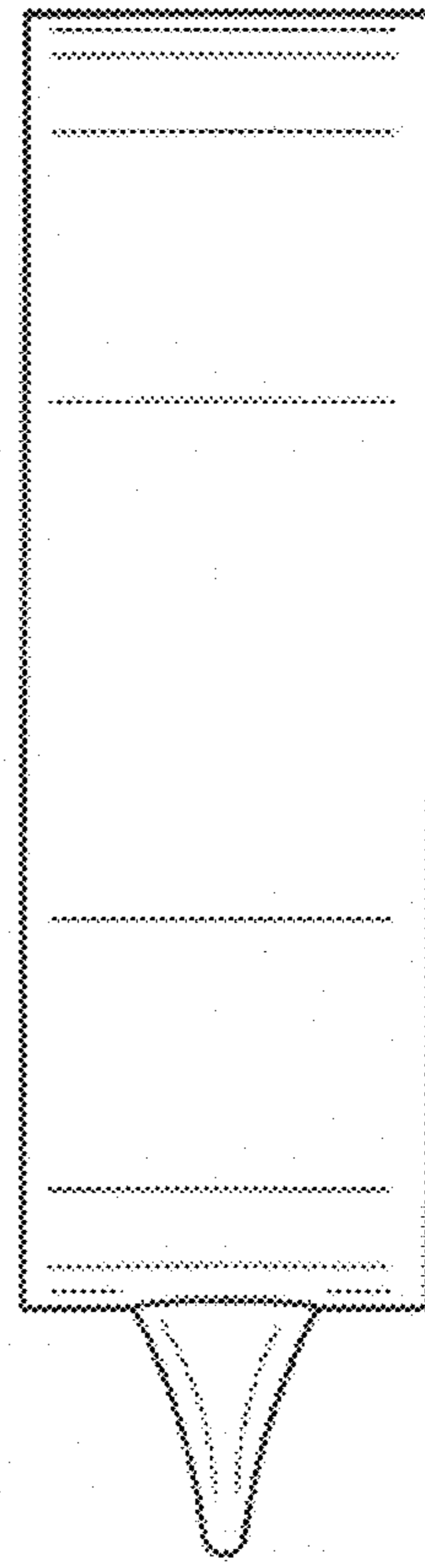

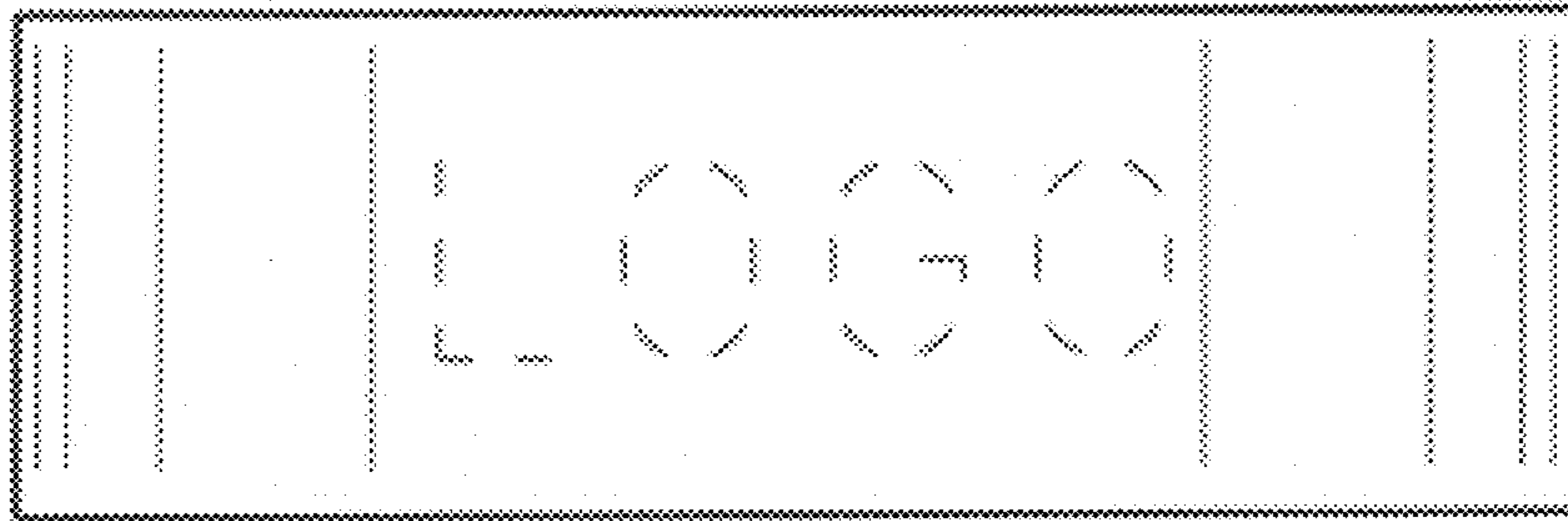

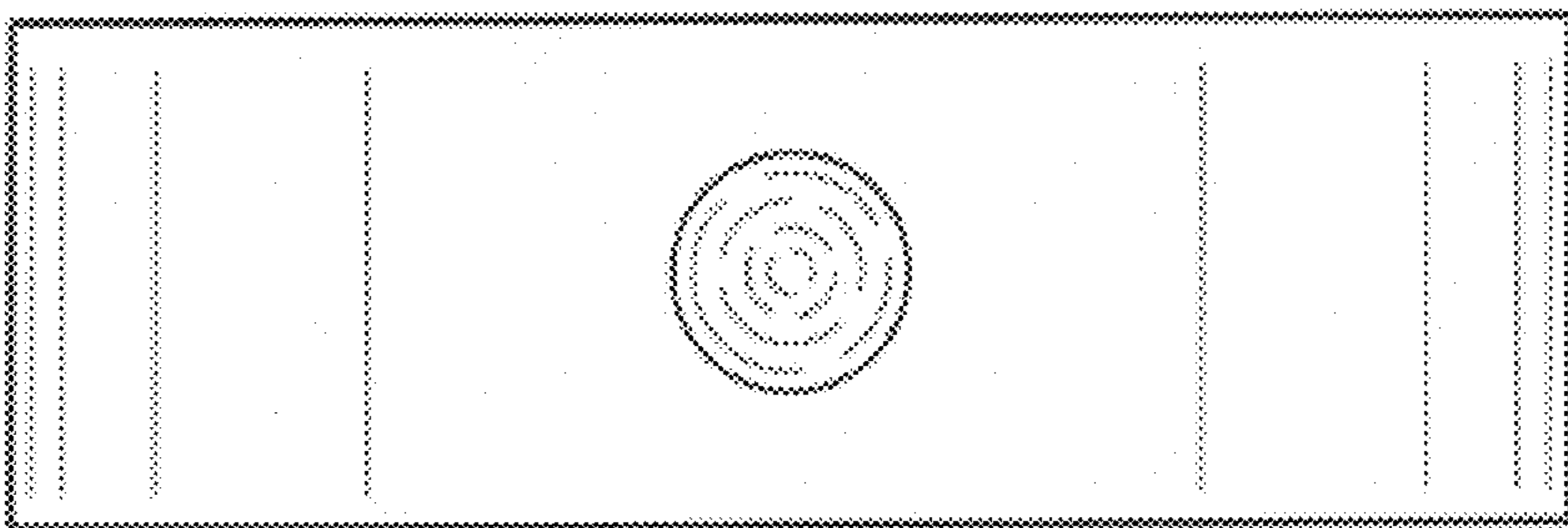
