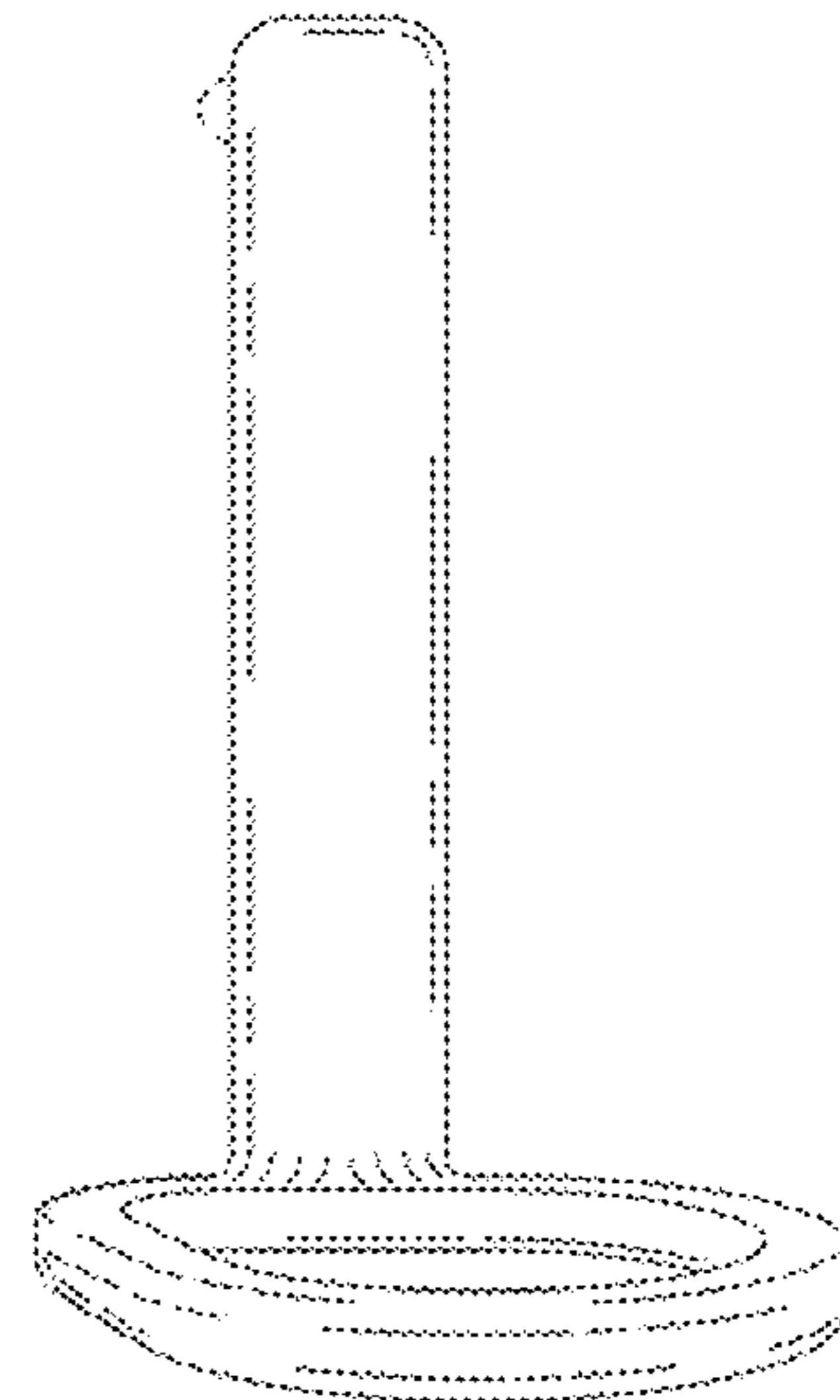
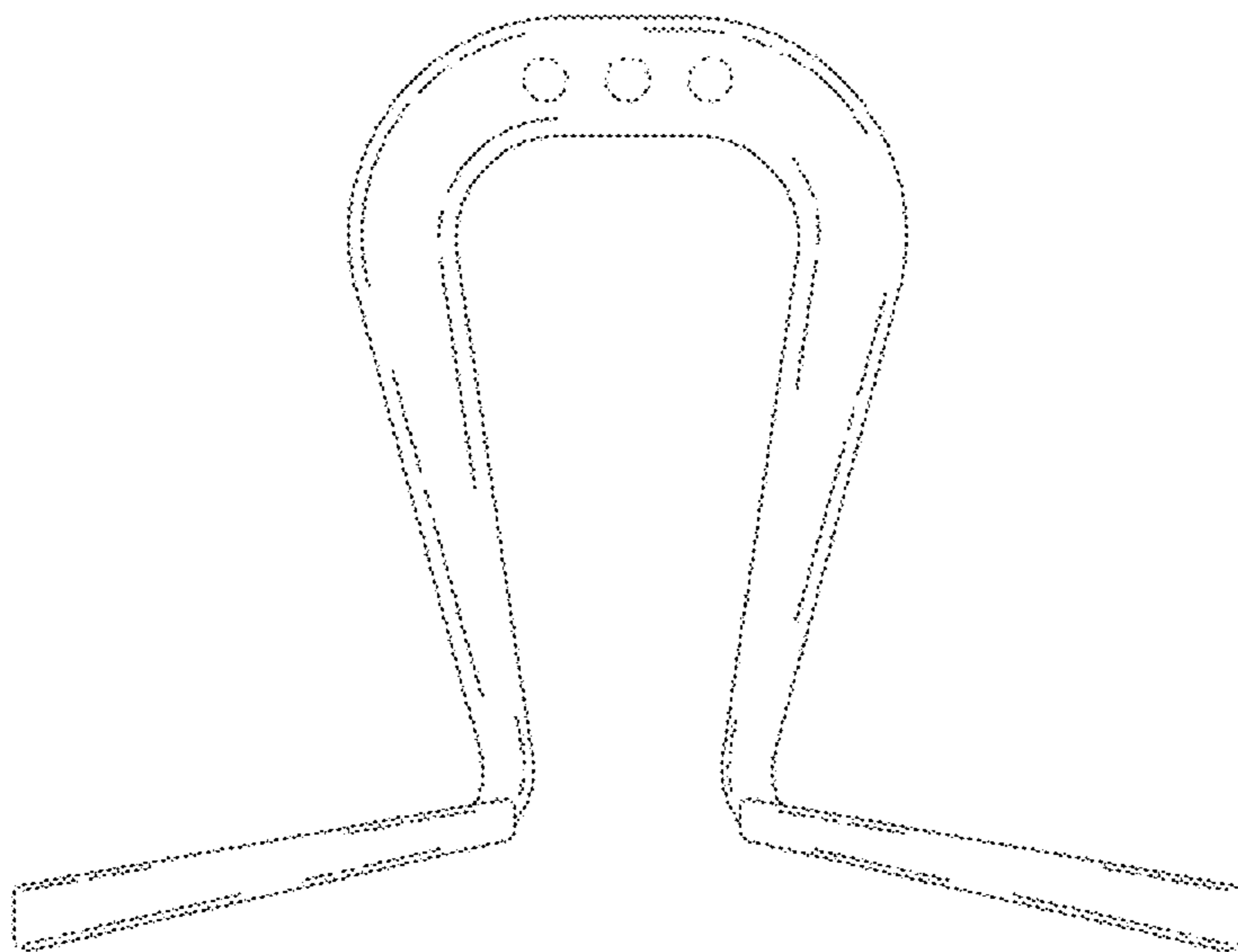
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric top front view of a nasal dilator;

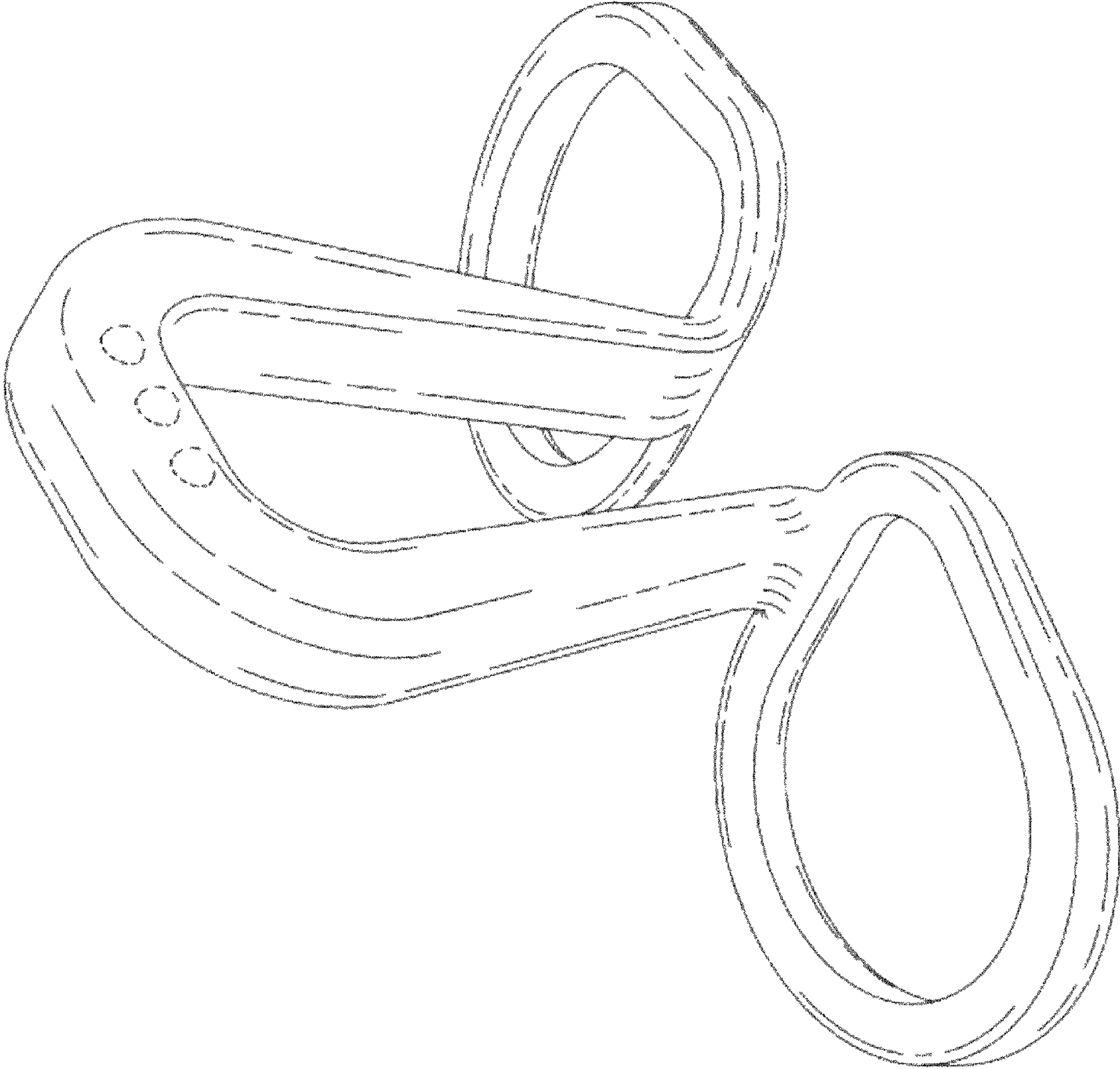

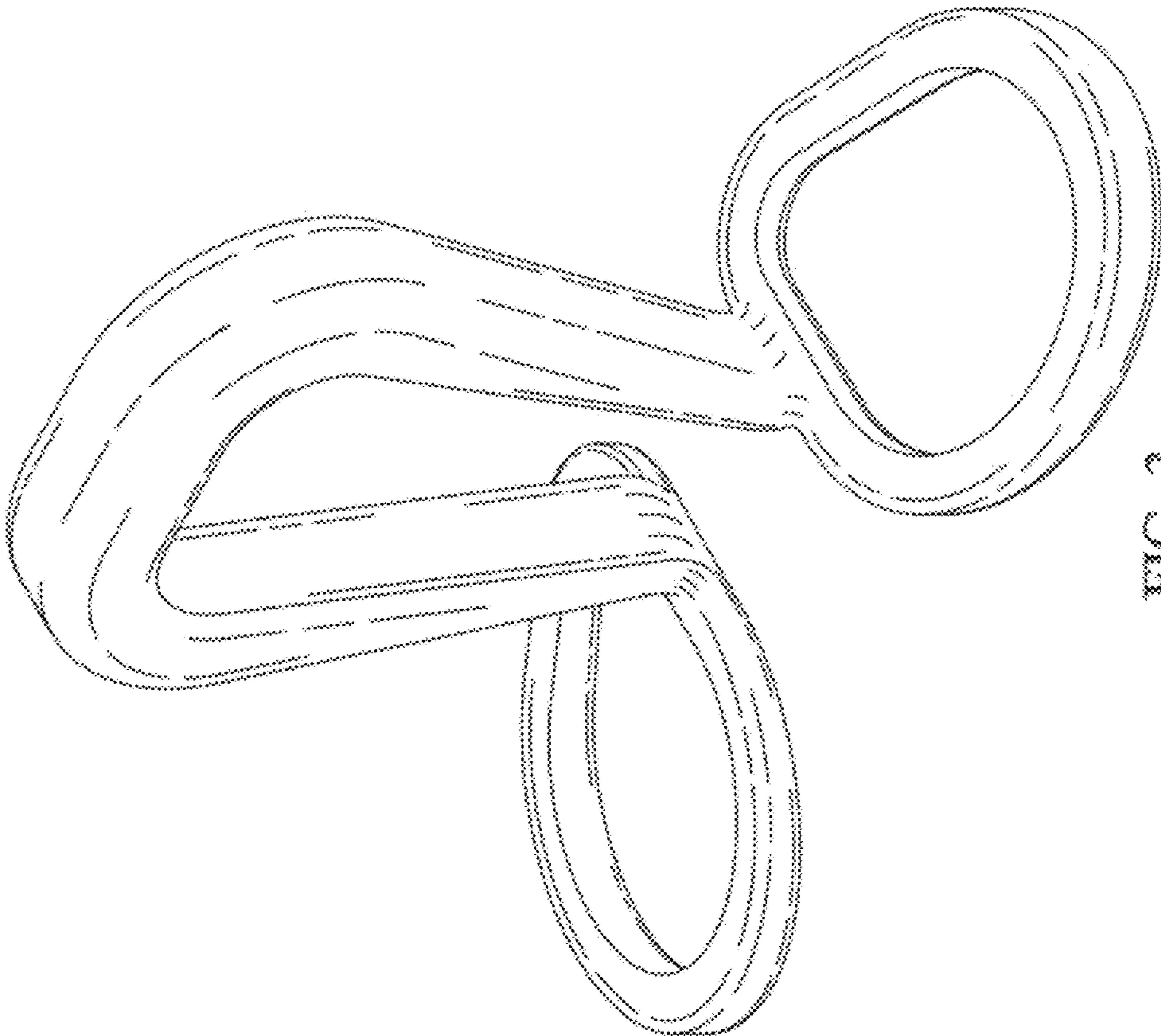

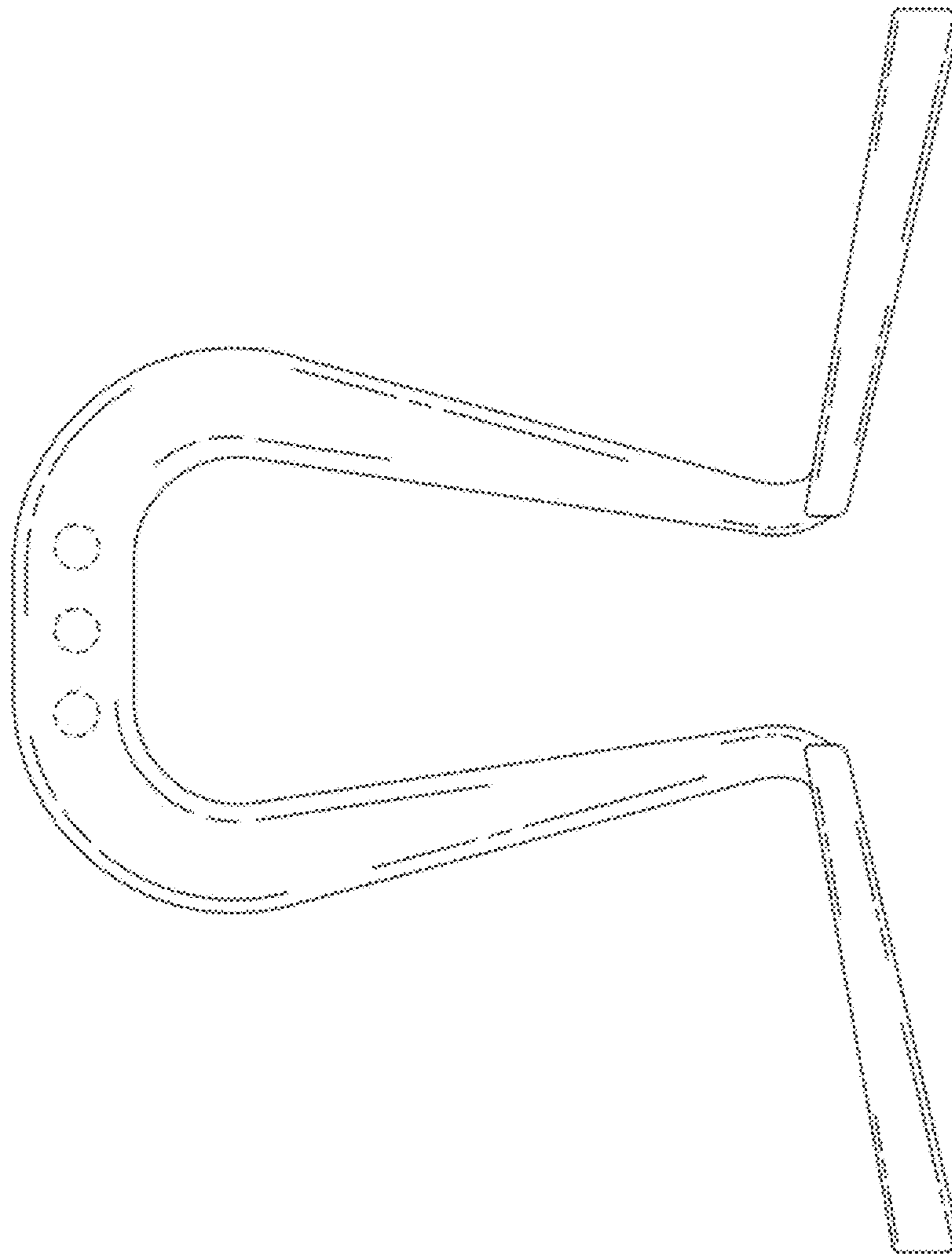

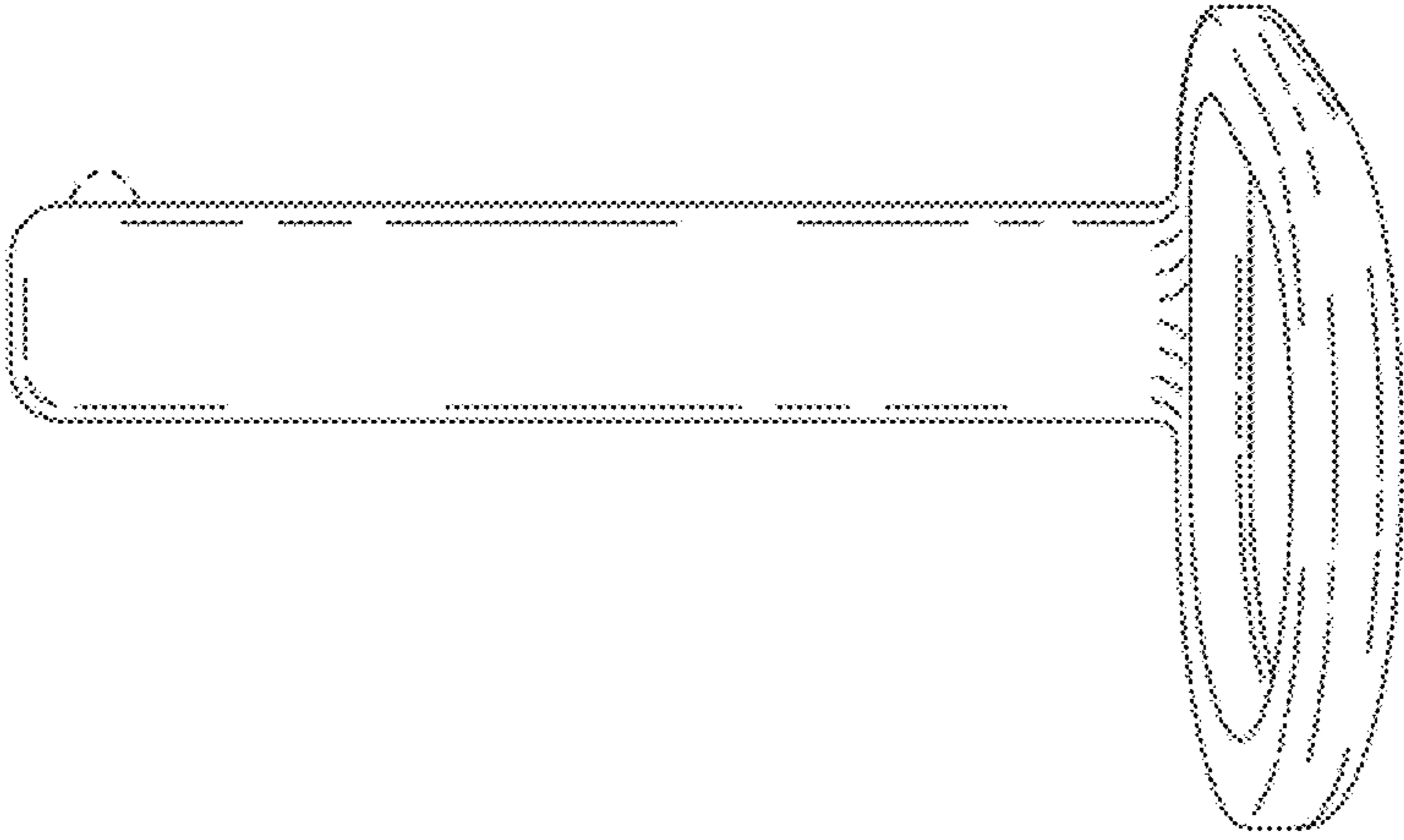

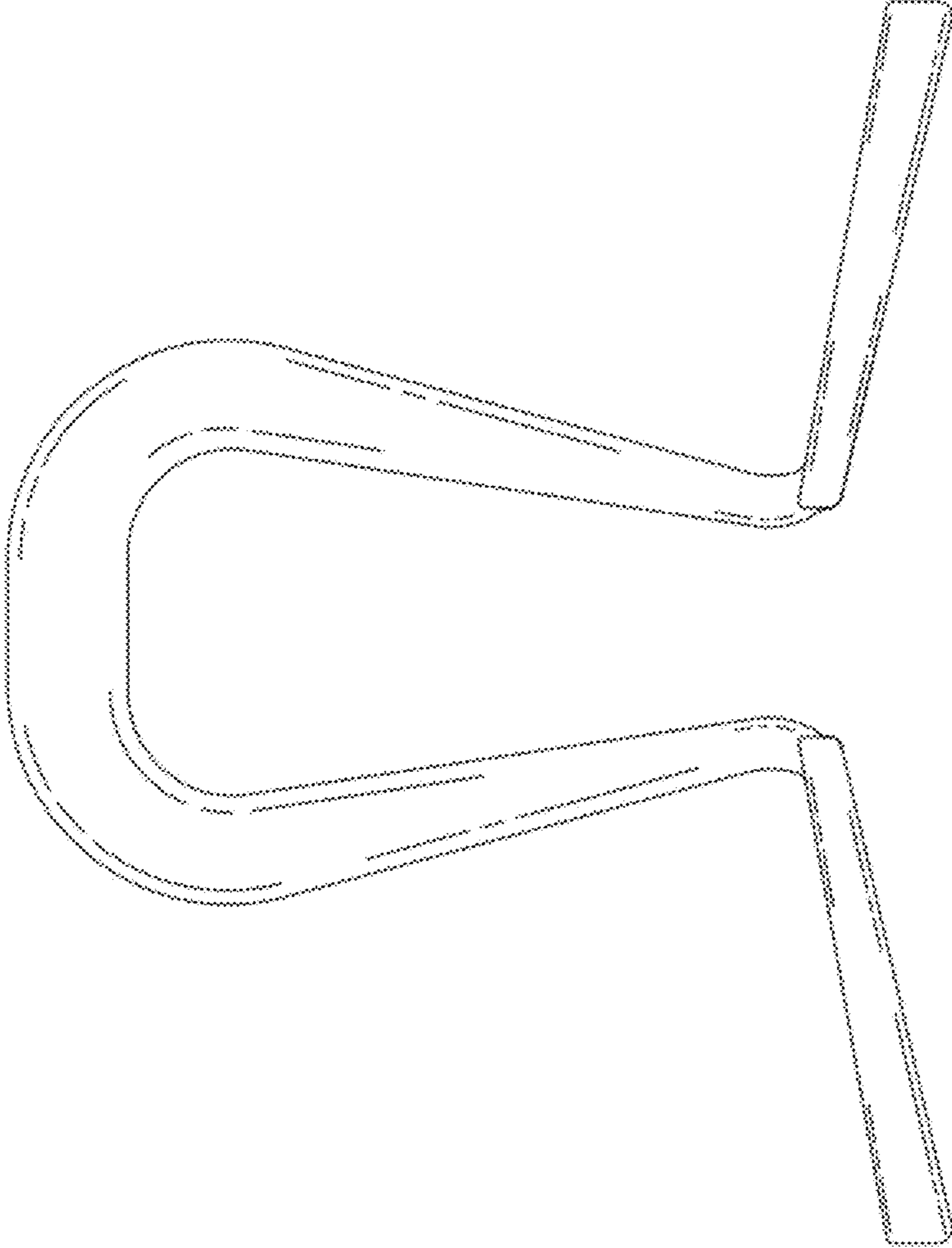

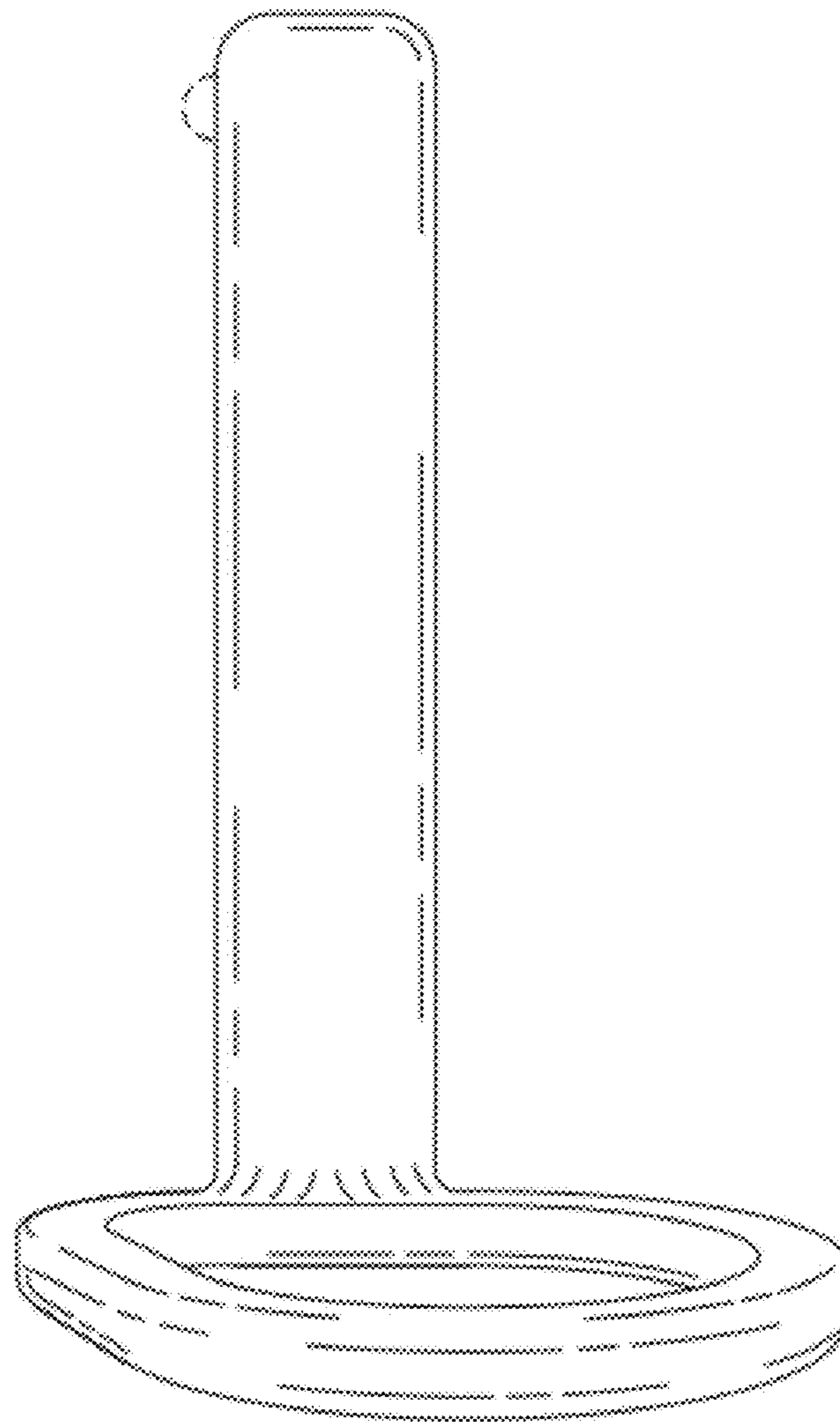

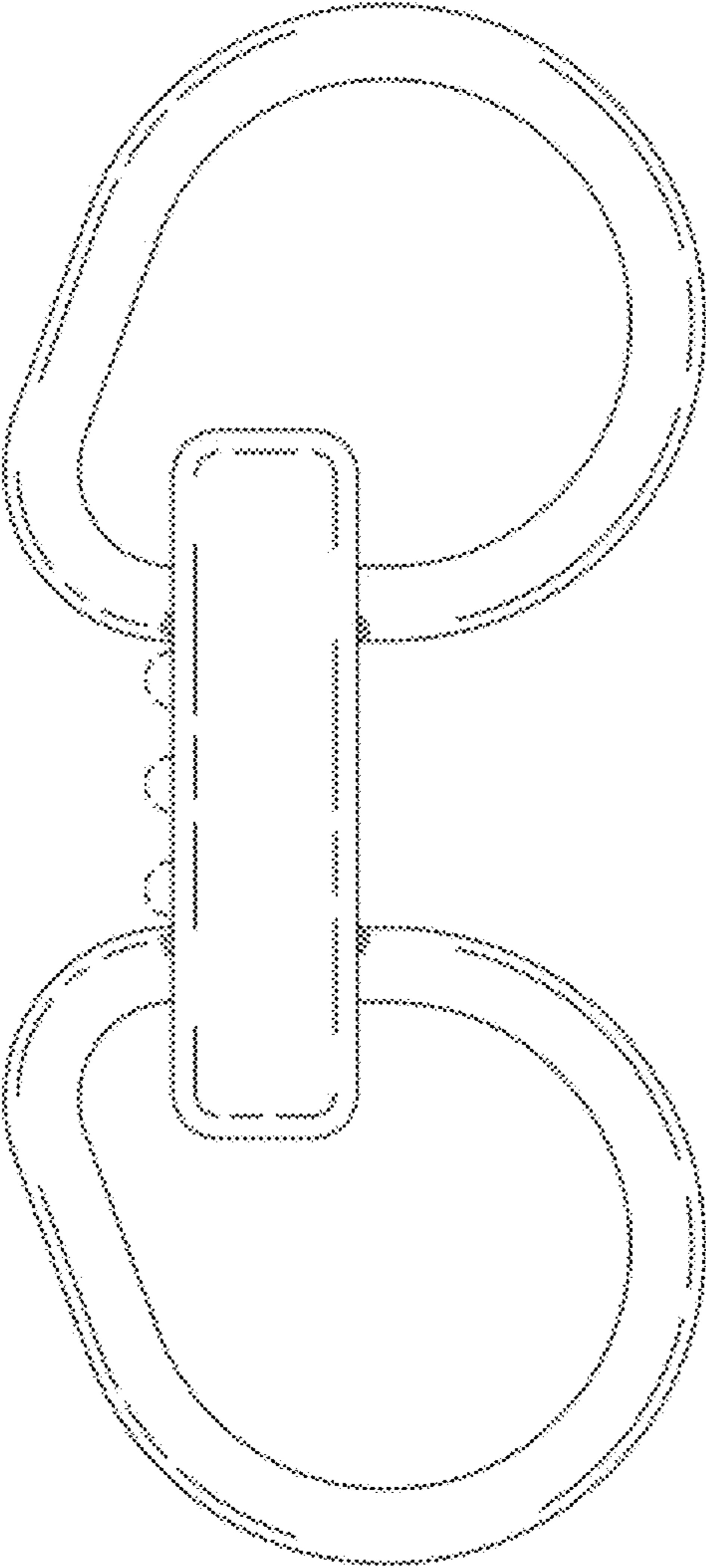

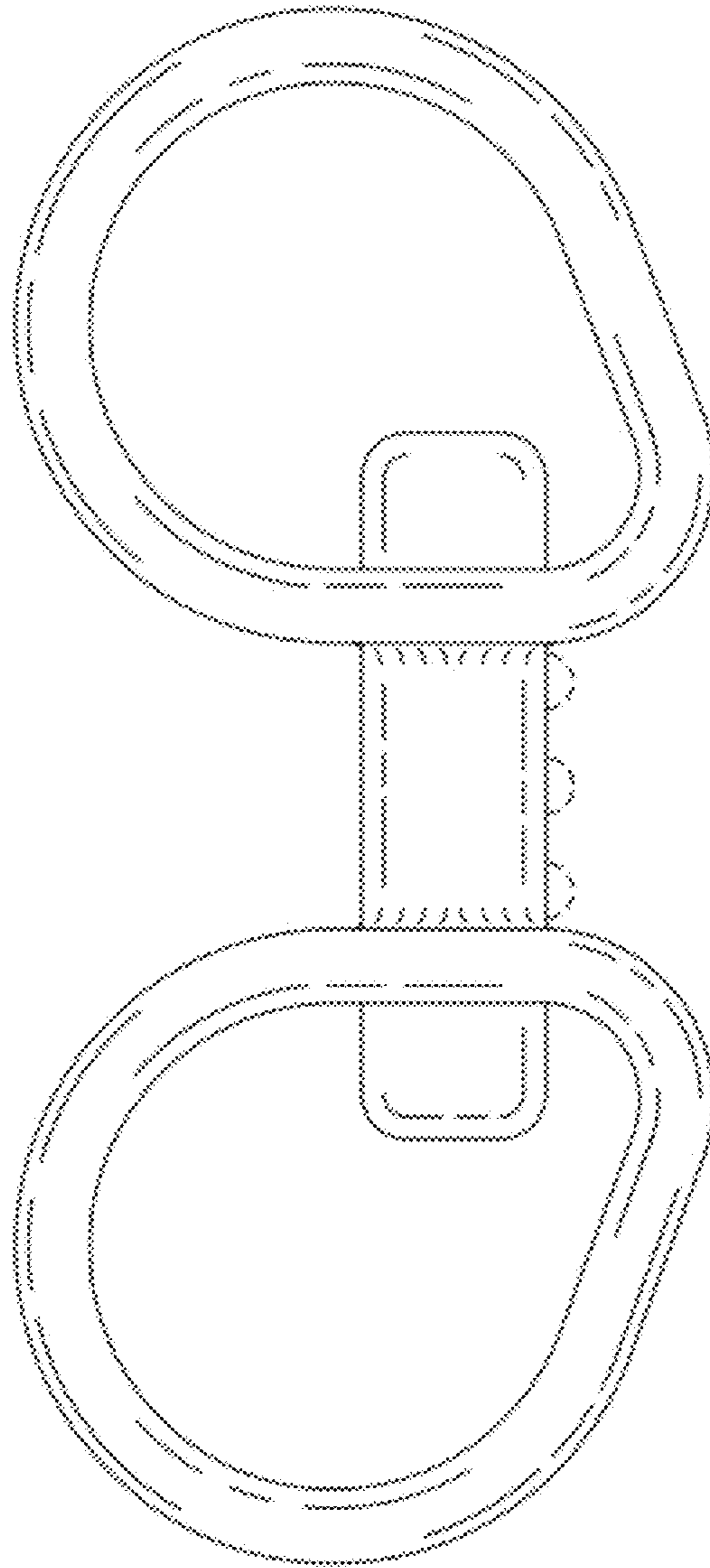
