(57) **CLAIM**

I claim the ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side view of a shoe according to my new design;  
FIG. 2 is a rear side view of the shoe shown in FIG. 1;  
FIG. 3 is a right side view of the shoe shown in FIG. 1;  
FIG. 4 is a left side view of the shoe shown in FIG. 1;  
FIG. 5 is a top side view of the shoe shown in FIG. 1;  
FIG. 6 is a bottom side view of the shoe shown in FIG. 1; and,  
FIG. 7 is a front perspective view of the shoe shown in FIG. 1.  
The ornamental design which is claimed is shown in solid lines in the drawings.

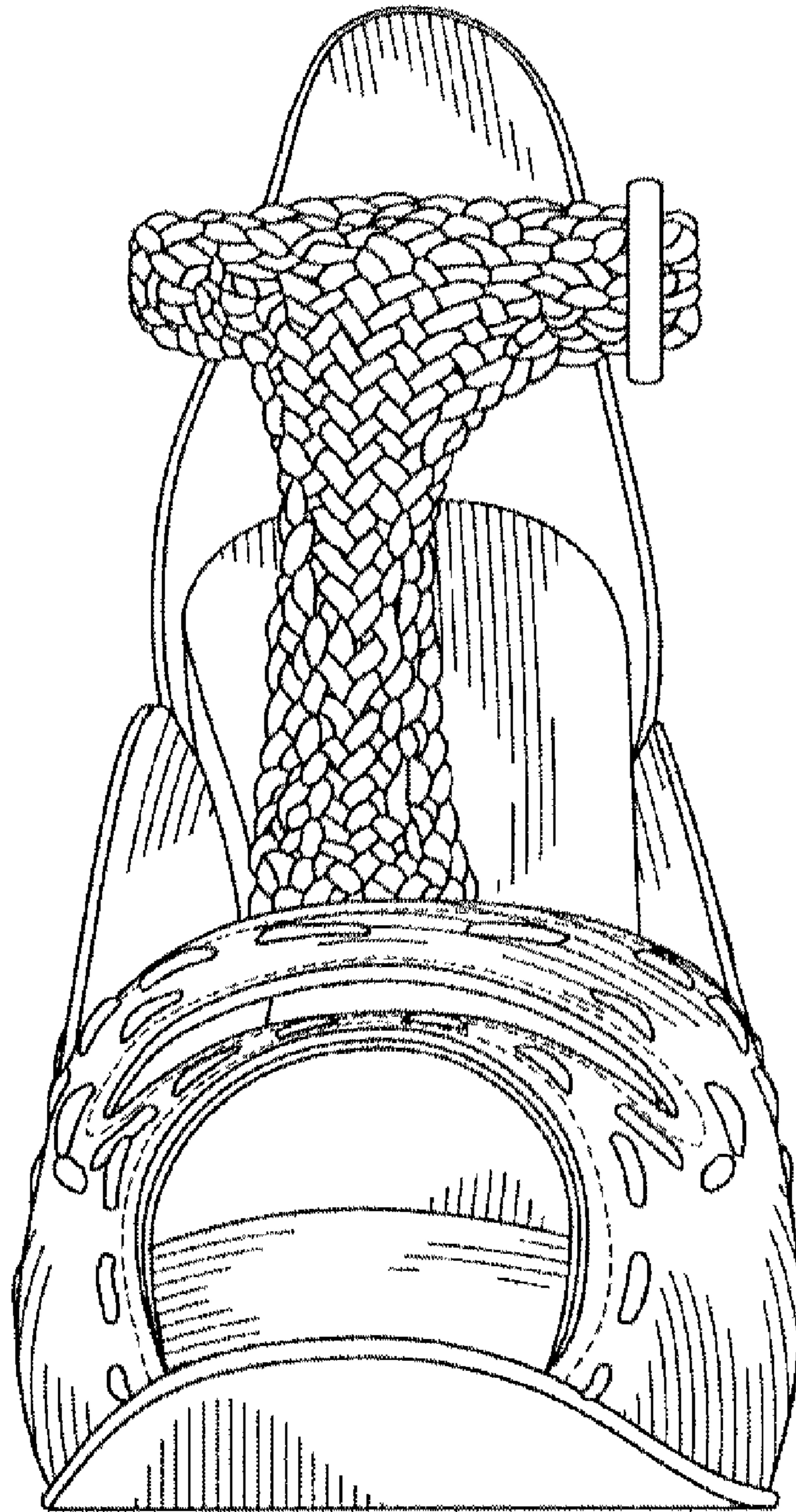

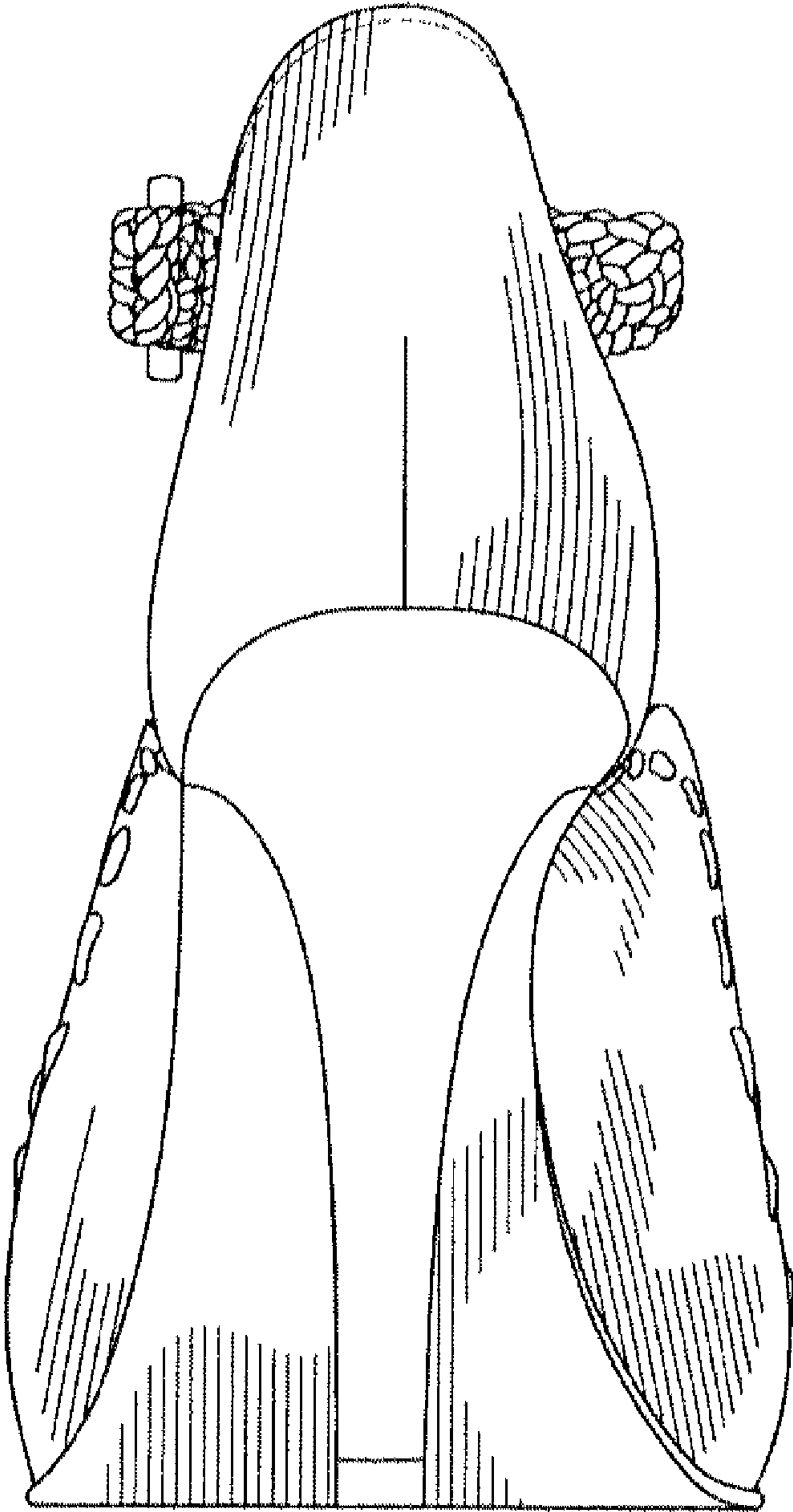

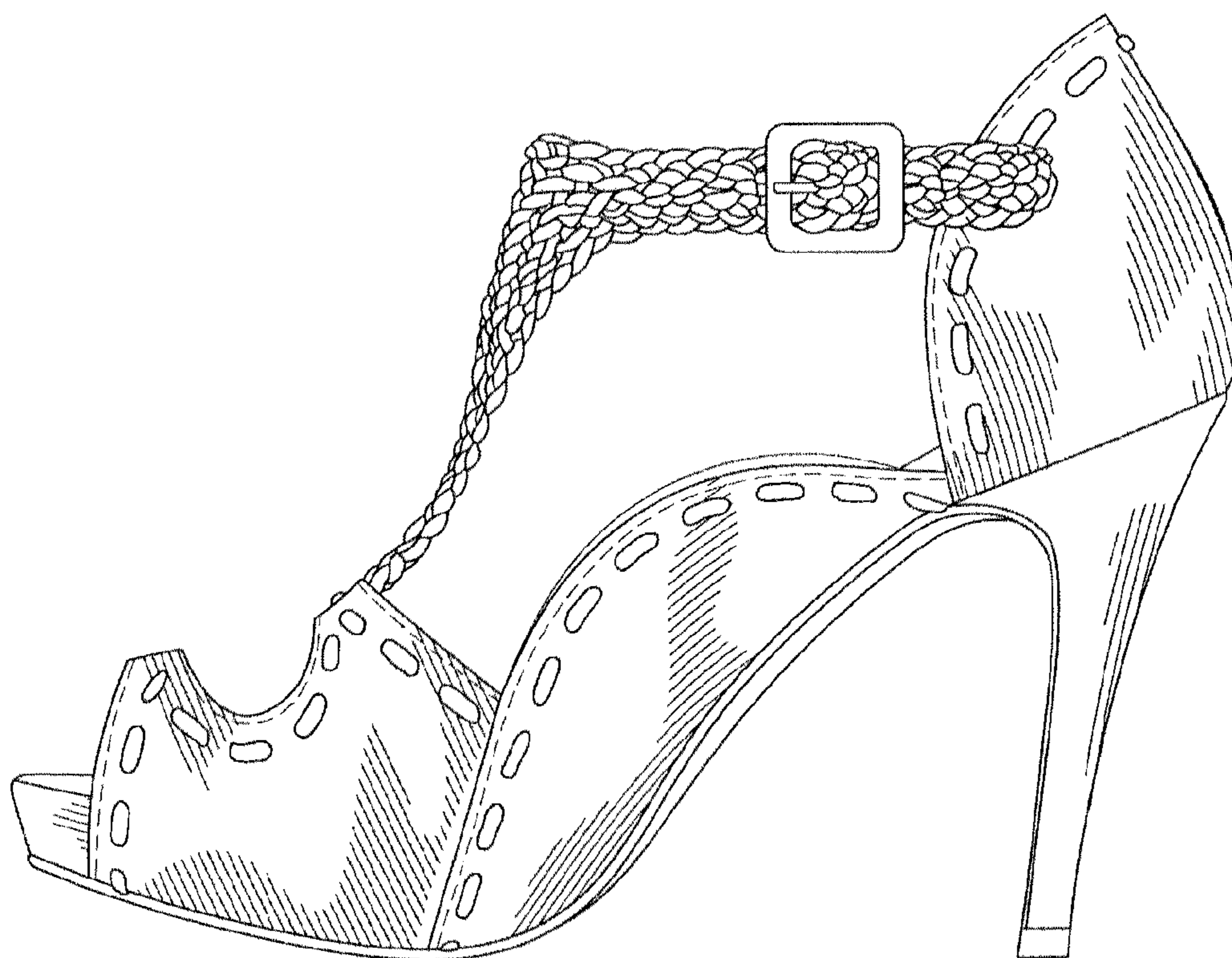

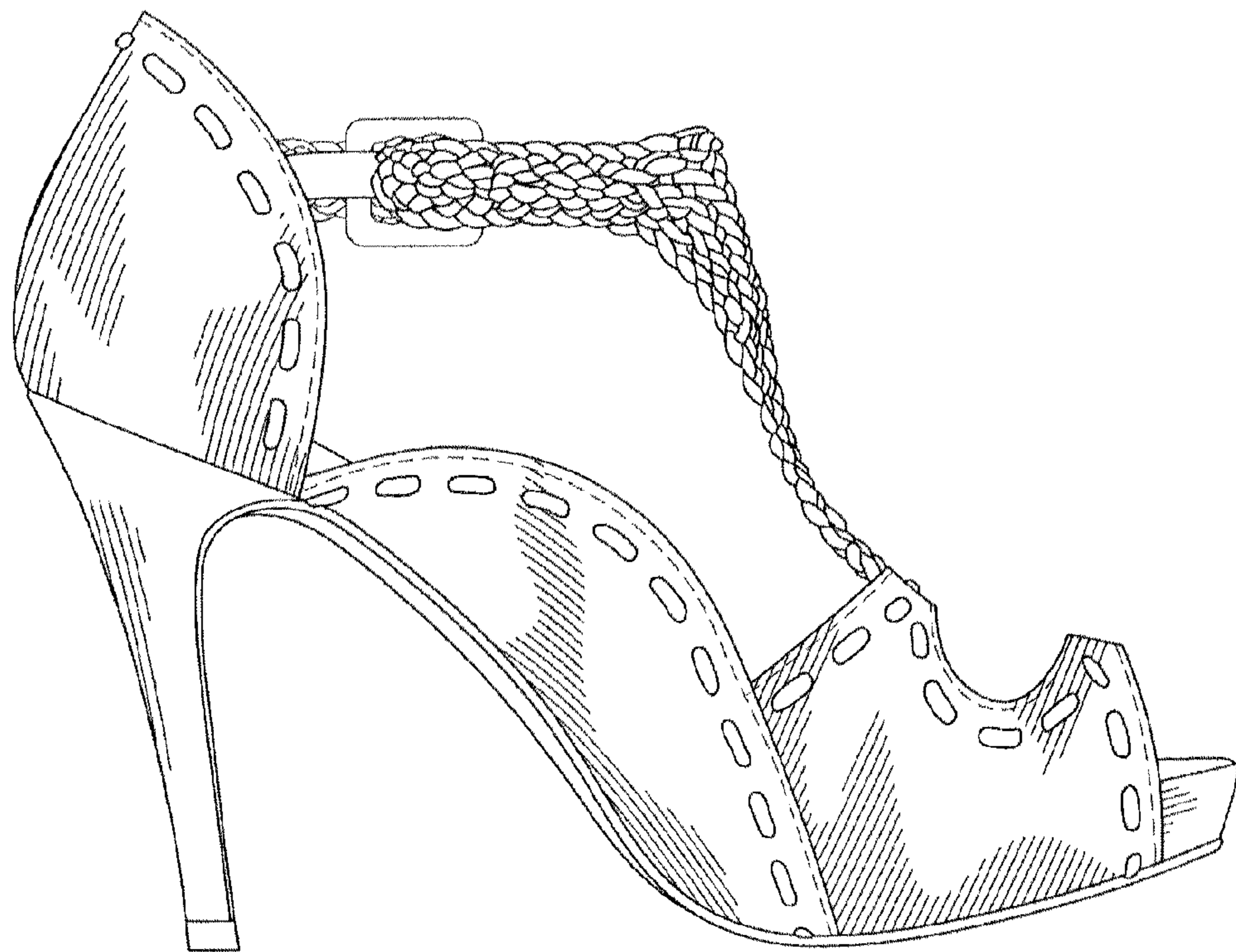

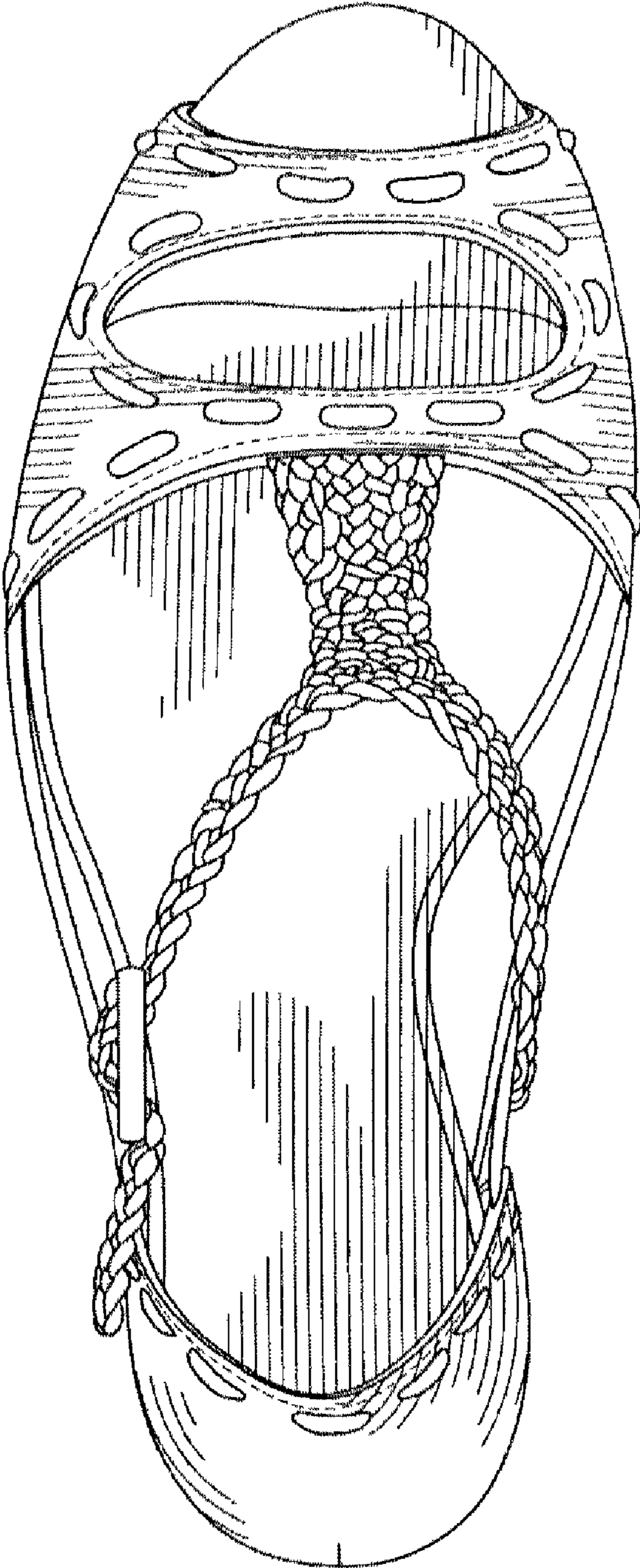

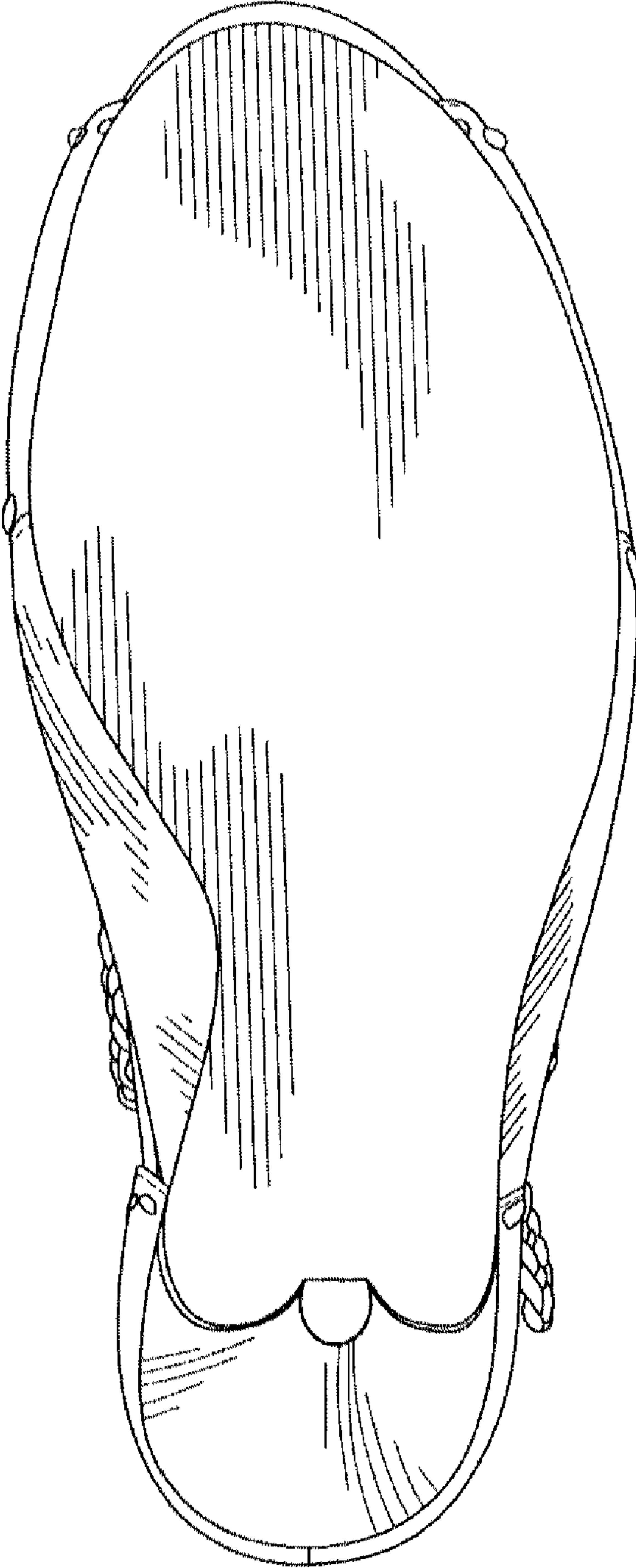
