DESCRIPTION

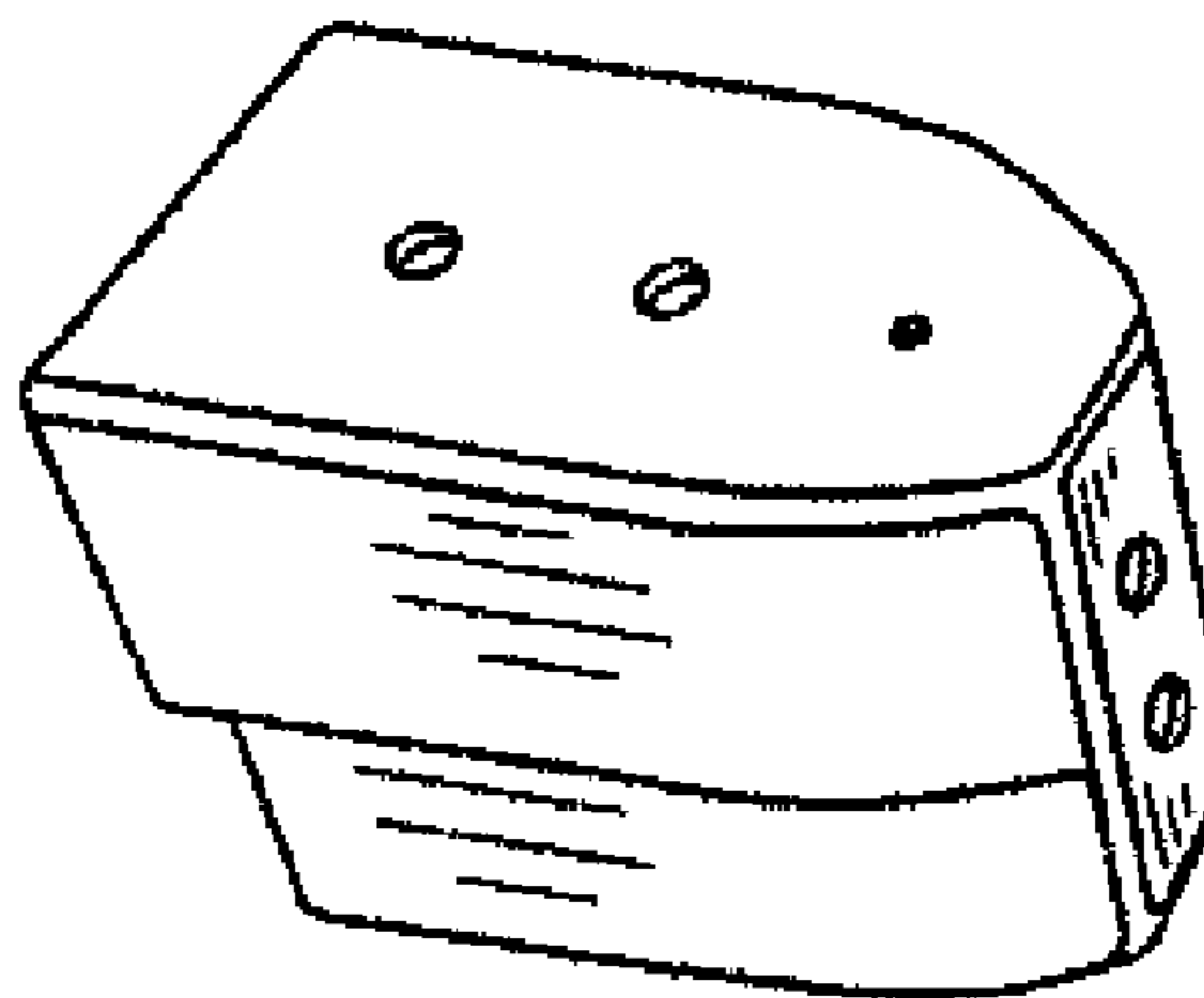
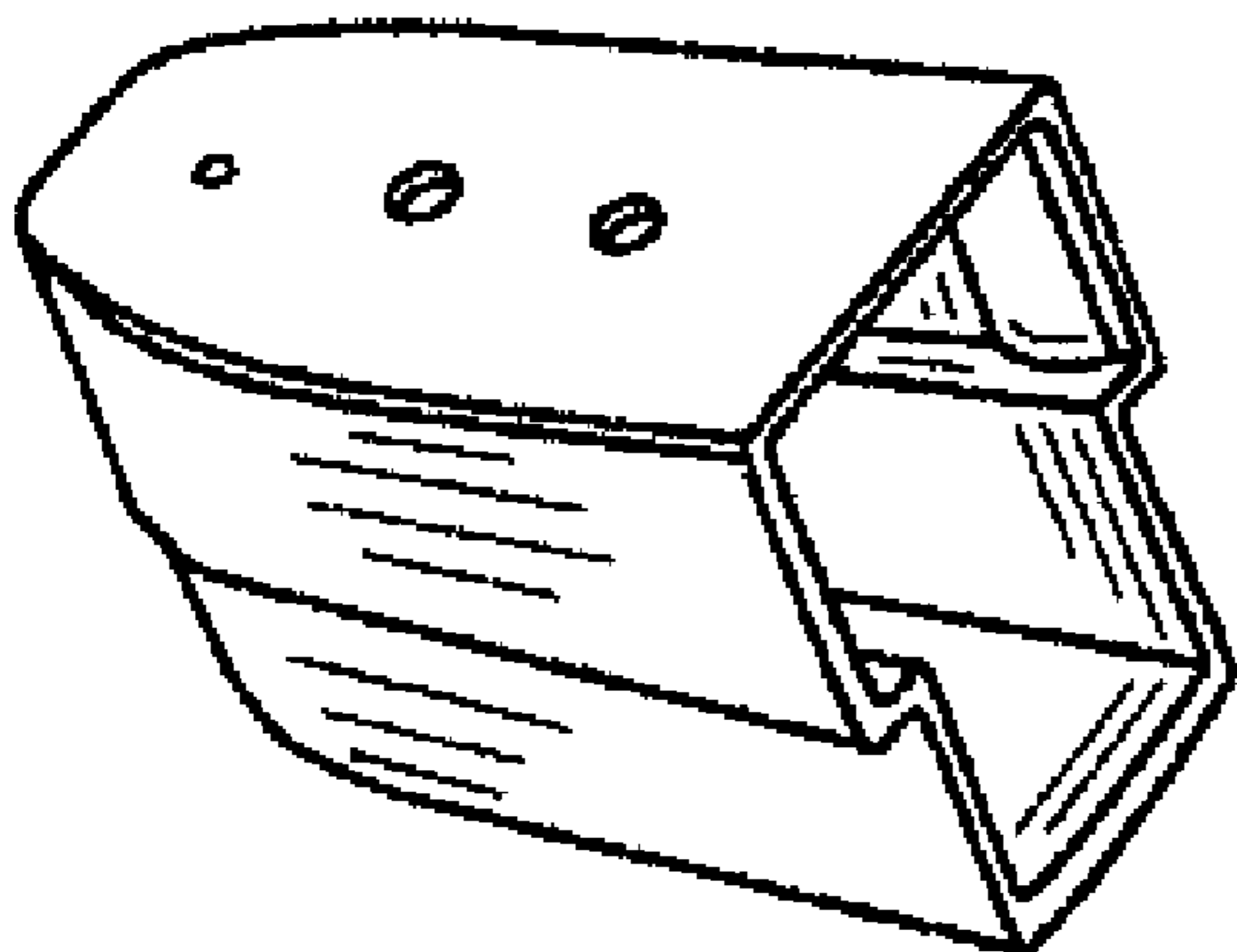

FIG. 4 is an front view thereof.

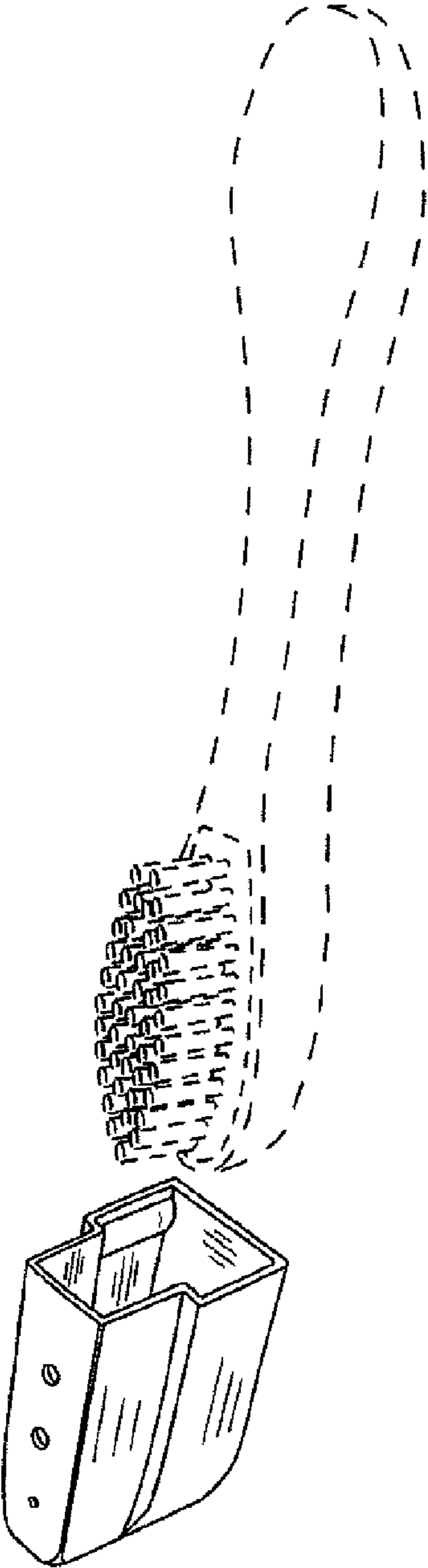

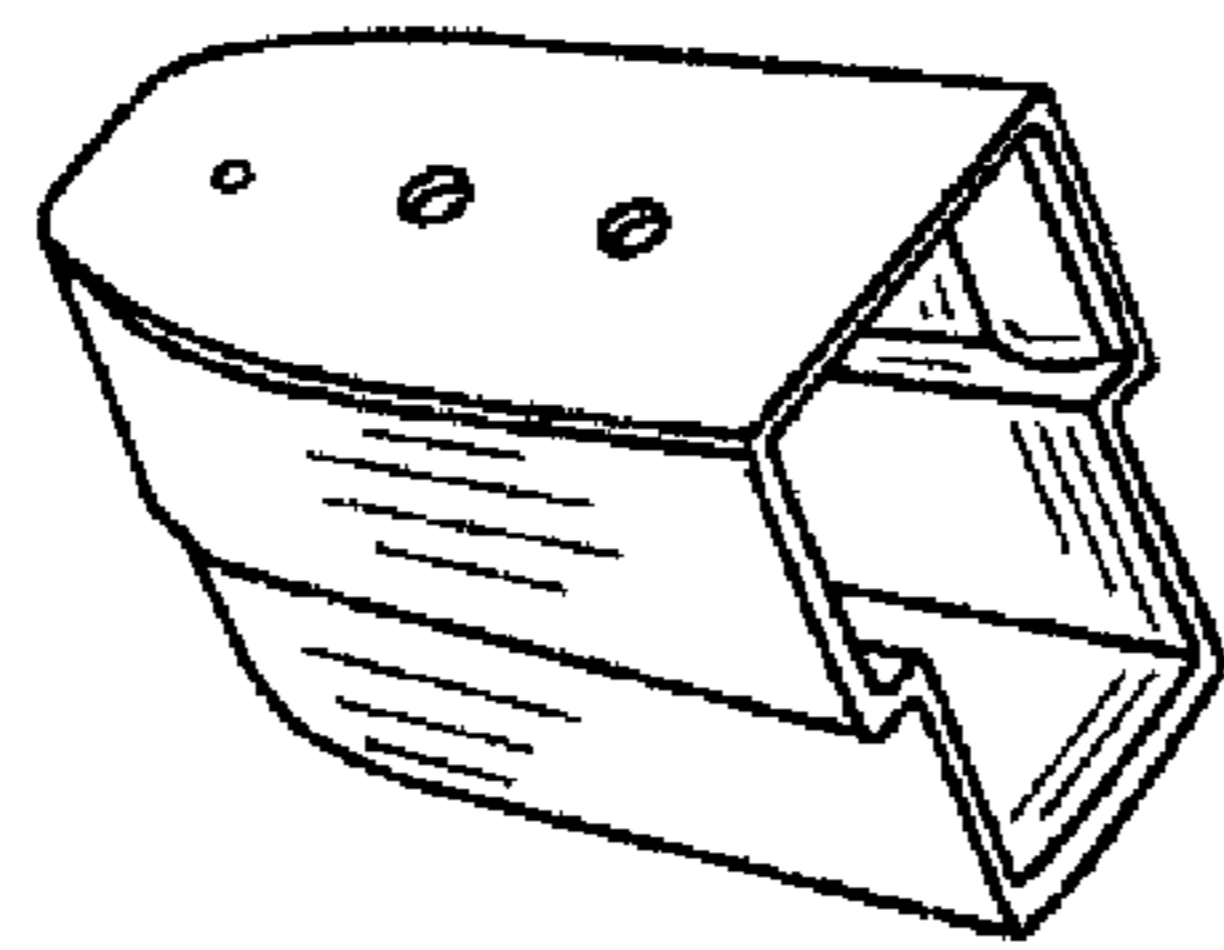

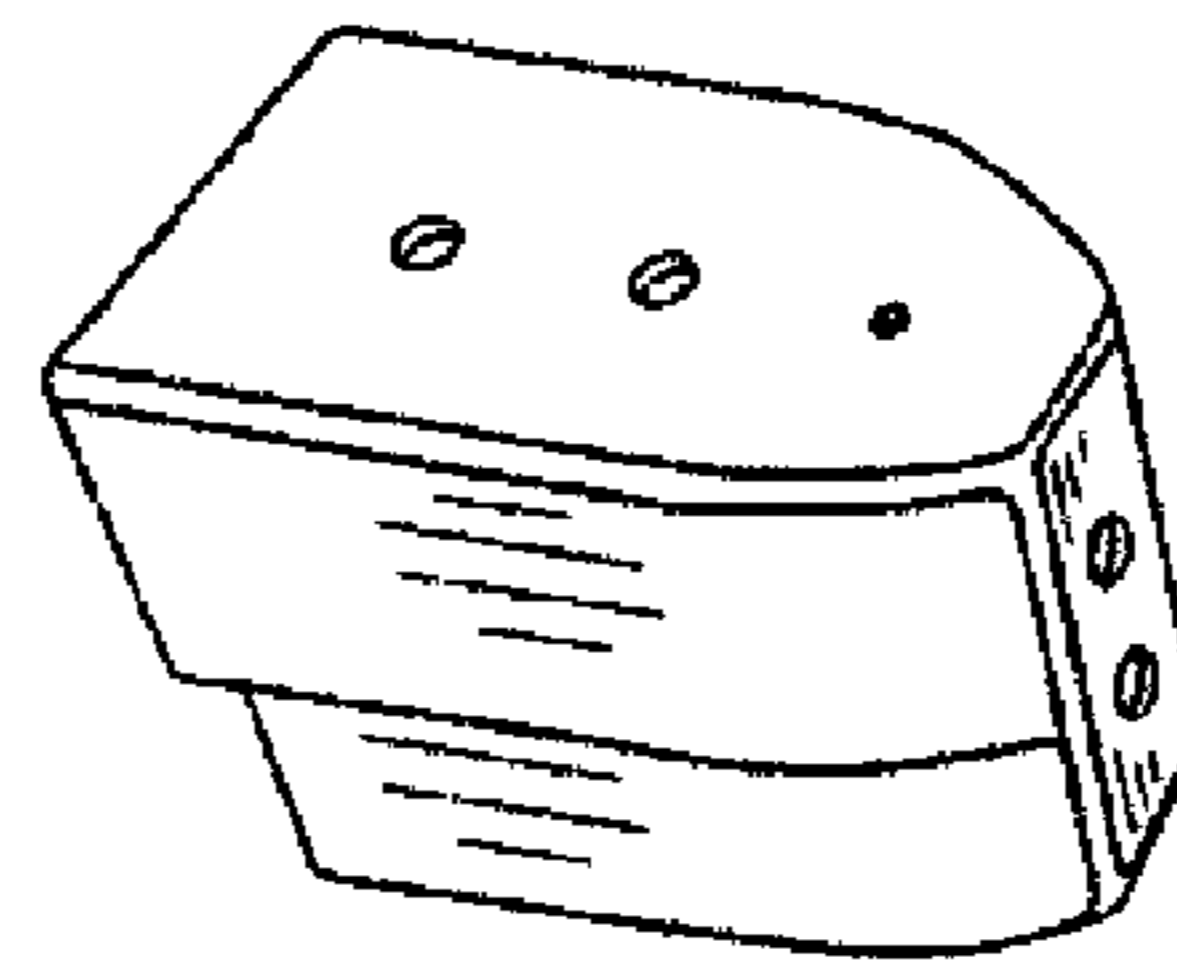

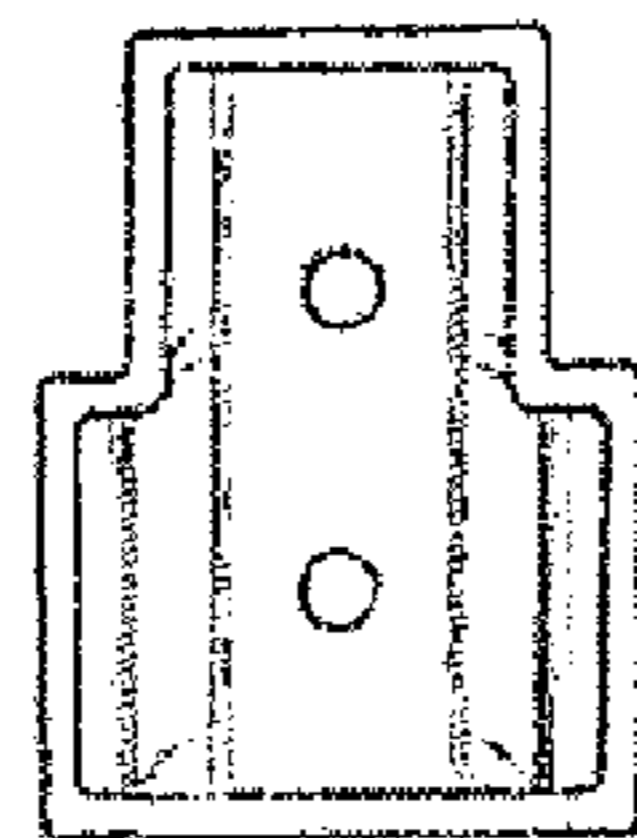
