(57) **CLAIM**

The ornamental design for a sports mascot decorative cup lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the front and top of the sports mascot decorative cup lid in which broken lines indicate the relative position of an unclaimed cup, straw and straw cap;

FIG. 2 is a perspective view taken from the rear and top of the sports mascot decorative cup lid of FIG. 1, in which broken lines indicate the relative position of an unclaimed cup, straw and straw cap;

FIG. 3 is a front elevation view of the sports mascot decorative cup lid of FIG. 1 in which broken lines indicate the relative position of an unclaimed cup, straw and straw cap;

FIG. 4 is a rear elevation view of the sports mascot decorative cup lid of FIG. 1, in which broken lines indicate the relative position of an unclaimed cup, straw and straw cap;

FIG. 5 is a side elevation view of the sports mascot decorative cup lid of FIG. 1, in which broken lines indicate the relative position of an unclaimed cup, straw and straw cap;

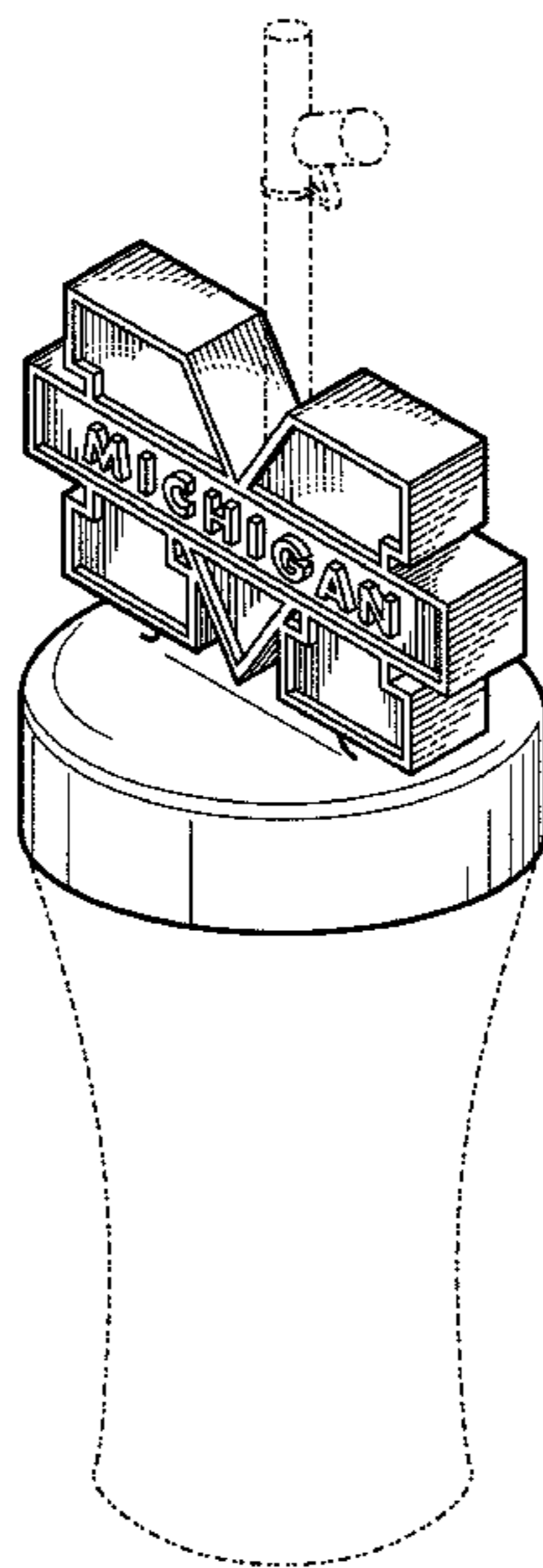
FIG. 6 is a side elevation view of the sports mascot decorative cup lid of FIG. 1, in which broken lines indicate the relative position of an unclaimed cup, straw and straw cap and the view is opposite of that depicted in FIG. 5; and,

FIG. 7 is a top plan view of the sports mascot decorative cup lid of FIG. 1, in which broken lines indicate the relative position of an unclaimed cup, straw and straw cap.

The broken lines showing a cup, straw and straw cap illustrate environmental structure which forms no part of the claimed design.

The ornamental design that is claimed is shown in solid lines in the drawings. The stylized “M” and “MICHIGAN” design forming part of the claimed design is a registered trademark of the University of Michigan.

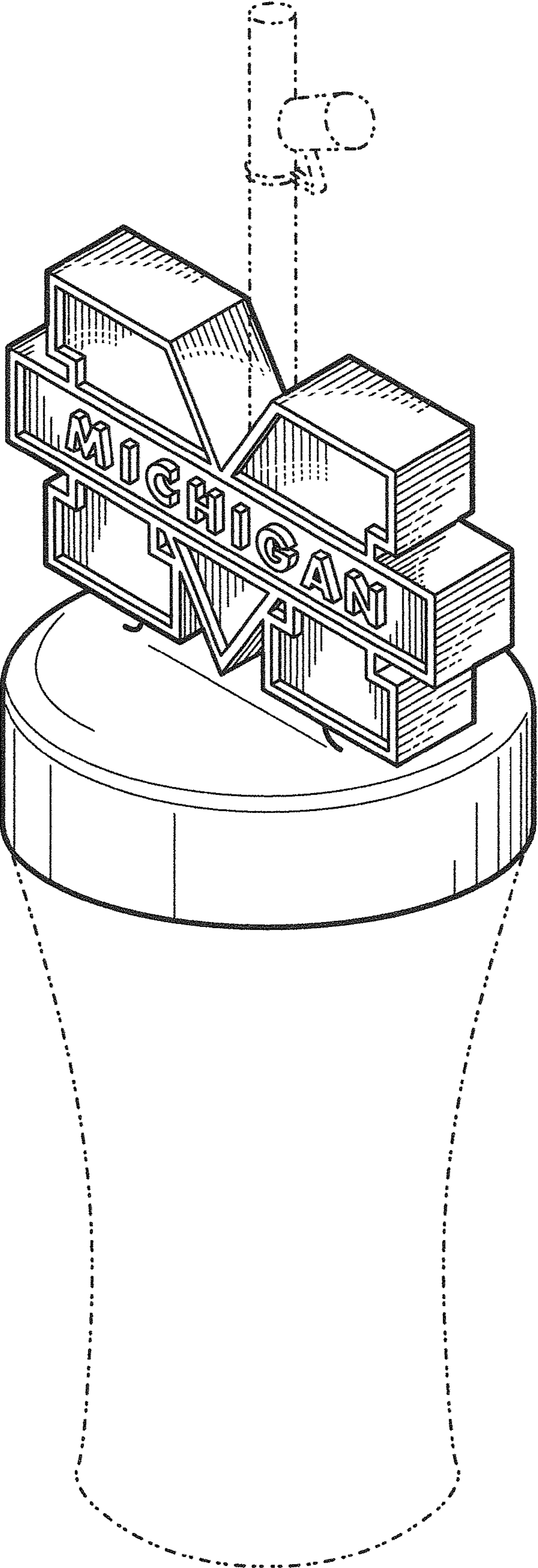

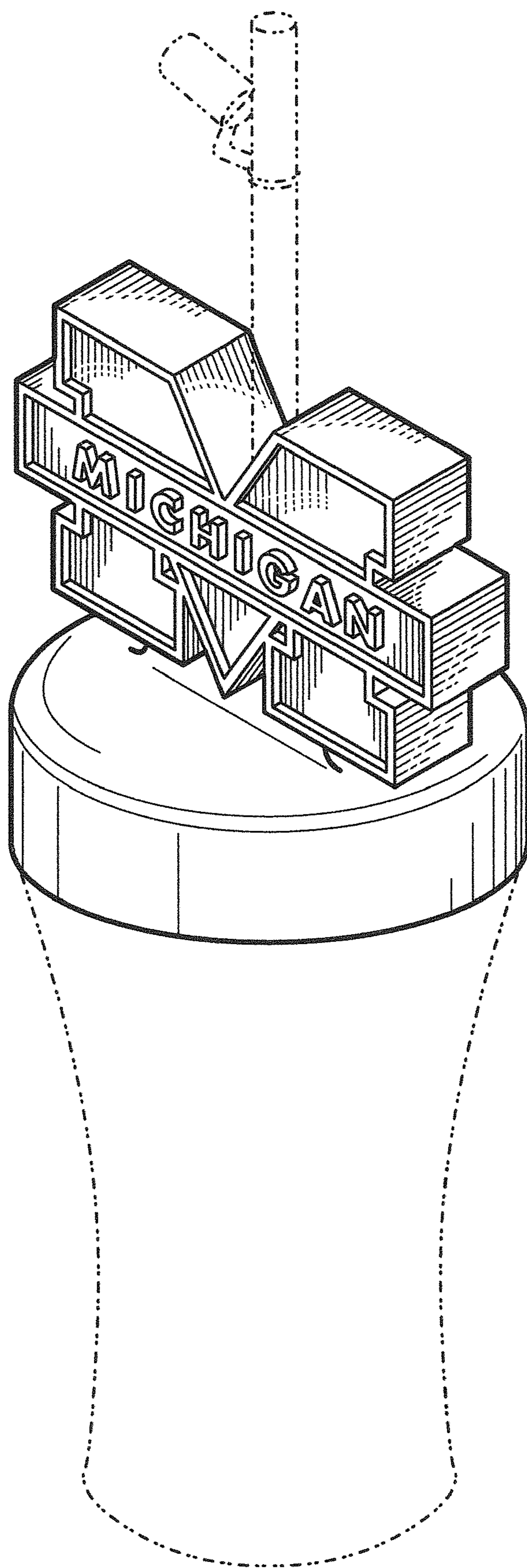

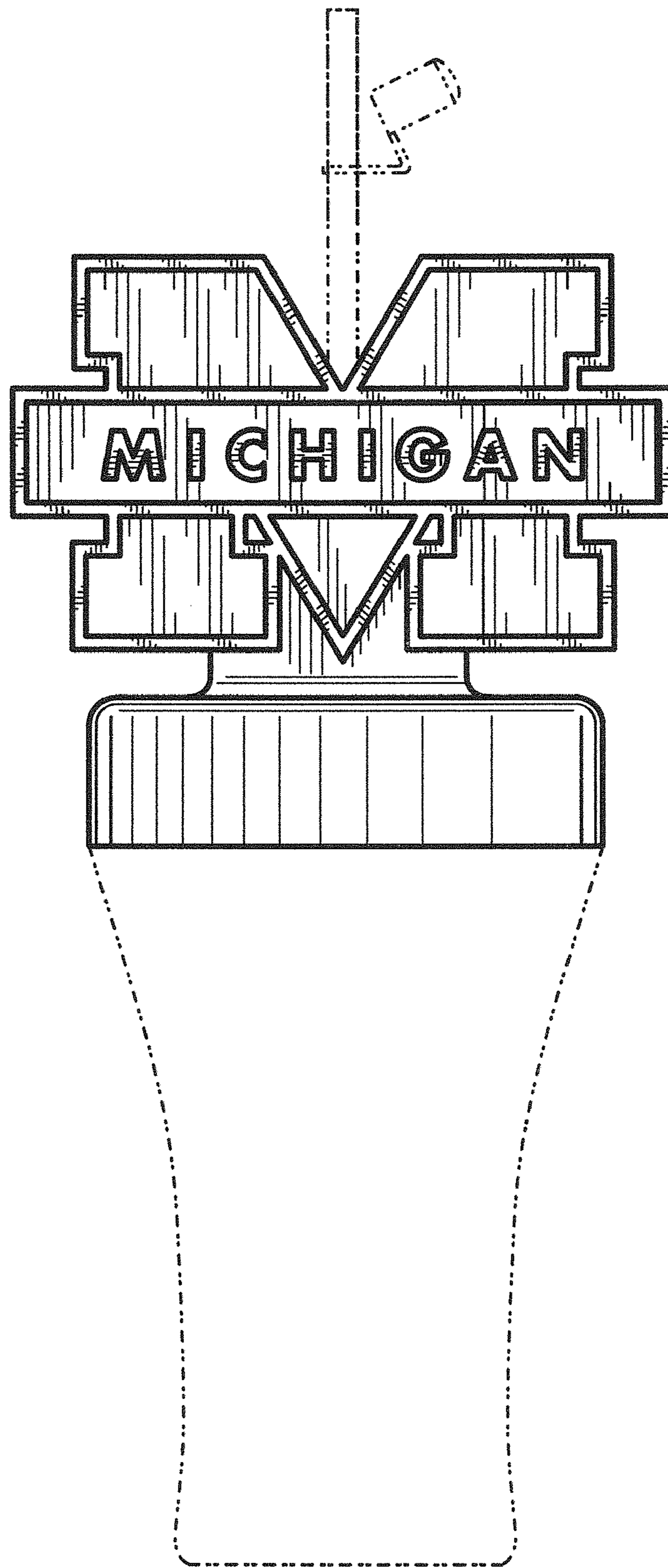

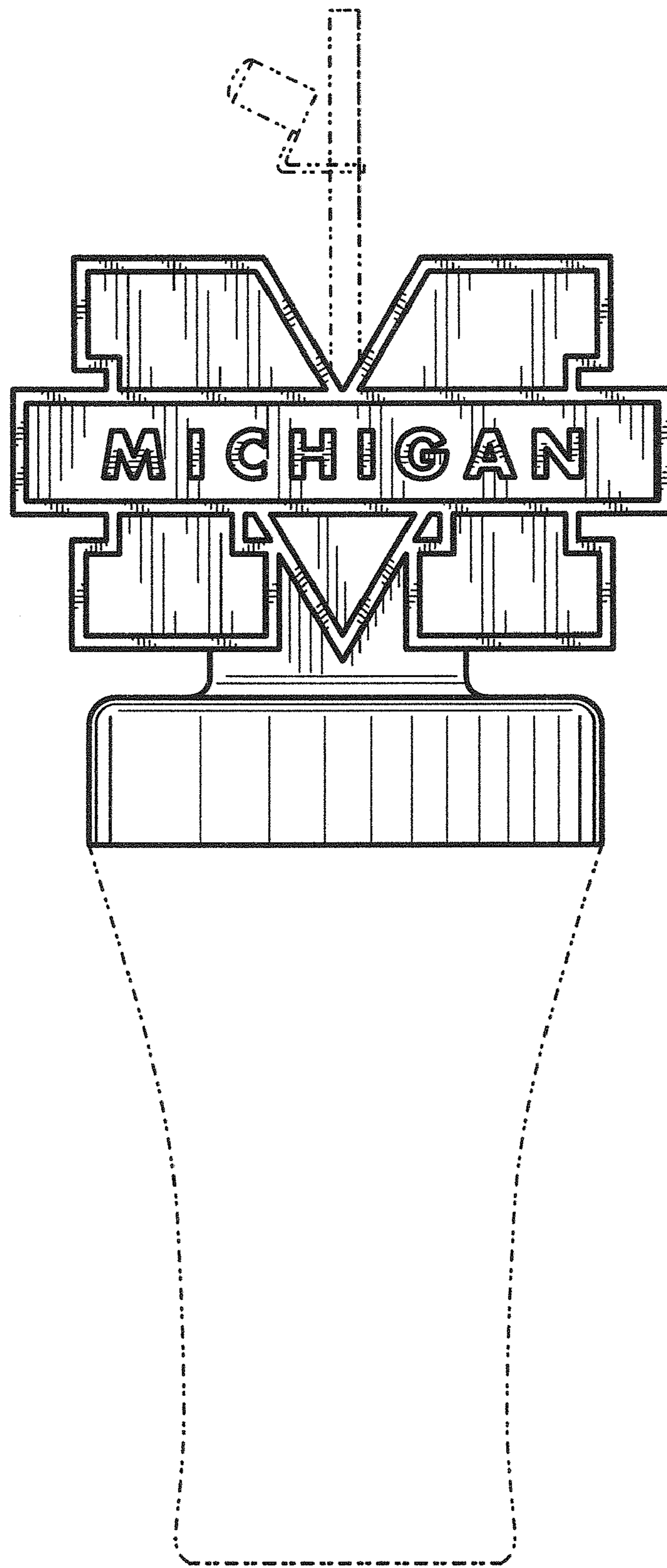

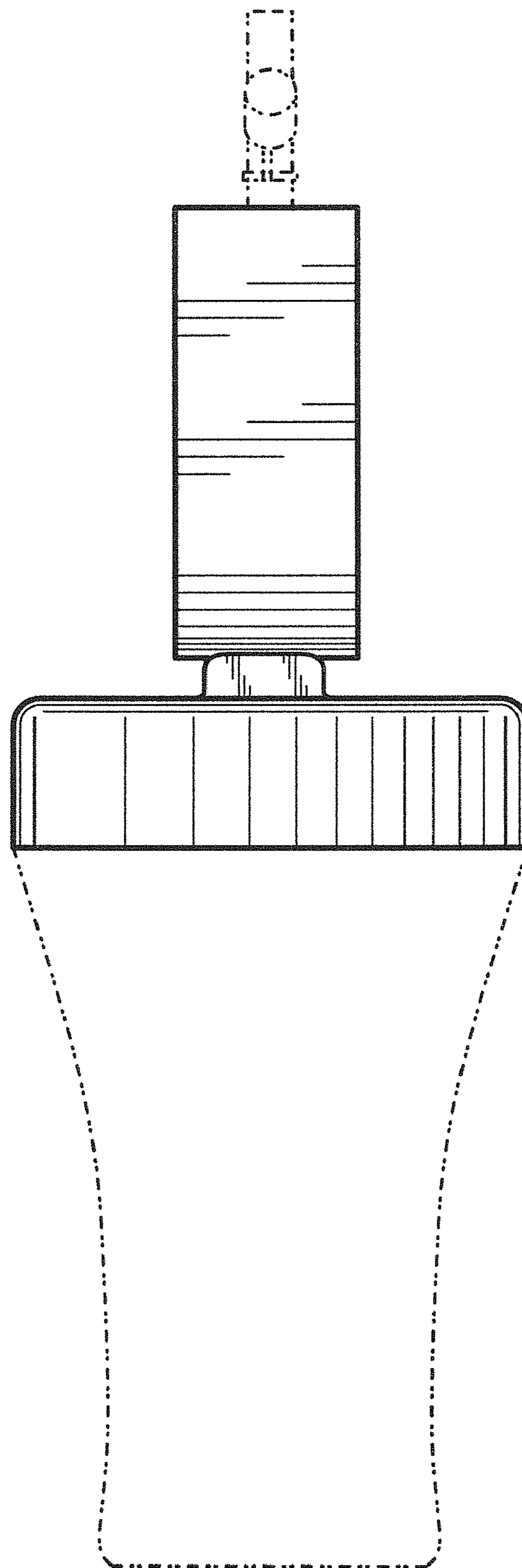

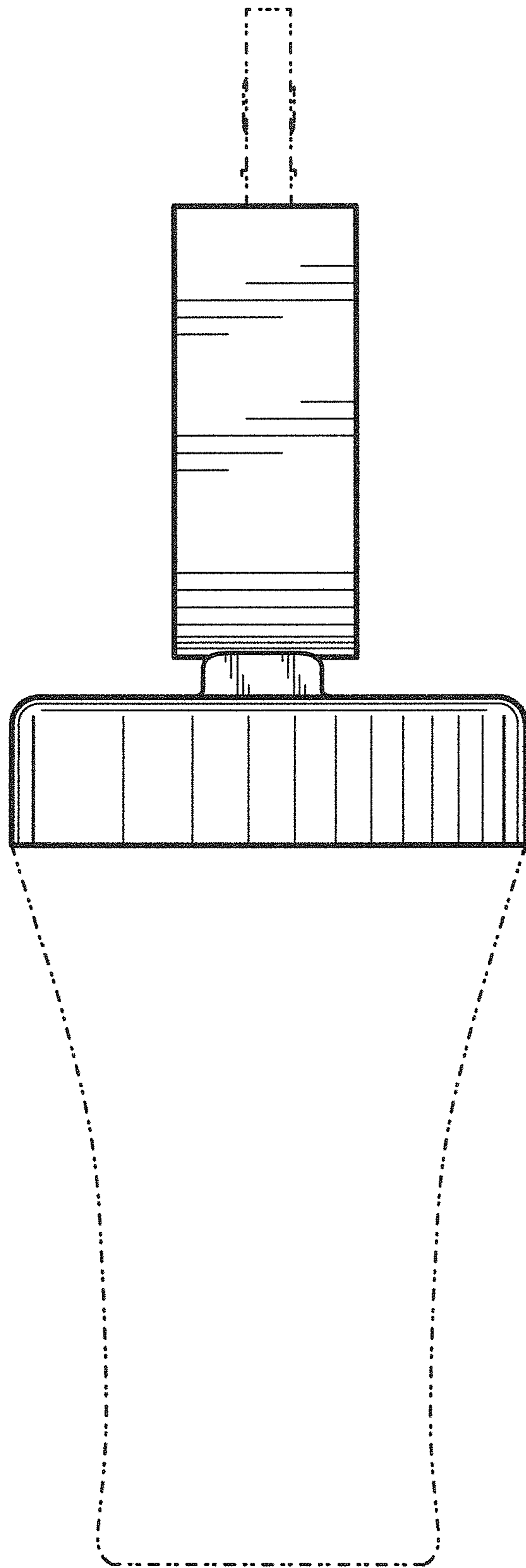

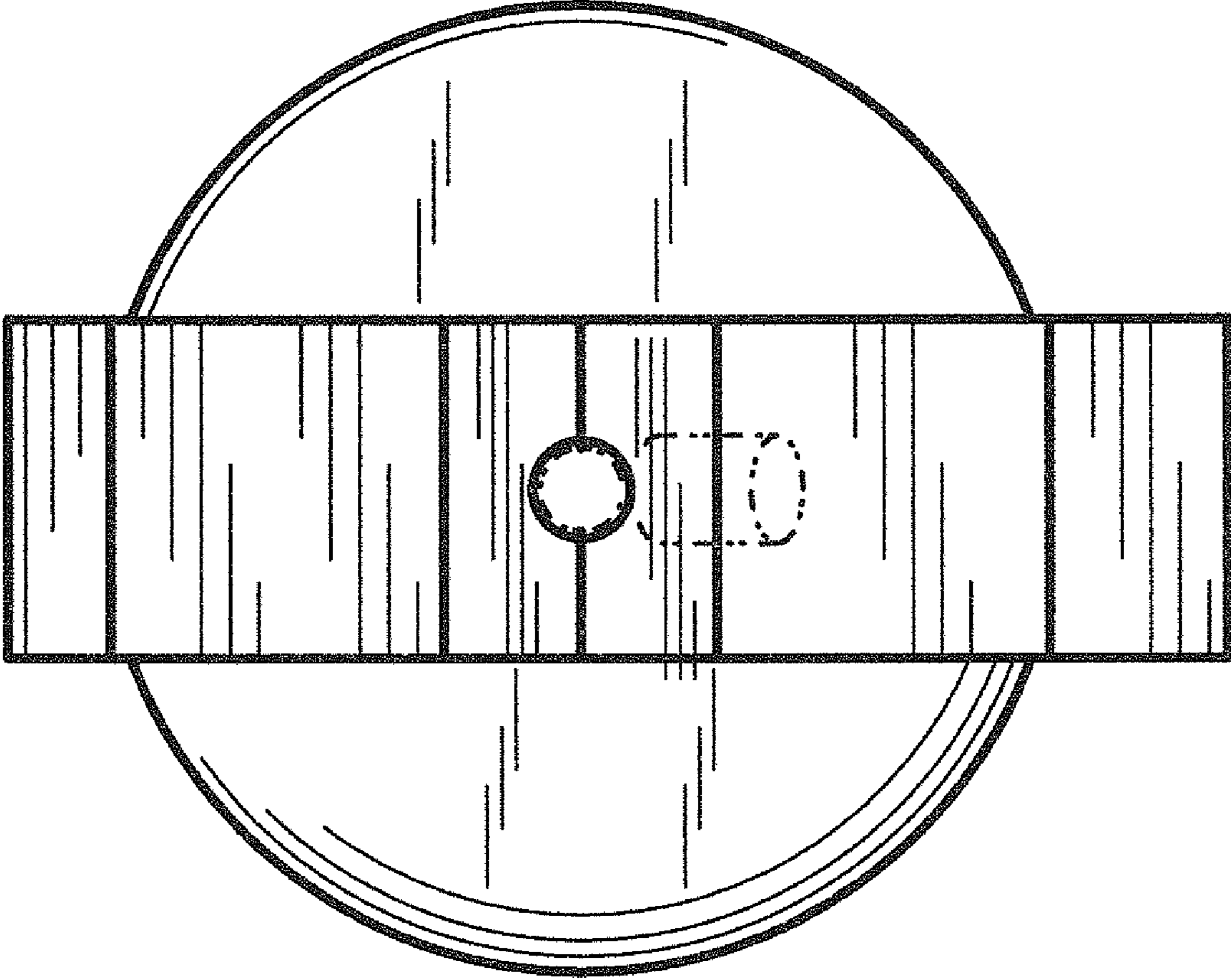
