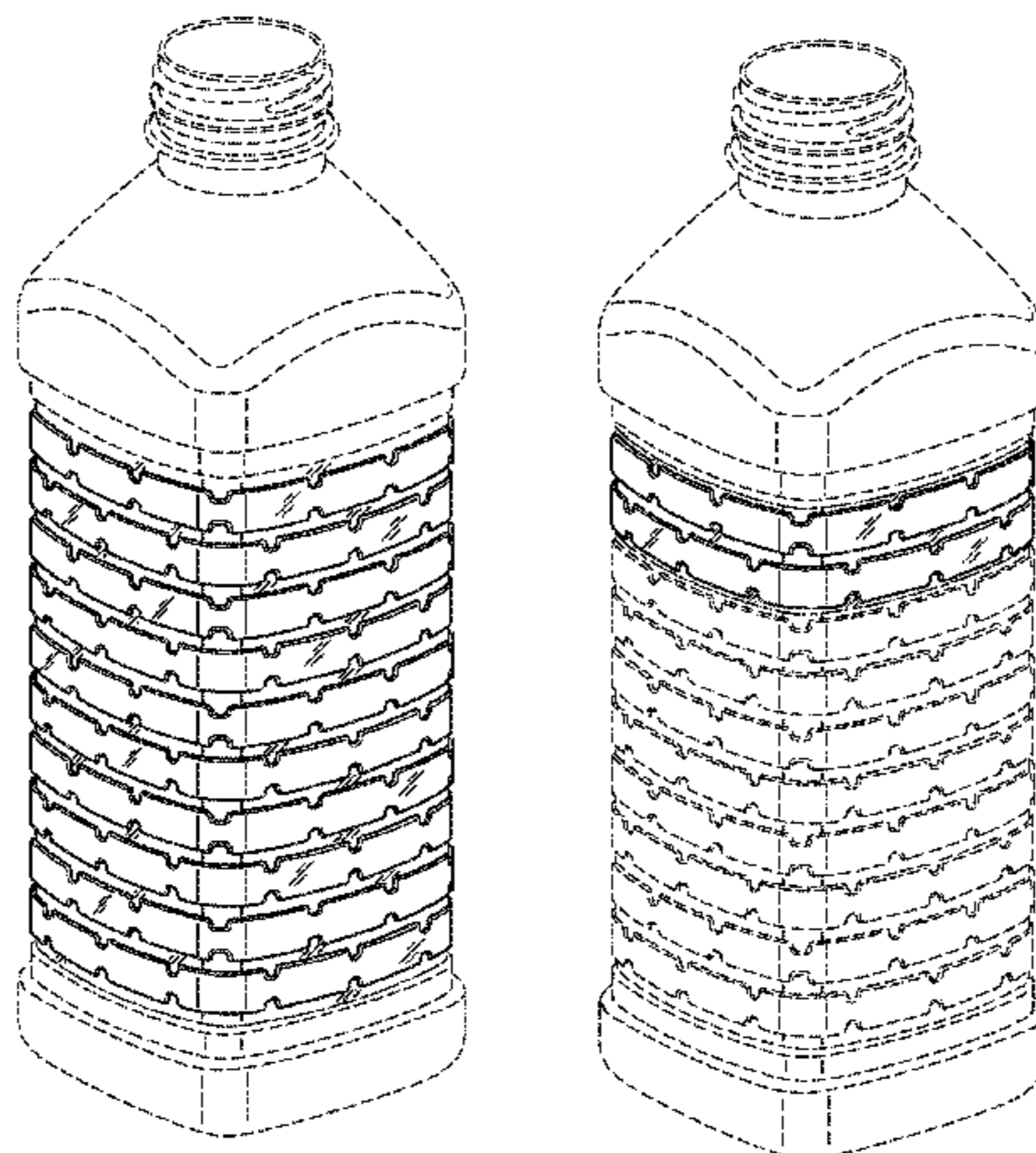
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a first embodiment of a bottle showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a top, front, right side perspective view of a second embodiment of a bottle showing my new design; FIG. 9 is a front elevational view thereof; FIG. 10 is a right side elevational view thereof; FIG. 11 is a rear elevational view thereof; FIG. 12 is a left side elevational view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof. The dash-dash-dash-dash broken lines shown in the drawings are included for the purpose of illustrating environmental structure and form no part of the claimed design. The dot-dash-dot-dash broken lines shown in the drawings represent the unclaimed boundaries of the claimed design. The oblique shade lines shown in the drawing views indicate a transparent surface.

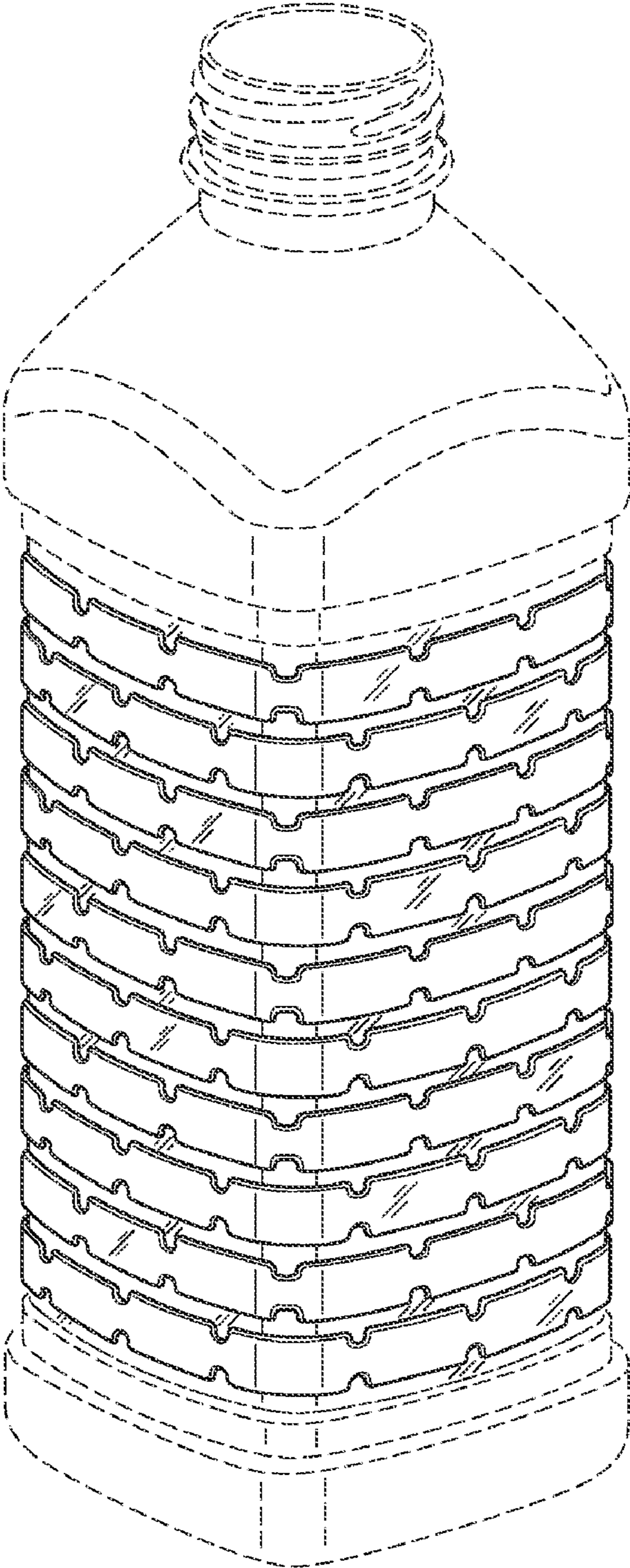

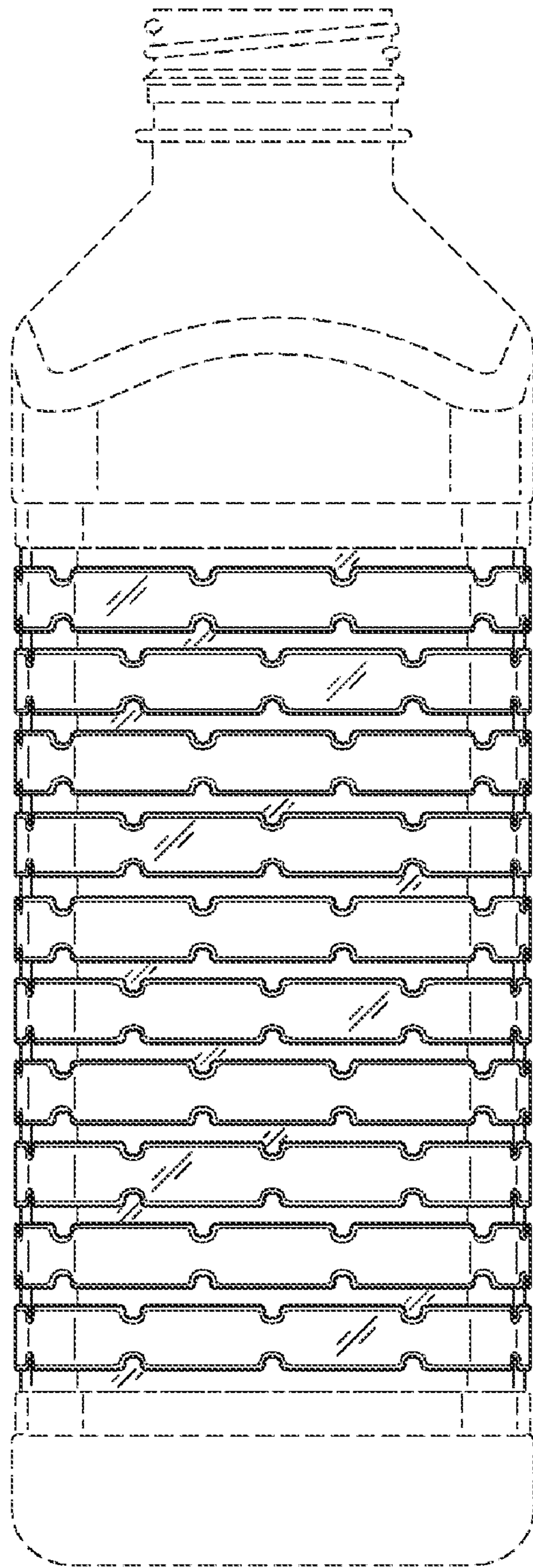

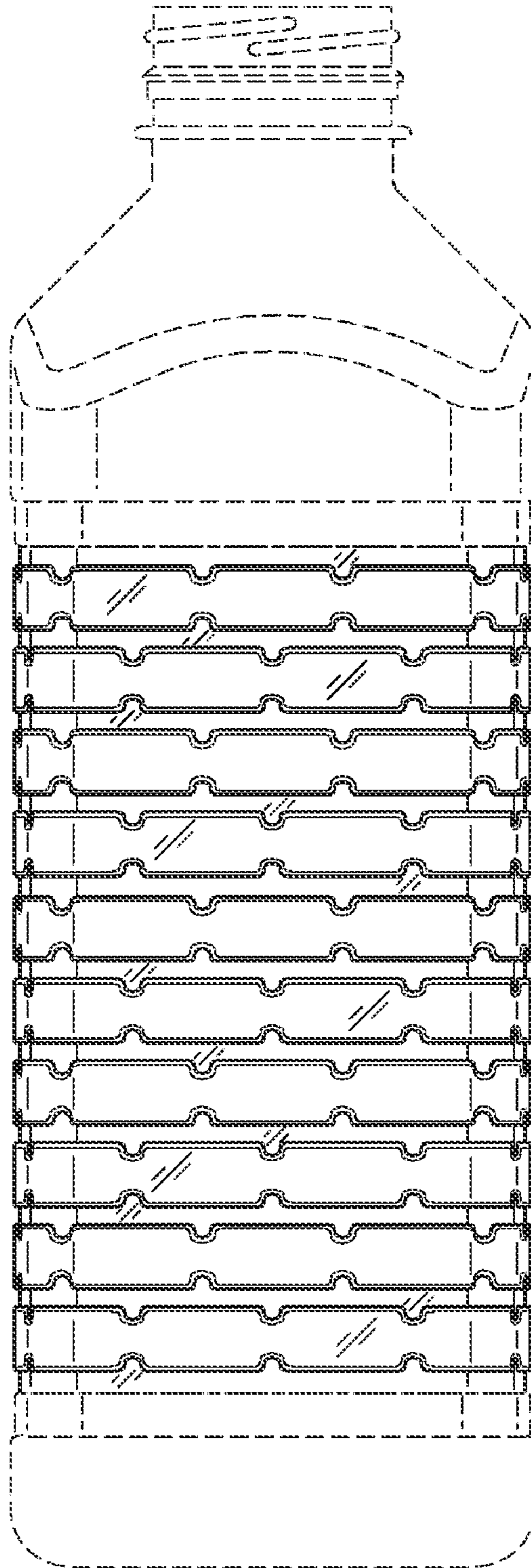

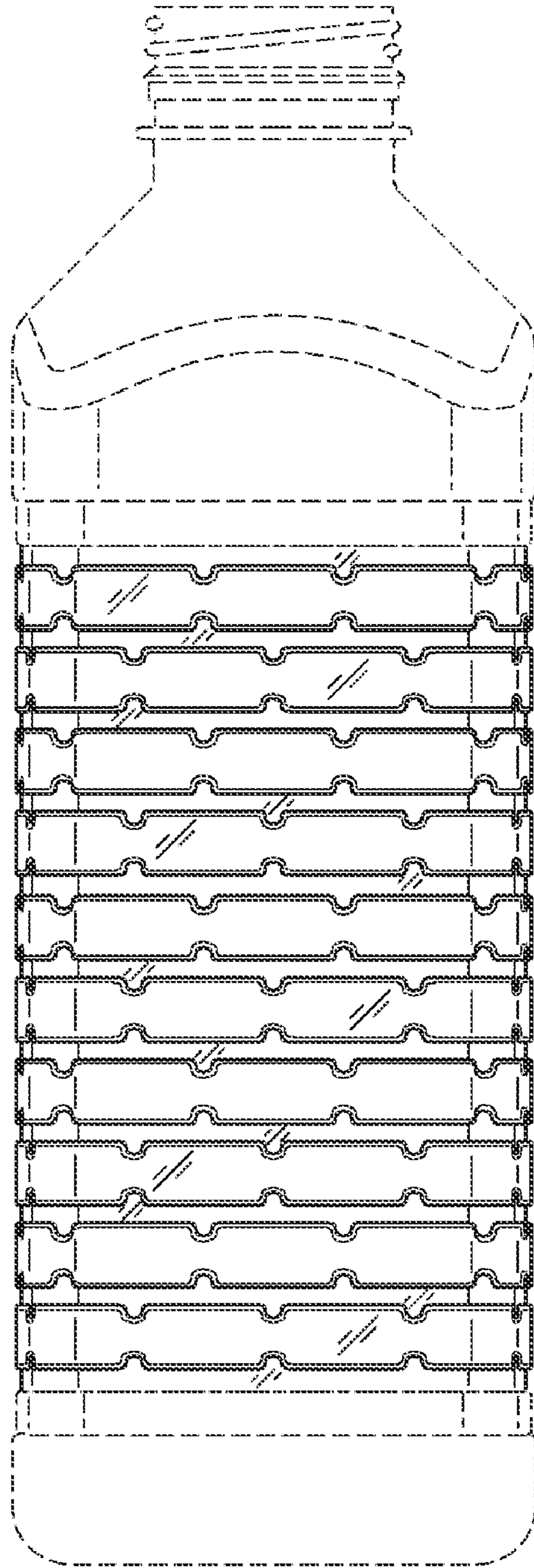

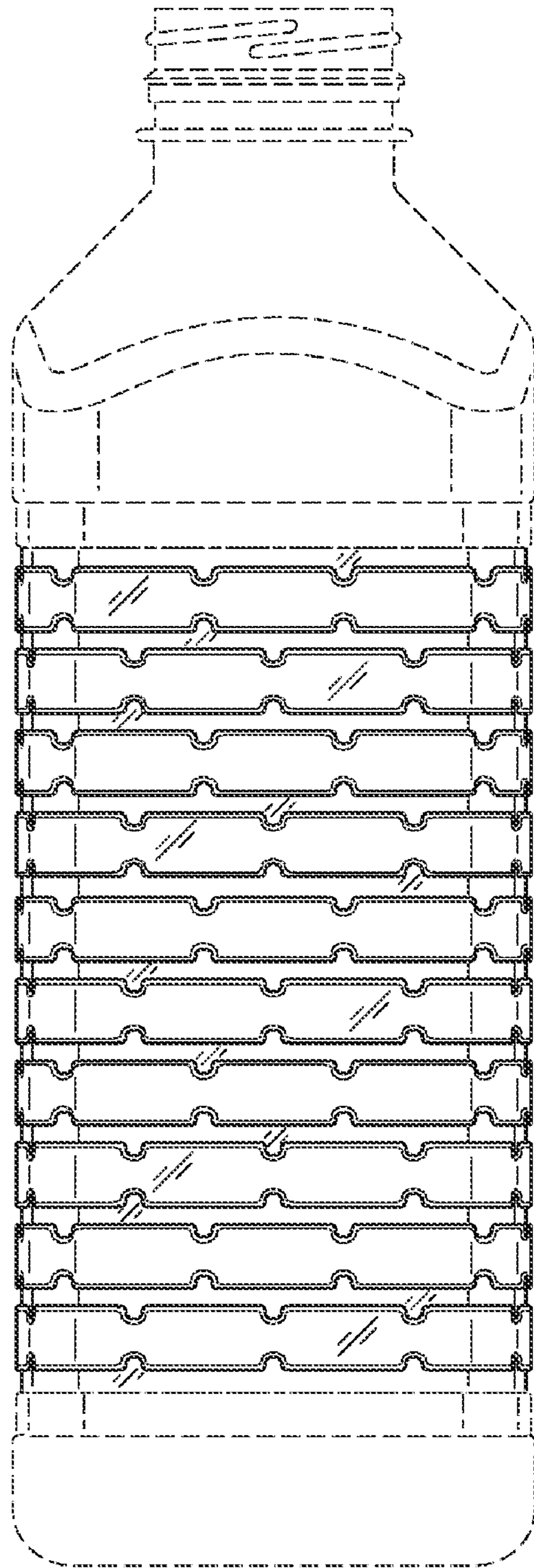

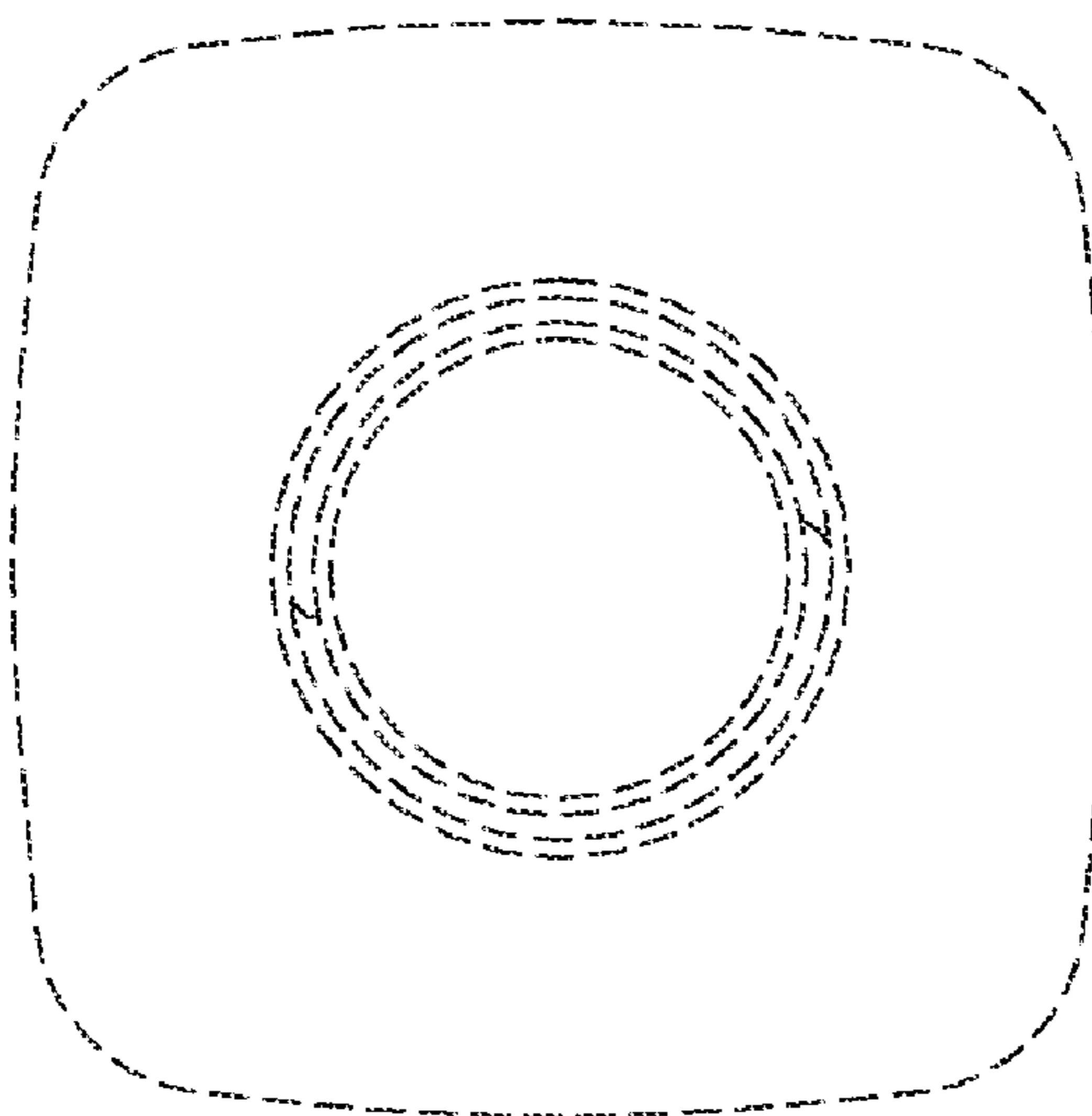

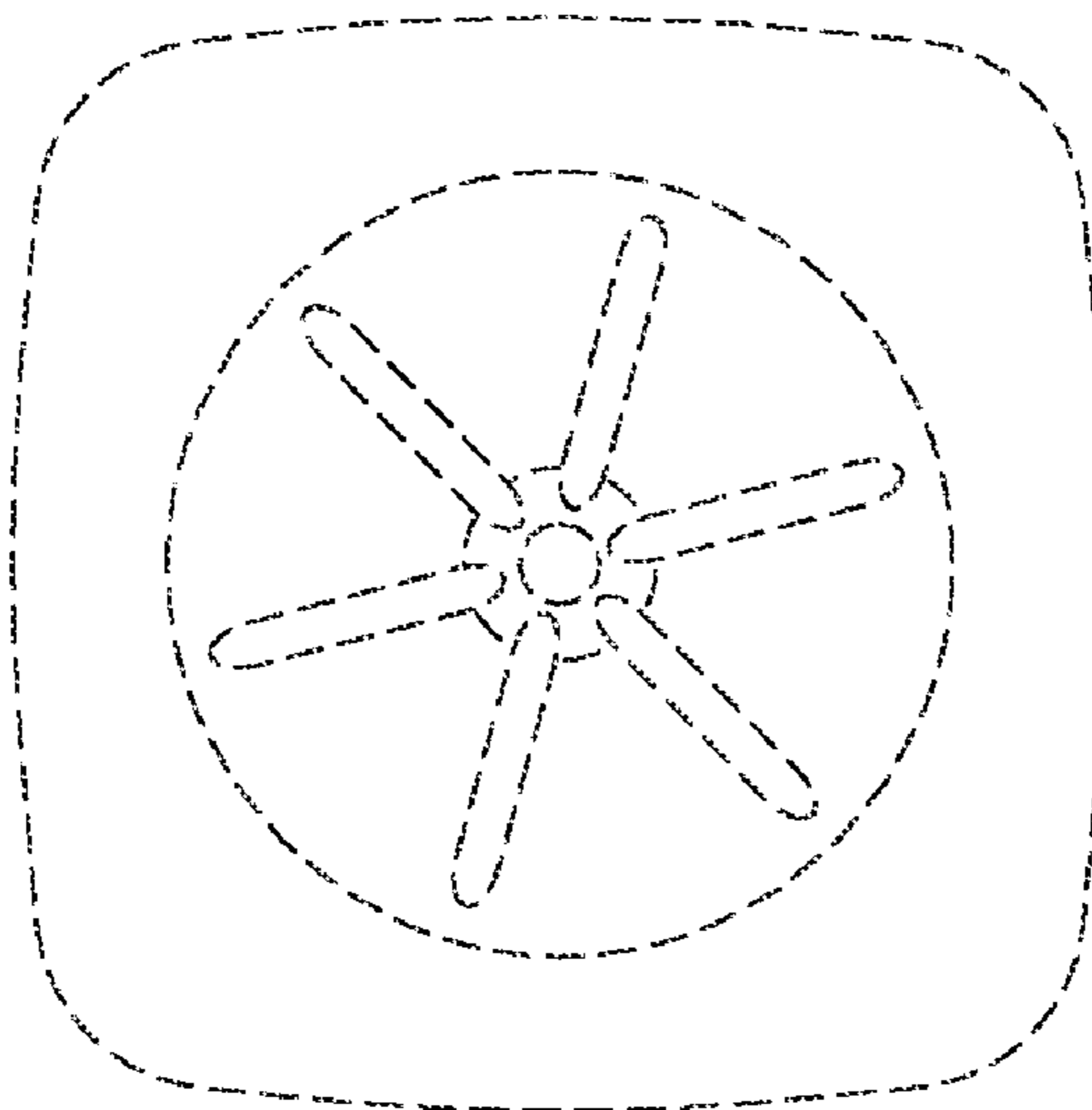

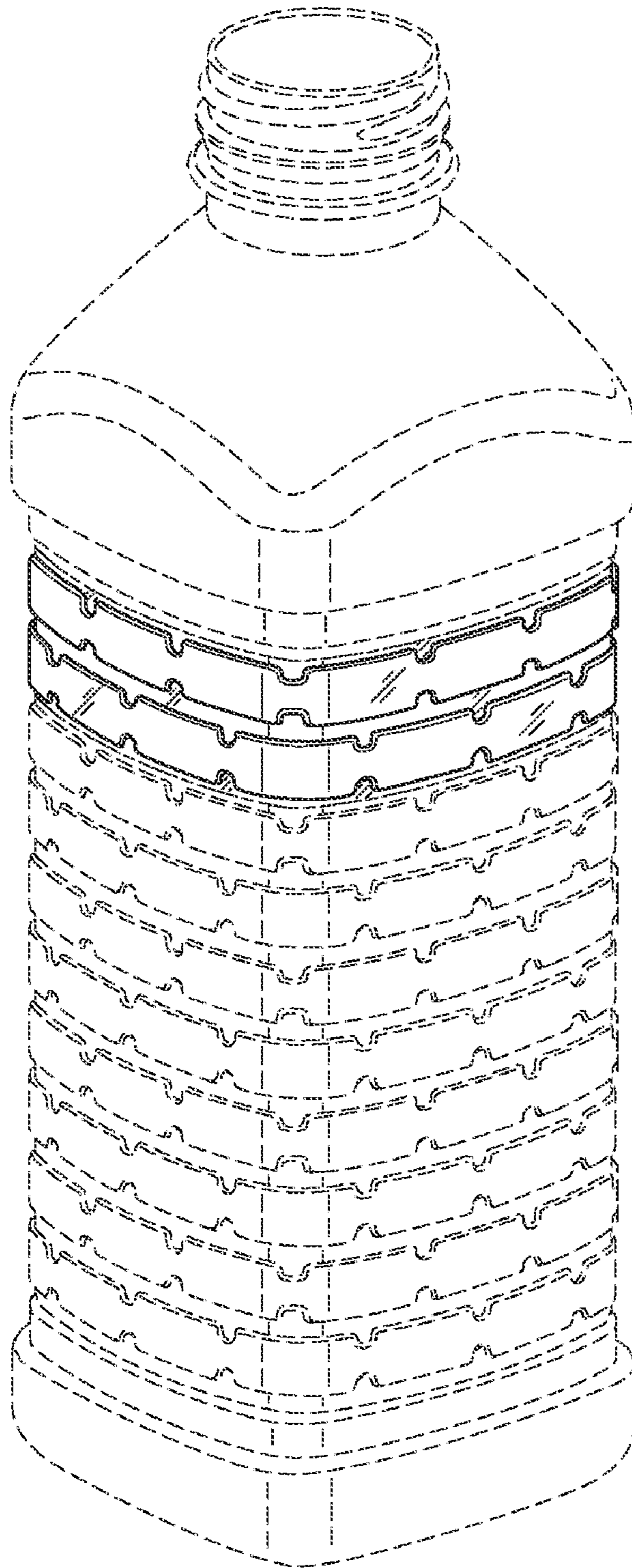

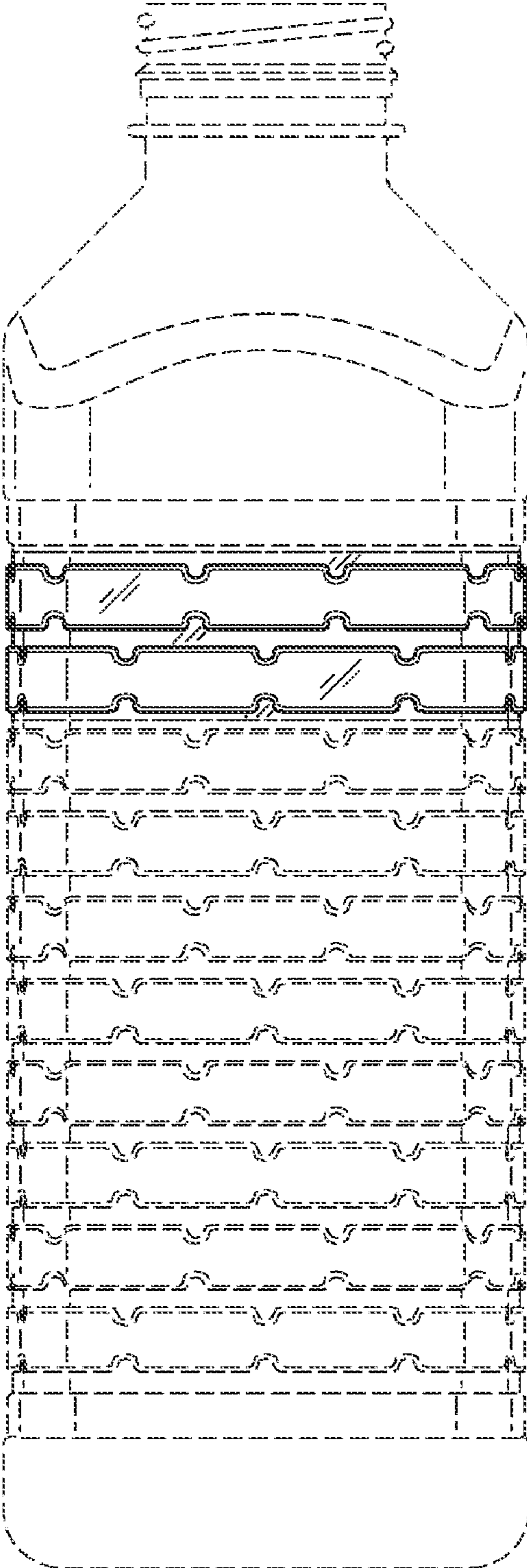

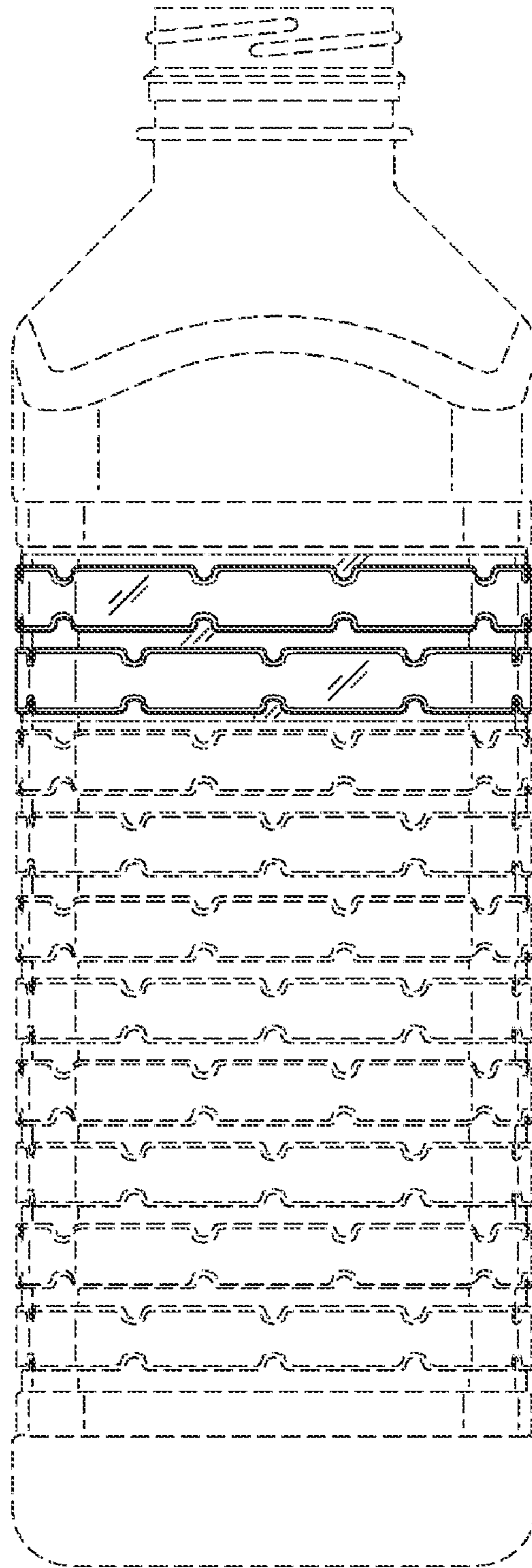

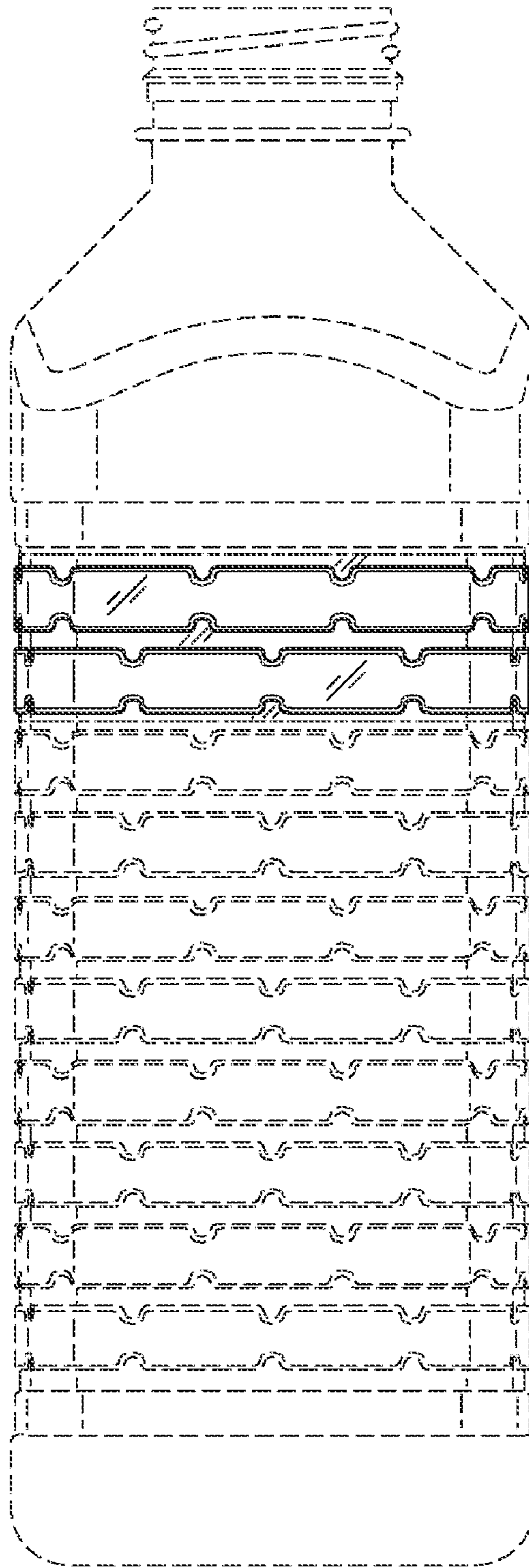

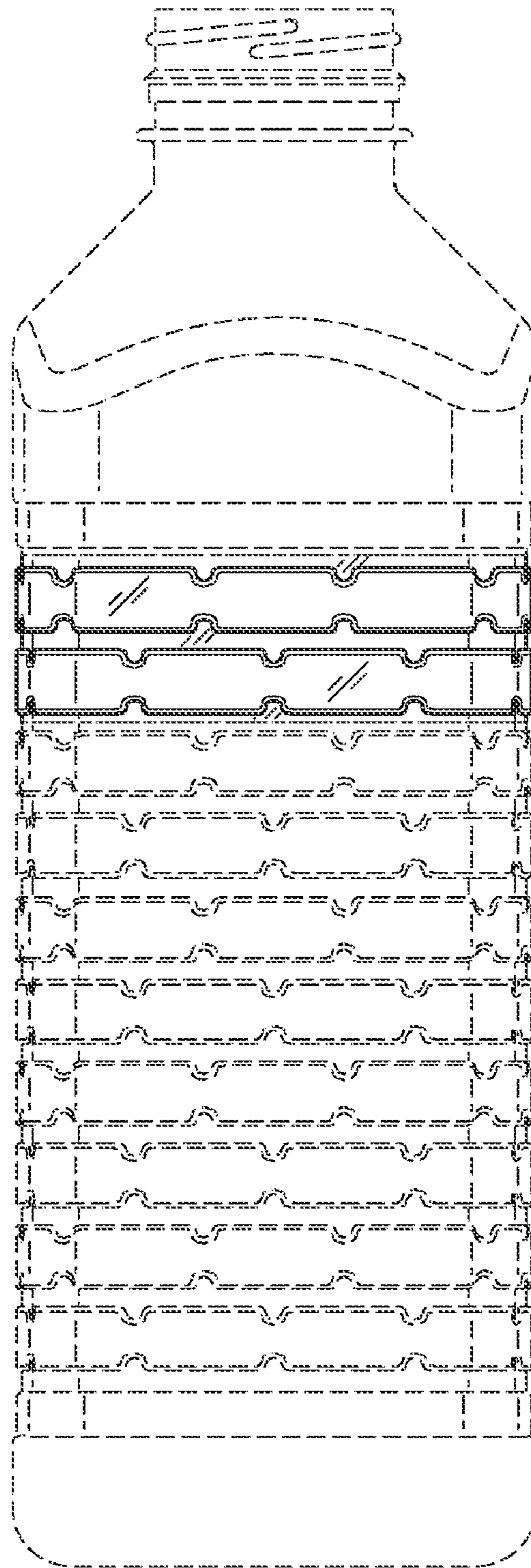

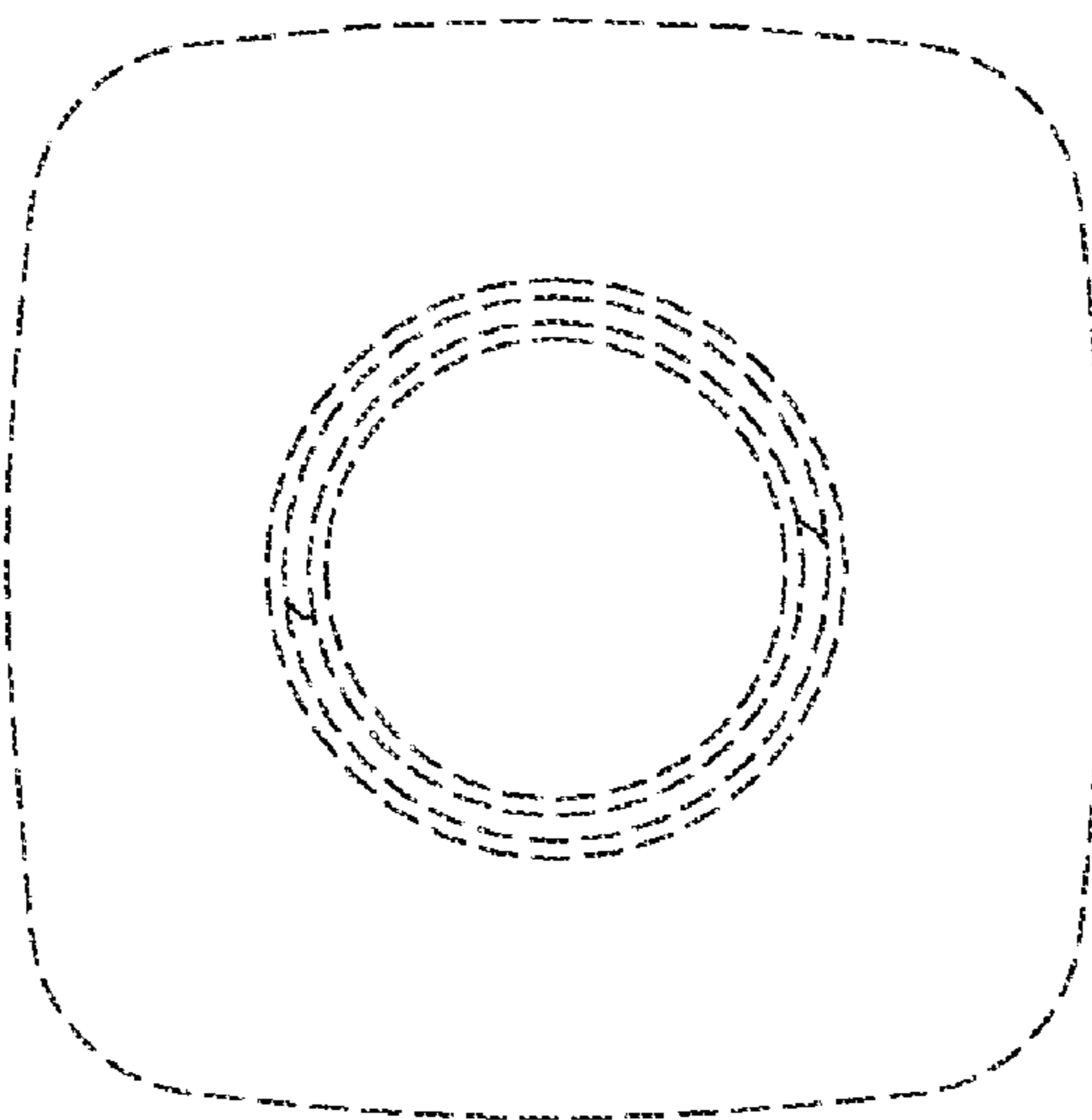

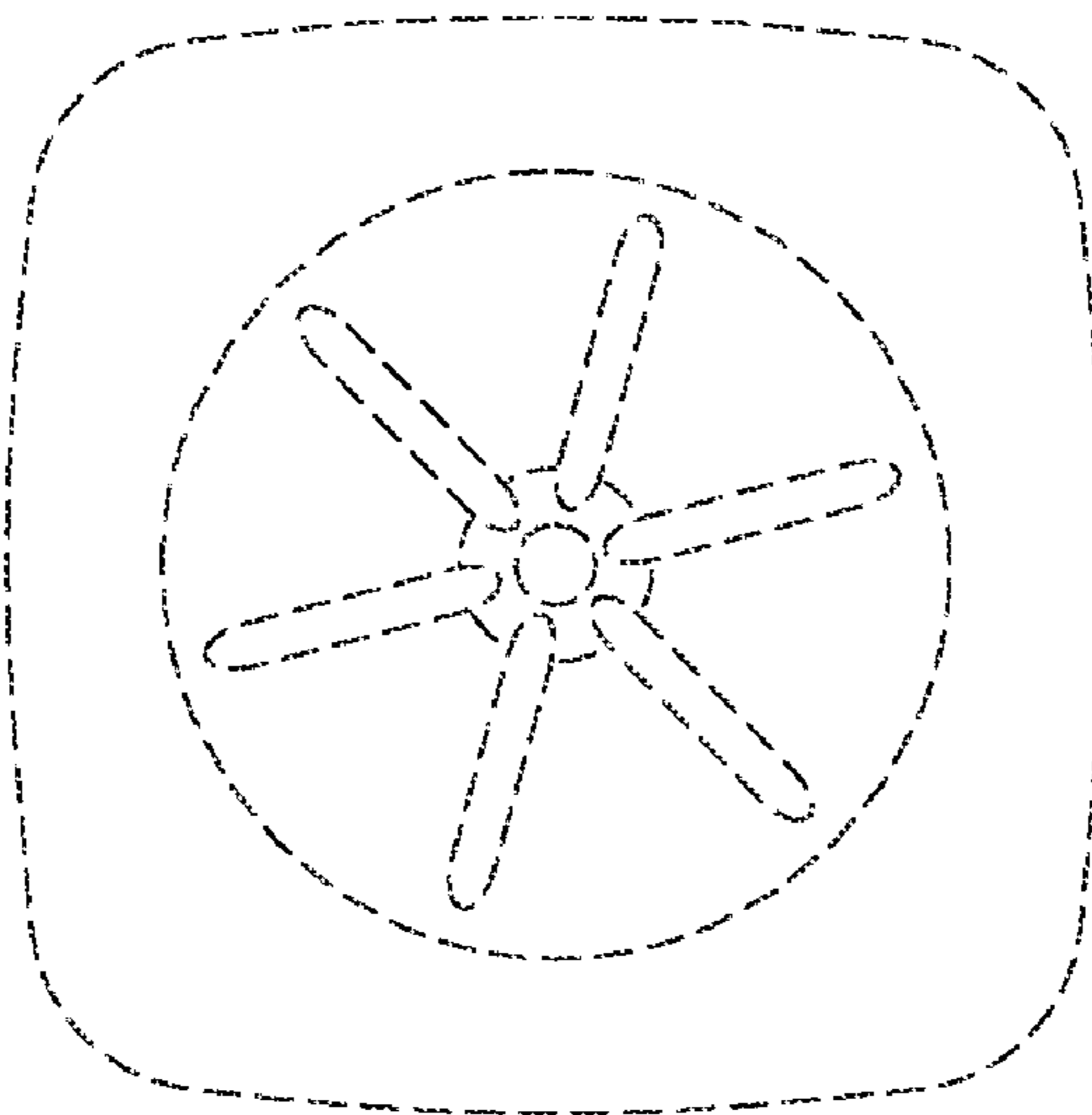
