(57) **CLAIM**

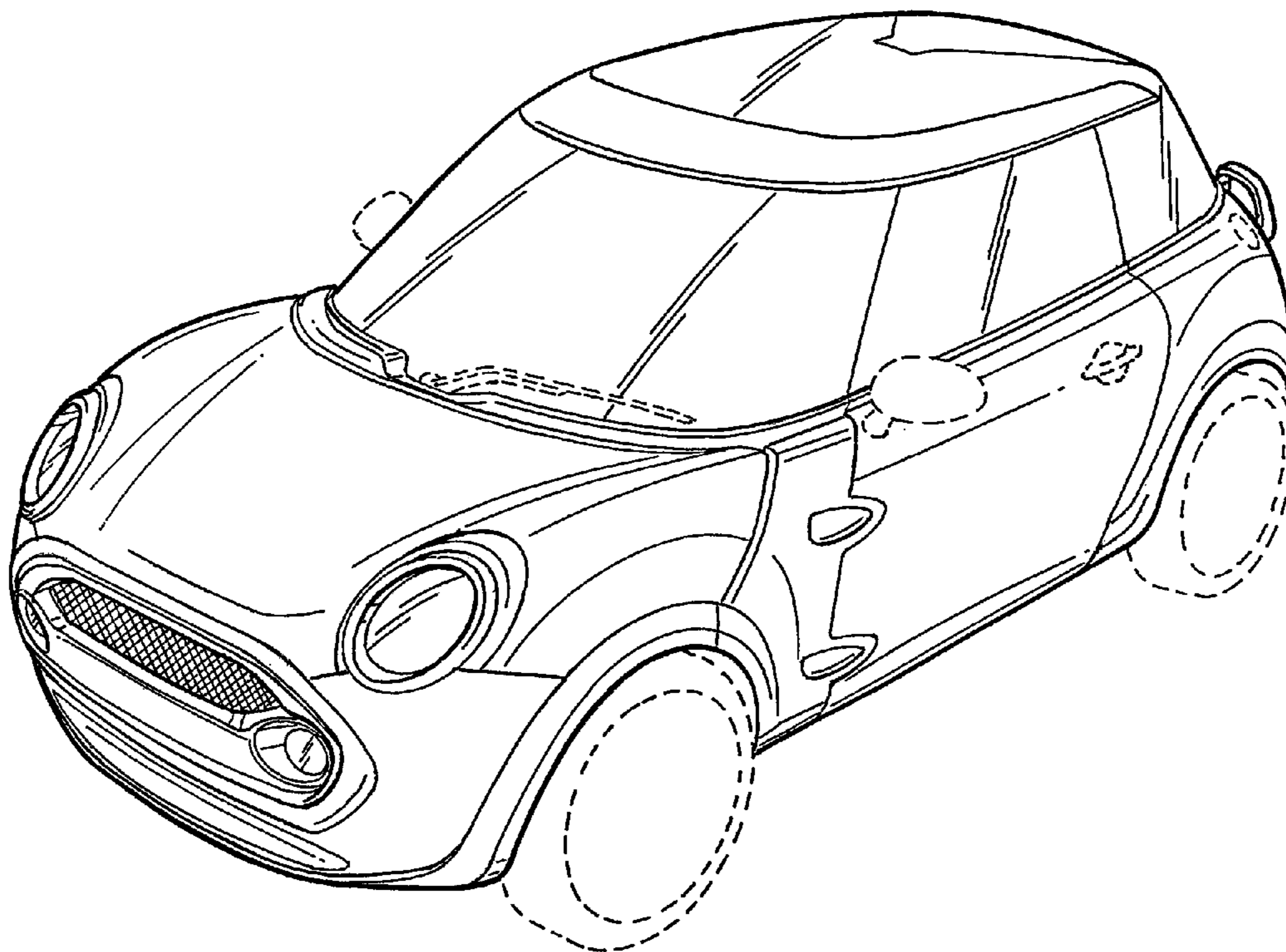
The ornamental design for a vehicle, toy, and/or replicas thereof, as shown and described.

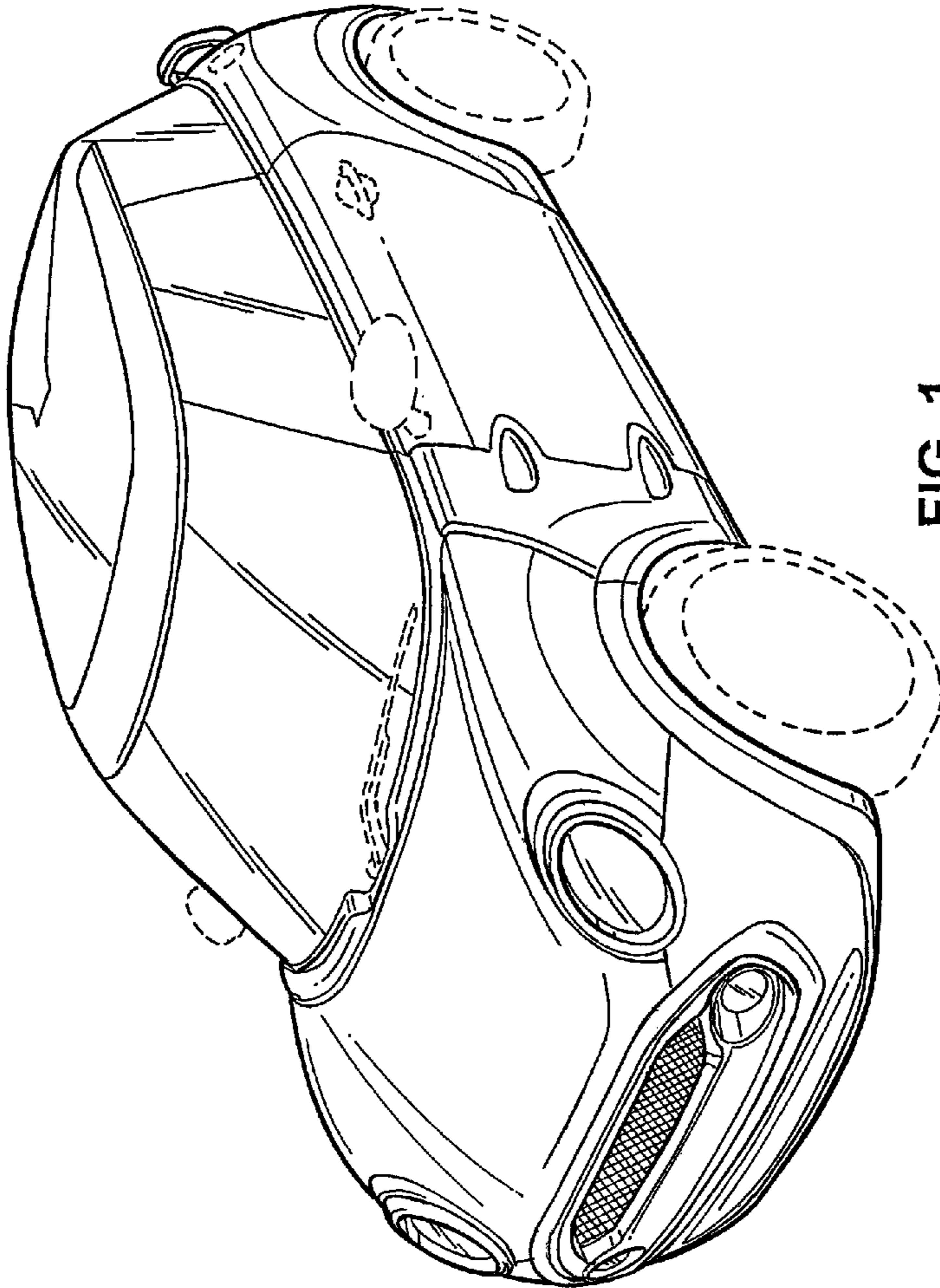

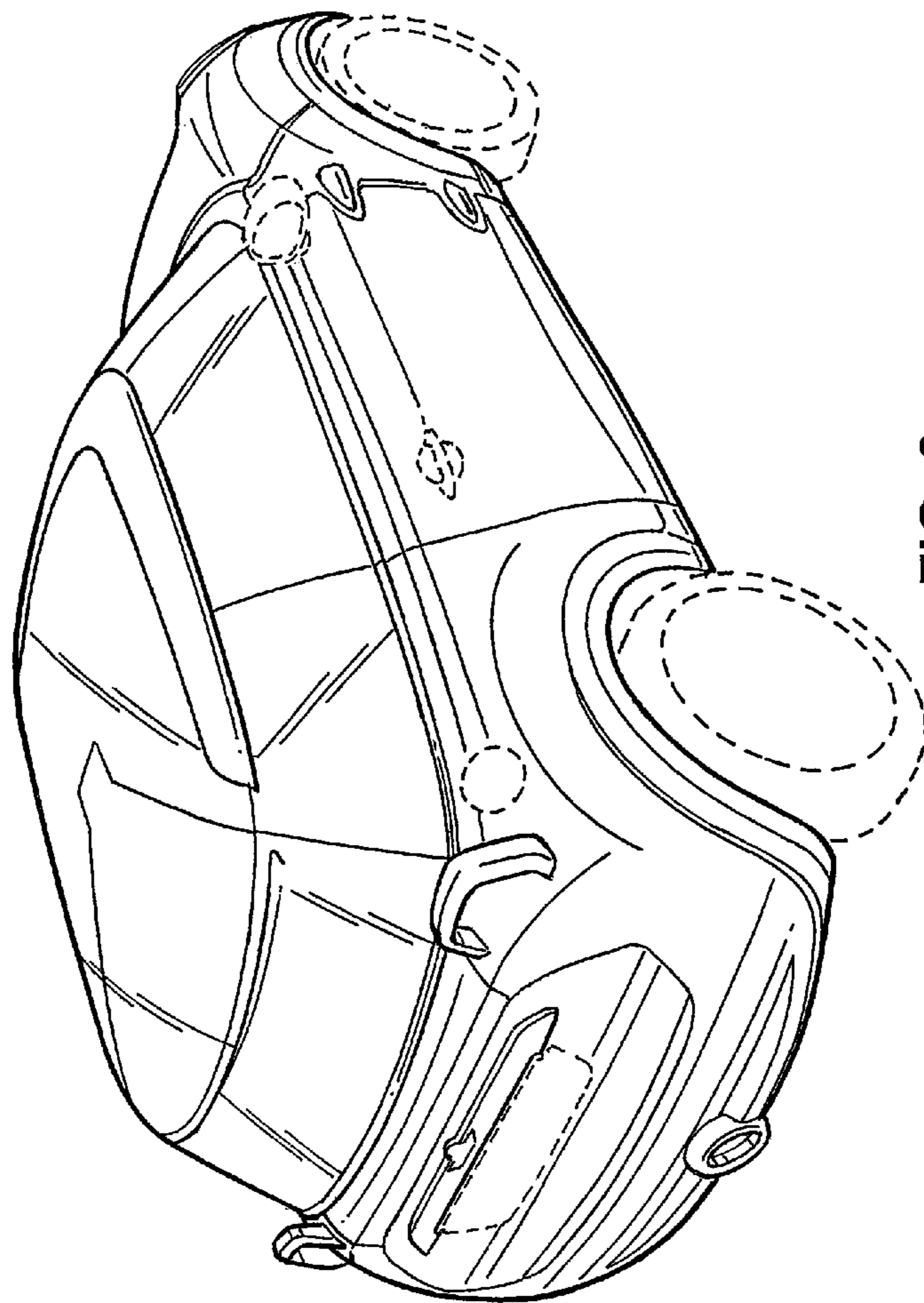

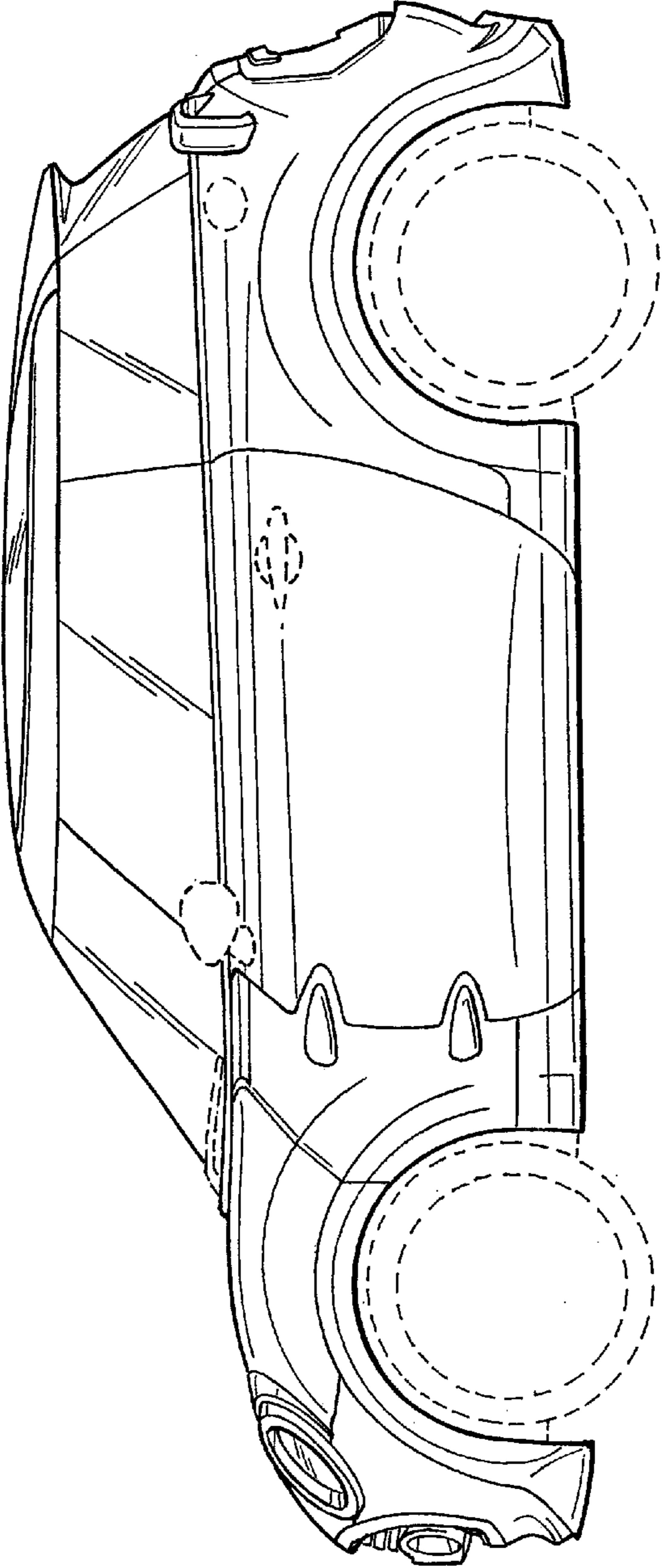

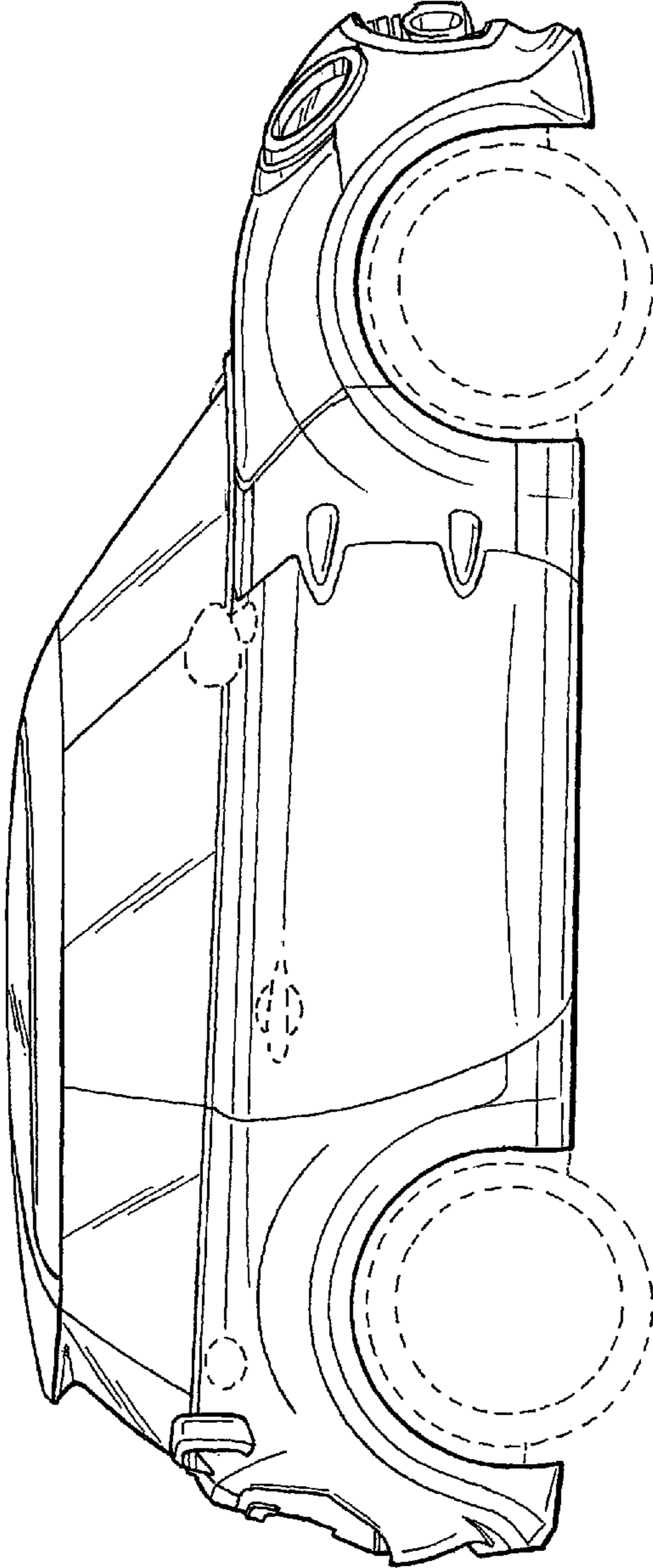

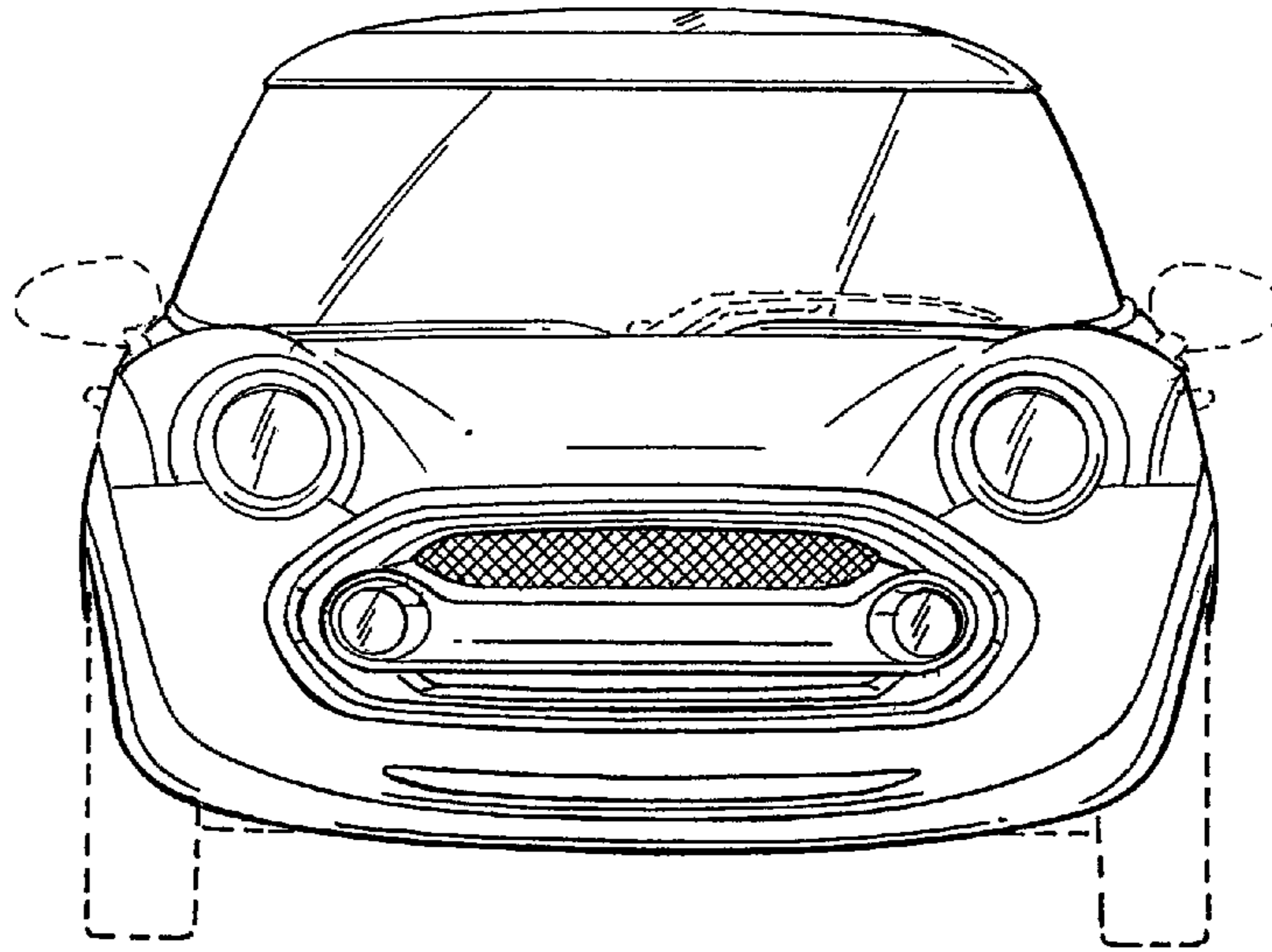

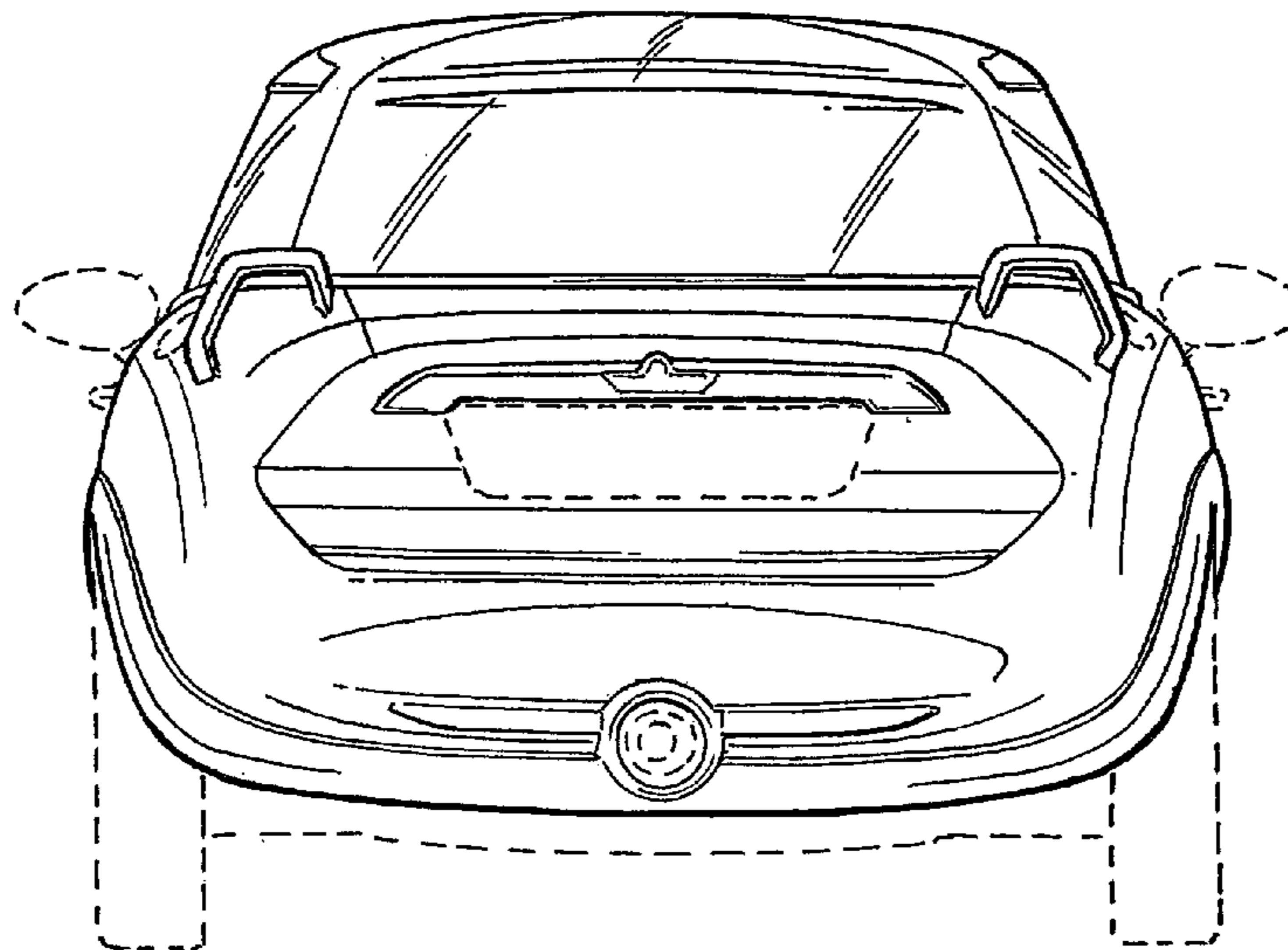

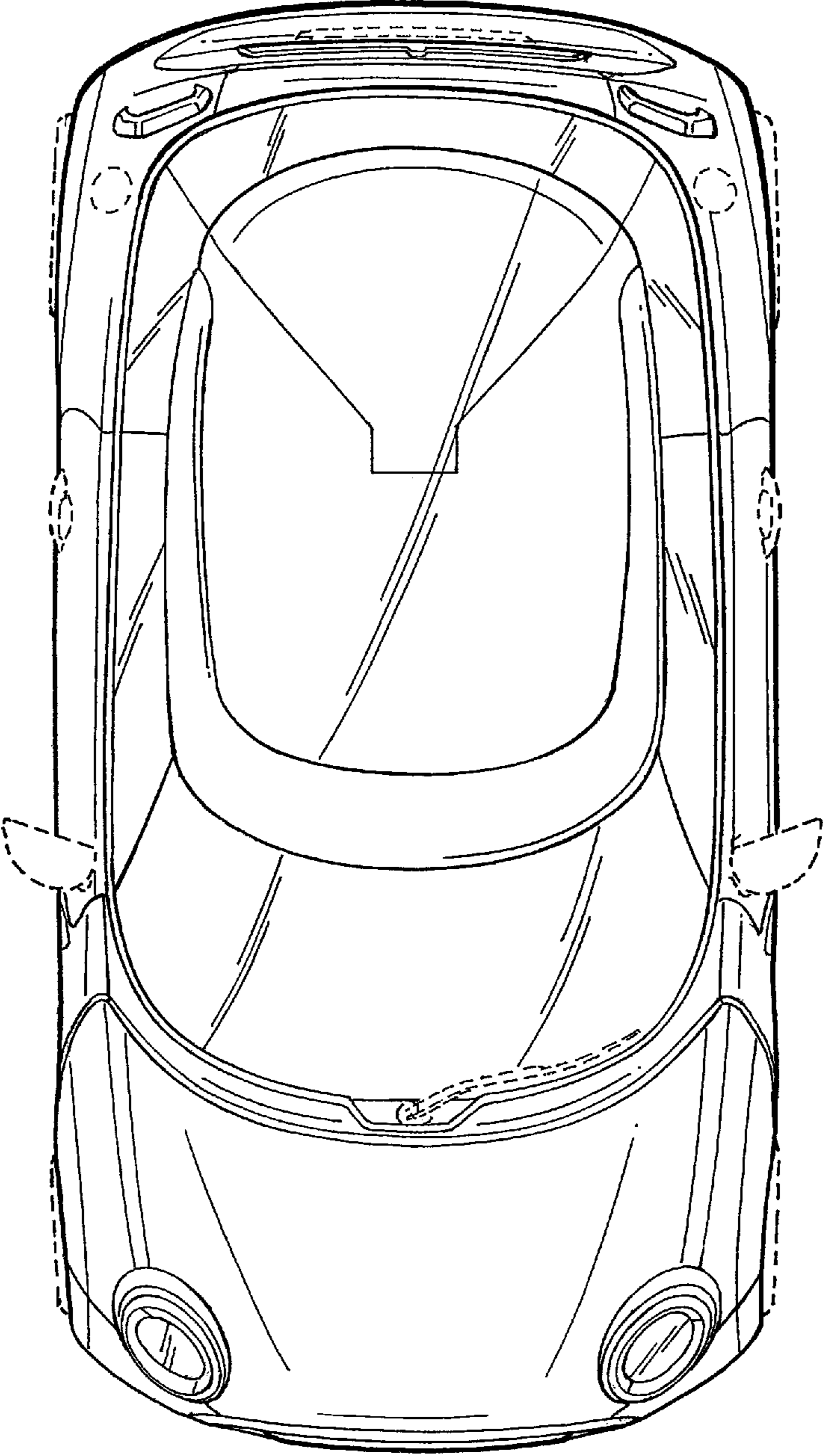
