(57) **CLAIM**

The ornamental design for a radiator grill for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a left, perspective view of a radiator grill for a vehicle according to our design, the right, perspective view being mirror symmetrical;

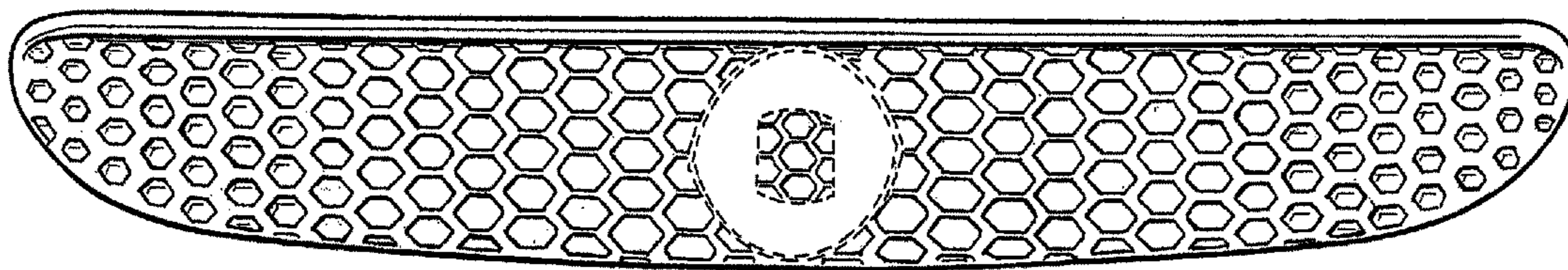
FIG. 2 is a right side view thereof, the left side view being mirror symmetrical;

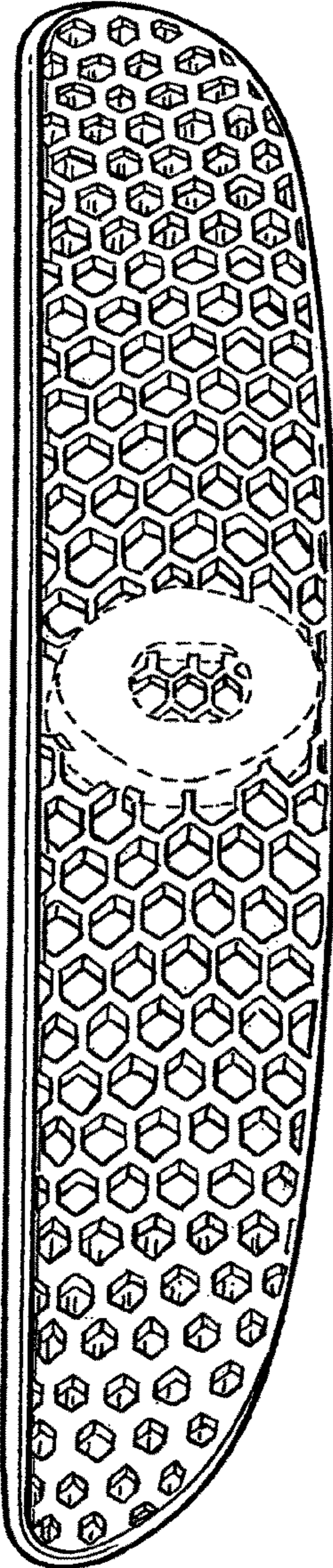

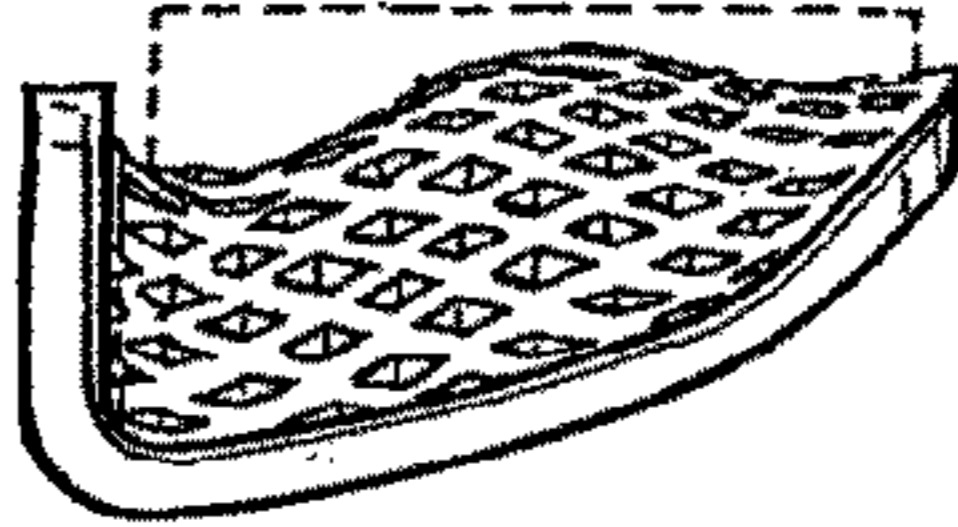

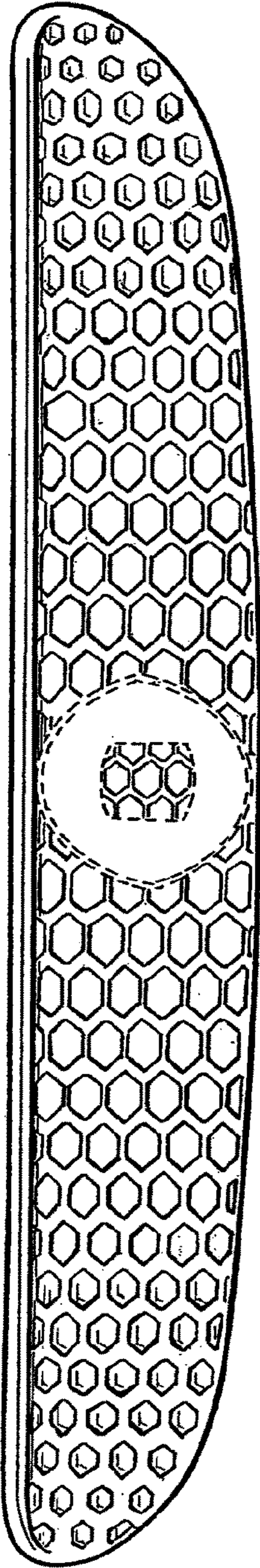

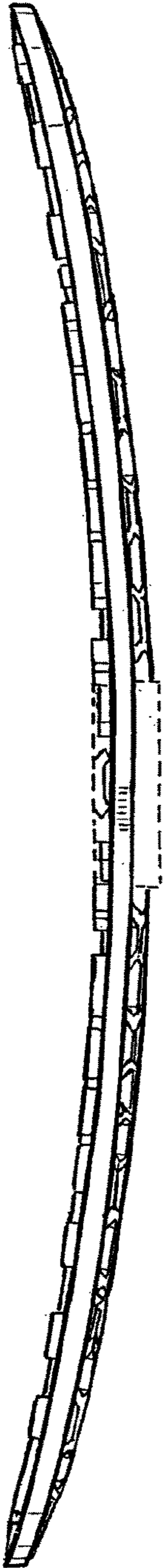
