(57) **CLAIM**

The ornamental design for a front bumper for a vehicle, as shown and described.

DESCRIPTION

This application contains subject matter related to the following co-pending U.S. design patent applications: application Ser. No. 29/311,356, filed Feb. 27, 2009 and entitled "Front Bumper for a Vehicle."

FIG. 3 is a top view thereof;

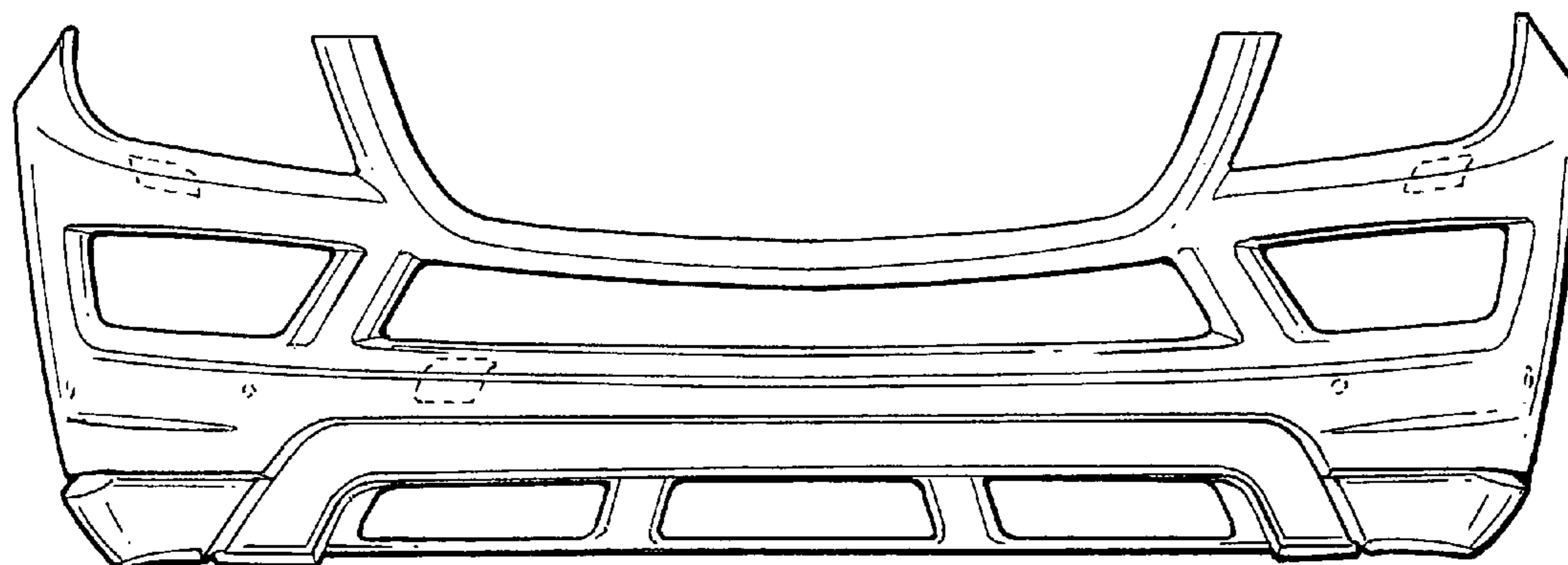
FIG. 4 is a bottom view thereof;

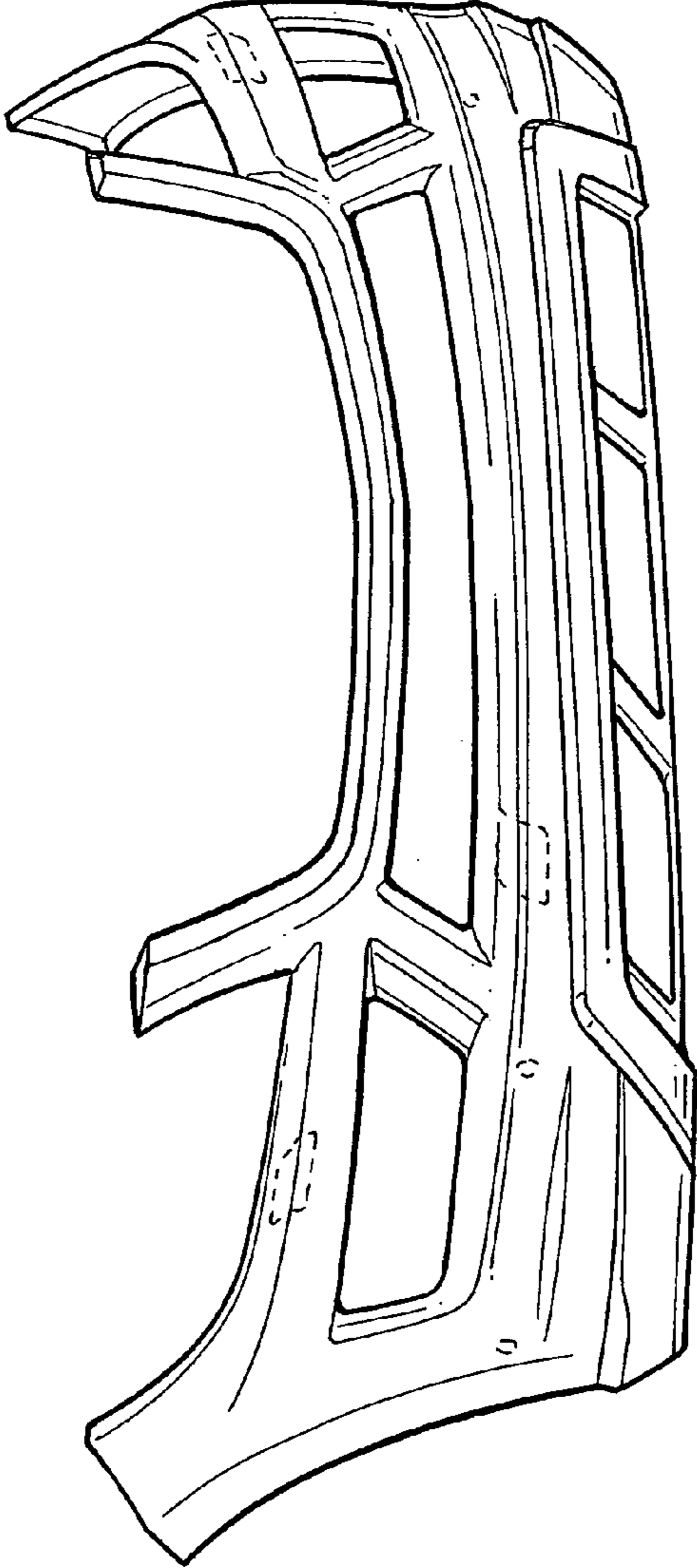

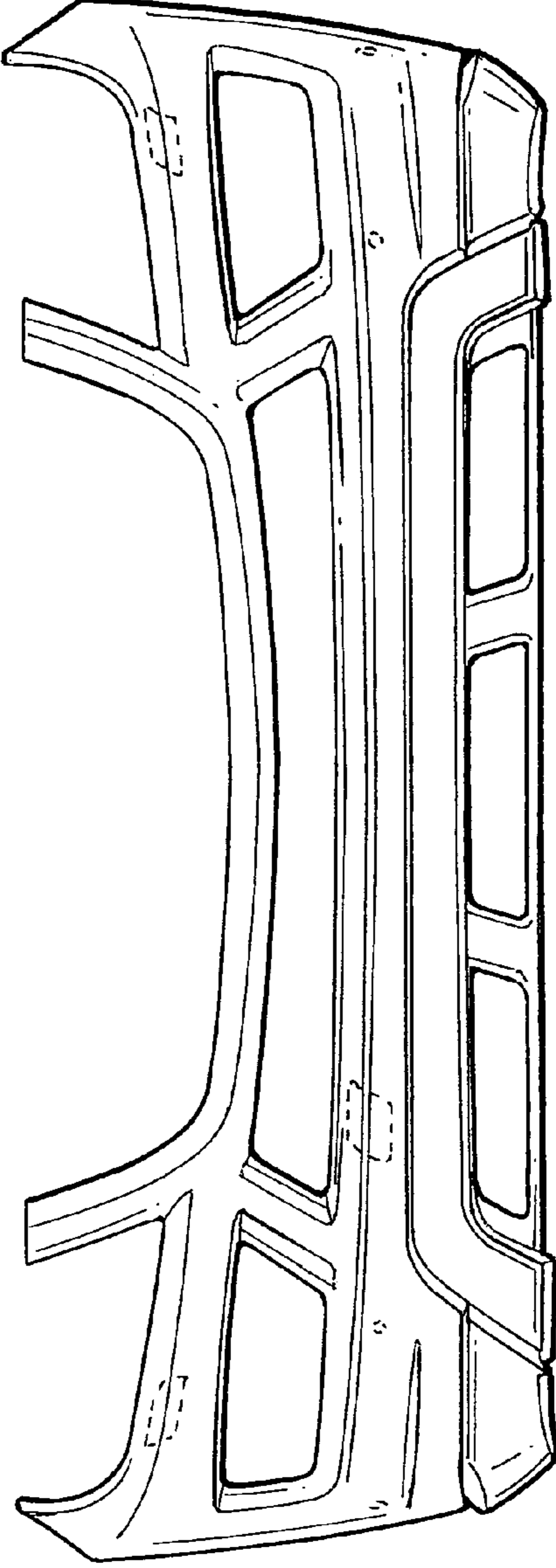

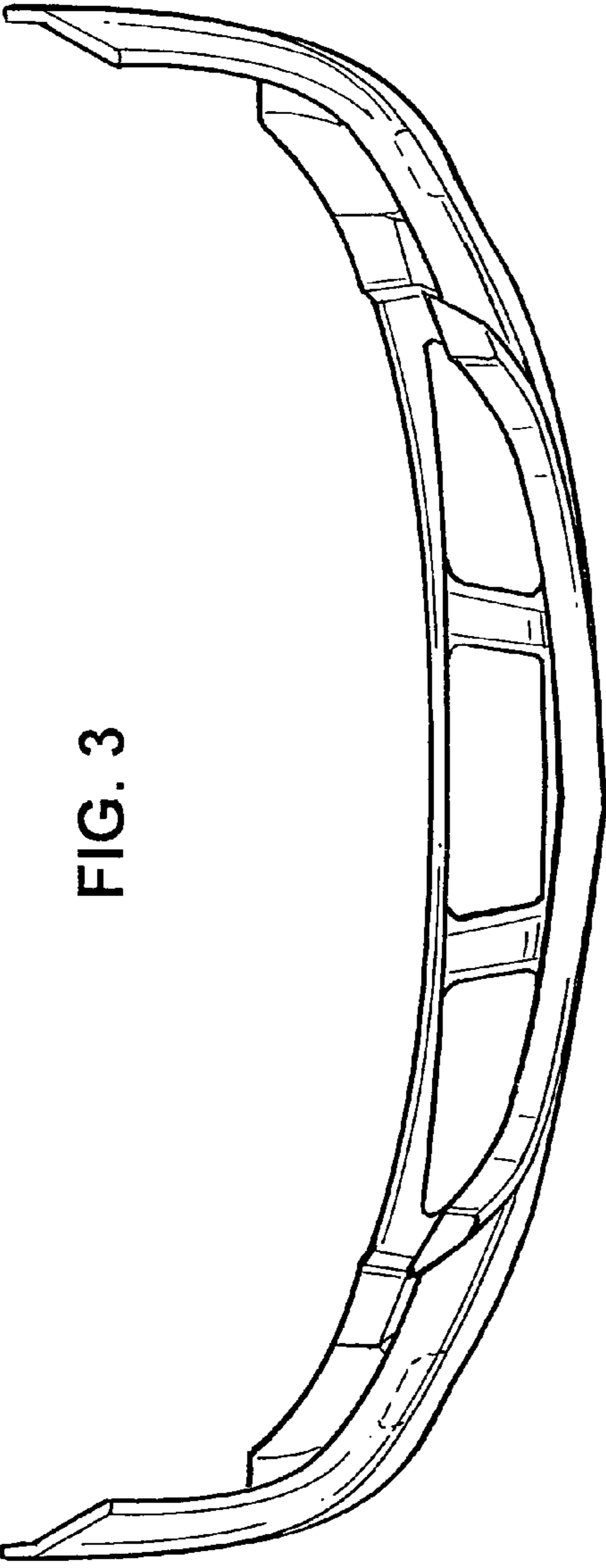

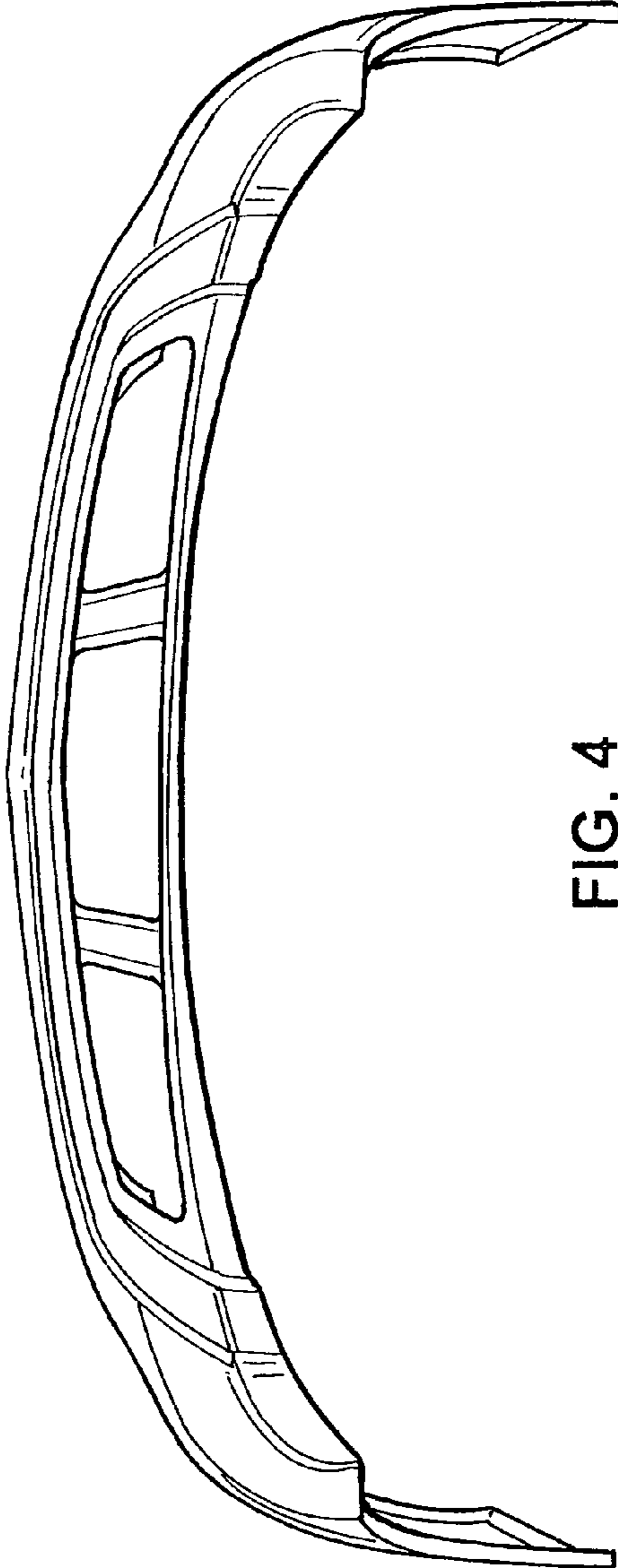

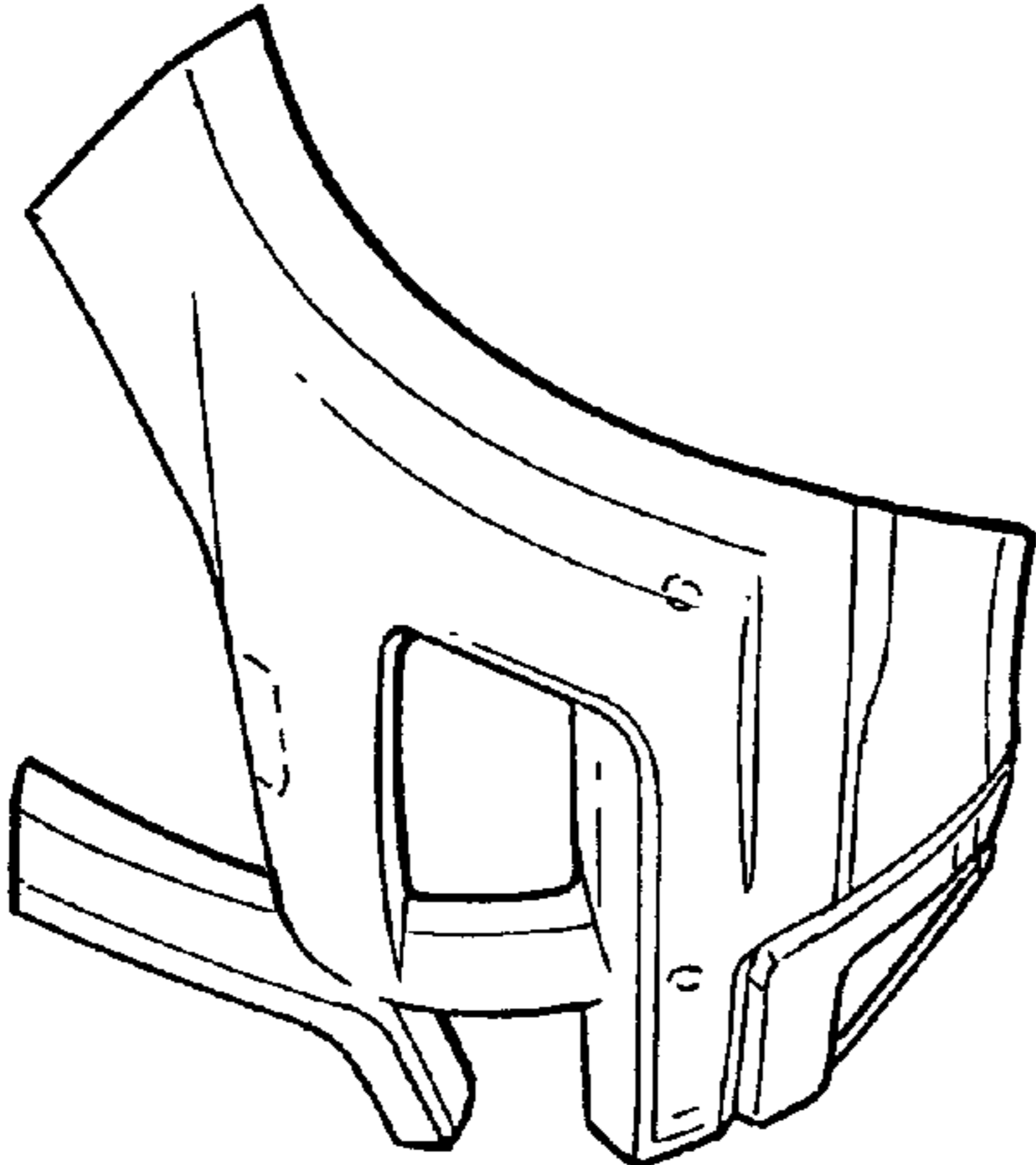

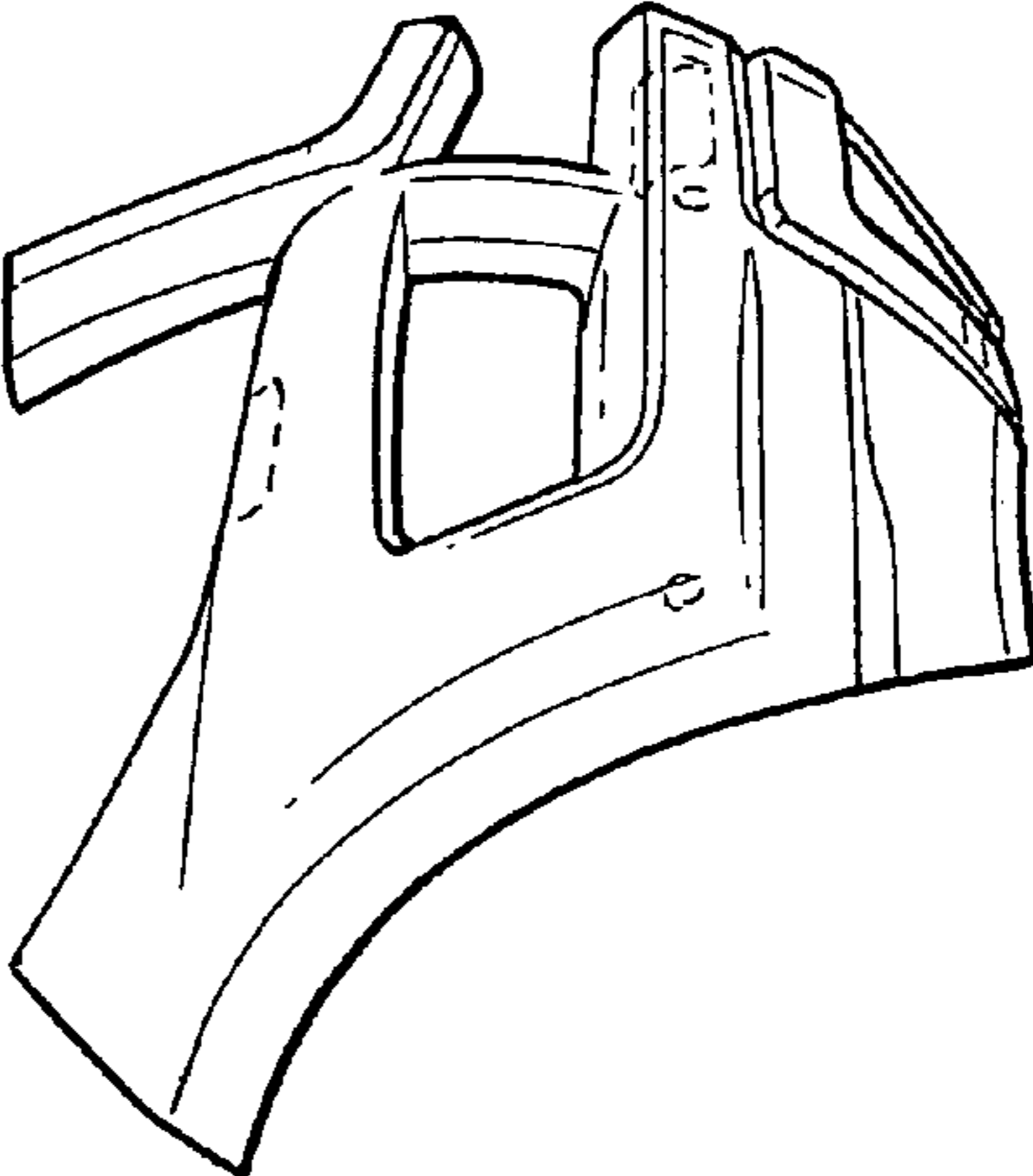
