(57) **CLAIM**

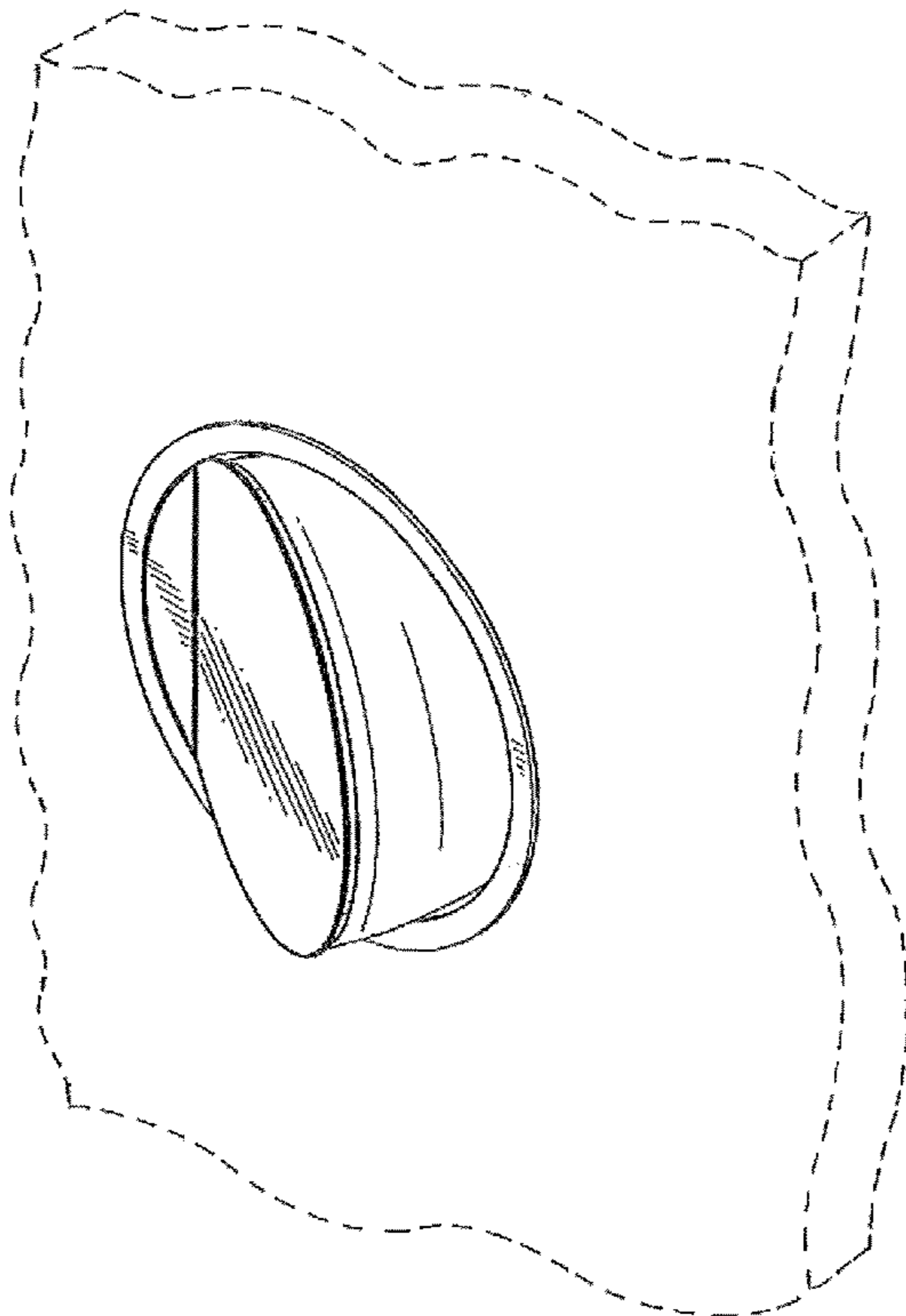
The ornamental design for a speaker, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a speaker in an open position according to my new design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a right side elevation view thereof.
FIG. 4 is a left side elevation view thereof.
FIG. 5 is a top elevation view, the bottom elevation being a mirror image.
FIG. 6 is a front perspective view thereof in a closed position.
FIG. 7 is a front elevation view thereof.
FIG. 8 is a left elevation view thereof.
FIG. 9 is a right elevation view thereof; and,
FIG. 10 is a top elevation view, the bottom elevation being a mirror image.

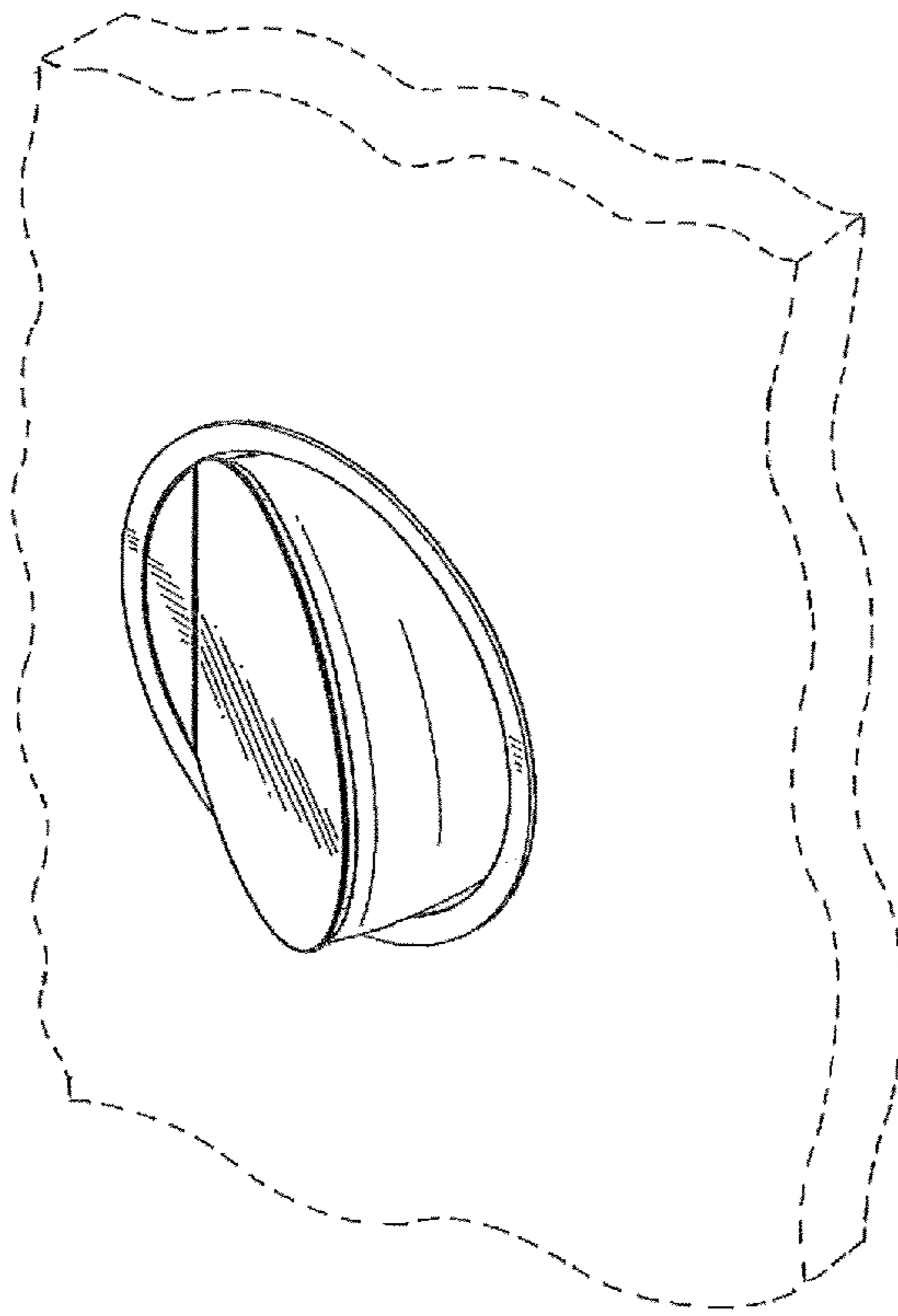

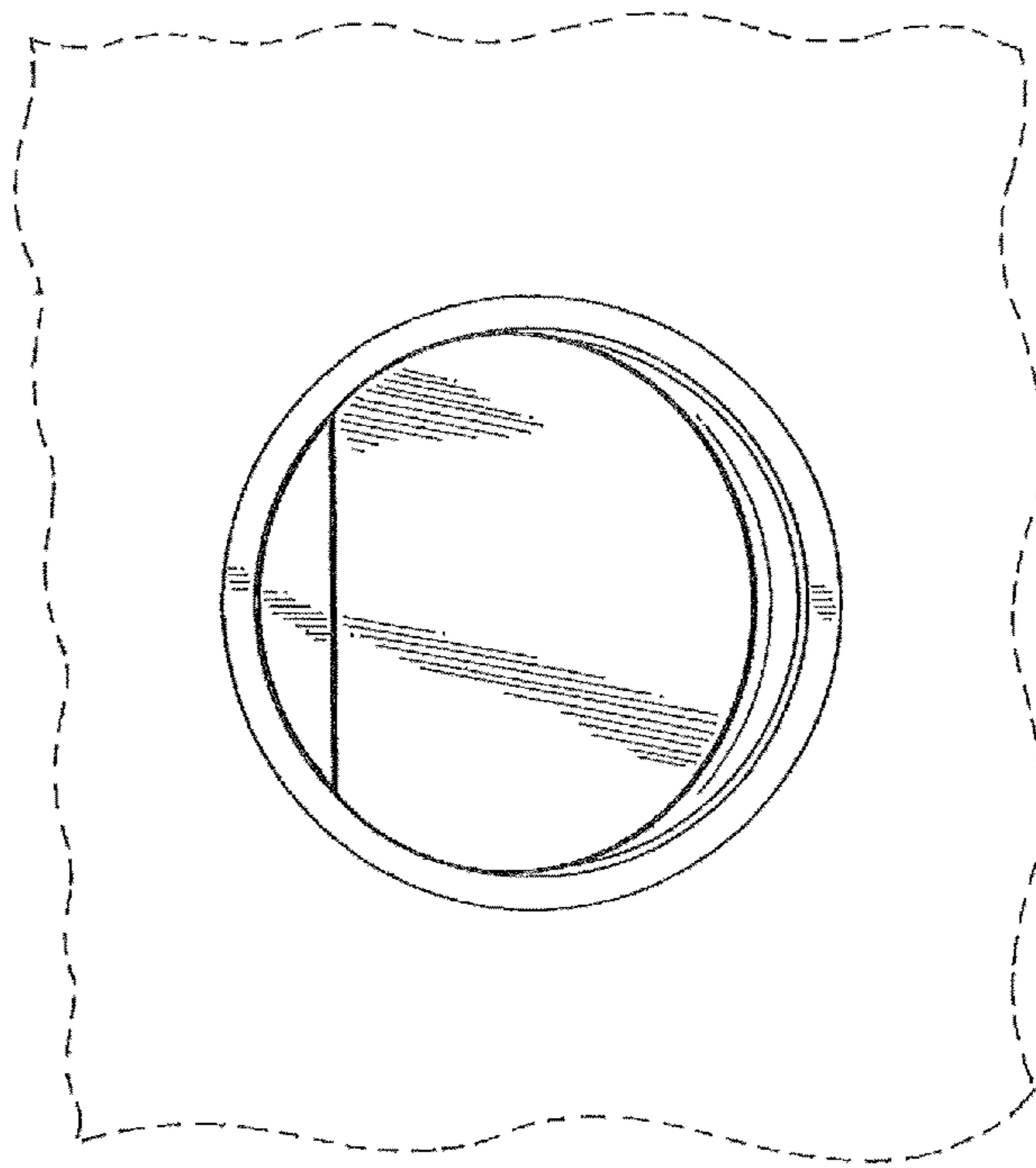

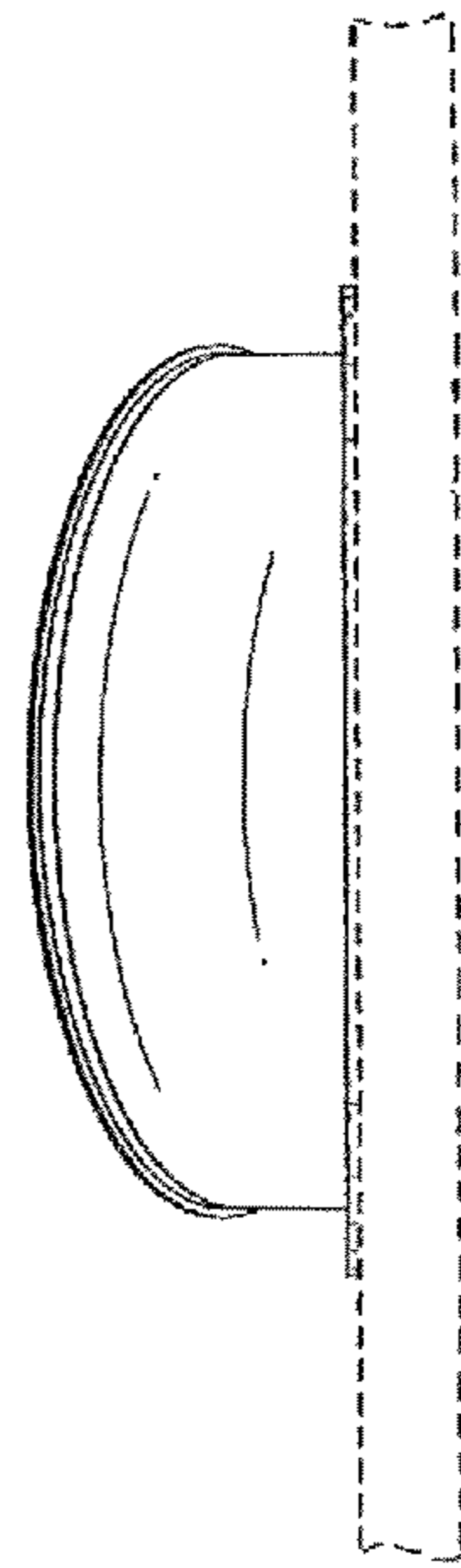

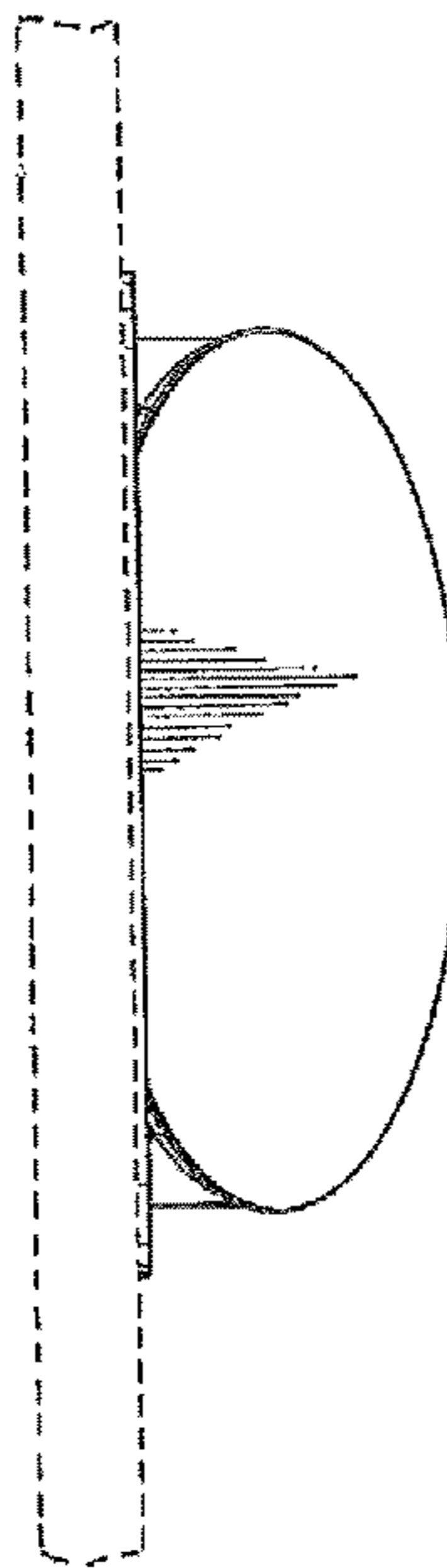

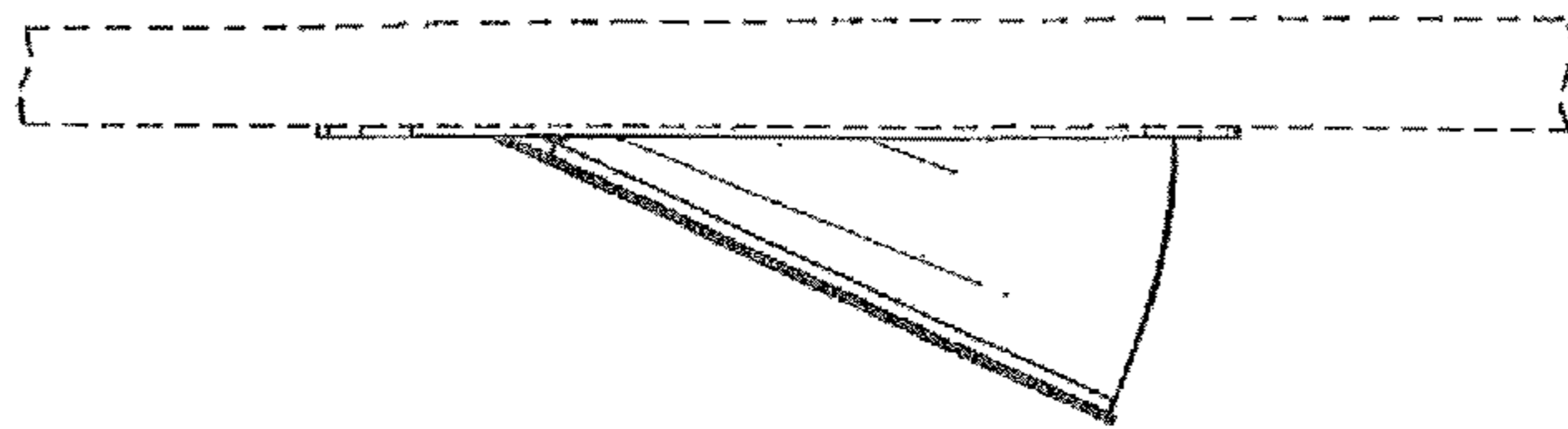

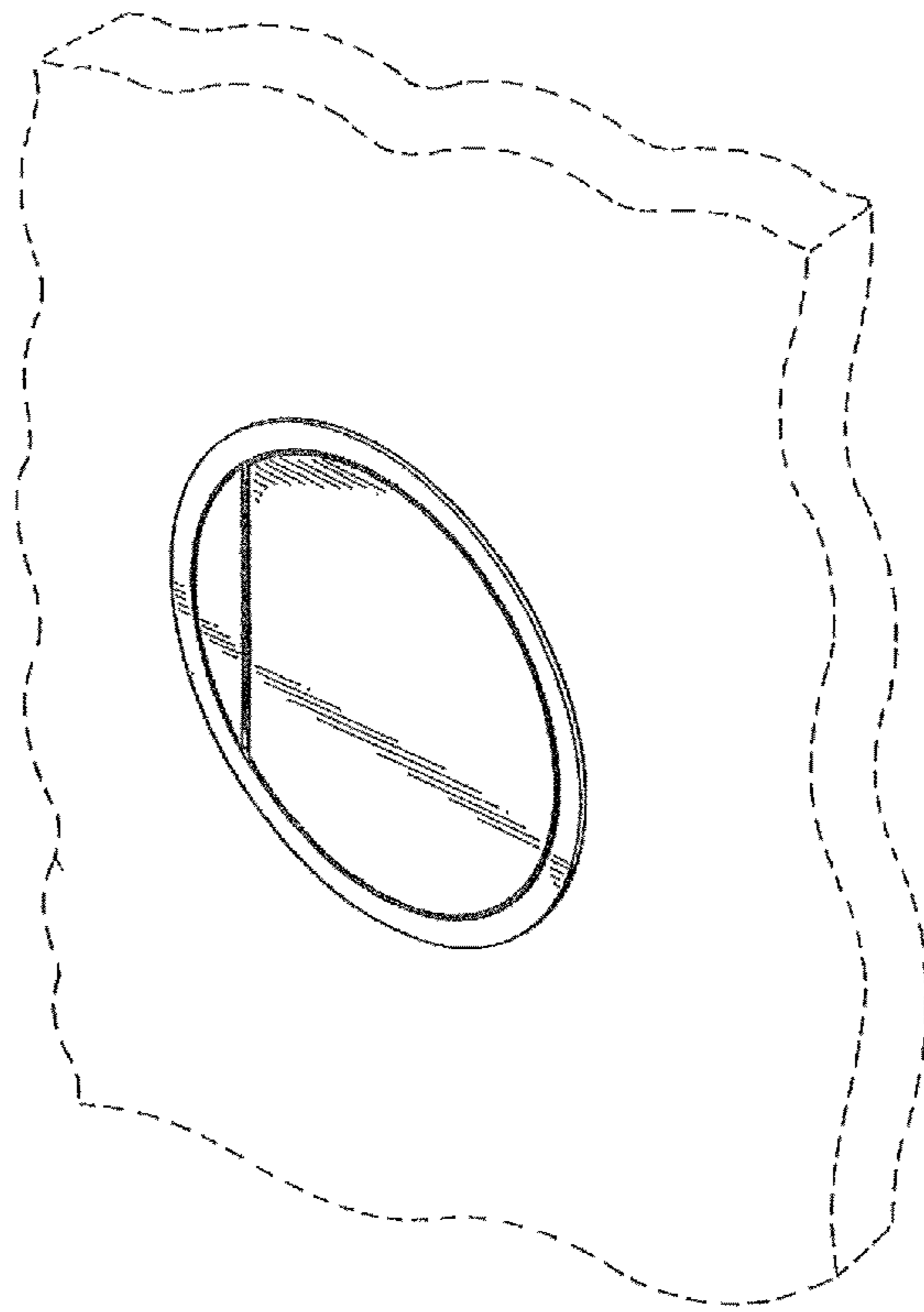

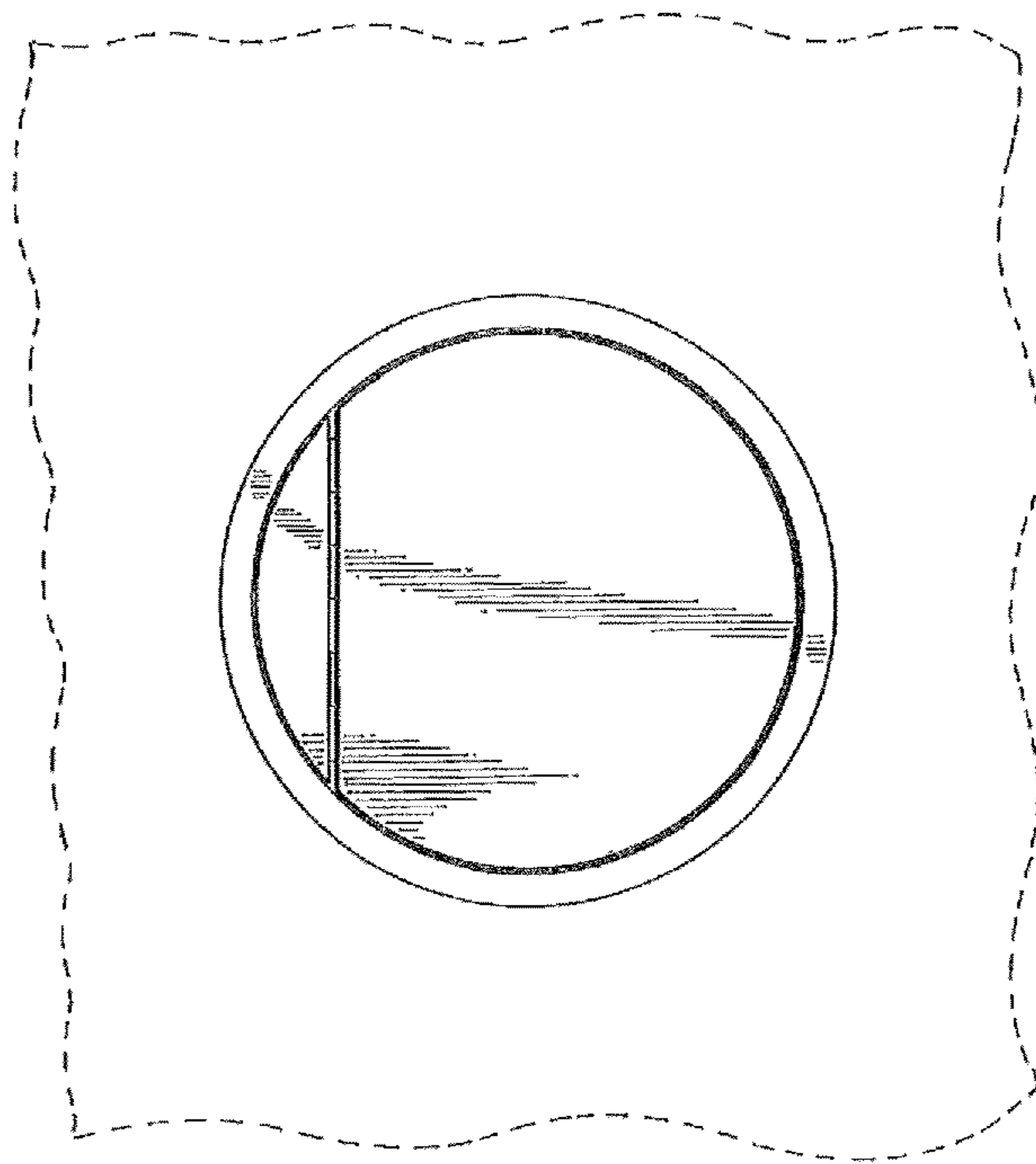

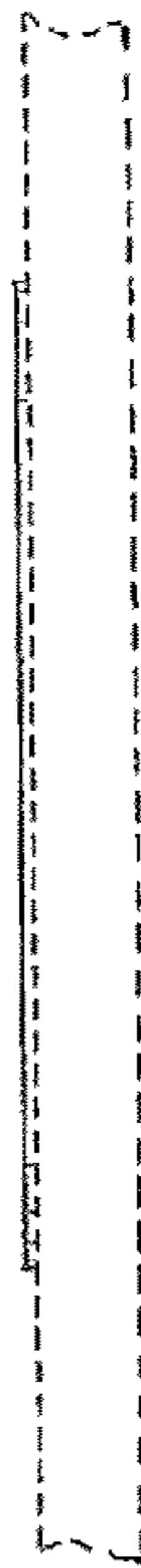

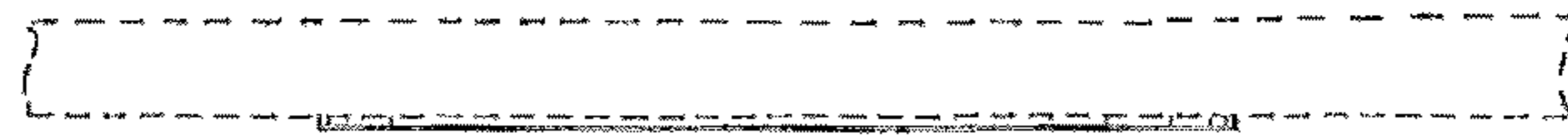
