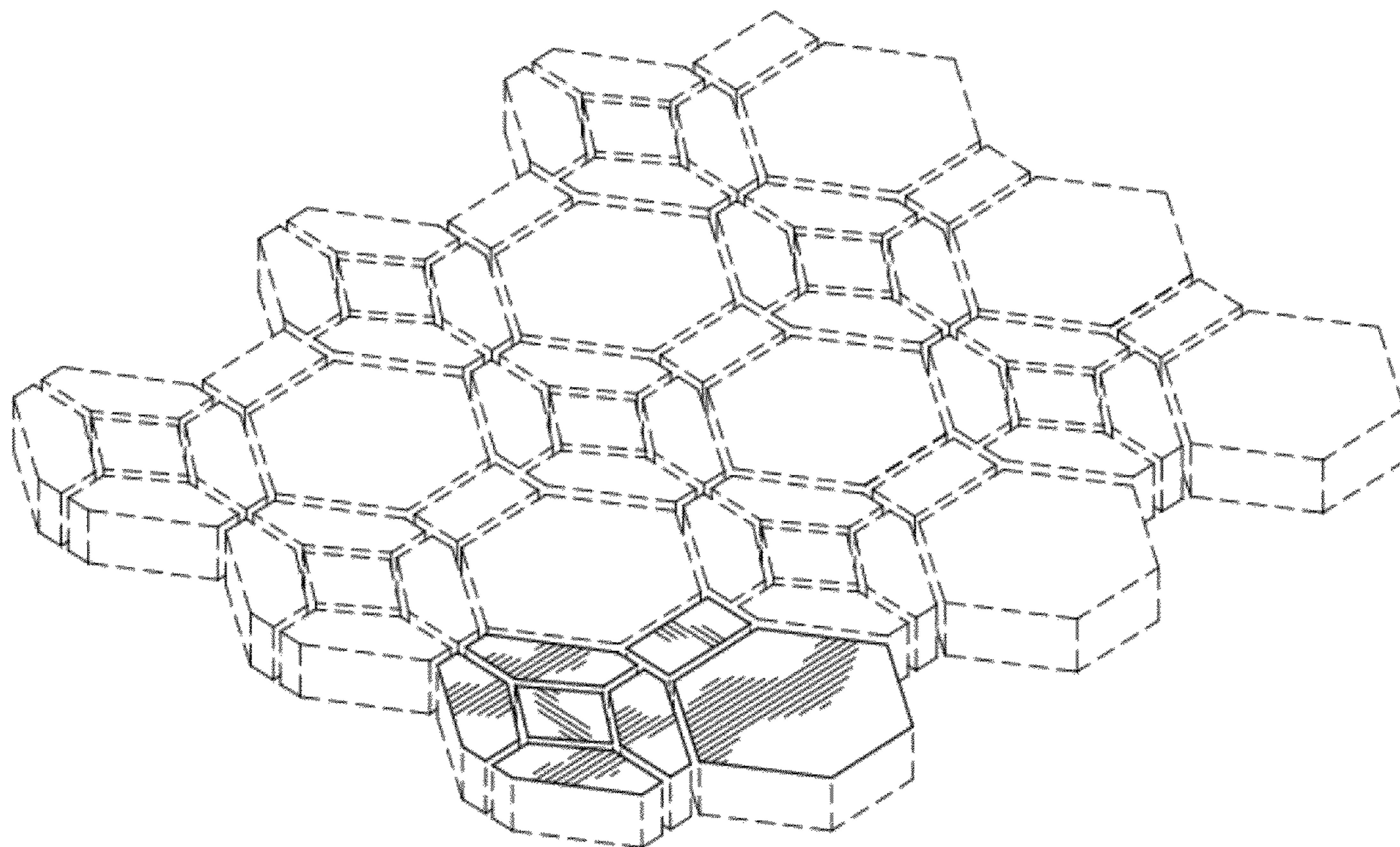
(57) **CLAIM**

I claim, the ornamental design for a tile pattern, as shown and described.

**DESCRIPTION**

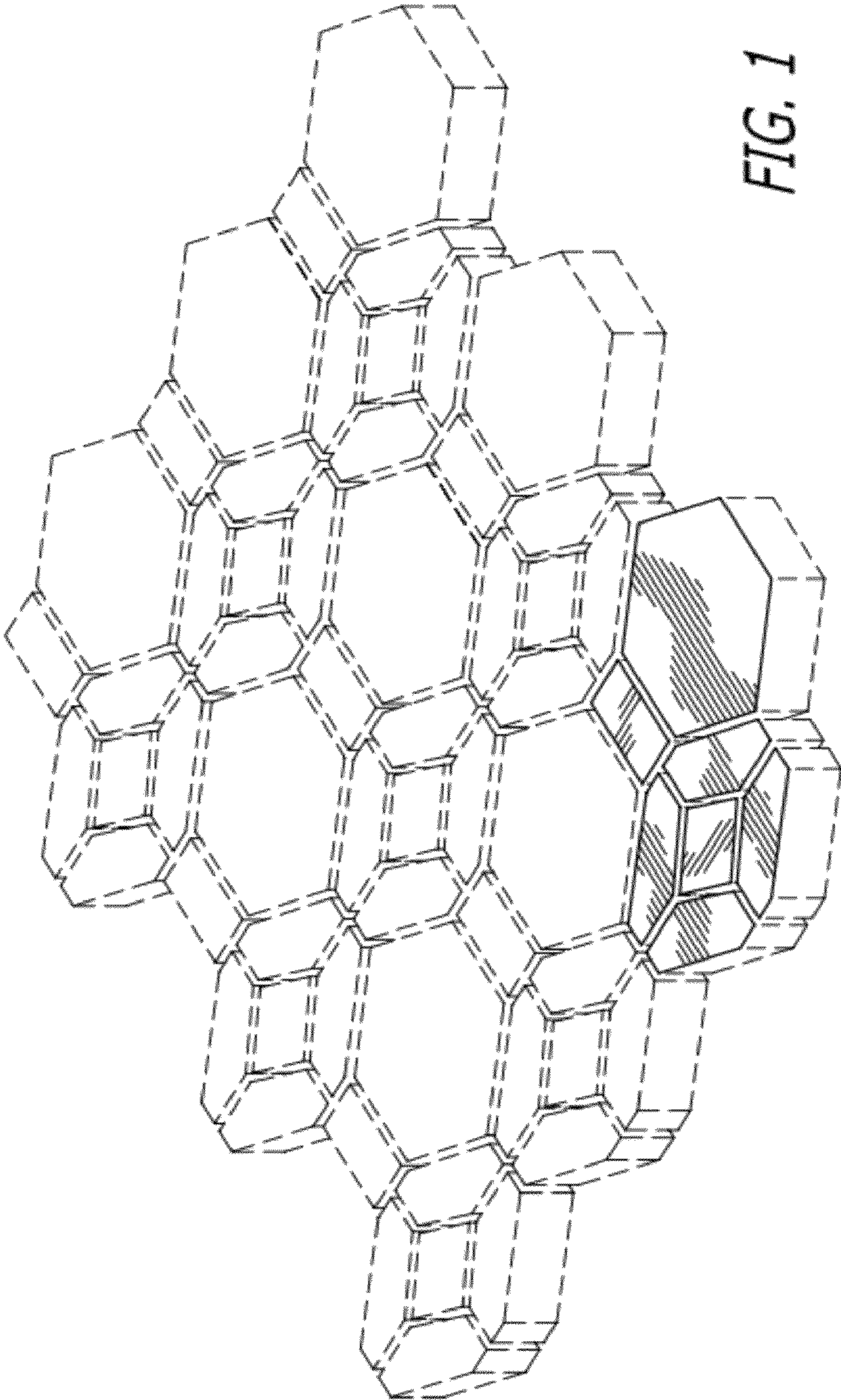

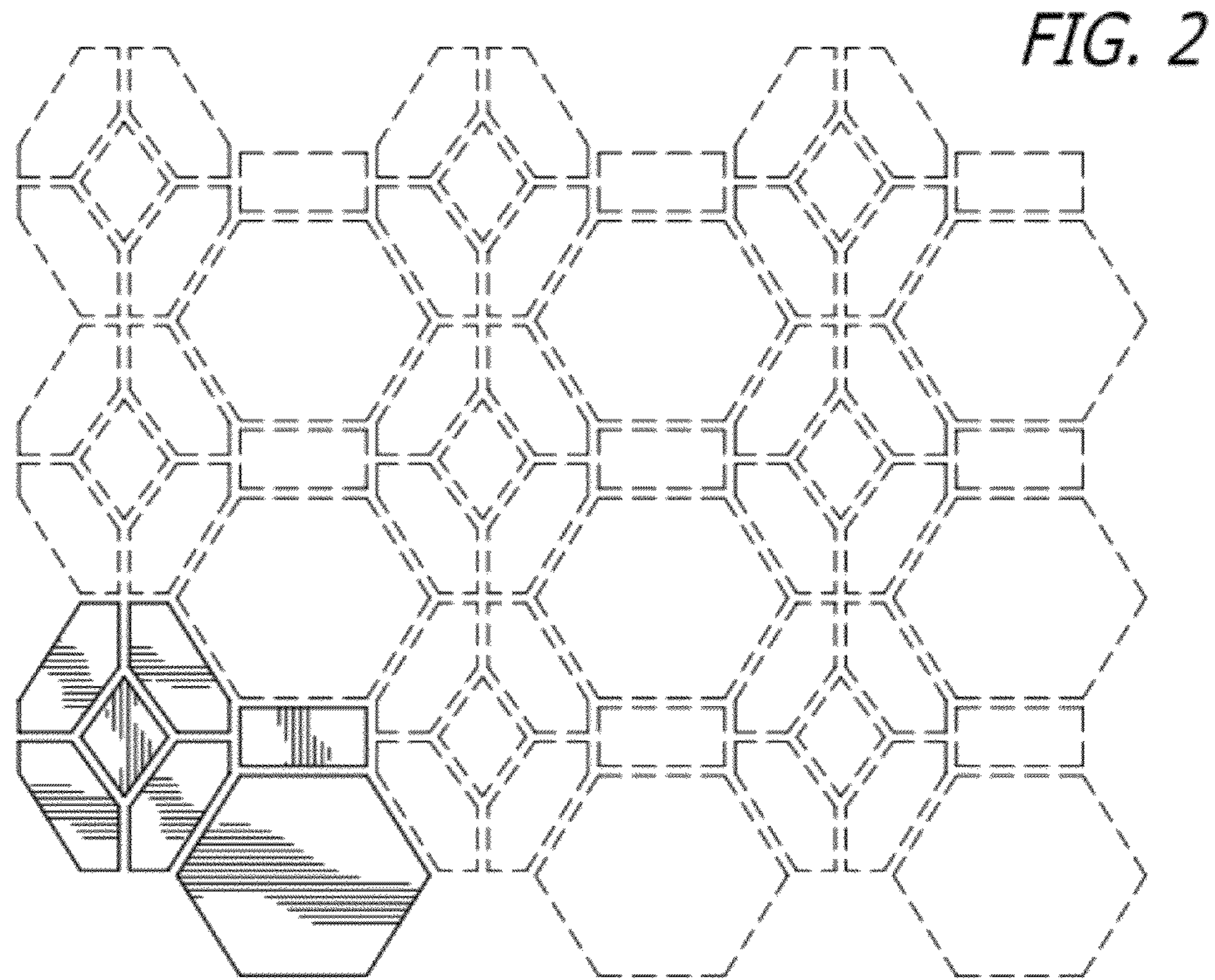

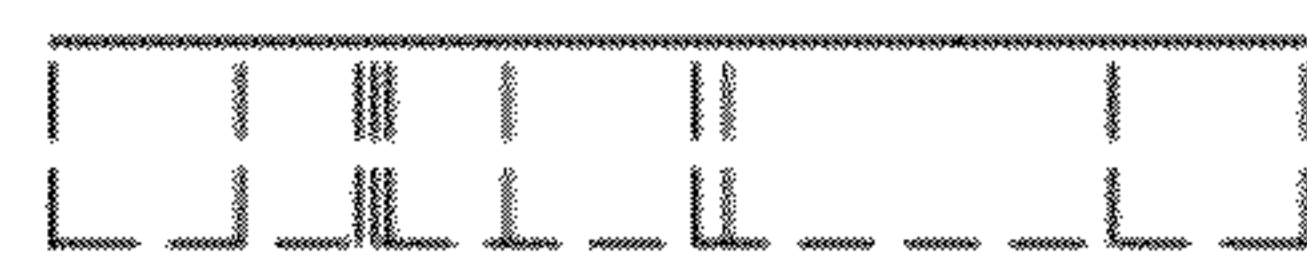

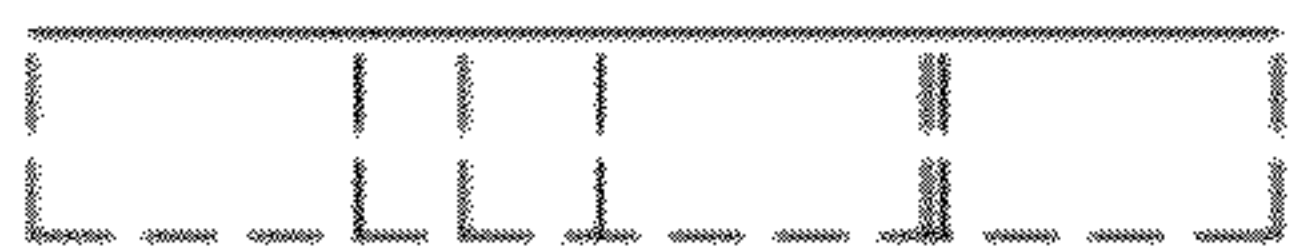
