DESCRIPTION

FIG. 1 is a first side view of an embodiment of a wrist sweatband showing the new design.

FIG. 2 is a second side view of the embodiment of a wrist sweatband.

FIG. 3 is a bottom side view of the embodiment of a wrist sweatband.

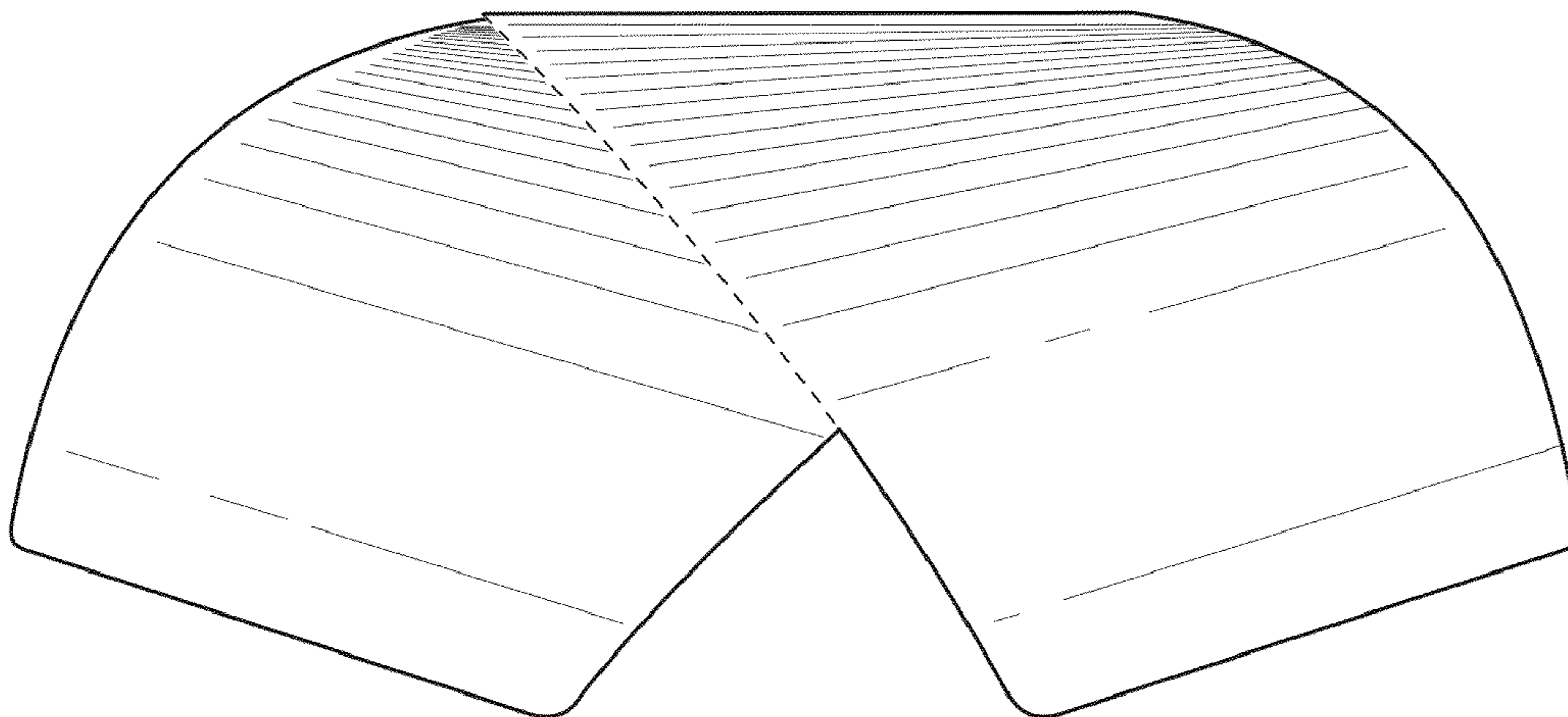
FIG. 4 is a top side view of the embodiment of a wrist sweatband.

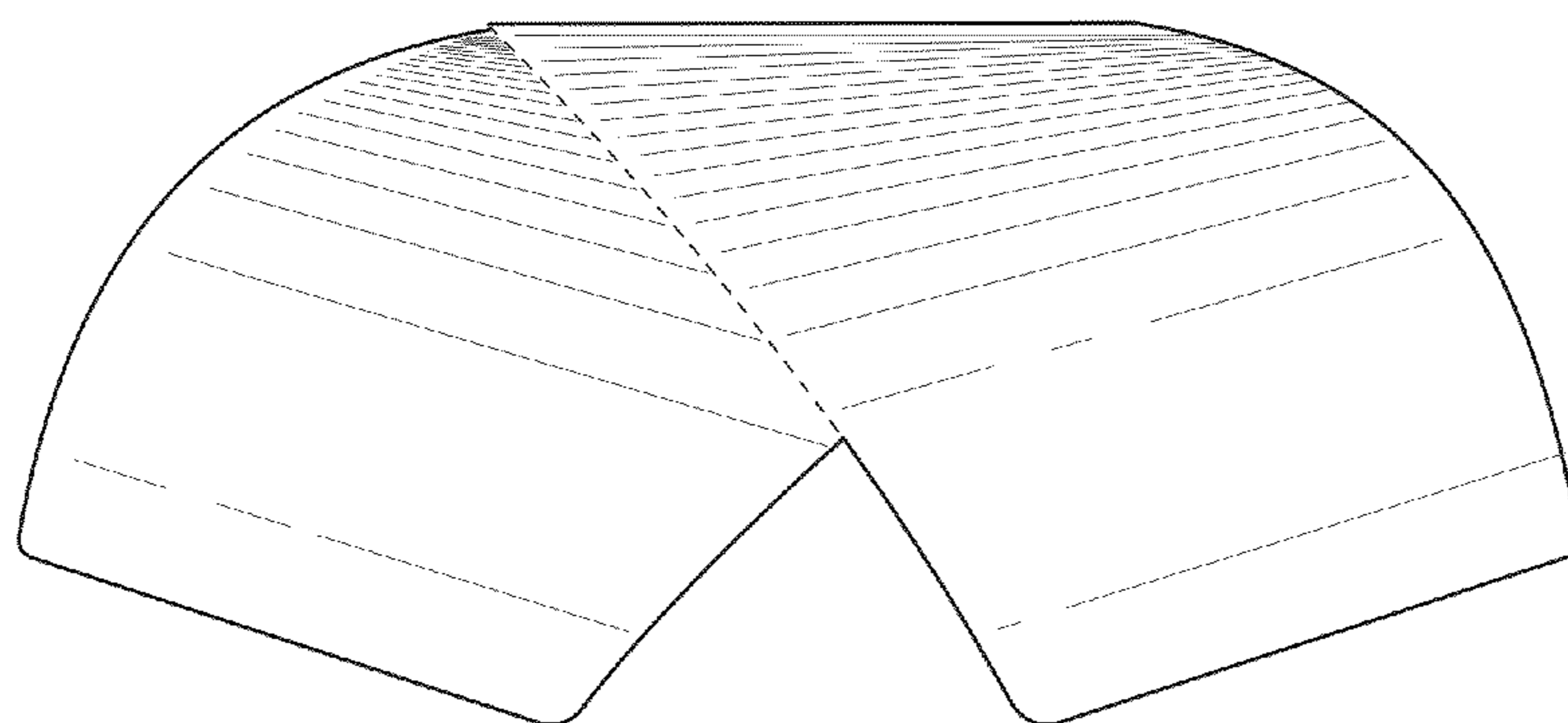

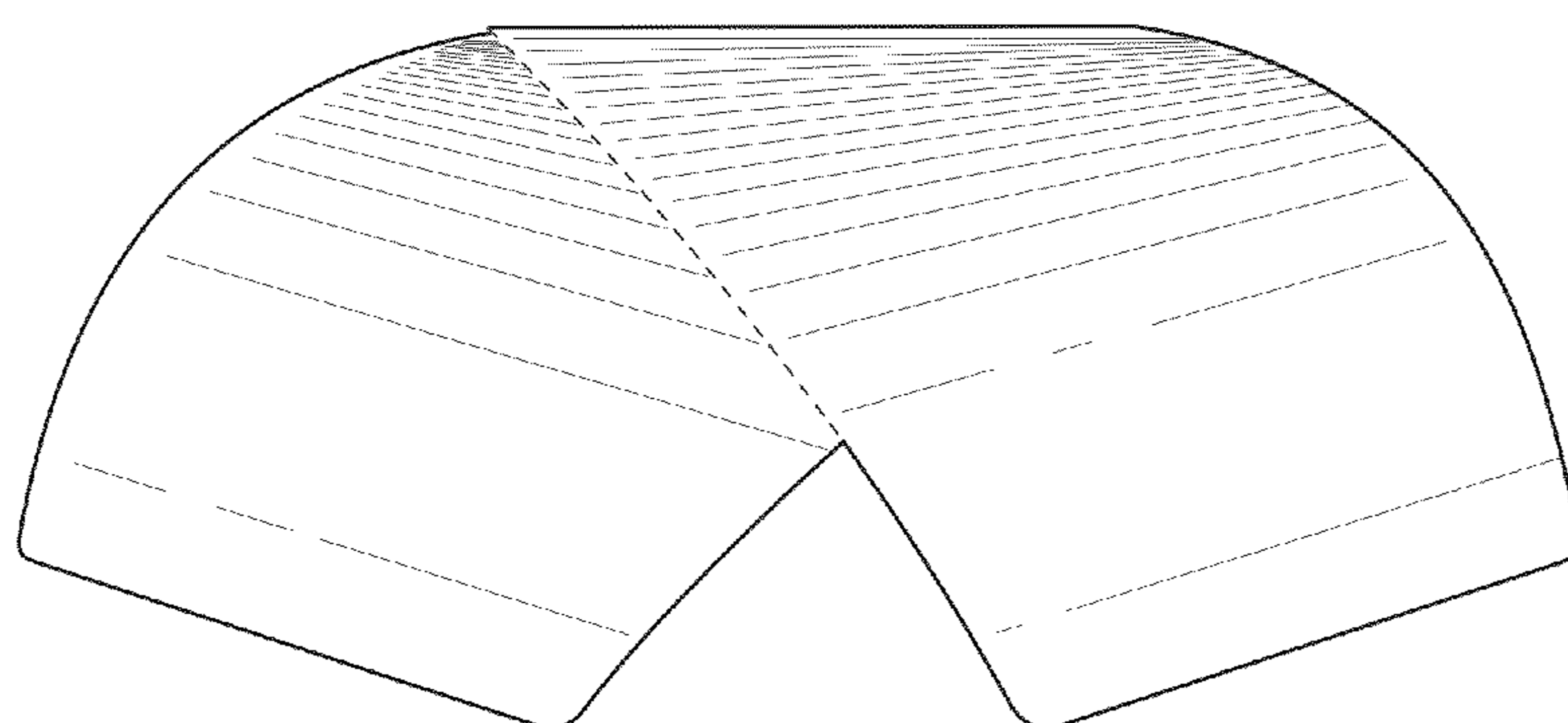

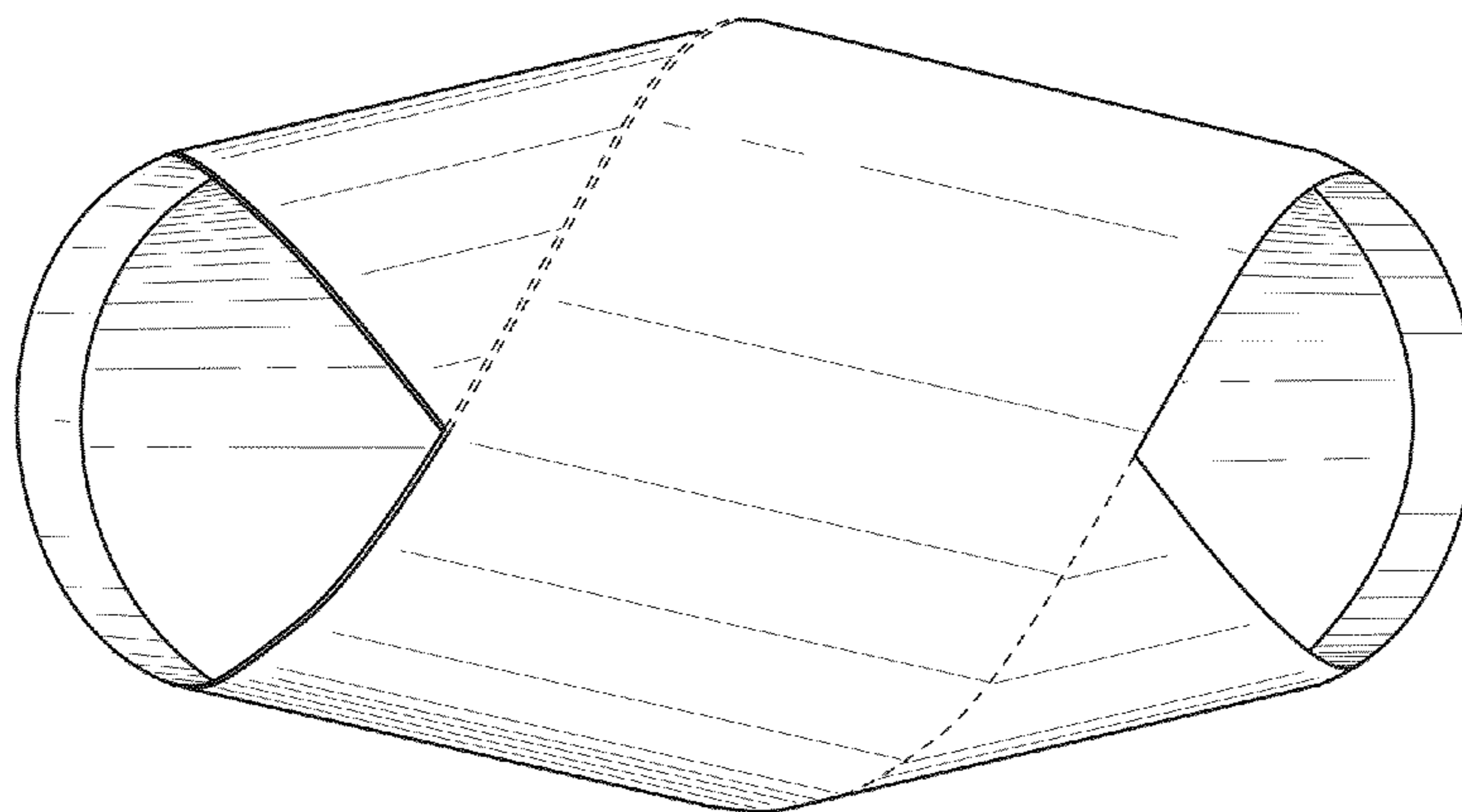

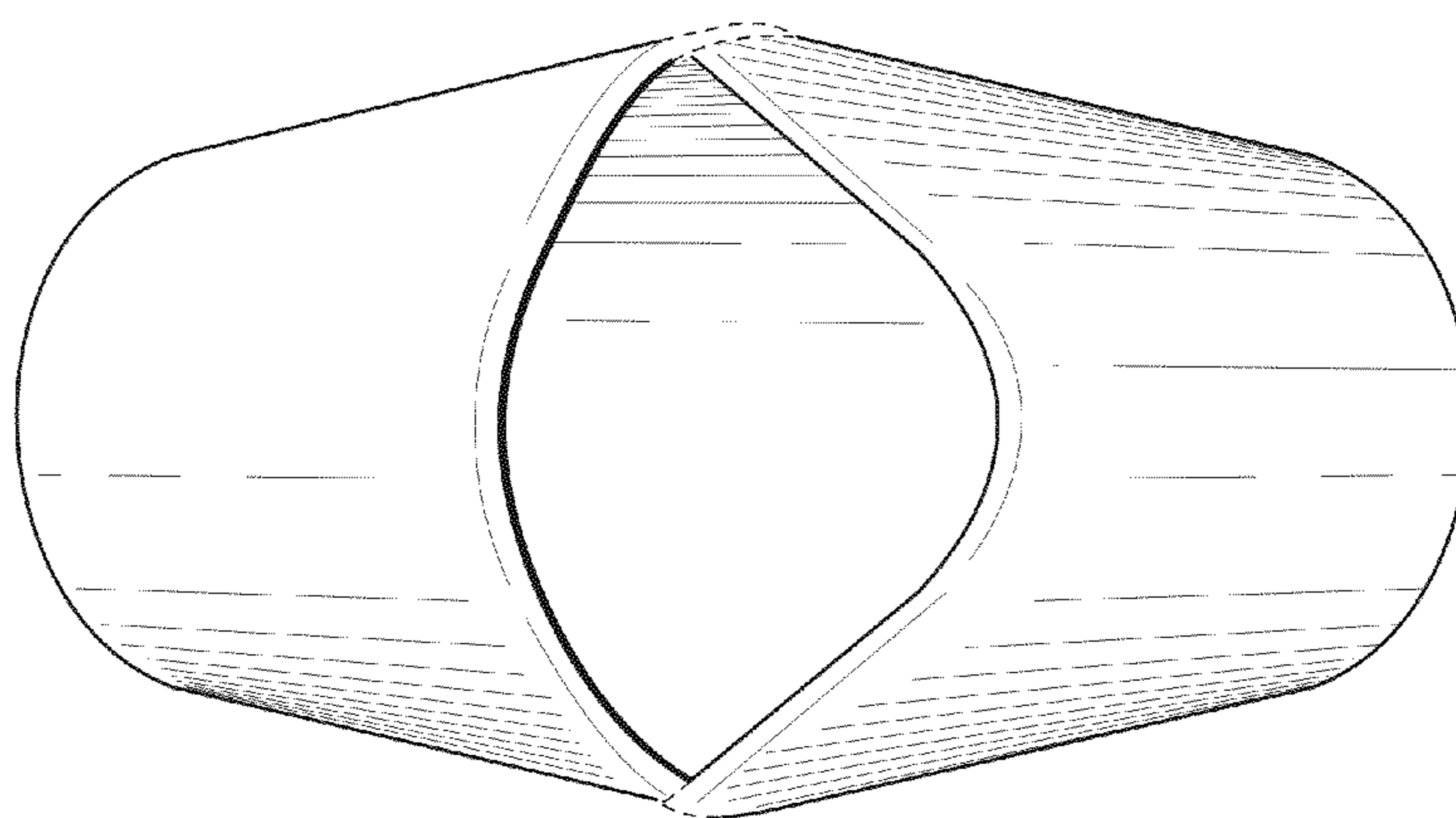

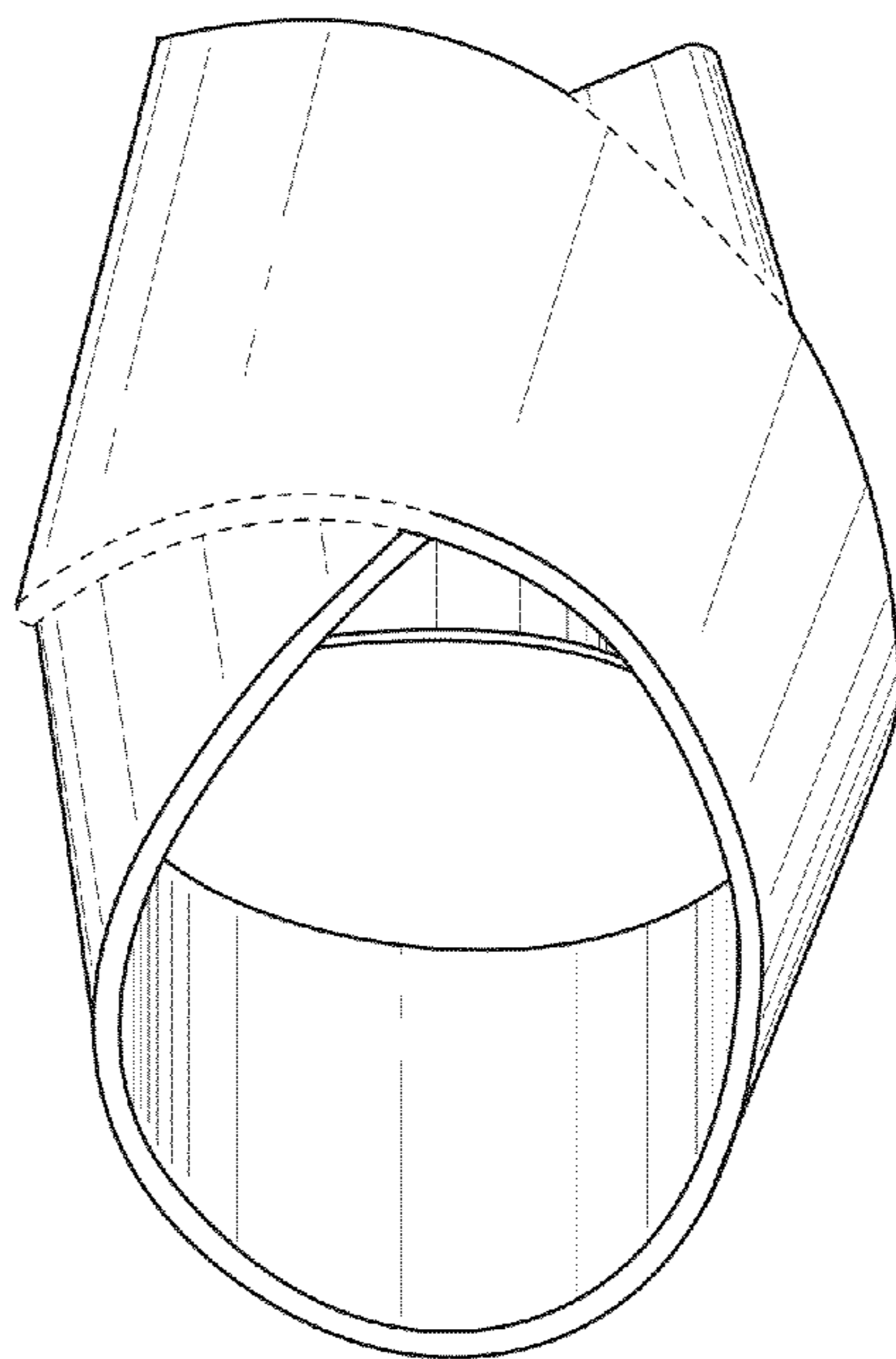

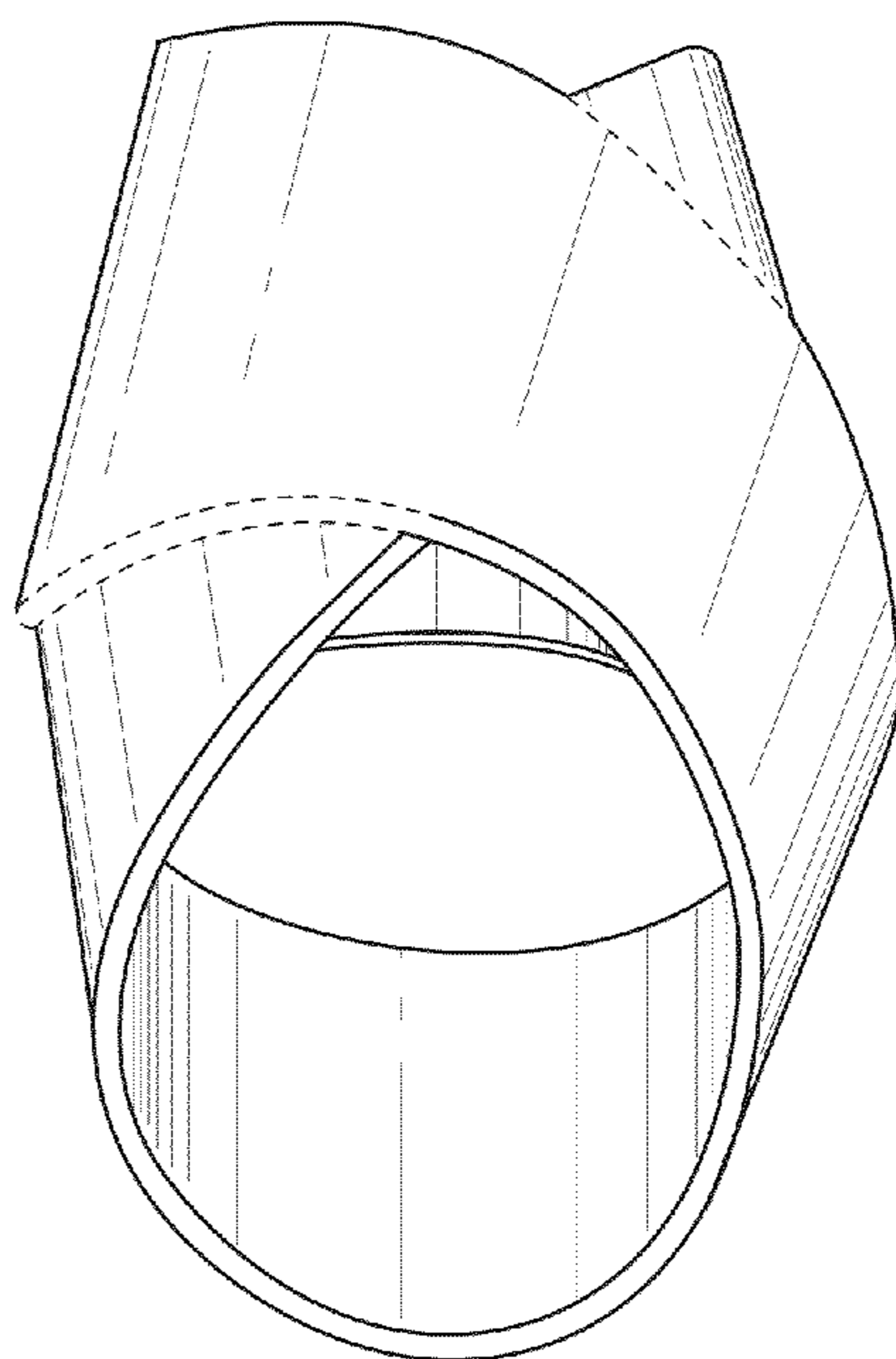
