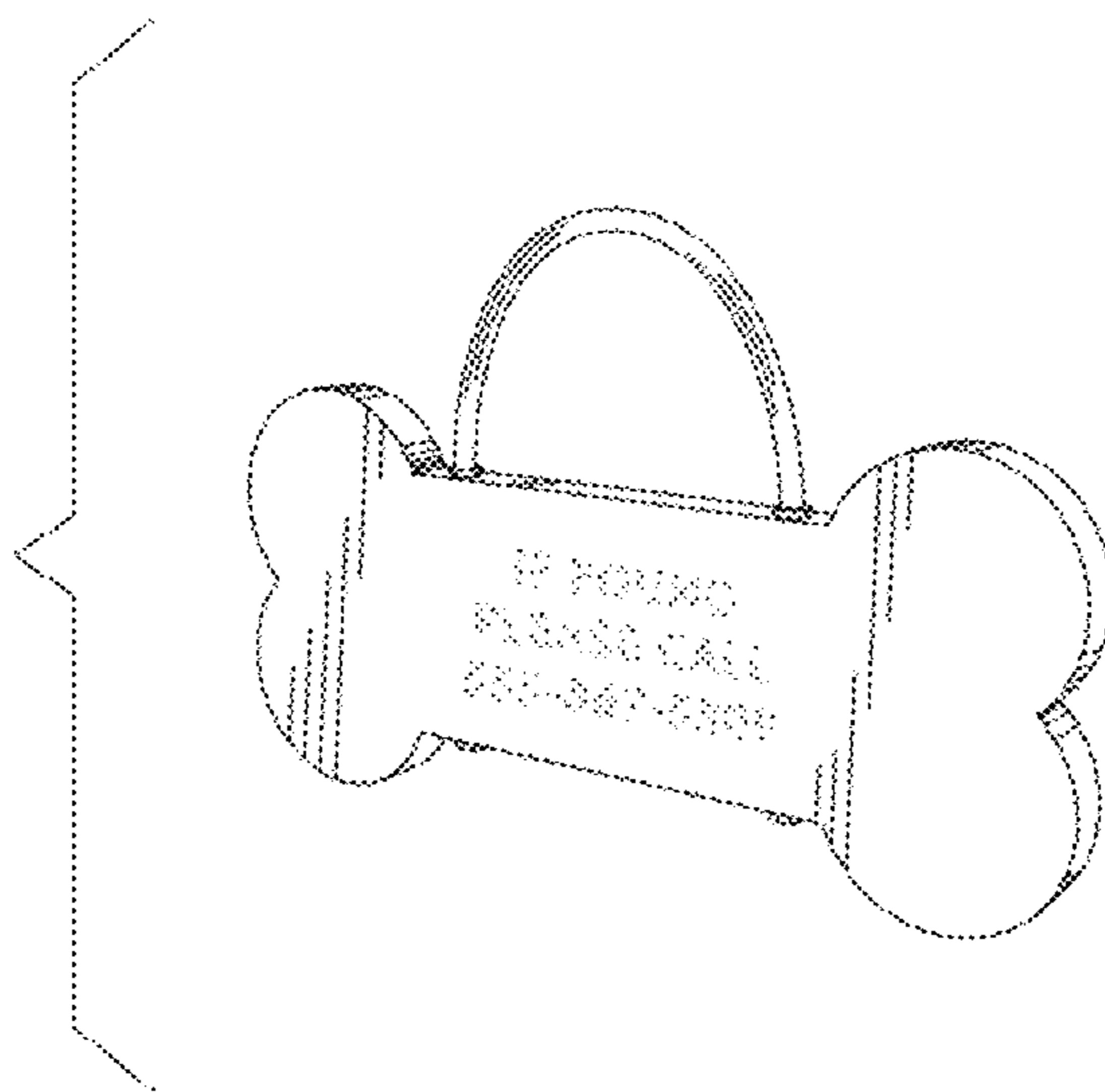
(57) **CLAIM**

FIG. 1 is a front perspective view of a lost and found tag, showing our new design;

 FIG. 4 is a left side view thereof with a right side view being a mirror image;
 FIG. 5 is a top view thereof; and,
 FIG. 6 is a bottom view thereof.

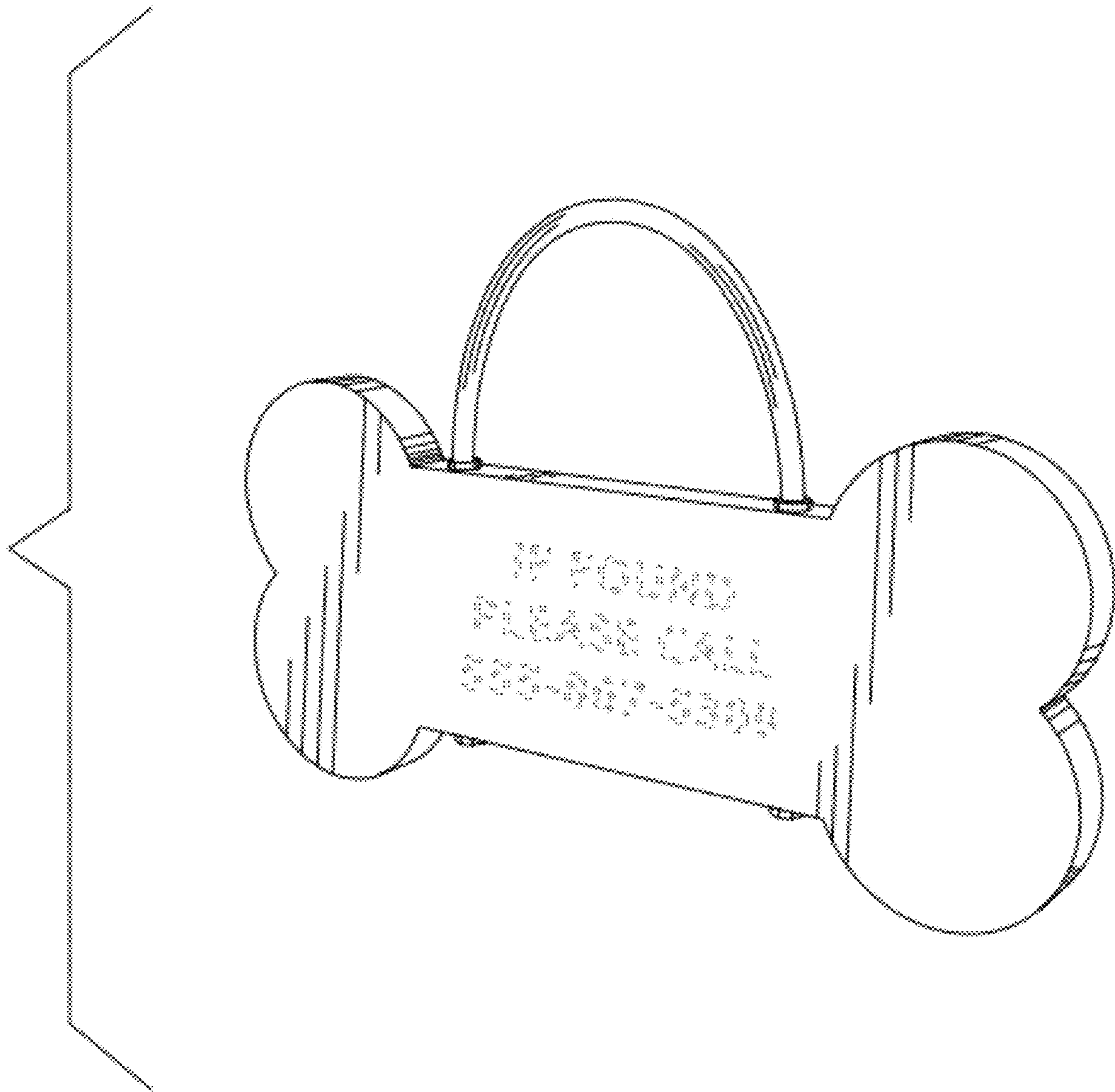

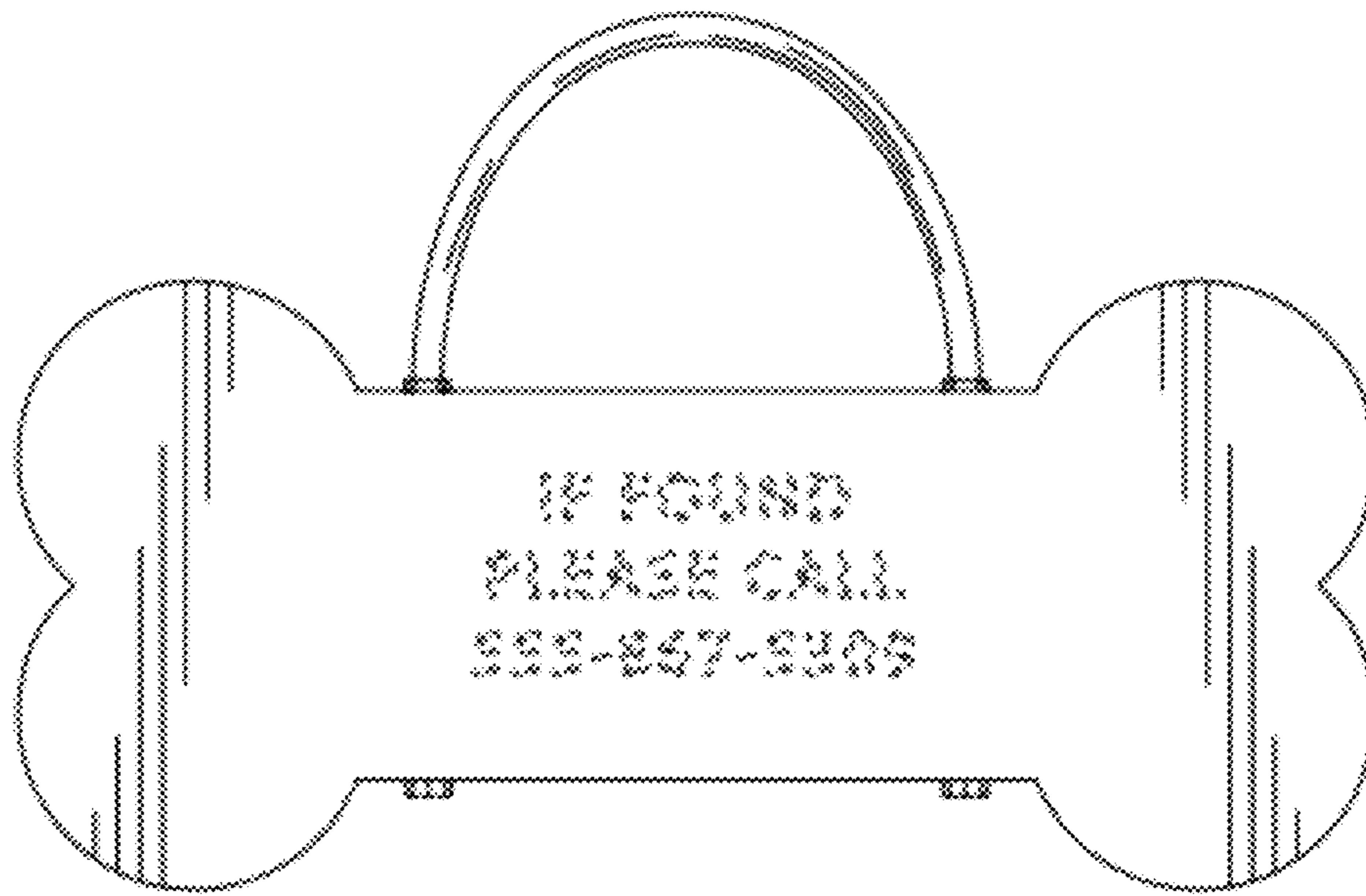

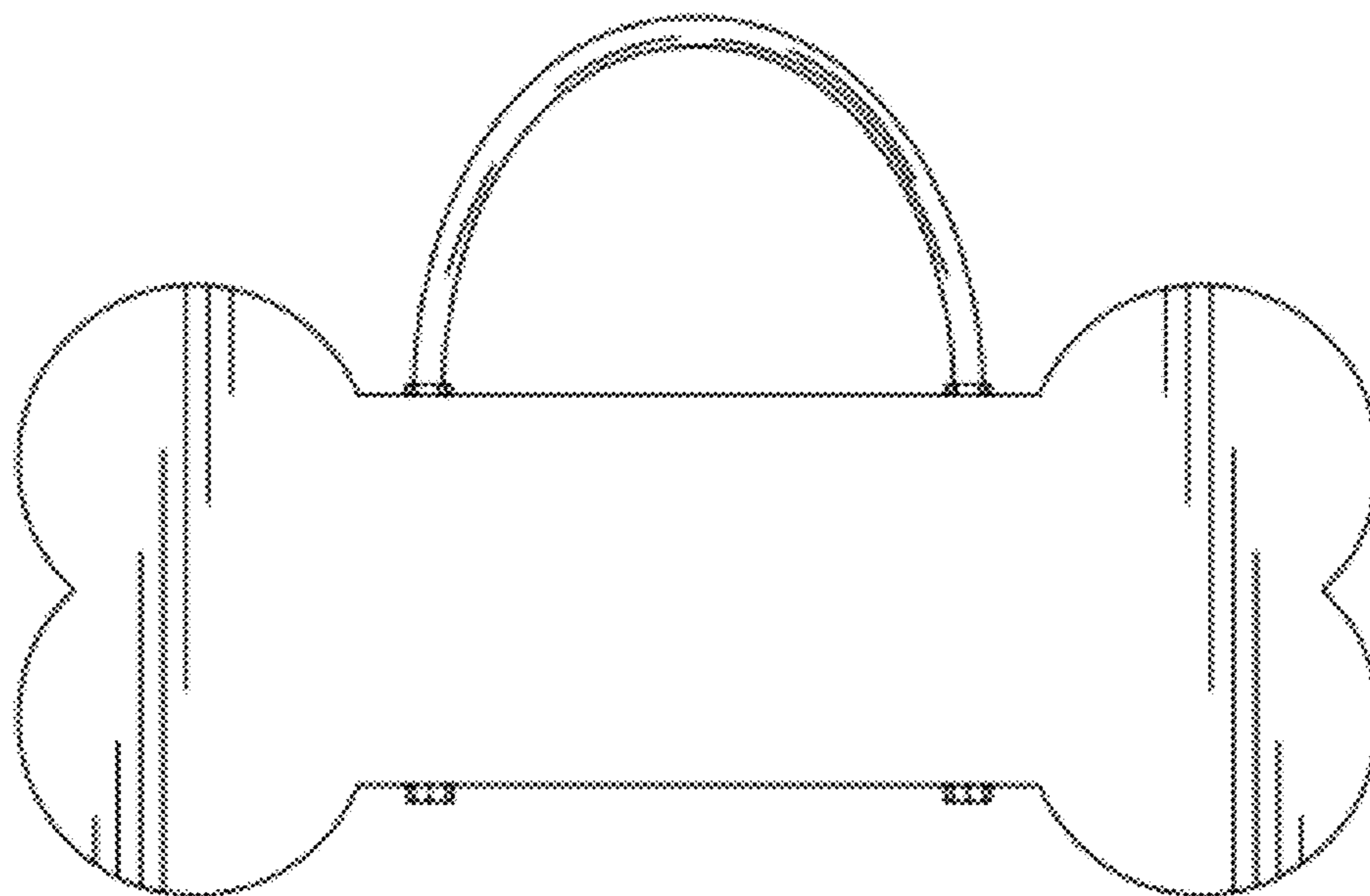

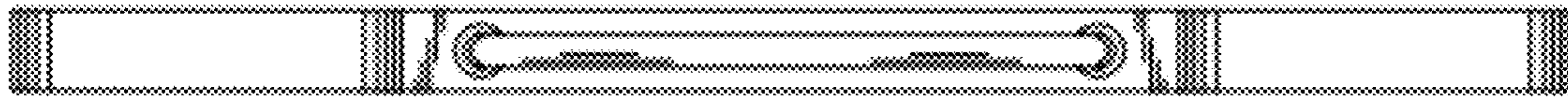
