(57) **CLAIM**

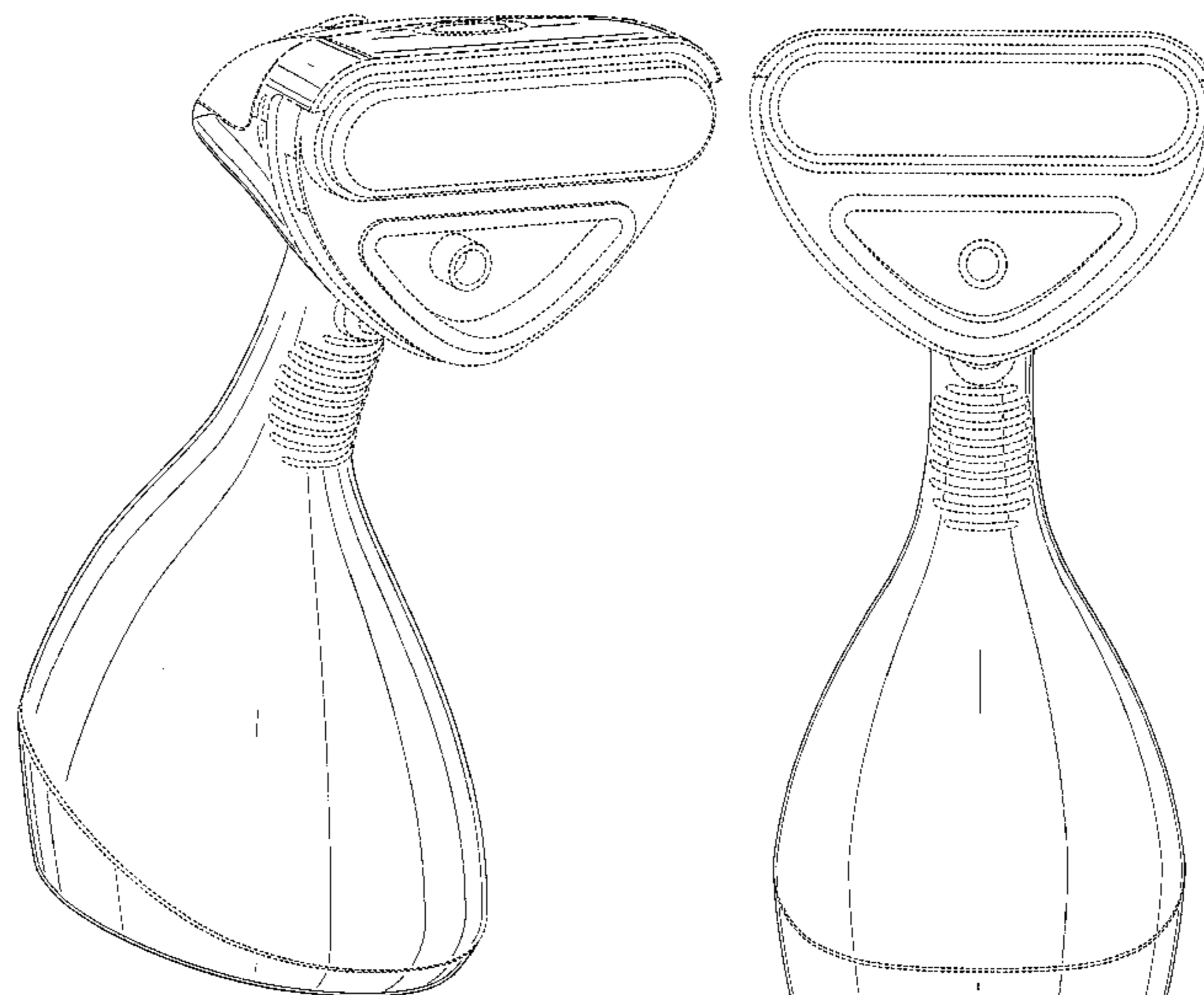
The ornamental design for a fabric care appliance, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a fabric care appliance showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

In the drawings, the broken lines in FIGS. 1-7 depict portions of the design that form no part of the claim. The dashed-dot-dashed lines on the top head of the fabric care appliance define an unclaimed boundary of a claimed shaded surface.

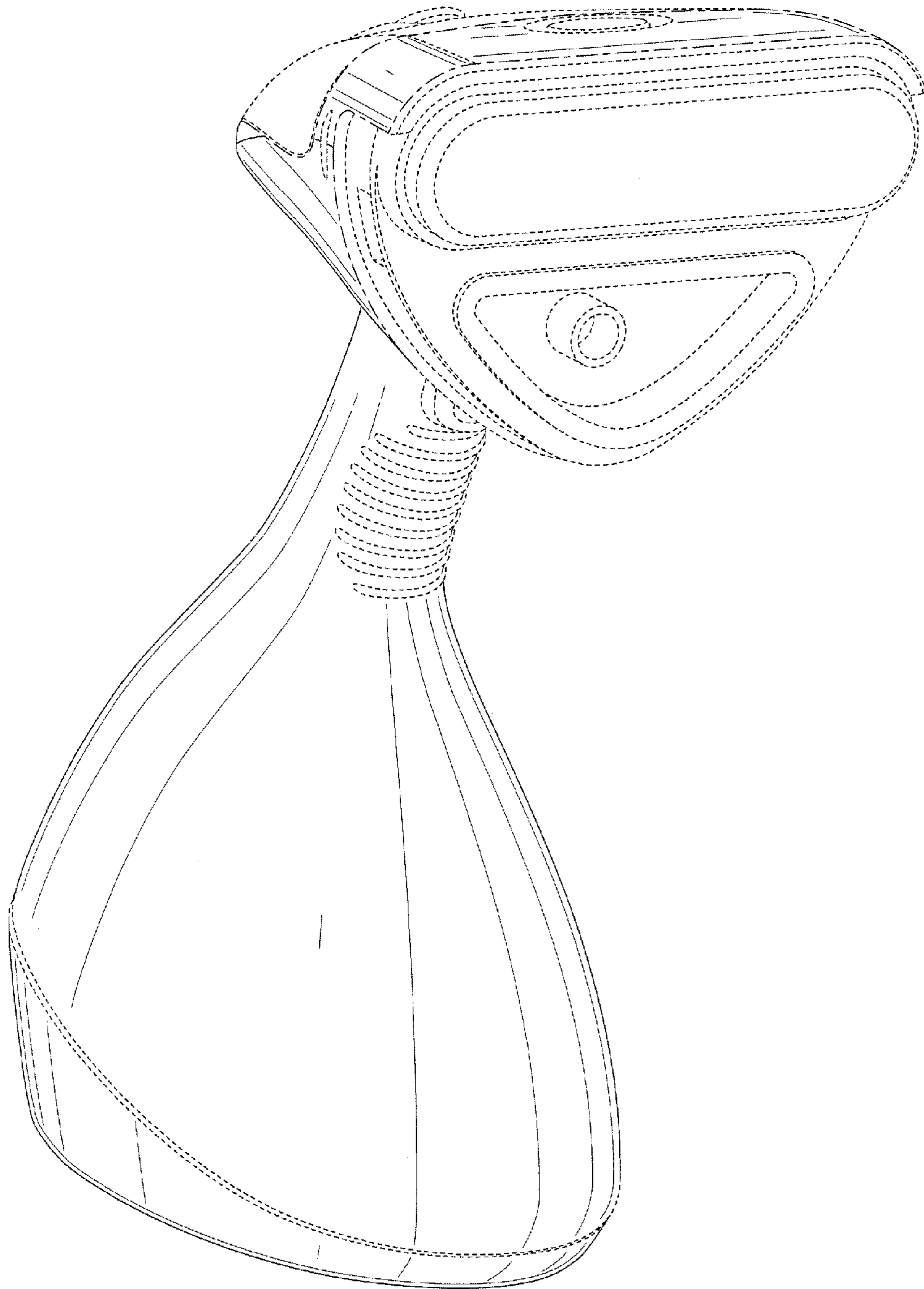

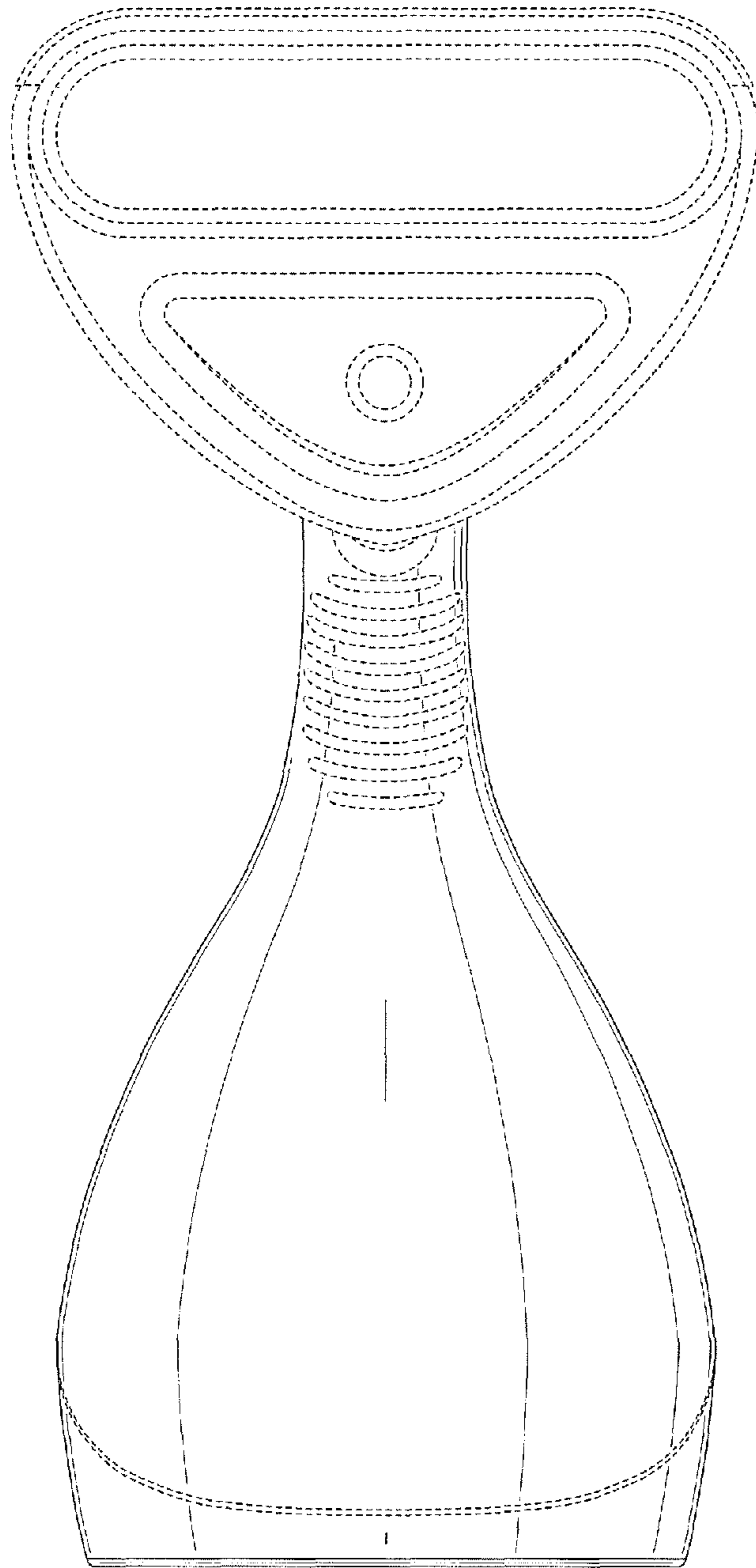

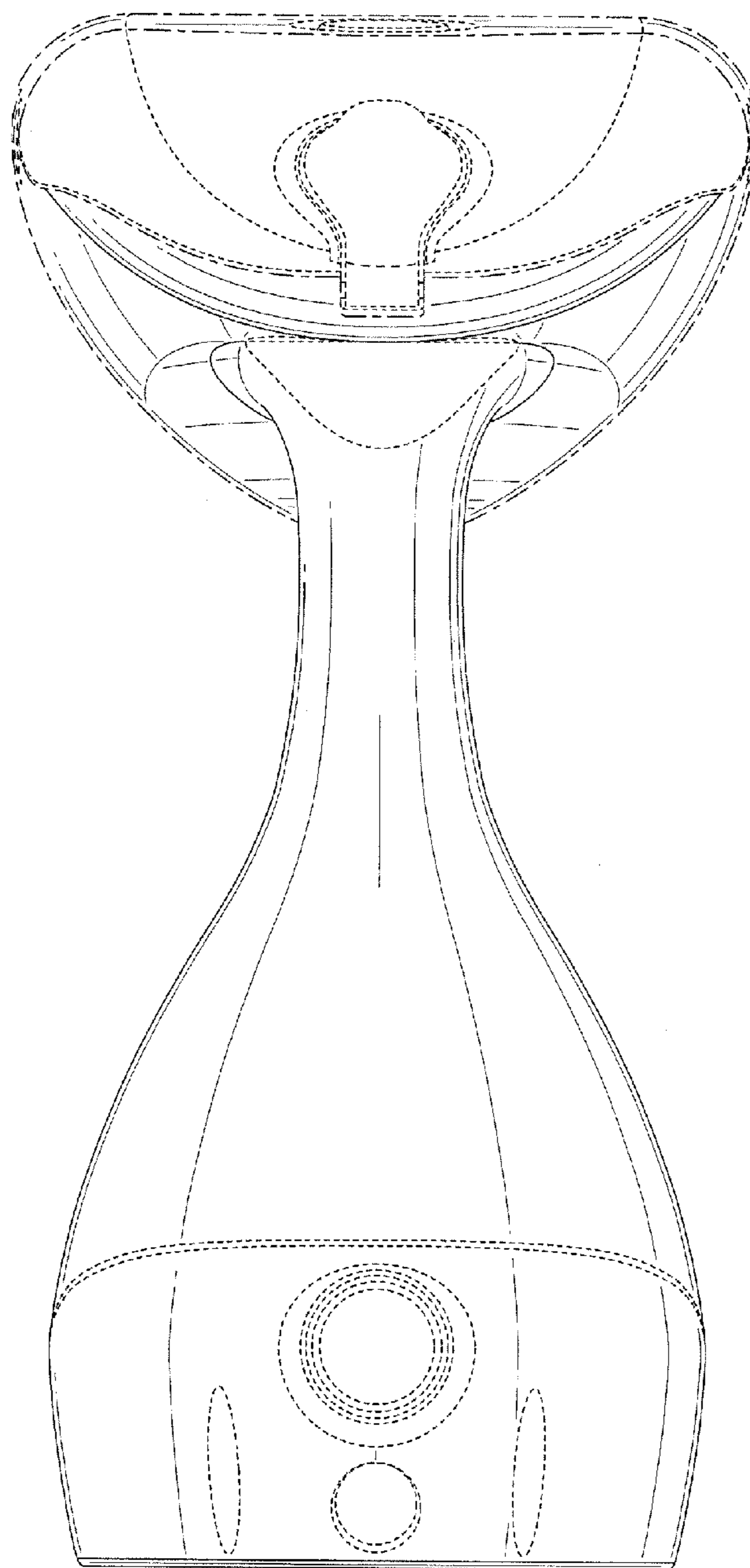

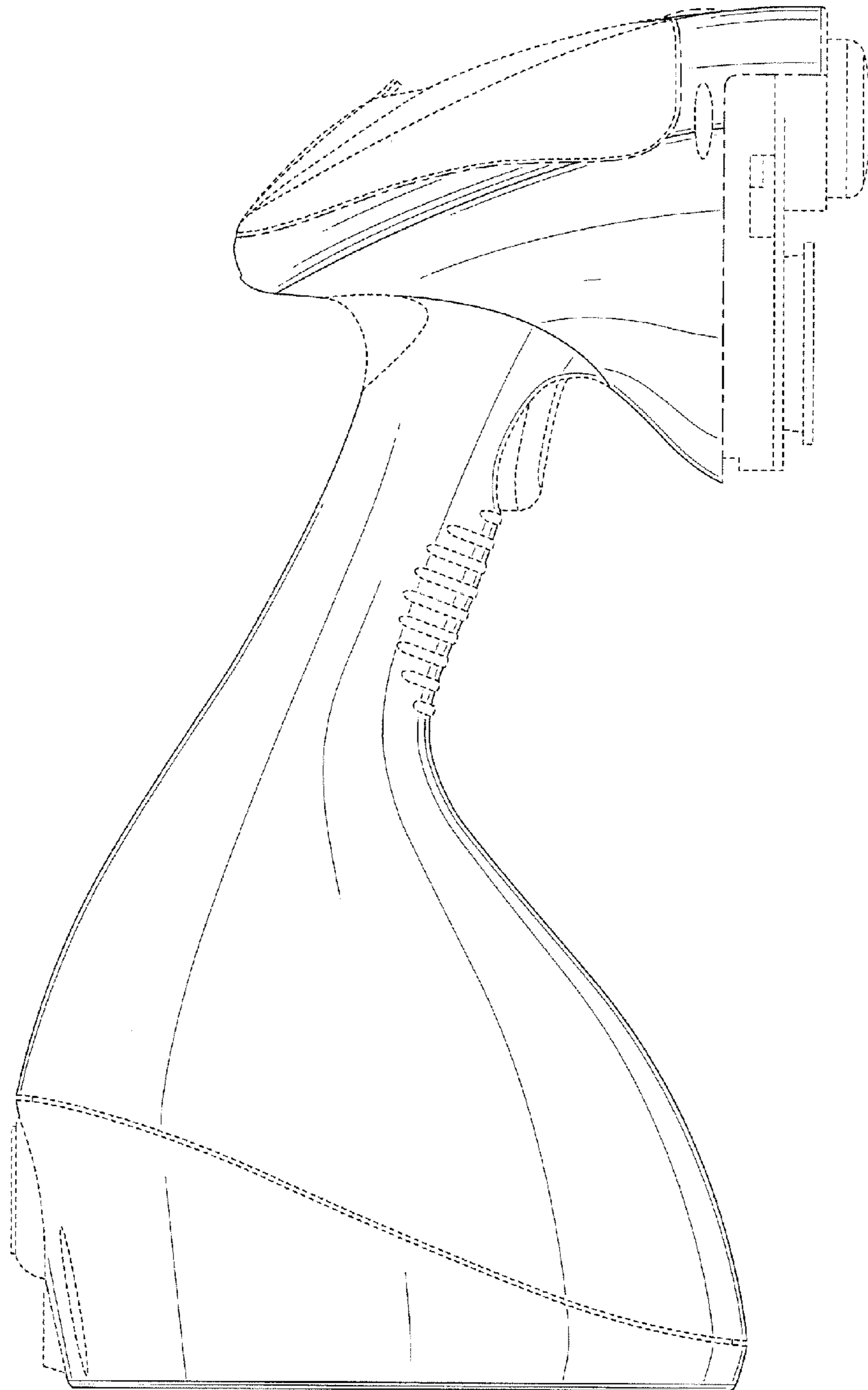

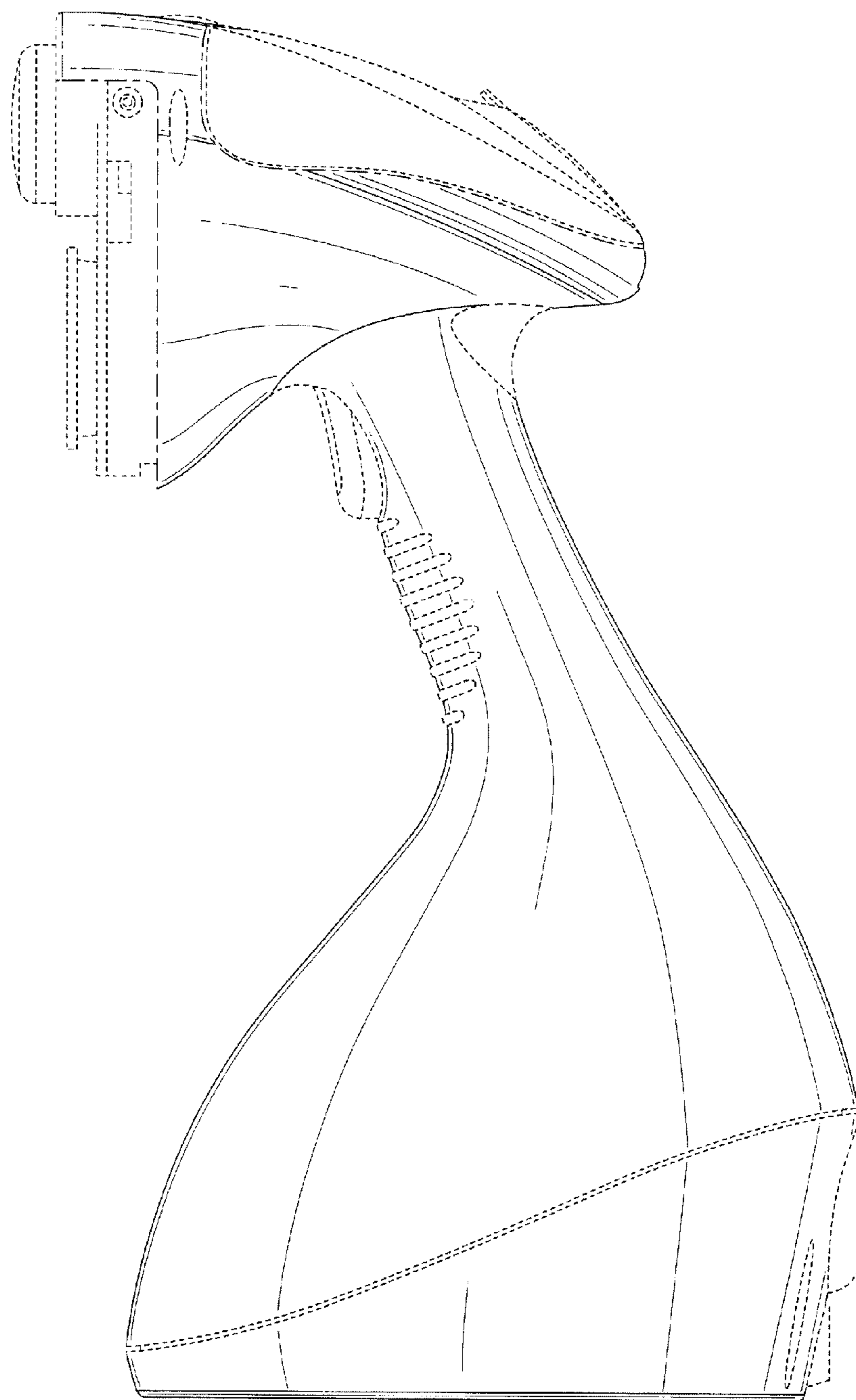

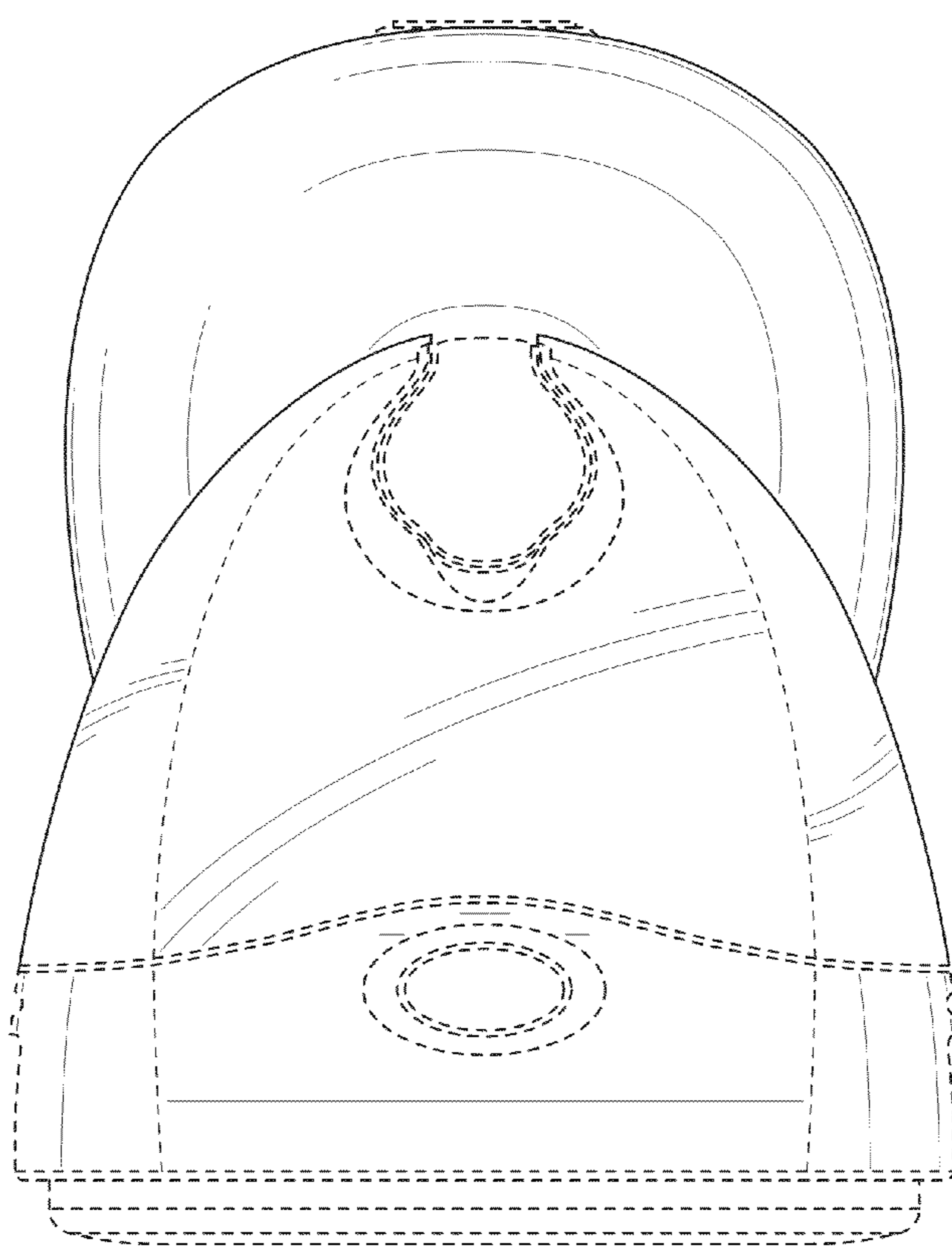

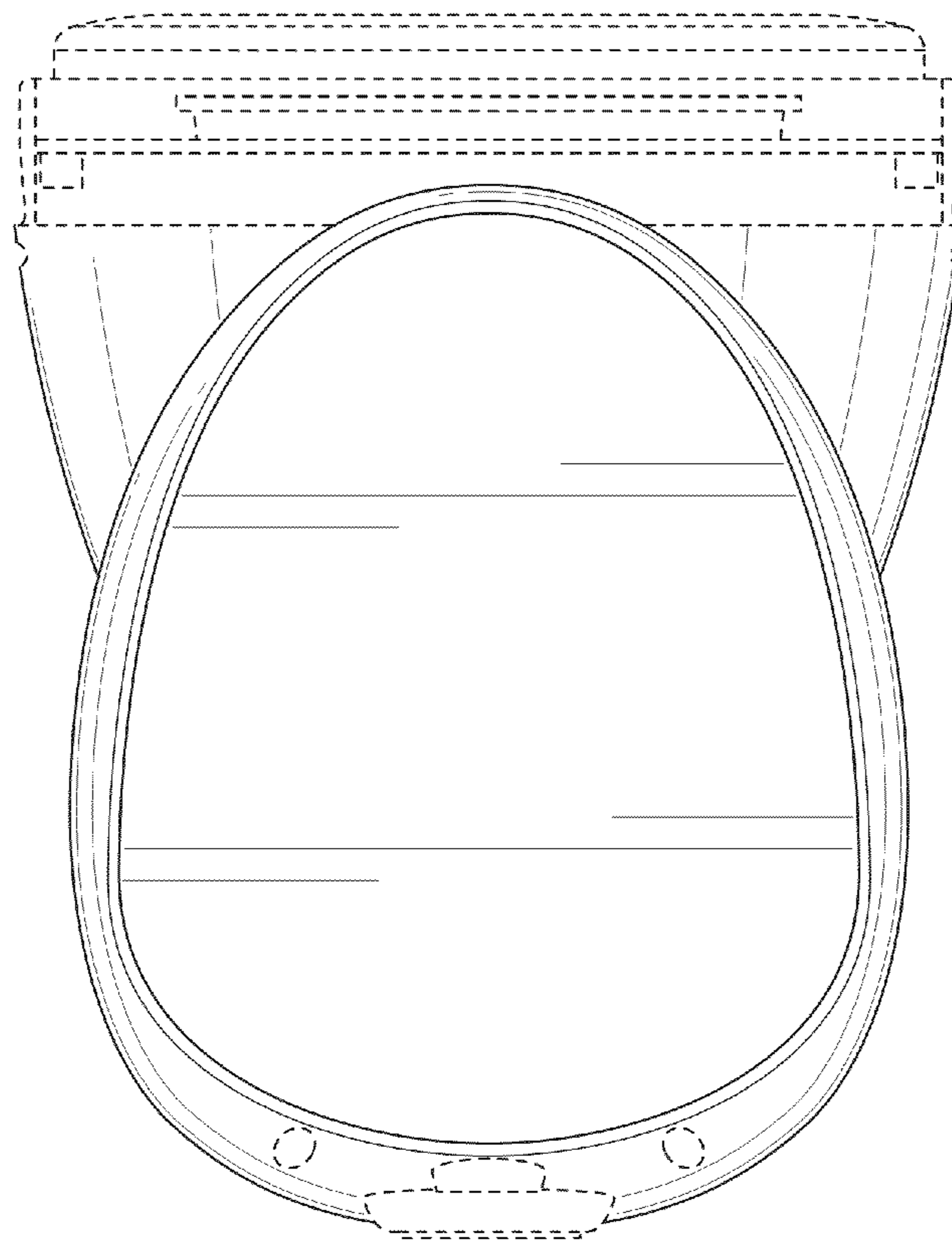
