(57) **CLAIM**

The ornamental design for a toe seam and portion of a sock, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a toe seam and portion of a sock showing my new design, without coordinating colors between the lettering and toe seam, and with a first color toe seam;

FIG. 2 is a left side view of the toe seam and portion of a sock;

FIG. 3 is a right side view of the toe seam and portion of a sock;

FIG. 4 is a bottom plan view of the toe seam and portion of a sock;

FIG. 5 is a top plan view of the toe seam and portion of a sock without coordinating colors between the lettering and toe seam, and with a second color toe seam;

FIG. 6 is a top plan view of the toe seam and portion of a sock without coordinating colors between the lettering and toe seam, and with a third color toe seam;

FIG. 7 is a top plan view of the toe seam and portion of a sock without coordinating colors between the lettering and toe seam, and with a fourth color toe seam;

FIG. 8 is a top plan view of the toe seam and portion of a sock without coordinating colors between the lettering and toe seam, and with a fifth color toe seam;

FIG. 9 is a top plan view of the toe seam and portion of a sock with coordinating colors between the lettering and toe seam, and with a first color toe seam;

FIG. 10 is a top plan view of the toe seam and portion of a sock with coordinating colors between the lettering and toe seam, and with a second color toe seam;

FIG. 11 is a top plan view of the toe seam and portion of a sock with coordinating colors between the lettering and toe seam, and with a third color toe seam;

FIG. 12 is a top plan view of the toe seam and portion of a sock with coordinating colors between the lettering and toe seam, and with a fourth color toe seam;

FIG. 13 is a top plan view of the toe seam and portion of a sock with coordinating colors between the lettering and toe seam, and with a fifth color toe seam;

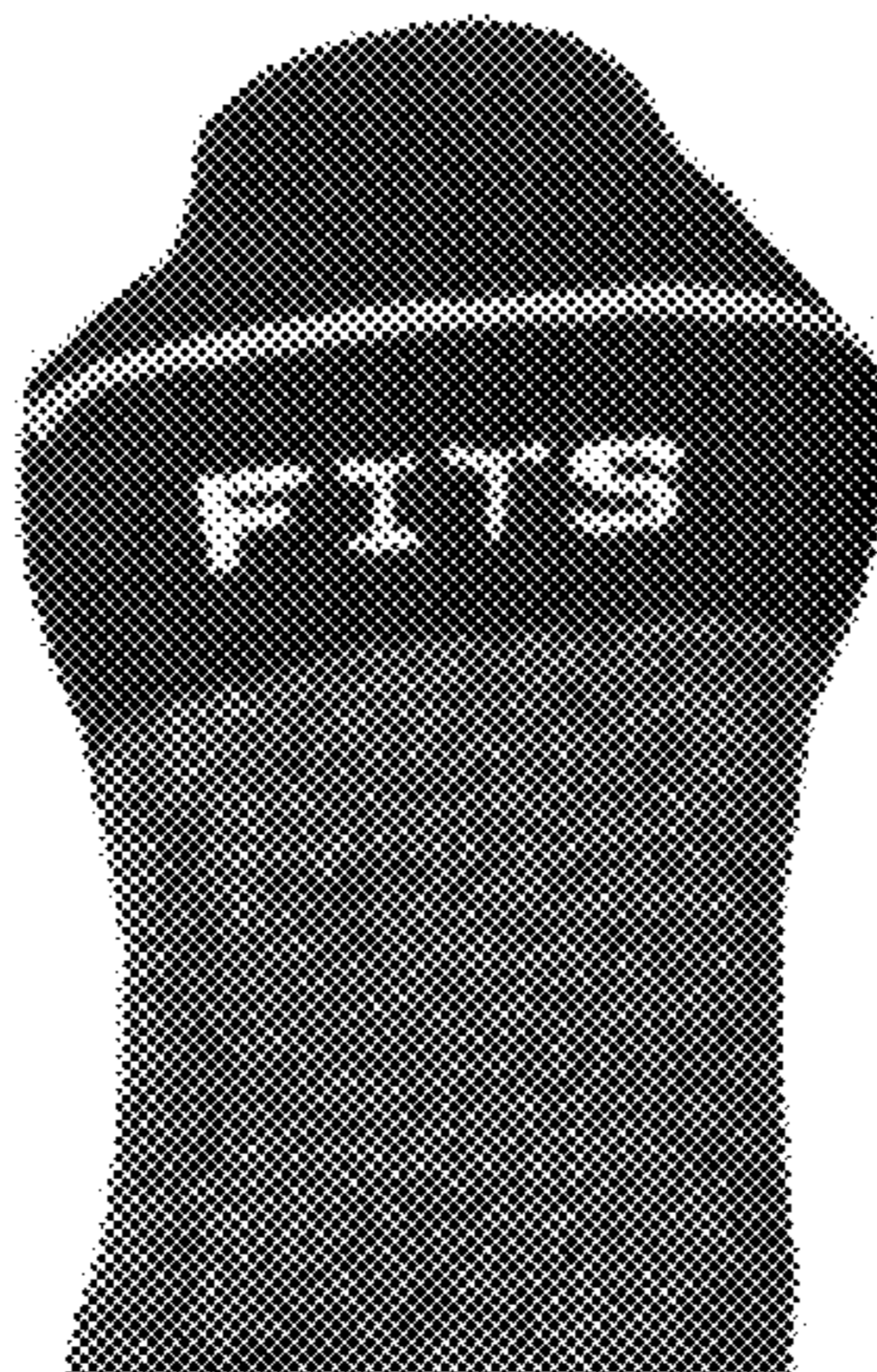
FIGS. 14 and 15 are comparison views of the toe seam and portion of a sock without coordinating colors between the lettering and toe seam and the toe seam and portion of a sock with coordinating colors between the lettering and toe seam, side-by-side;

FIGS. 16-20 are comparison views of the first, second, third, fourth, and fifth colors of the toe seam and portion of a sock without coordinating colors between the lettering and toe seam, side-by-side; and,

FIGS. 21-25 are comparison views of the first, second, third, fourth, and fifth colors of the toe seam and portion of a sock with coordinating colors between the lettering and toe seam, side-by-side.

A specific length of sock beyond what is shown forms no part of the claimed design.

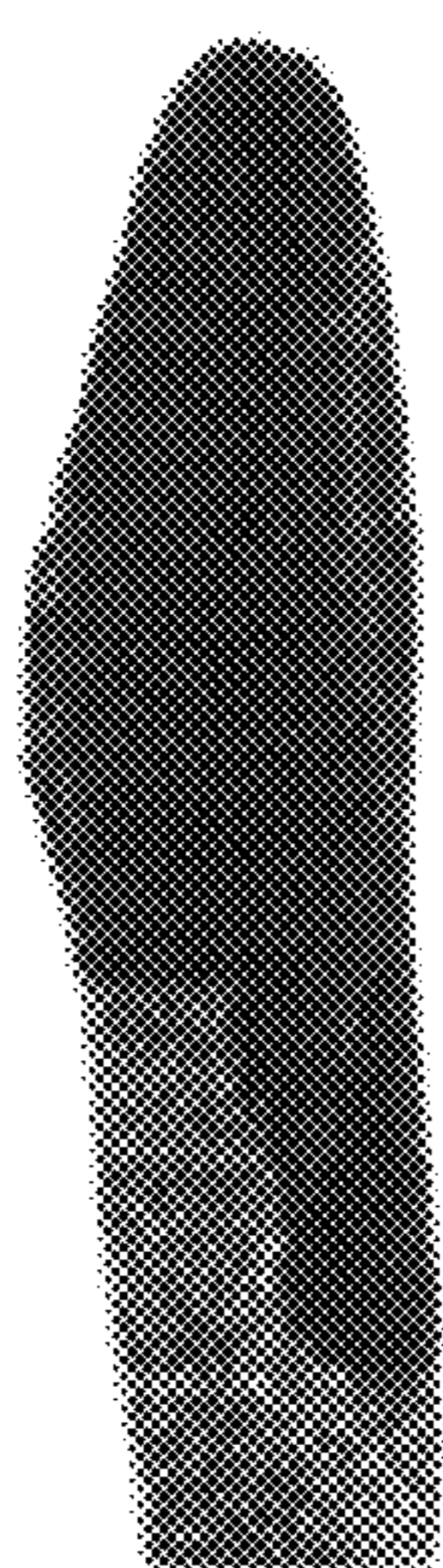

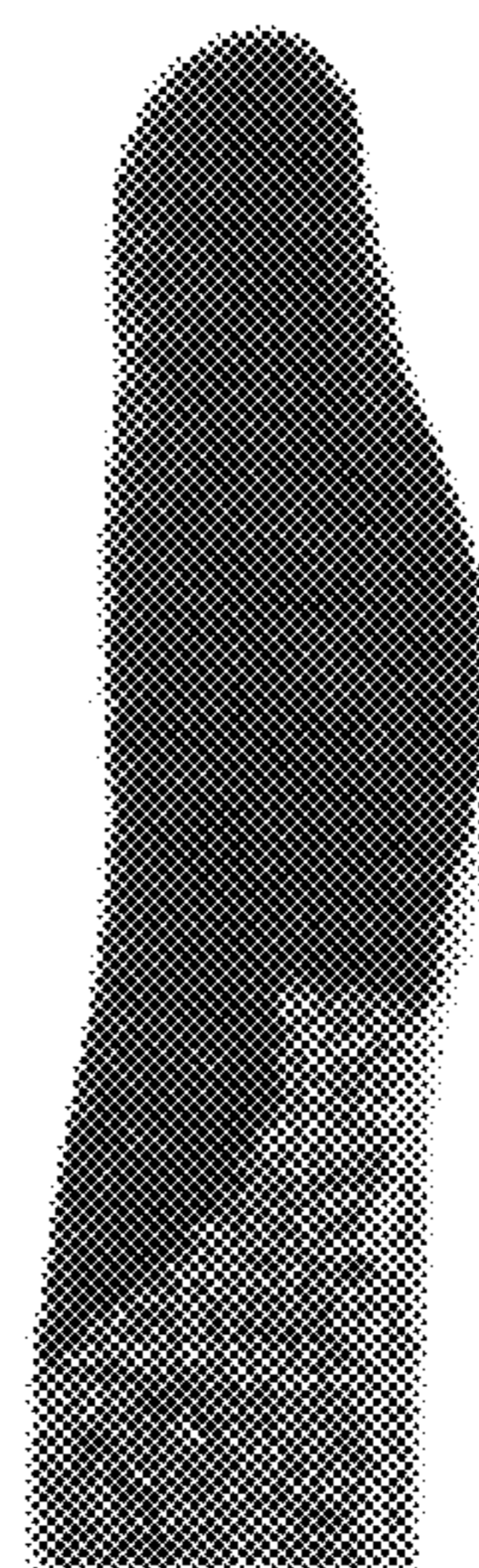

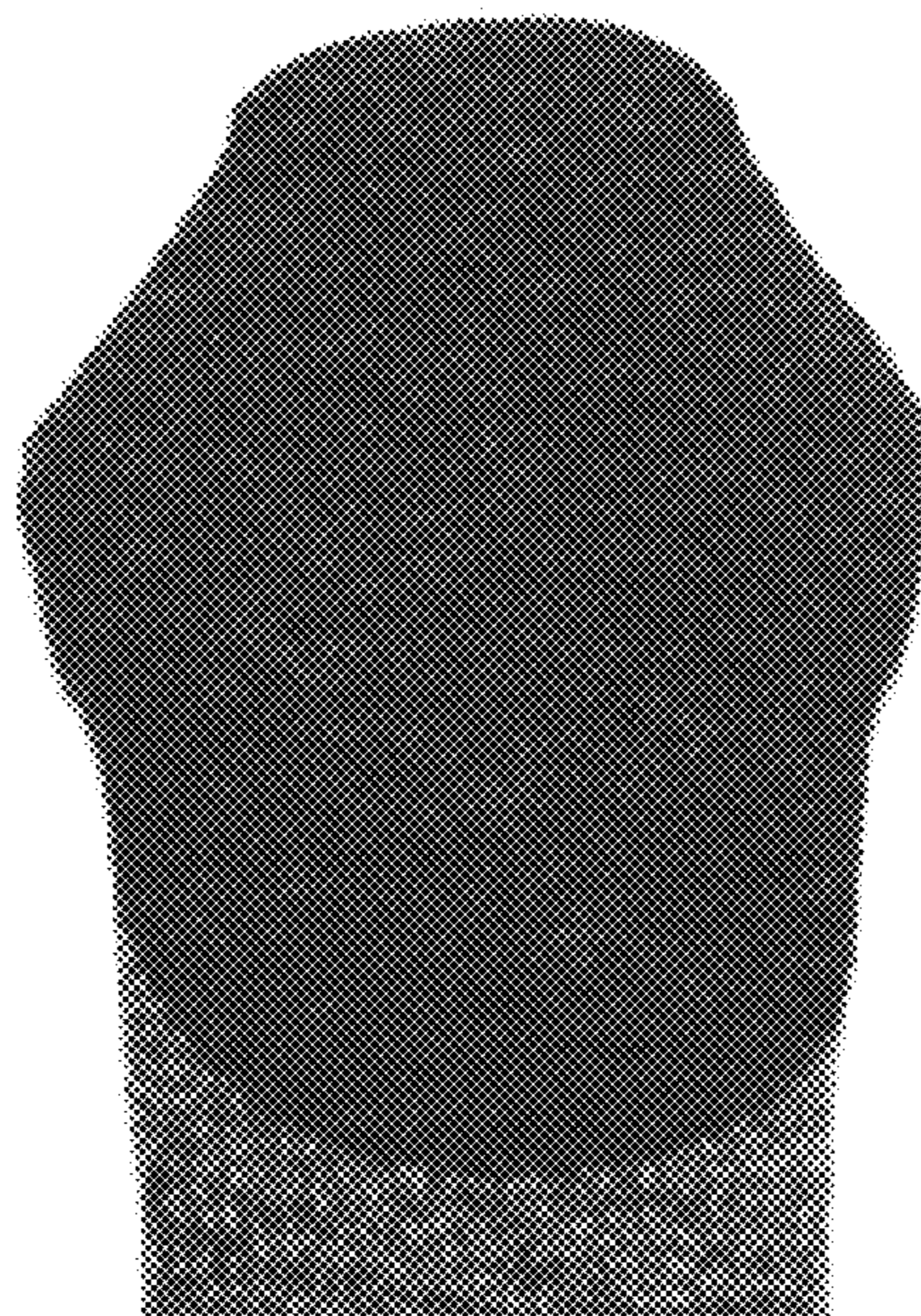

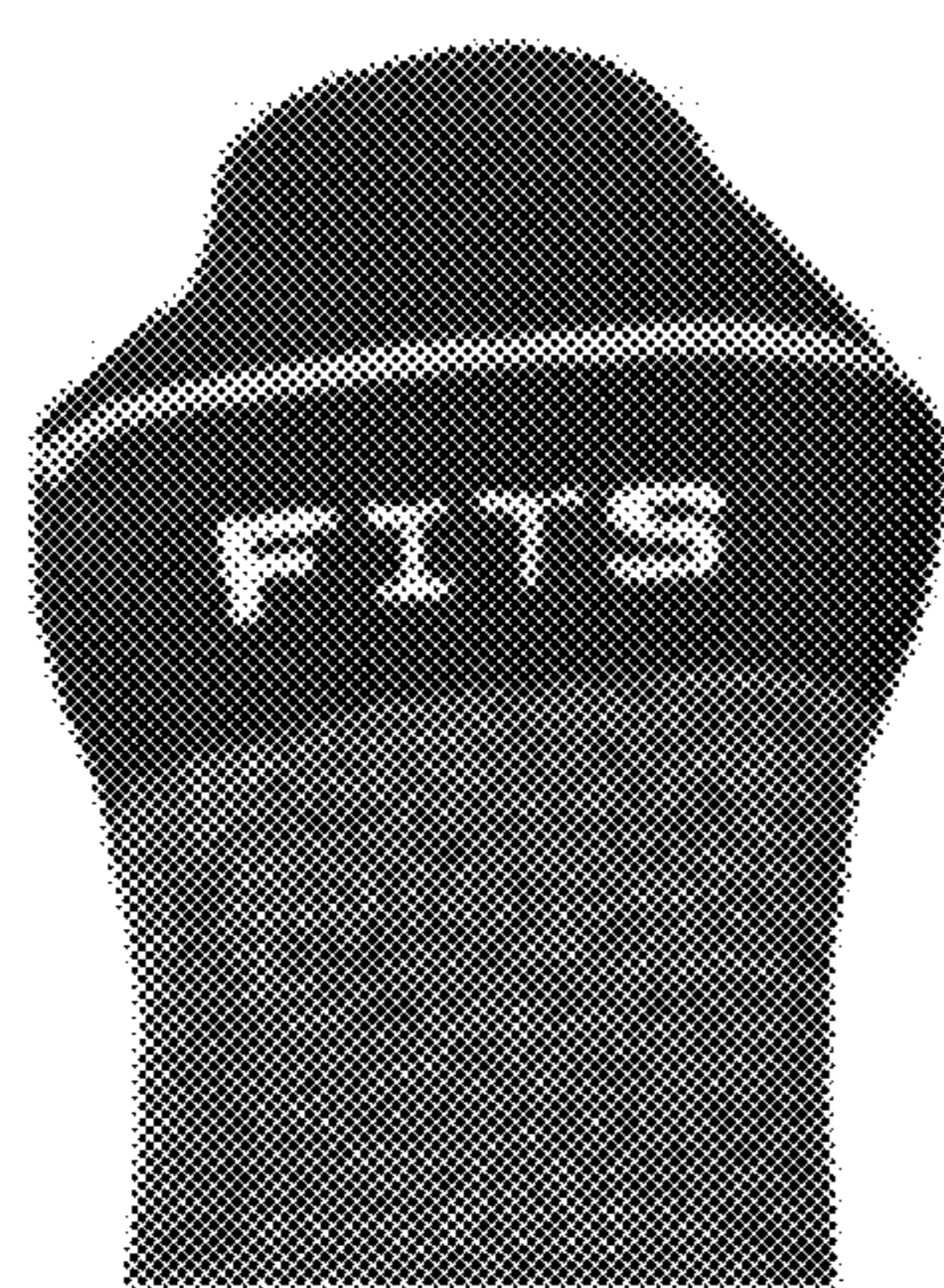
