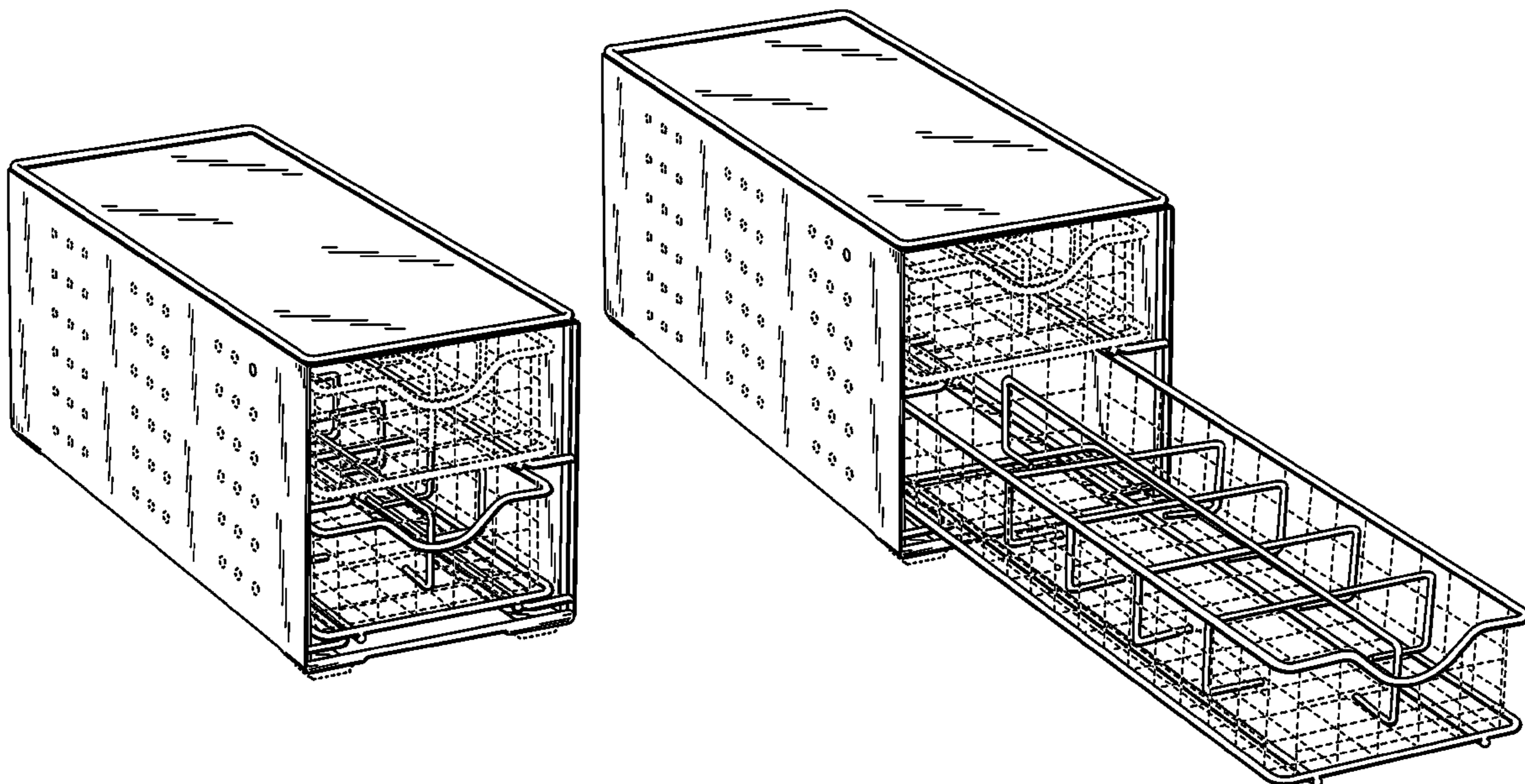
(57) **CLAIM**

The ornamental design for a removable divider drawer system, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the design; FIG. 2 is a front perspective view of the design with a drawer extended from the enclosure; FIG. 3 is a front elevational view of the design; FIG. 4 is a rear elevational view of the design; FIG. 5 is a first side elevational view of the design, with the opposed second side being a mirror image of the first side; FIG. 6 is a top plan view of the design; and, FIG. 7 is a bottom plan view of the design. The broken line showing is for illustrative purposes only, and forms no part of the claimed design.

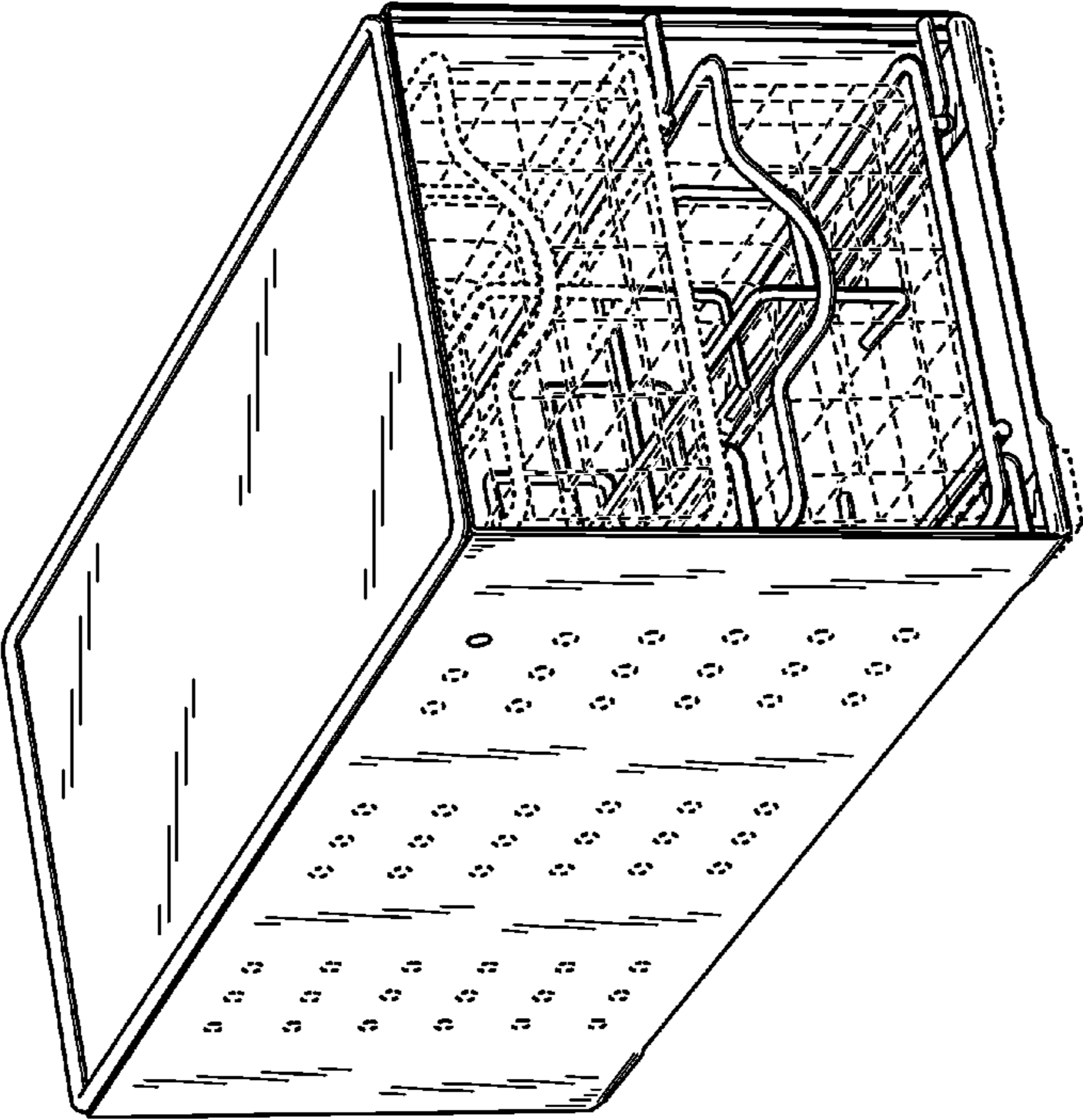

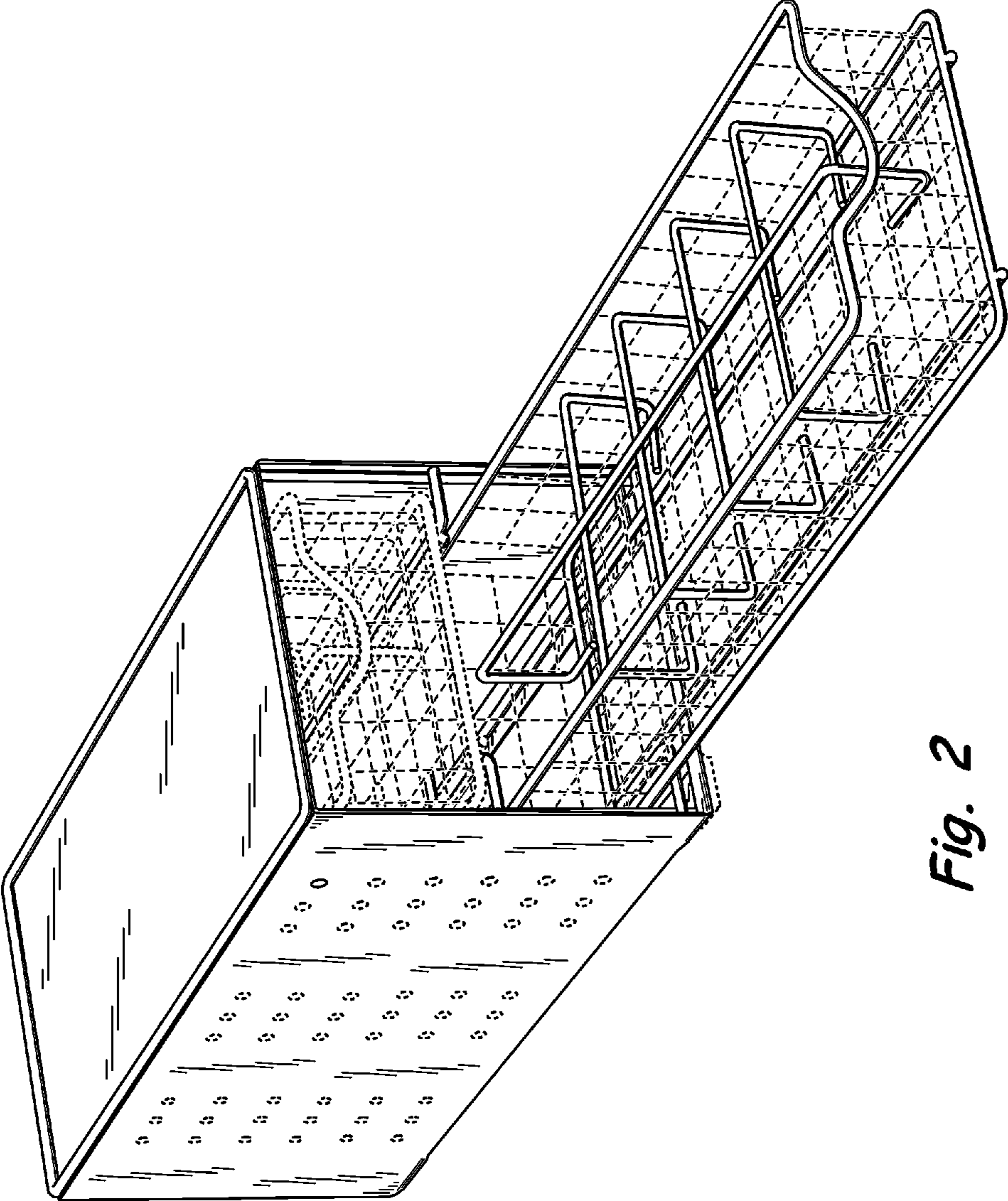

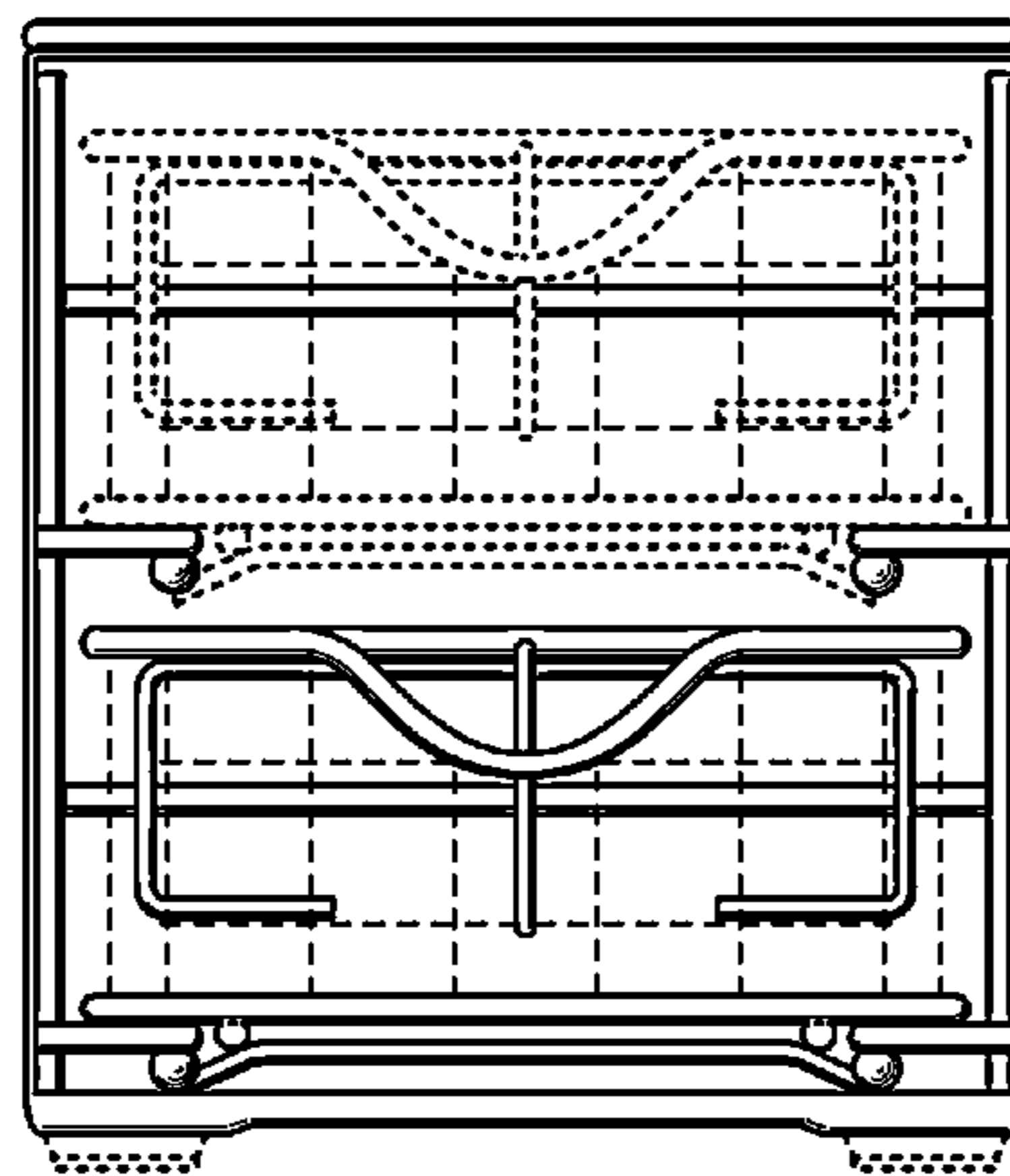

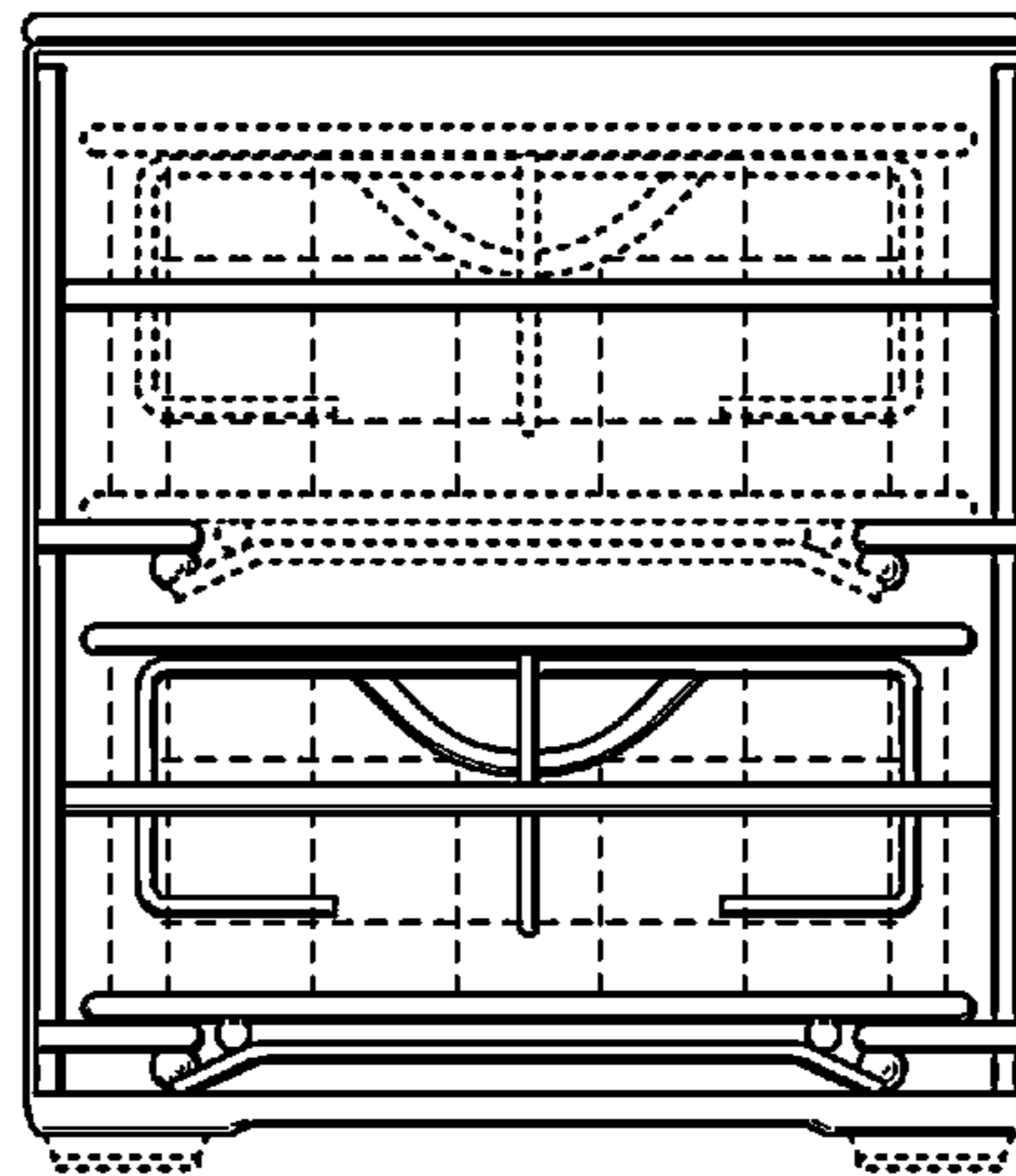

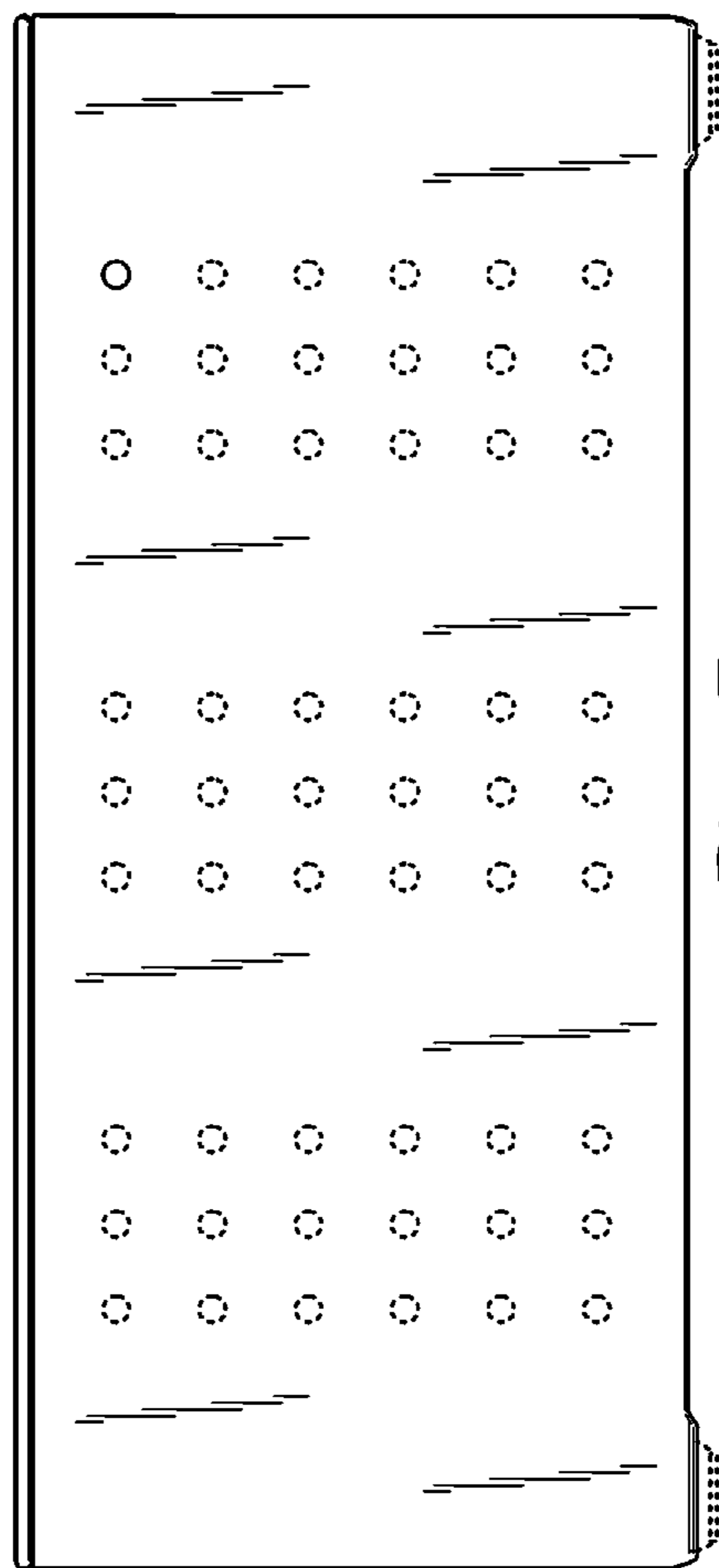

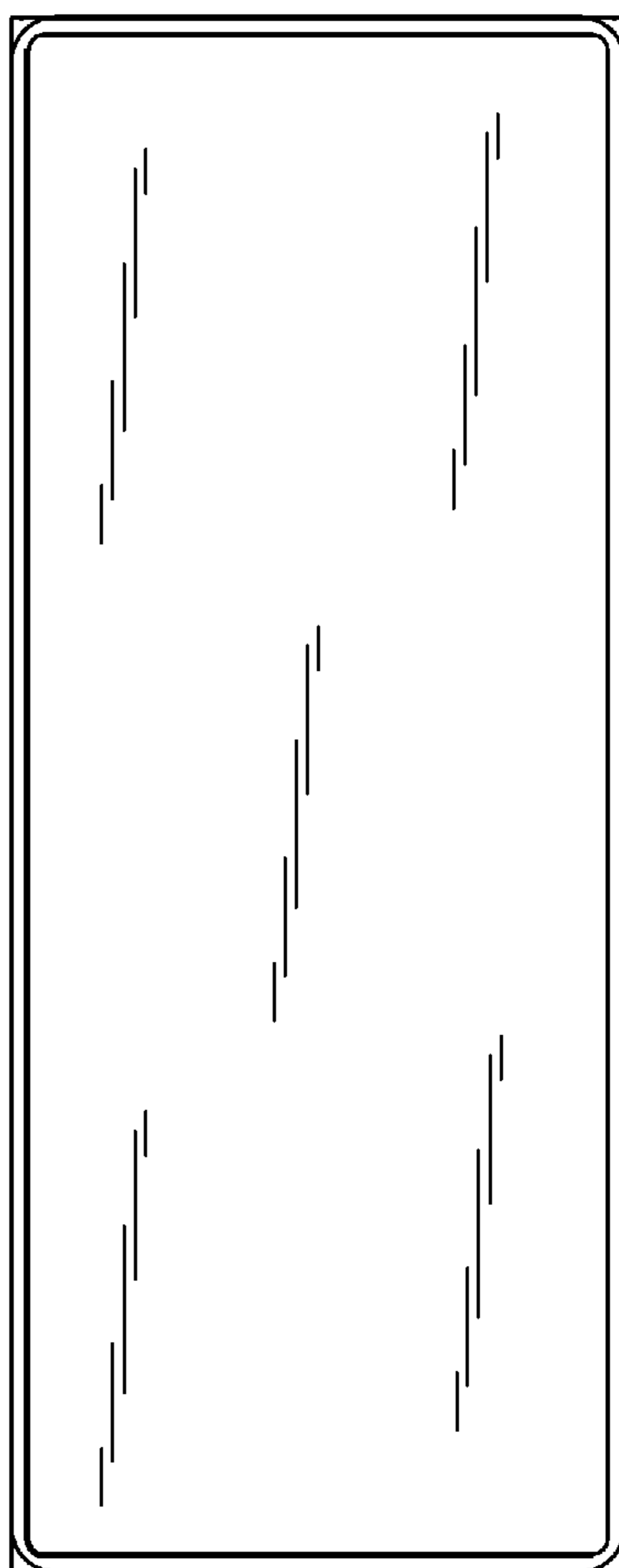

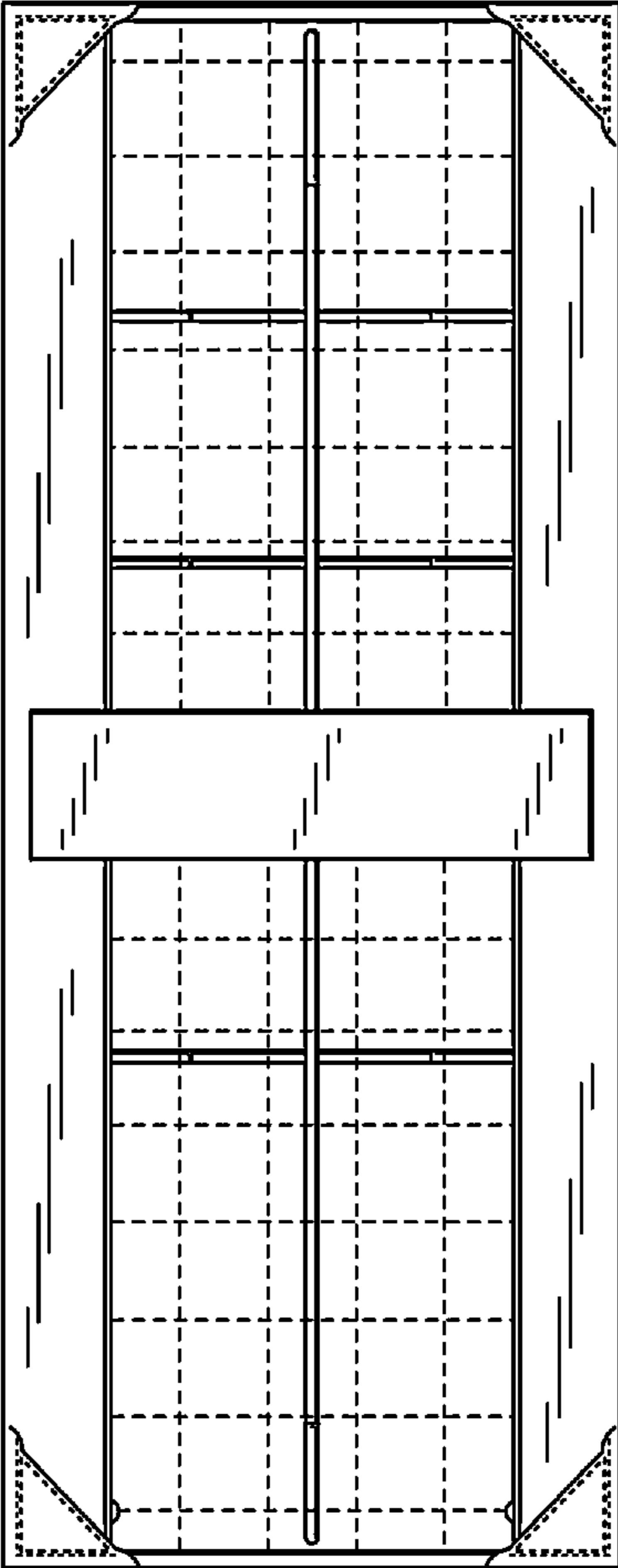
