(57) **CLAIM**

The ornamental design for flatware, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a new ornamental design for flatware embodied as a spoon.

FIG. 2 is a bottom plan view thereof.

FIG. 3 is a side elevation view thereof, the opposite side being a mirror image.

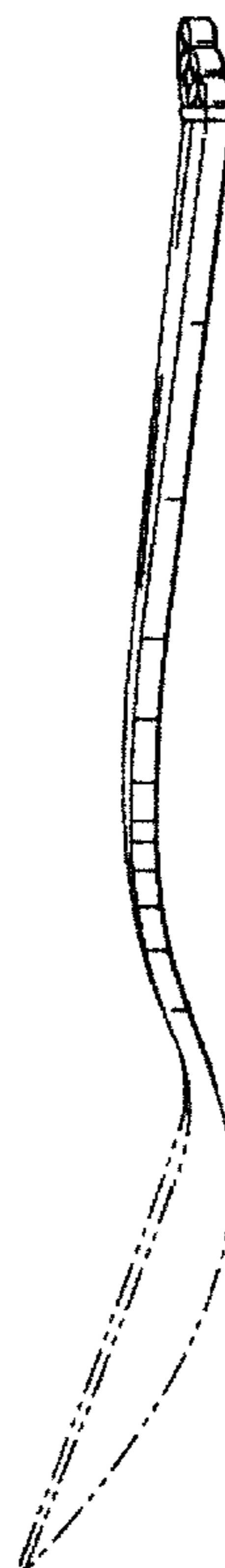
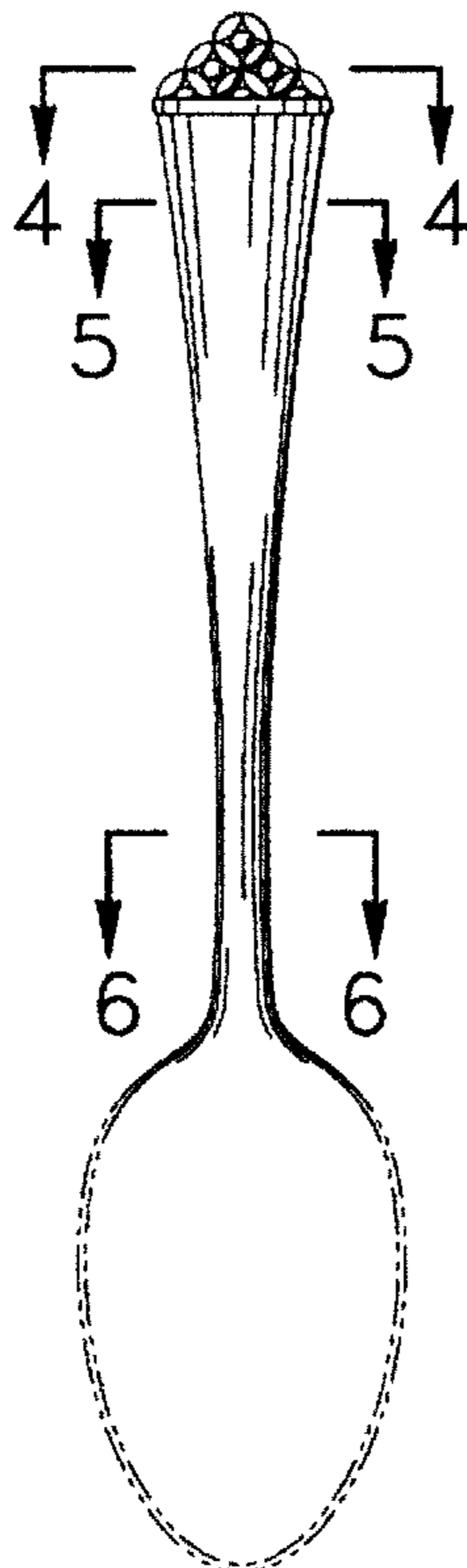
FIG. 4 is an enlarged cross-sectional view taken along section line 4-4 of FIG. 1 to illustrate the exterior peripheral shape of the article at the cross-section.

FIG. 5 is an enlarged cross-sectional view taken along section line 5-5 of FIG. 1 to illustrate the exterior peripheral shape of the article at the cross-section; and,

FIG. 6 is an enlarged cross-sectional view taken along section line 6-6 of FIG. 1 to illustrate the exterior peripheral shape of the article at the cross-section.

The broken lines in the drawings are included for purposes of illustrating portions of the article that form no part of the claimed design.

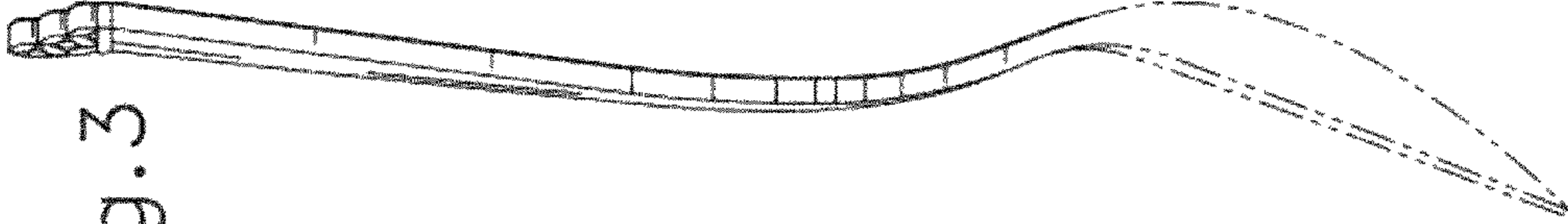

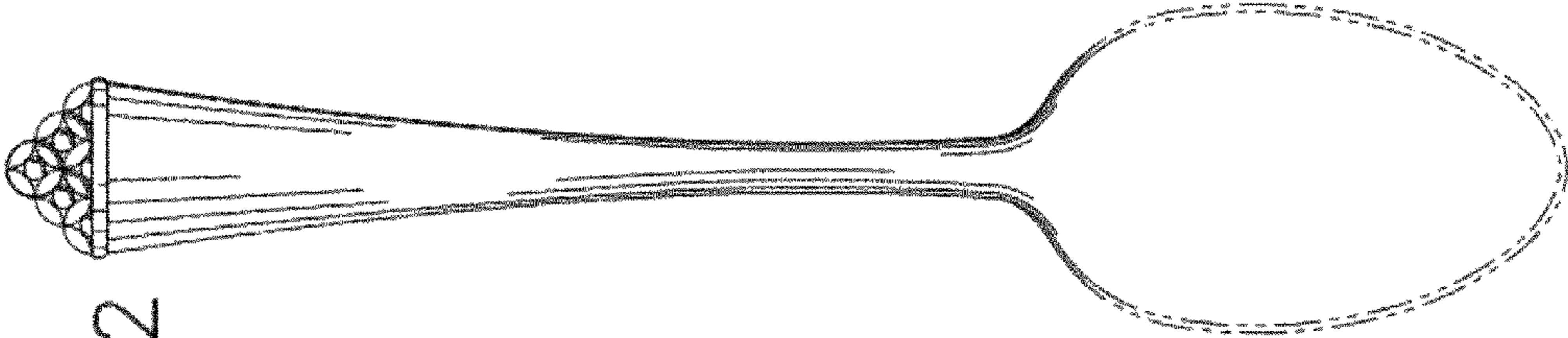

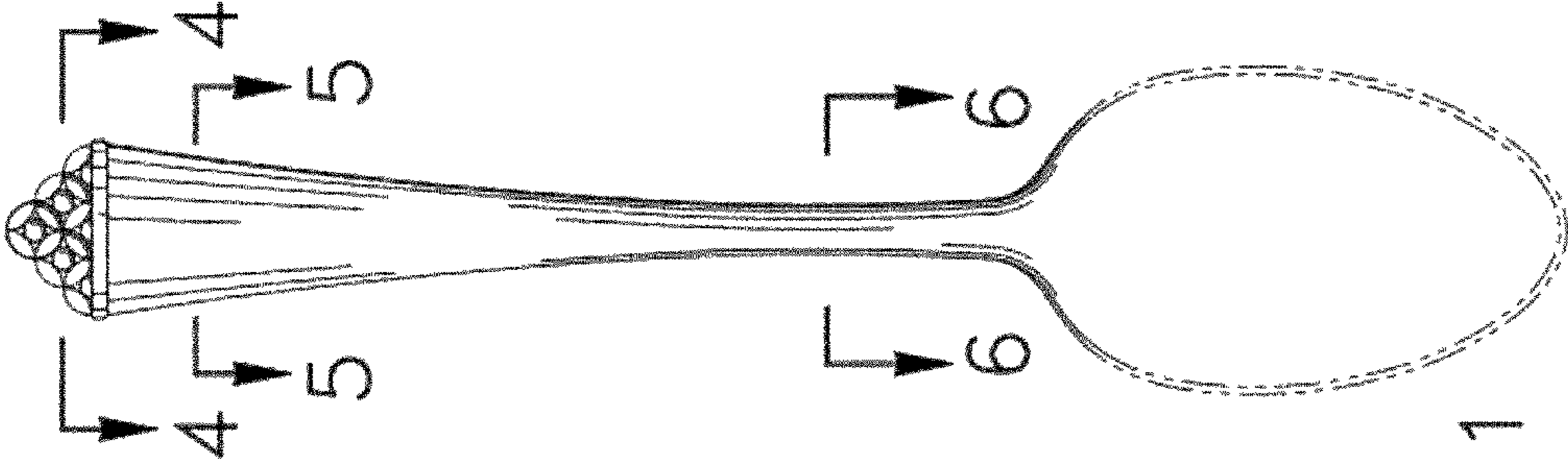
