**DESCRIPTION**

FIG. 1 is a front right perspective view of a wristwatch showing our new design;

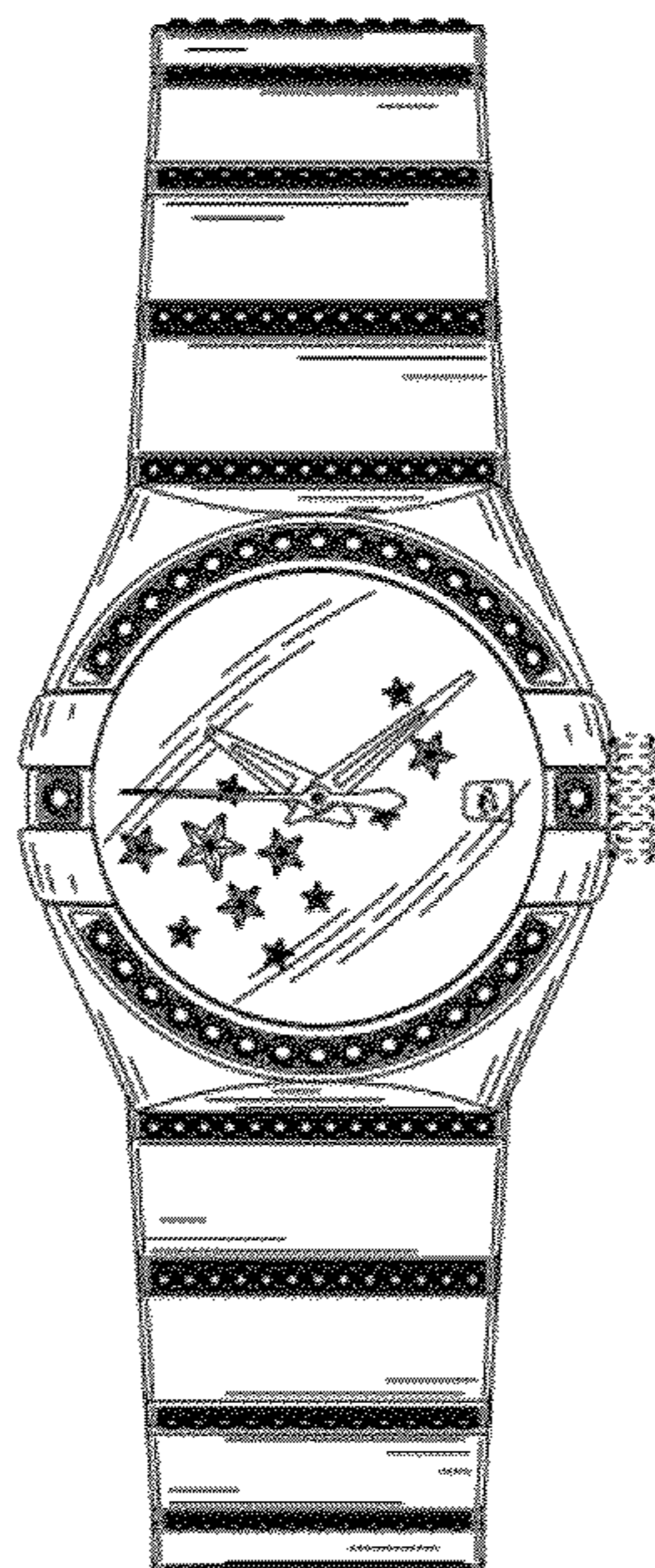

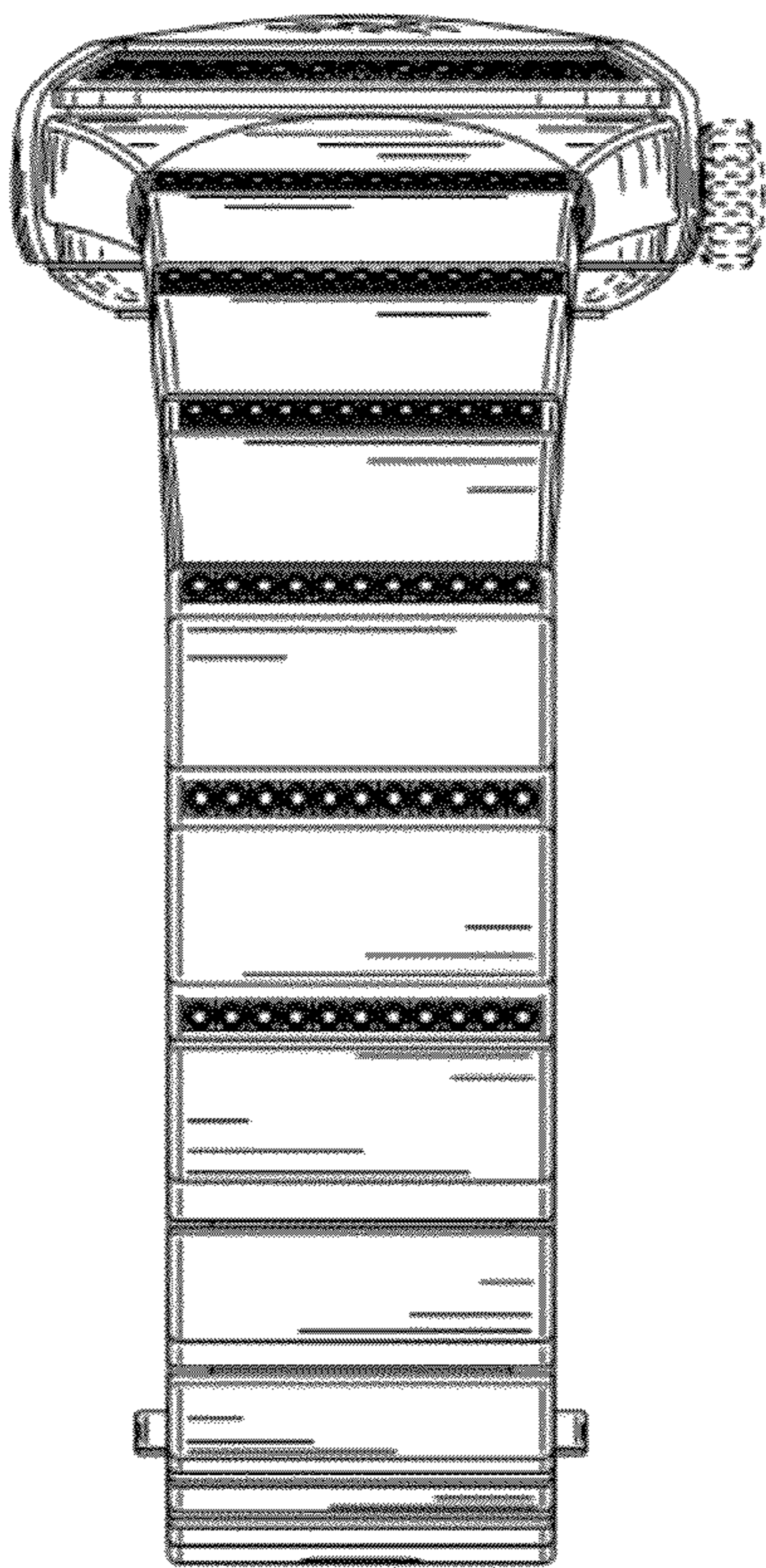

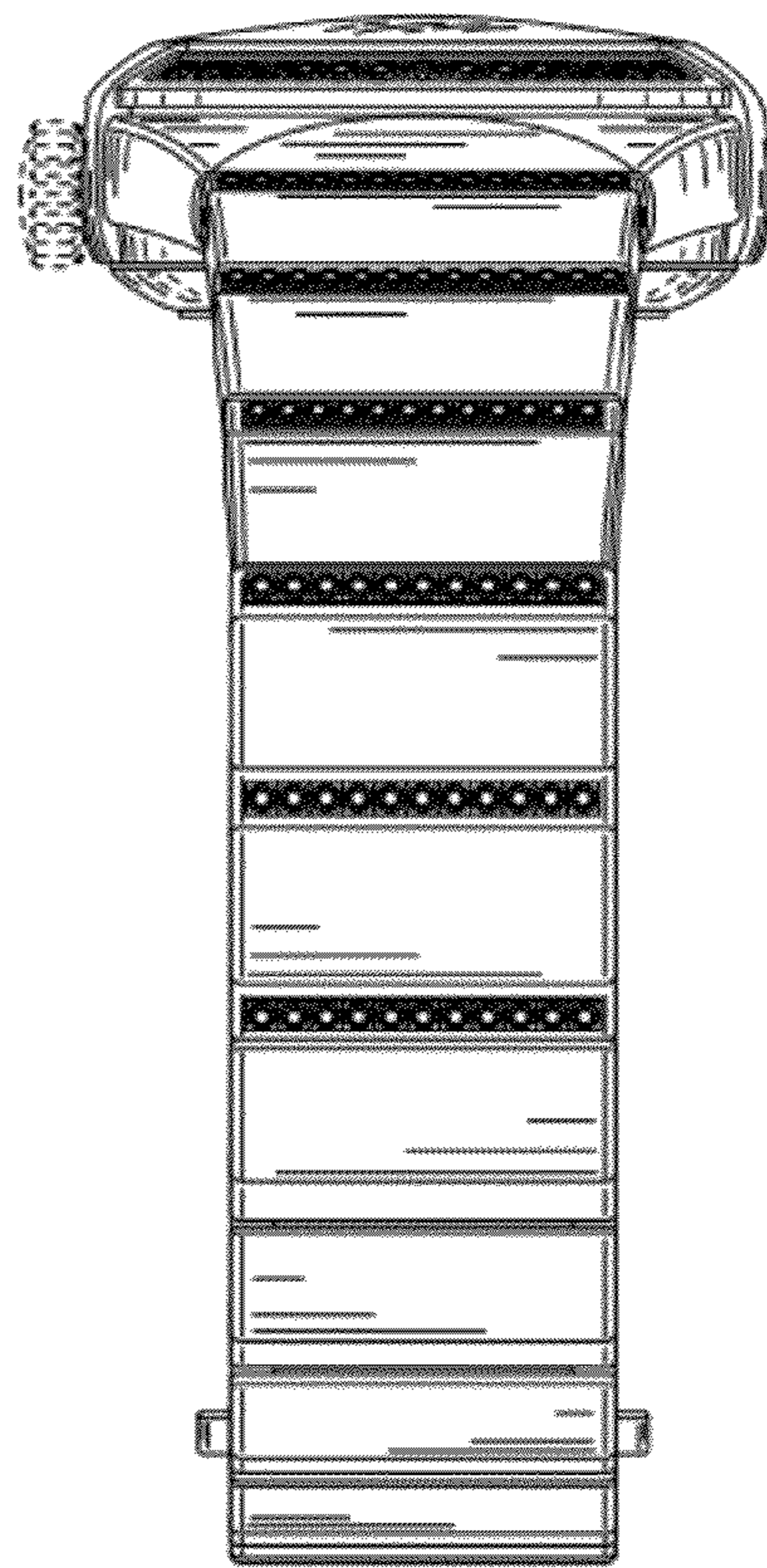

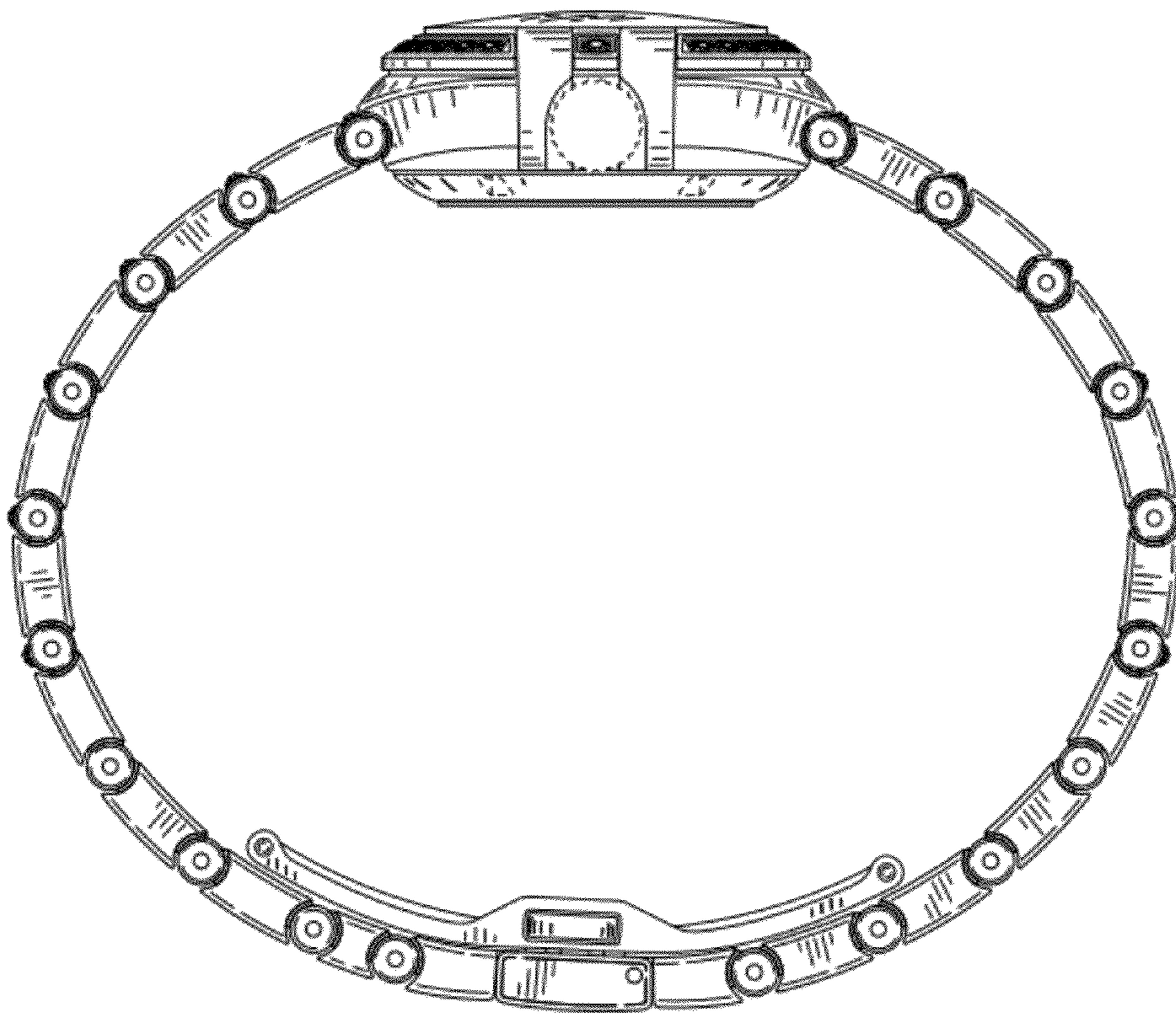

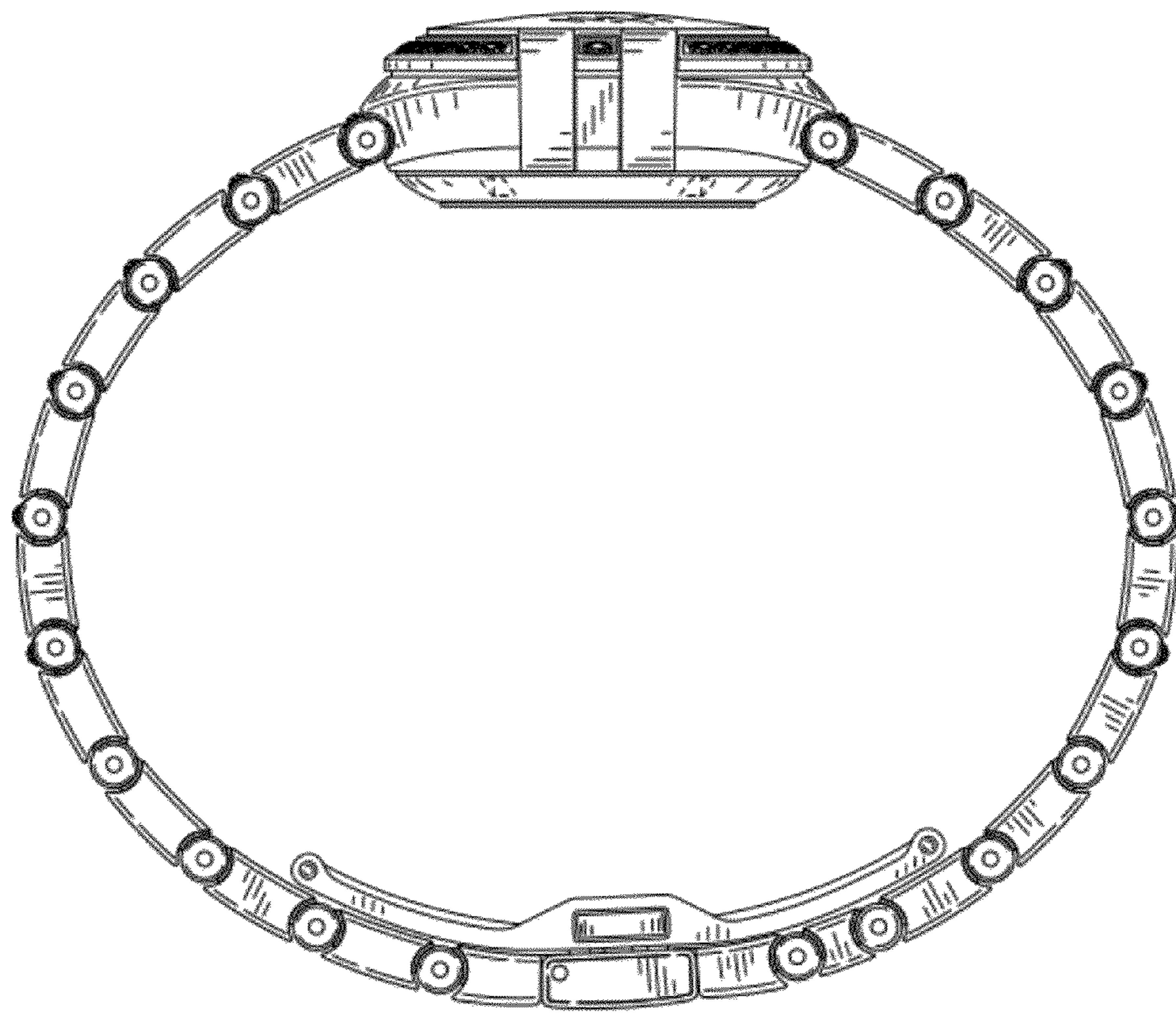

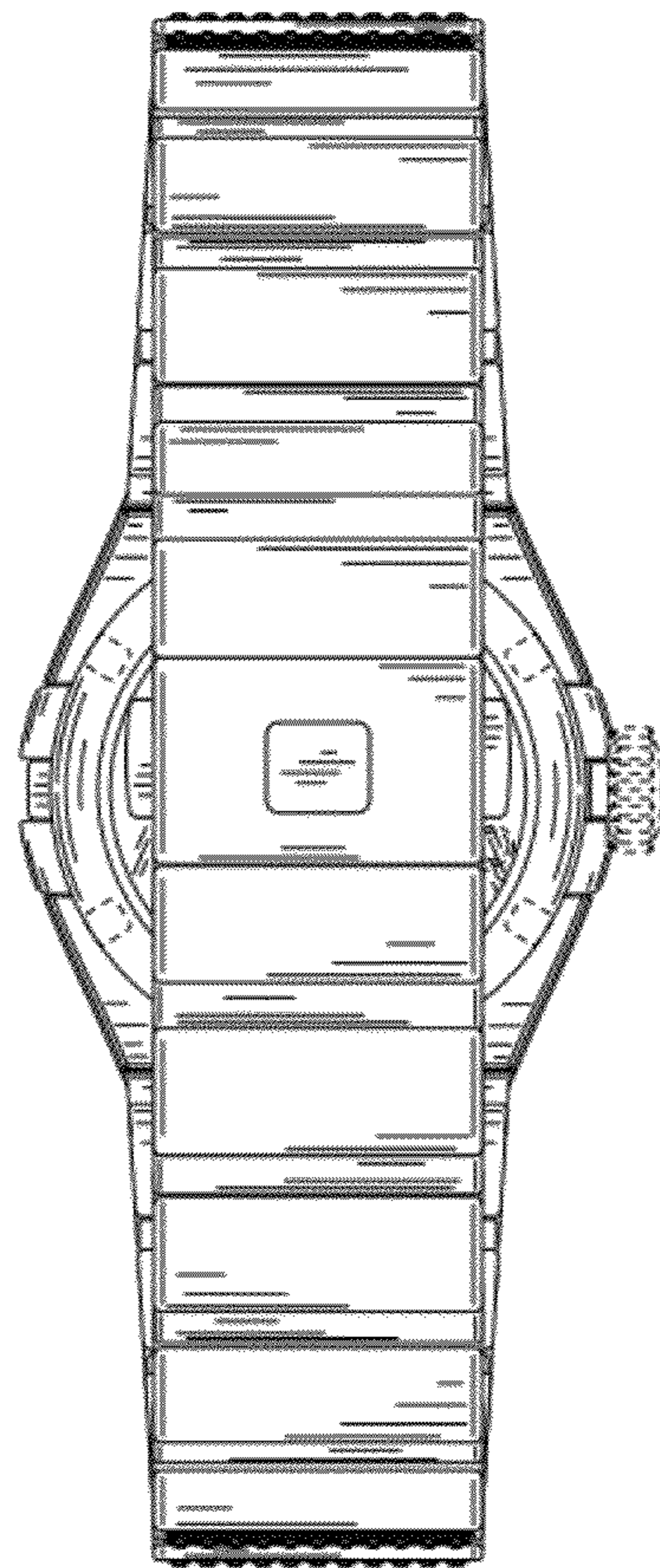

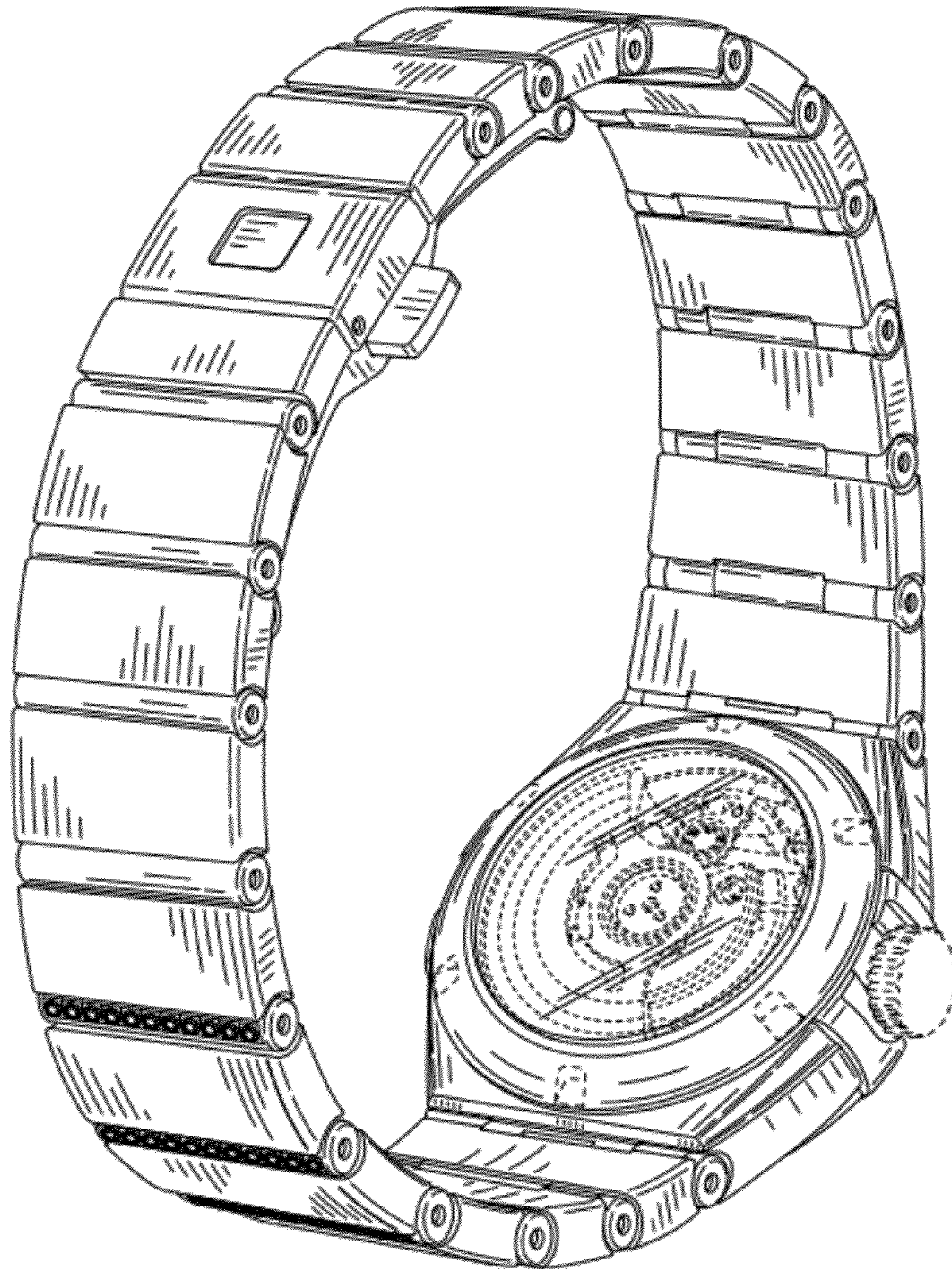

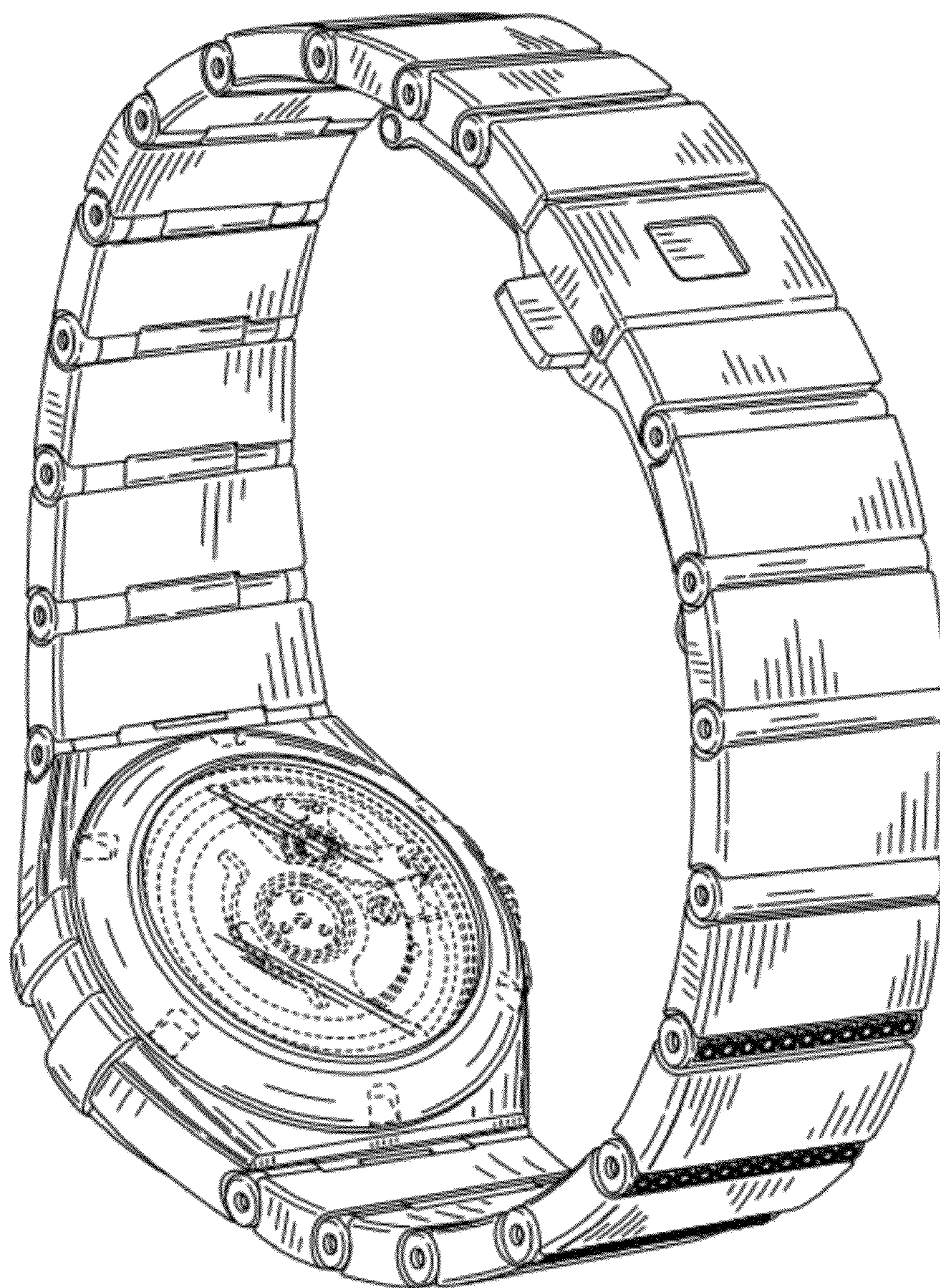
