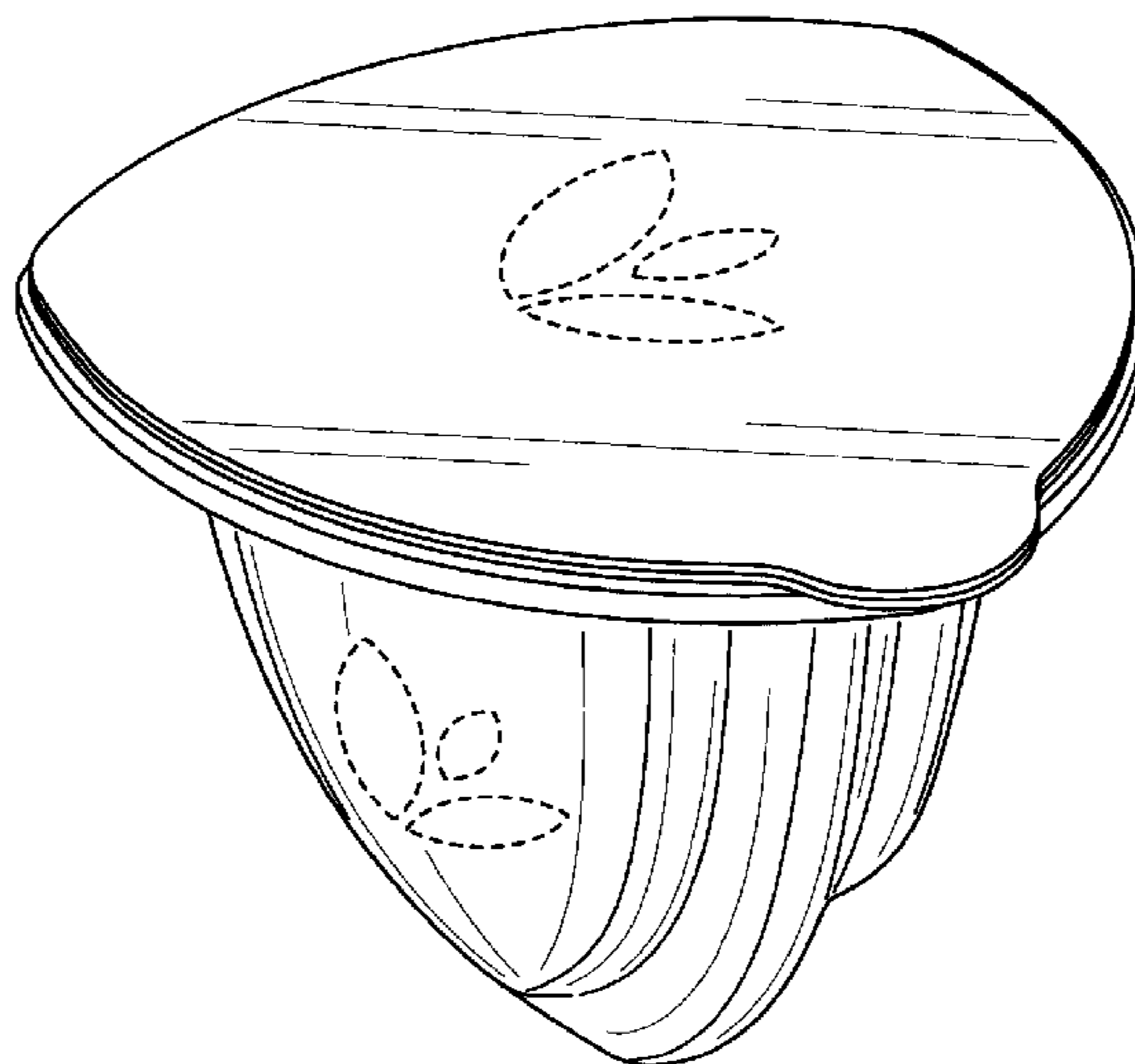
(57) **CLAIM**

We claim The ornamental design for a planting system, as shown and described.

**DESCRIPTION**

FIG. 1 depicts a perspective view of a planting system. FIG. 2 is a front elevational view thereof. FIG. 3 is a rear elevational view thereof. FIG. 4 is a side elevational view thereof. FIG. 5 is an opposite side elevational view thereof. FIG. 6 is a top plan view thereof. FIG. 7 is a bottom plan view thereof; and, FIG. 8 depicts a perspective view of a planting system depicting a layer of the top cover pulled back. The broken lines in the drawings illustrate environmental structure on the article and form no part of the claimed design.

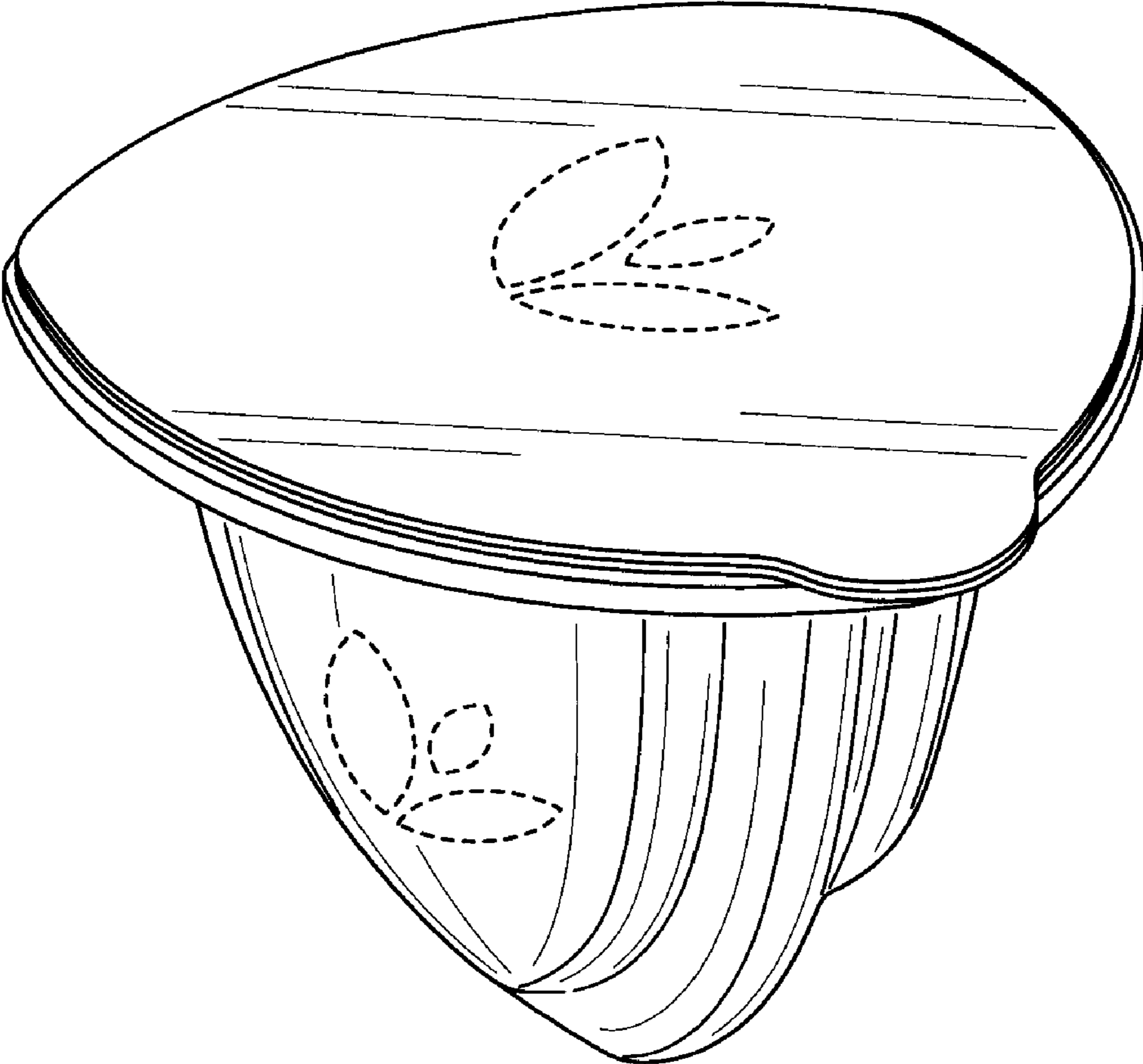

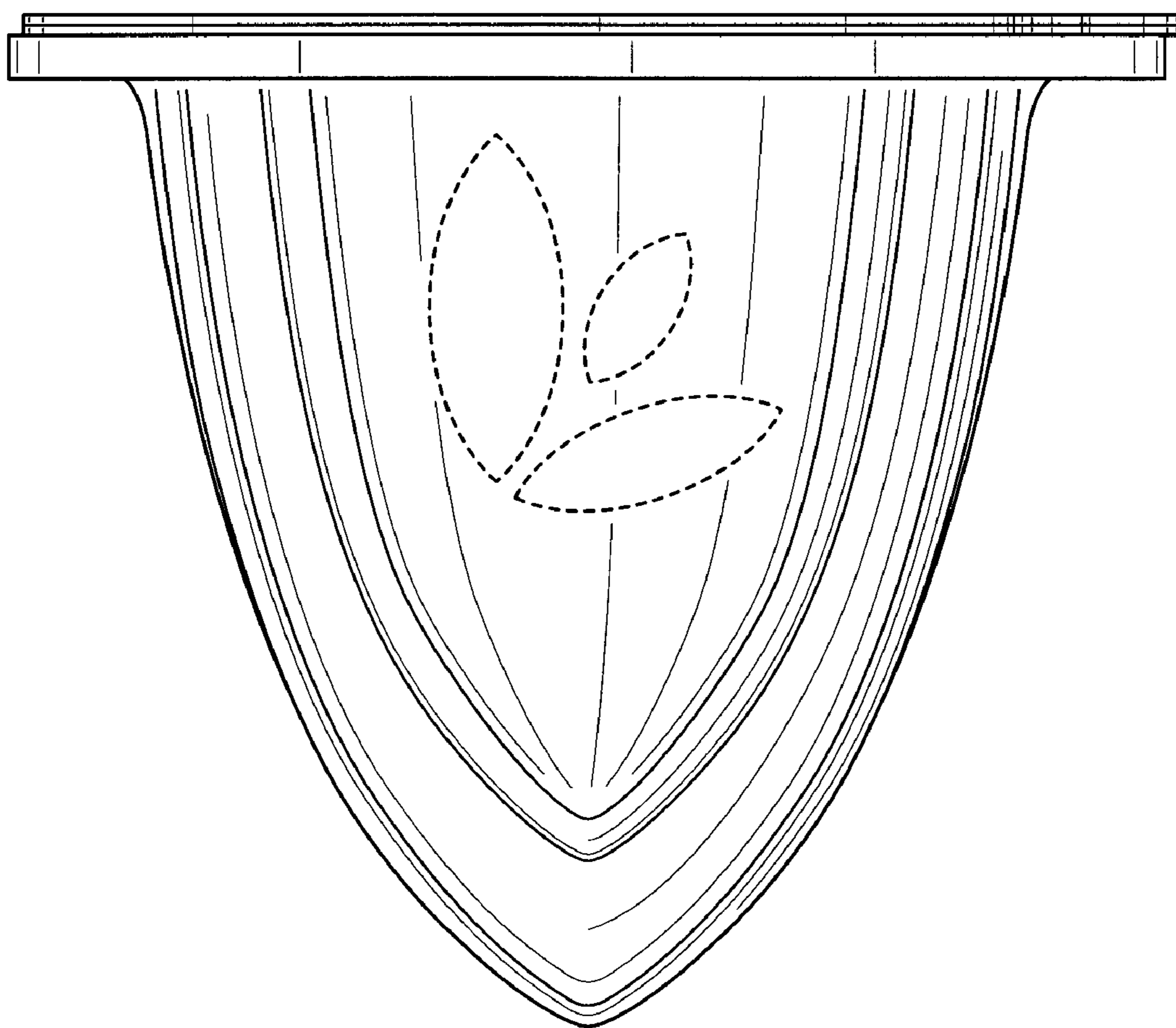

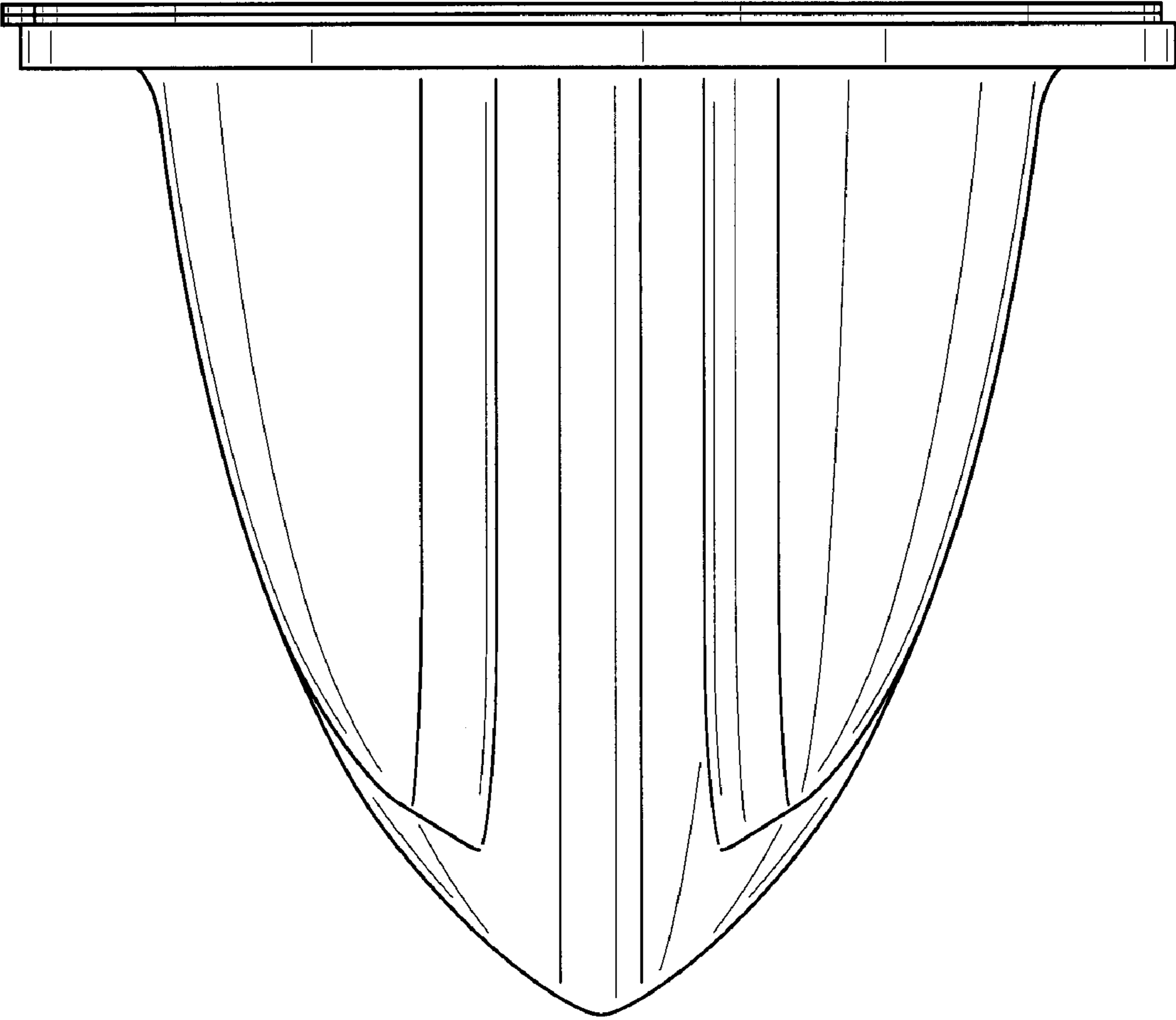

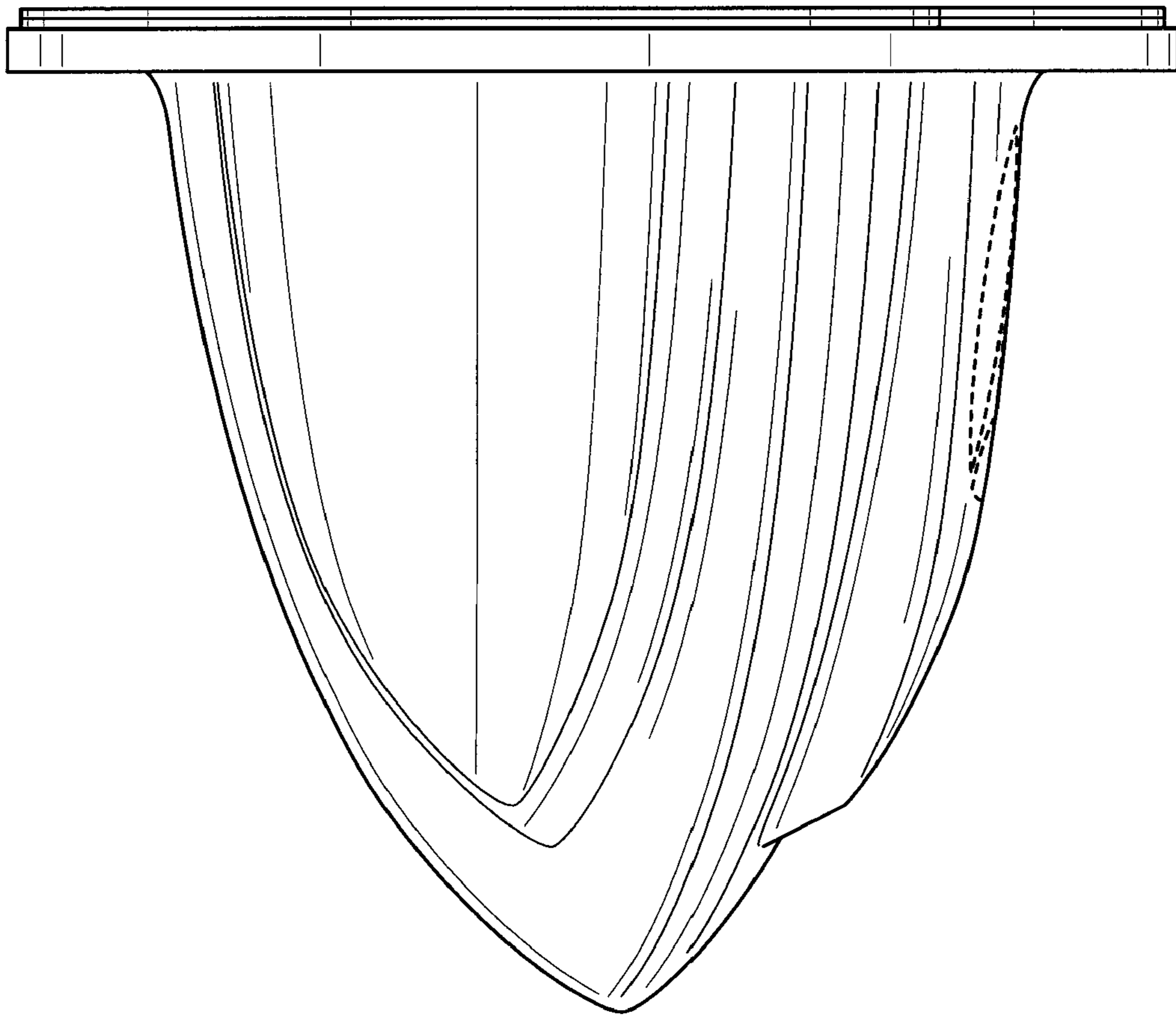

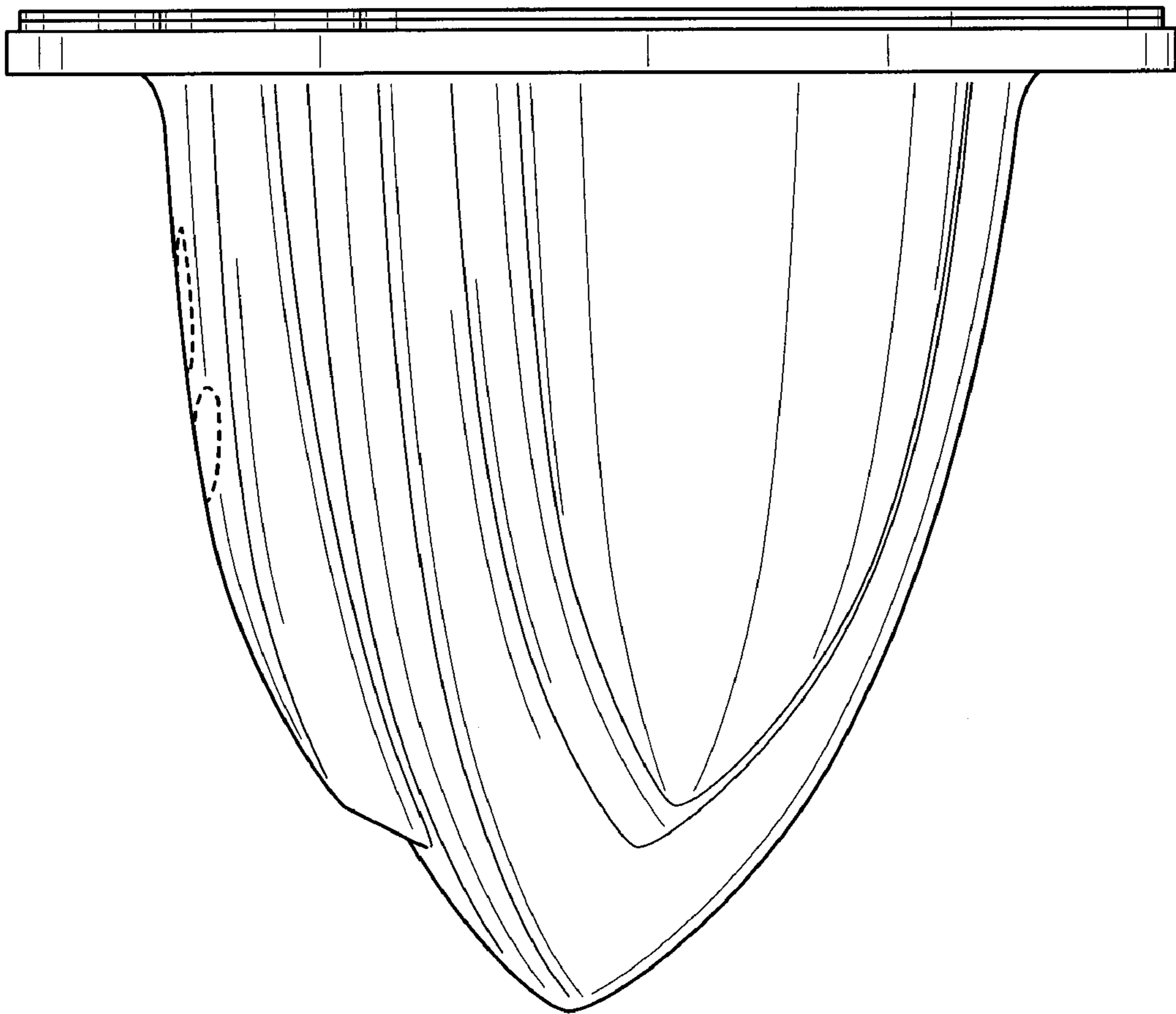

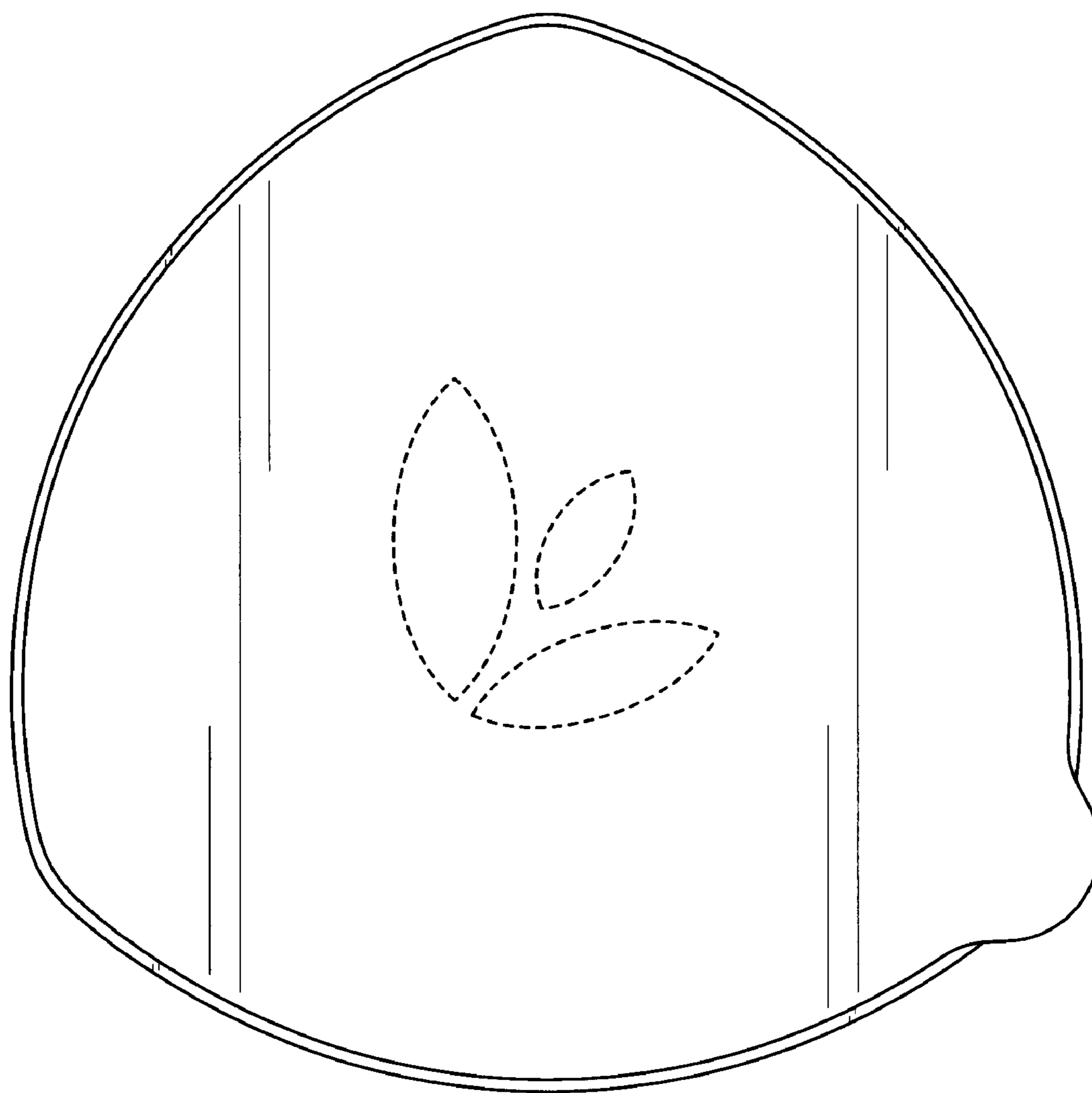

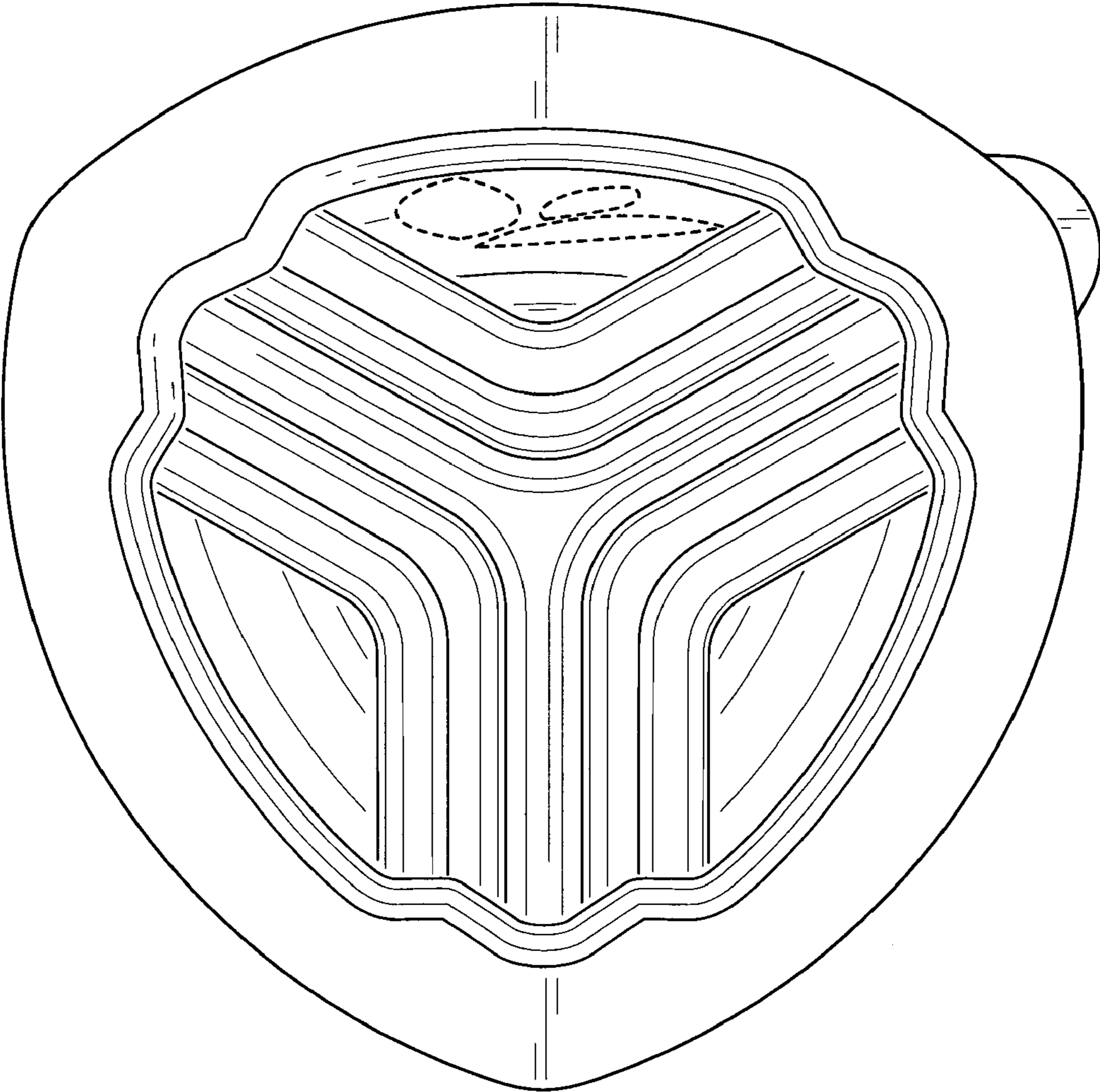

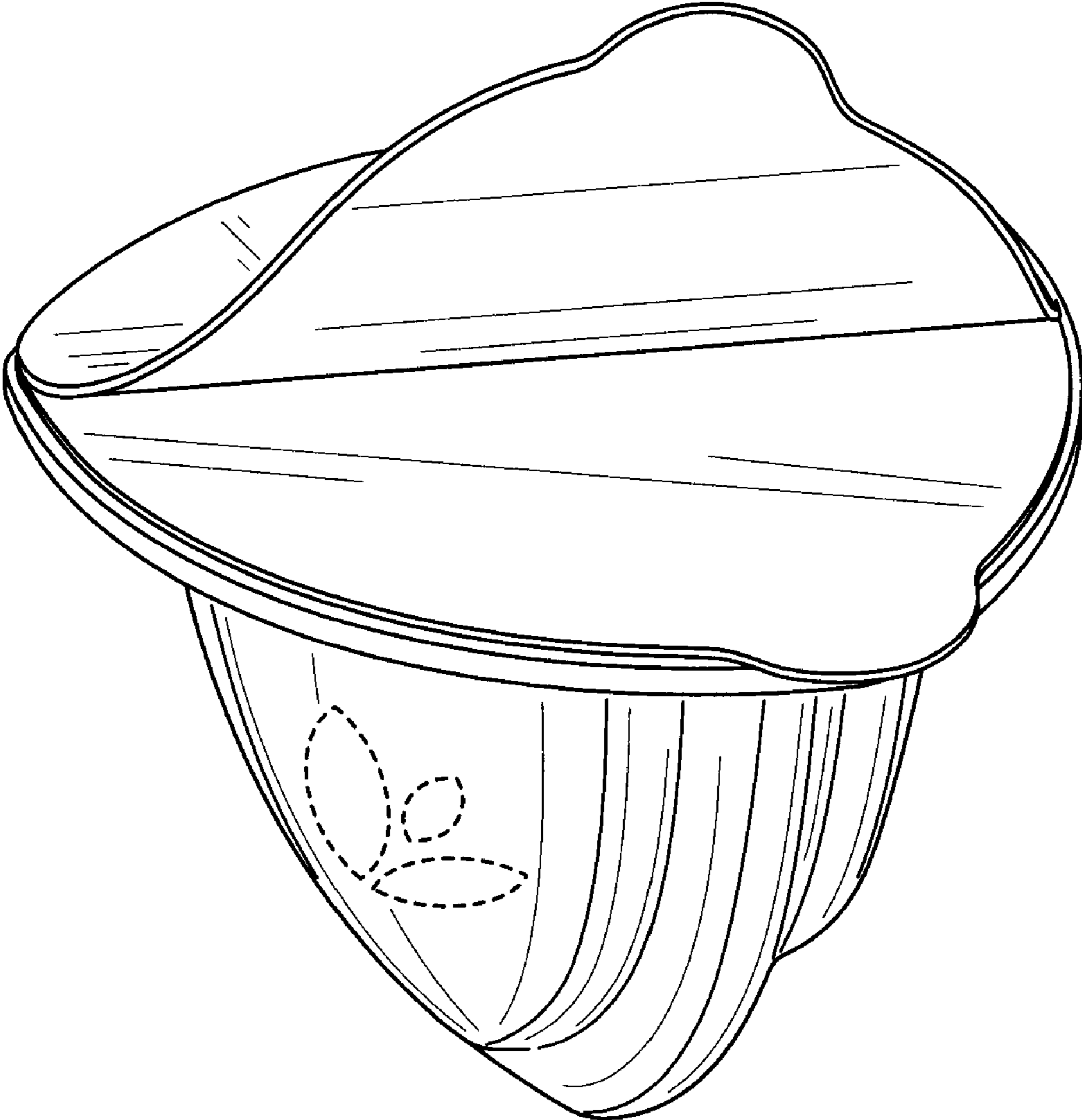
