FIG. 2 is a first side elevation view thereof;

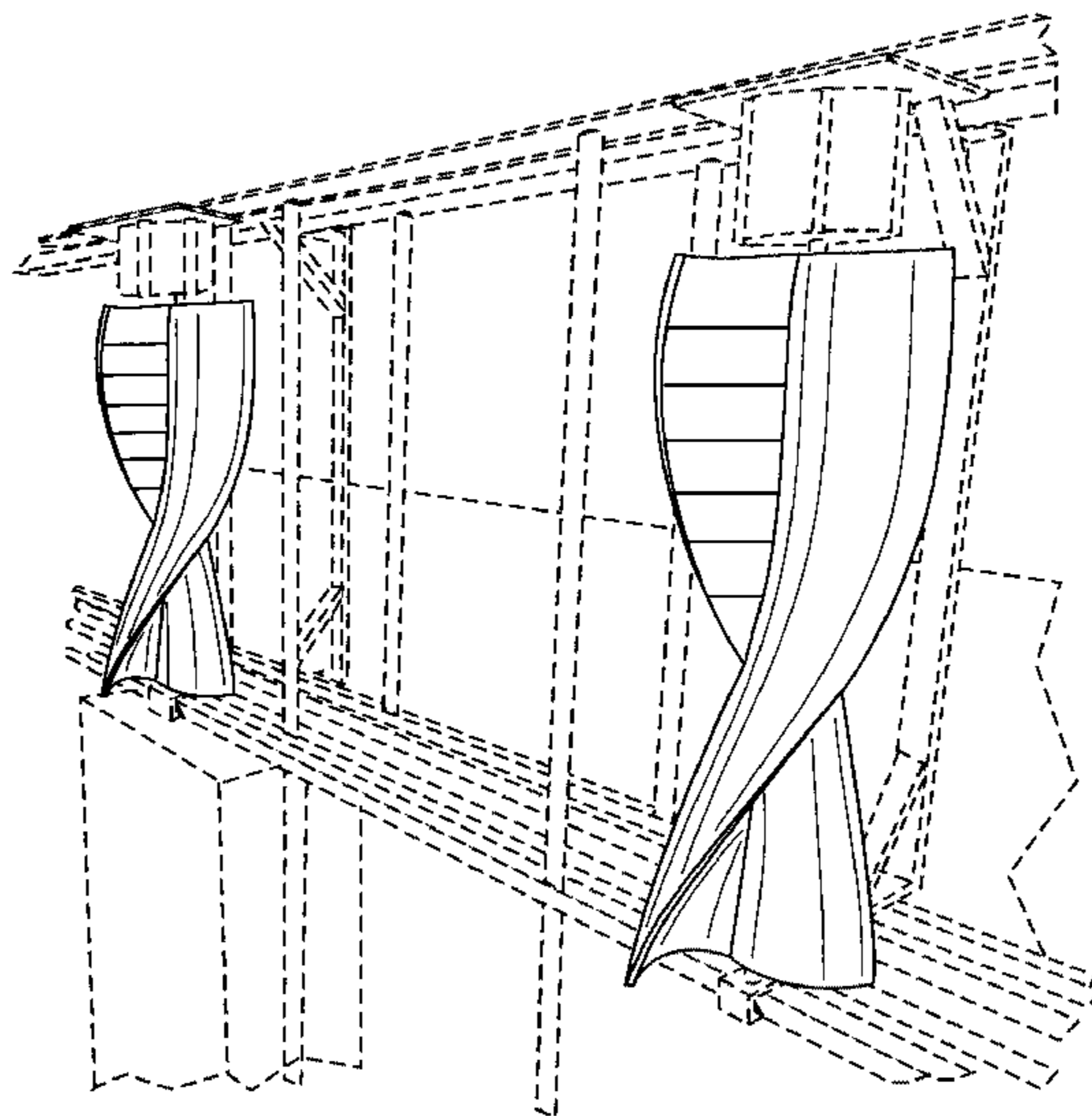
FIG. 3 is a second side elevation view thereof opposite that of FIG. 2;

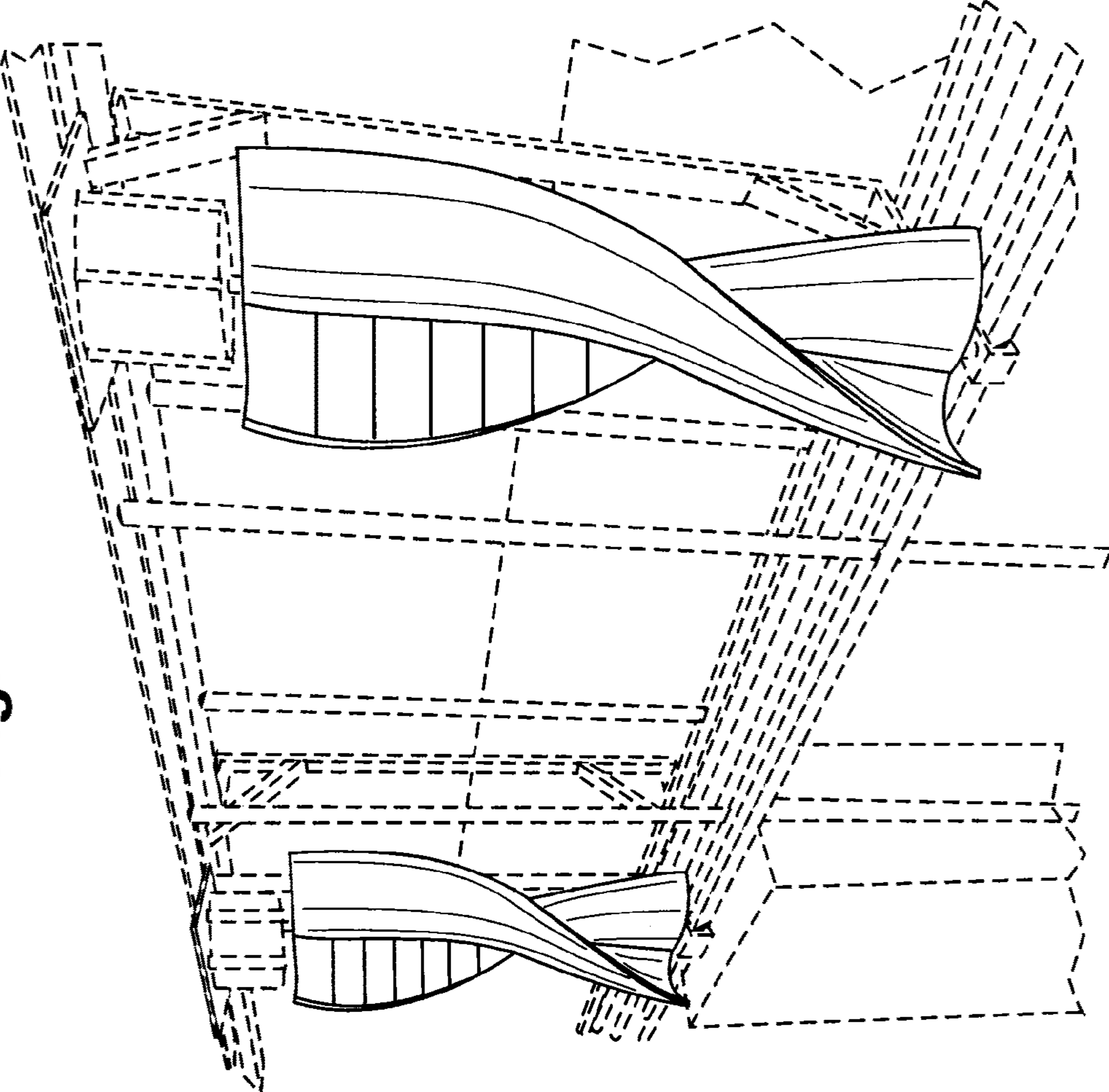

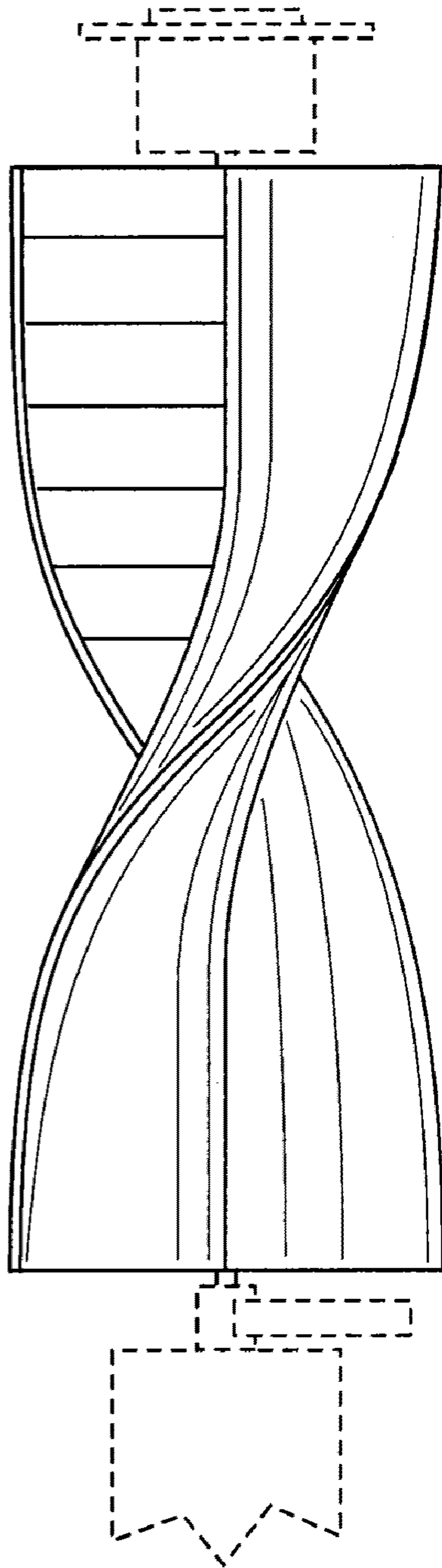

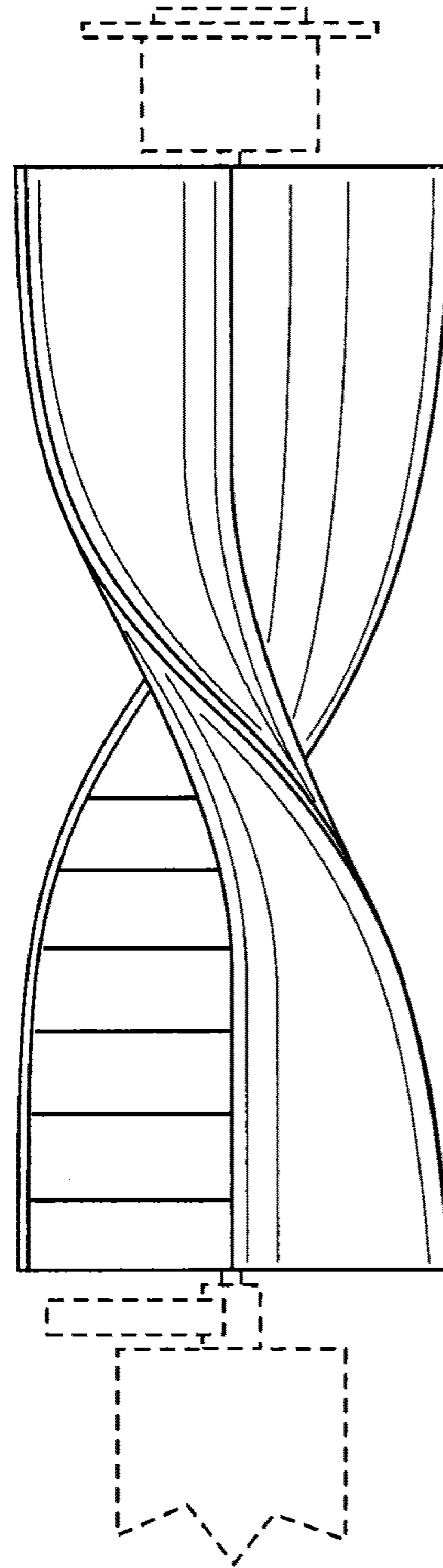

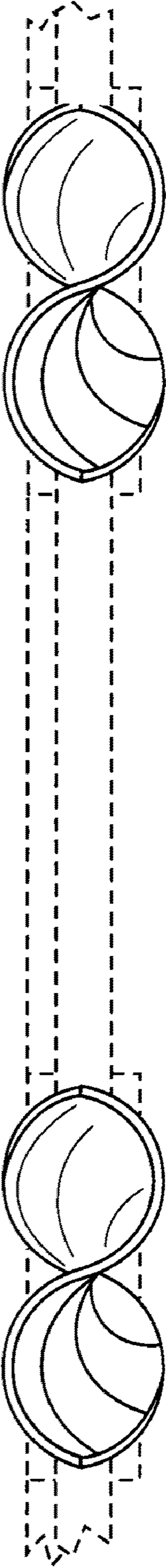
