The ornamental design for a temporary power service panel,  
as shown as described.

**DESCRIPTION**

service panel of FIG. 15.

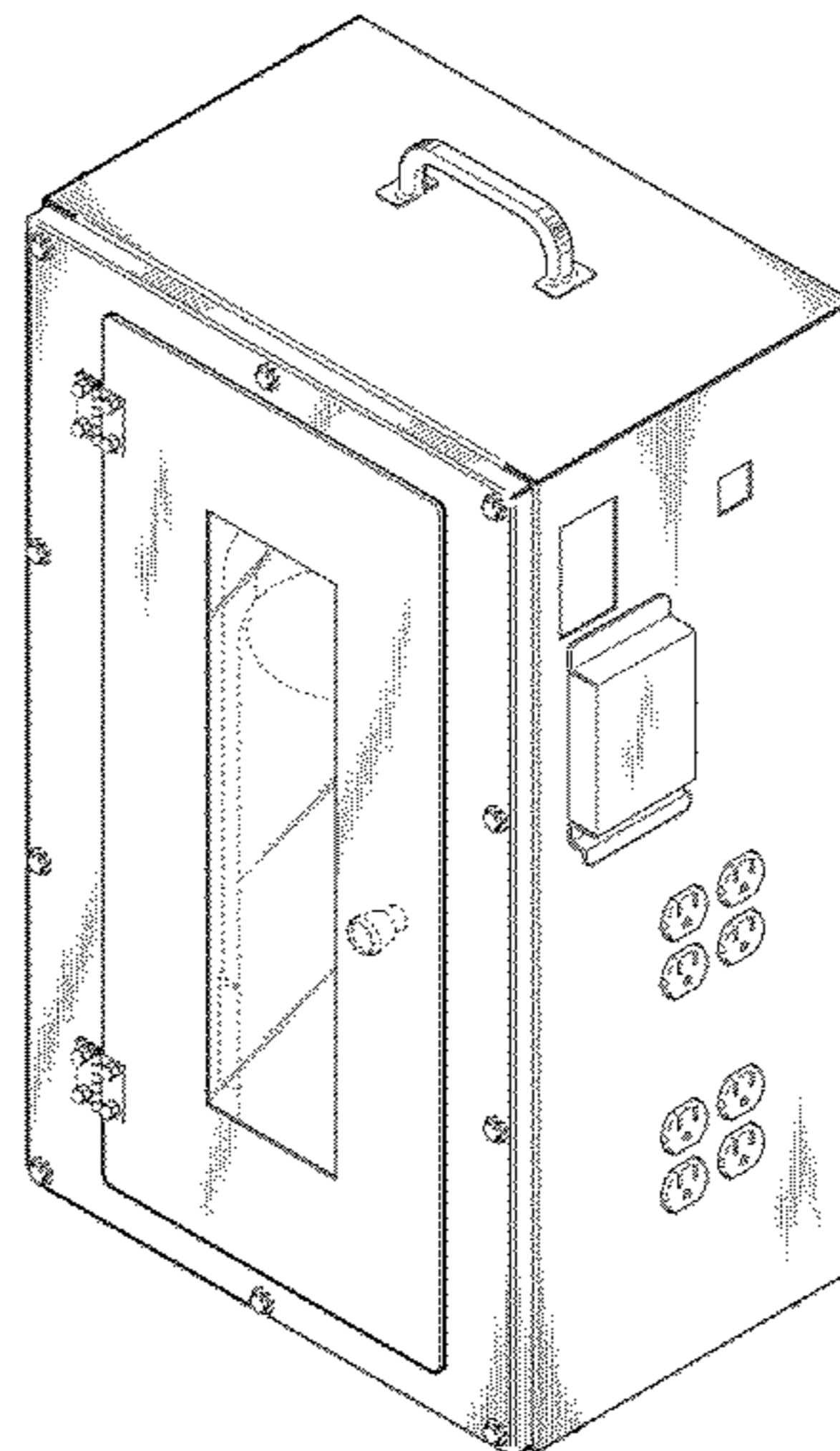
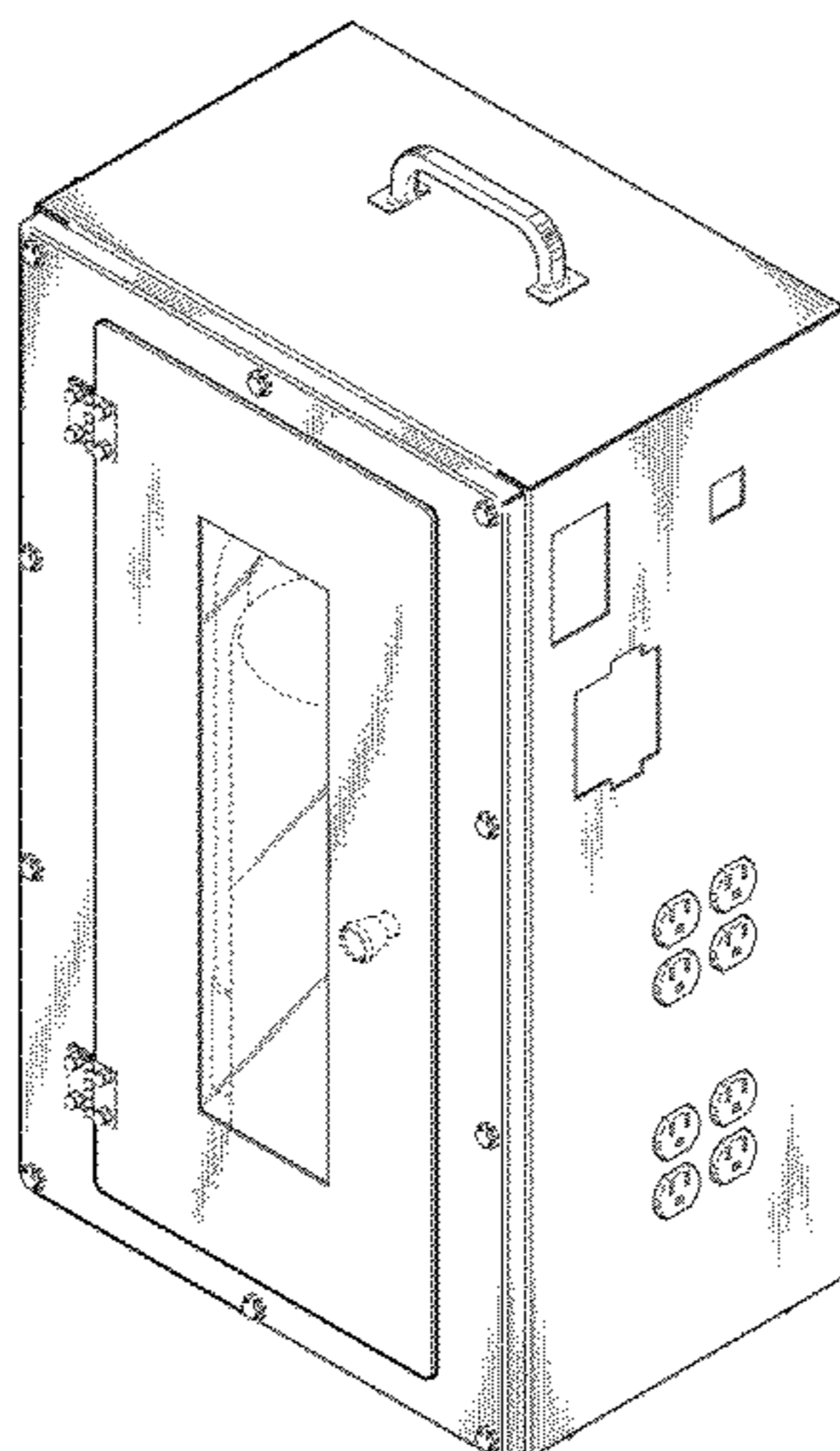
FIG. 19 is a rear elevation view of the temporary power

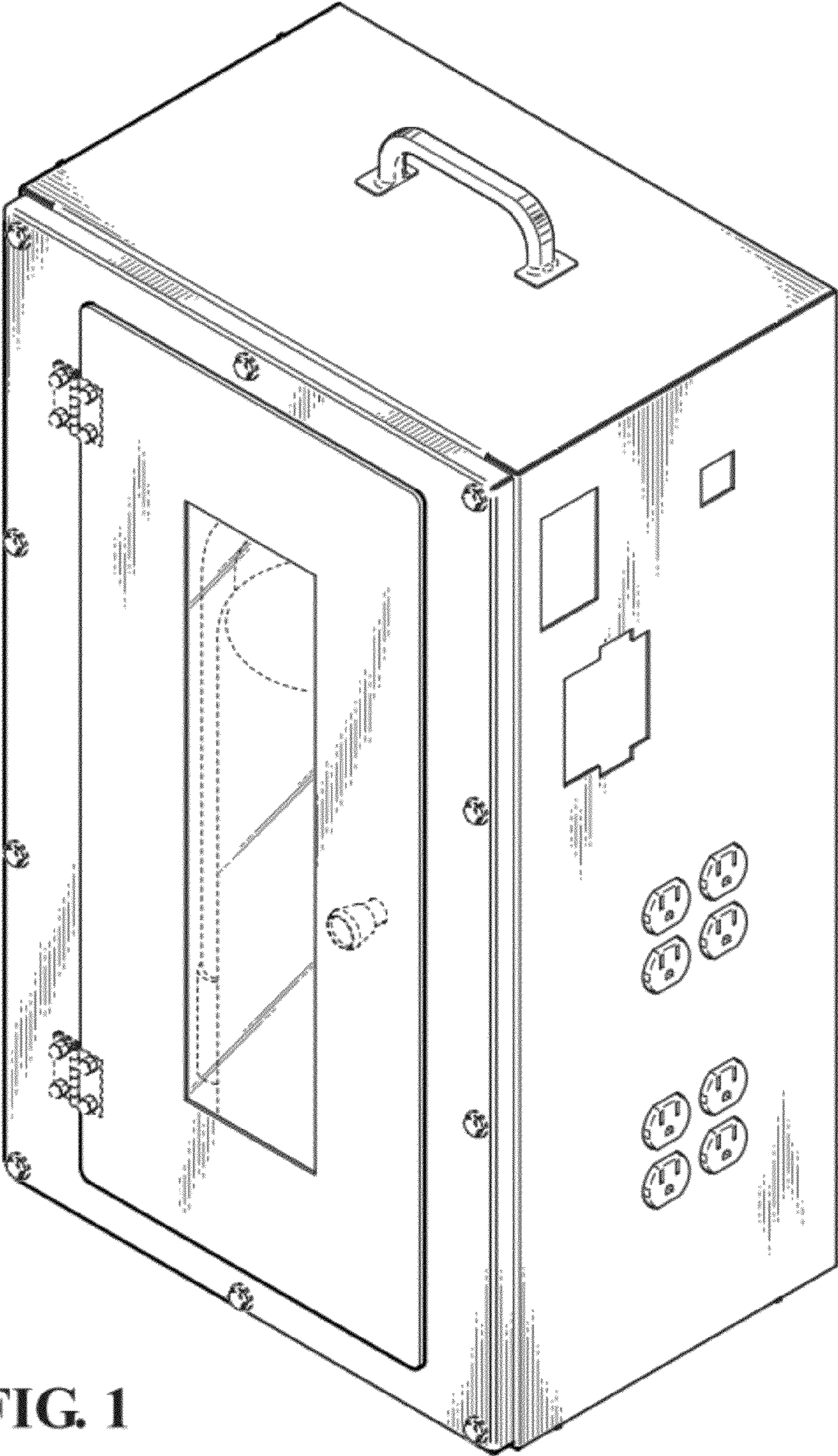

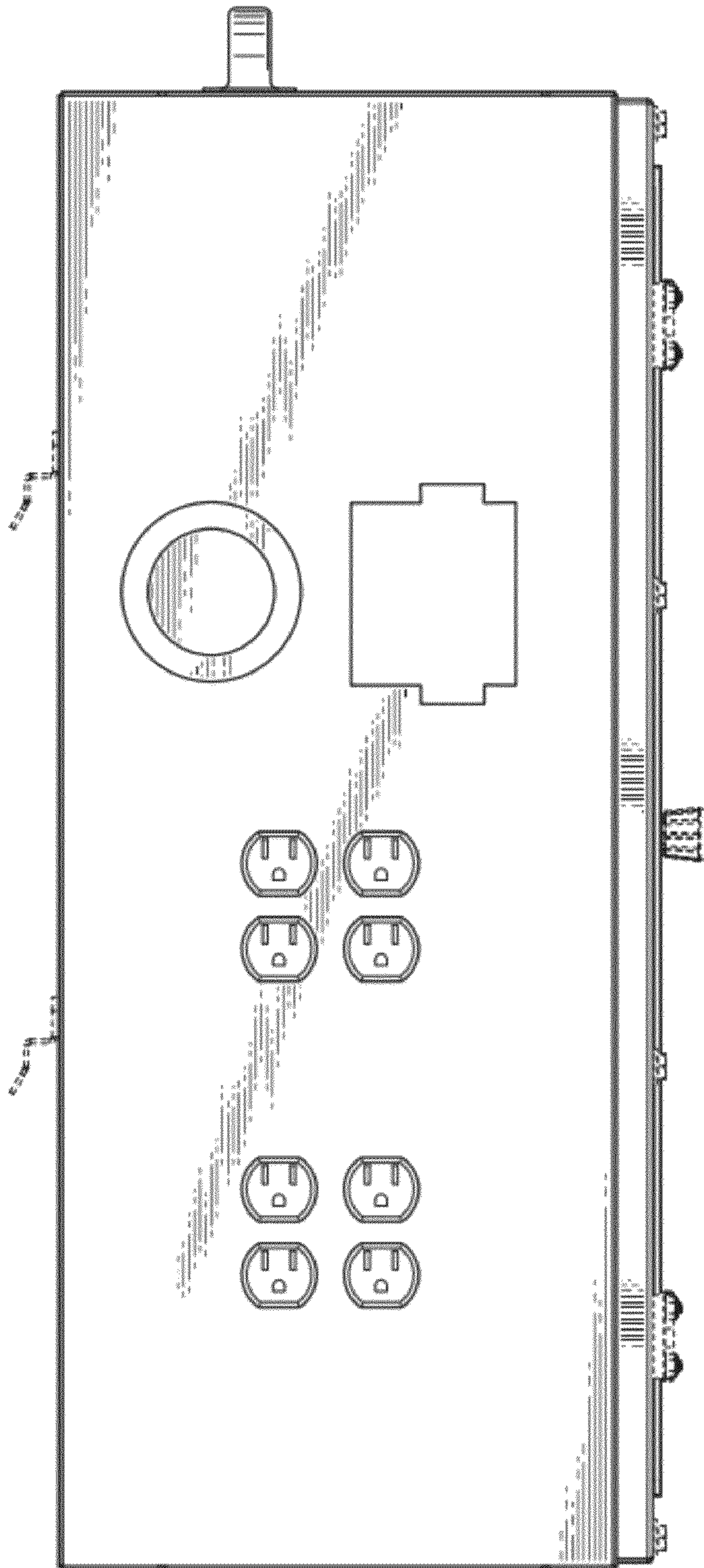

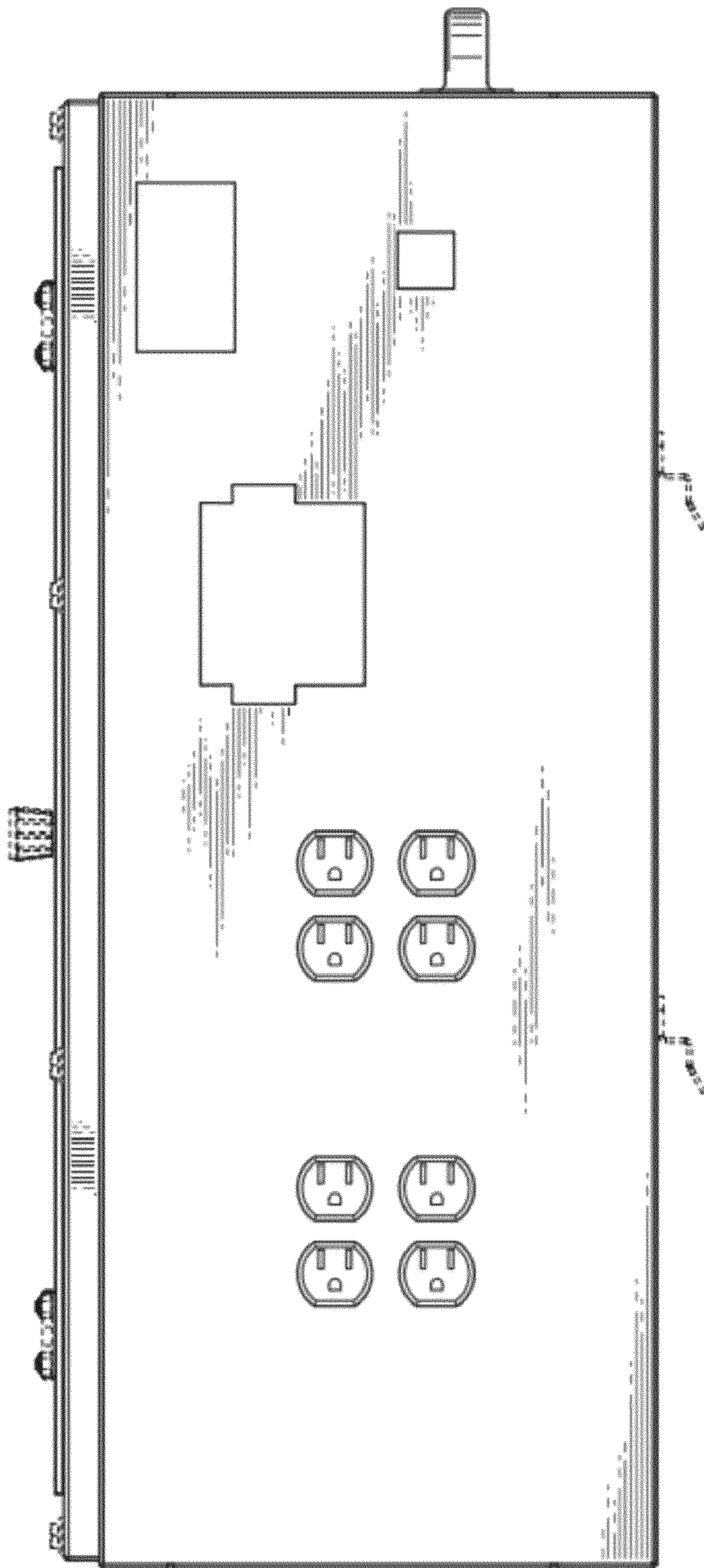

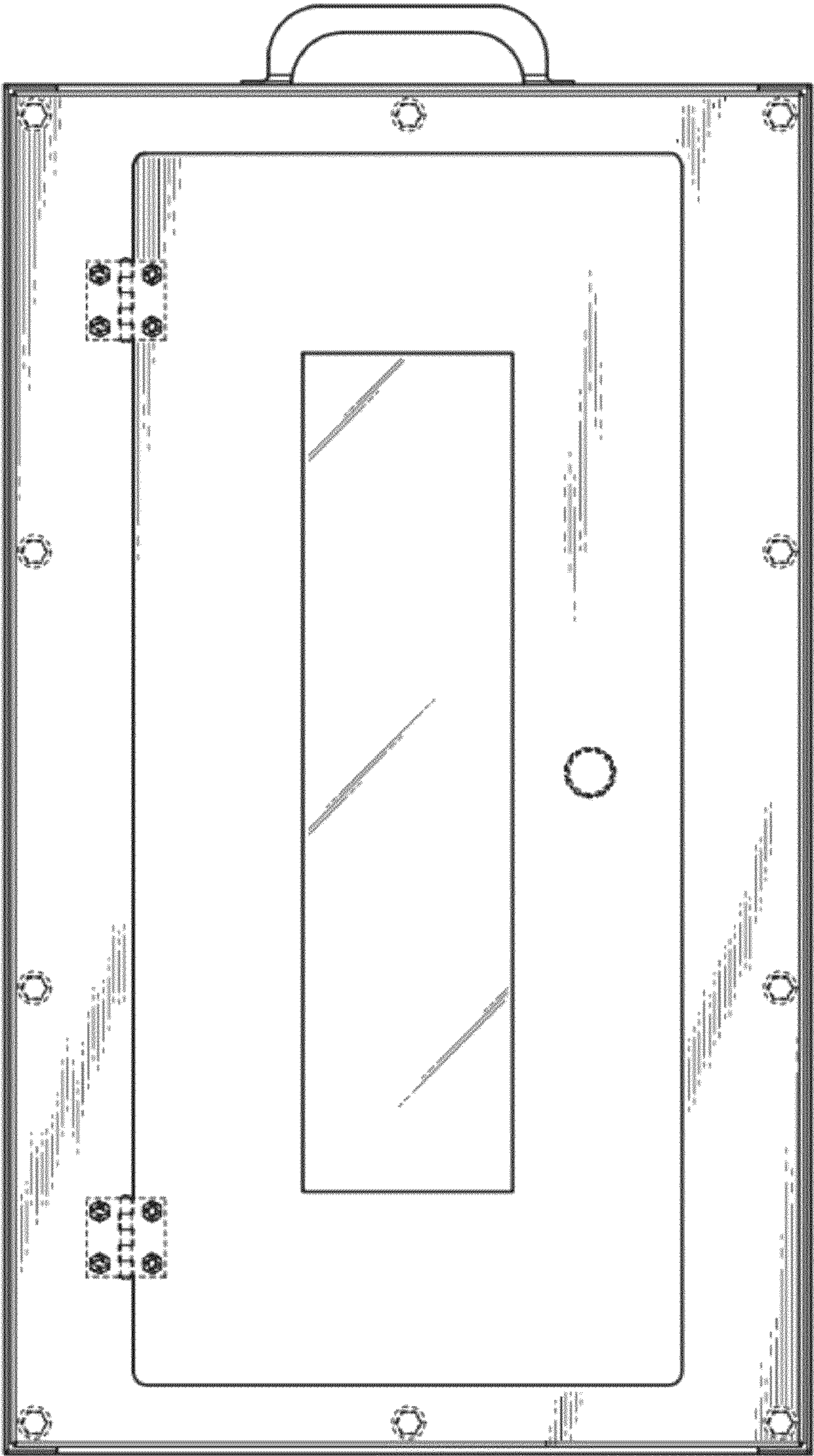
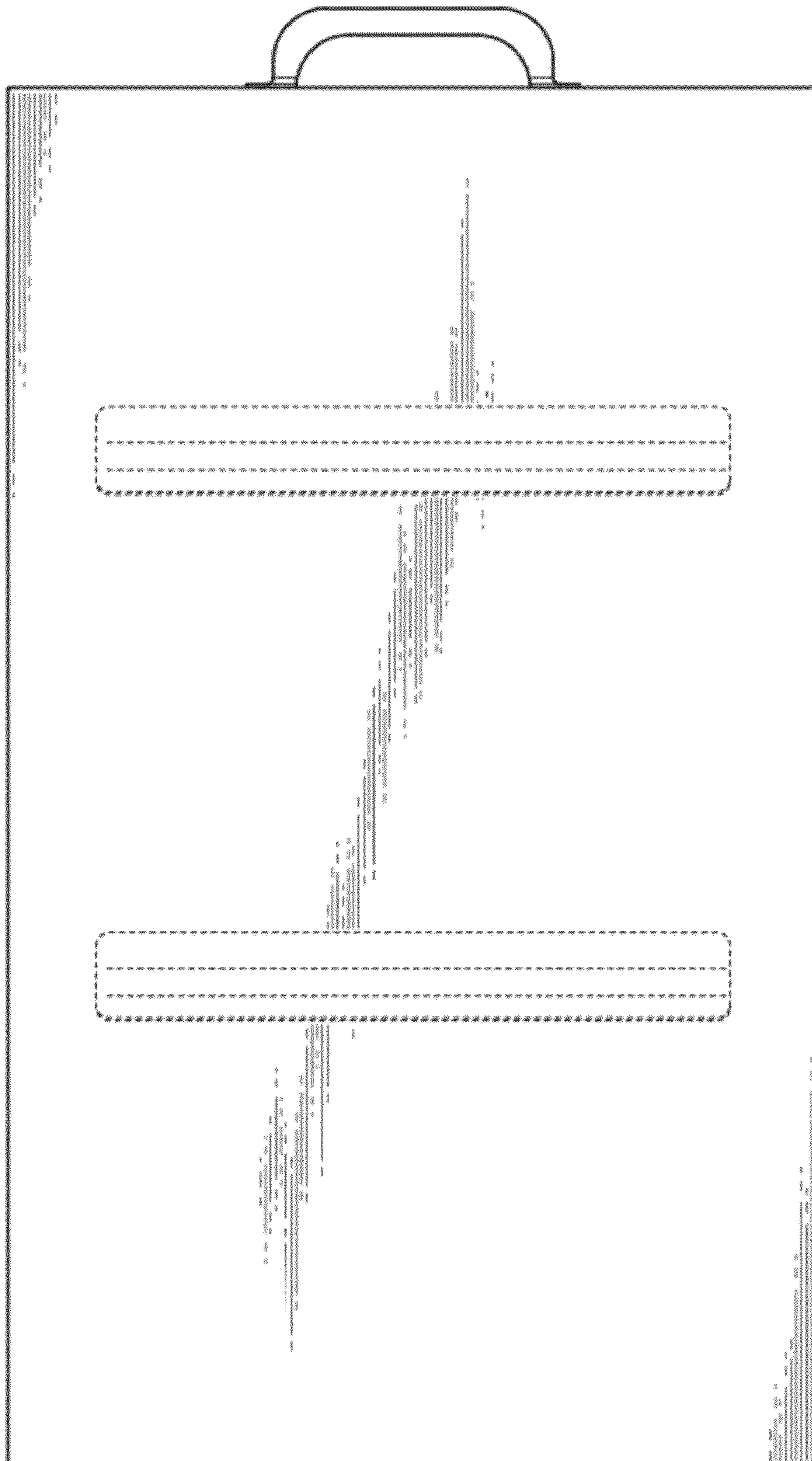

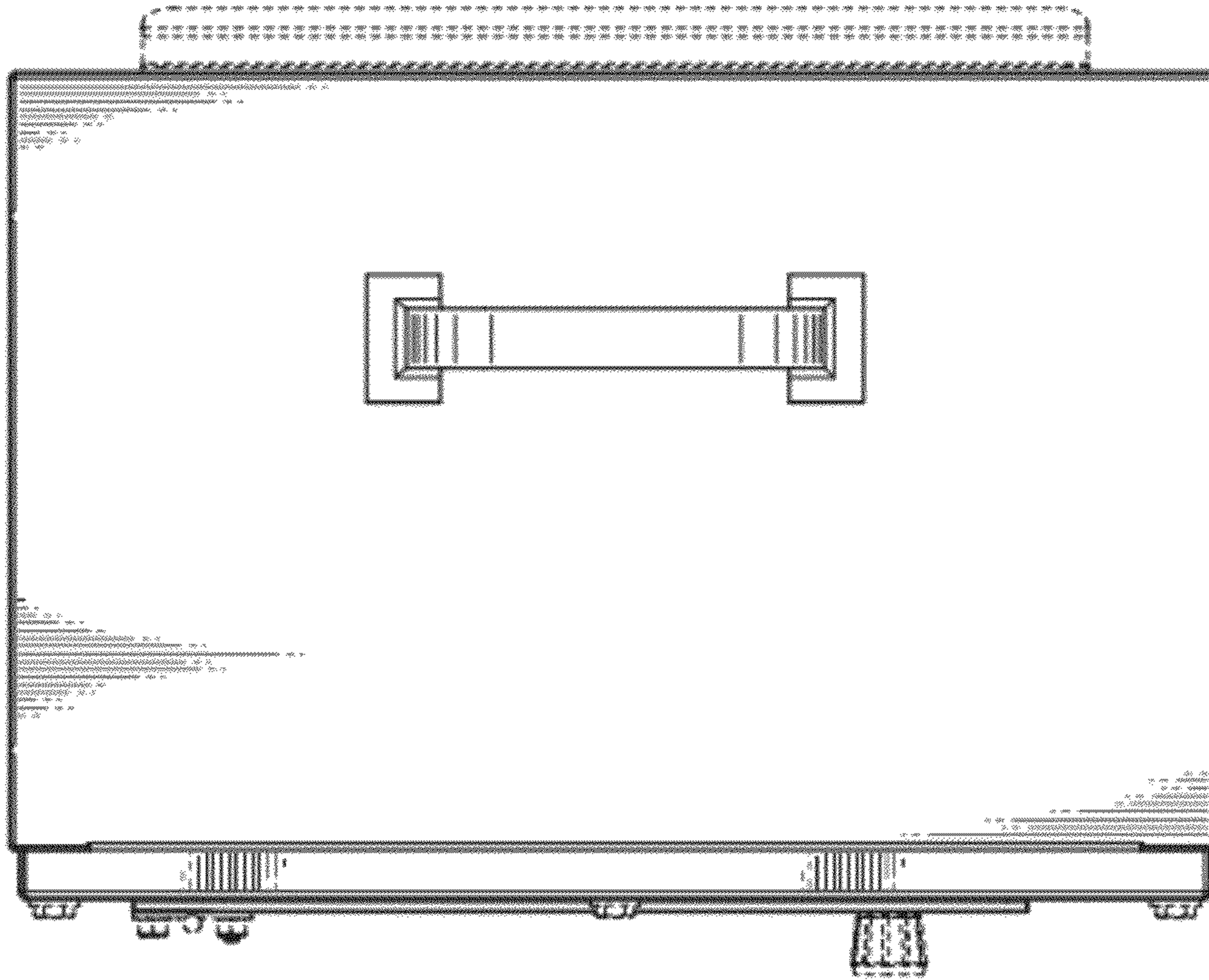

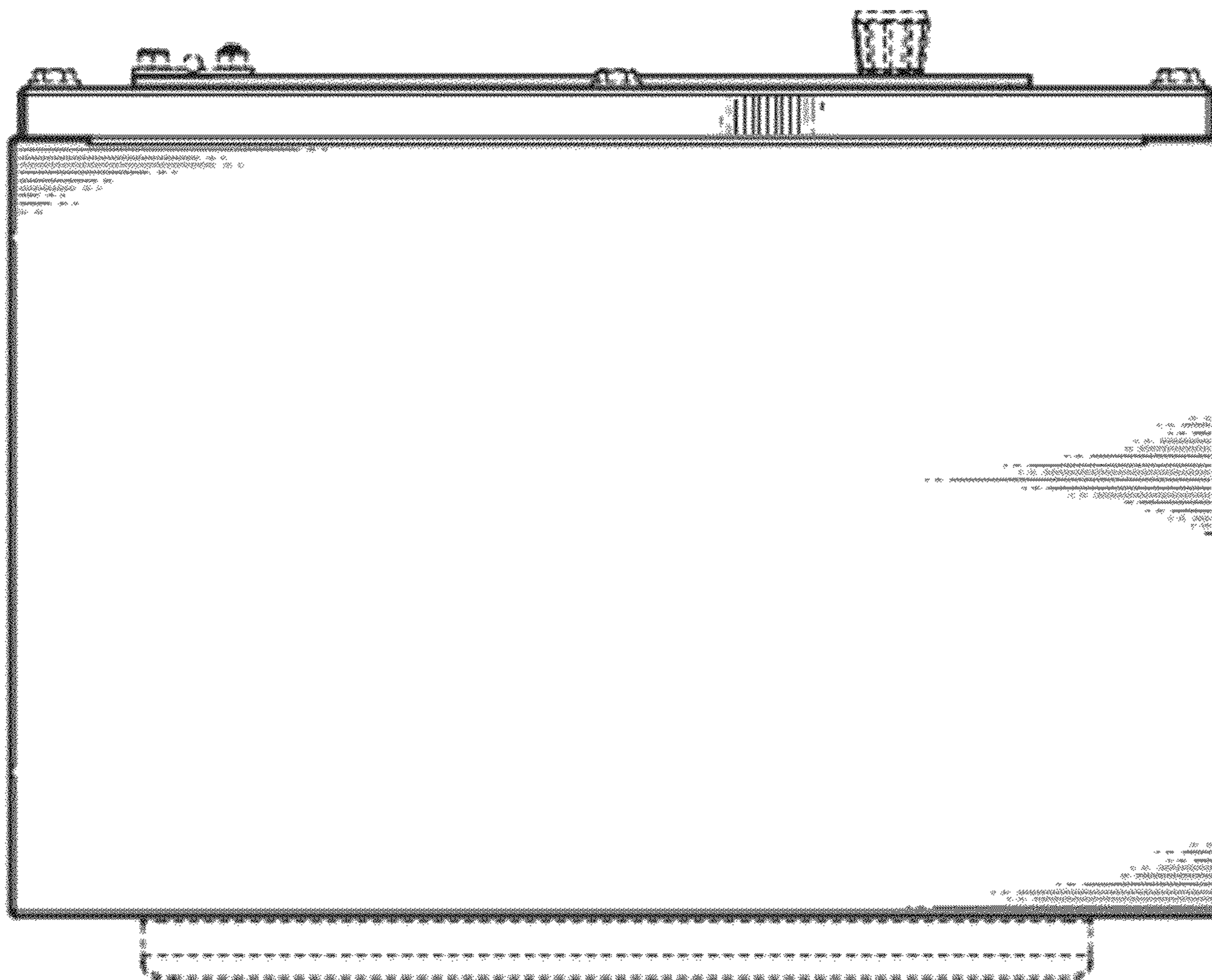

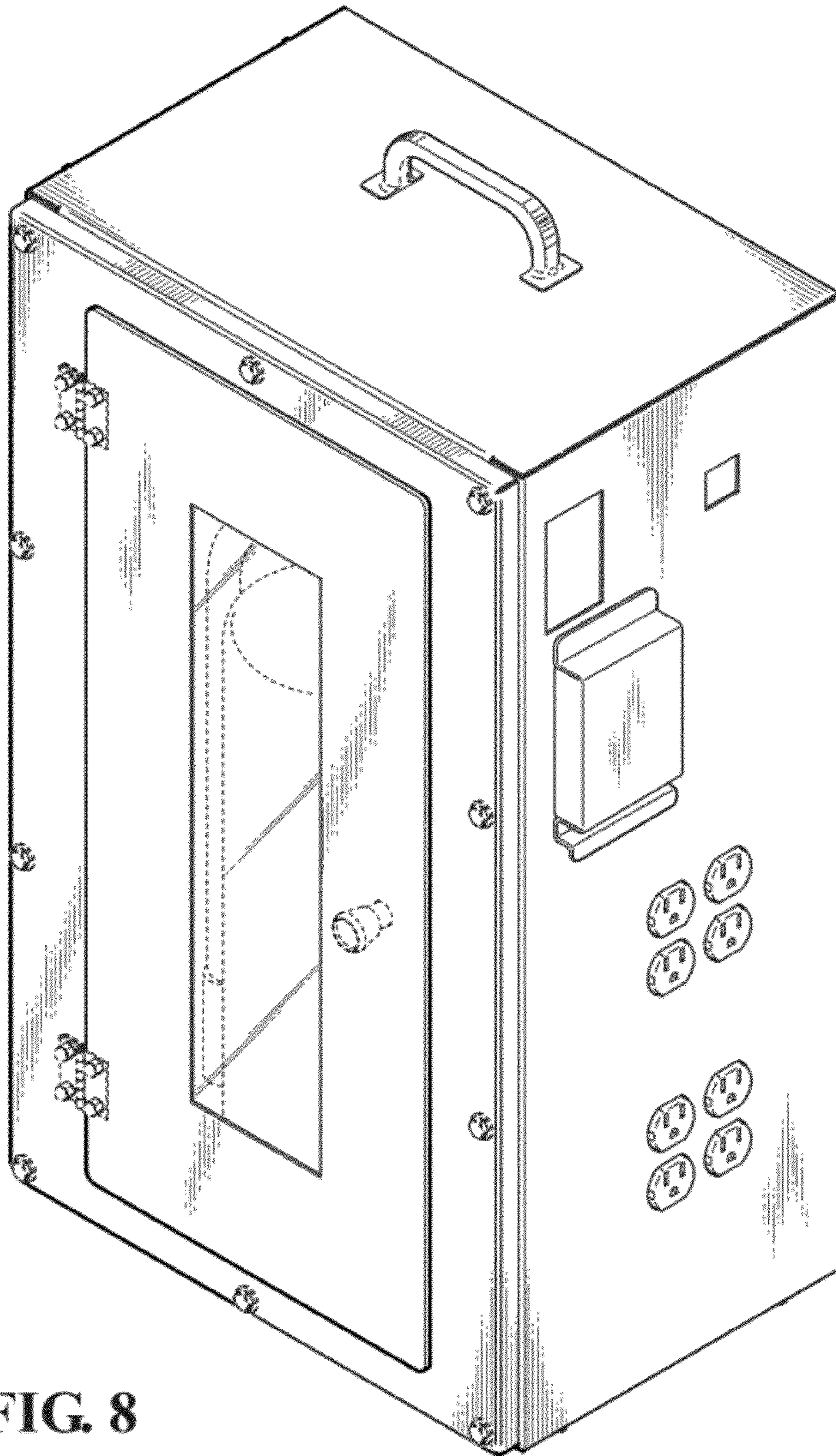

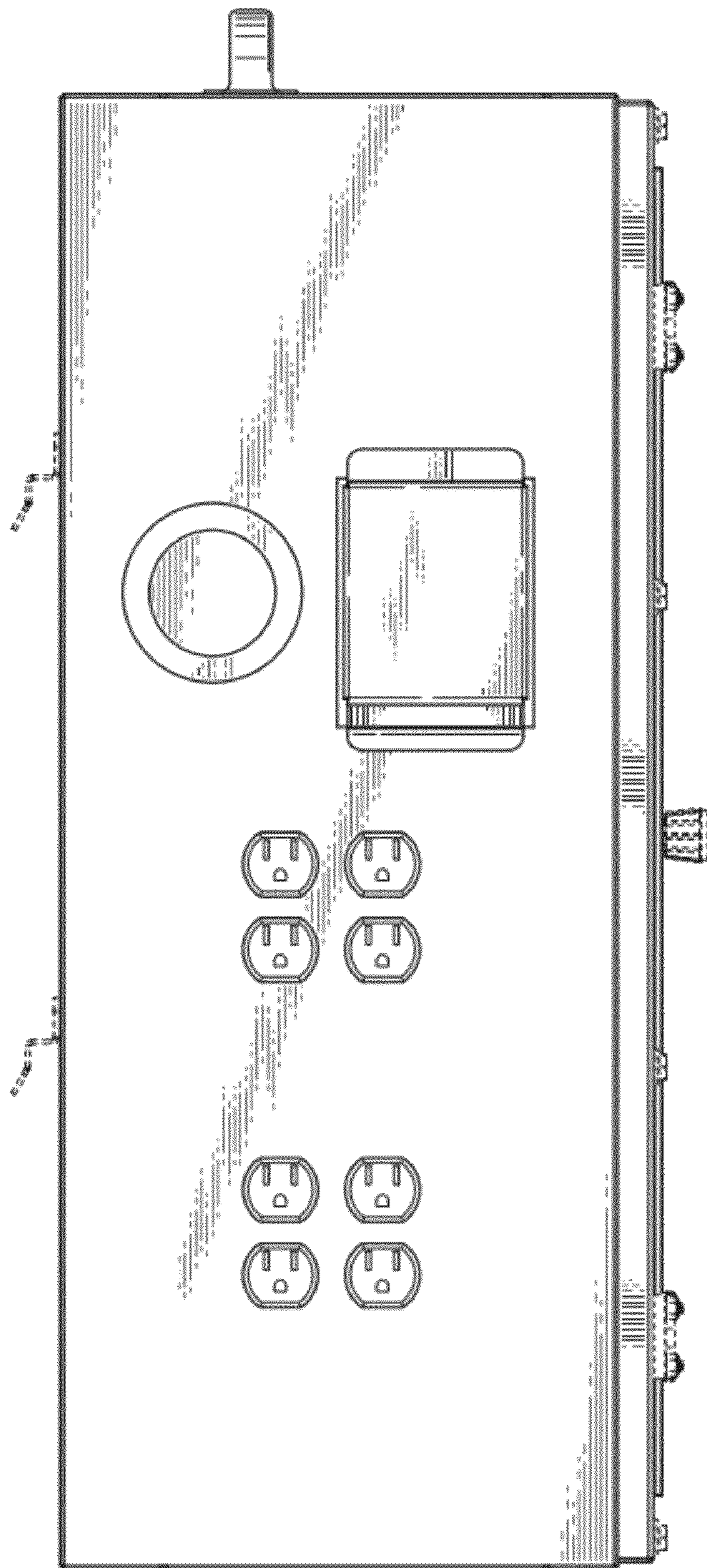

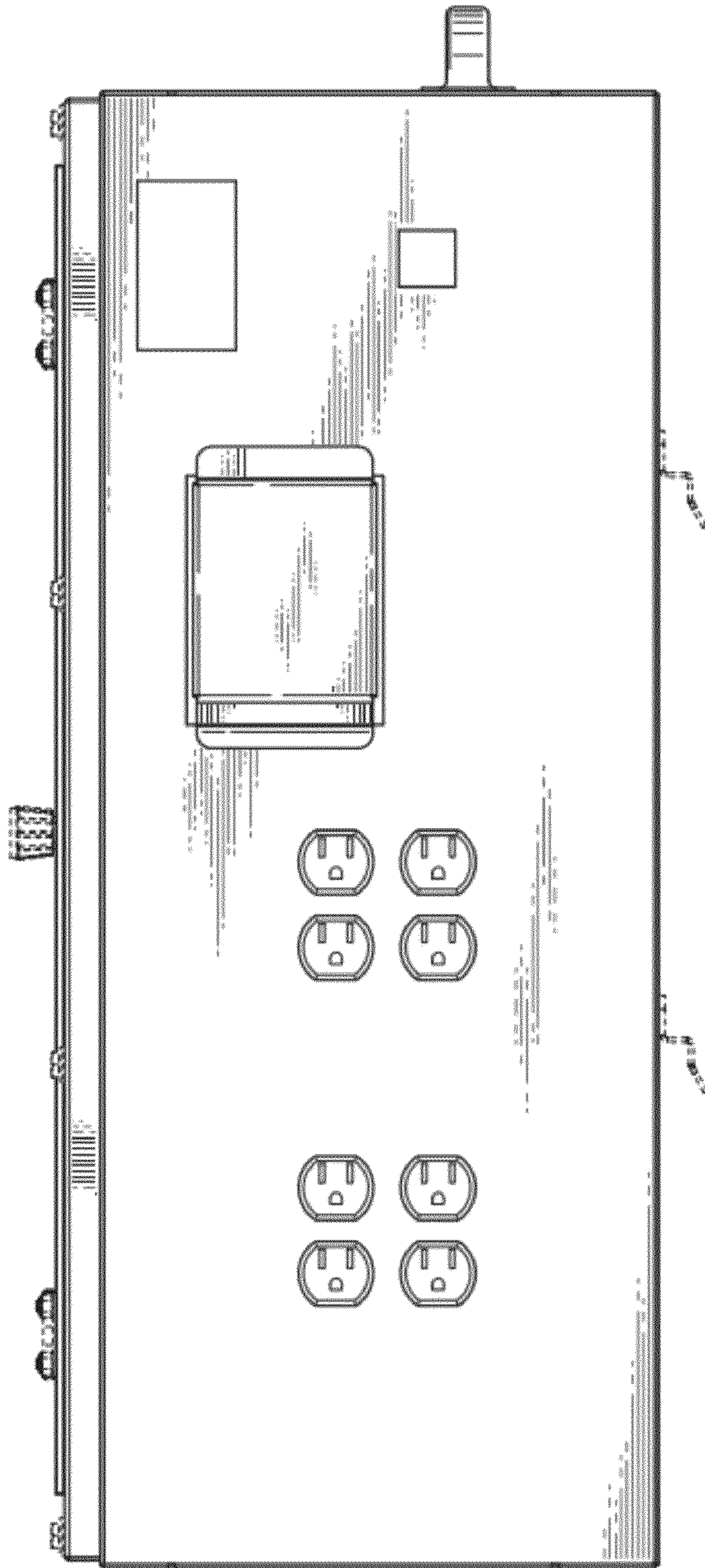

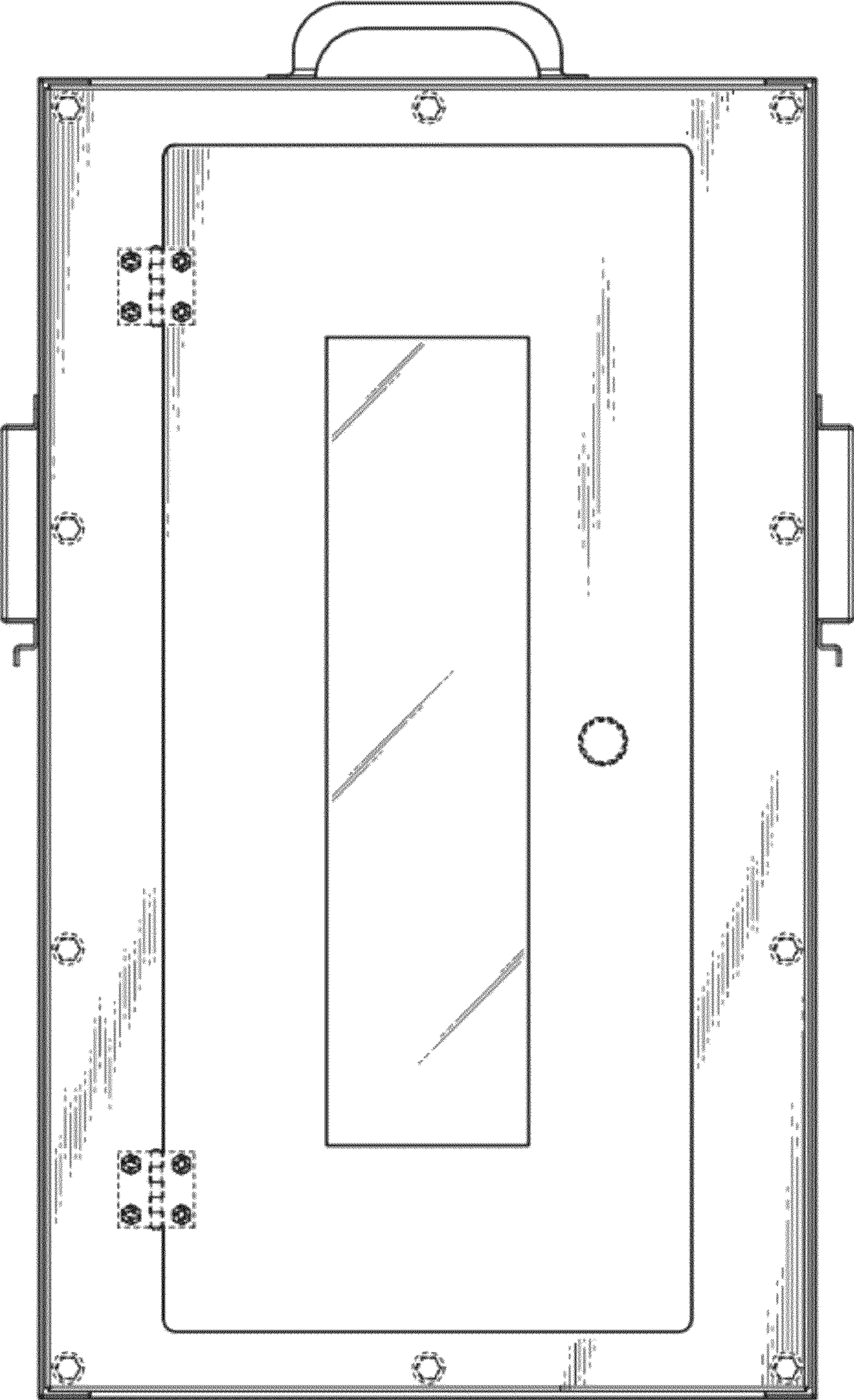

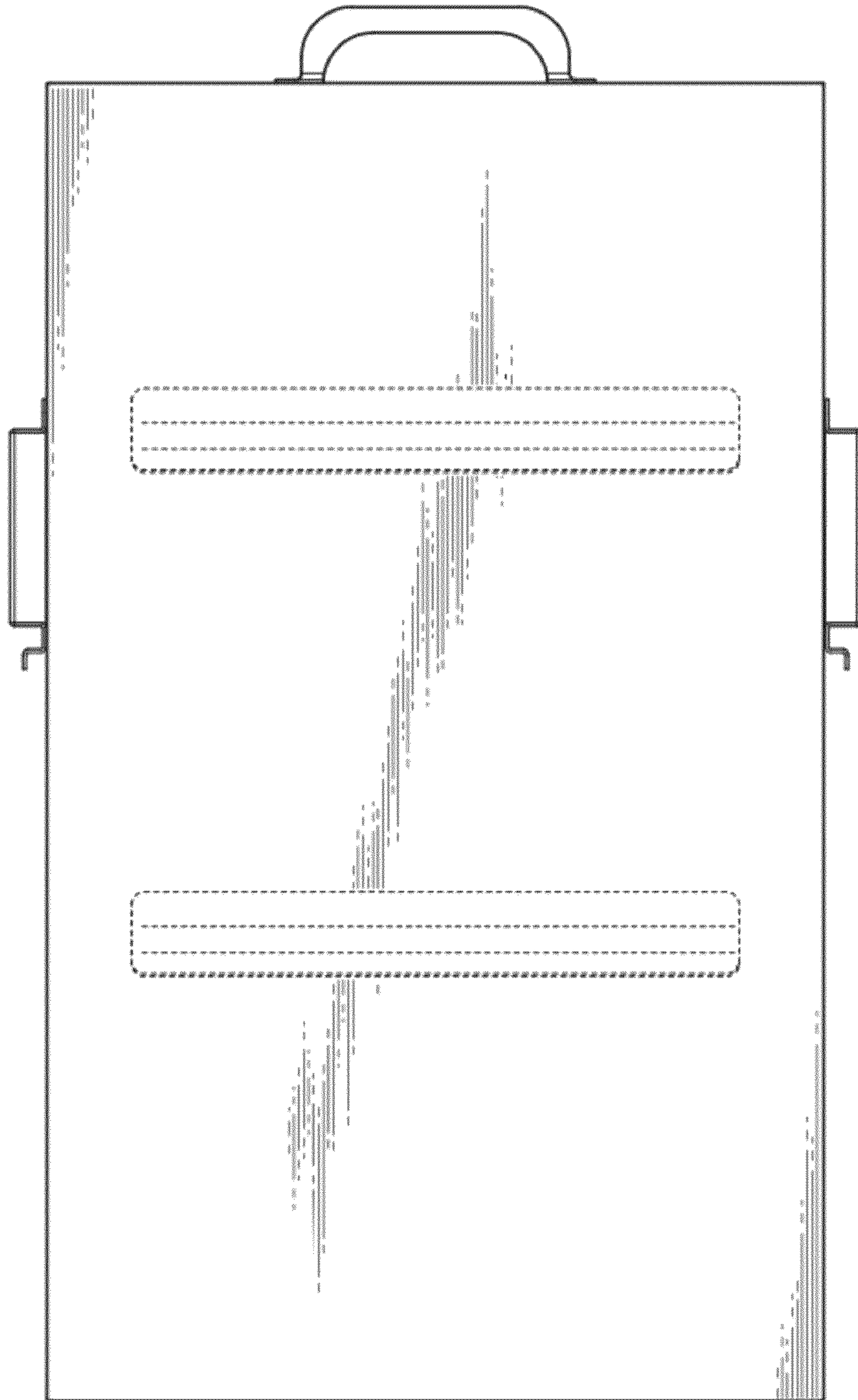

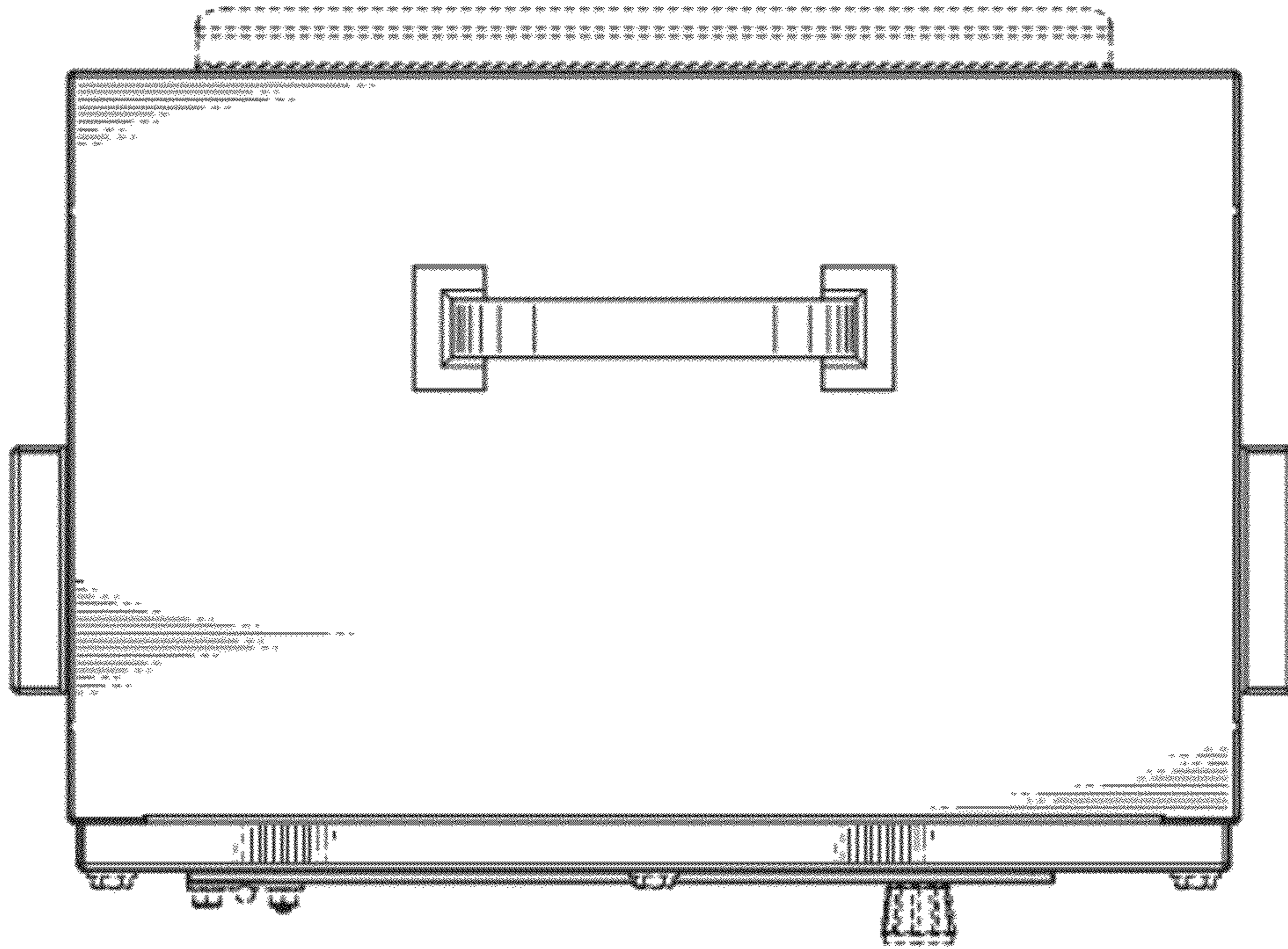

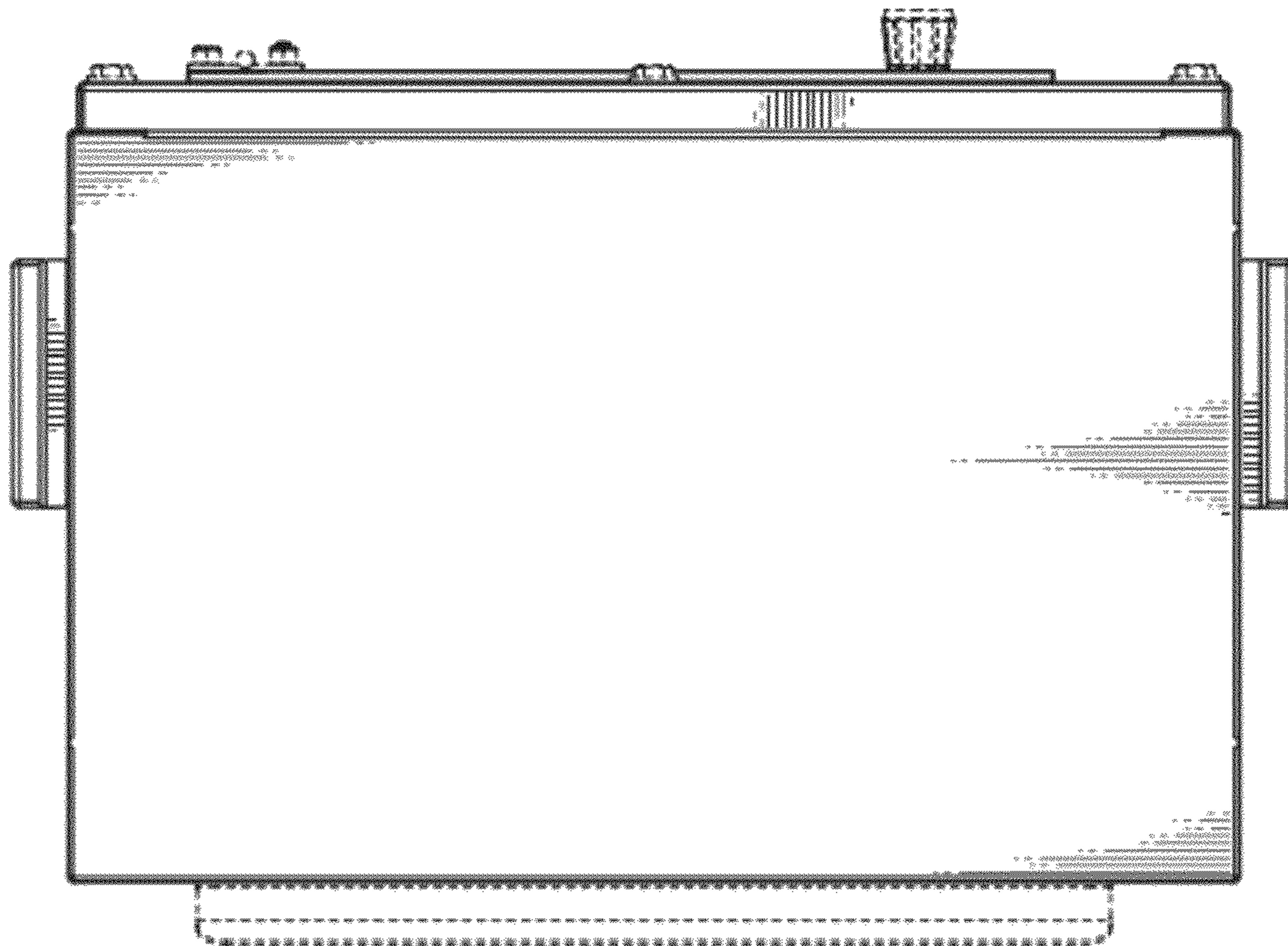

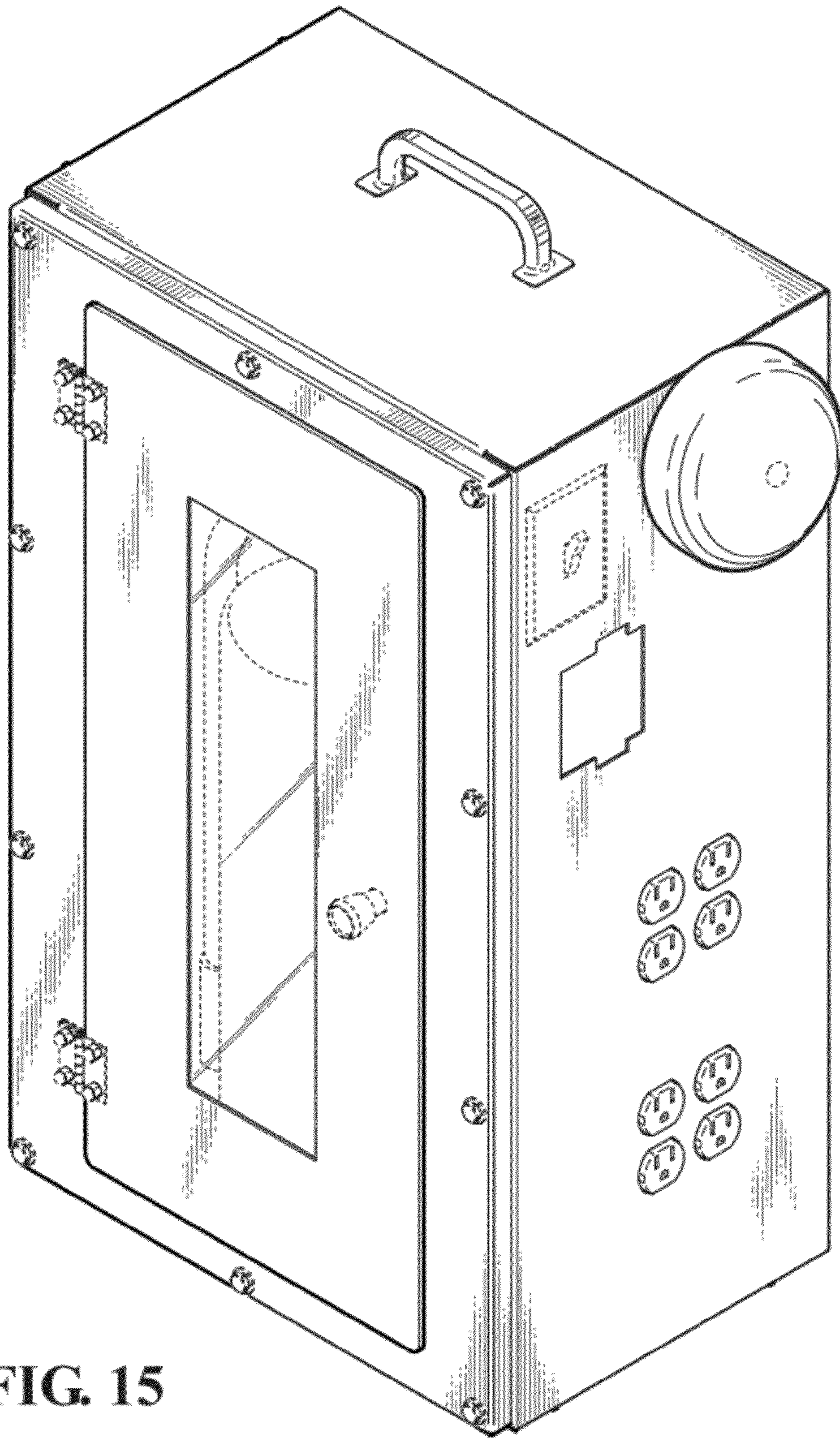

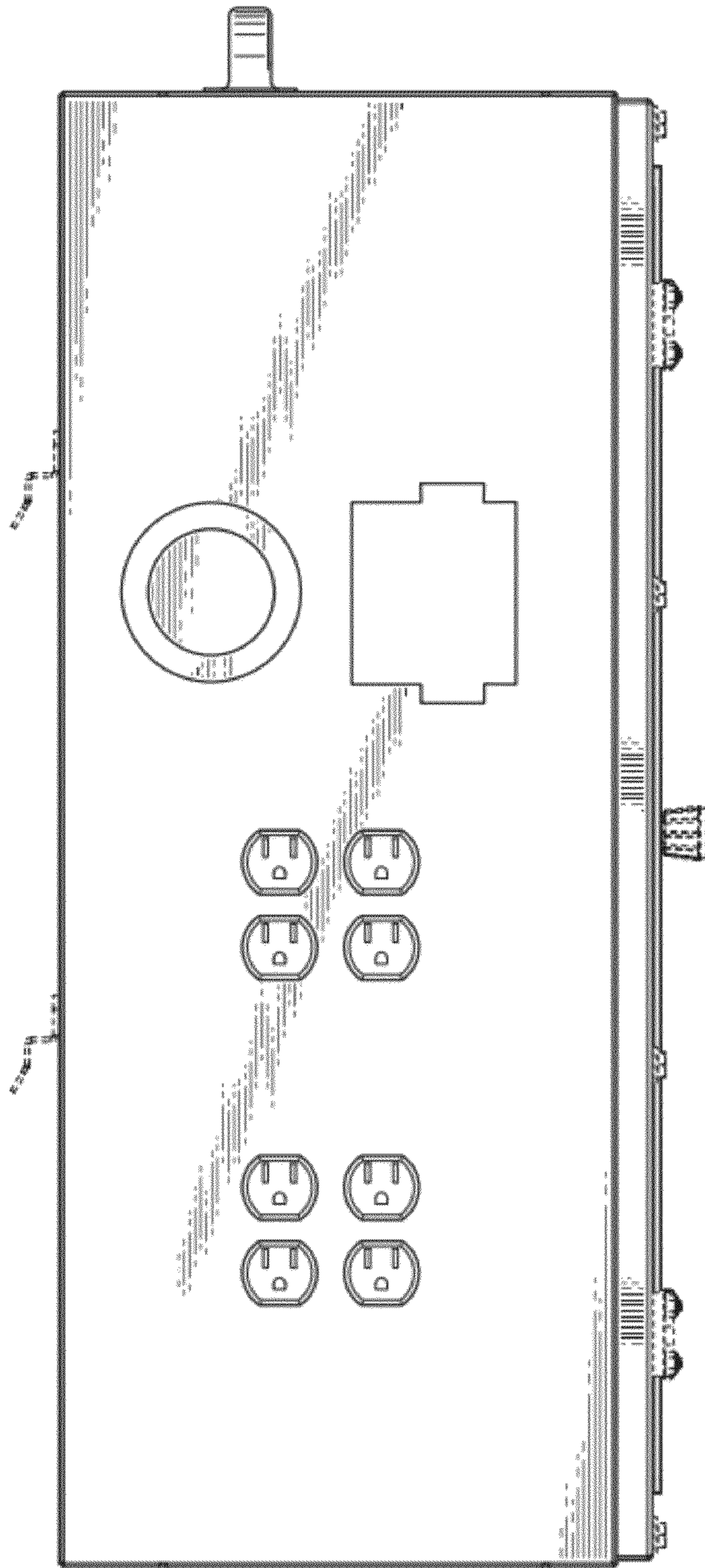

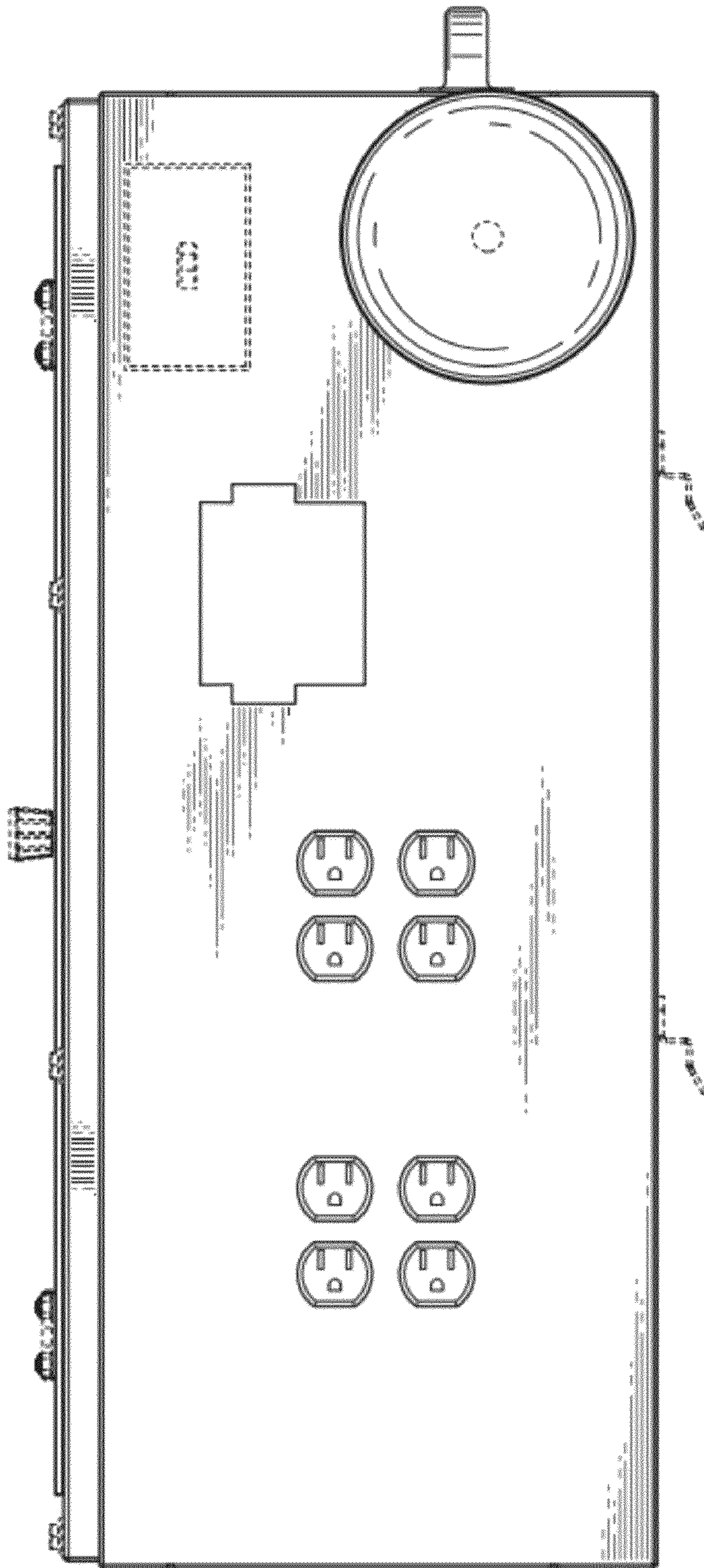

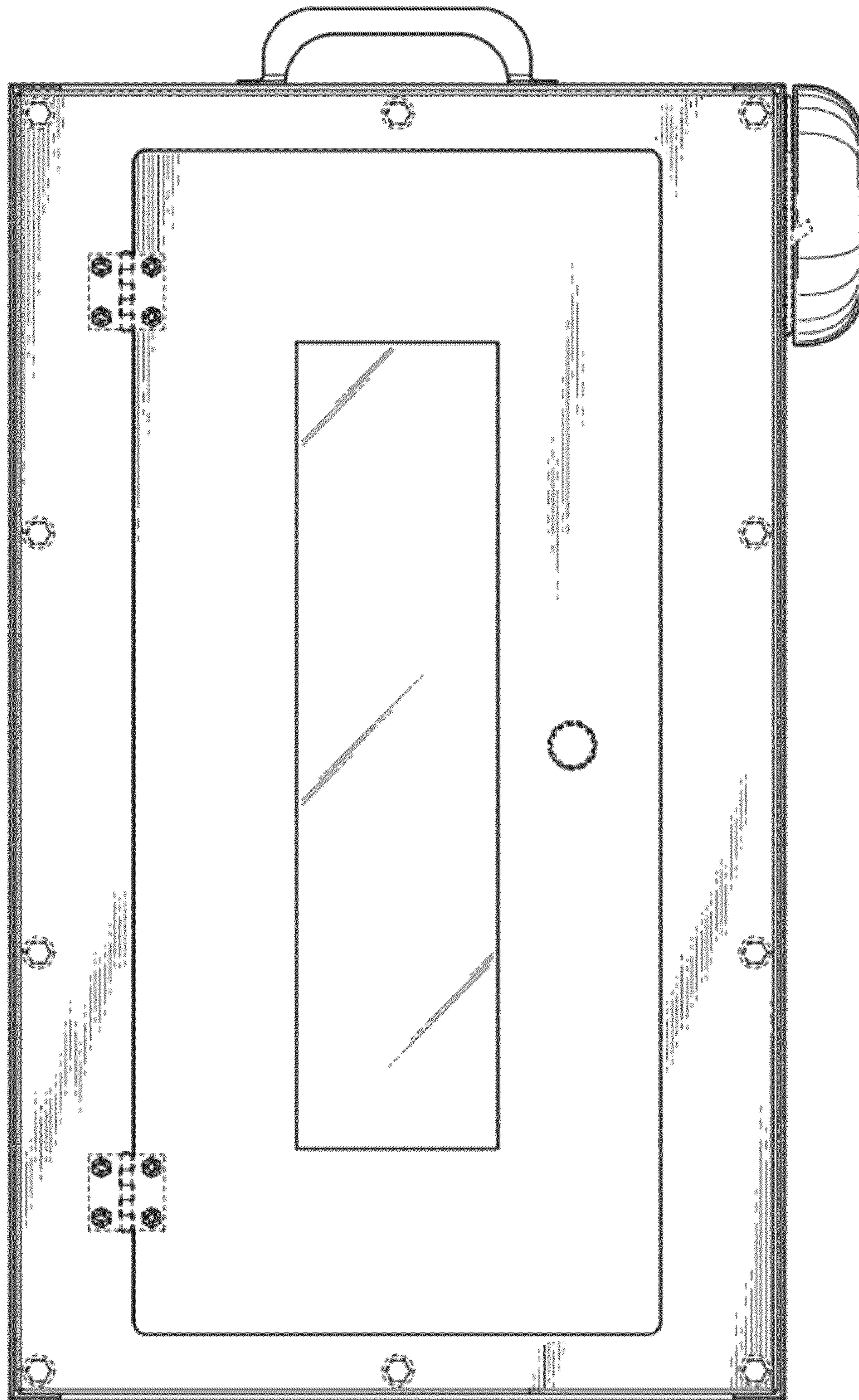

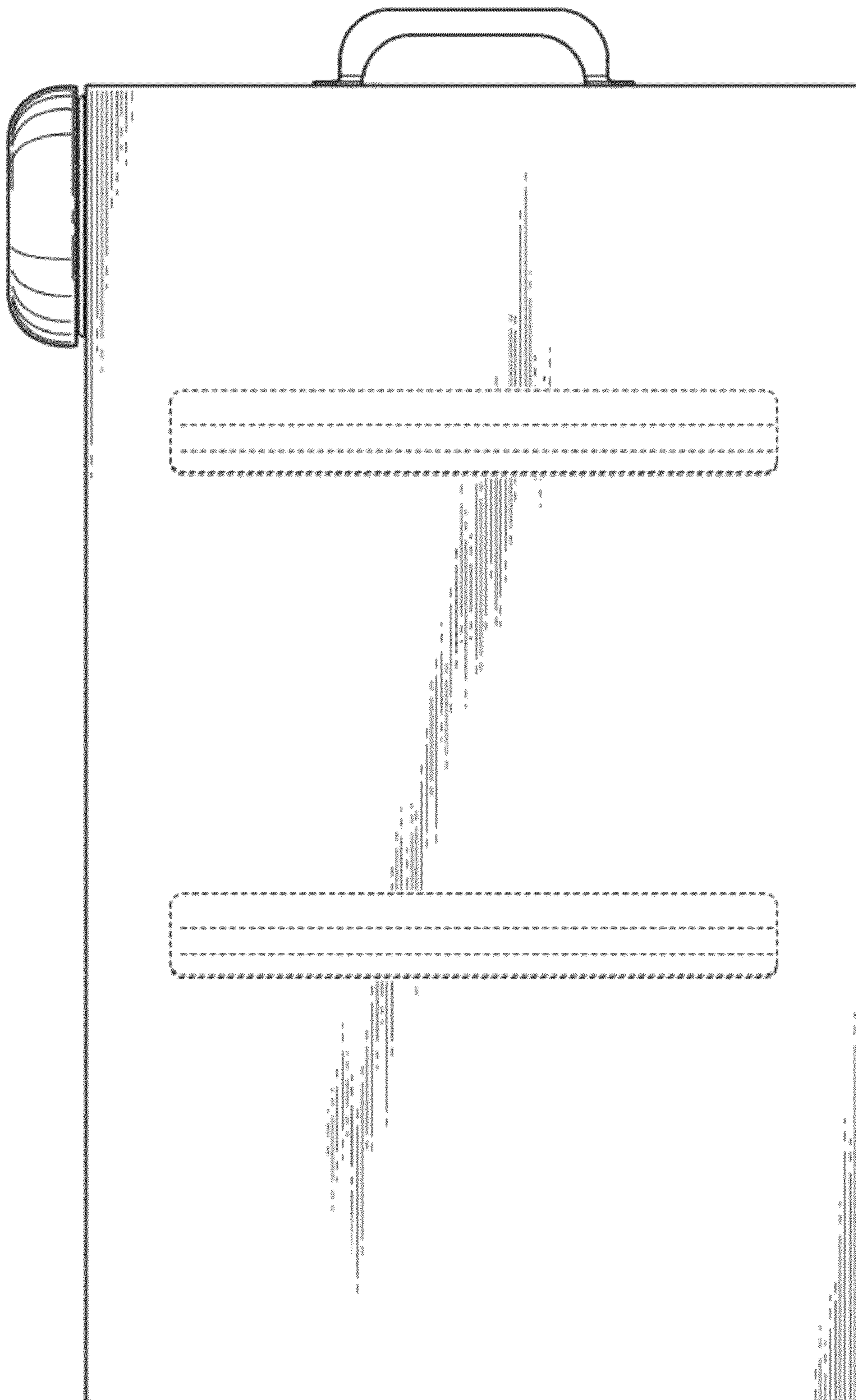

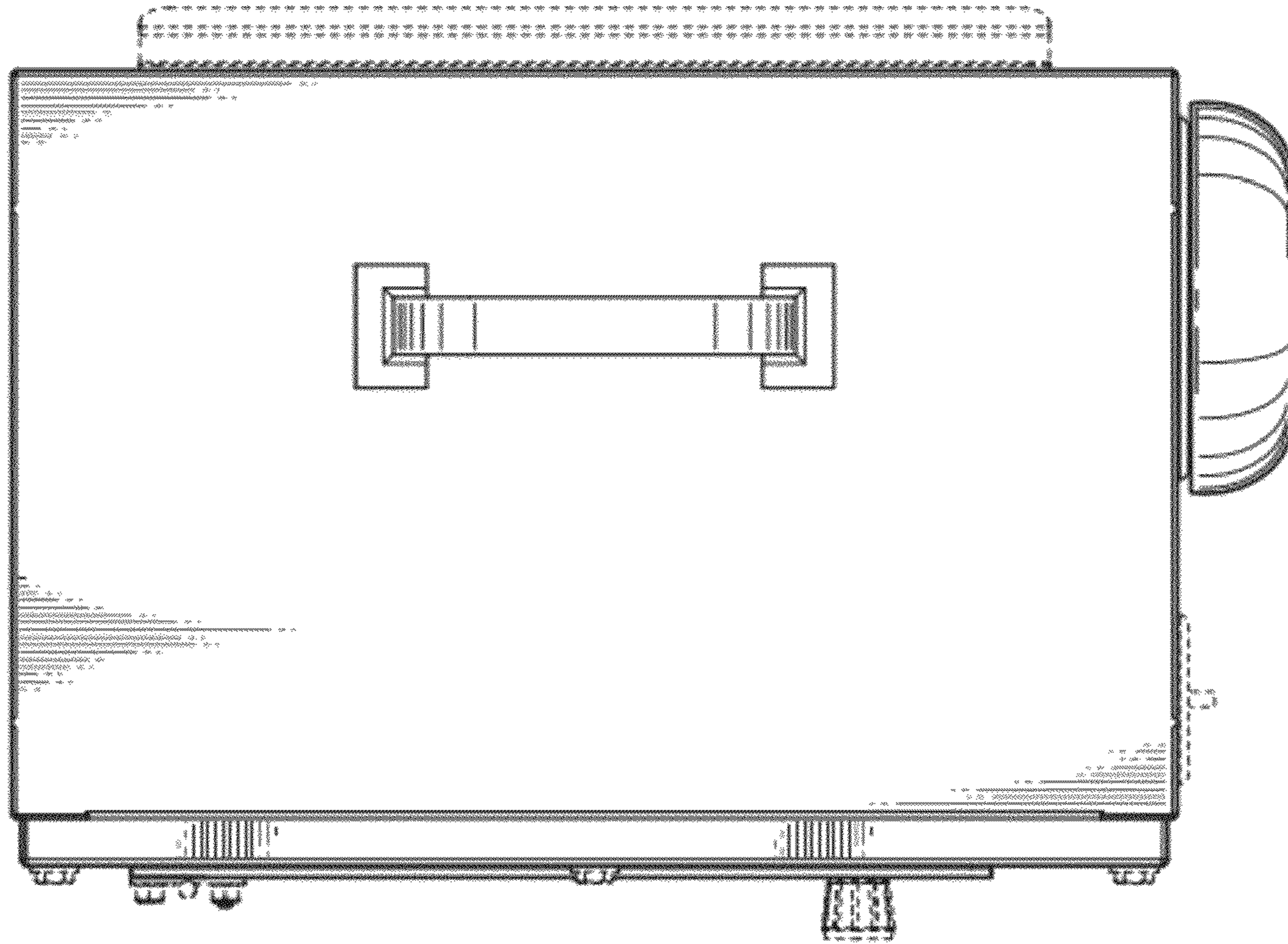

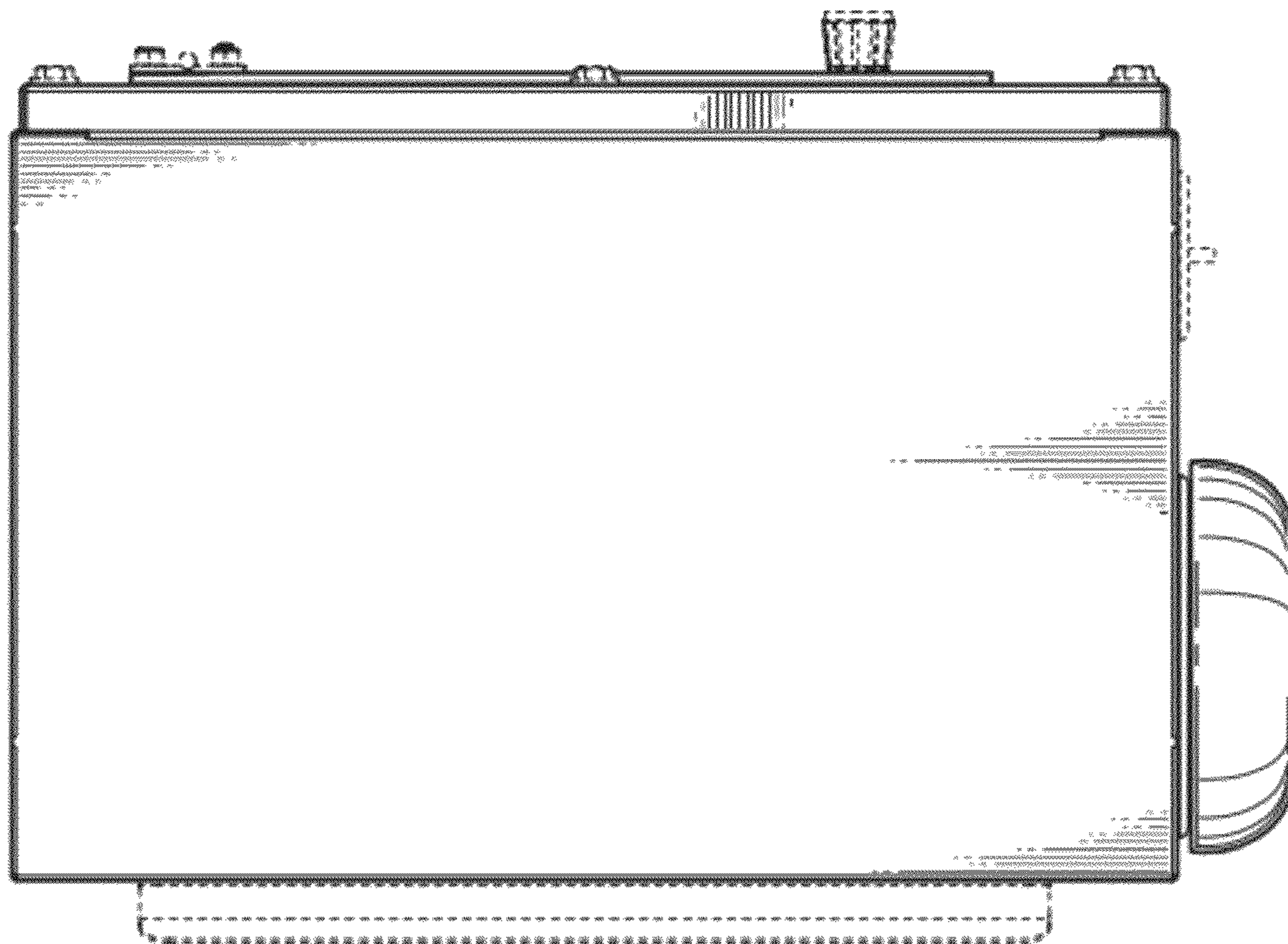
