DESCRIPTION

FIG. 1 is a right elevated perspective view of a teleconference room;
FIG. 2 is a right ground level view thereof;

FIG. 4 is a close up right side view of a front region of the teleconference room;
FIG. 5 is a front view of the teleconference room;
FIG. 6 is a close up view of a conference table in the teleconference room; and,
FIG. 7 is a close up right side view of a conference table in the teleconference room.

The broken lines showing wall features are for the purpose of illustrating the article and form no part of the claimed design.

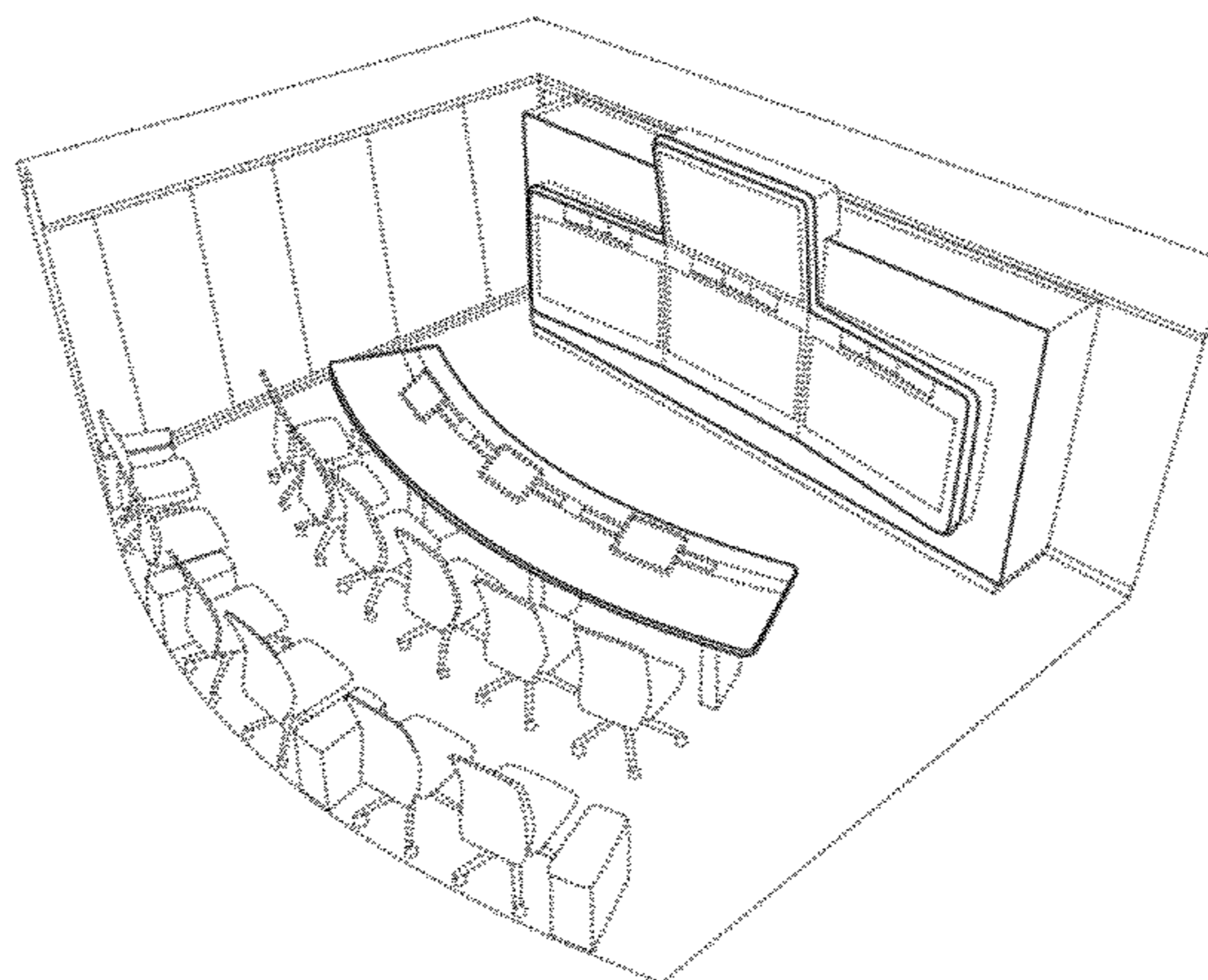
The broken lines showing ceiling and lighting features are for the purpose of illustrating the article, and form no part of the claimed design.

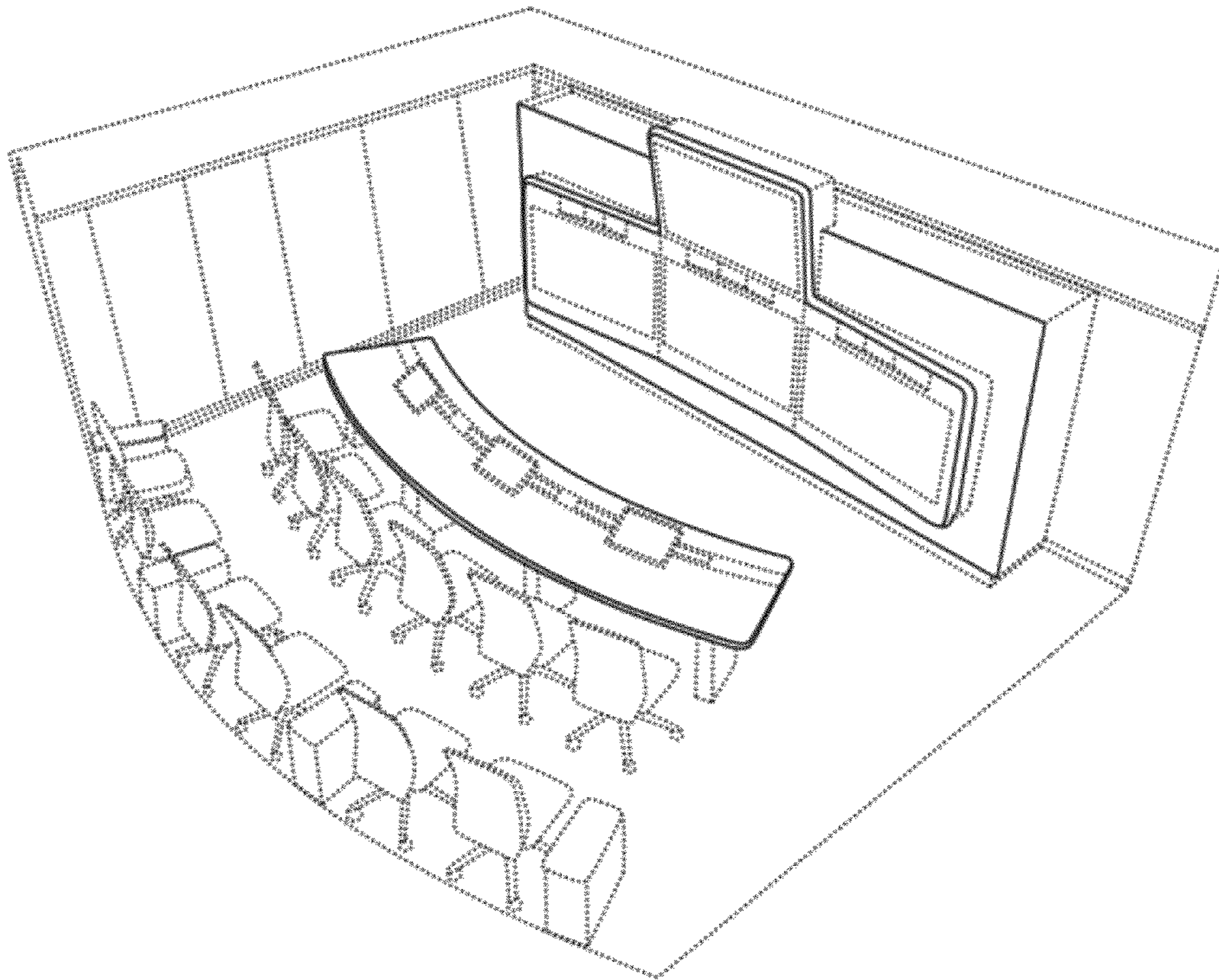

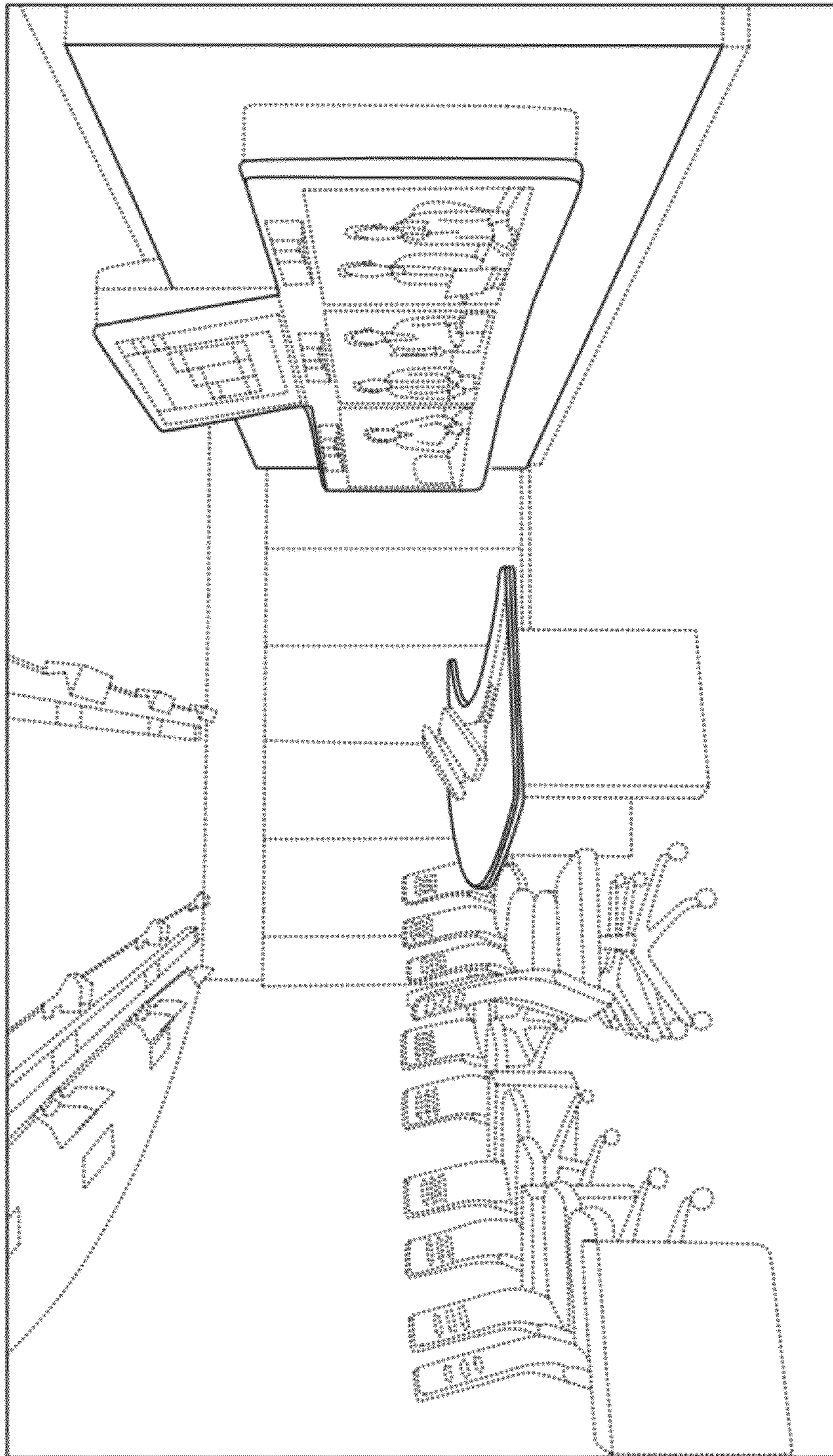

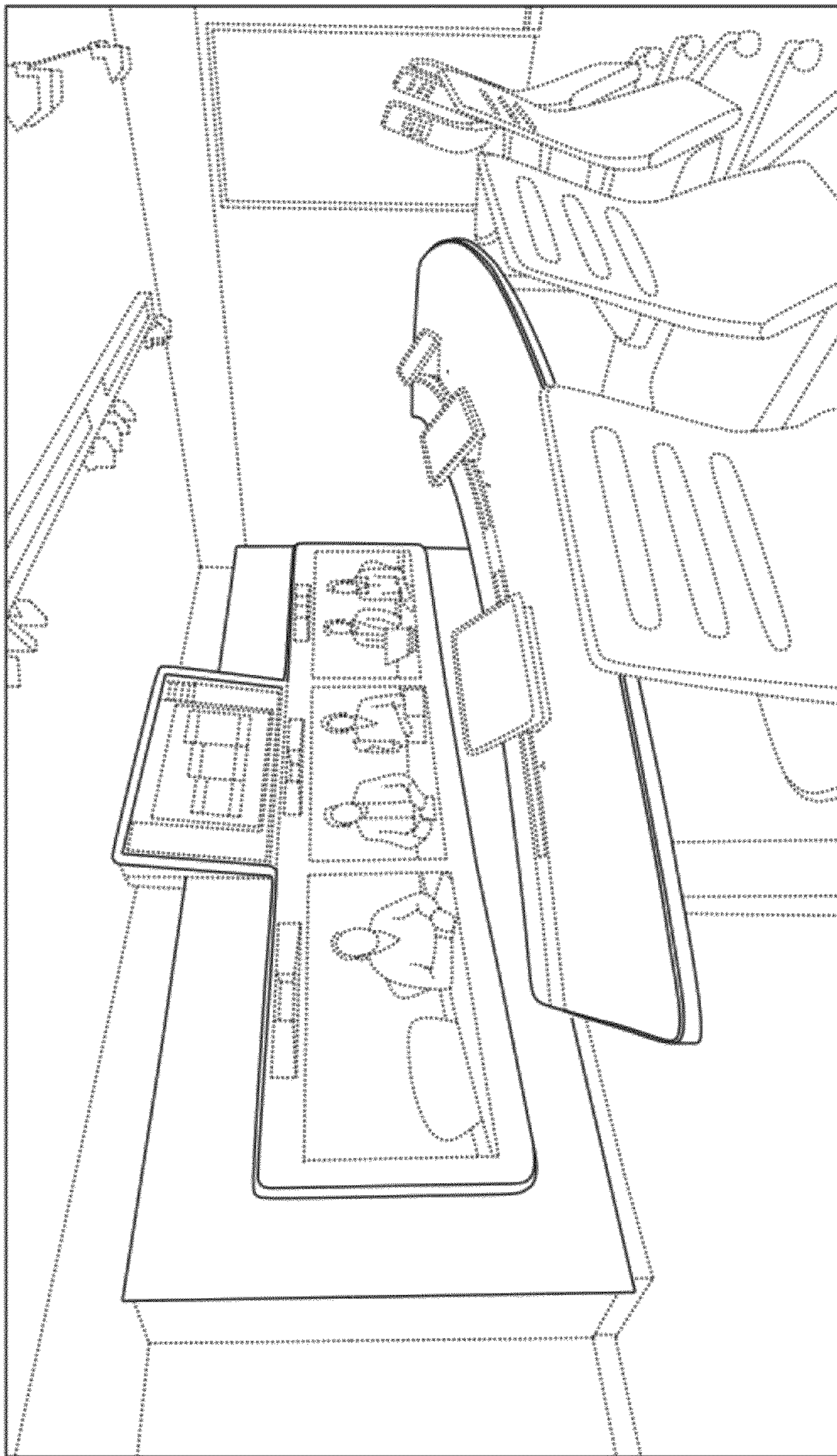

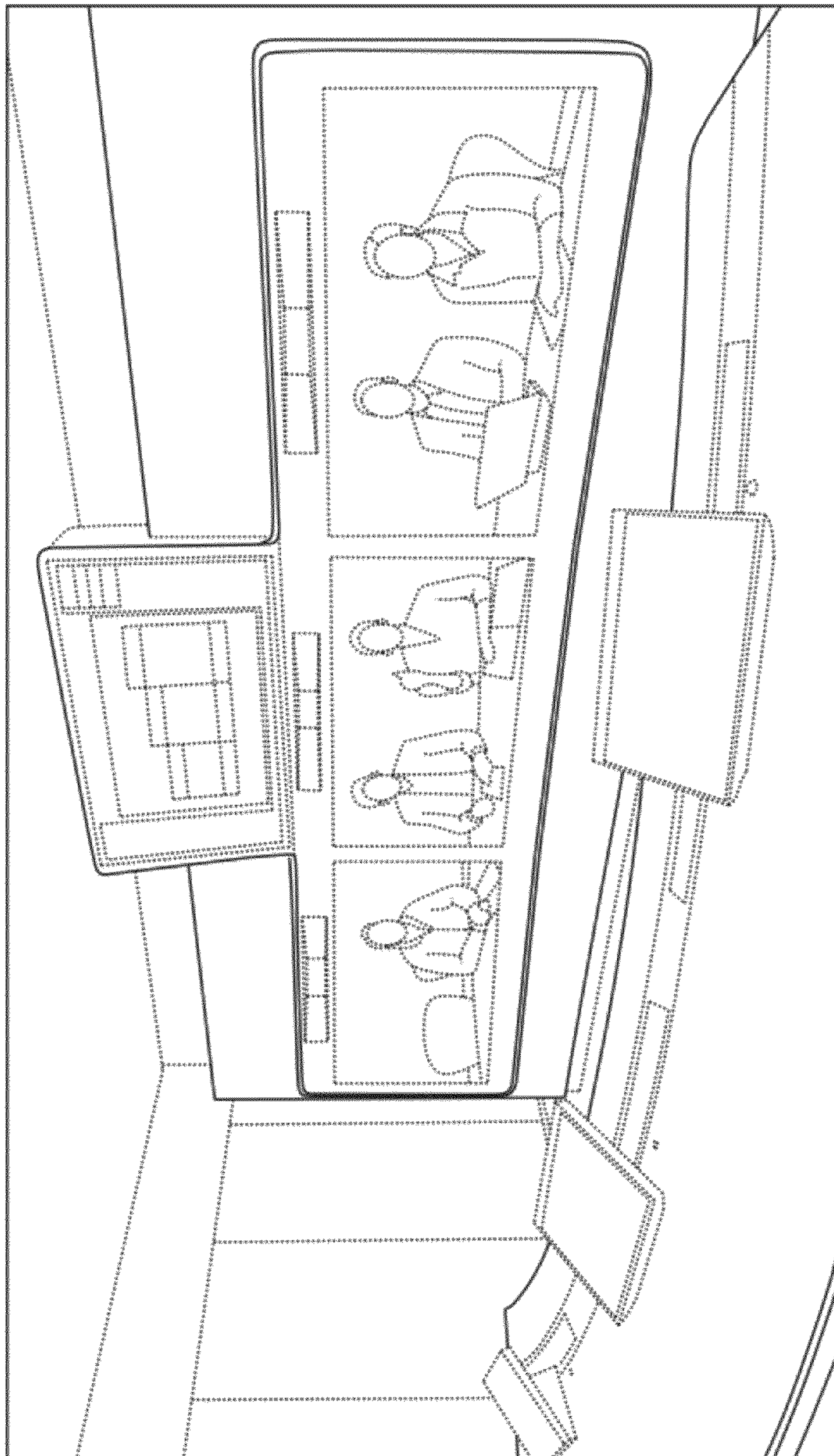

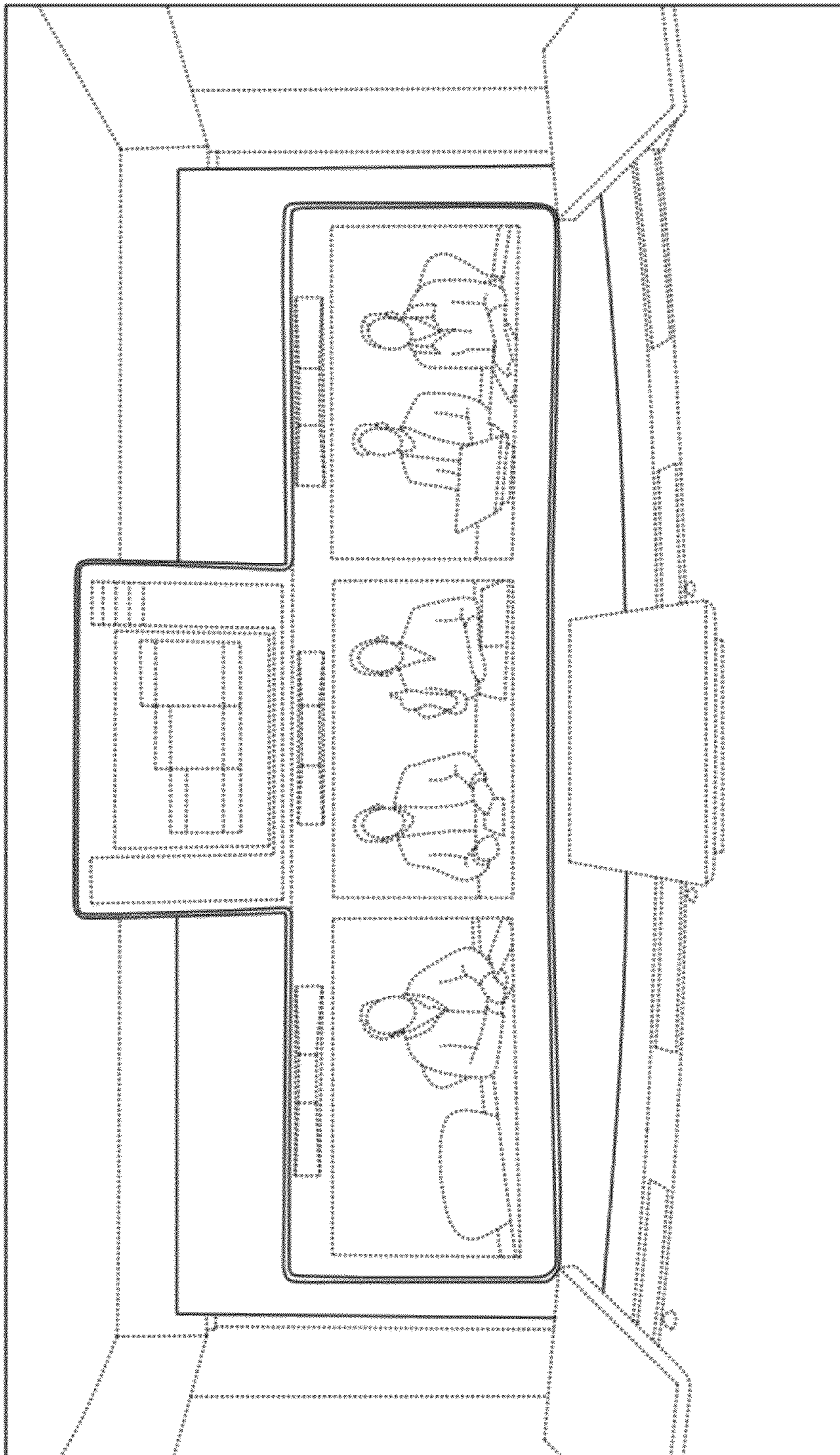

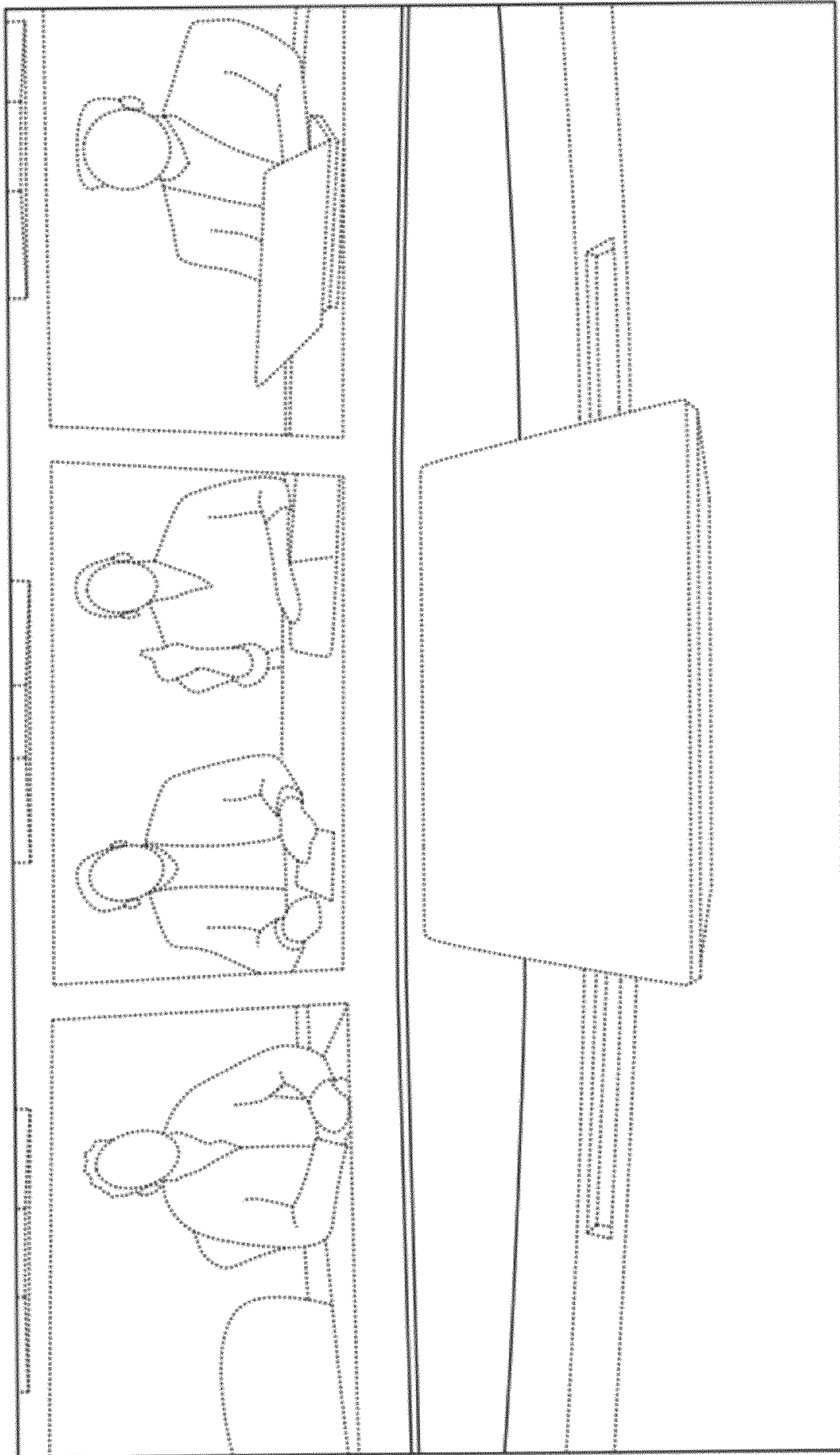

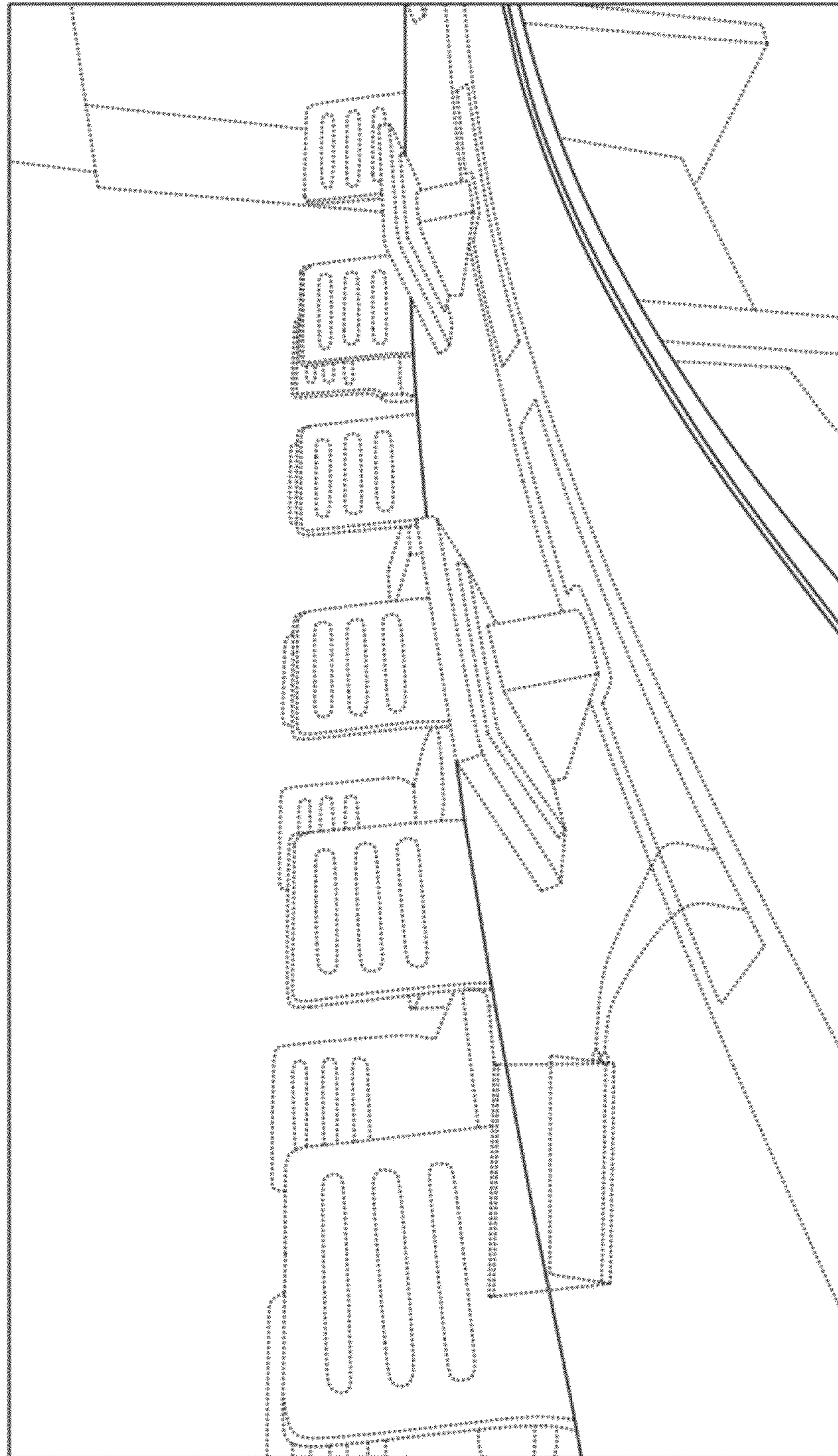
