(57) **CLAIM**

The ornamental design for a display and stand, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a display and stand showing our new design, wherein the display is shown in a first position;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a left side elevation view thereof, wherein the right side elevation view is a minor image of FIG. 3;

FIG. 4 is a top plan view thereof;

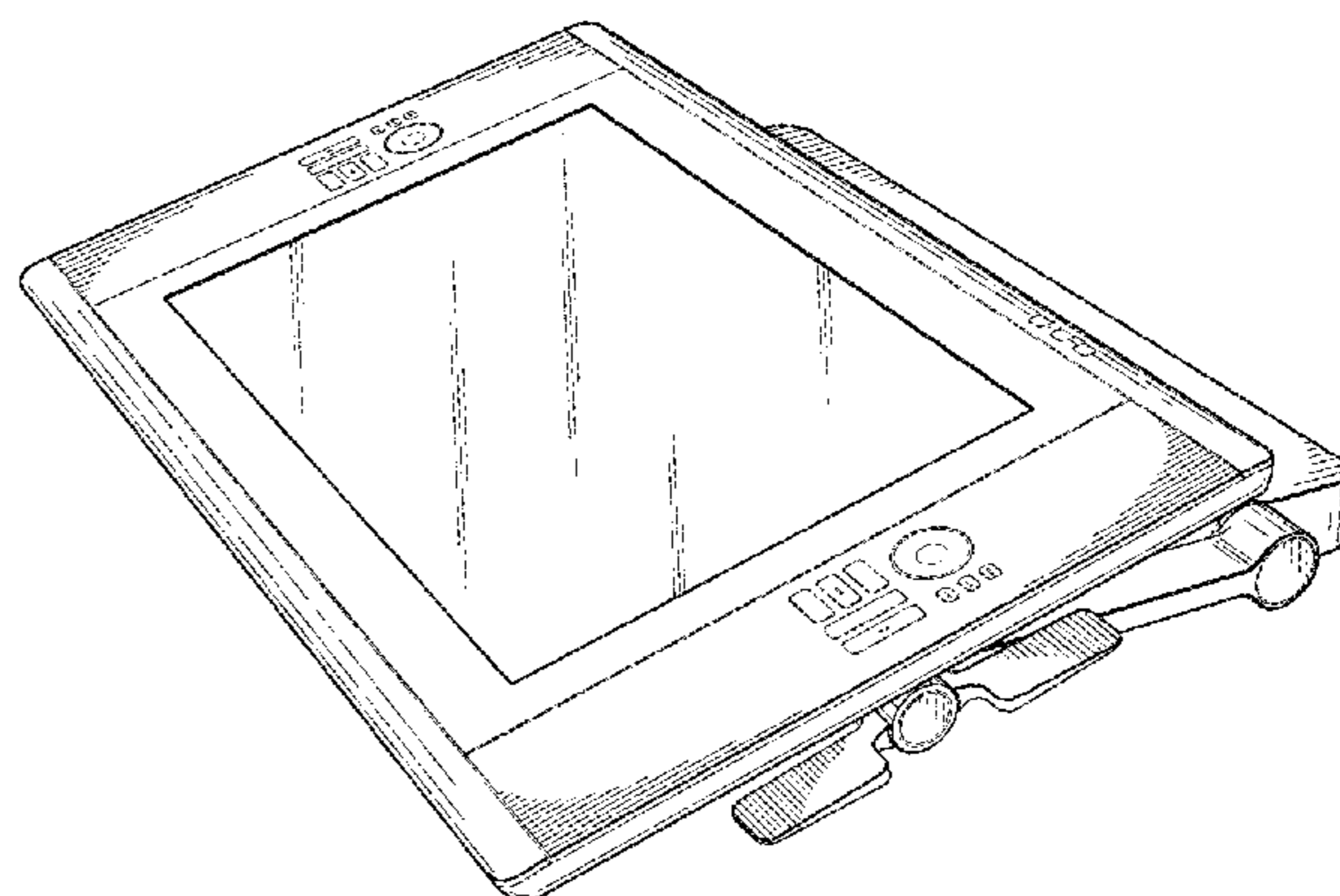
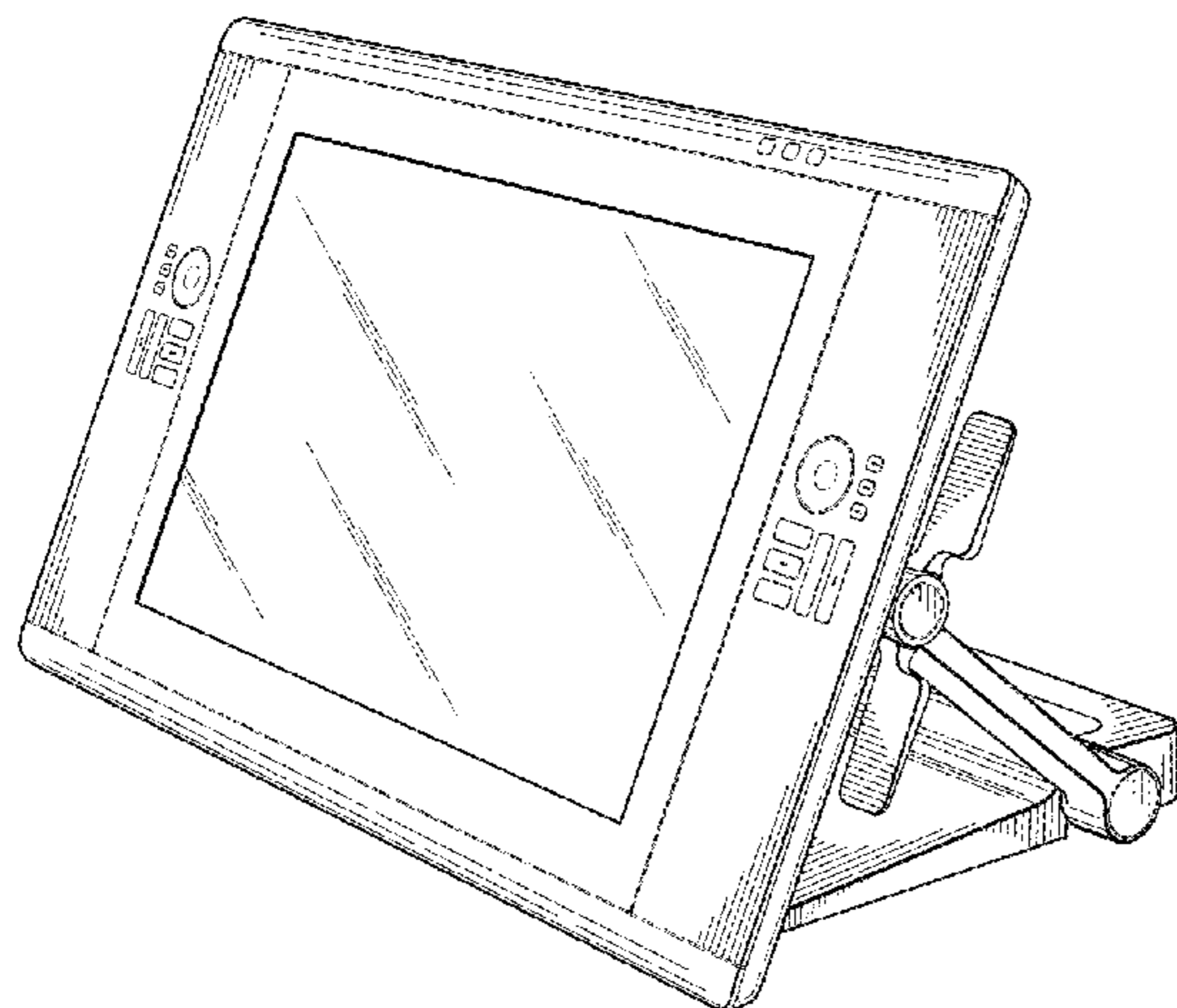
FIG. 5 is a bottom plan view thereof;

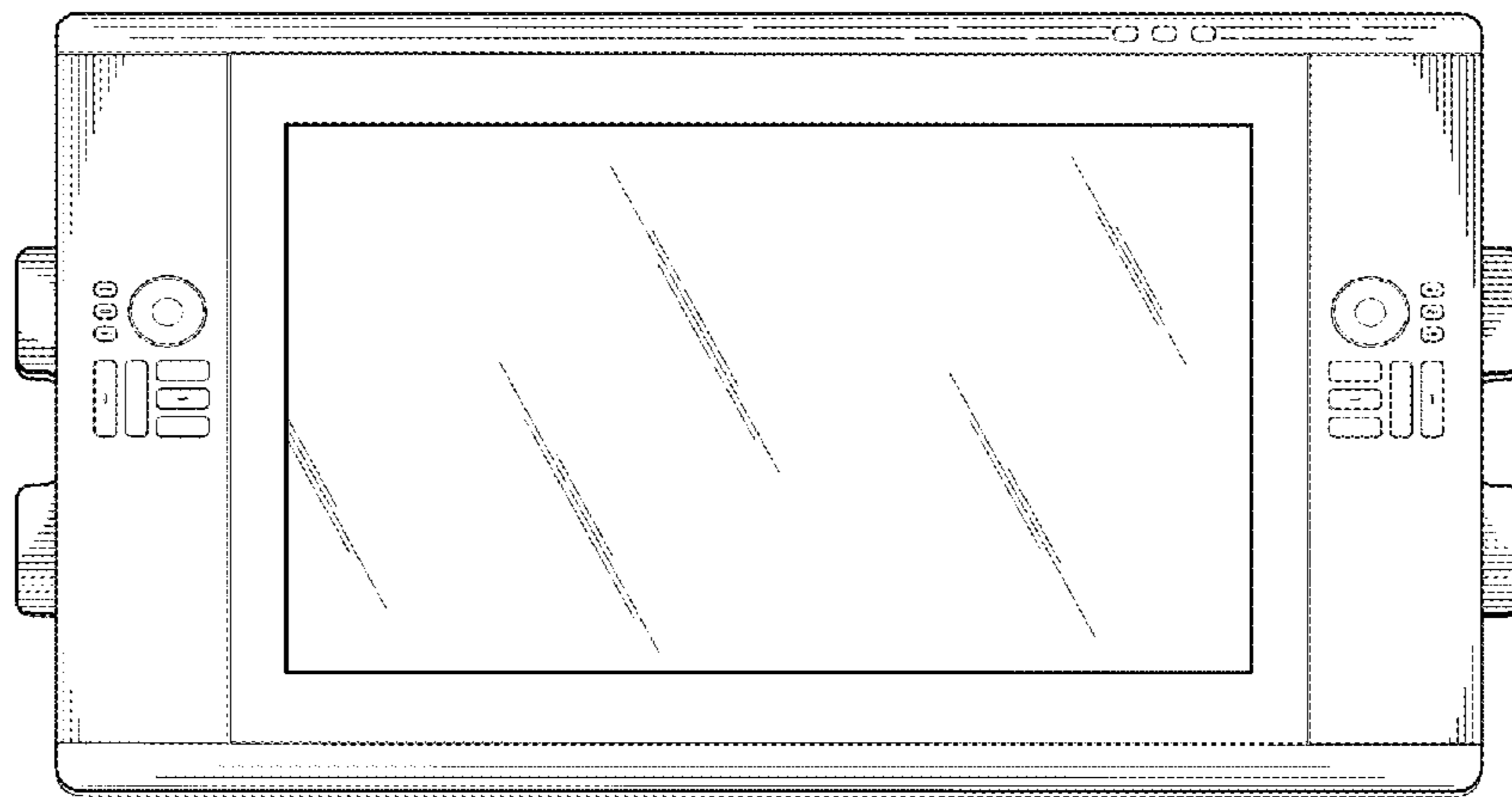

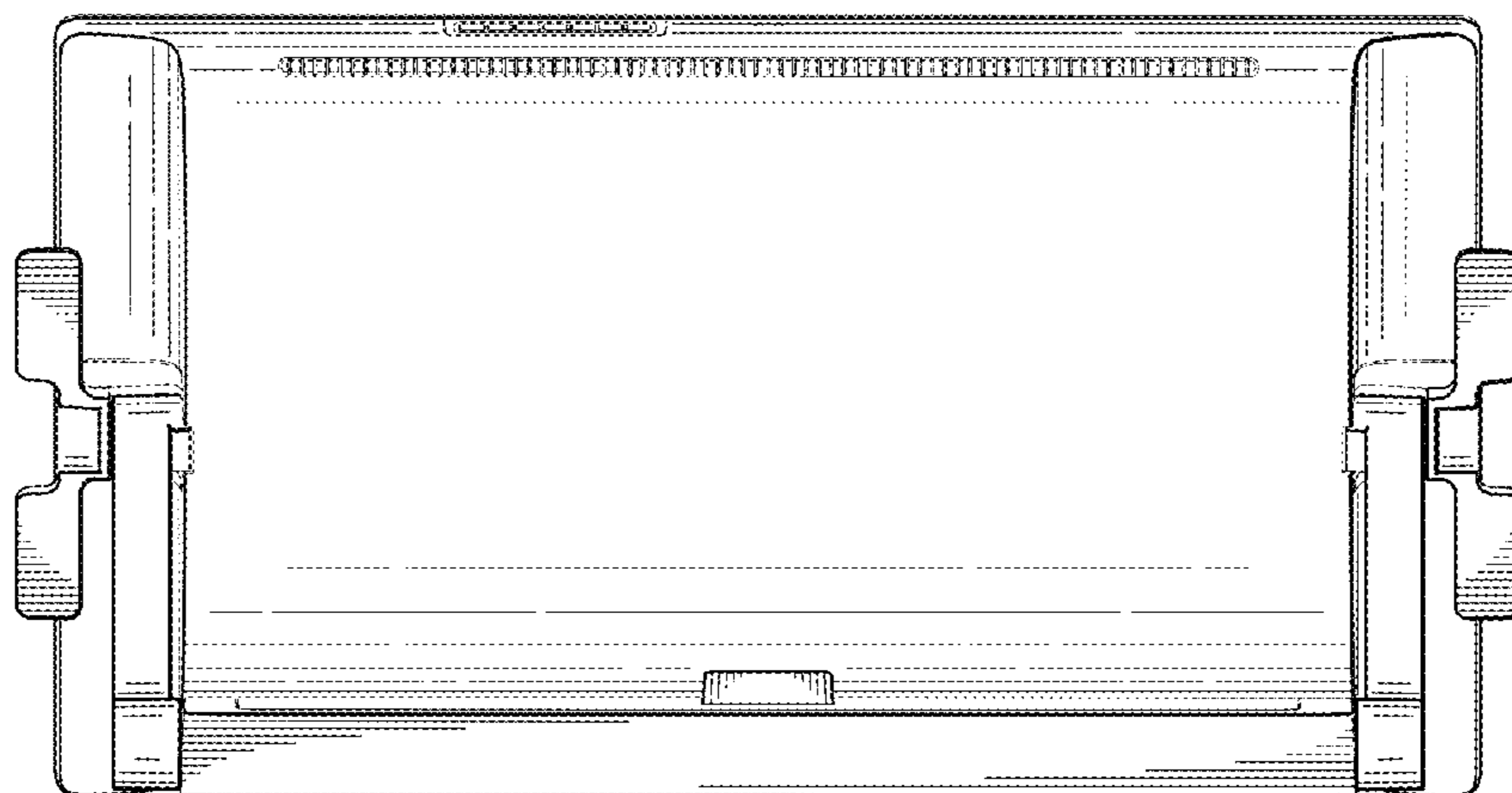

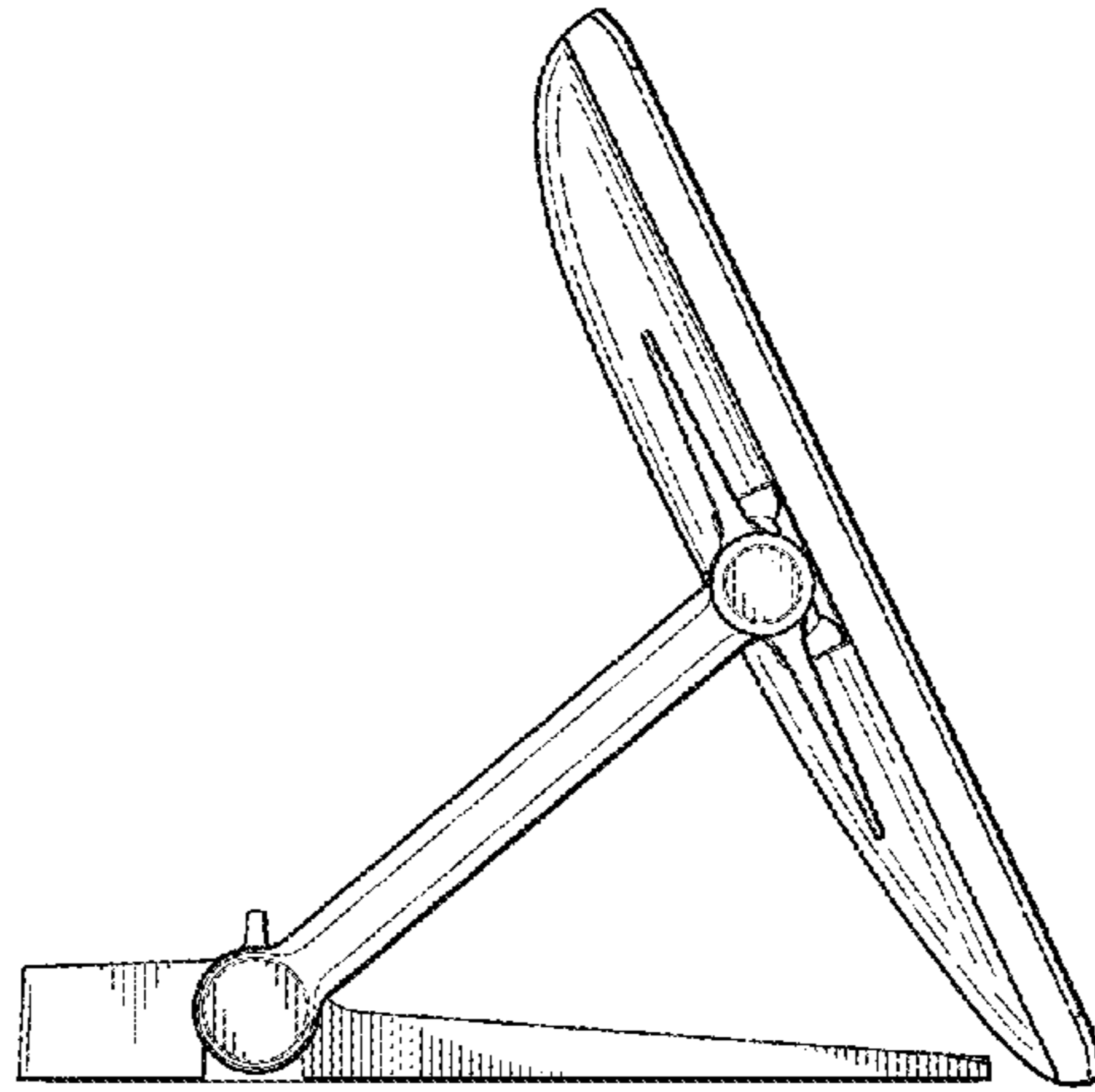

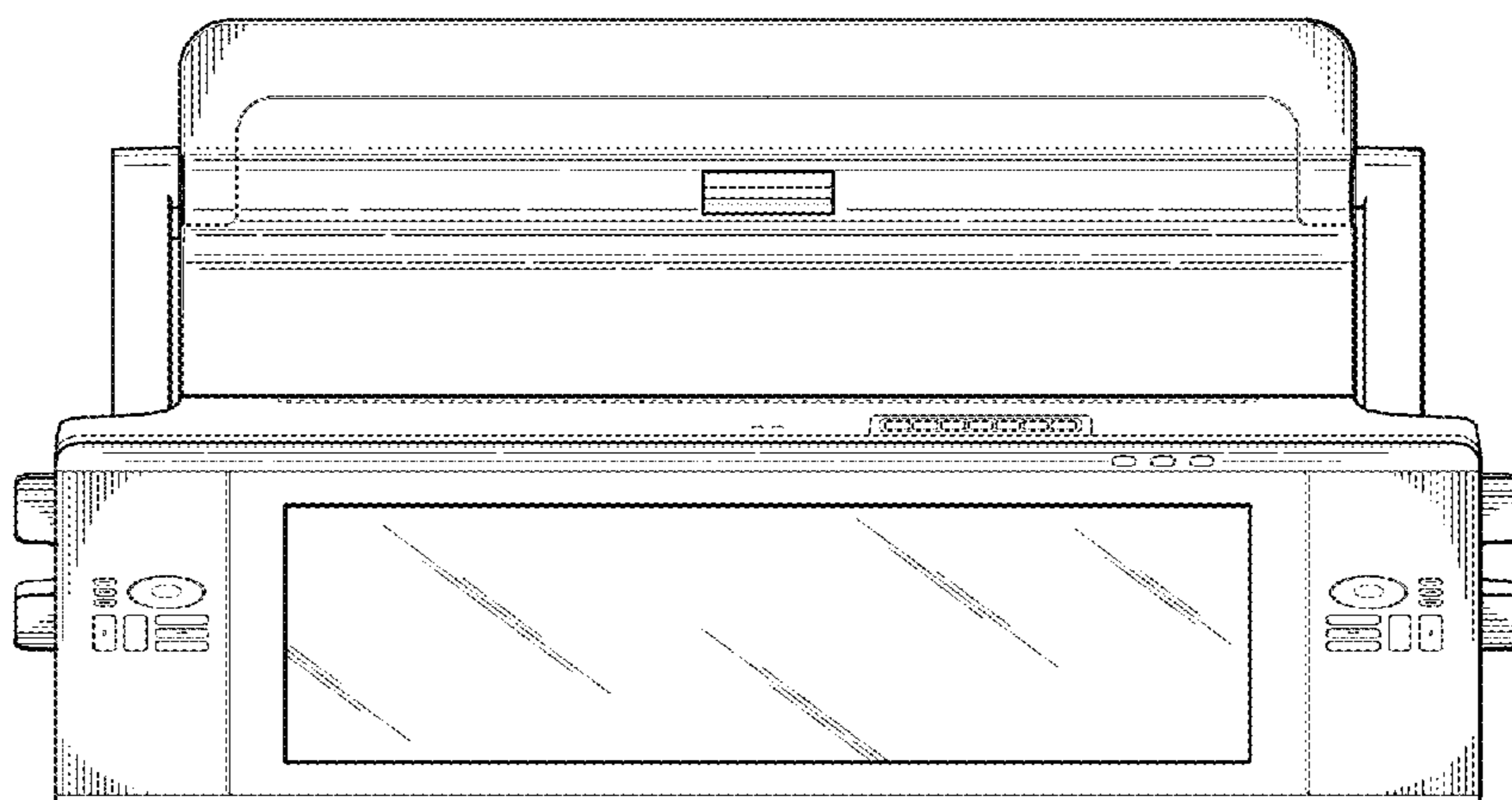

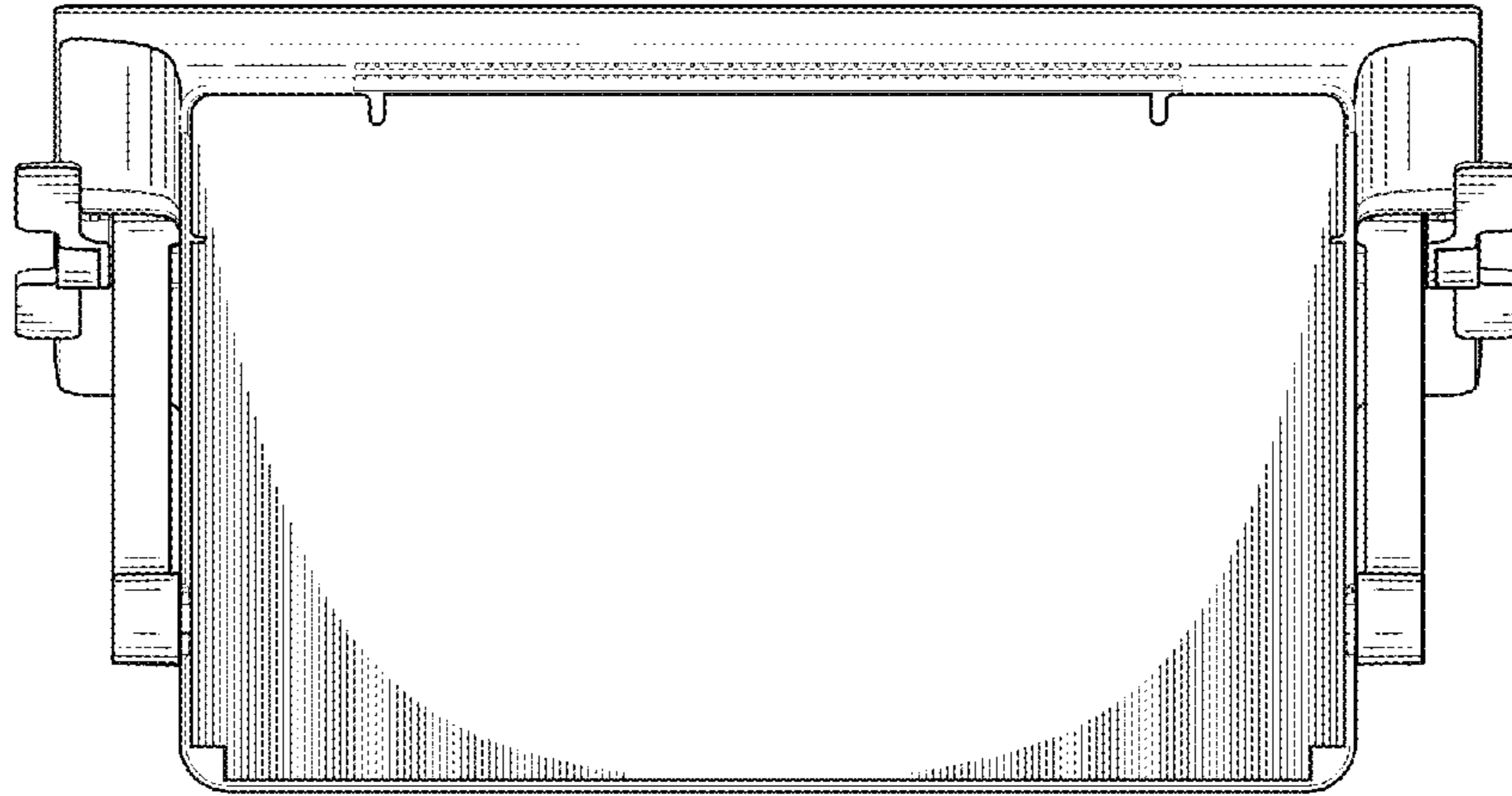

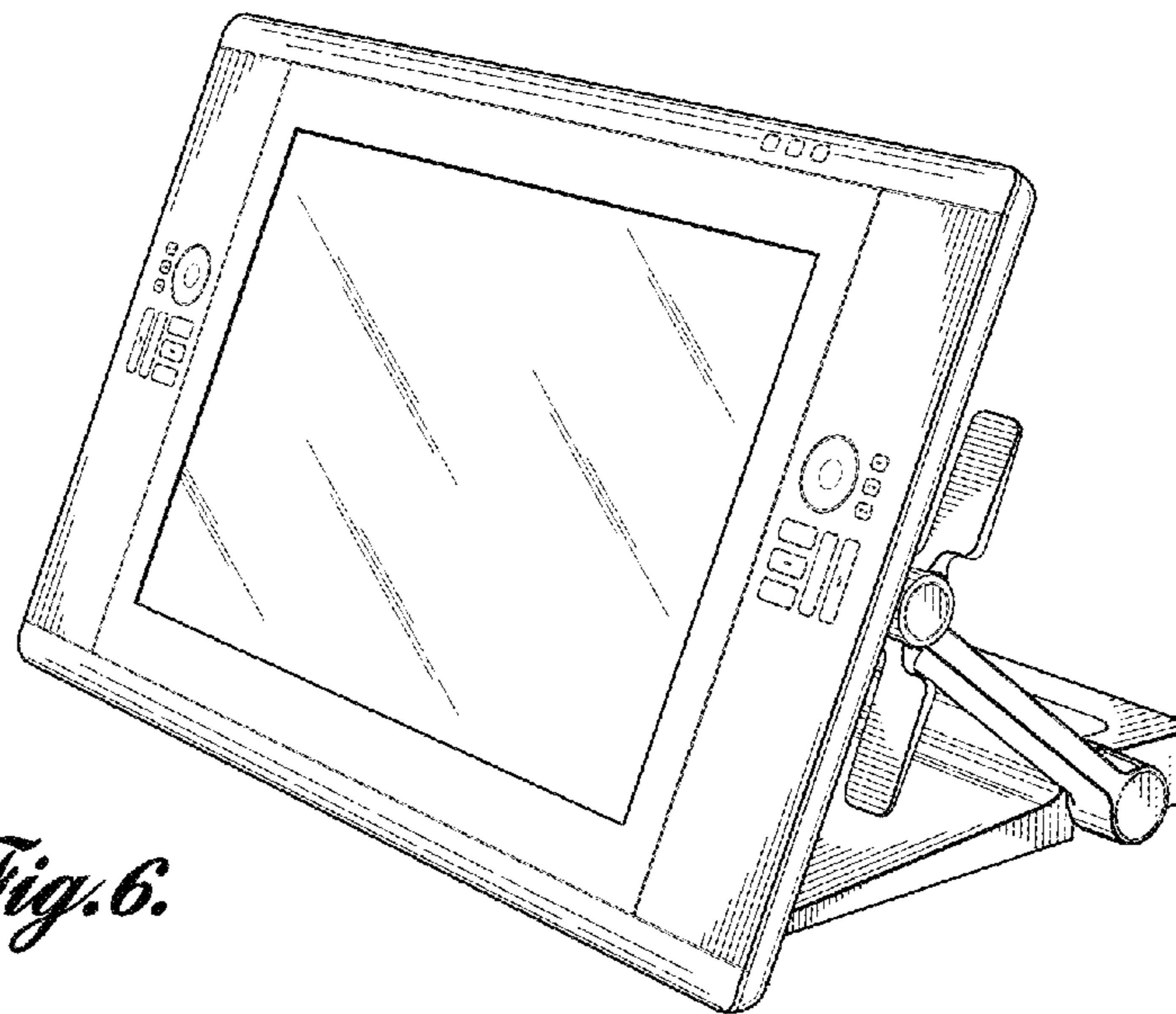

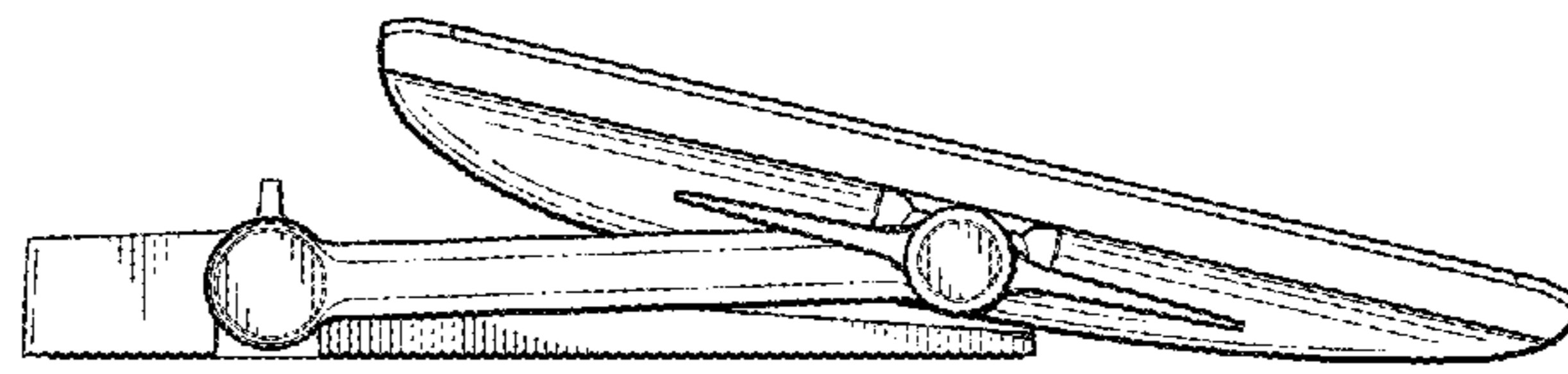

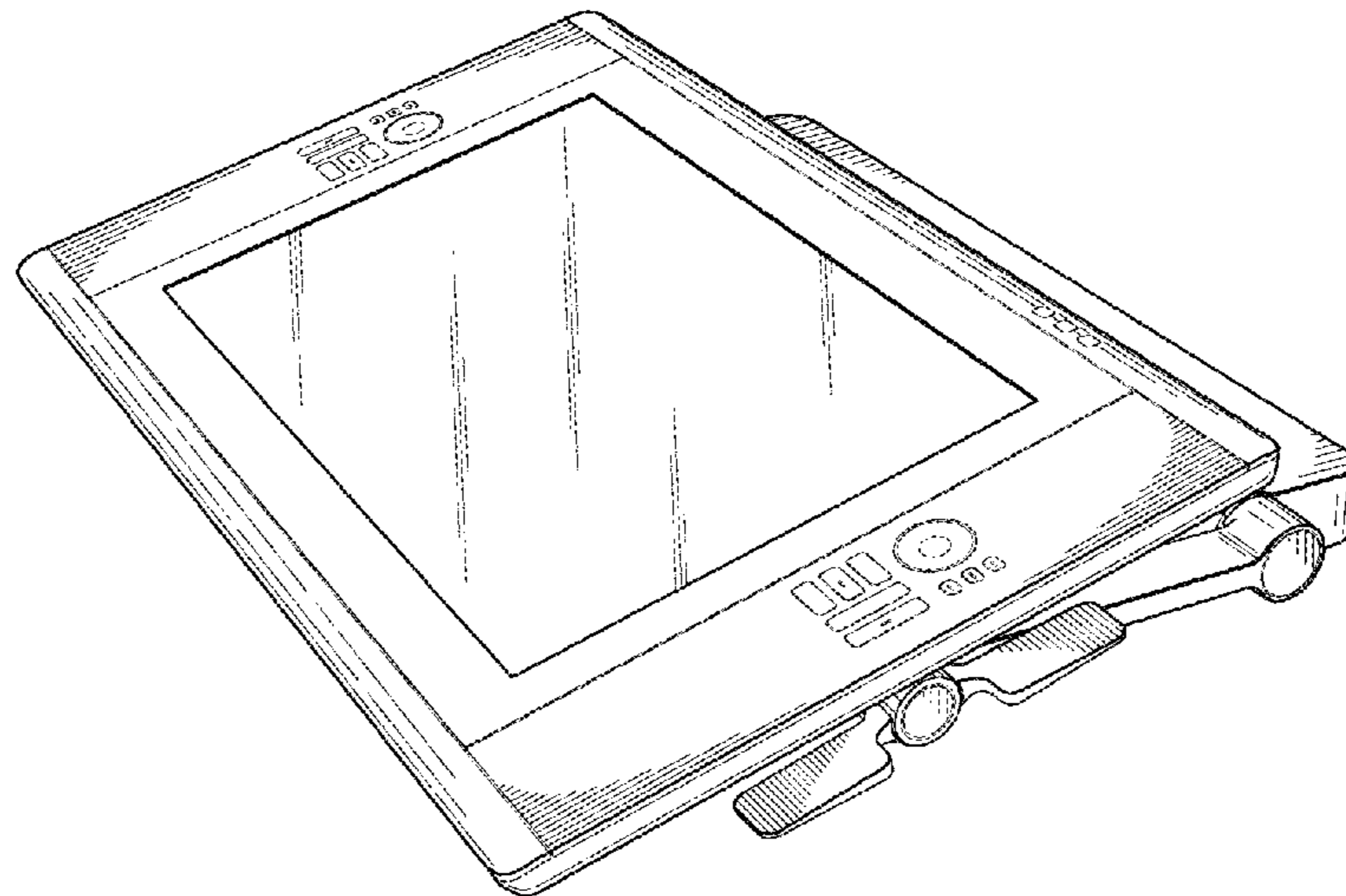
